**DESCRIPTION**

This application is related to a co-pending application of U.S. patent application Ser. No. 29/579,359, entitled “Bookmark Shaped Gift Card,” filed Sep. 29, 2016, the entire contents of which are incorporated herein by reference. All of the material from the U.S. Patent Application which is essential to the claimed design is included herein. FIG. 14 is a left-side view thereof.

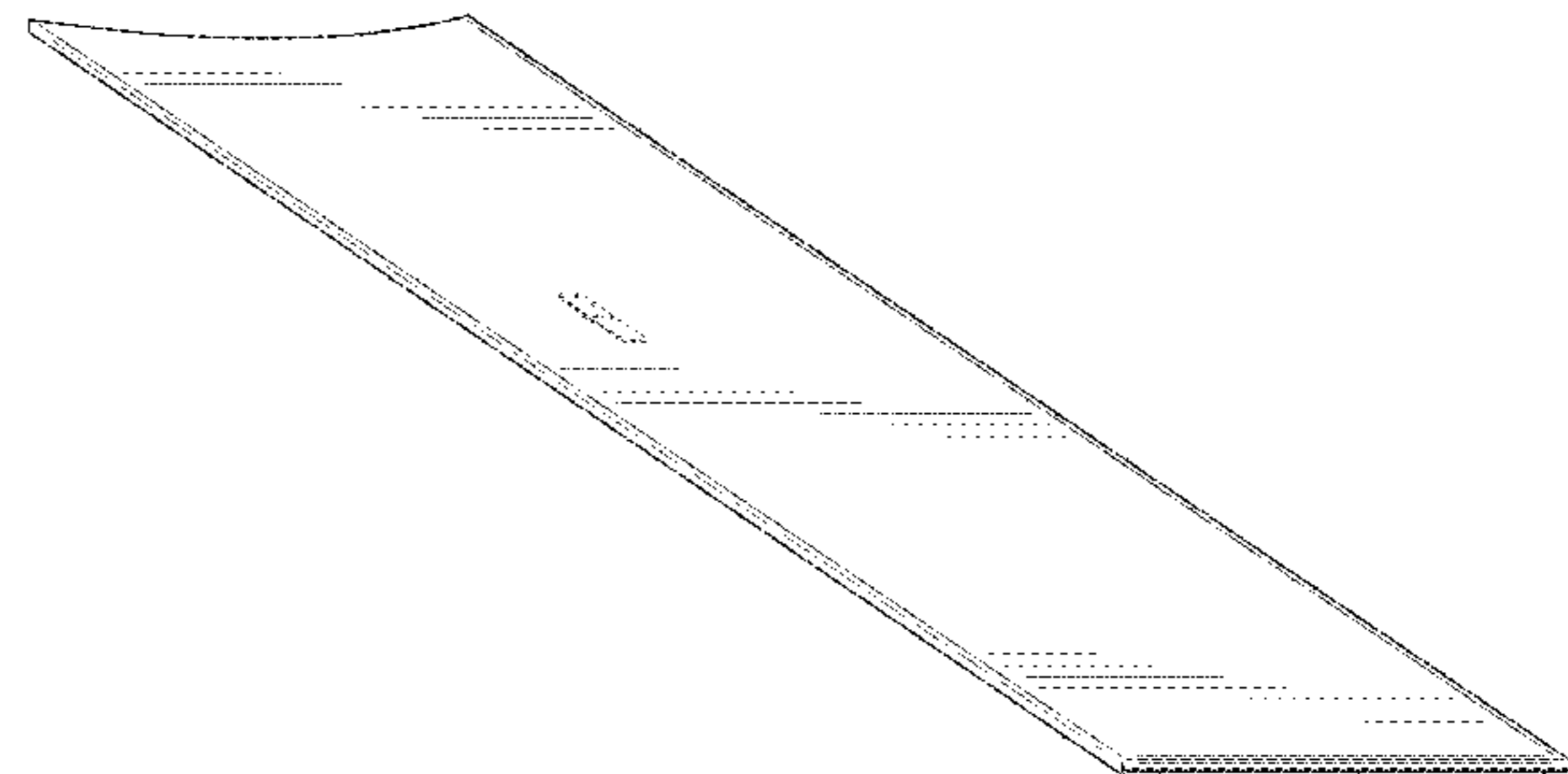
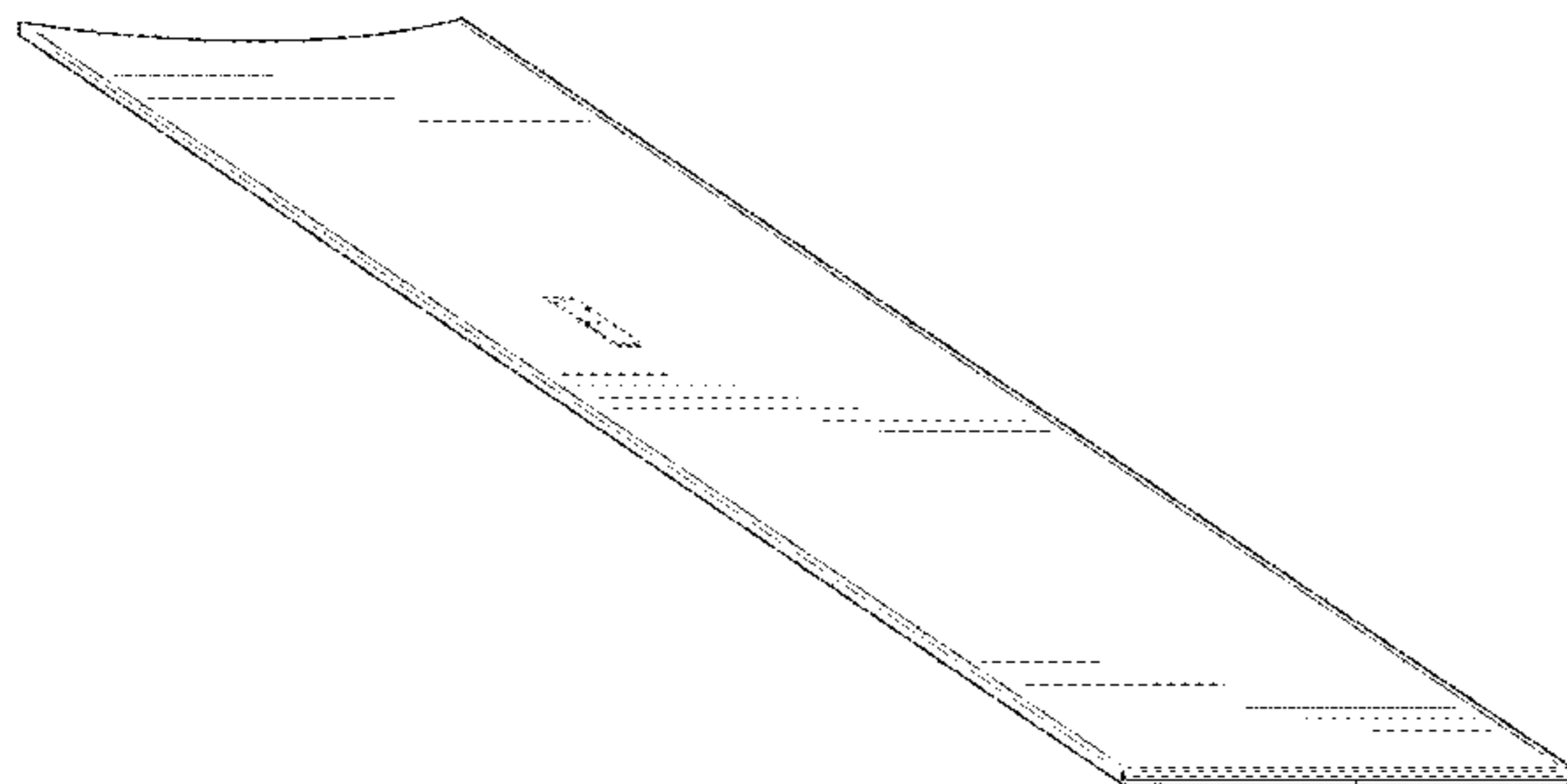
FIG. 15 is a right-side view thereof.

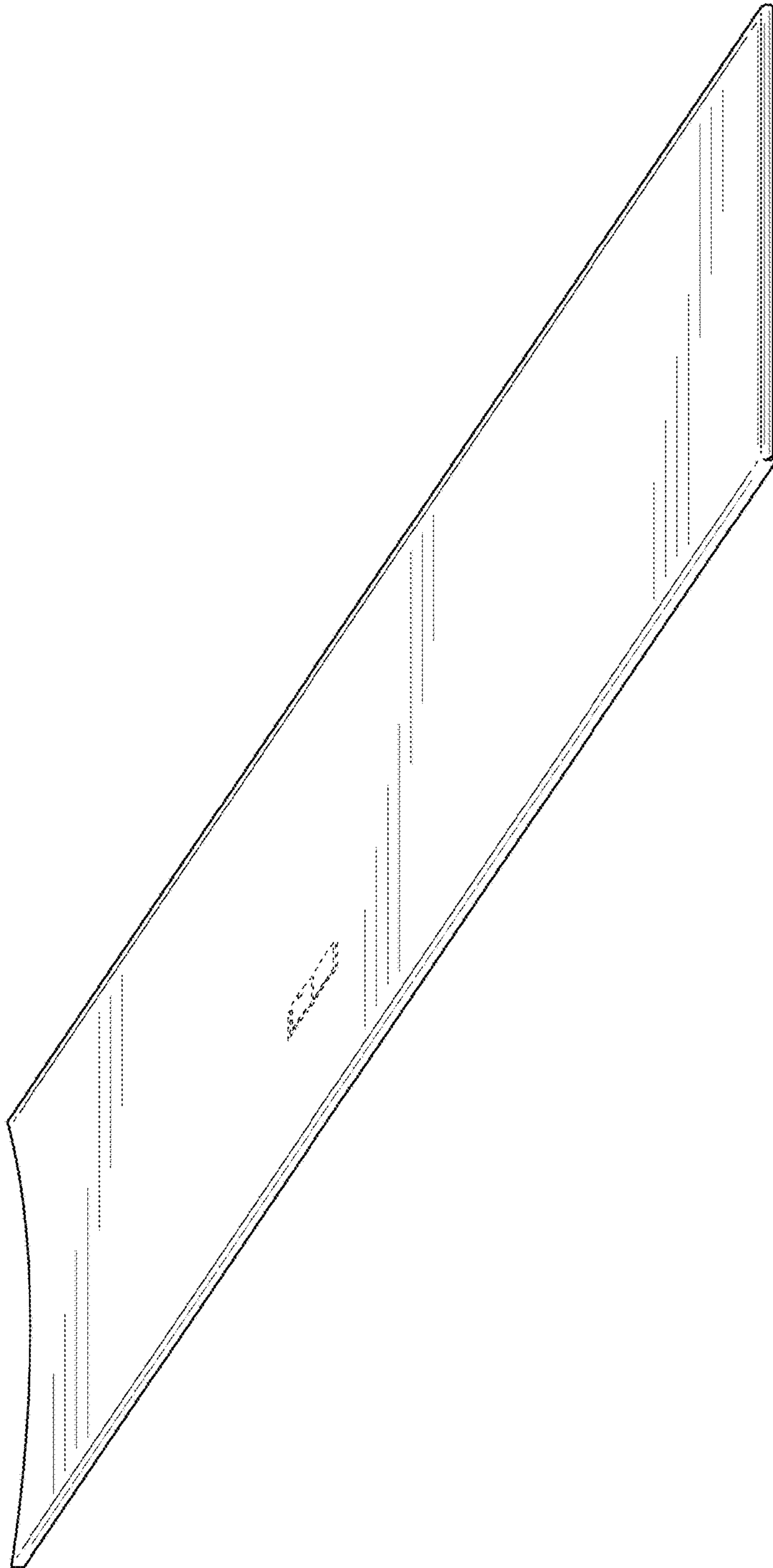

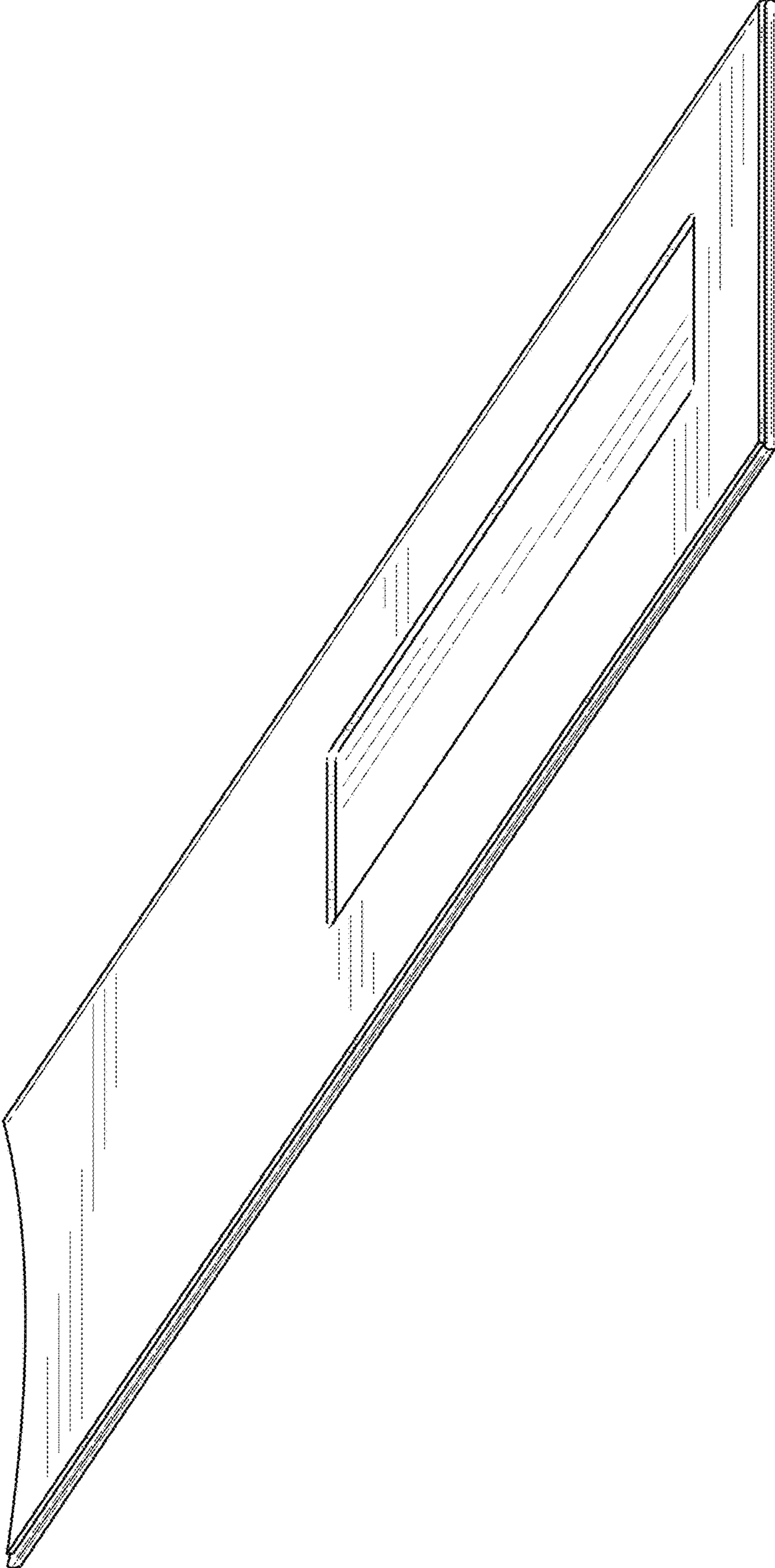

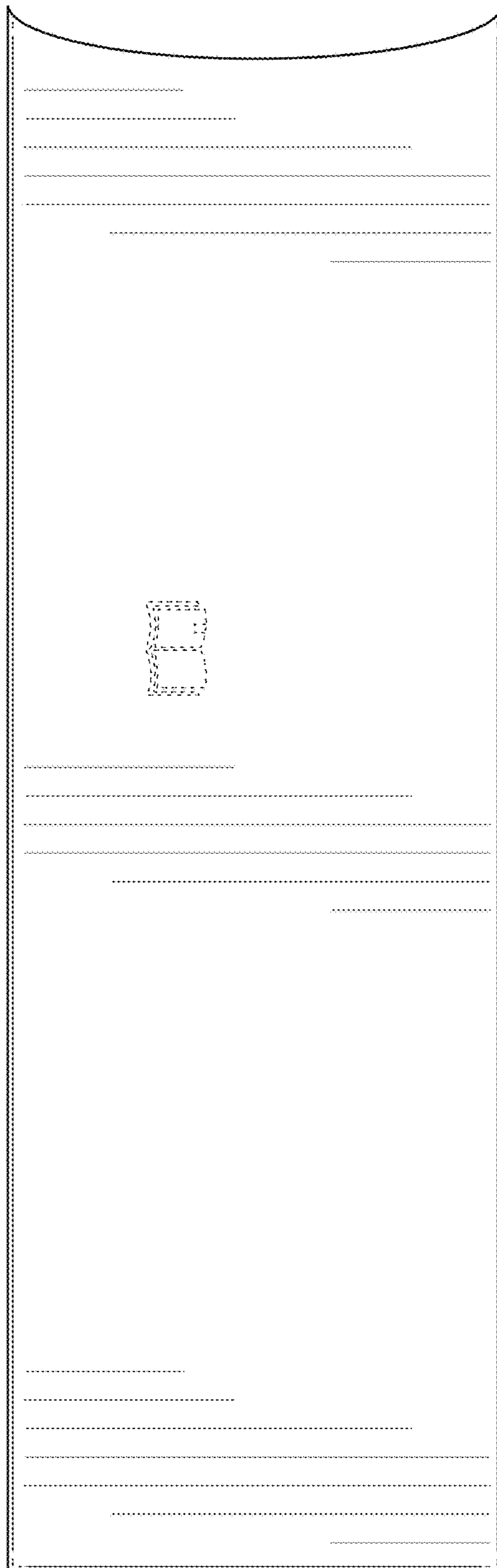

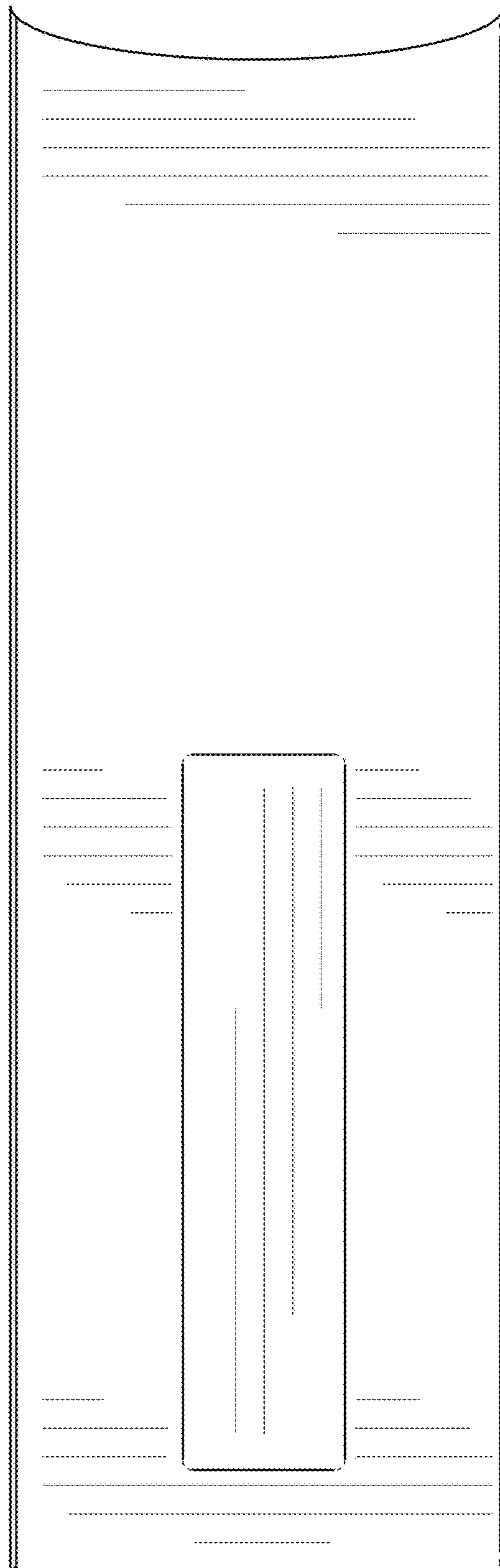

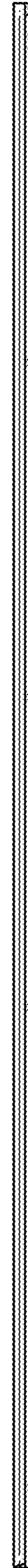

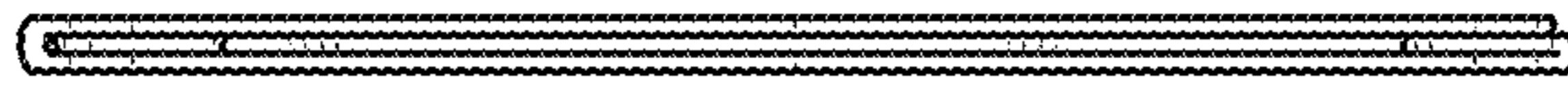

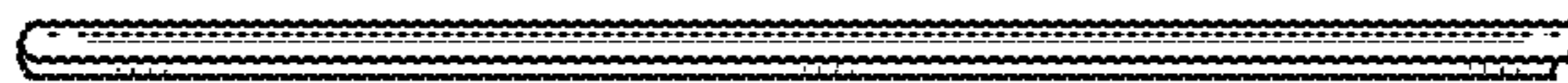

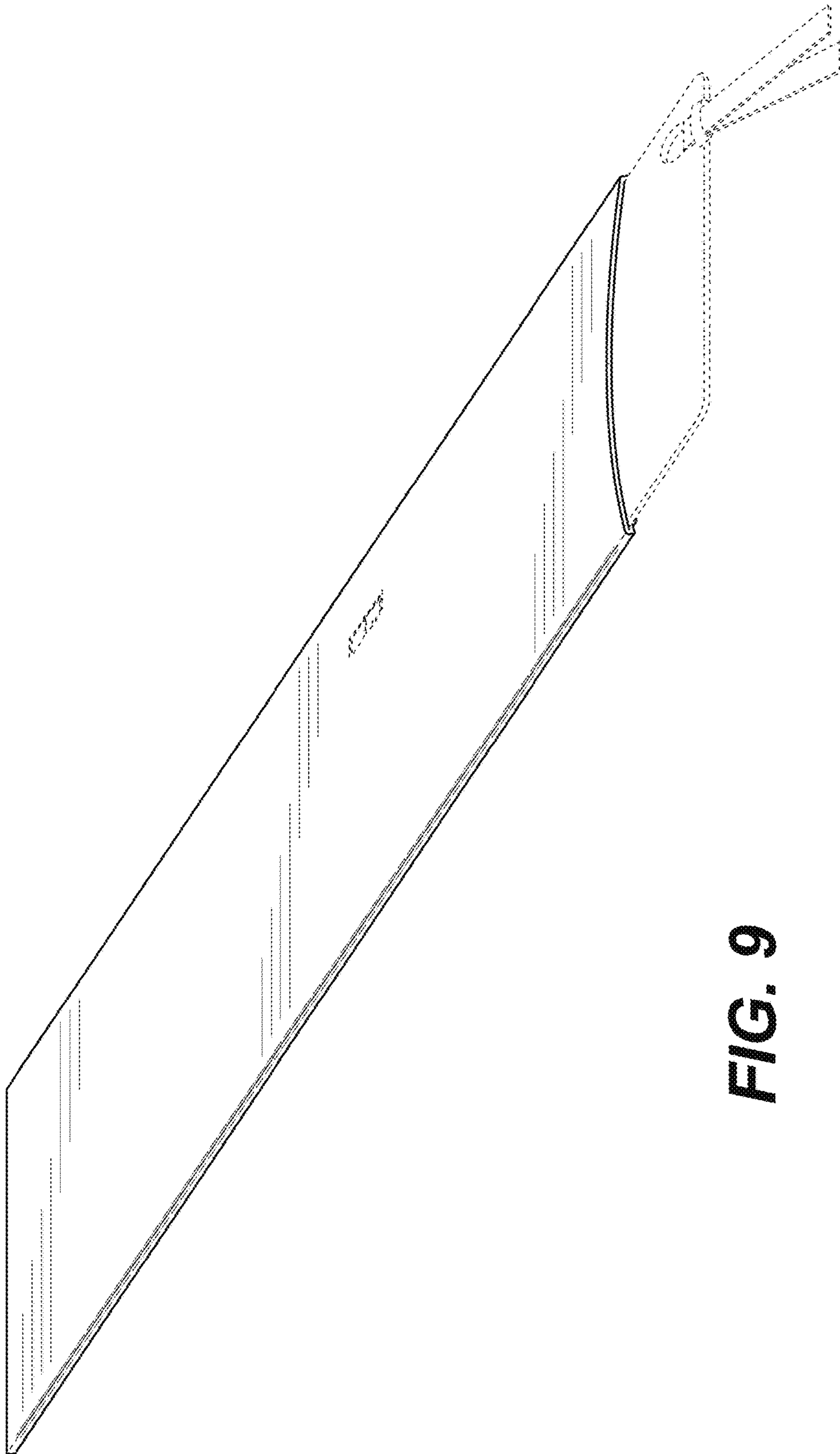

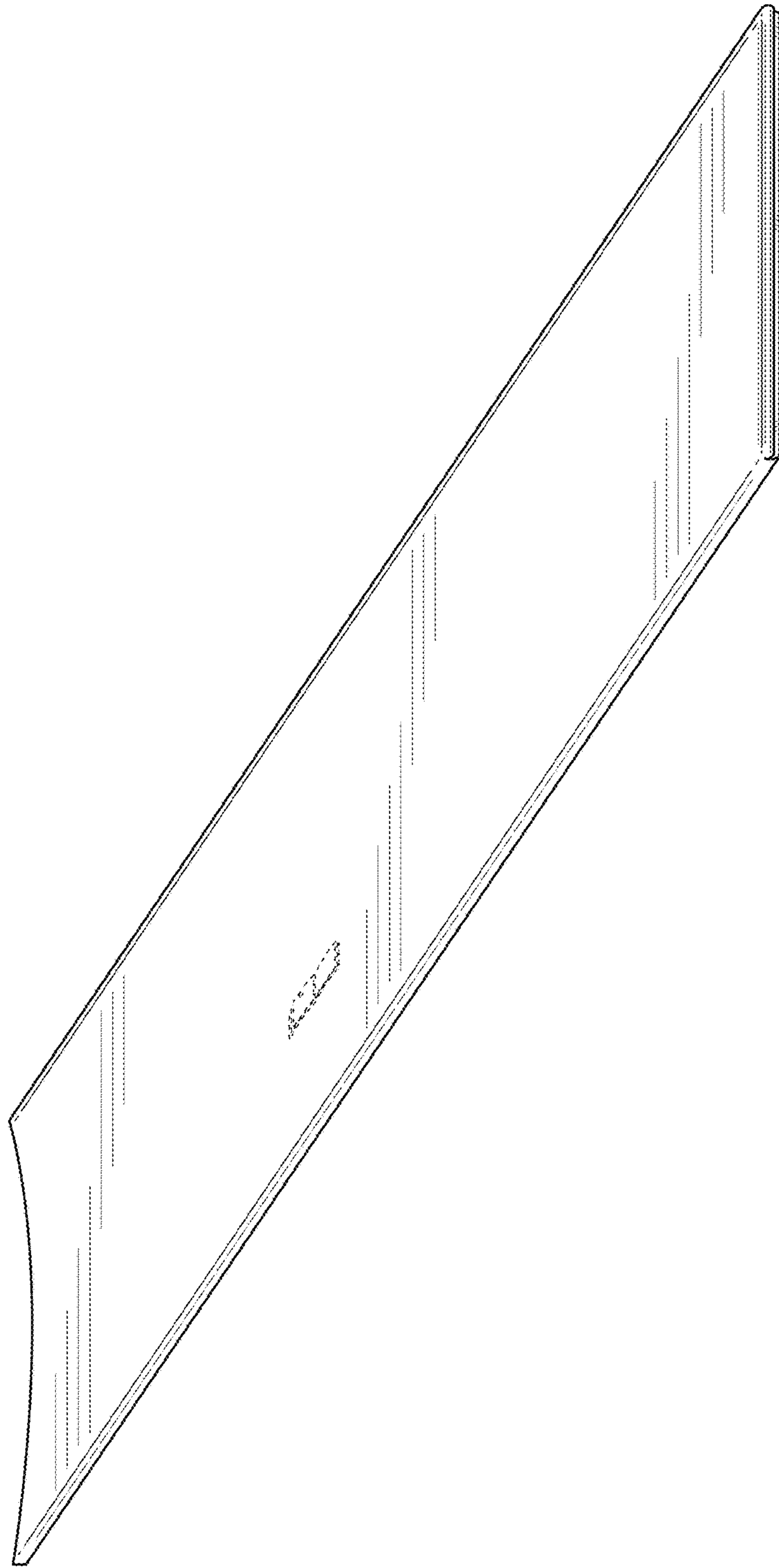

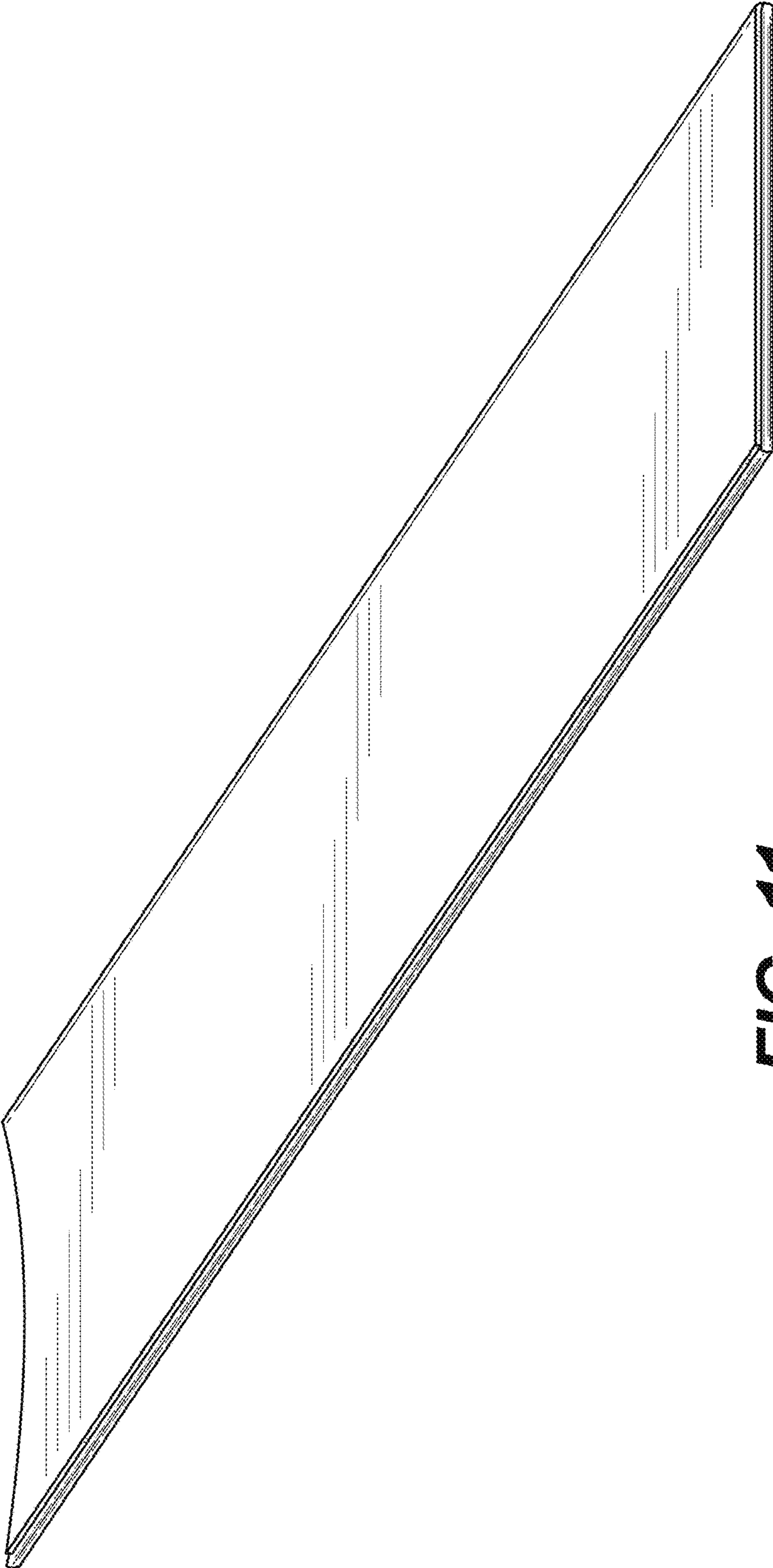




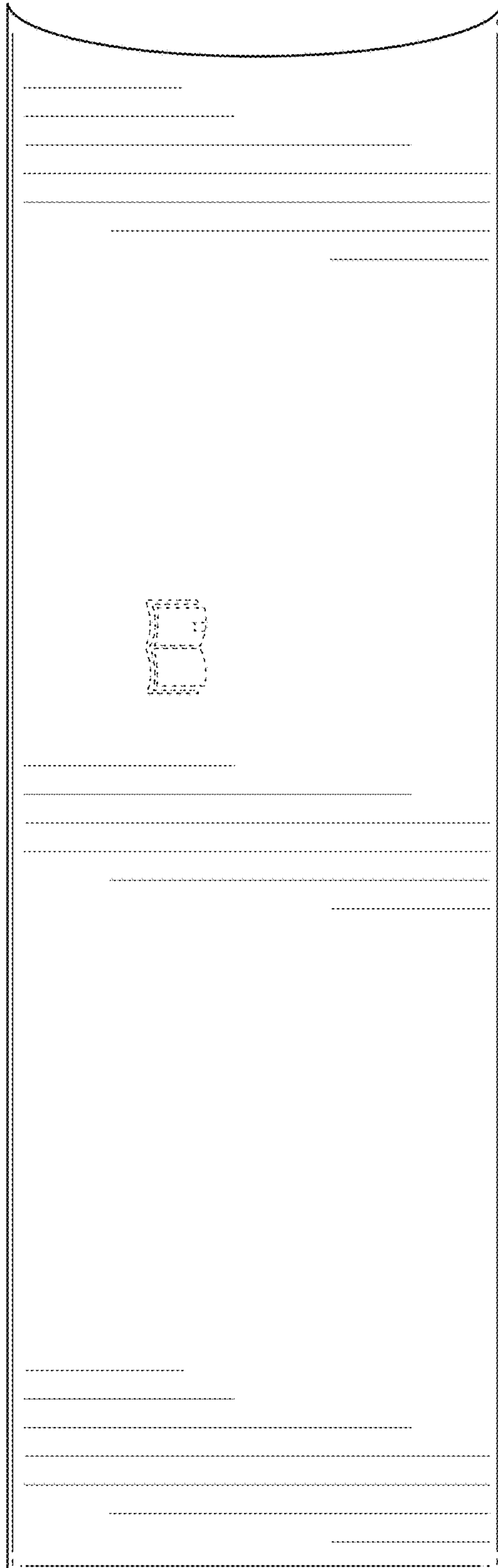

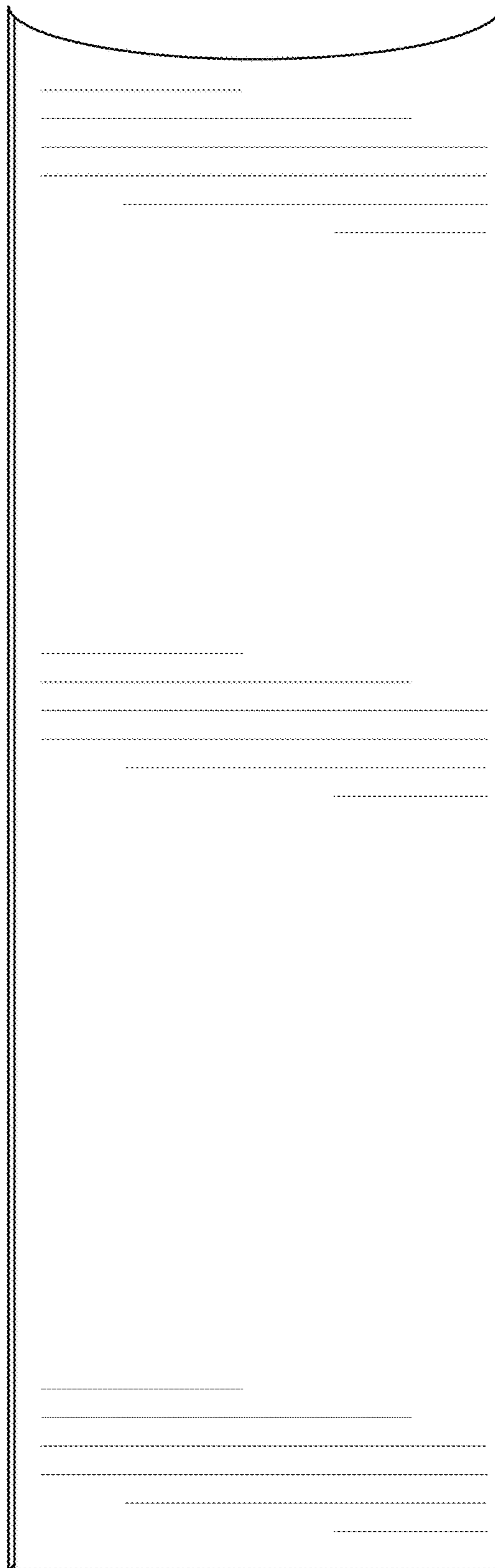

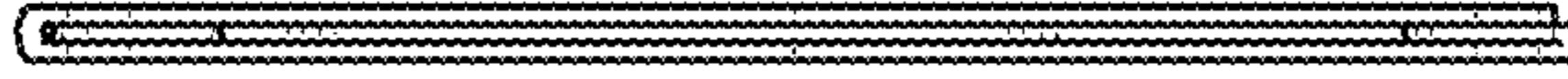

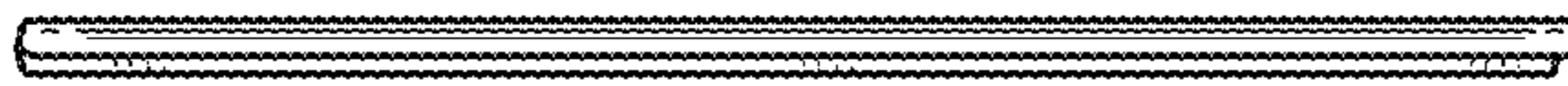
