(57) **CLAIM**

The ornamental design for a sizing guide slide display device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the sizing guide slide display device, showing our new design with the sliding card in a retracted position;

FIG. 2 is a rear view of the sizing guide slide display device of FIG. 1;

FIG. 3 is a top view of the sizing guide slide display device of FIG. 1;

FIG. 4 is a bottom view of the sizing guide slide display device of FIG. 1;

FIG. 5 is a left side view of the sizing guide slide display device of FIG. 1;

FIG. 6 is a right side view of the sizing guide slide display device of FIG. 1;

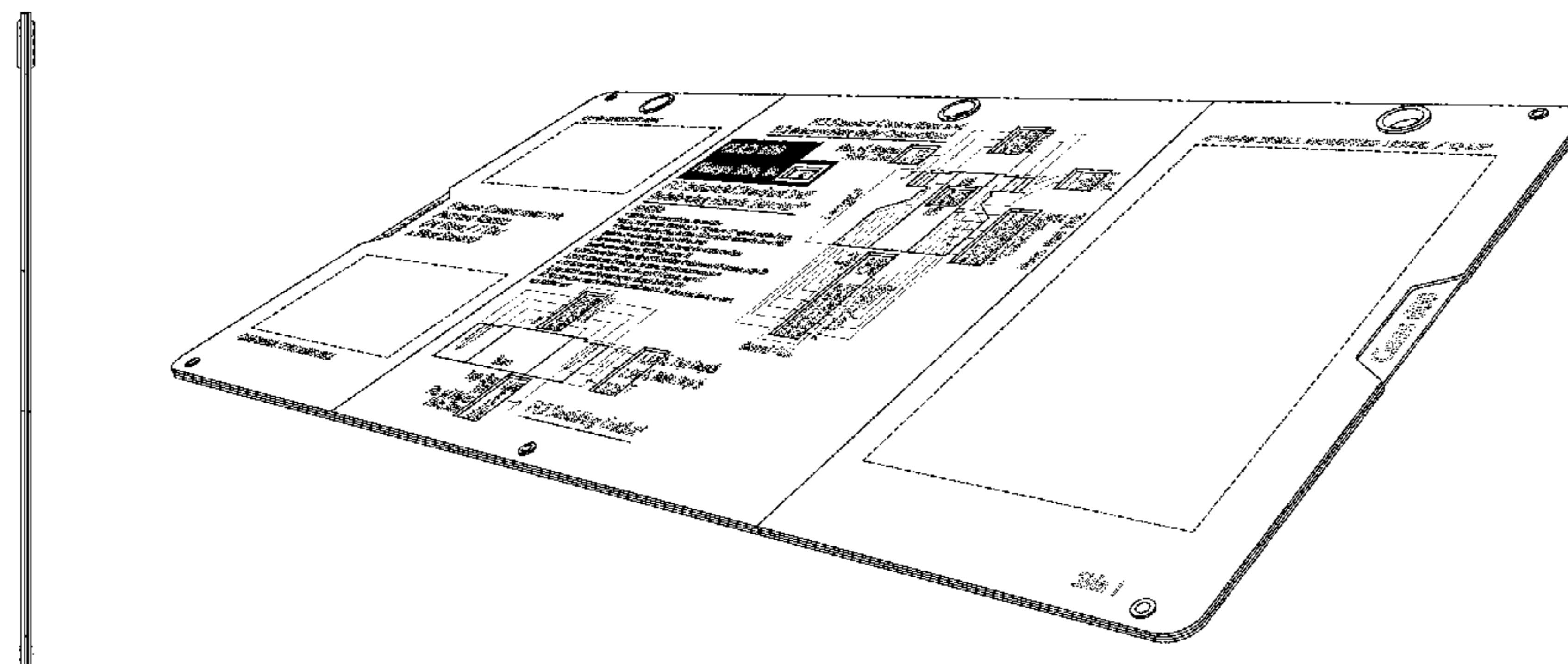
FIG. 7 is a perspective view of the sizing guide slide display device of FIG. 1;

FIG. 8 is a front view of the sizing guide slide display device, showing the sliding card in an extended position; and,

FIG. 9 is a front view of the sizing guide slide display device, showing the sliding card in another extended position.

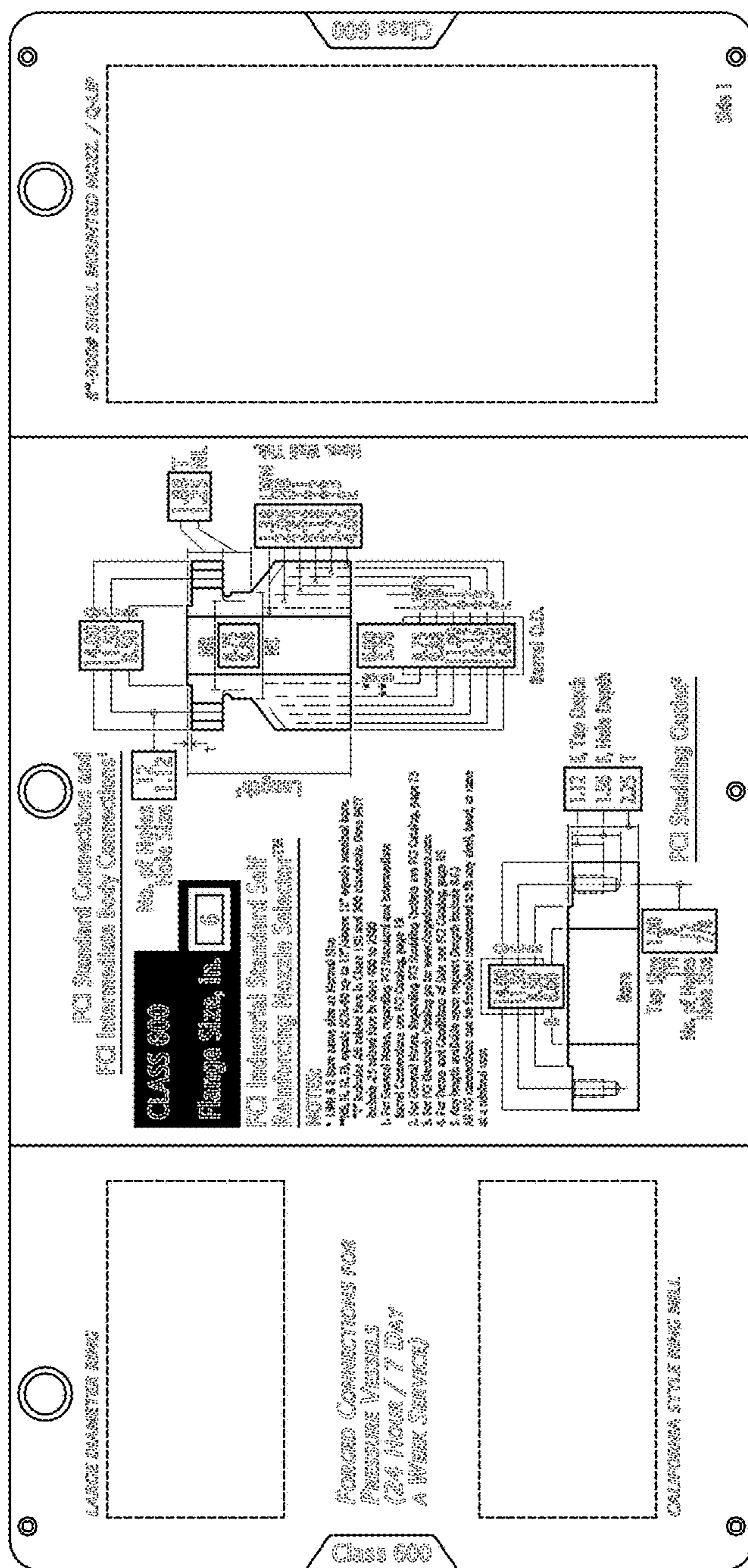

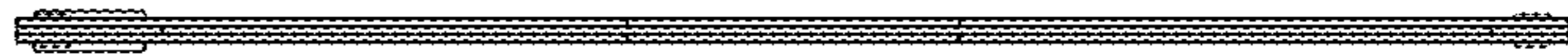




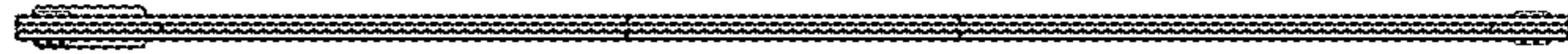

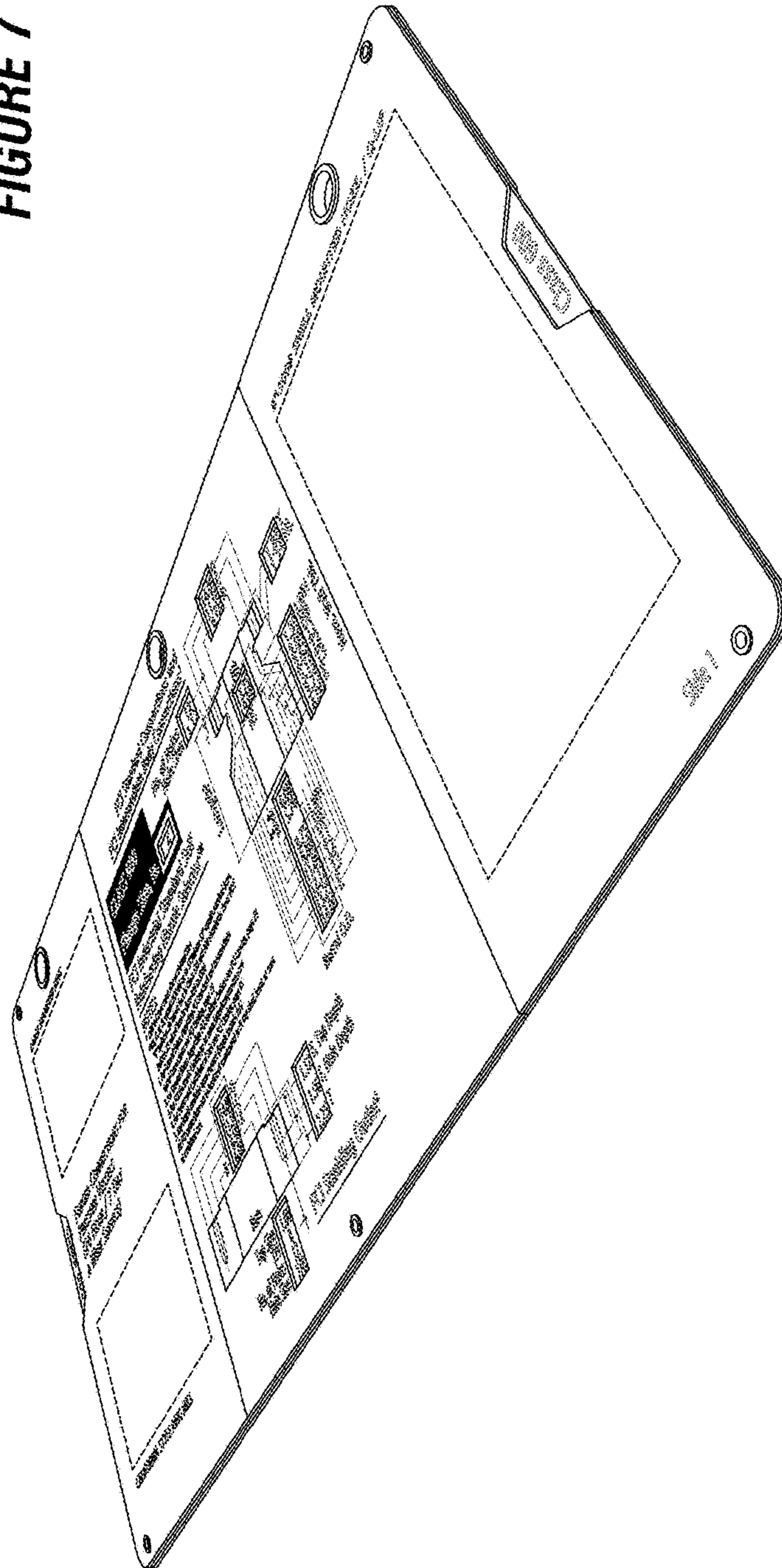

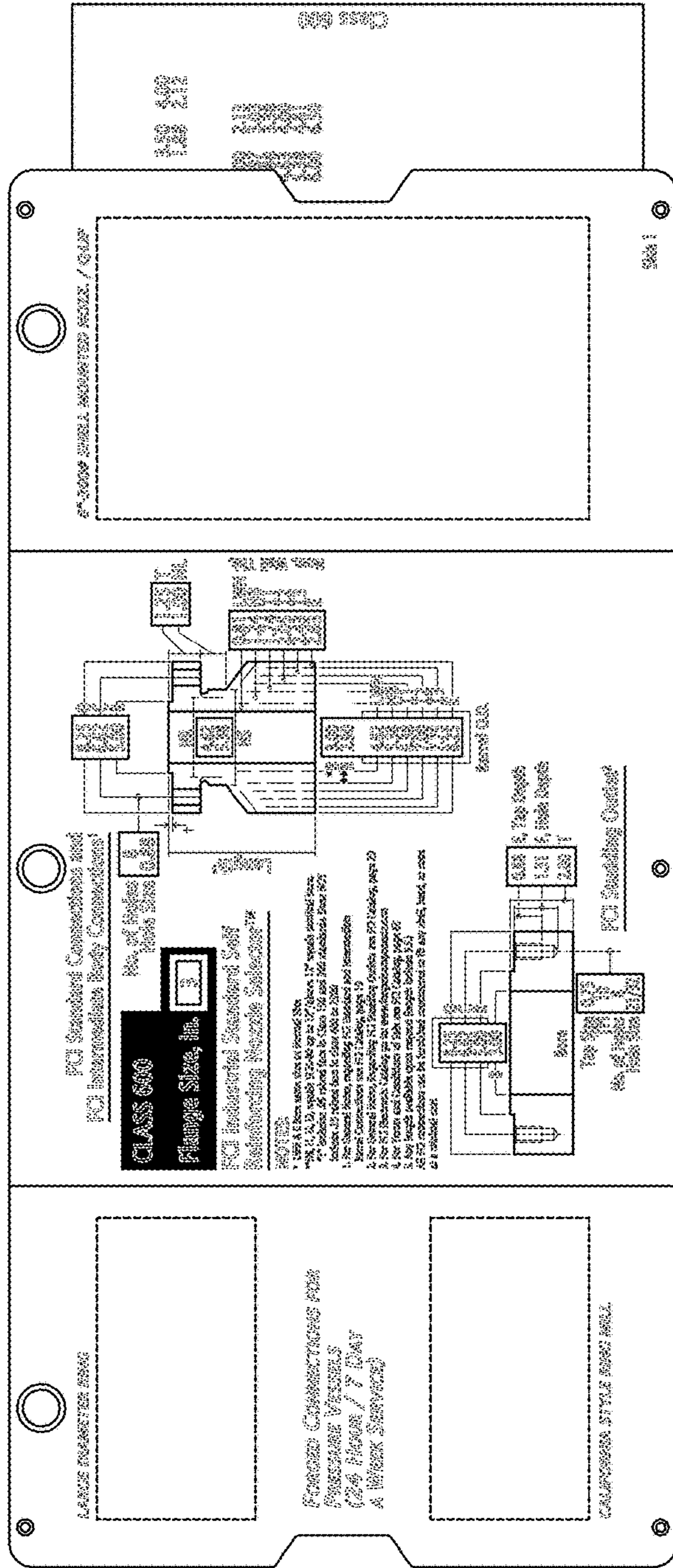

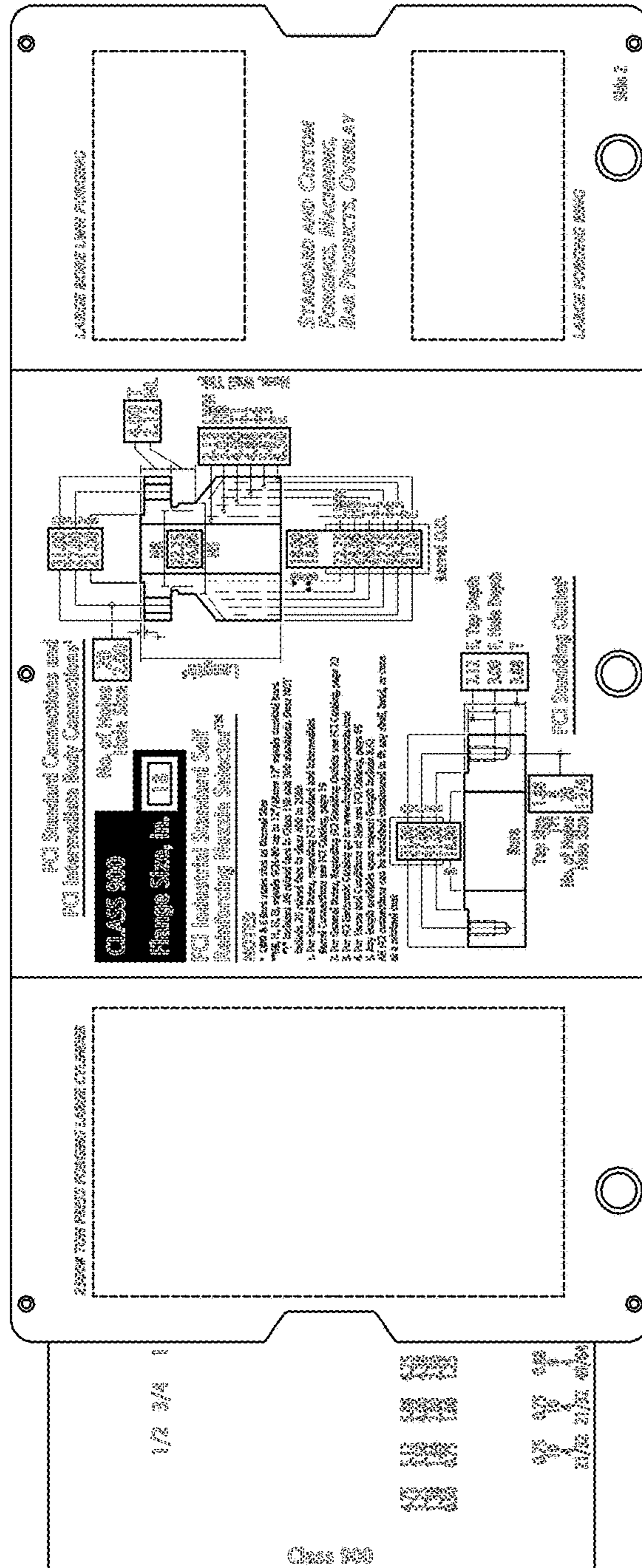
