FIG. 1 is an isometric view of a top, front, and left side of an ornamental design for a sport display in a deployed manner of use;
FIG. 2 is a front elevational view of the sport display of FIG. 1;
FIG. 3 is a rear elevational view of the sport display of FIG. 1;
FIG. 4 is a left side elevational view of the sport display of FIG. 1;
FIG. 5 is a right side elevational view of the sport display of FIG. 1;
FIG. 6 is a top plan view of the sport display of FIG. 1;
FIG. 7 is a bottom plan view of the sport display of FIG. 1;
FIG. 8 is an isometric view of a top, front, and left side of the sport display of FIG. 1 in a folded manner of use;
FIG. 9 is a left side elevational view of the sport display of FIG. 8;
FIG. 10 is a right side elevational view of the sport display of FIG. 8;
FIG. 11 is a top plan view of the sport display of FIG. 8;
FIG. 12 is a bottom plan view of the sport display of FIG. 8;
FIG. 13 is a front elevational view of the sport display of FIG. 8; and,
FIG. 14 is a rear elevational view of the sport display of FIG. 8. The dashed lines are for the purpose of illustrating portions of the sport display that form no part of the claimed design.

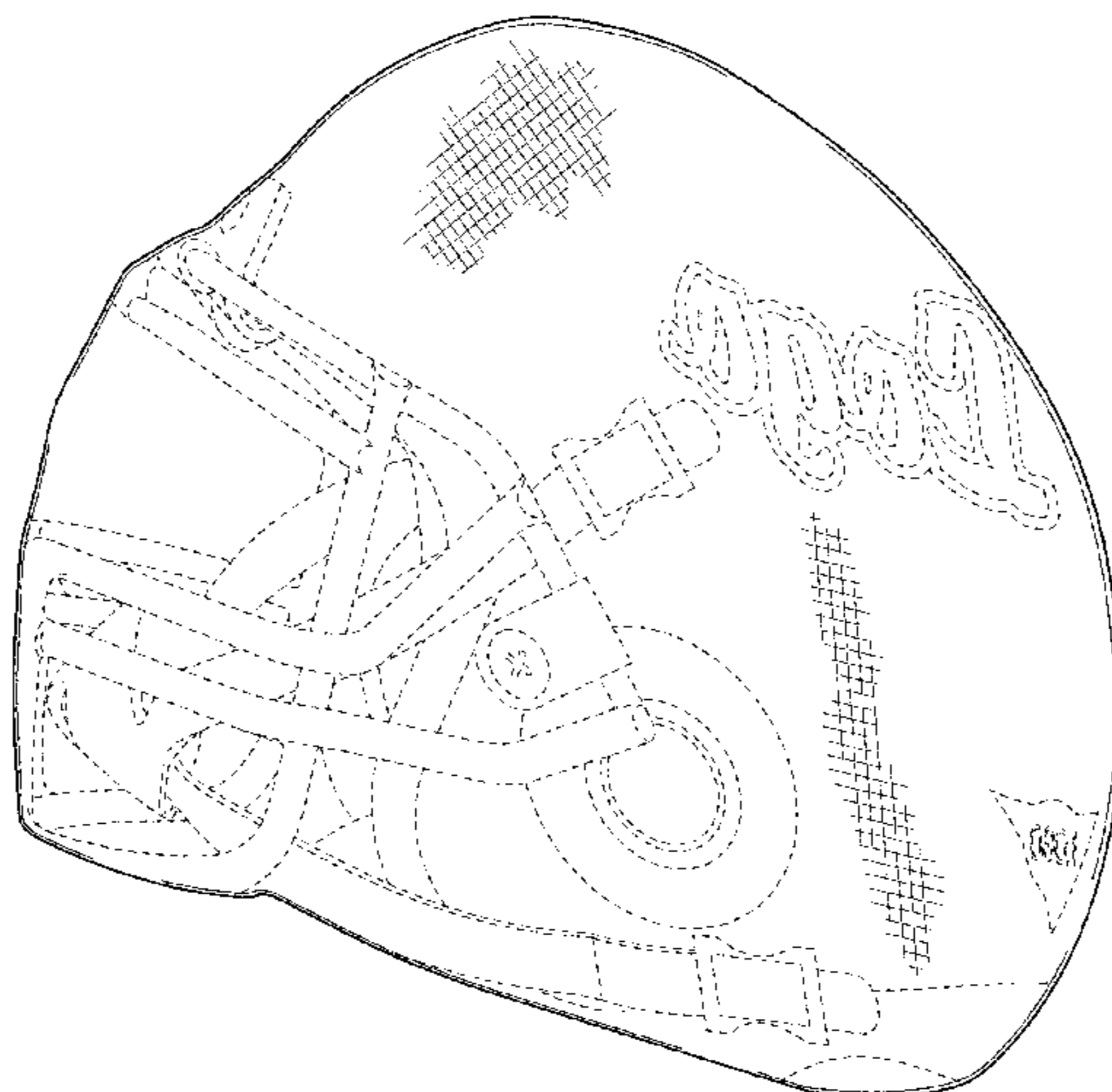

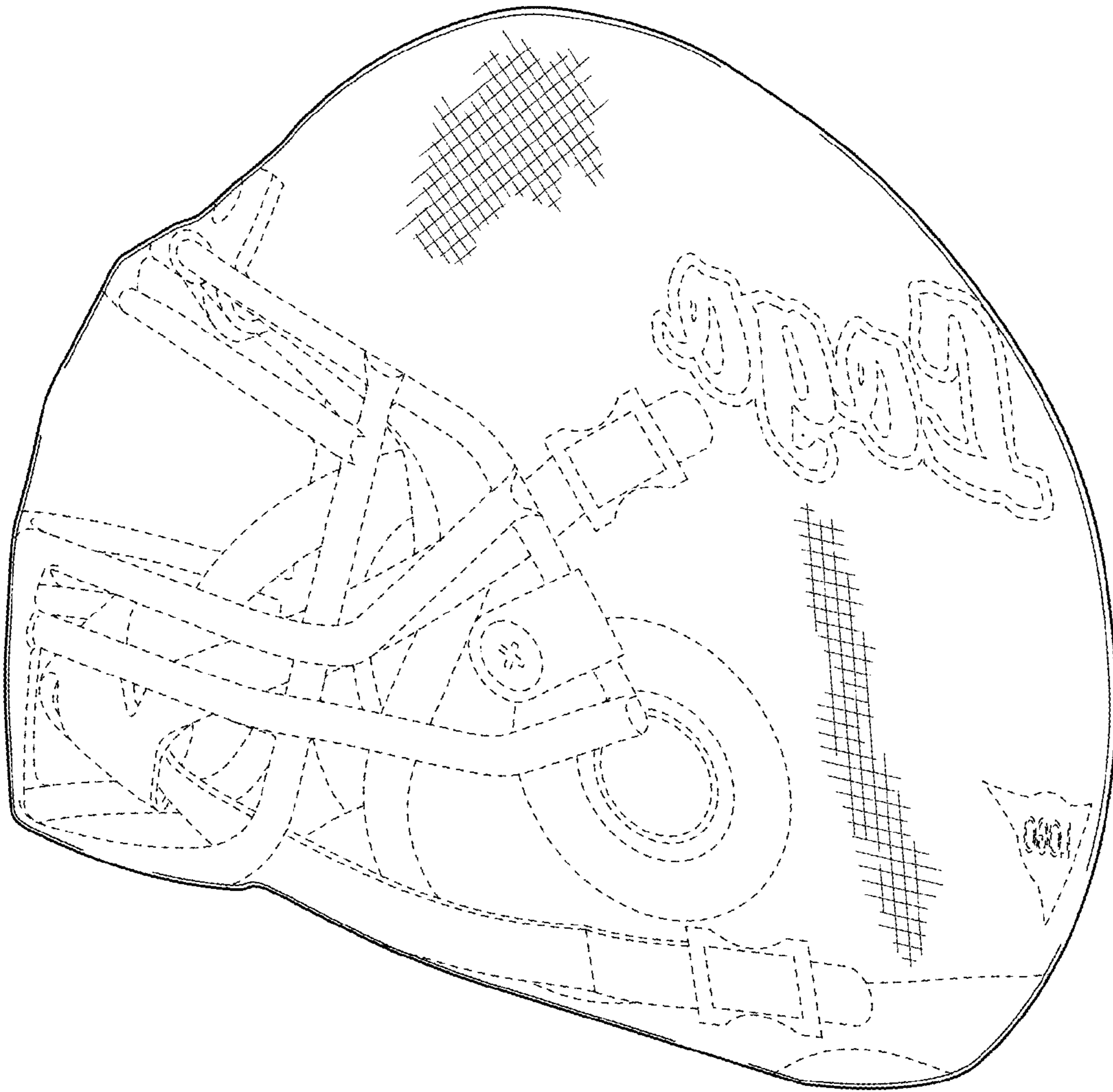

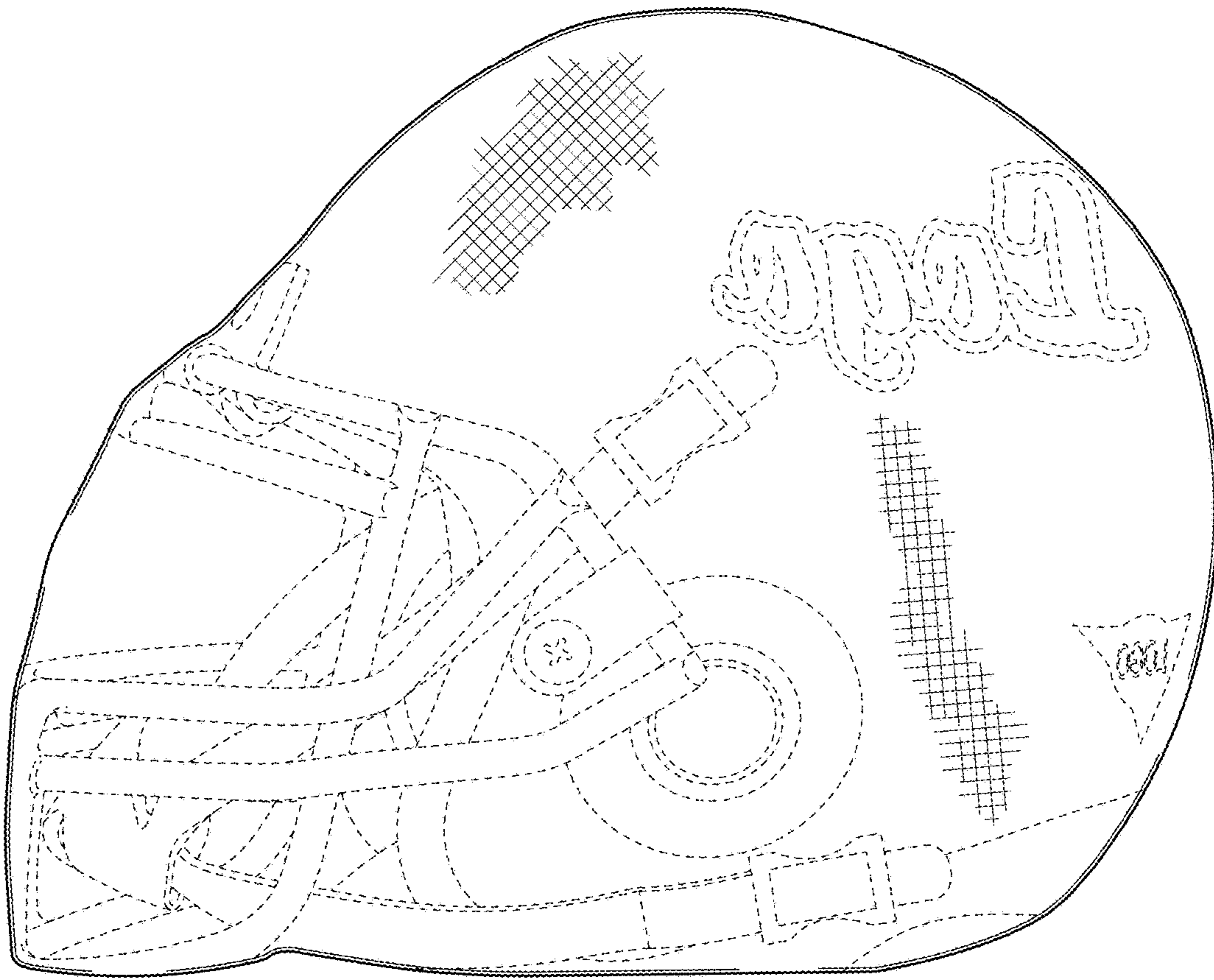

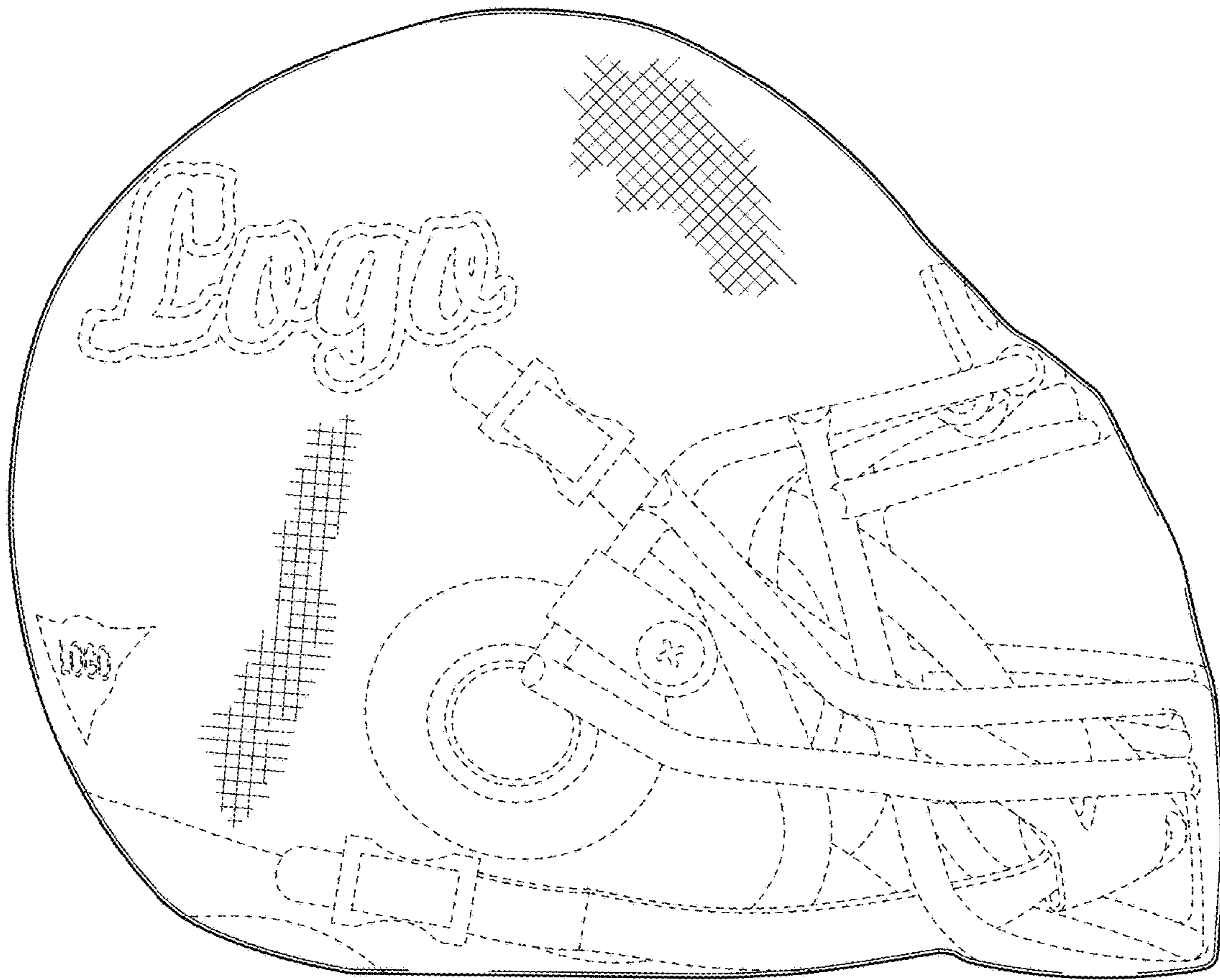

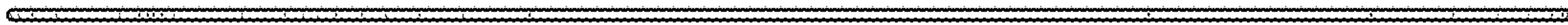

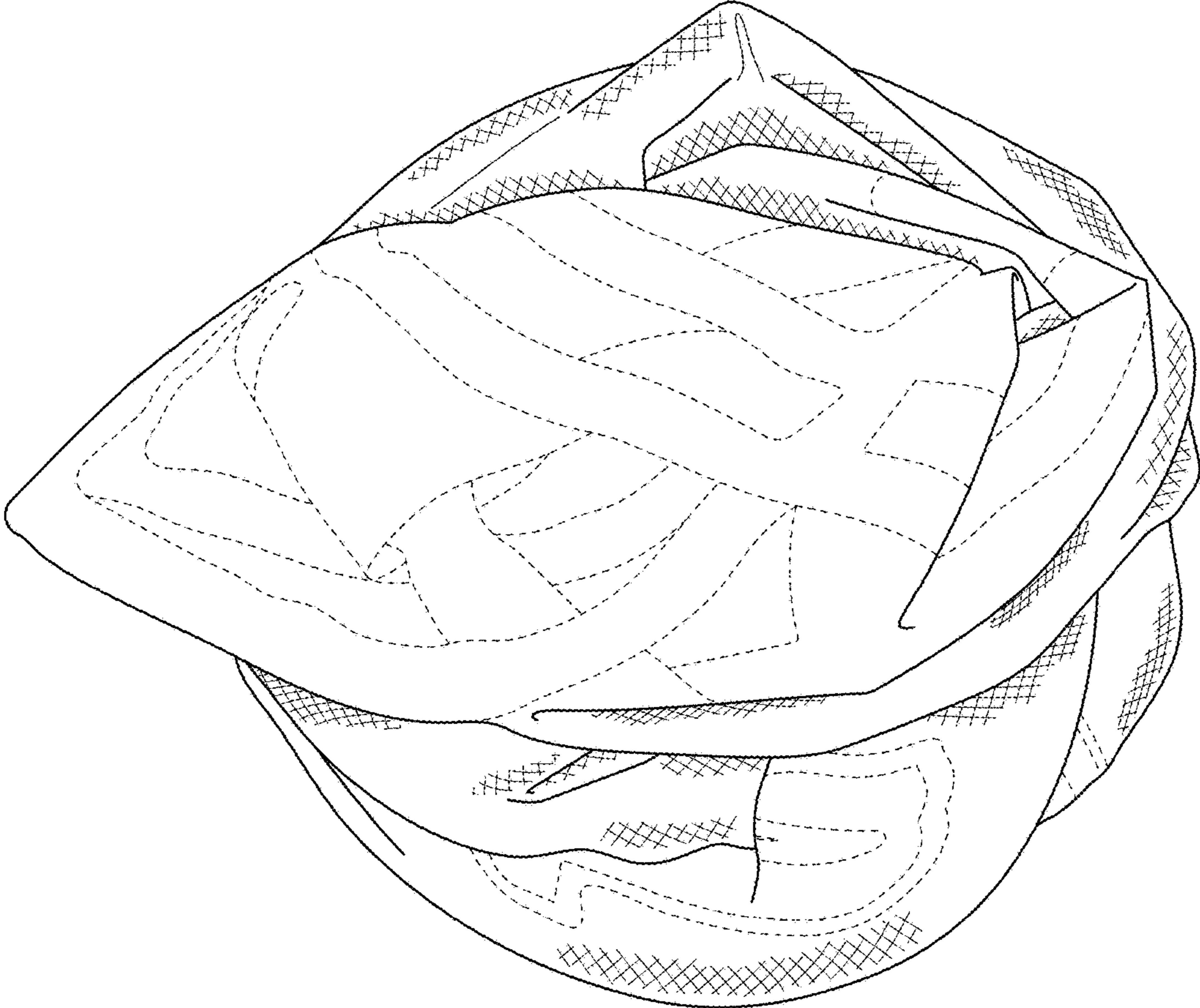

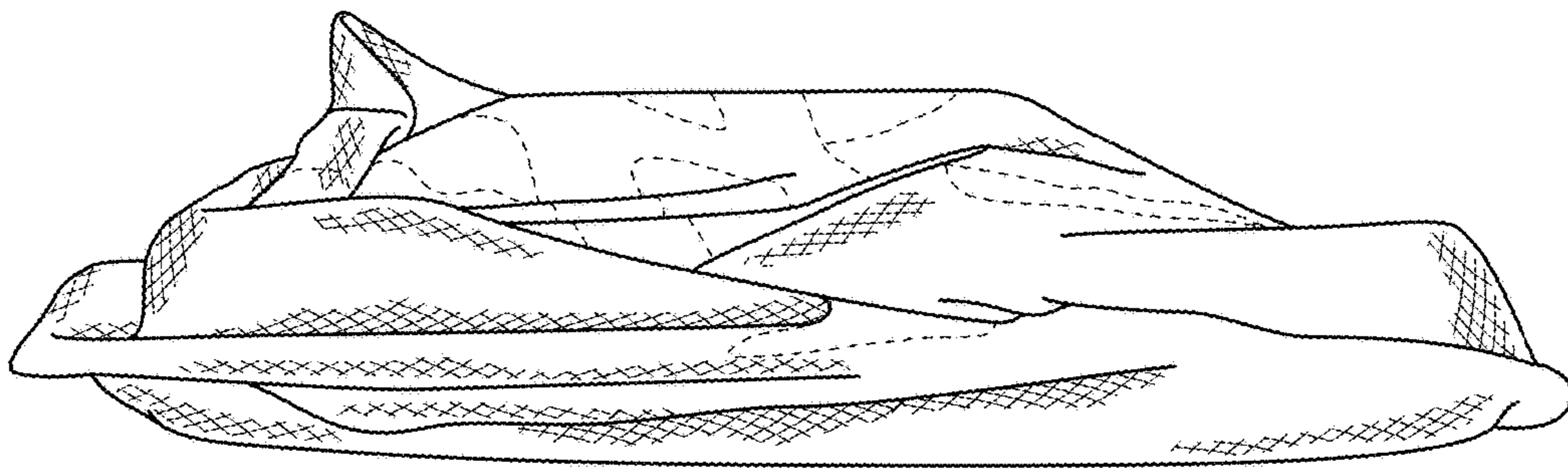

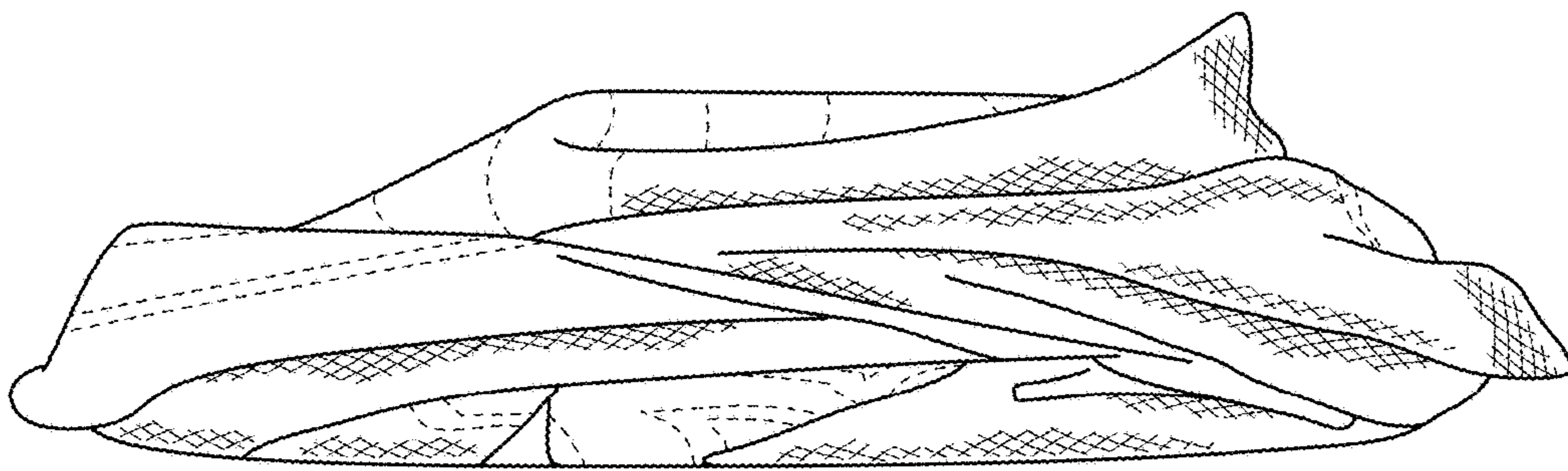

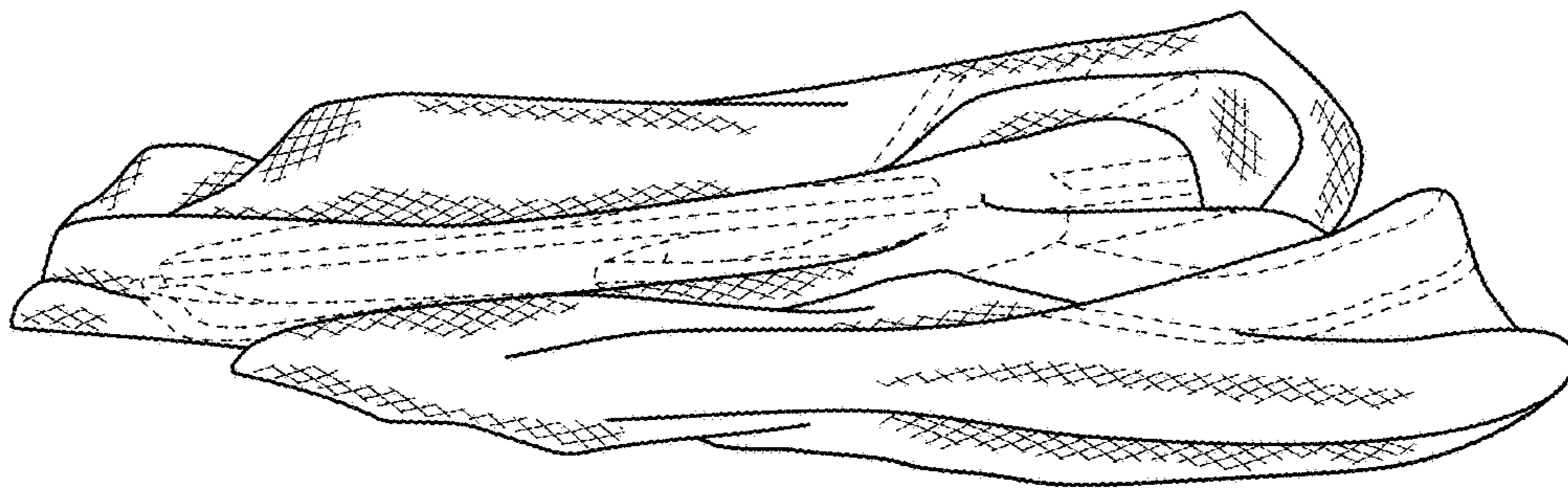

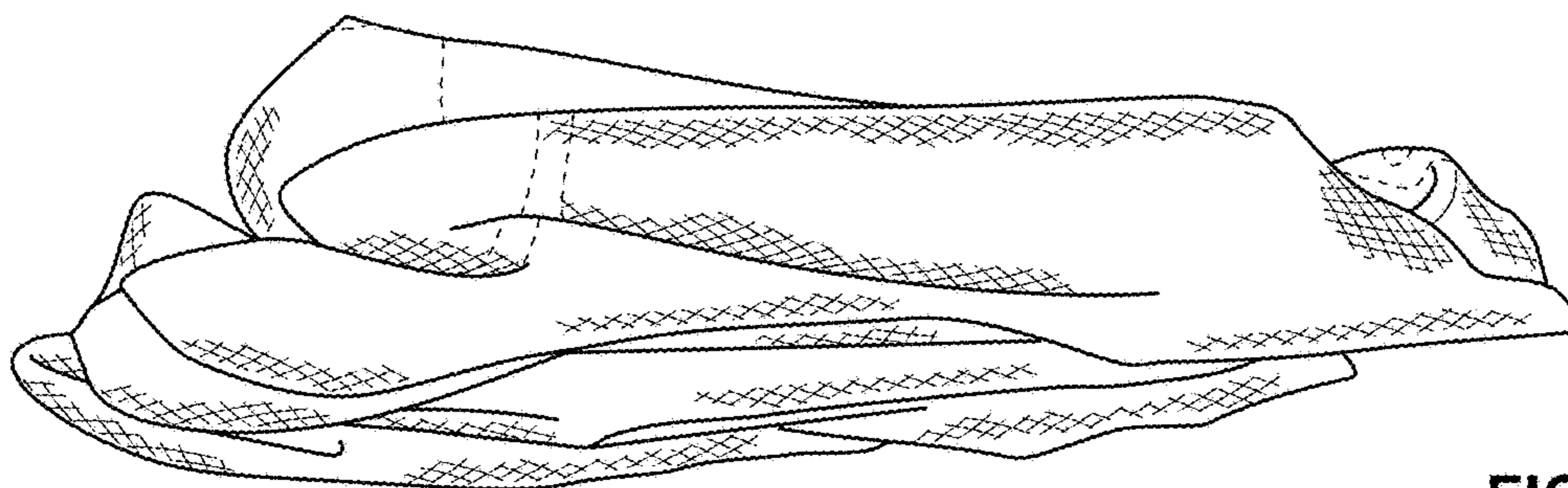

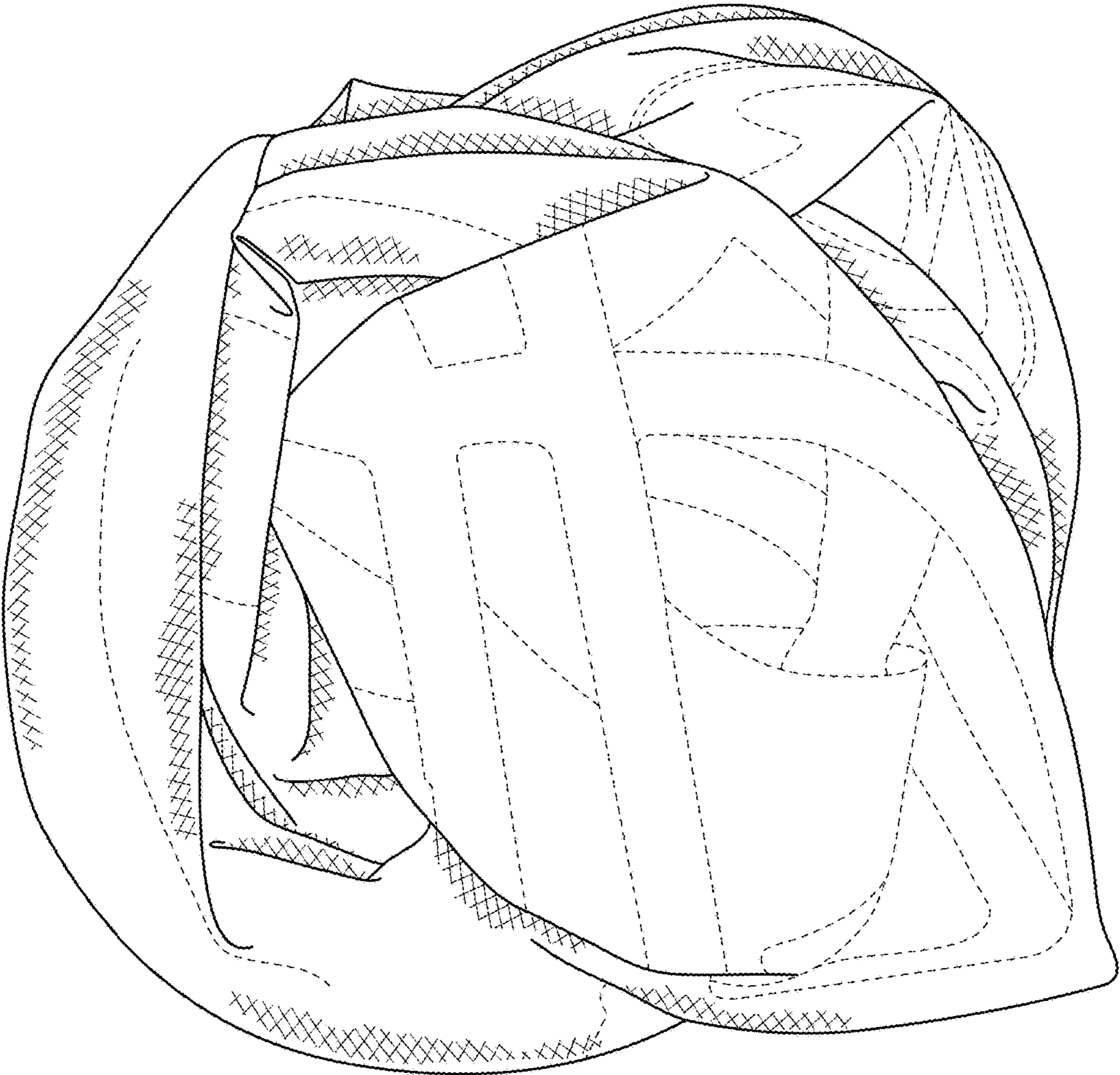

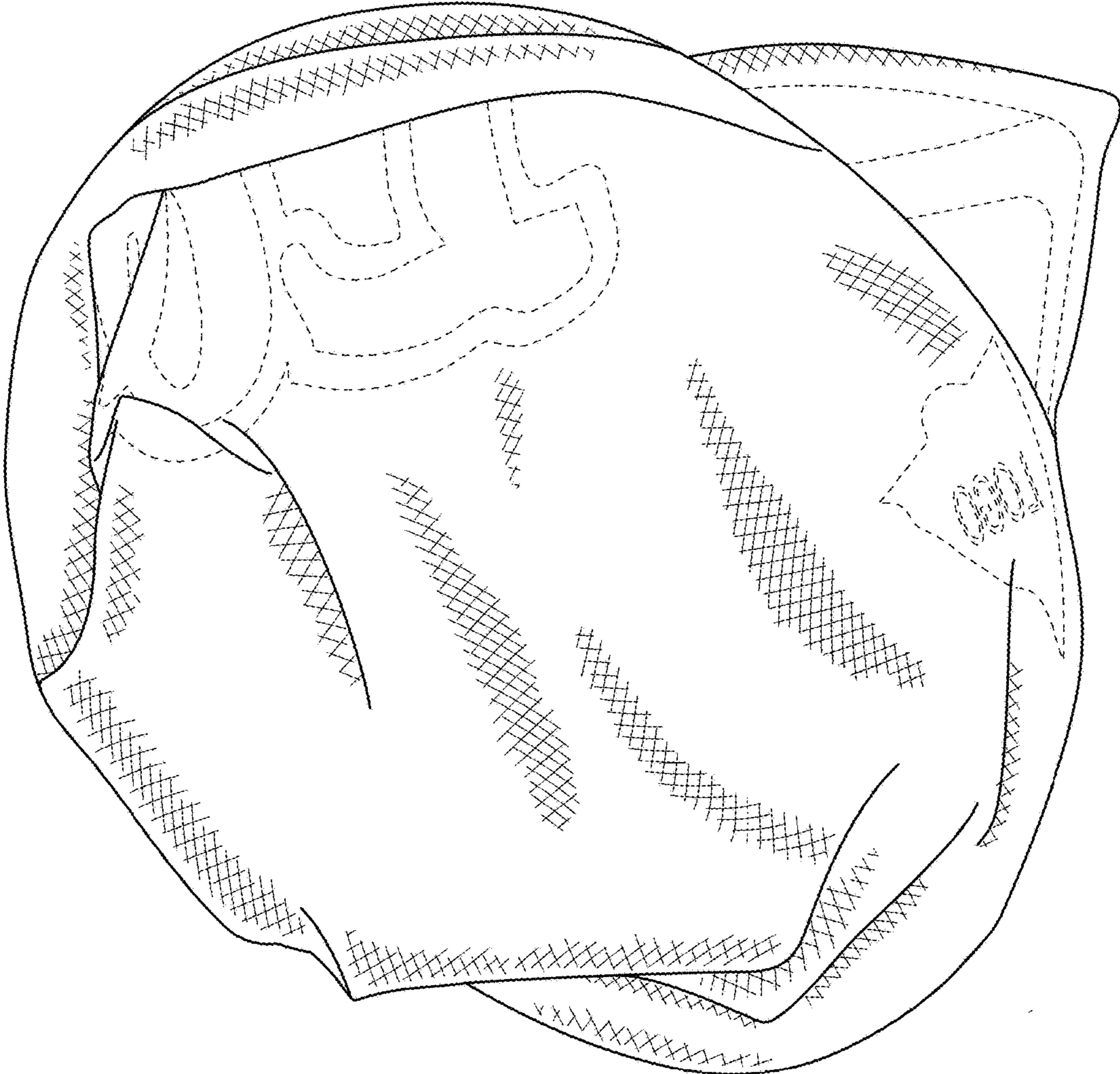
