The ornamental design for a buoyancy aid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a buoyancy aid, showing my new design;
FIG. 2 is a front elevational view of a buoyancy aid;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines on the buoyancy aid represent stitching and form part of the claimed design.

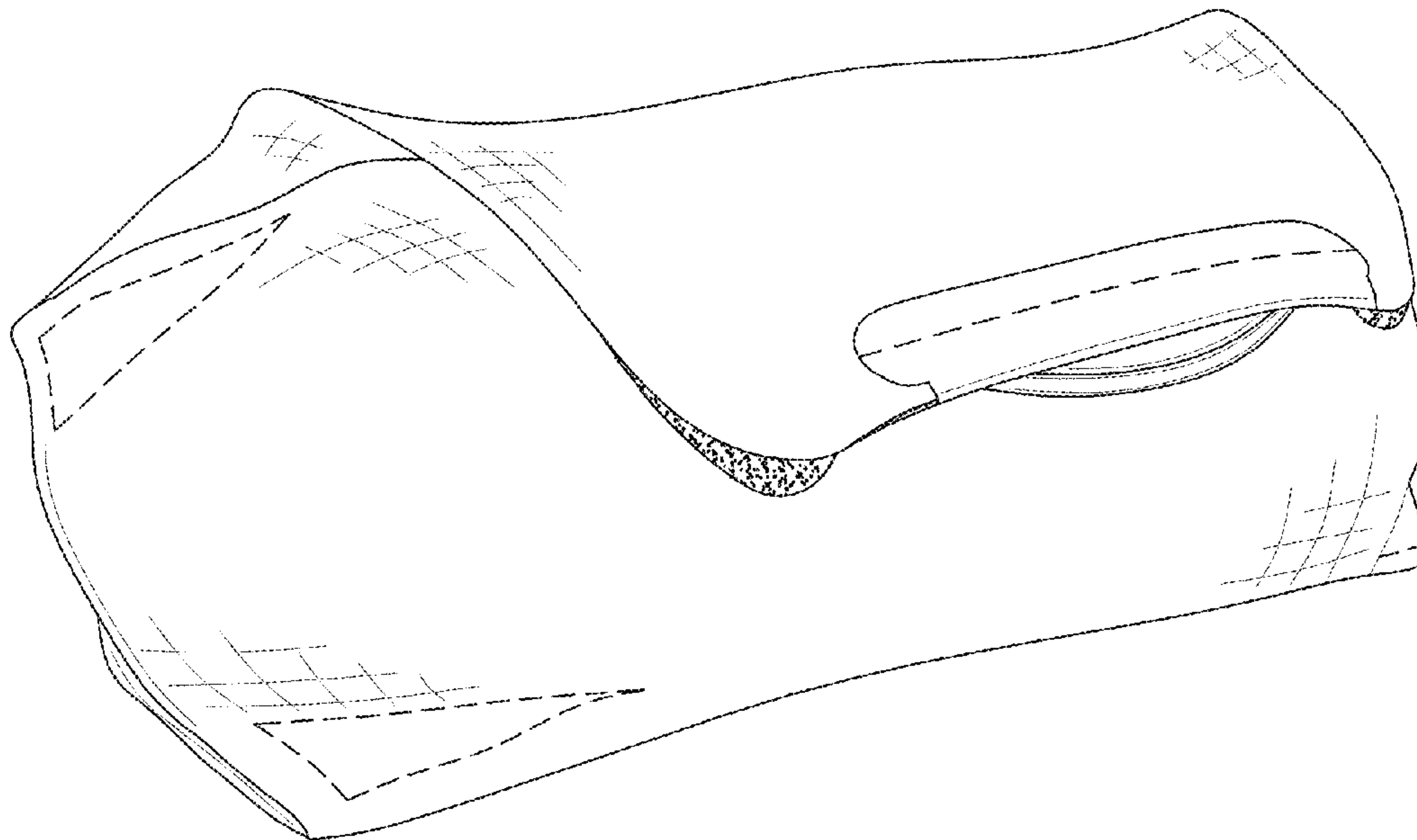

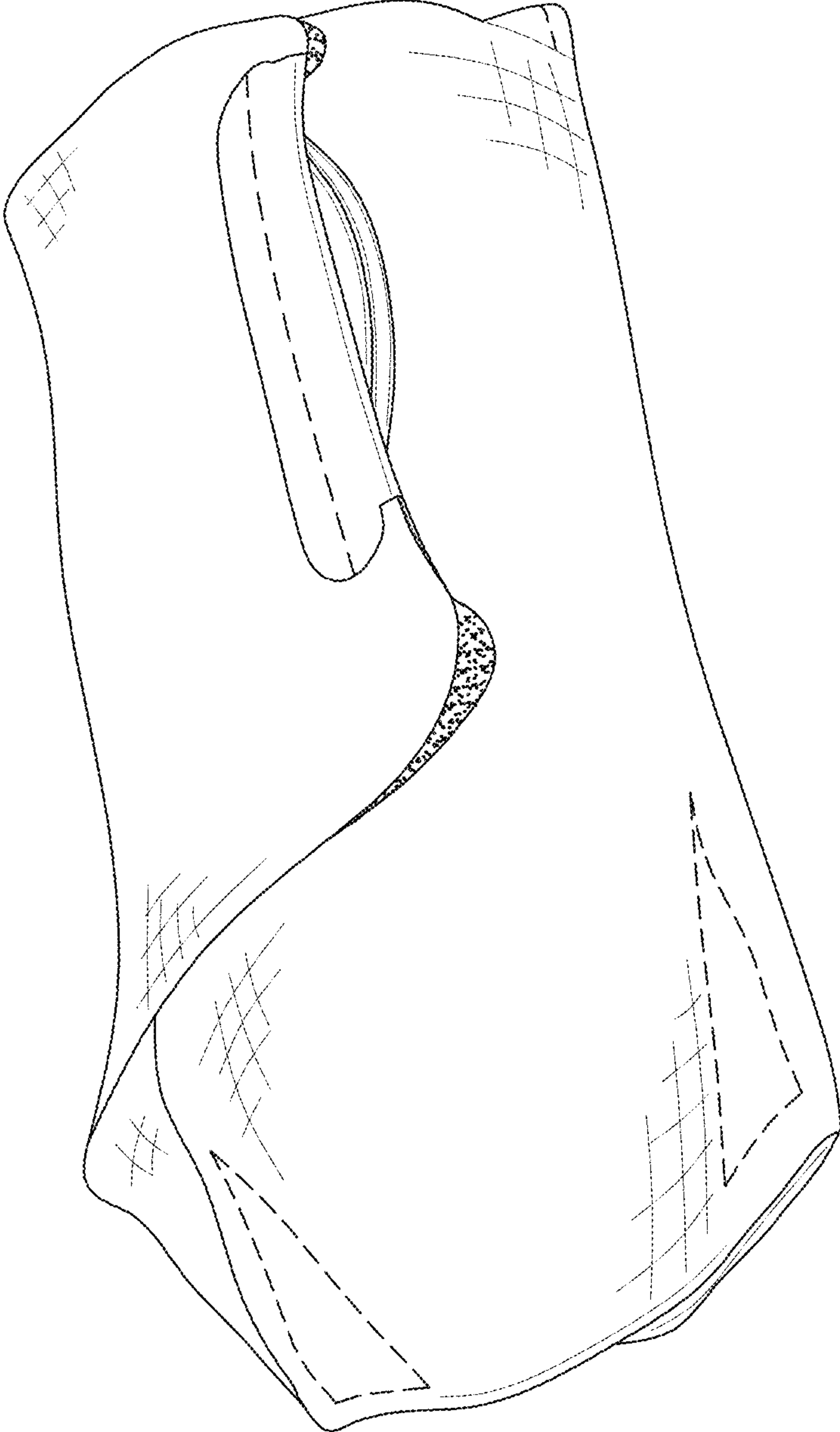

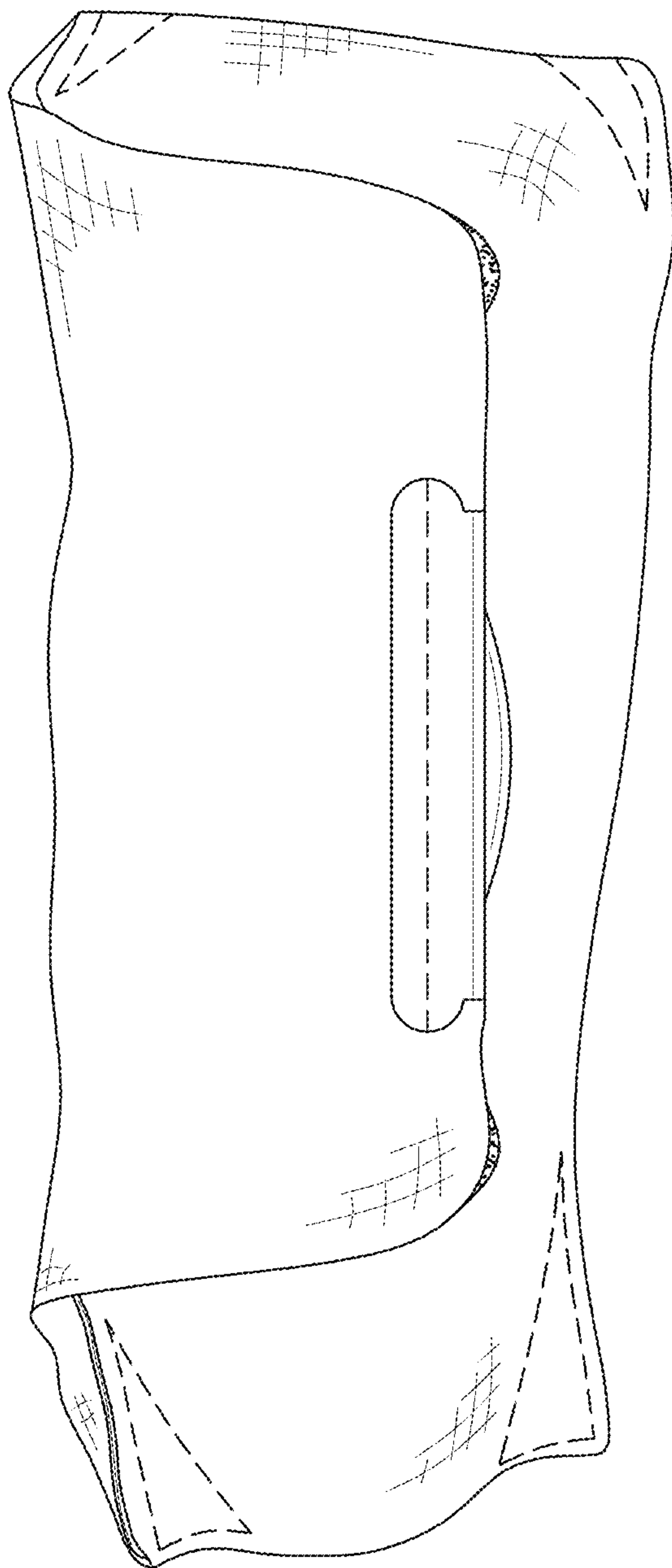

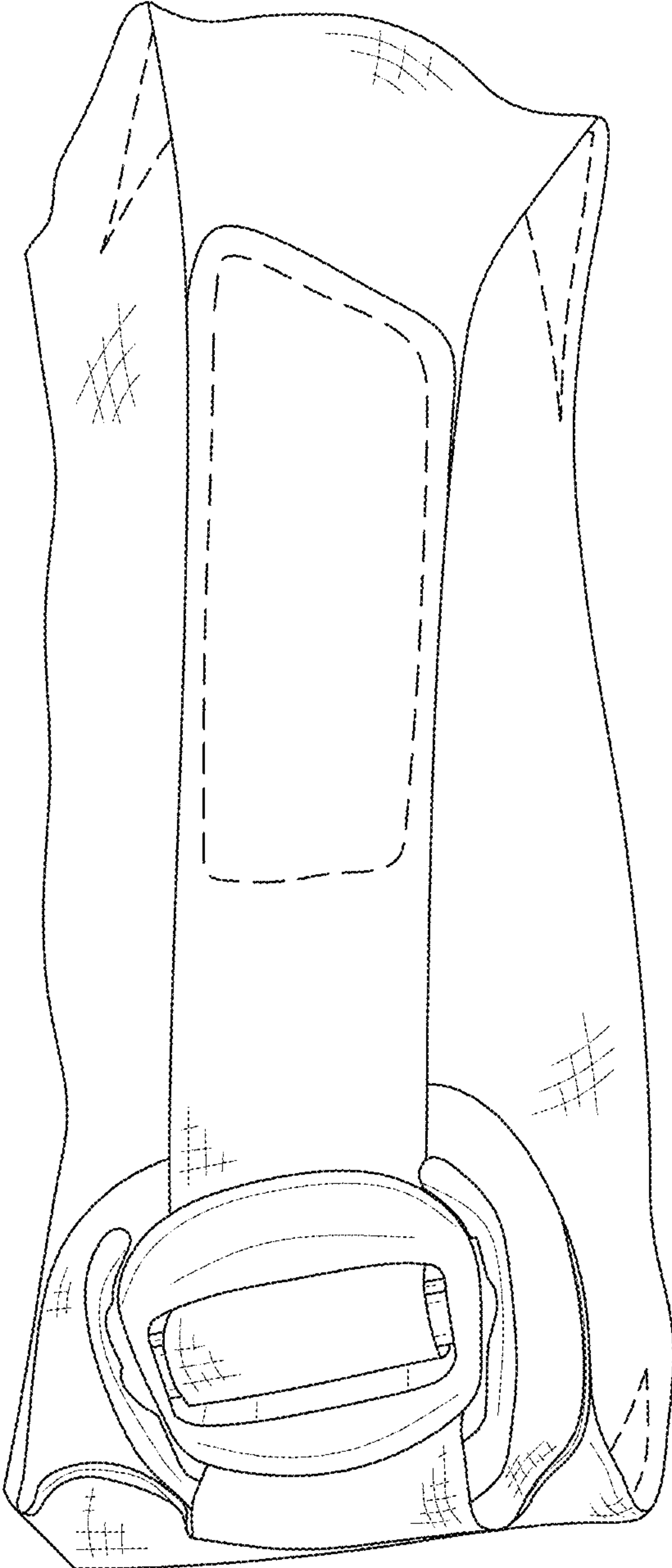

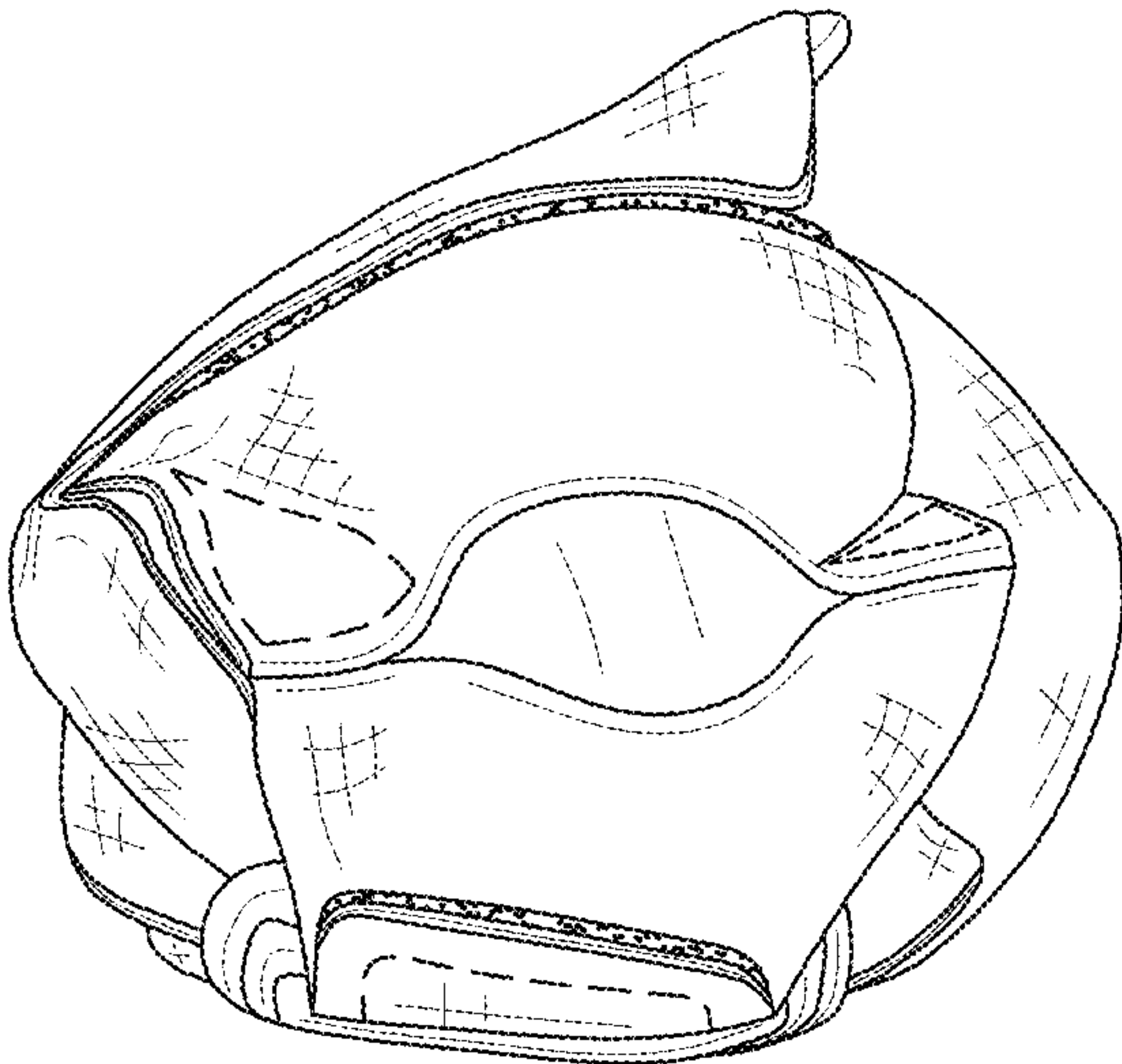

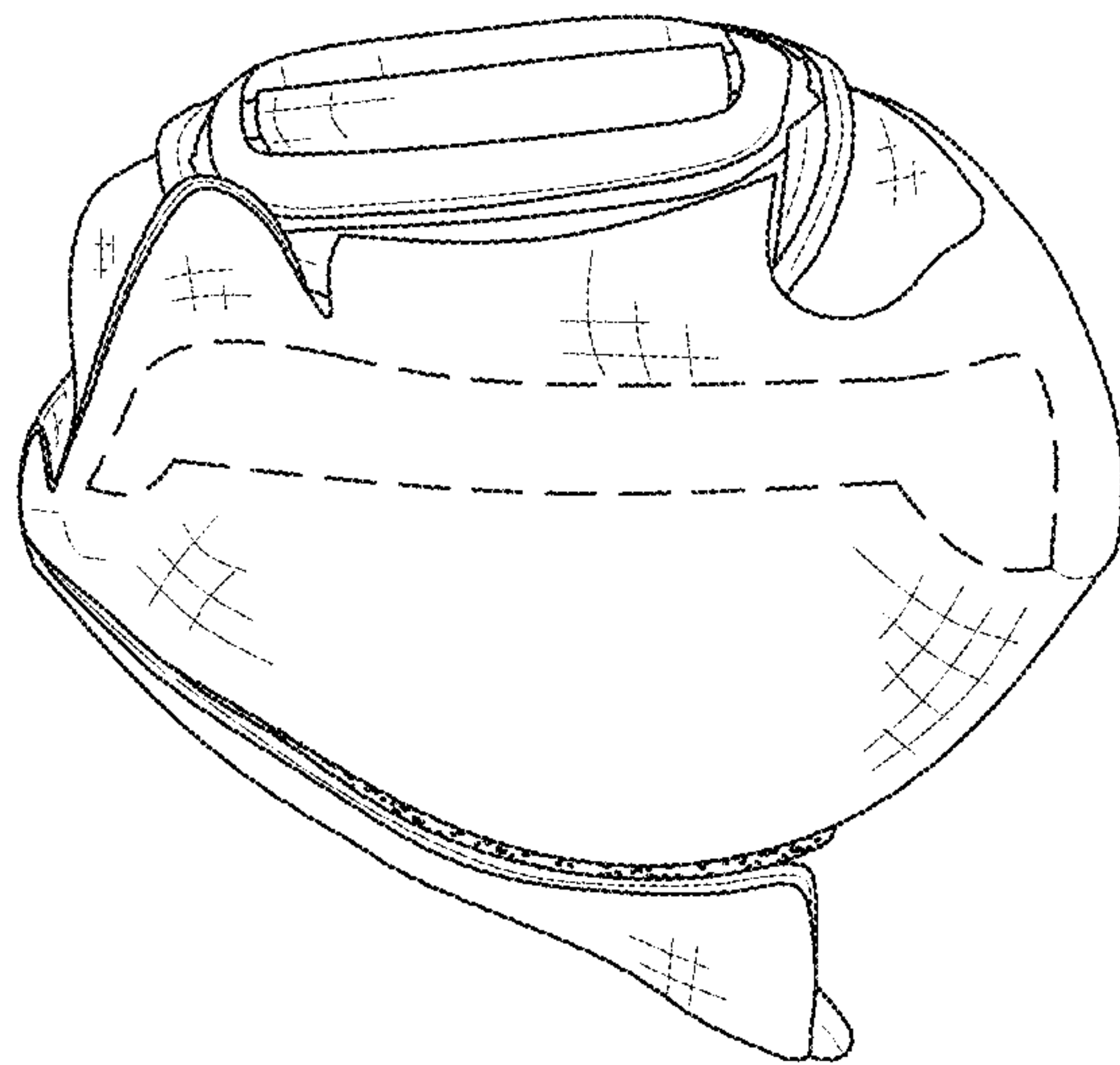

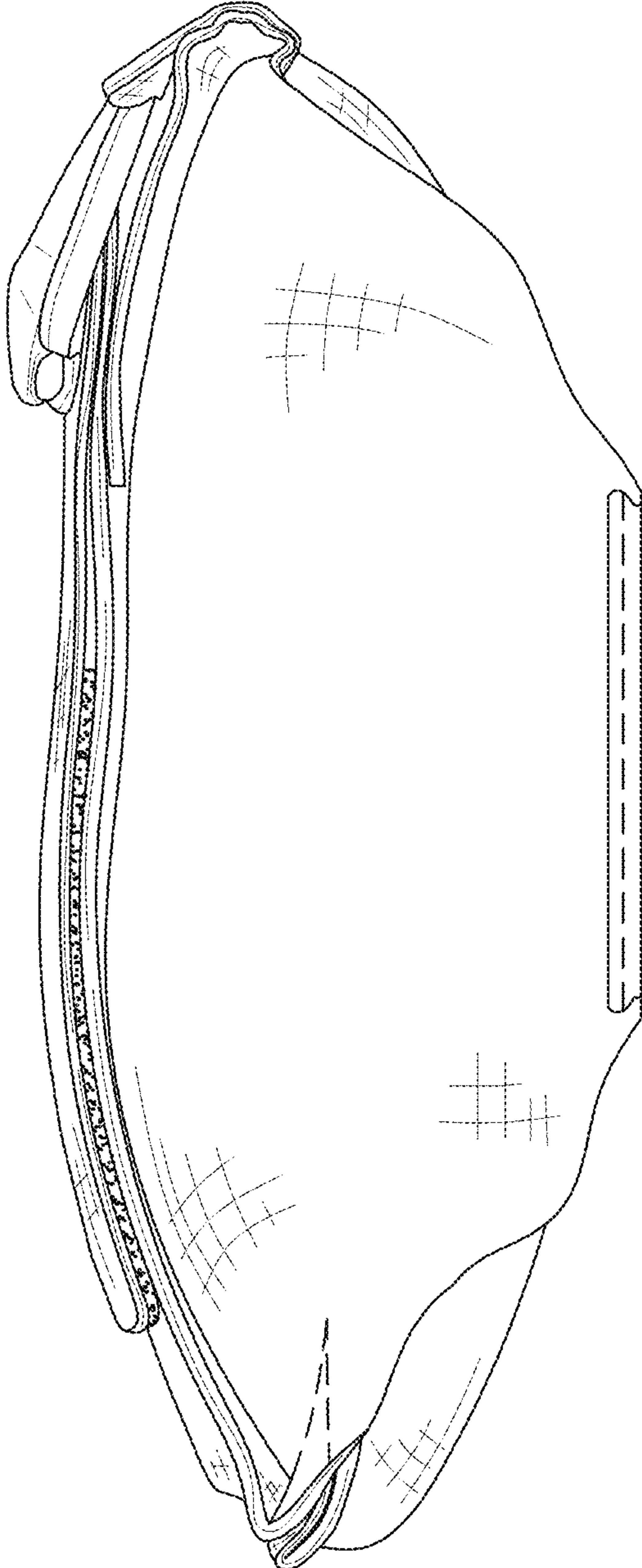

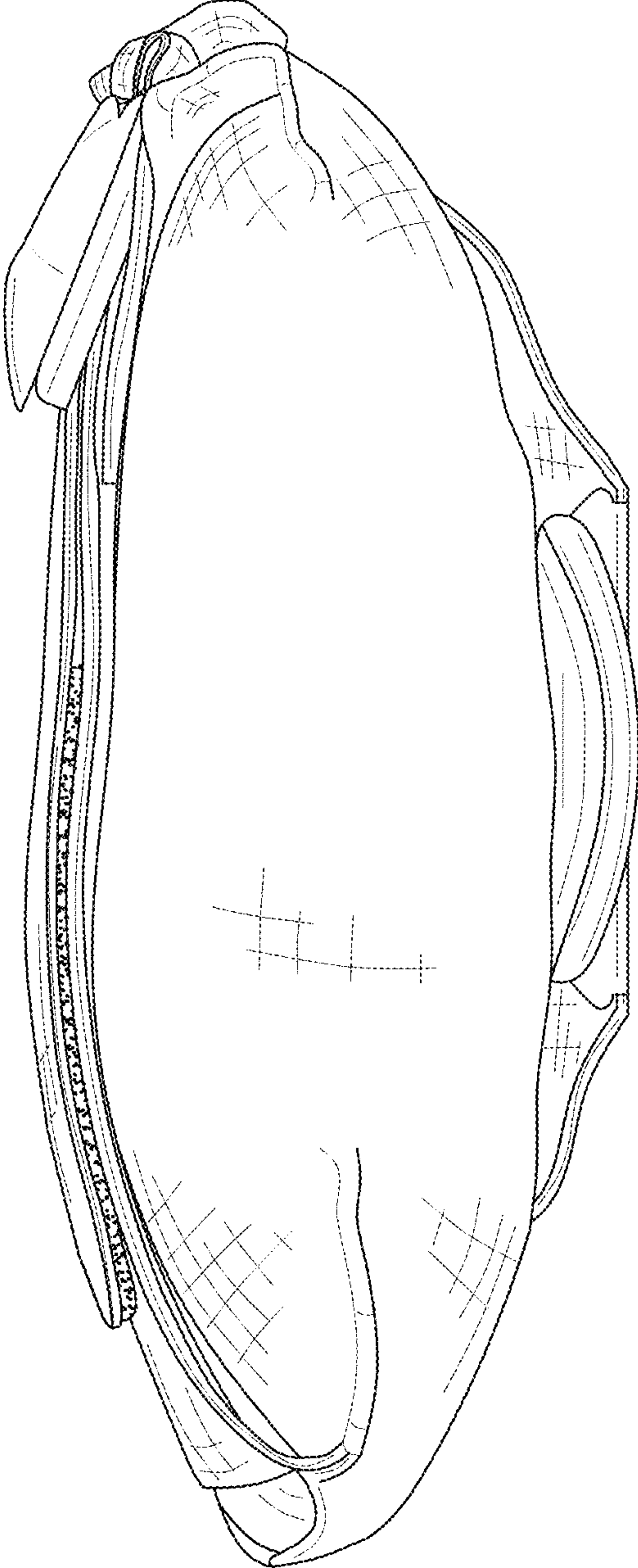
