DESCRIPTION

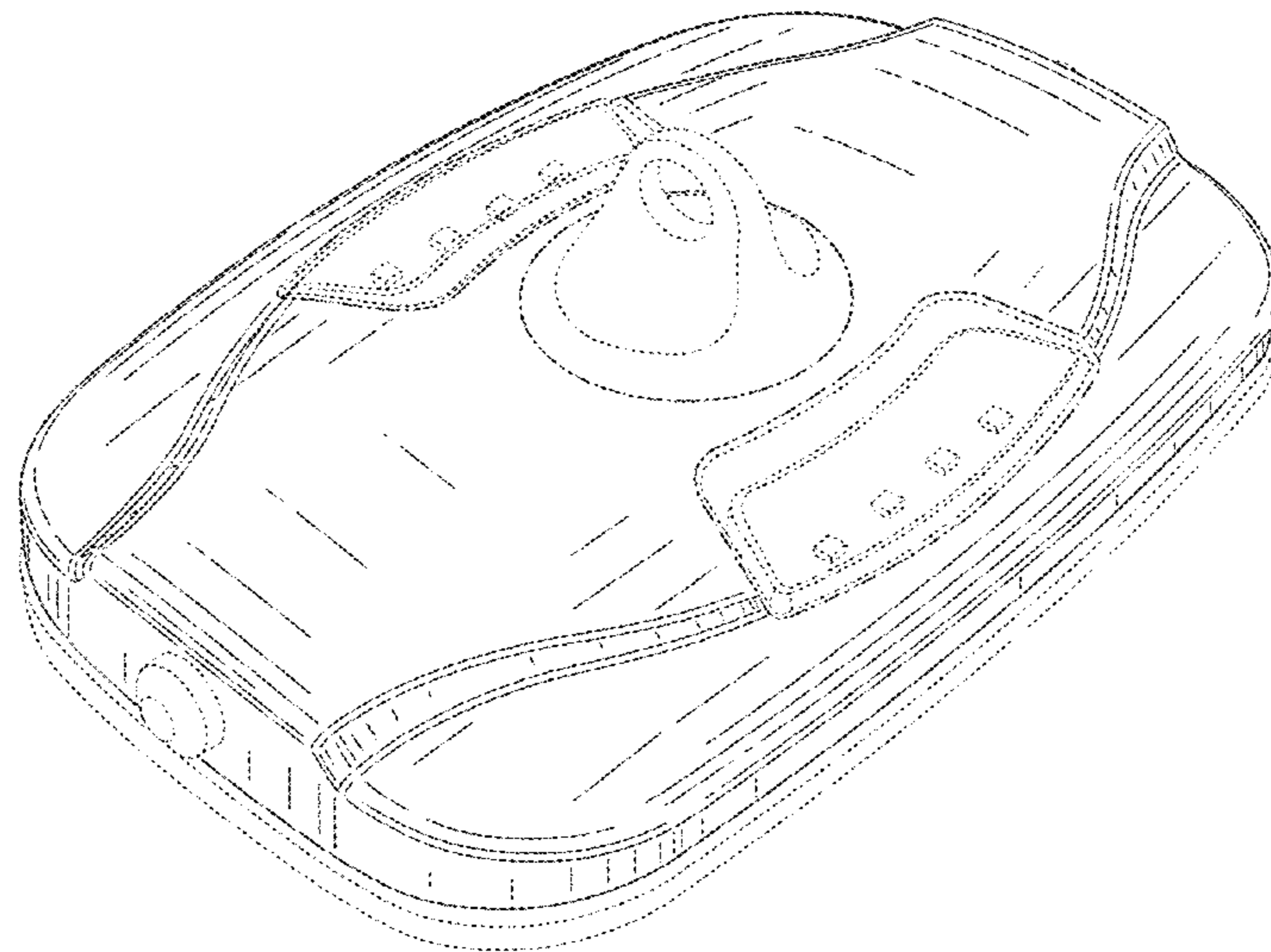
FIG. 1 is a top perspective view of the worklight of the present invention;

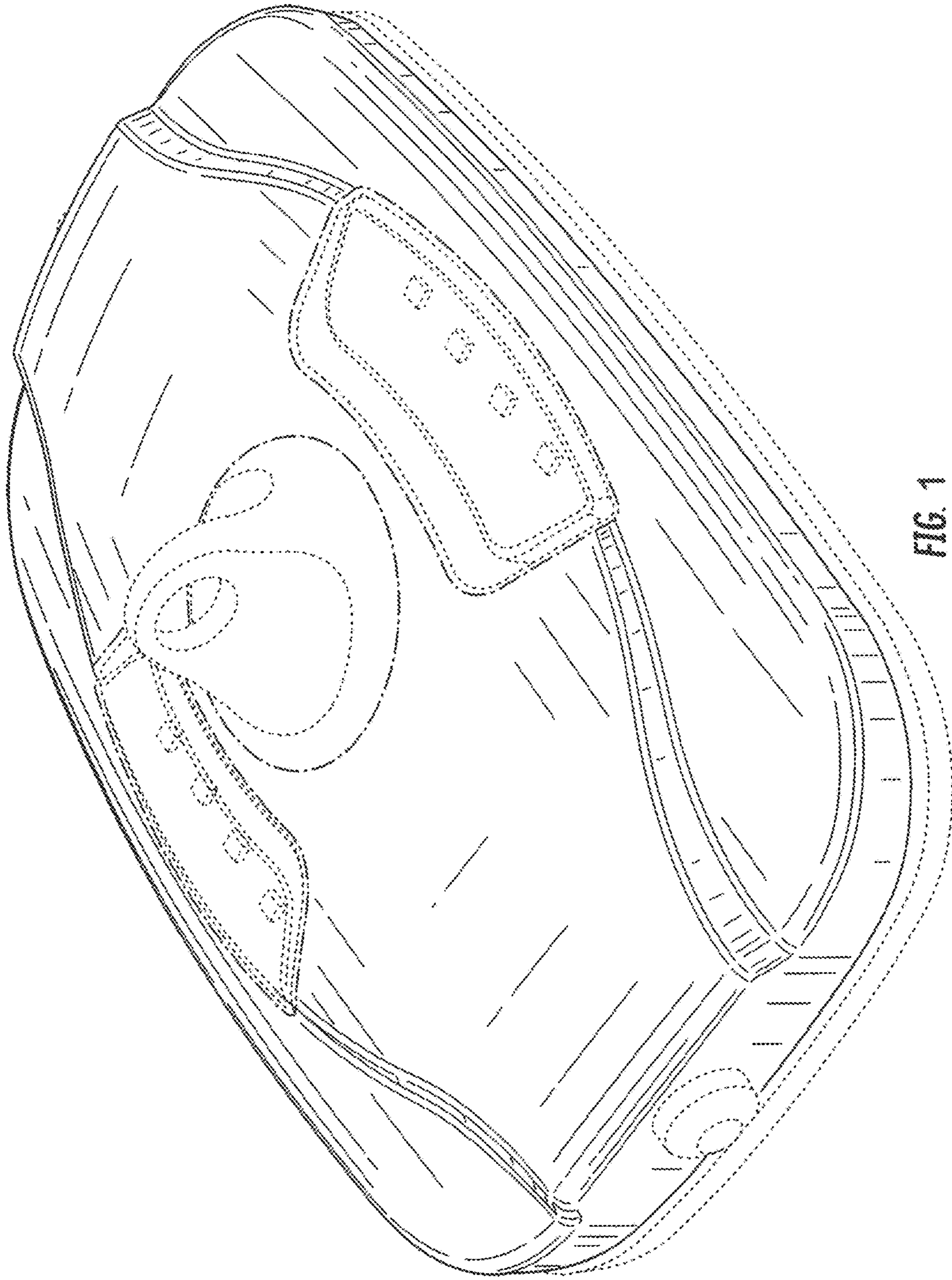

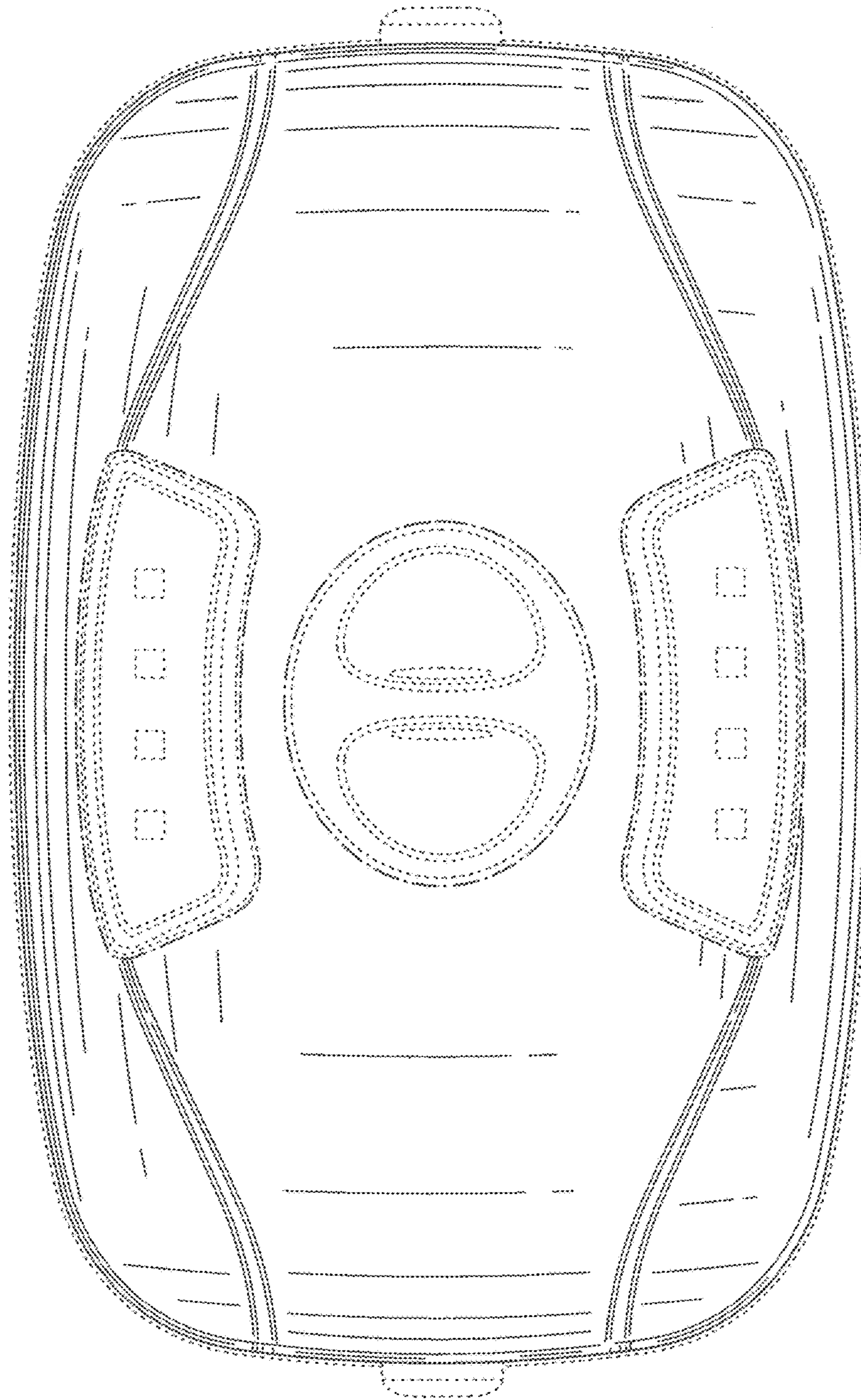

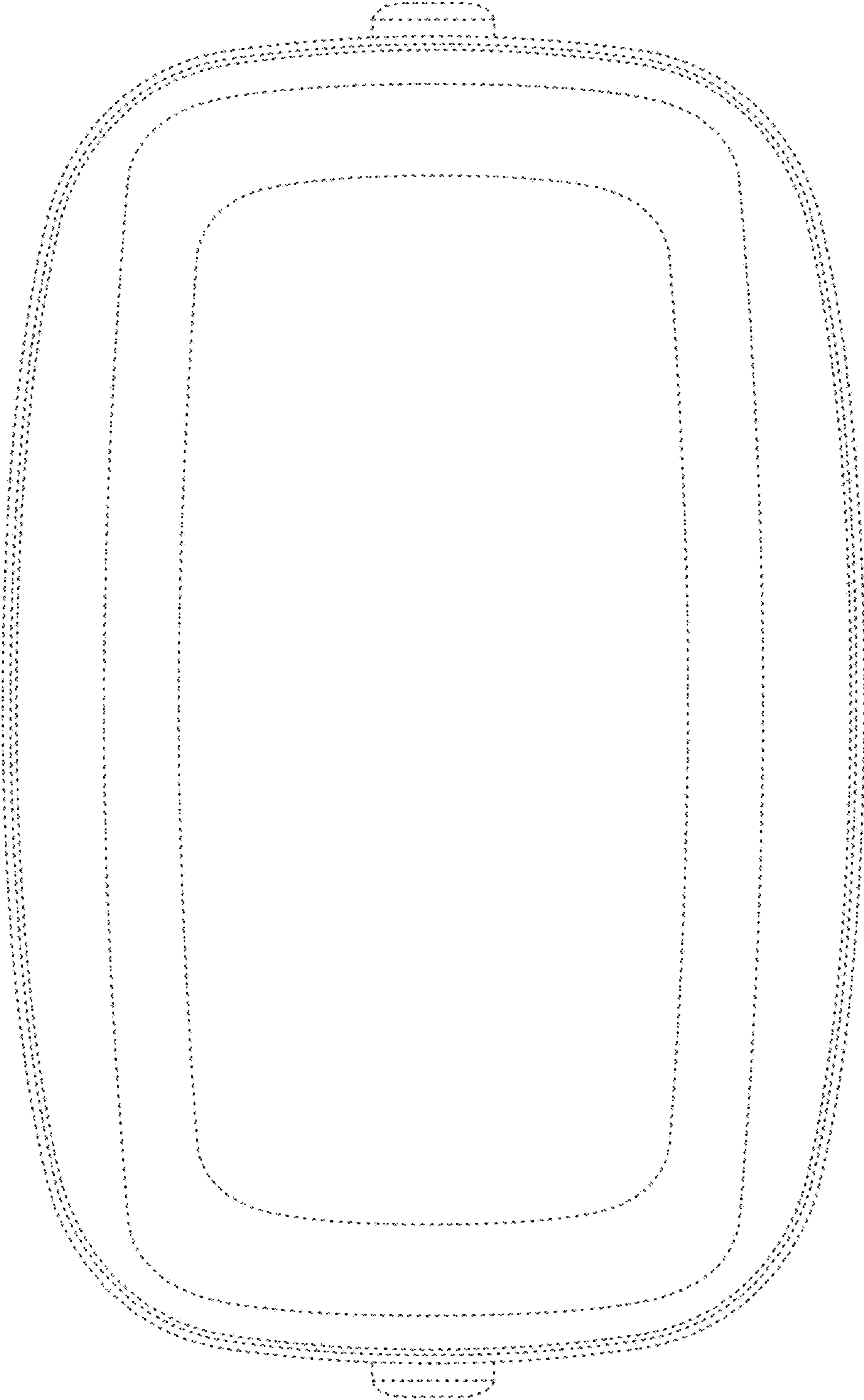

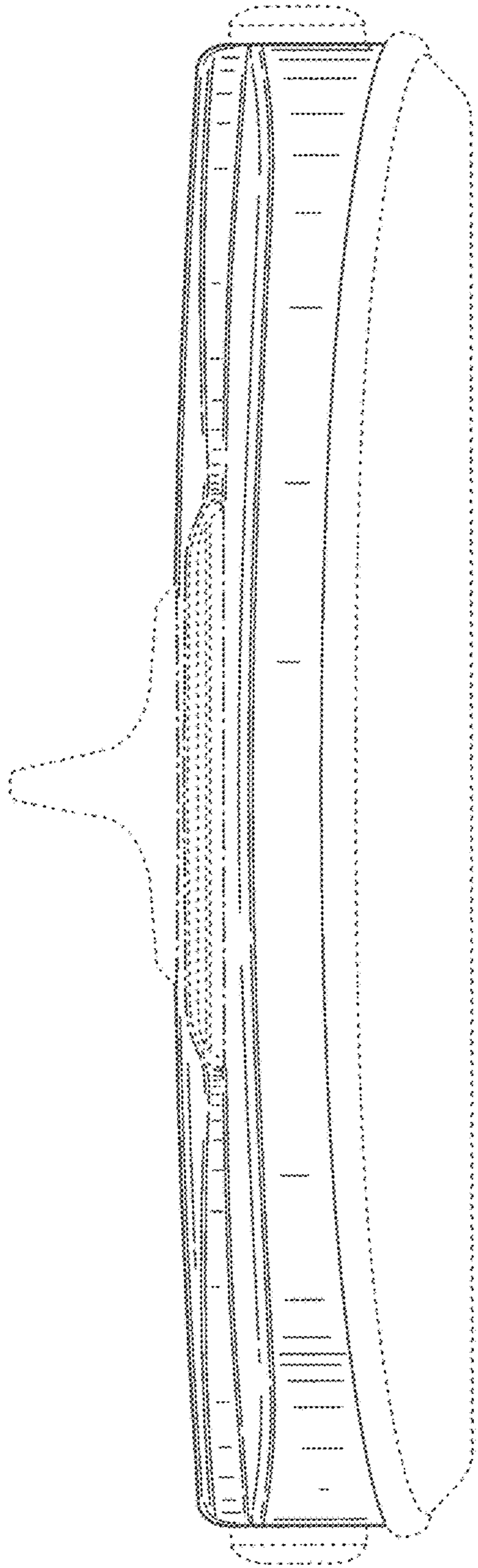

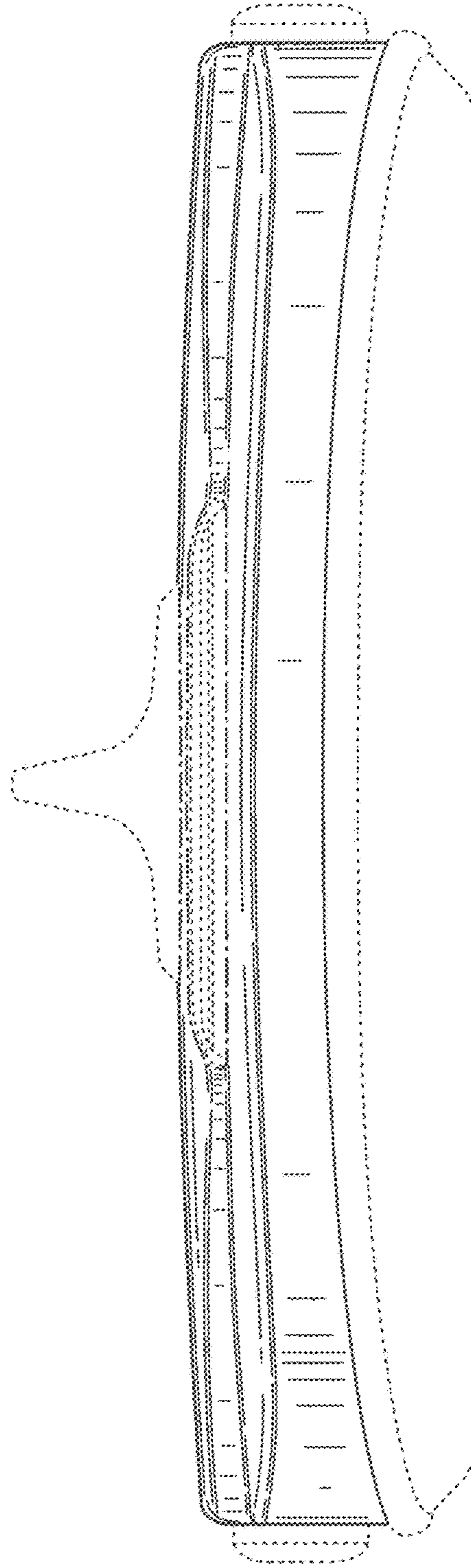

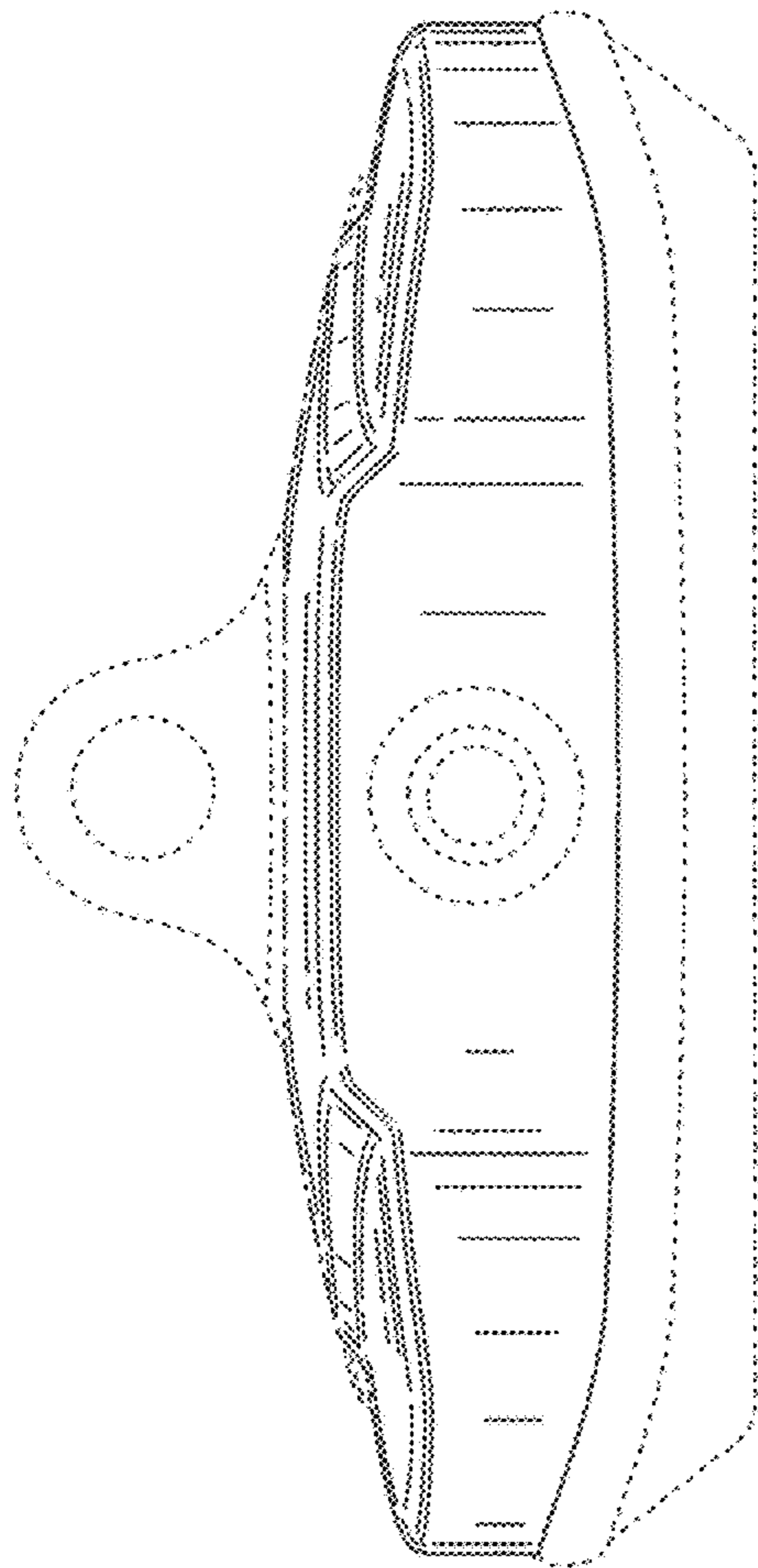

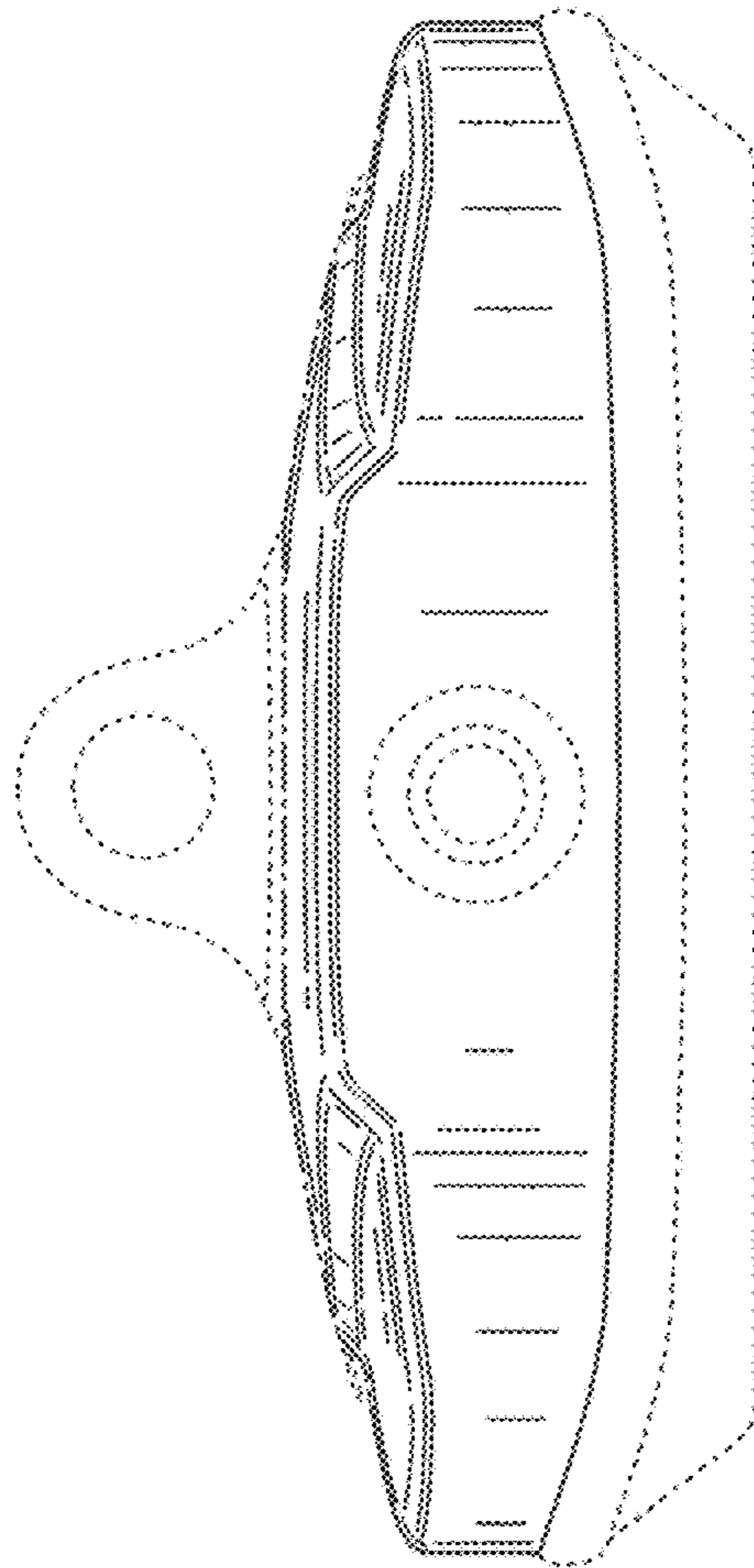
