(57) **CLAIM**

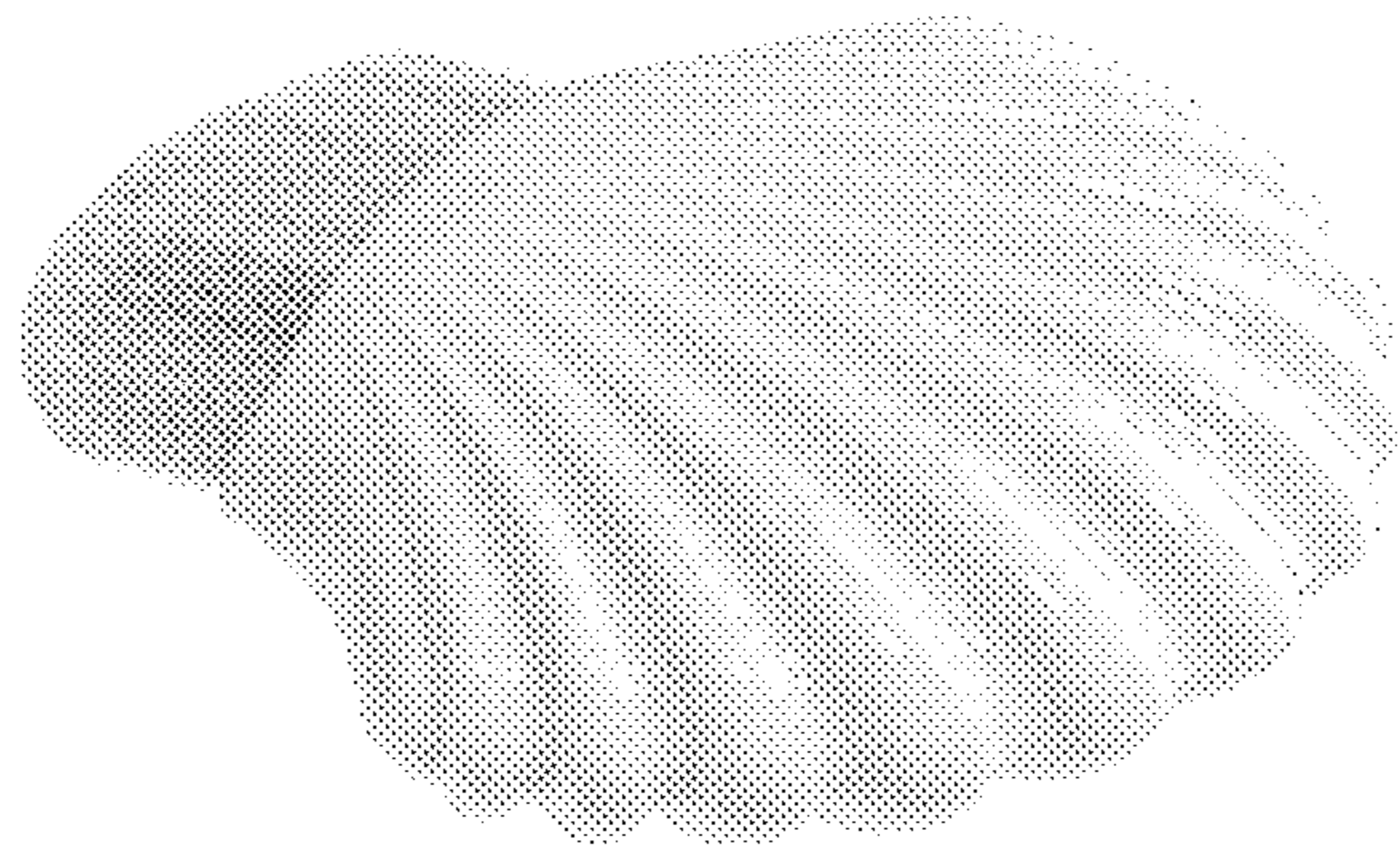
The ornamental design for a makeup tool, as shown and described.

FIG. 7 is a bottom plan view of FIG. 1.

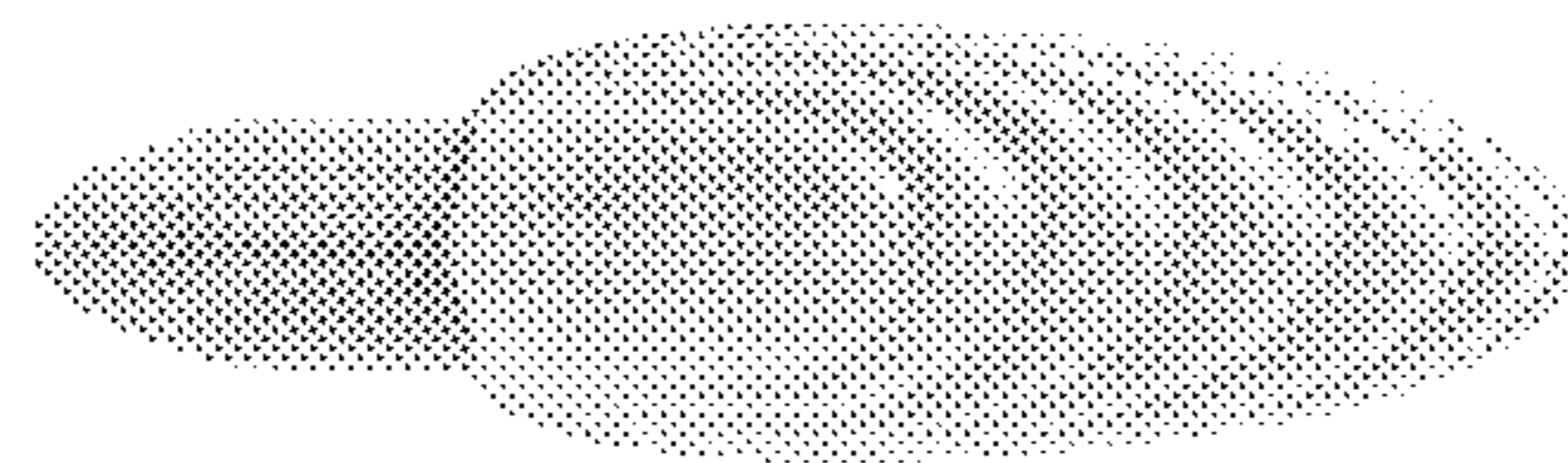

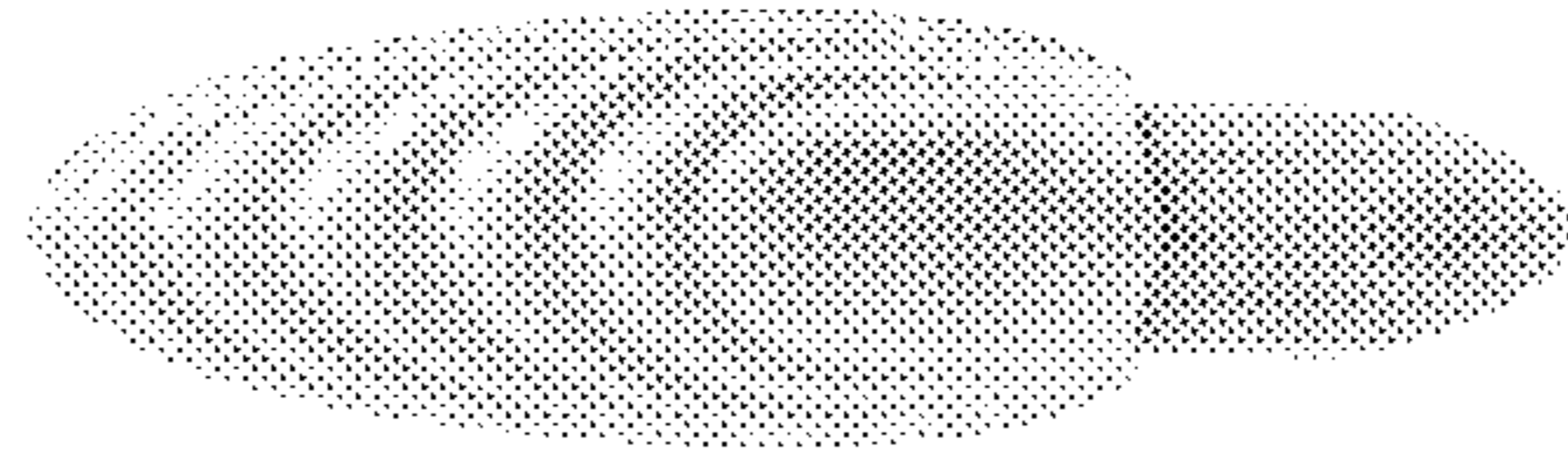




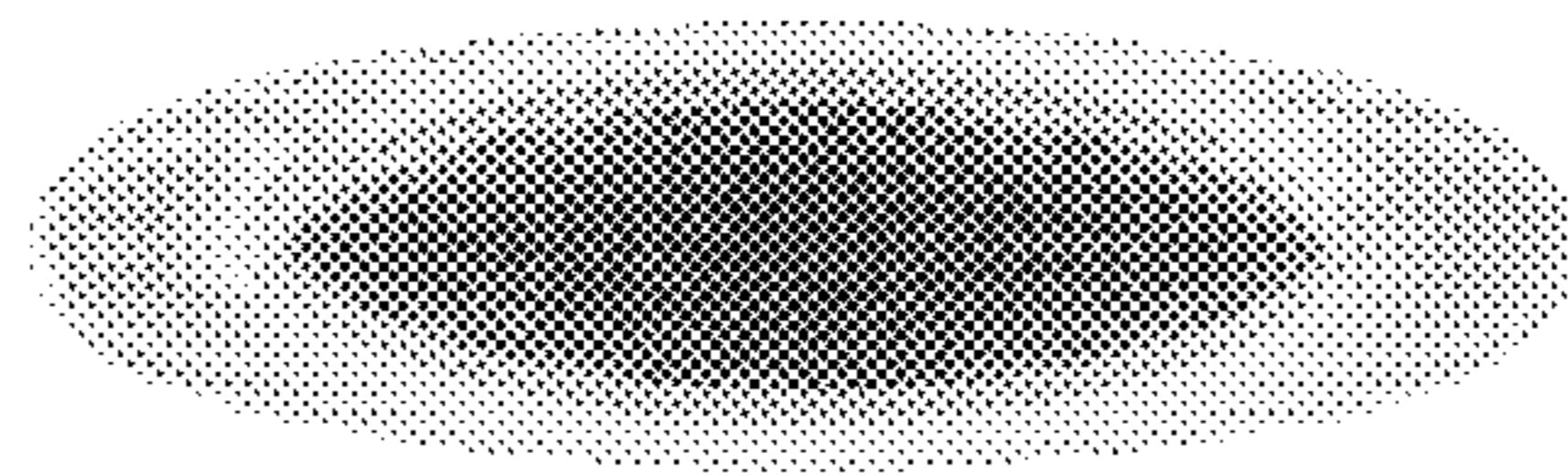

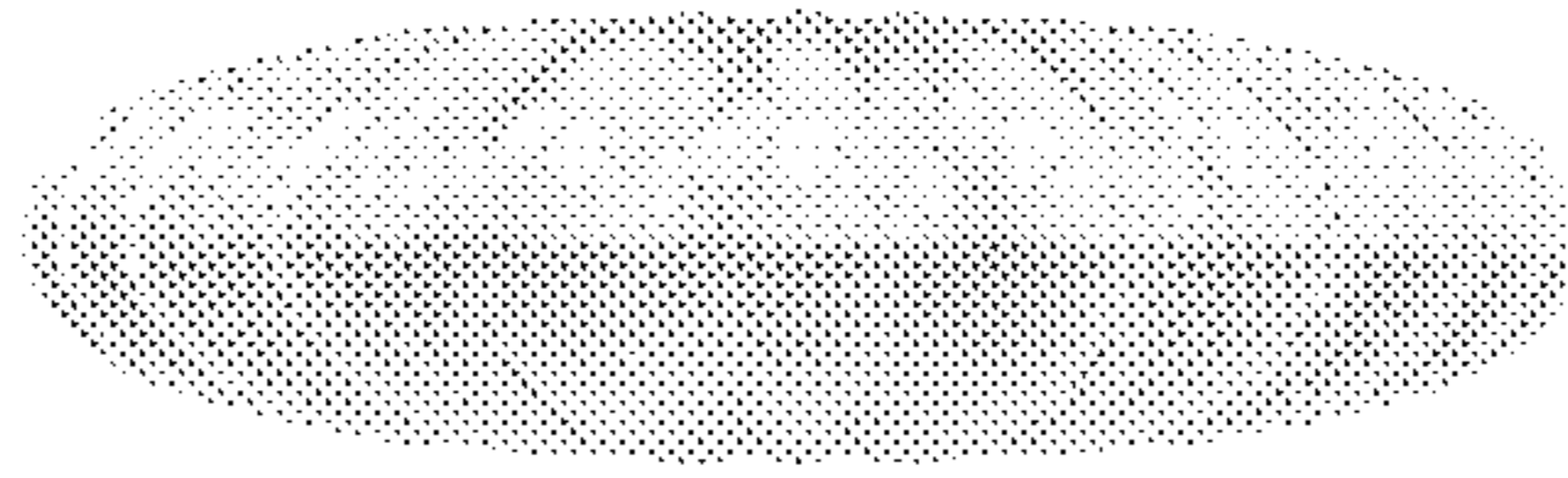

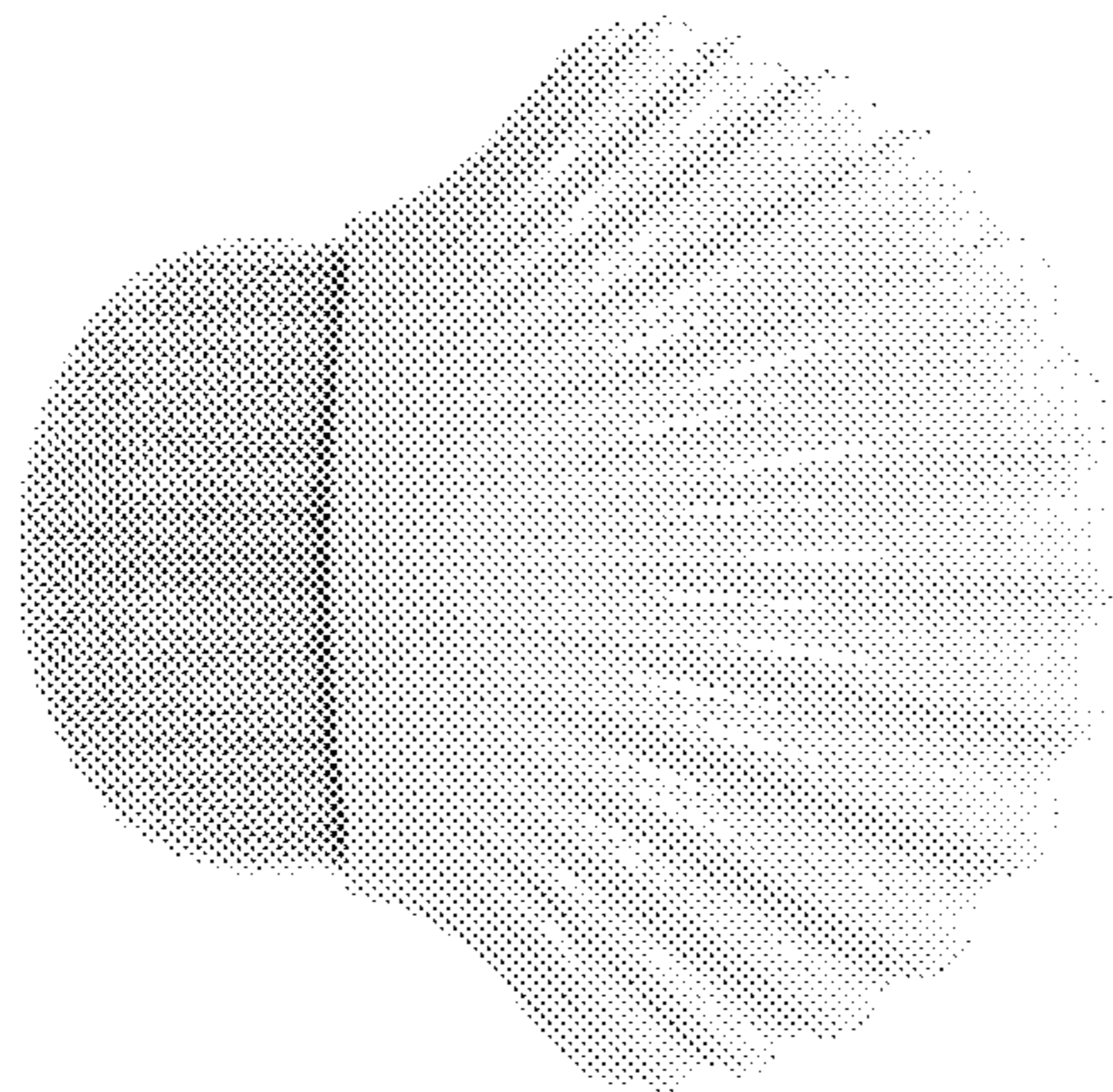

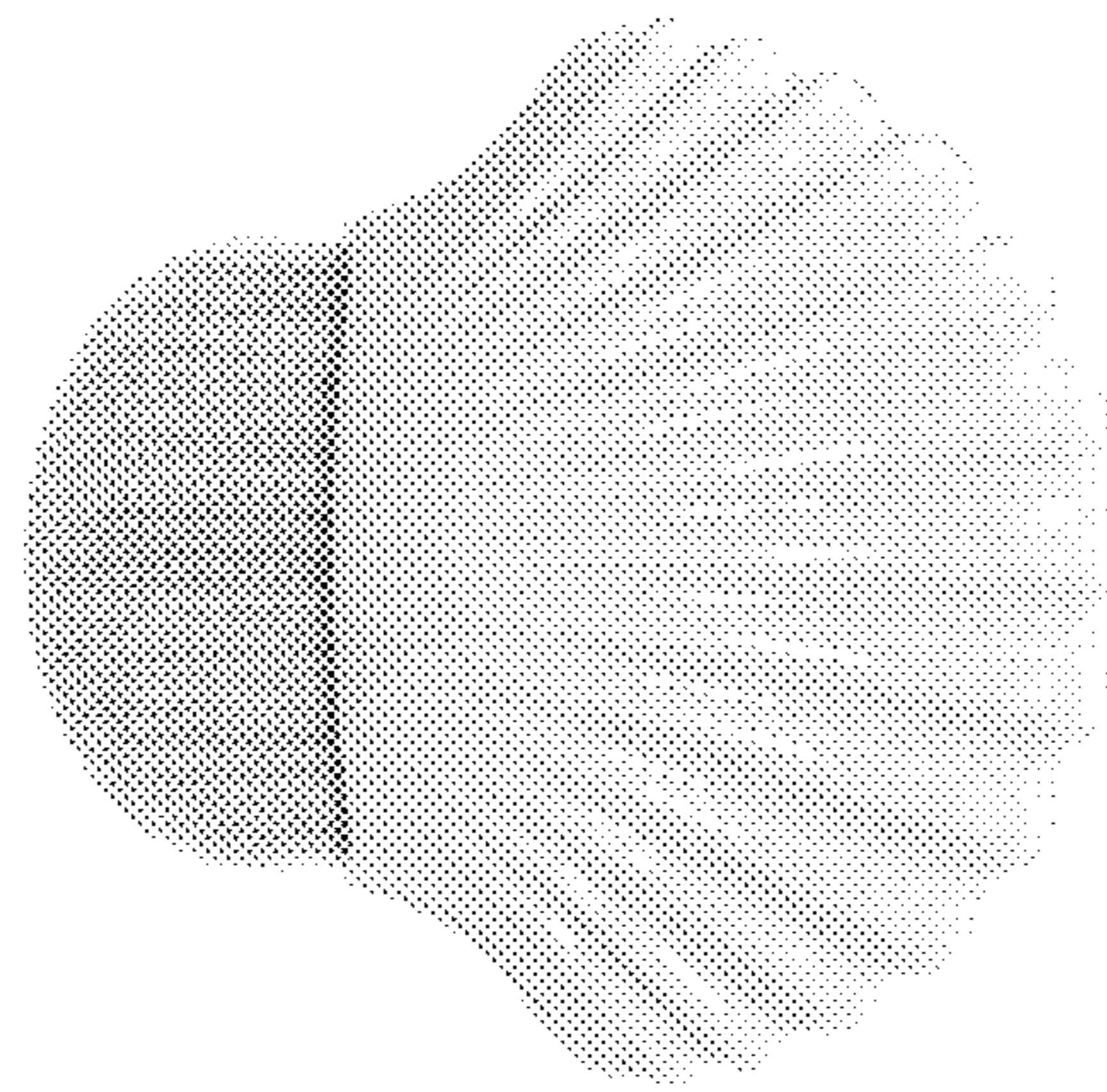
