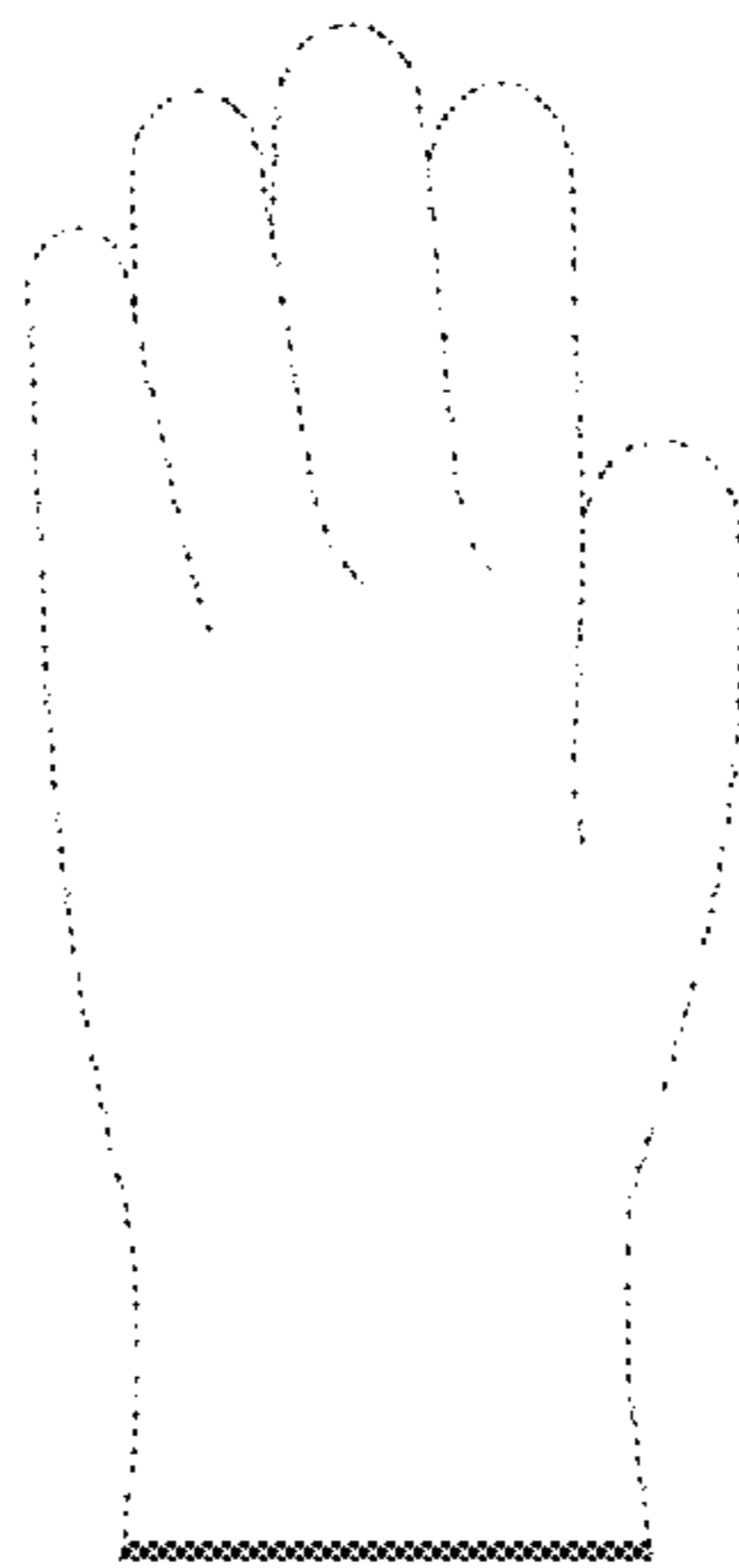
(57) **CLAIM**

The ornamental design for a protective glove cuff, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a protective glove cuff according to the present design;  
FIG. 2 is a rear view of the protective glove cuff of FIG. 1; and,  
FIG. 3 is a perspective view of the protective glove cuff of FIG. 1.  
The broken lines in the figures represent environmental subject matter and form no part of the claimed design.

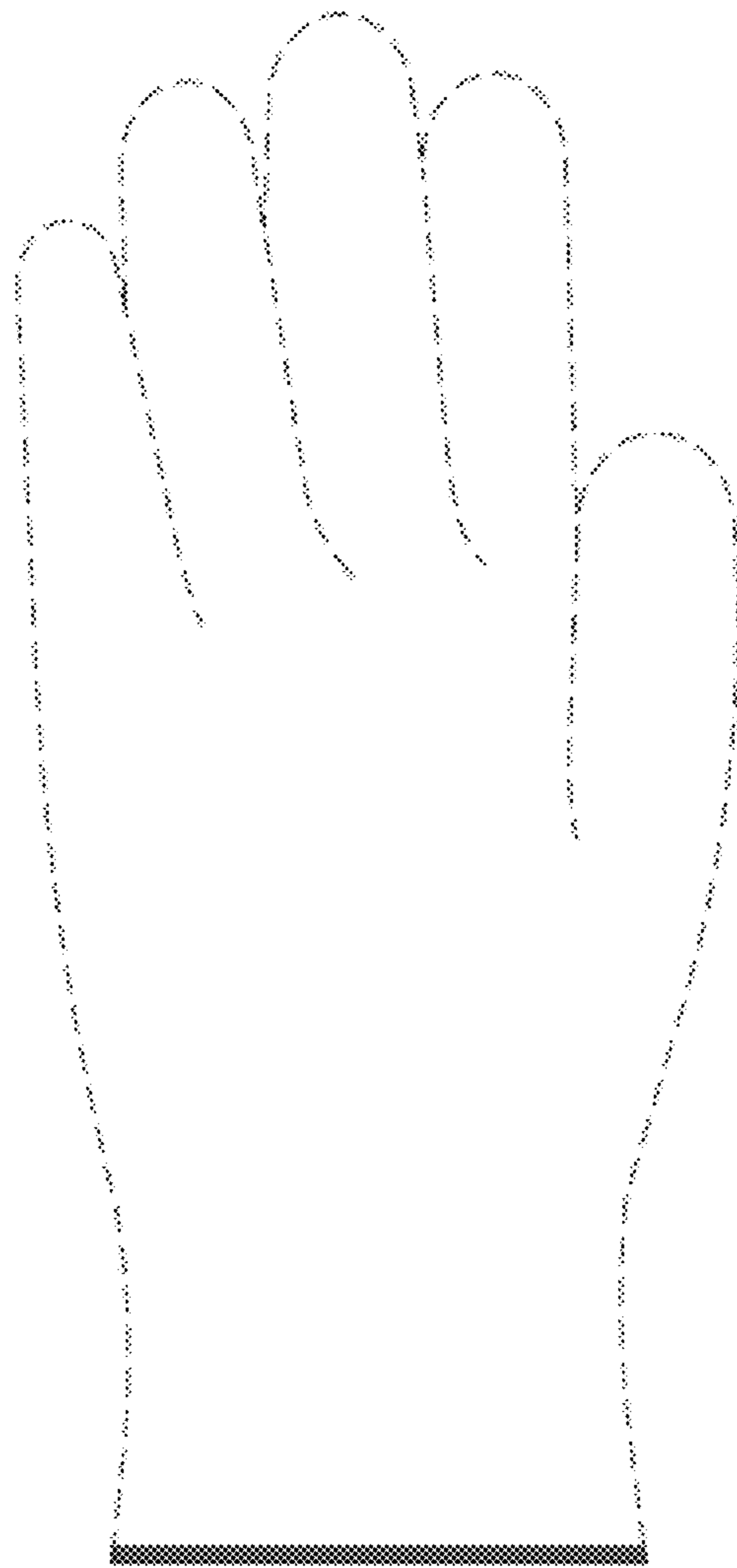

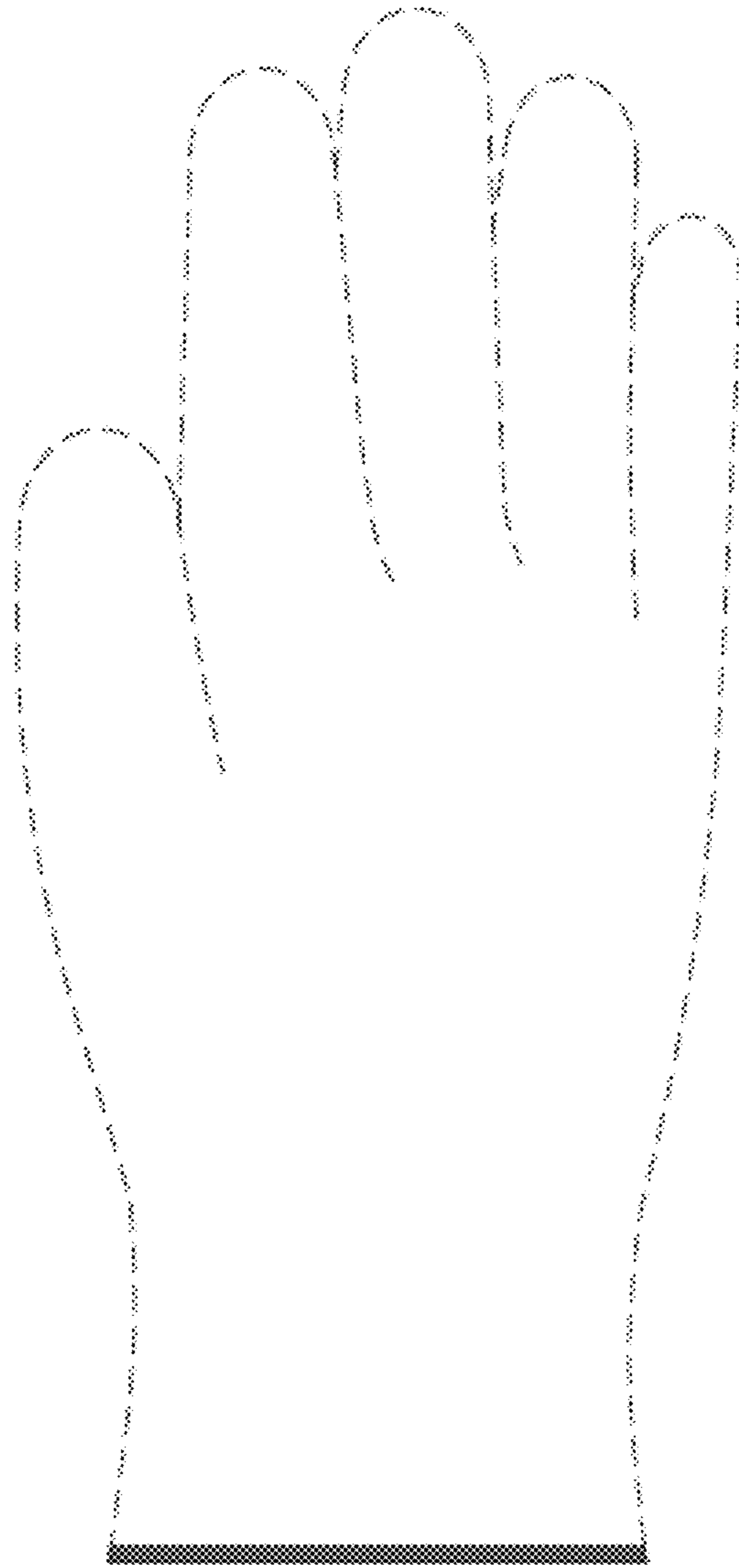

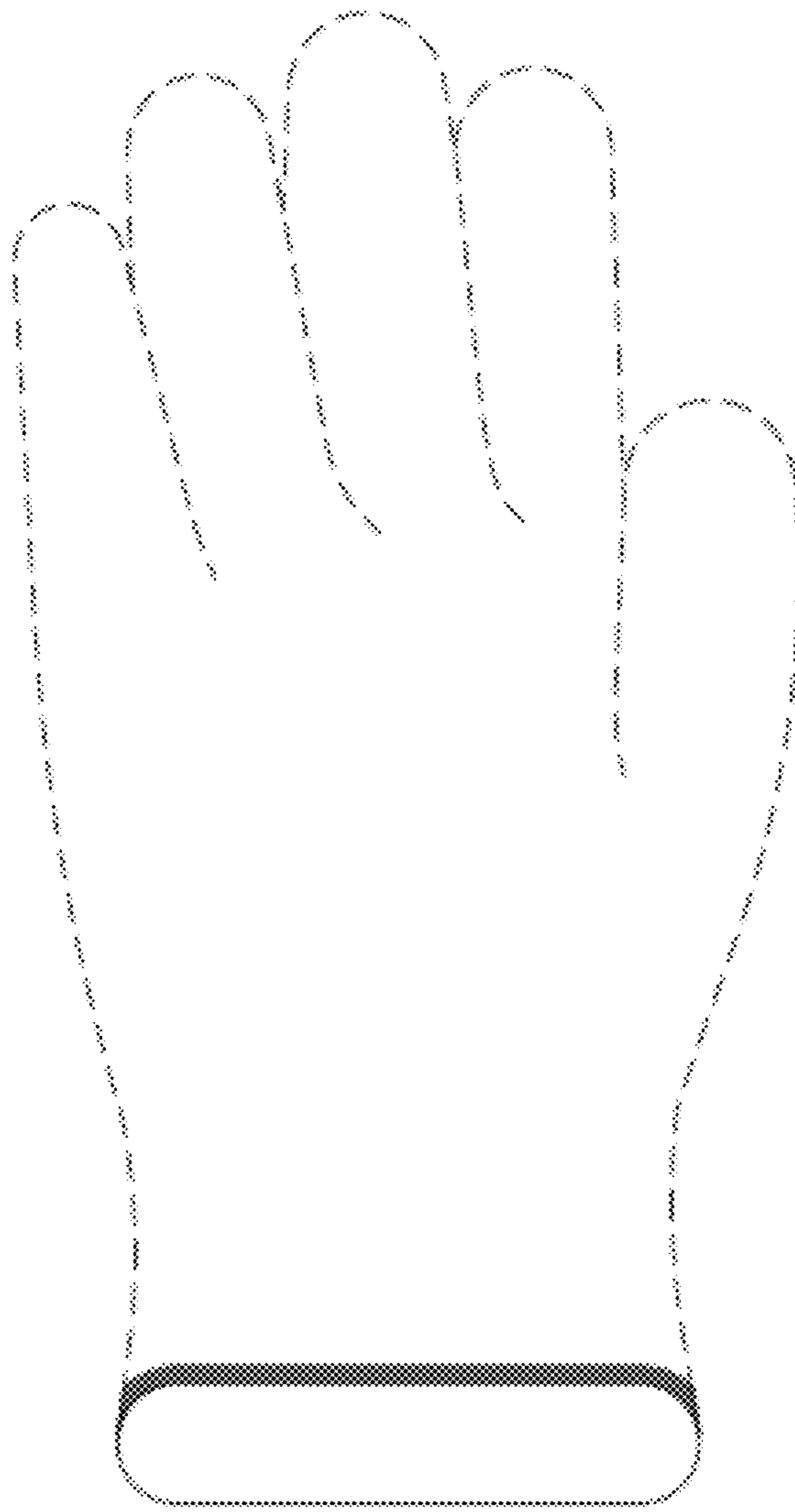
