FIG. 8 is a cross-sectional view along 8-8 of the tray of FIG. 6.

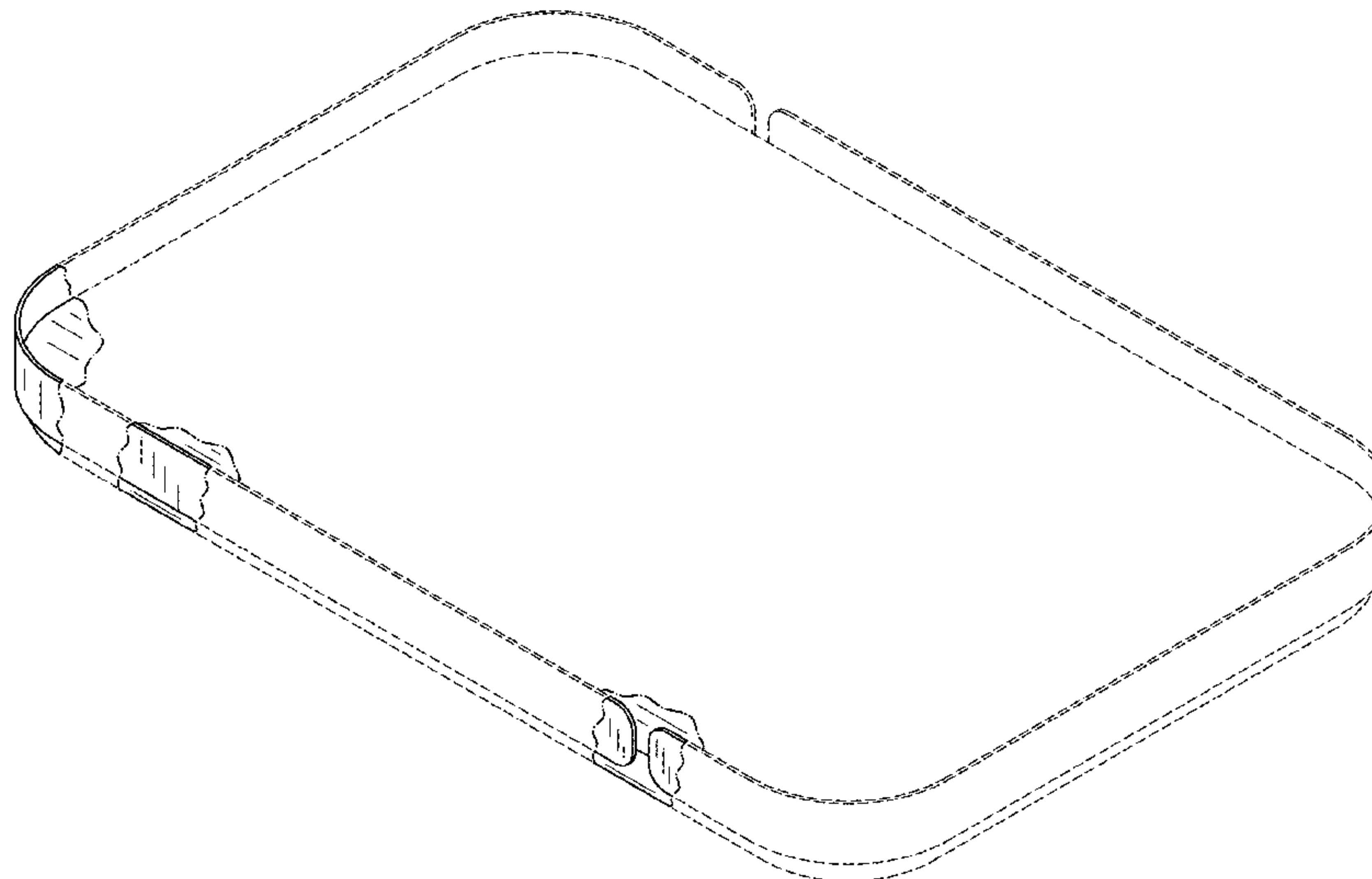
The dashed and broken lines are for purposes of illustrating environmental structure and form no part of the claimed design.

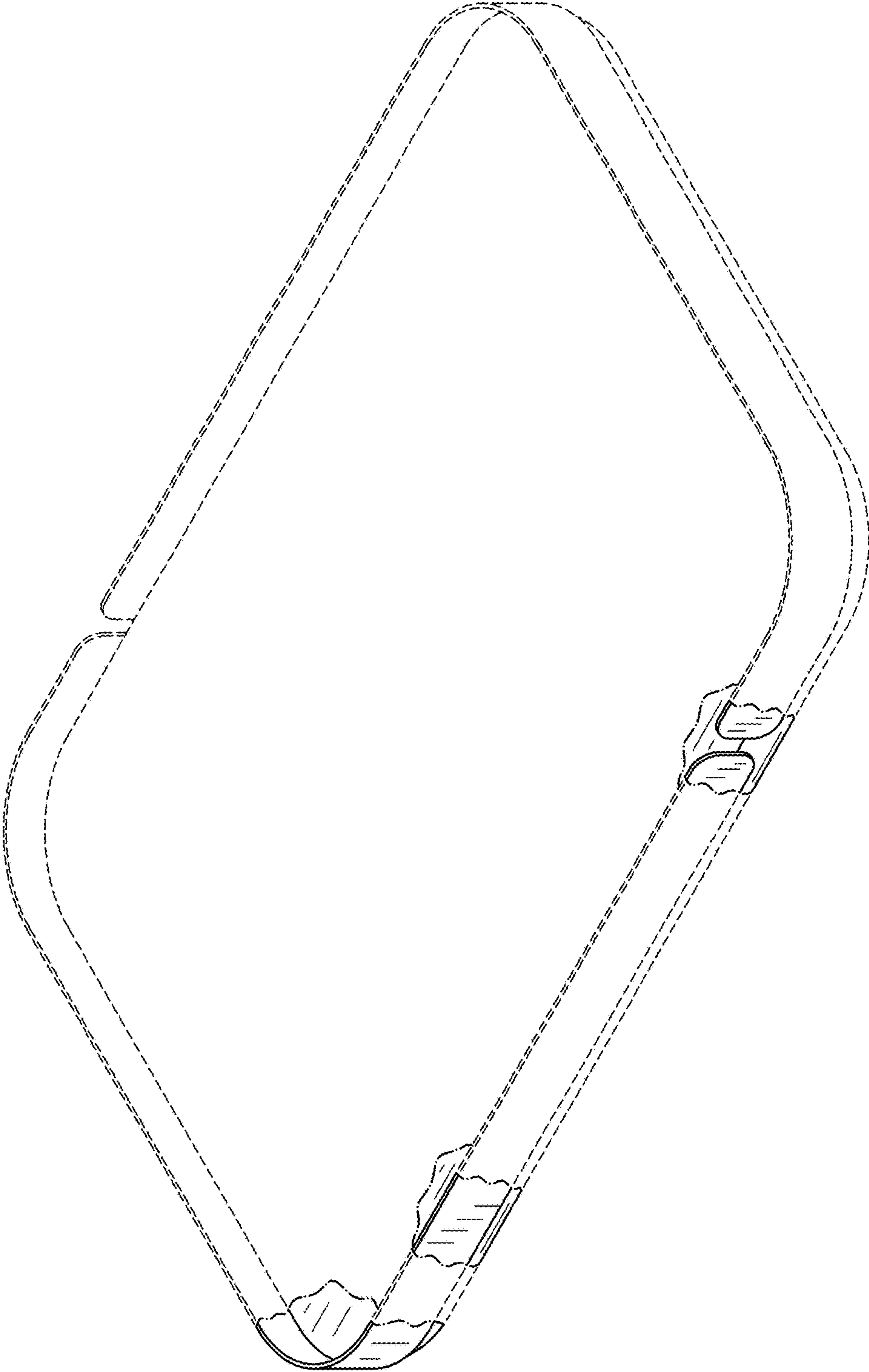

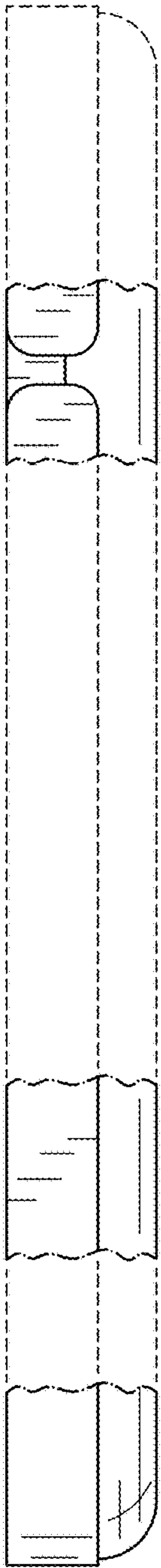

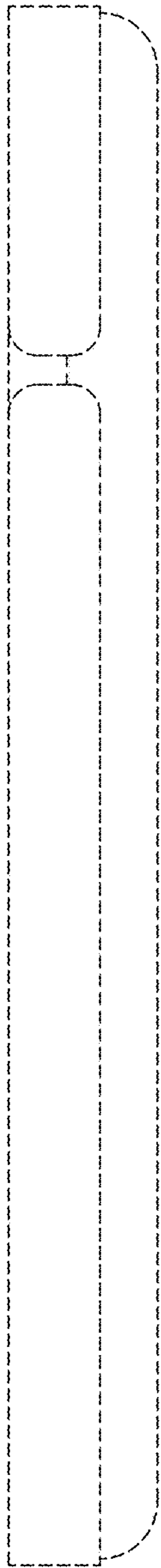

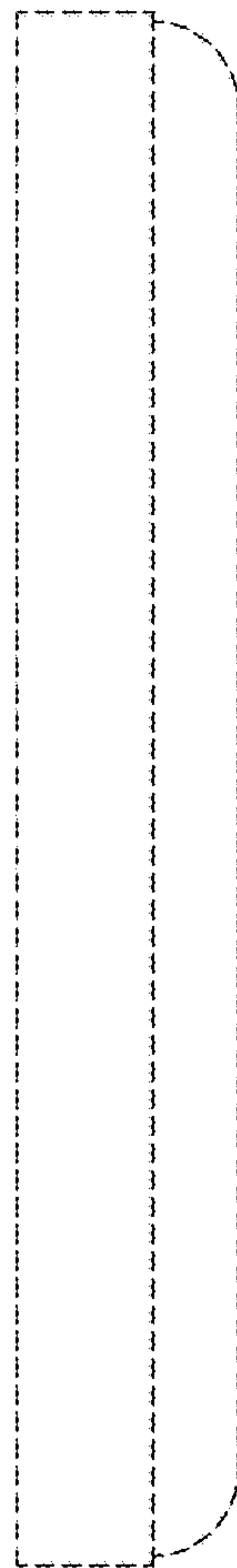

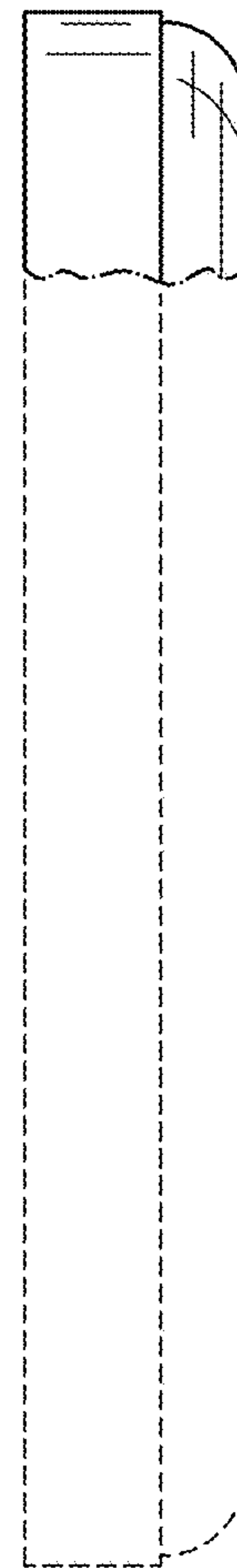

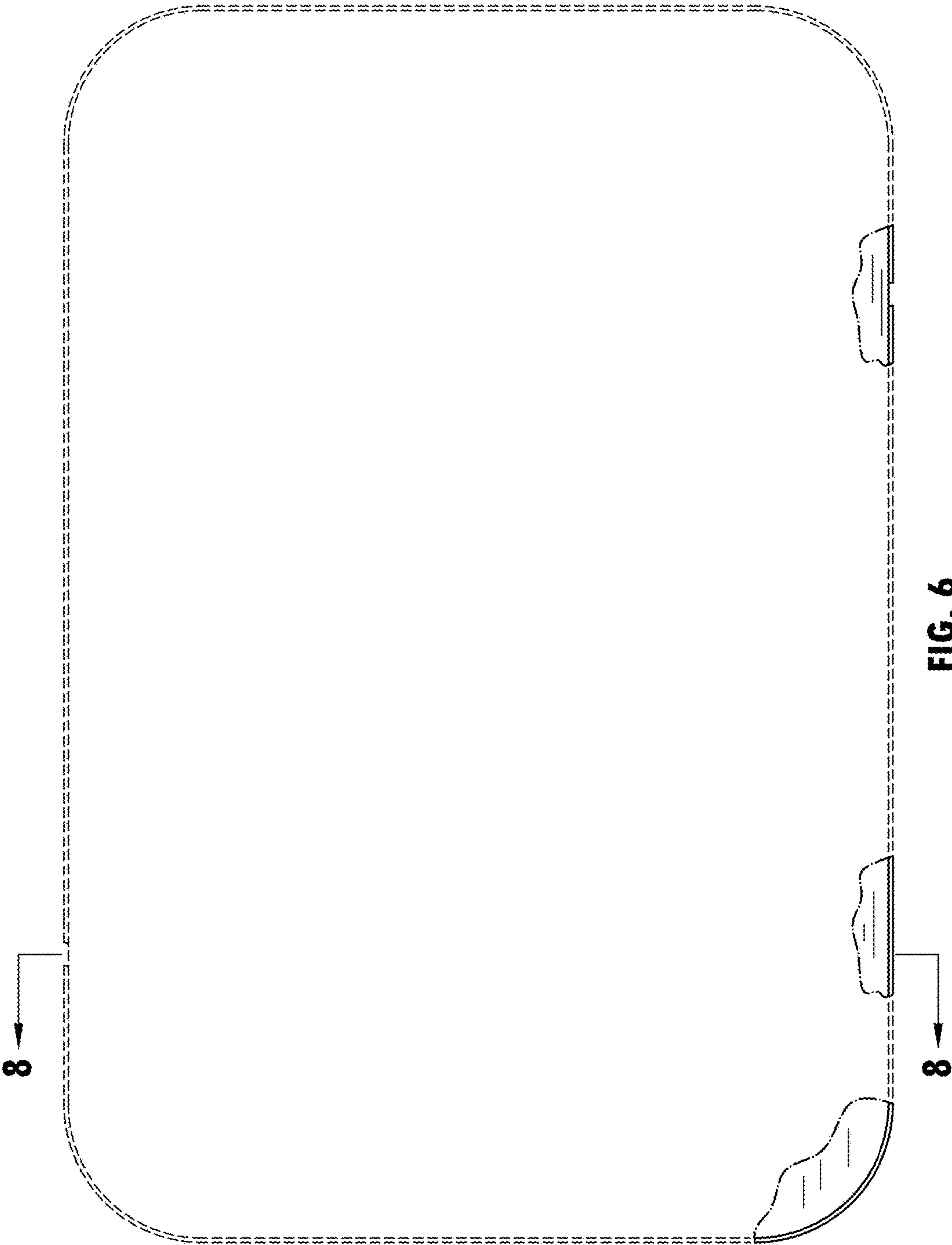

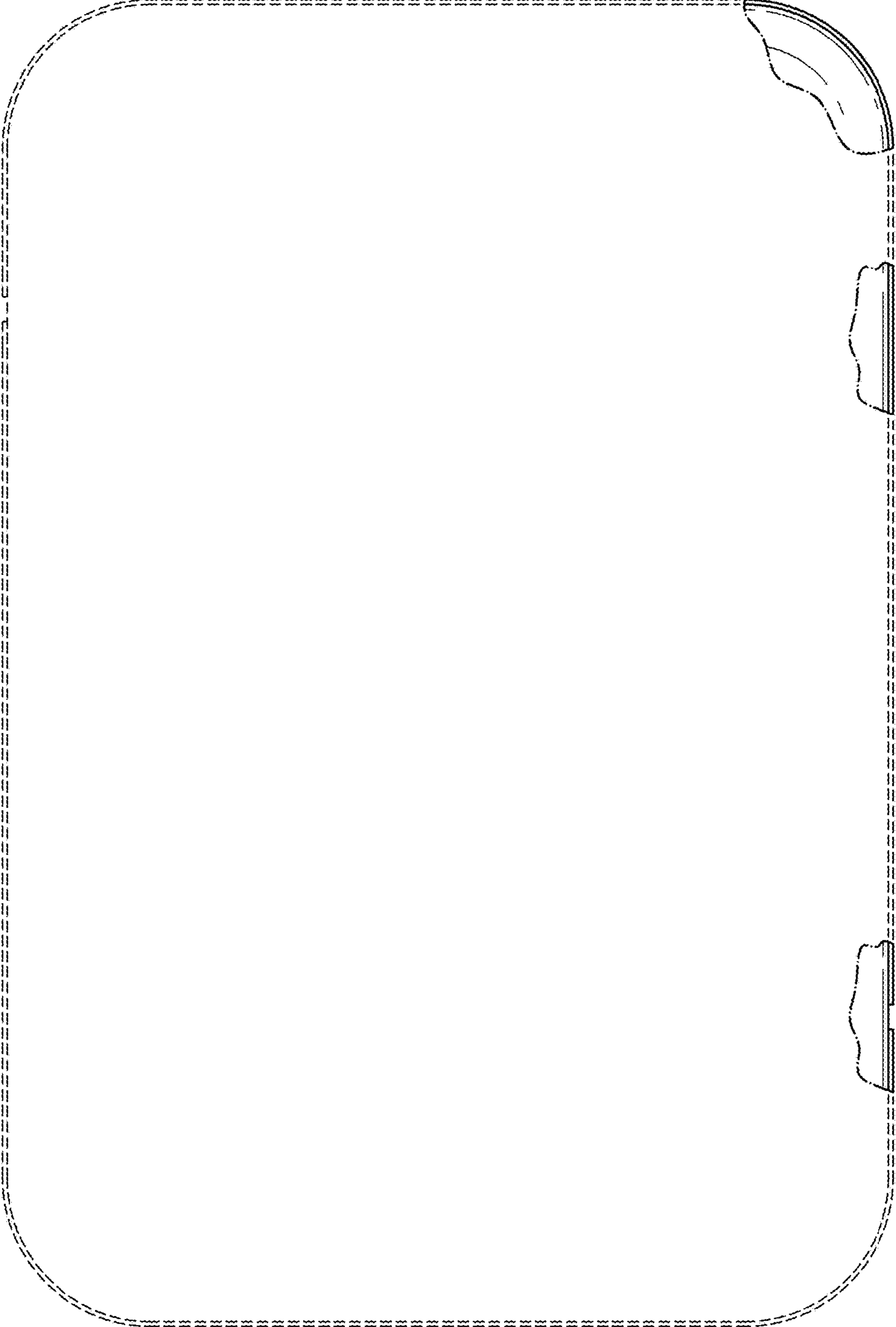

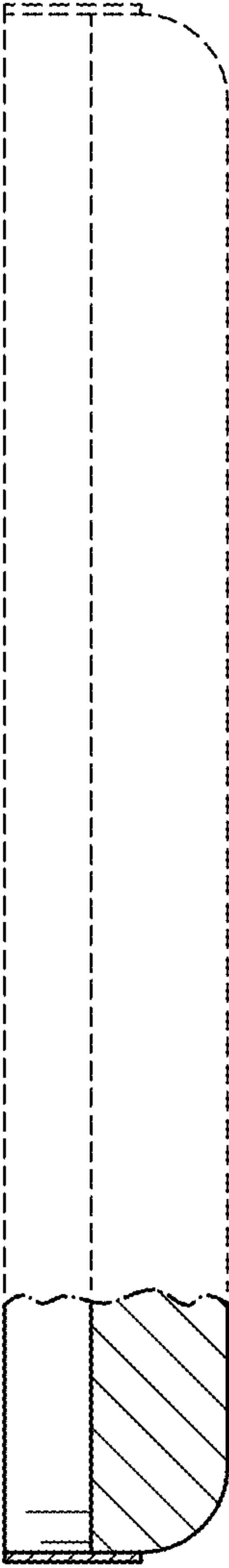
