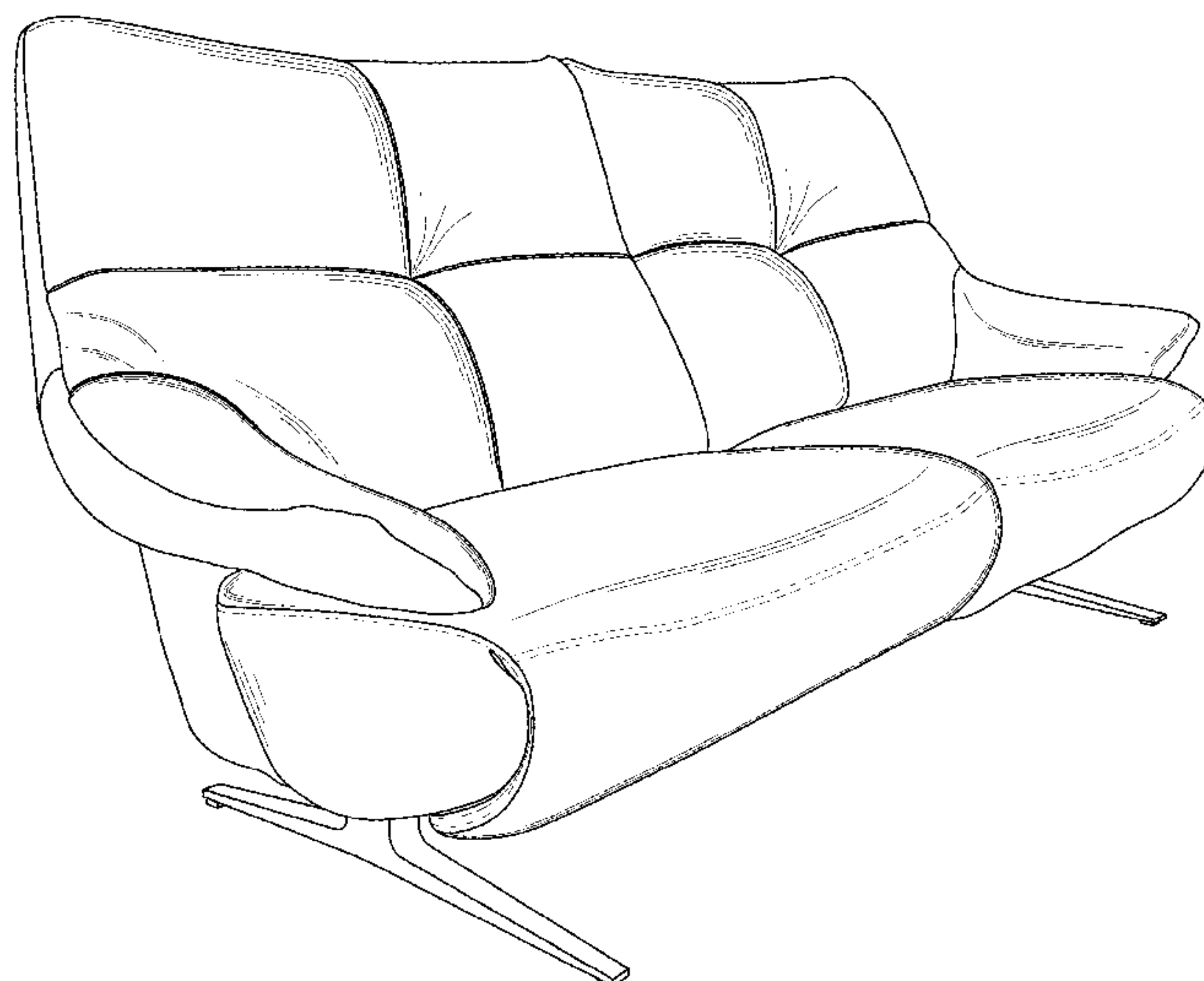
(57) **CLAIM**
The ornamental design for a sofa, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sofa showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines on the sofa in FIGS. 1, 2, and 4-6 are included to show unclaimed stitching on the article. The broken lines in FIG. 7 show portions of the design that form no part of the claimed design.

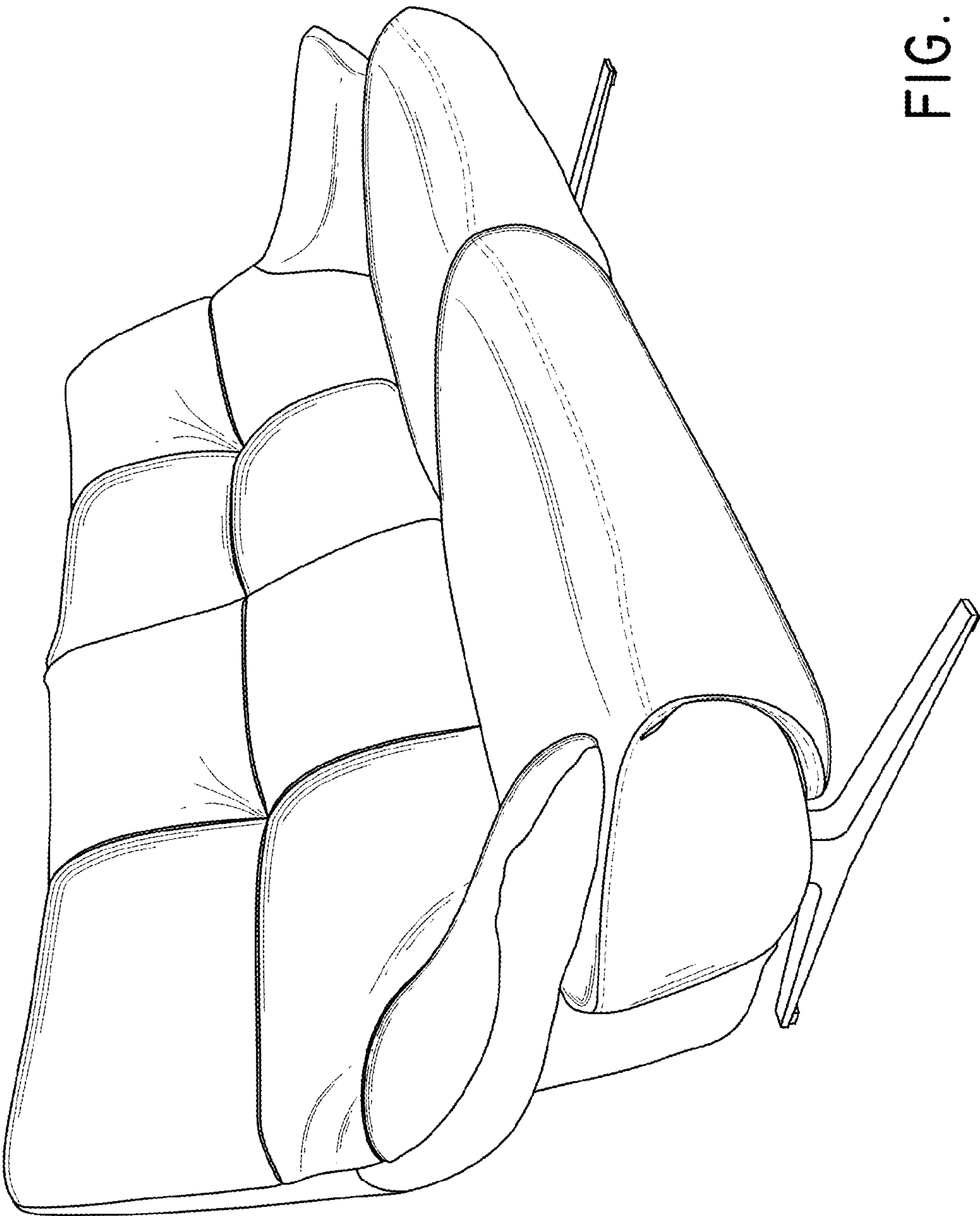

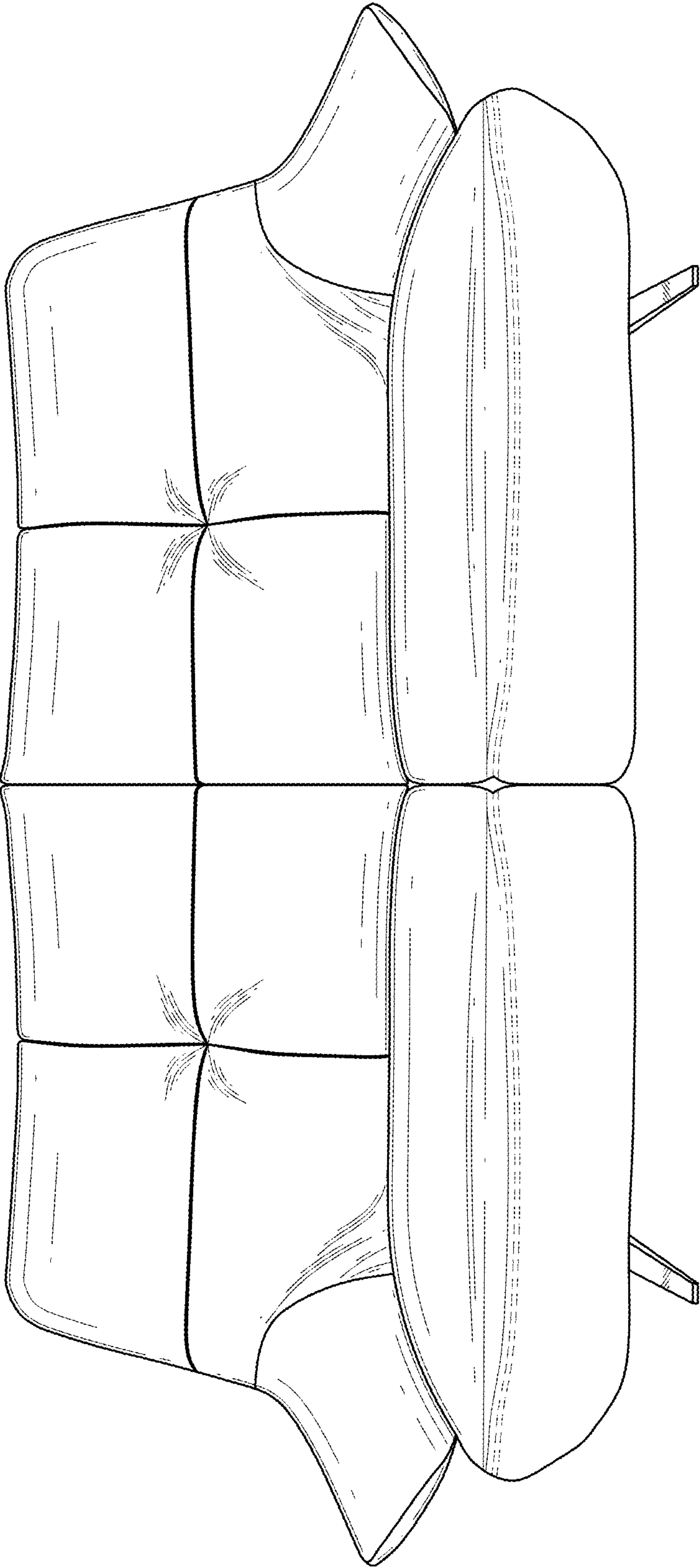

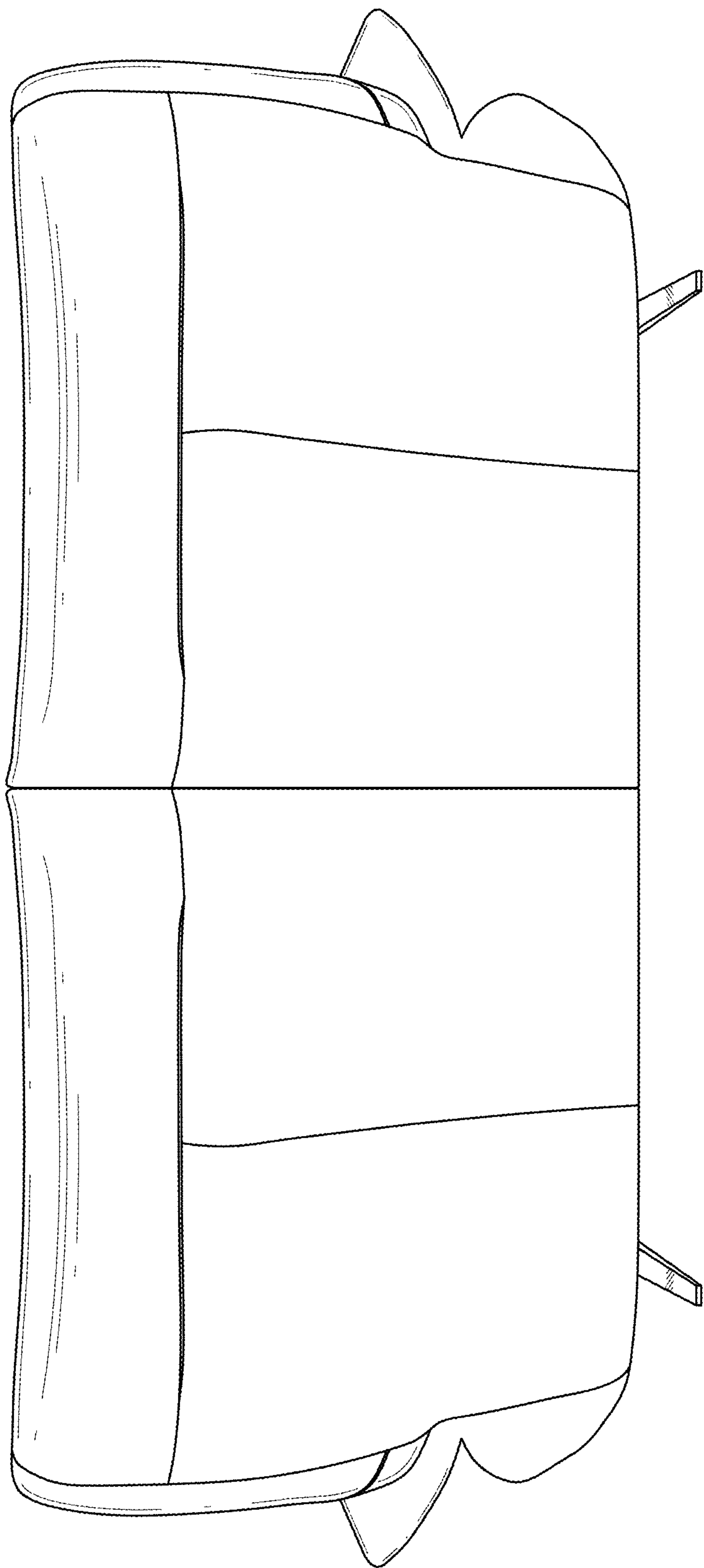

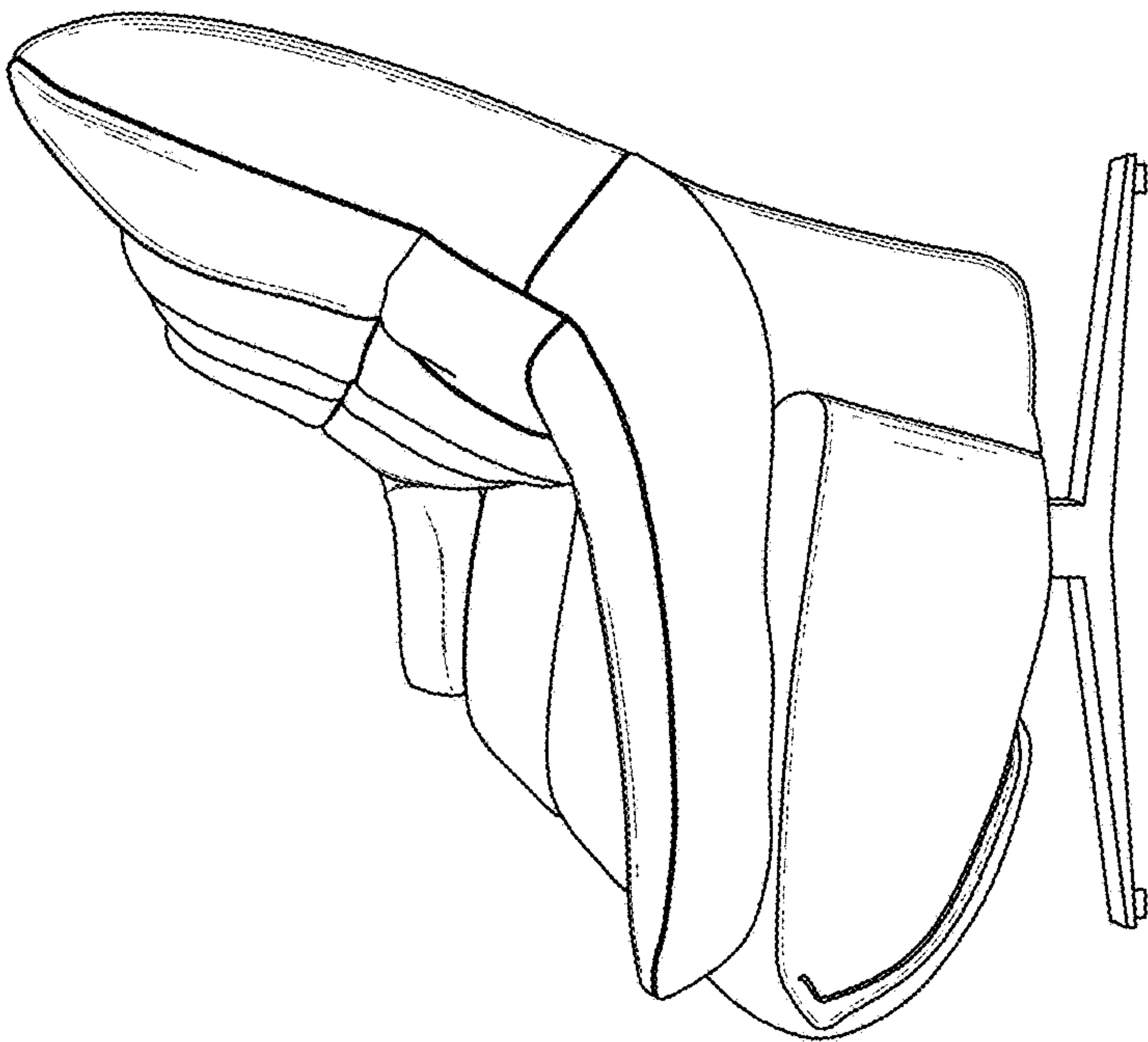

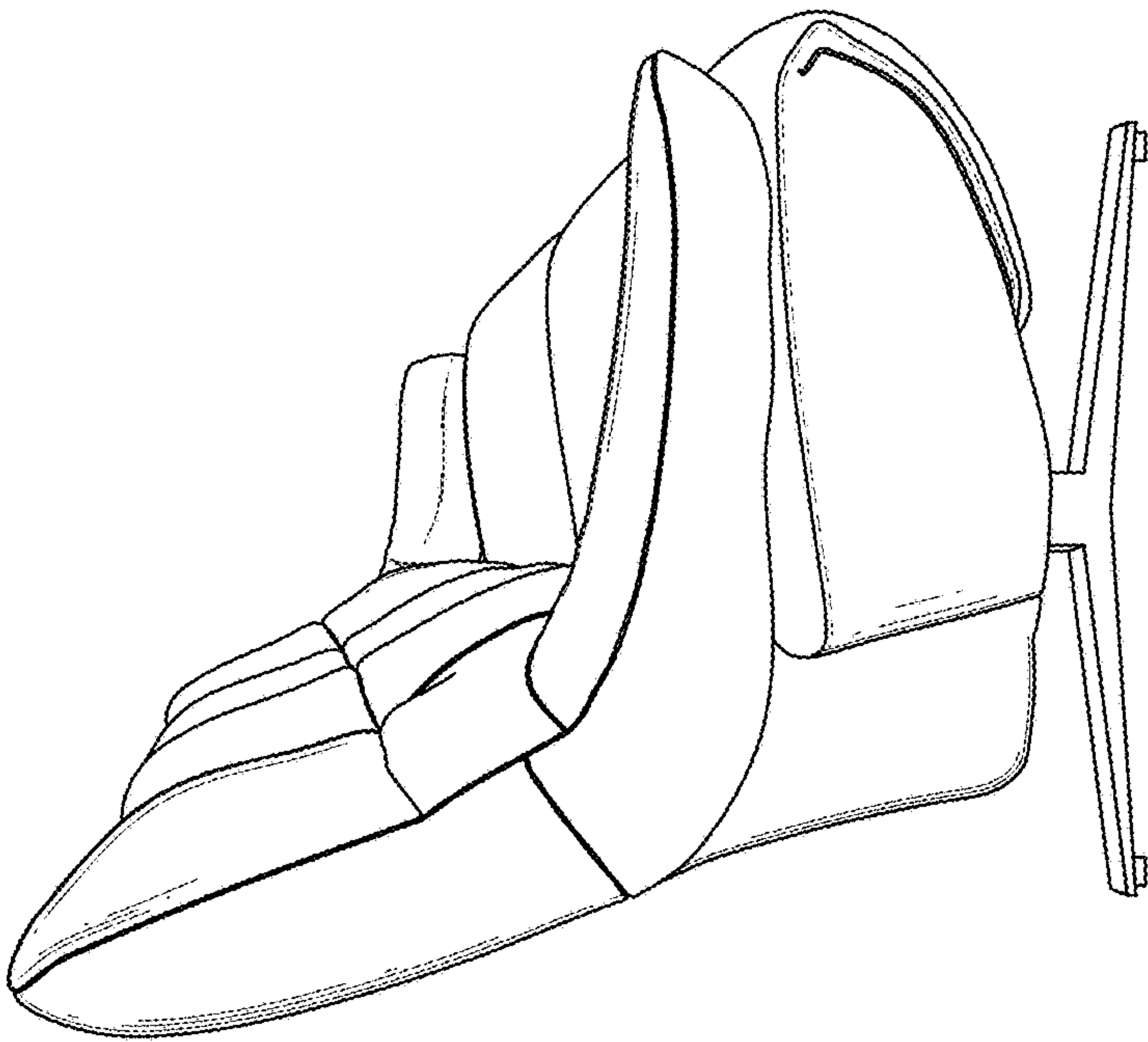

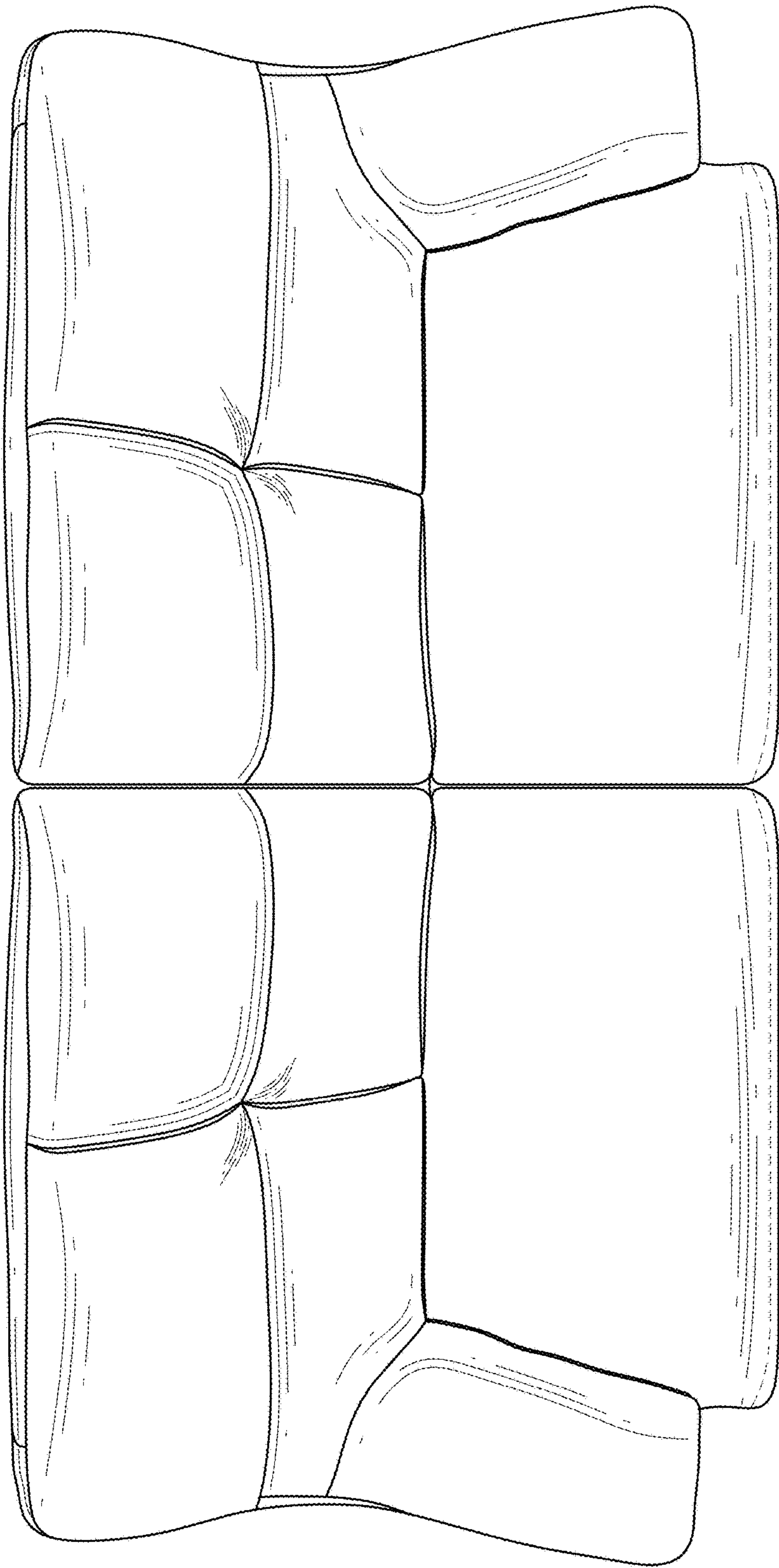

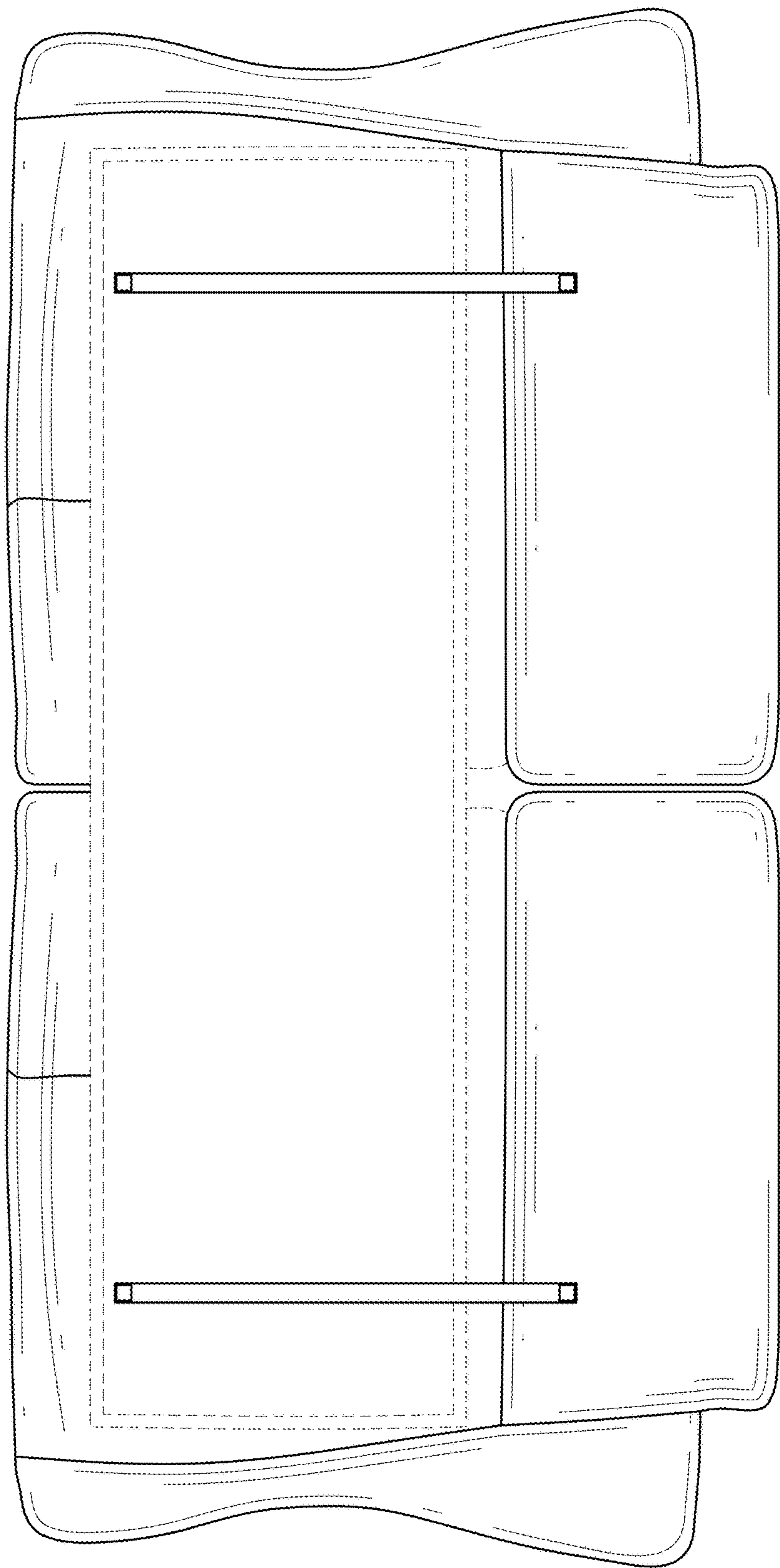
