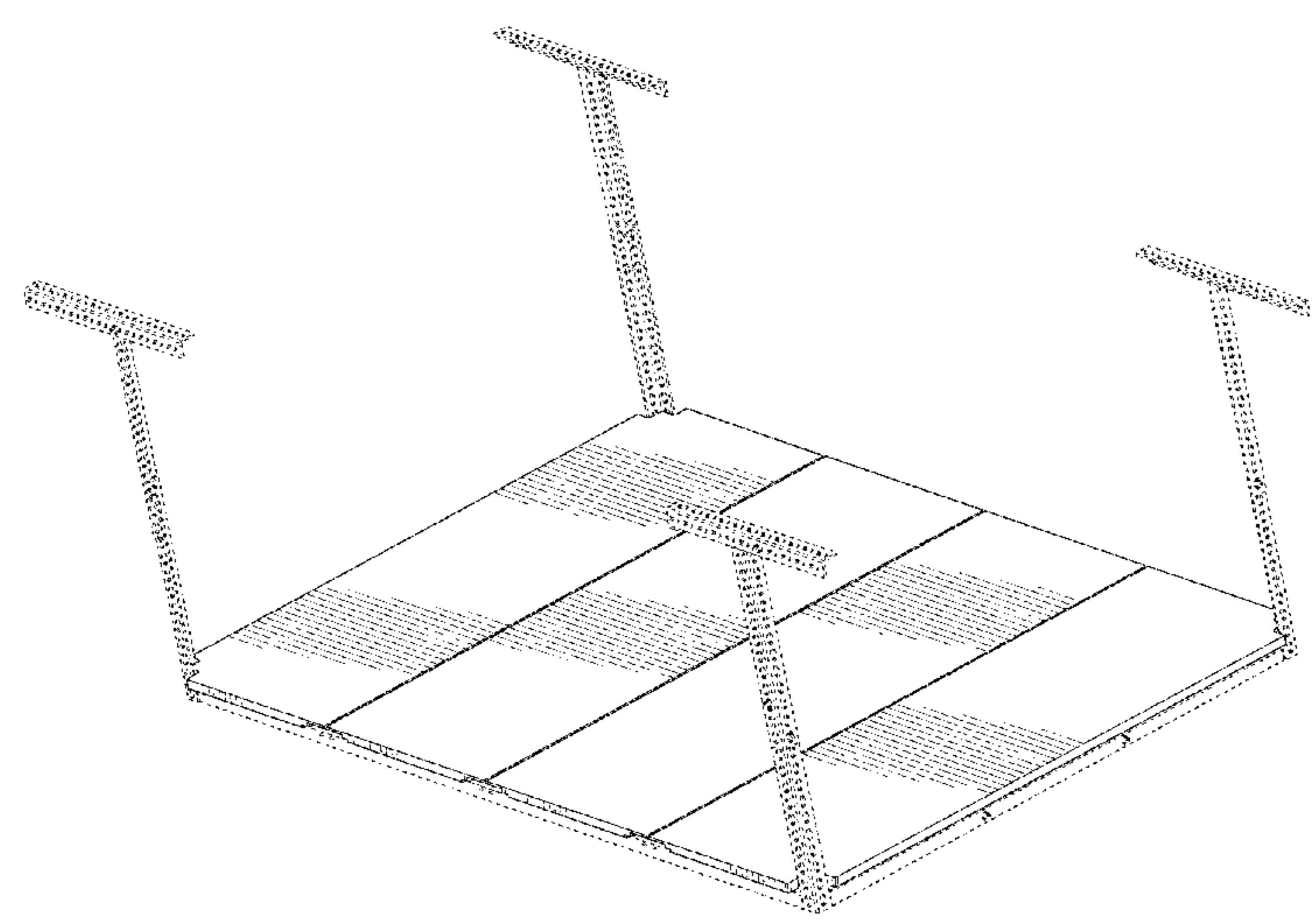
The ornamental design for a storage platform, as shown and described.

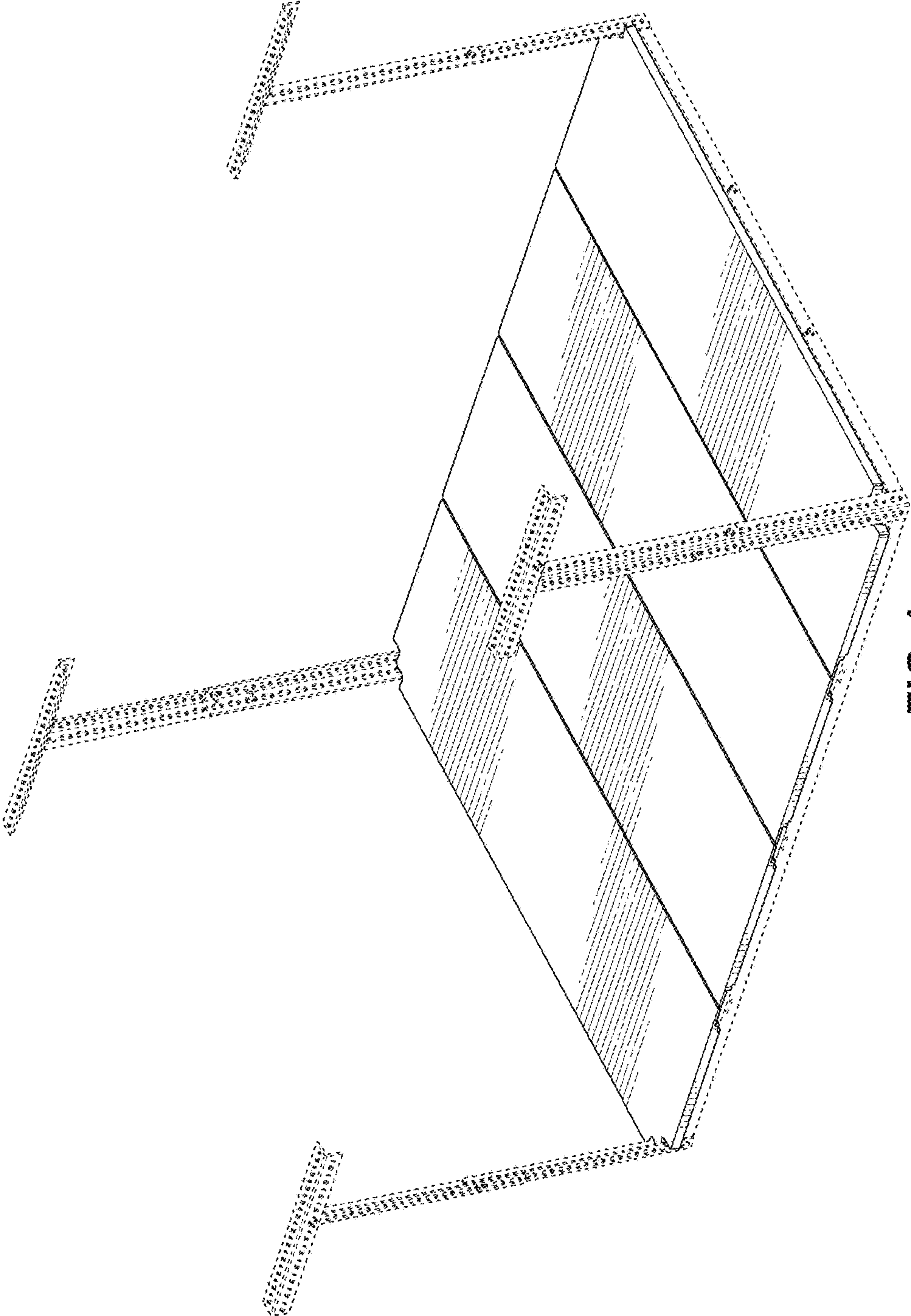

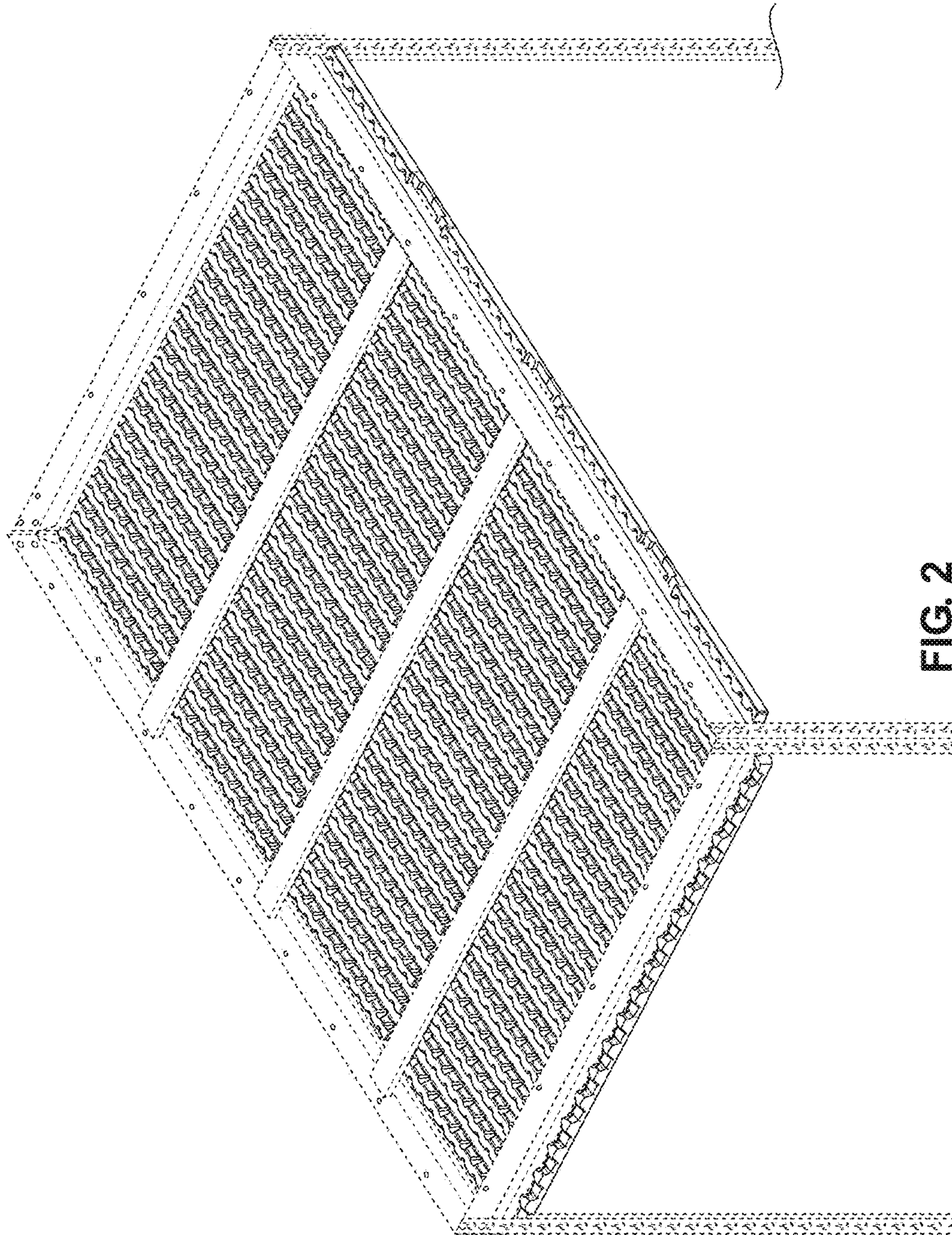

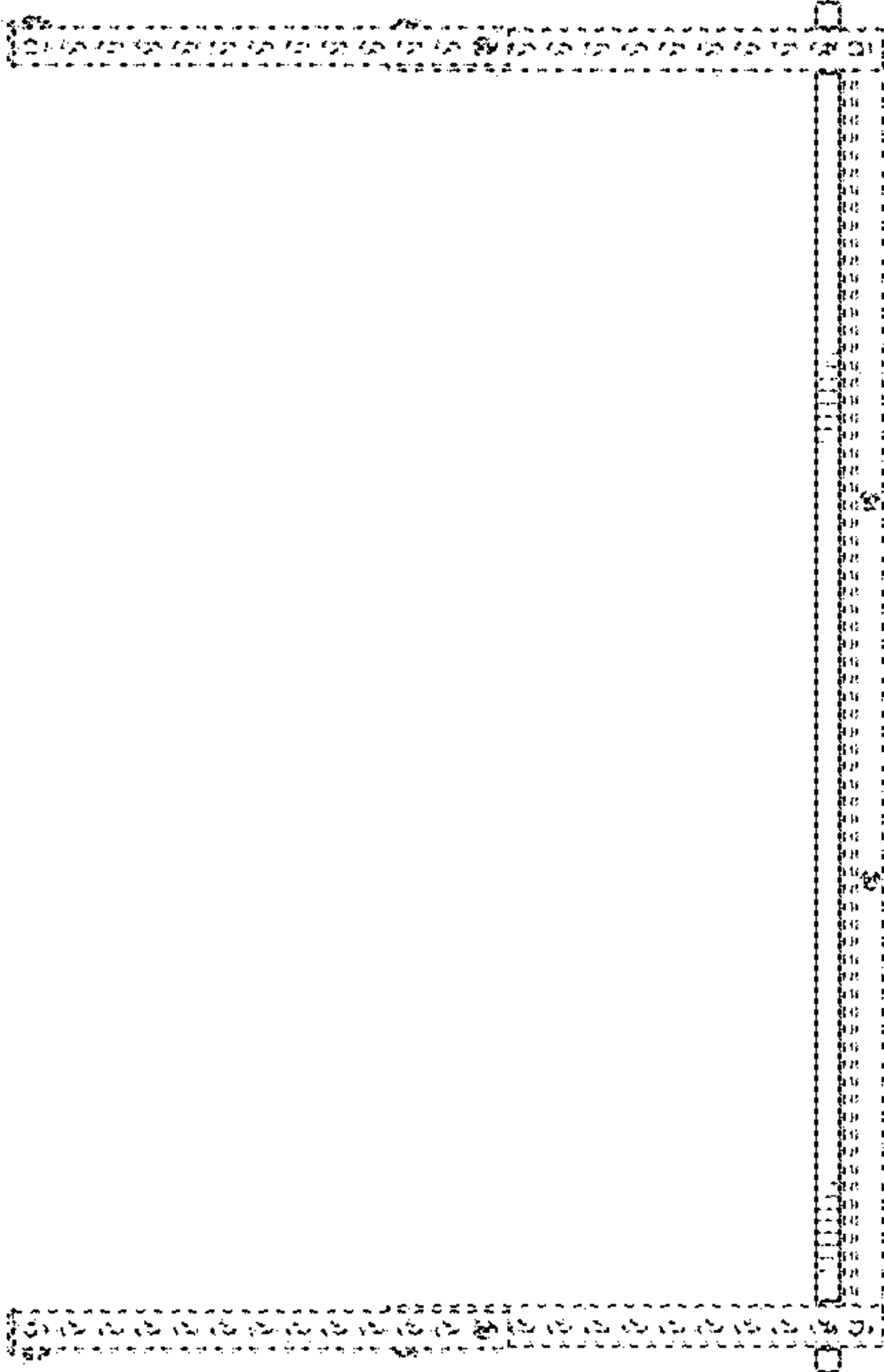

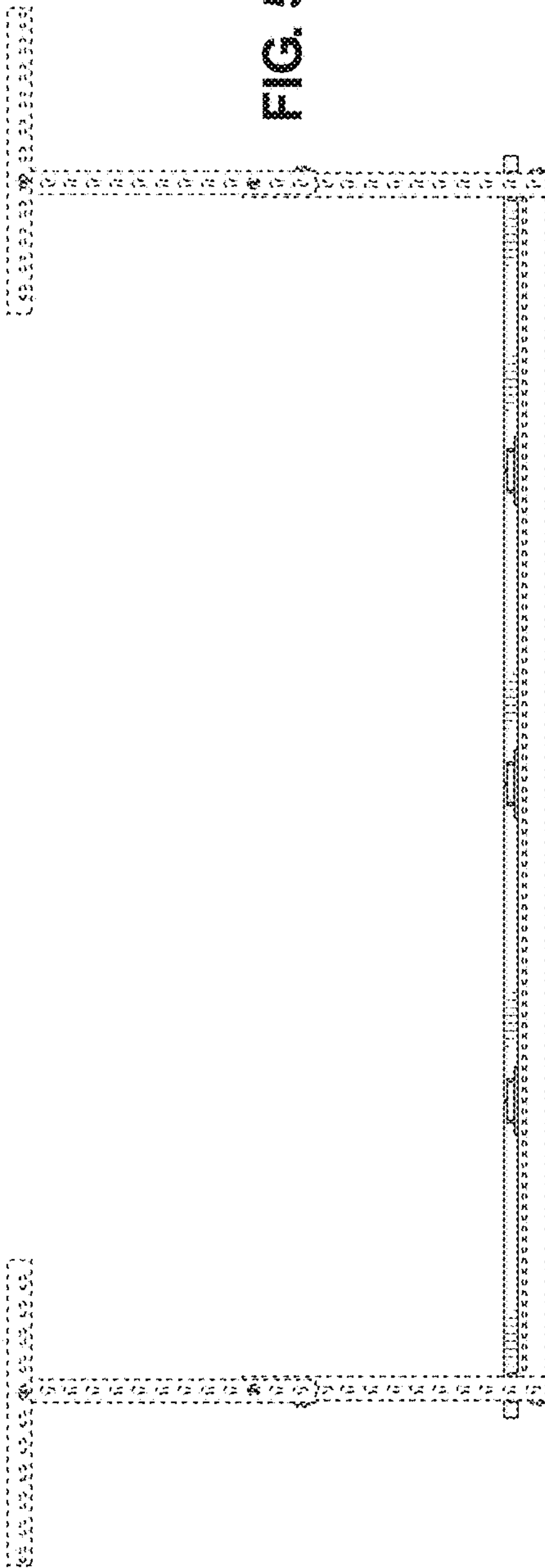
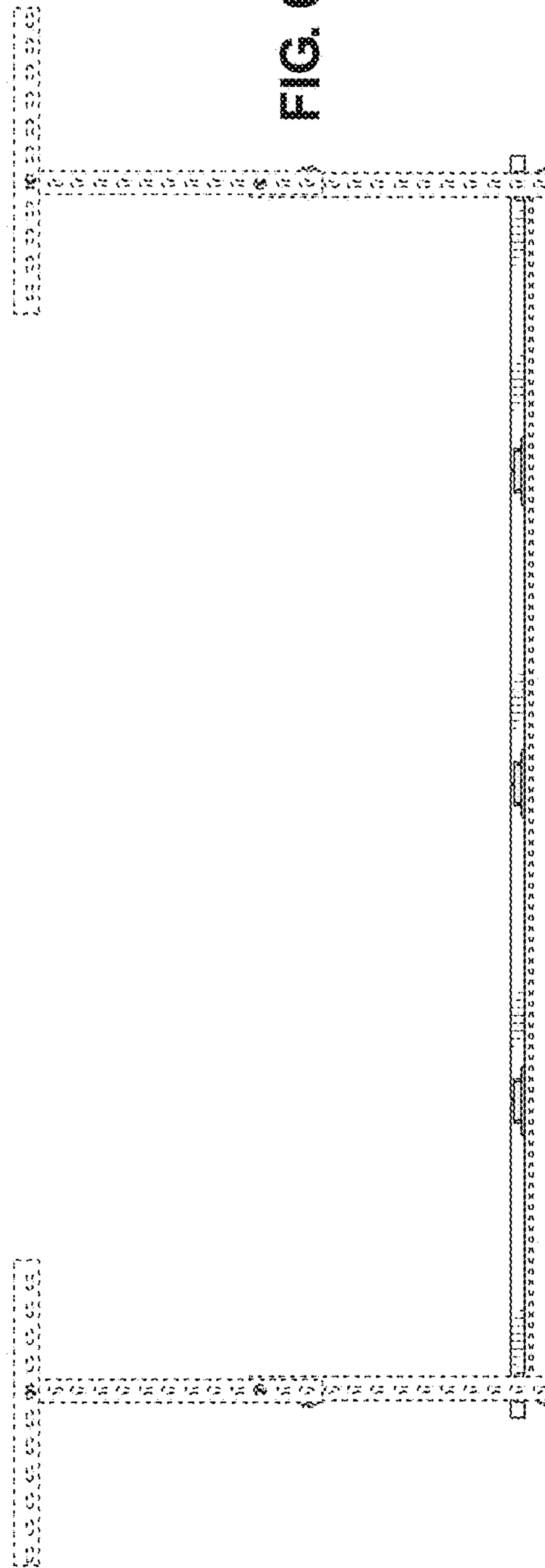

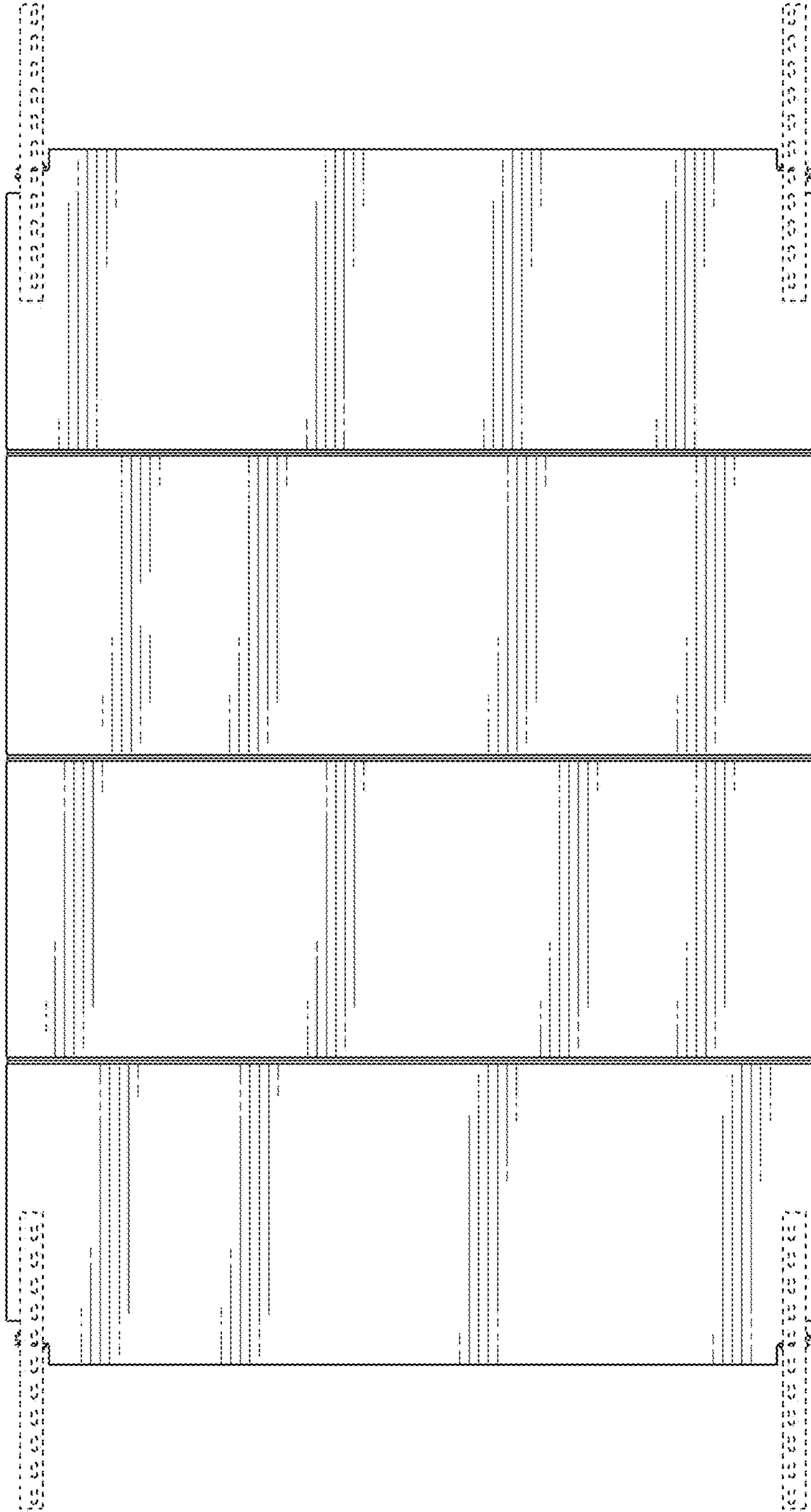

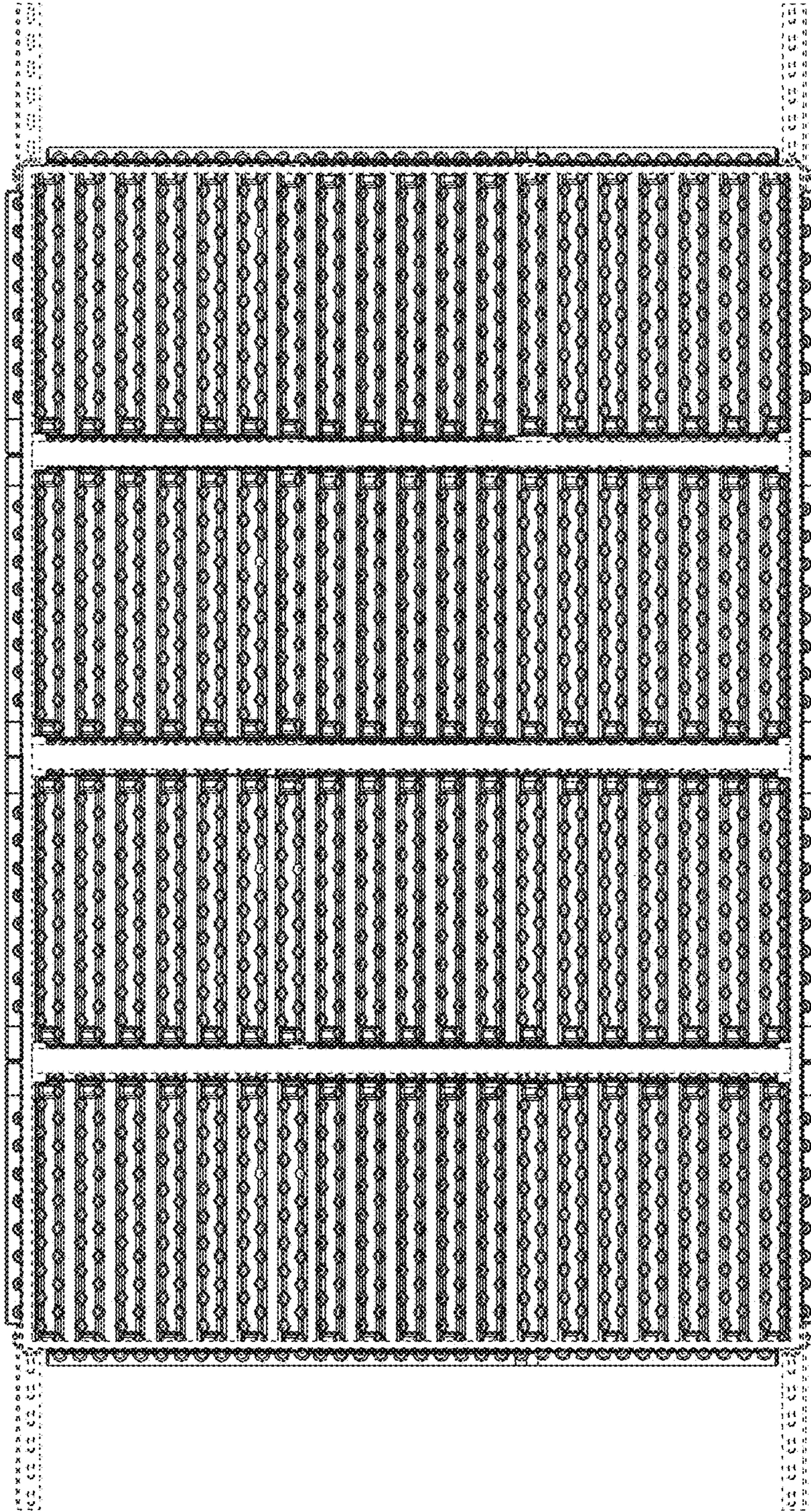

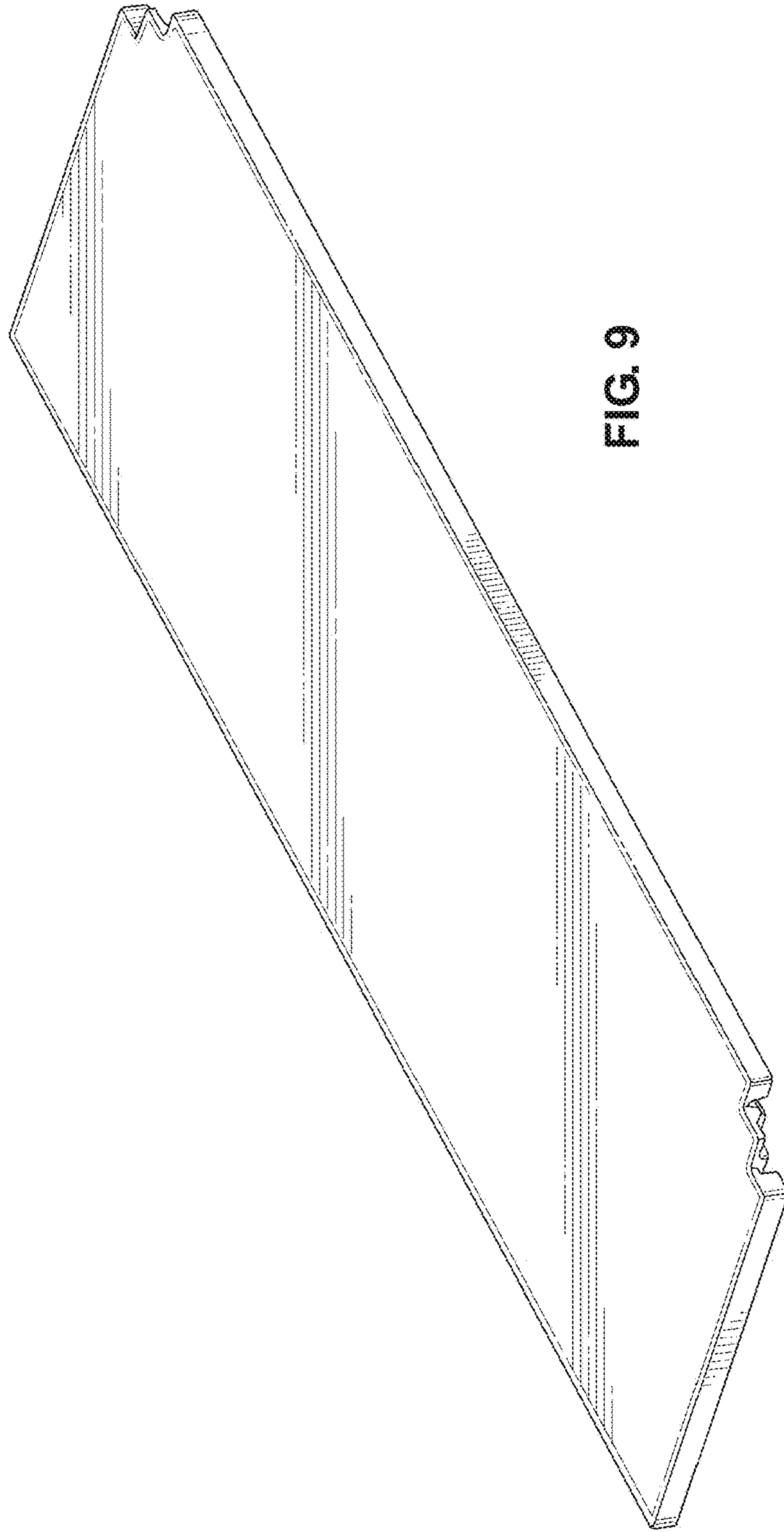

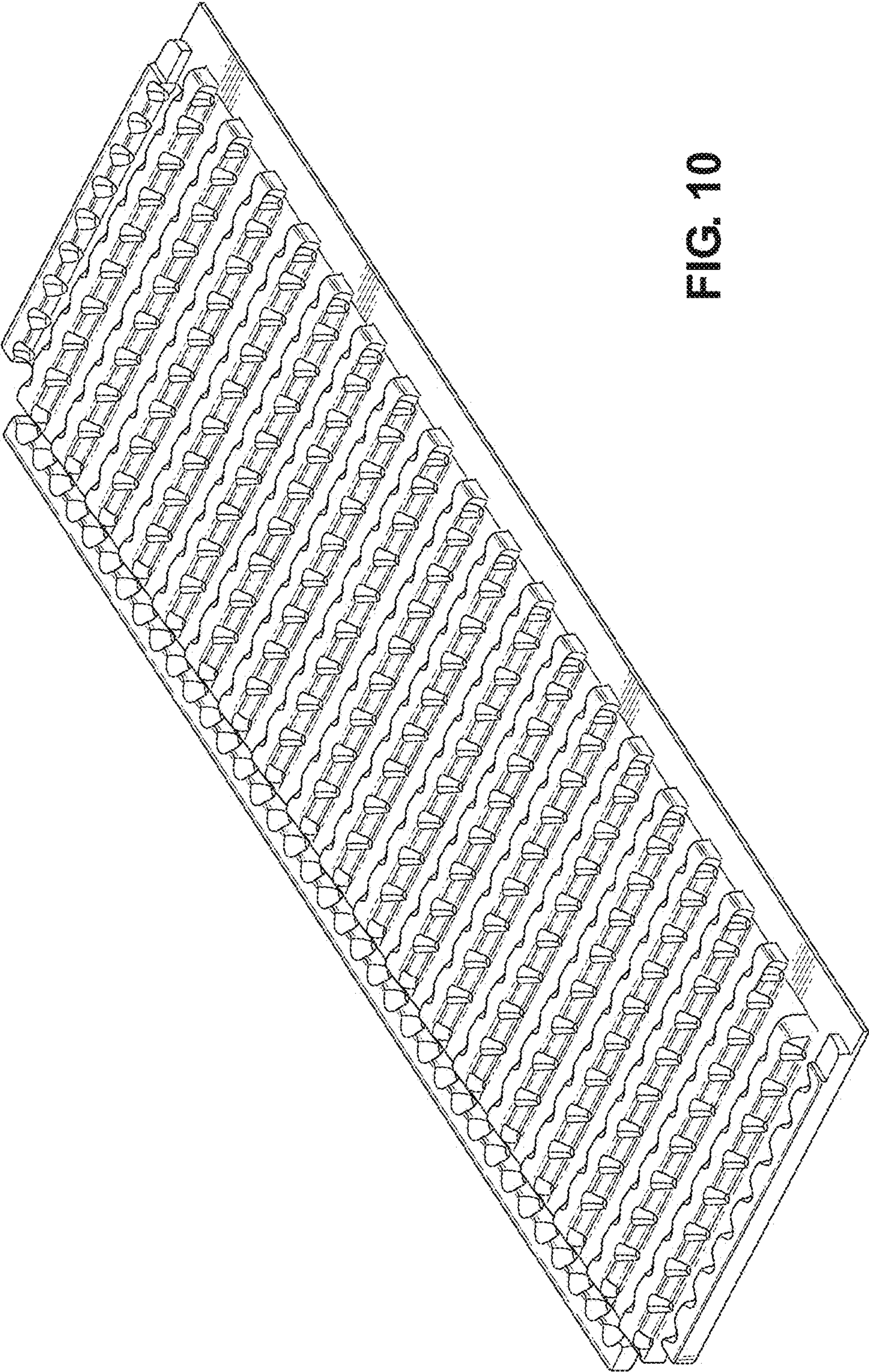
