DESCRIPTION

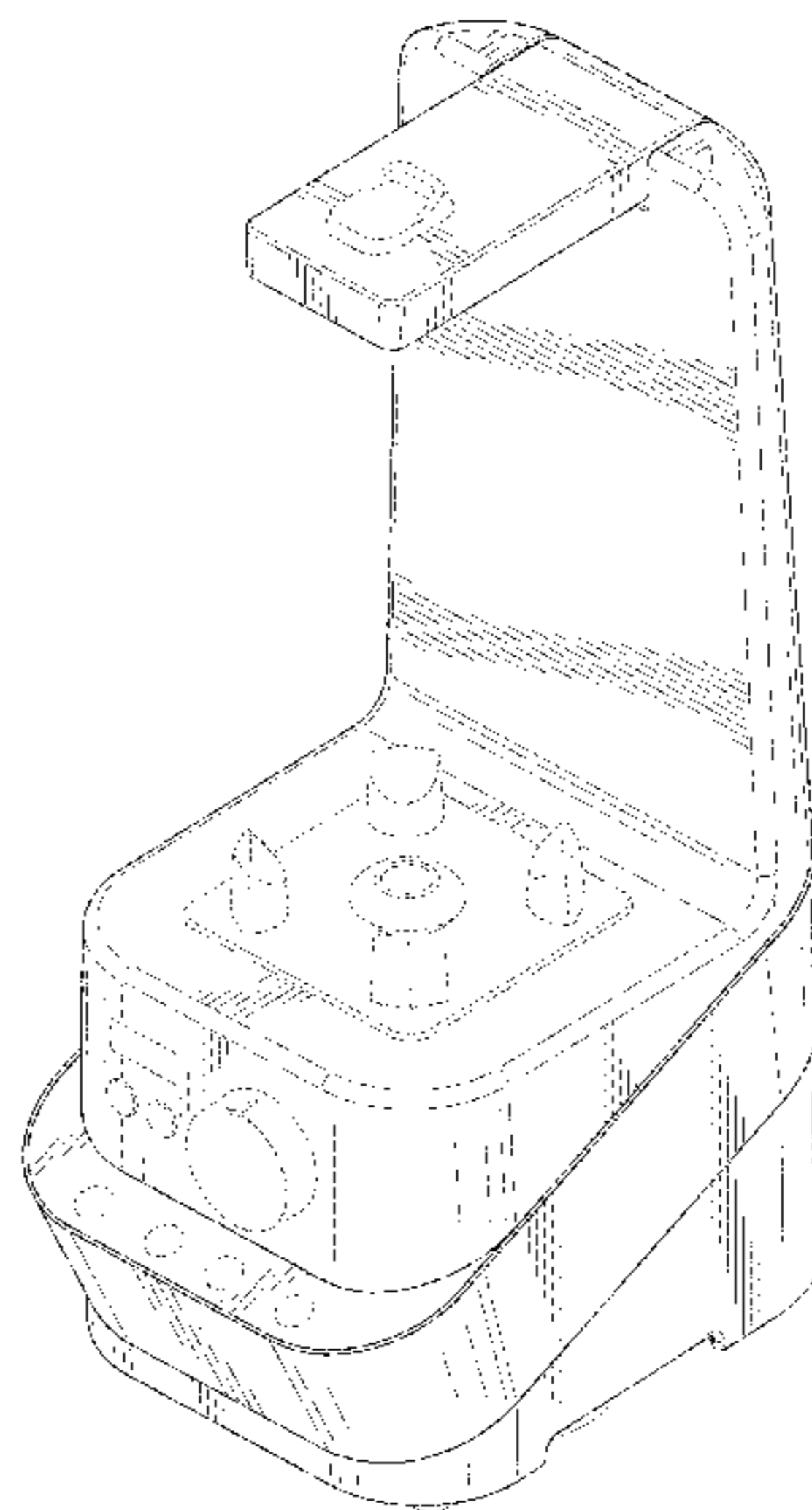
FIG. 1 is an elevated isometric view of a vacuum blender base showing the new design;

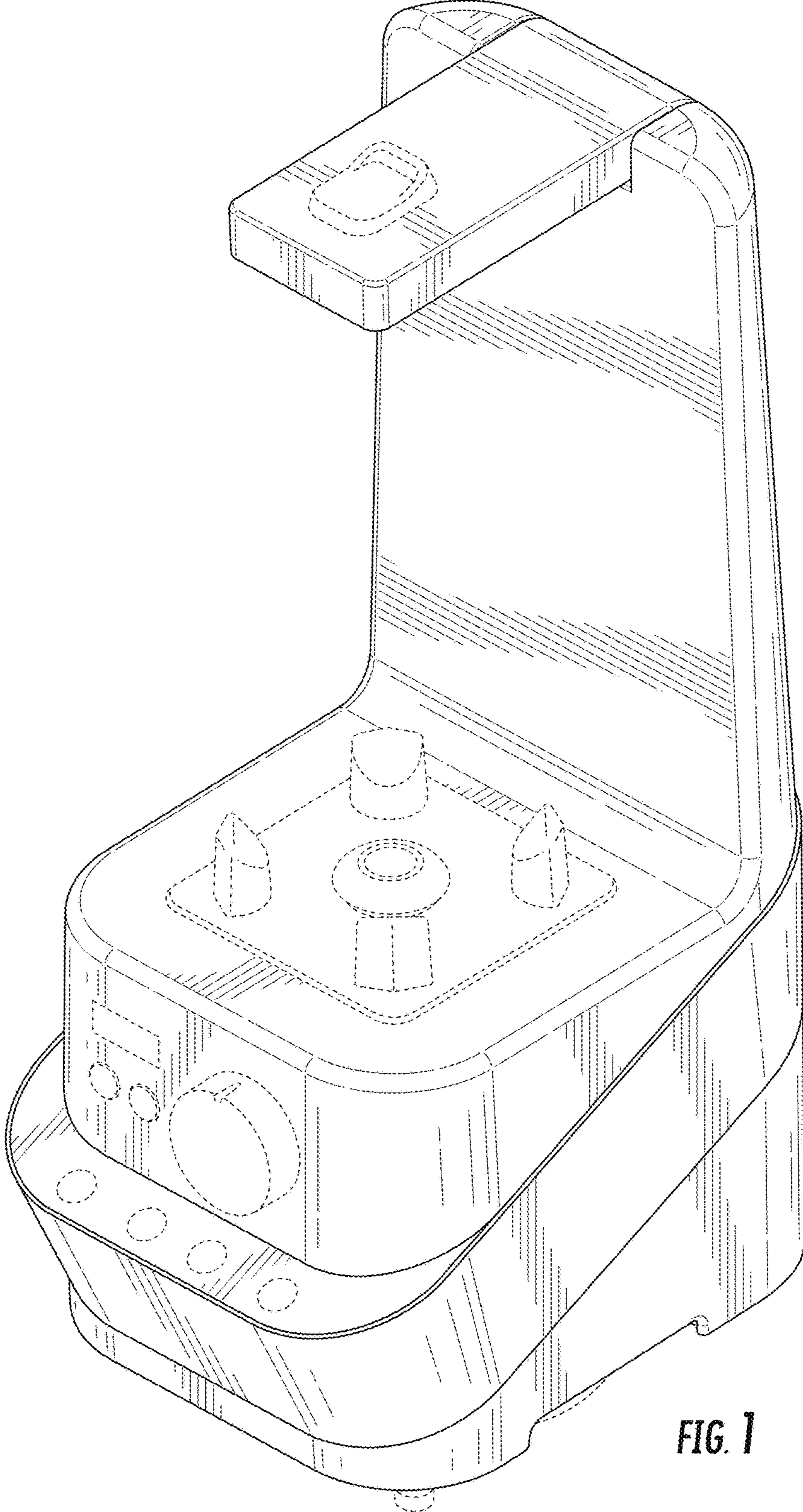

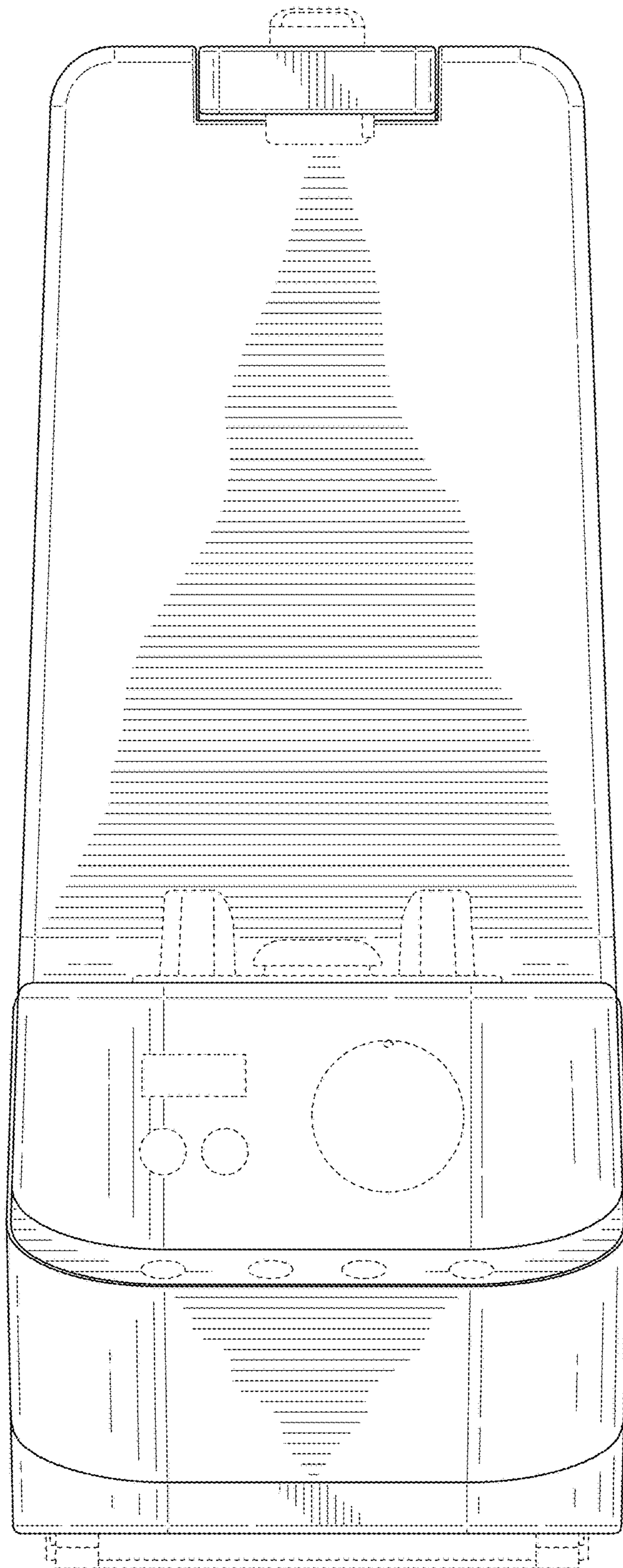

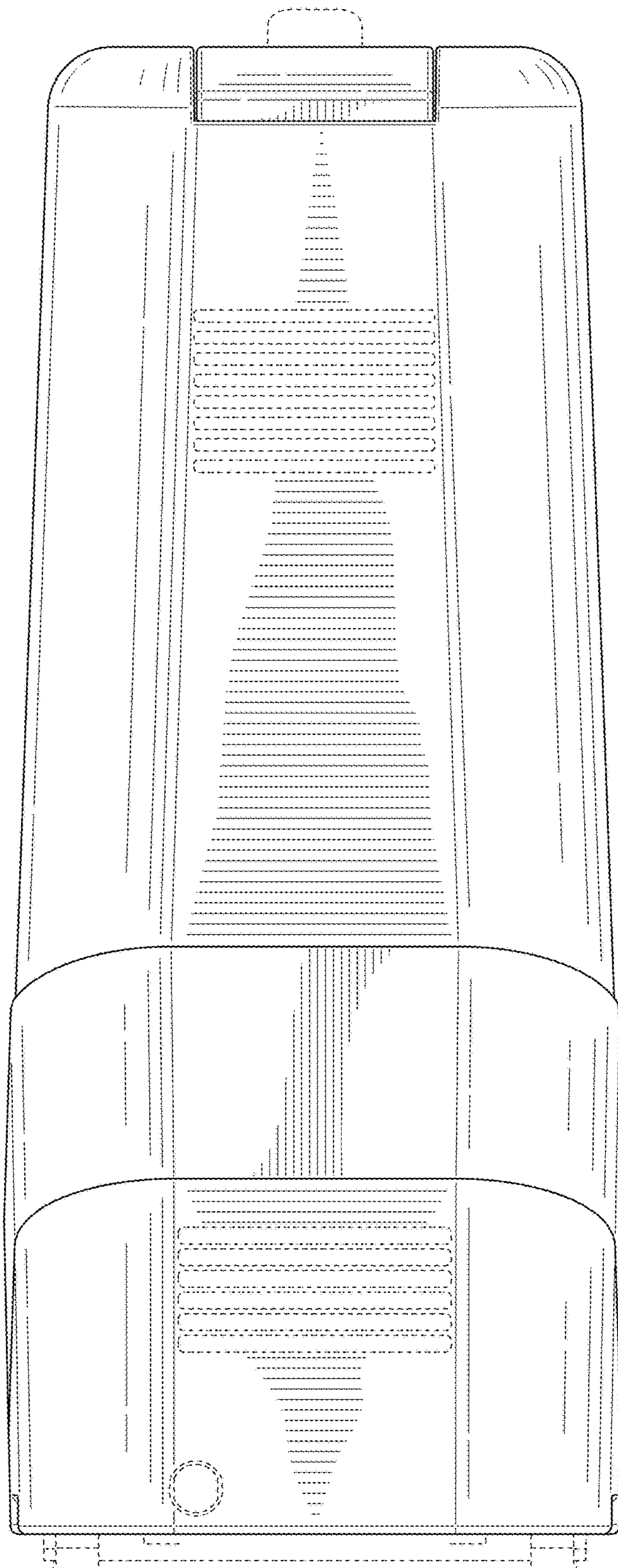

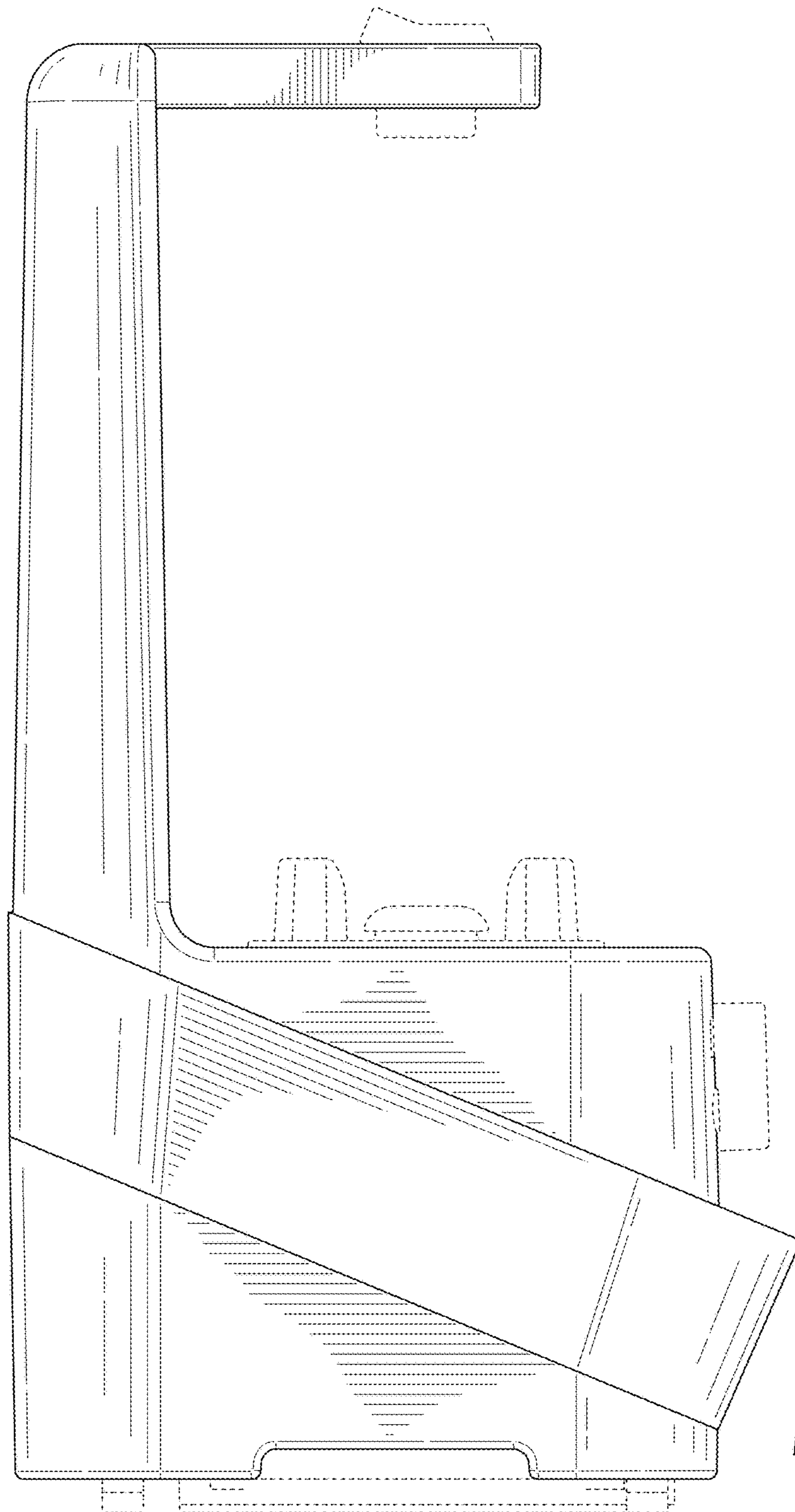

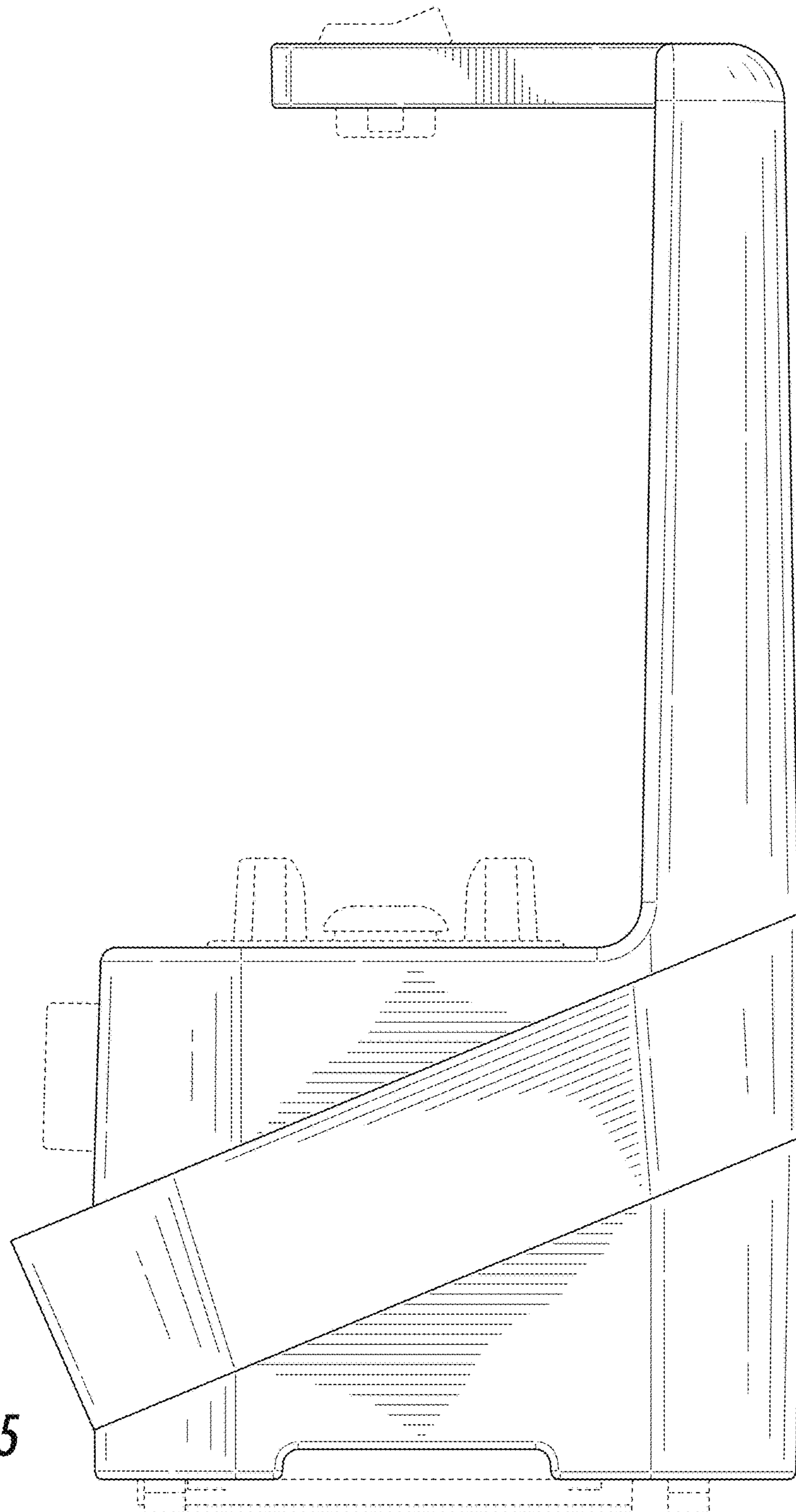

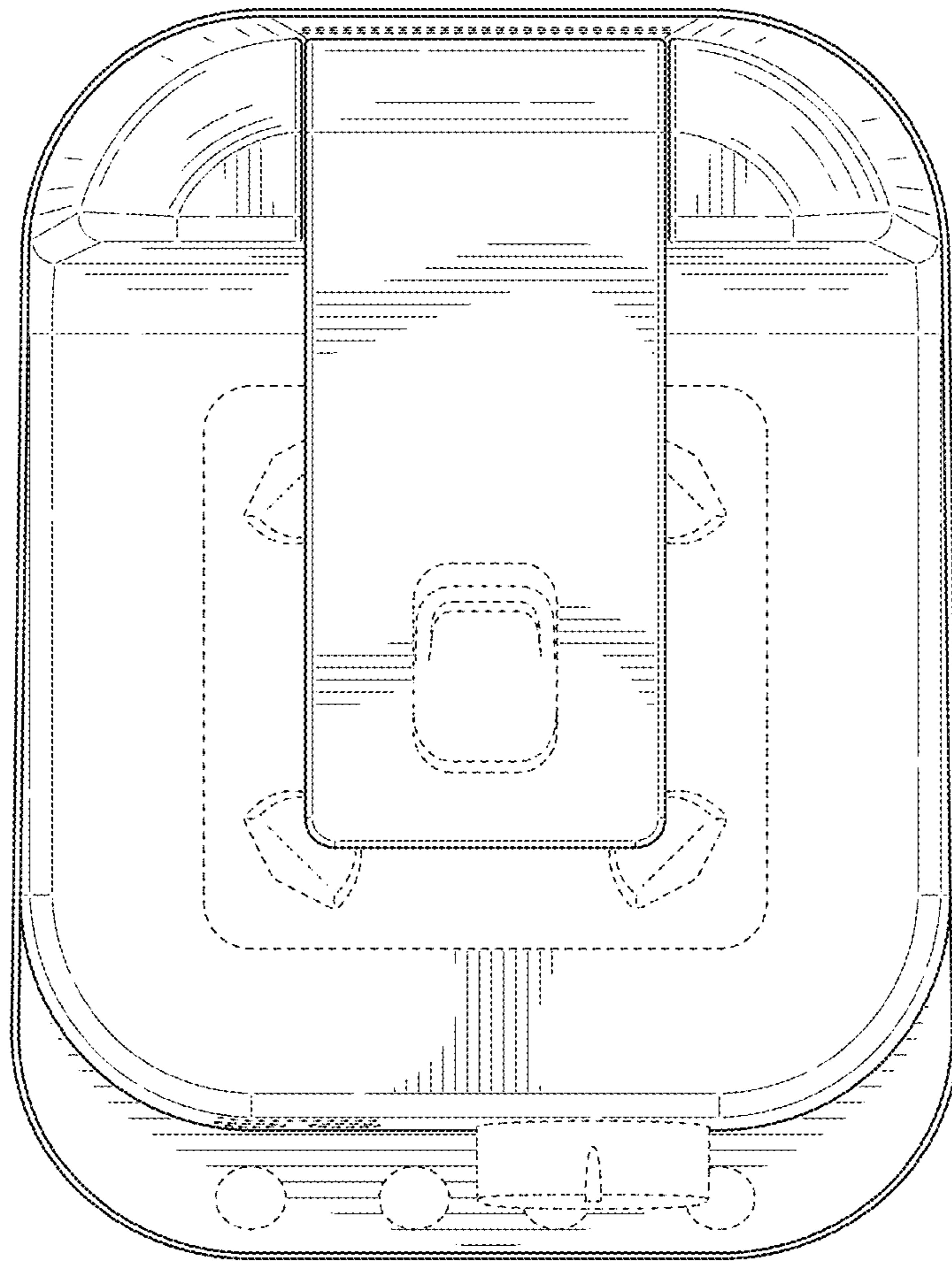

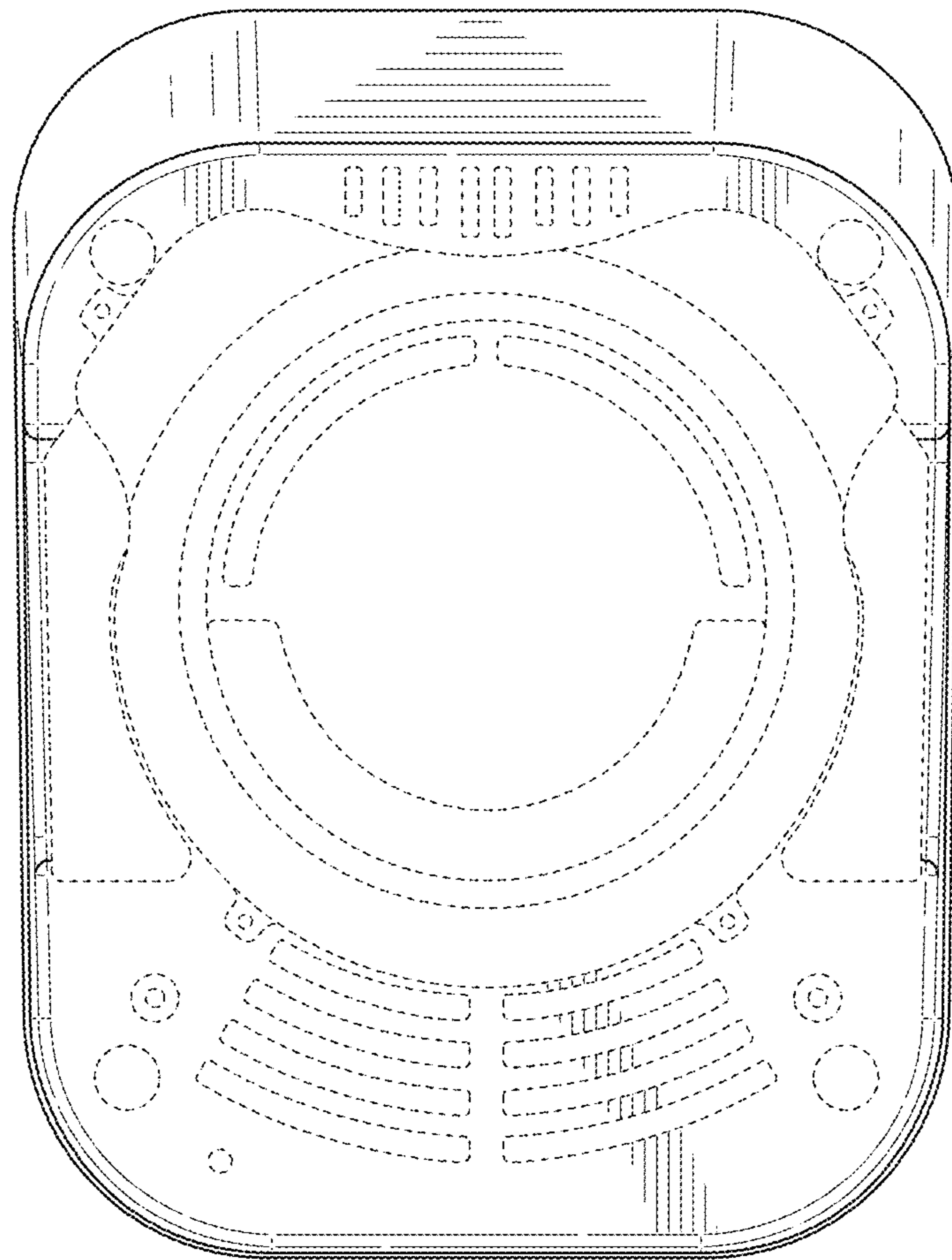
