The ornamental design for an antiperspirant barrel, as shown and described.

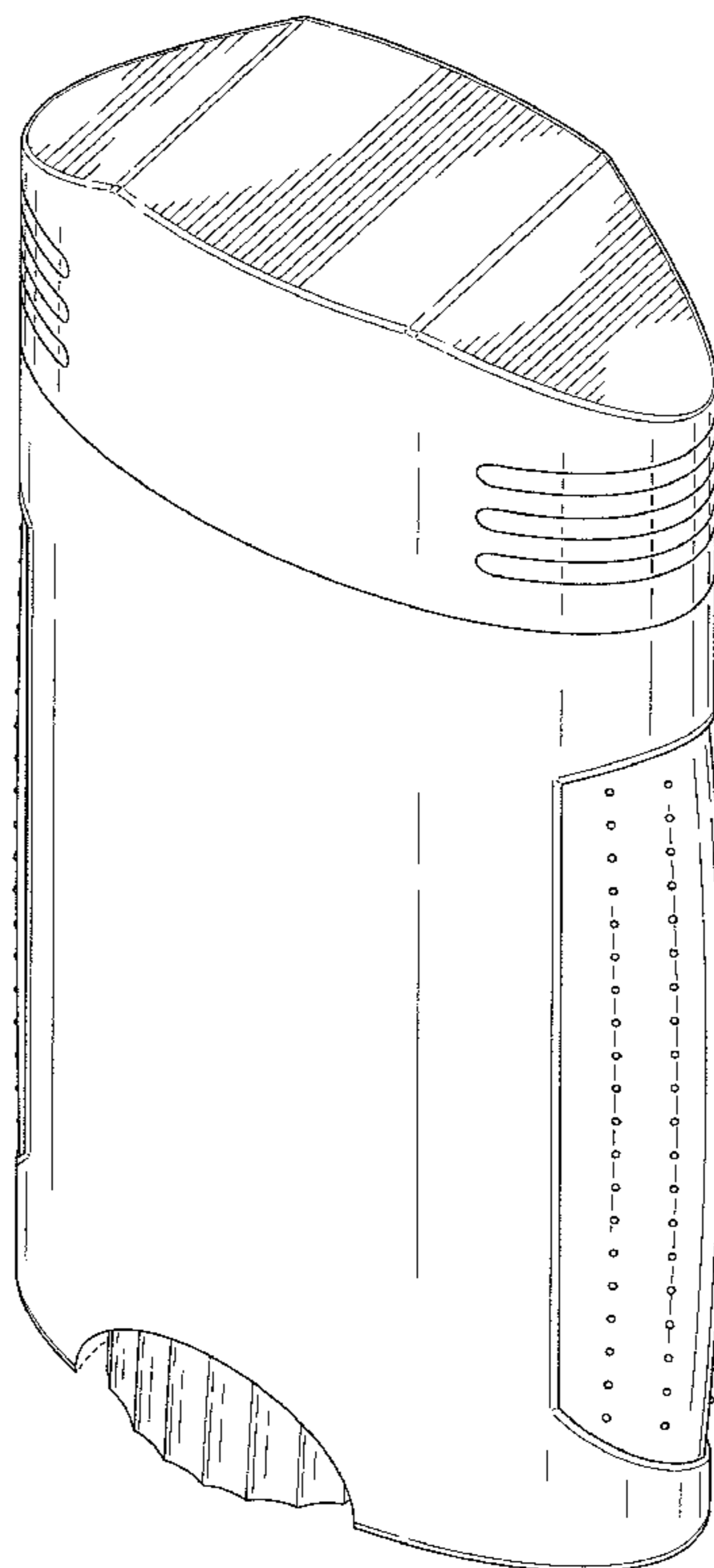
DESCRIPTION

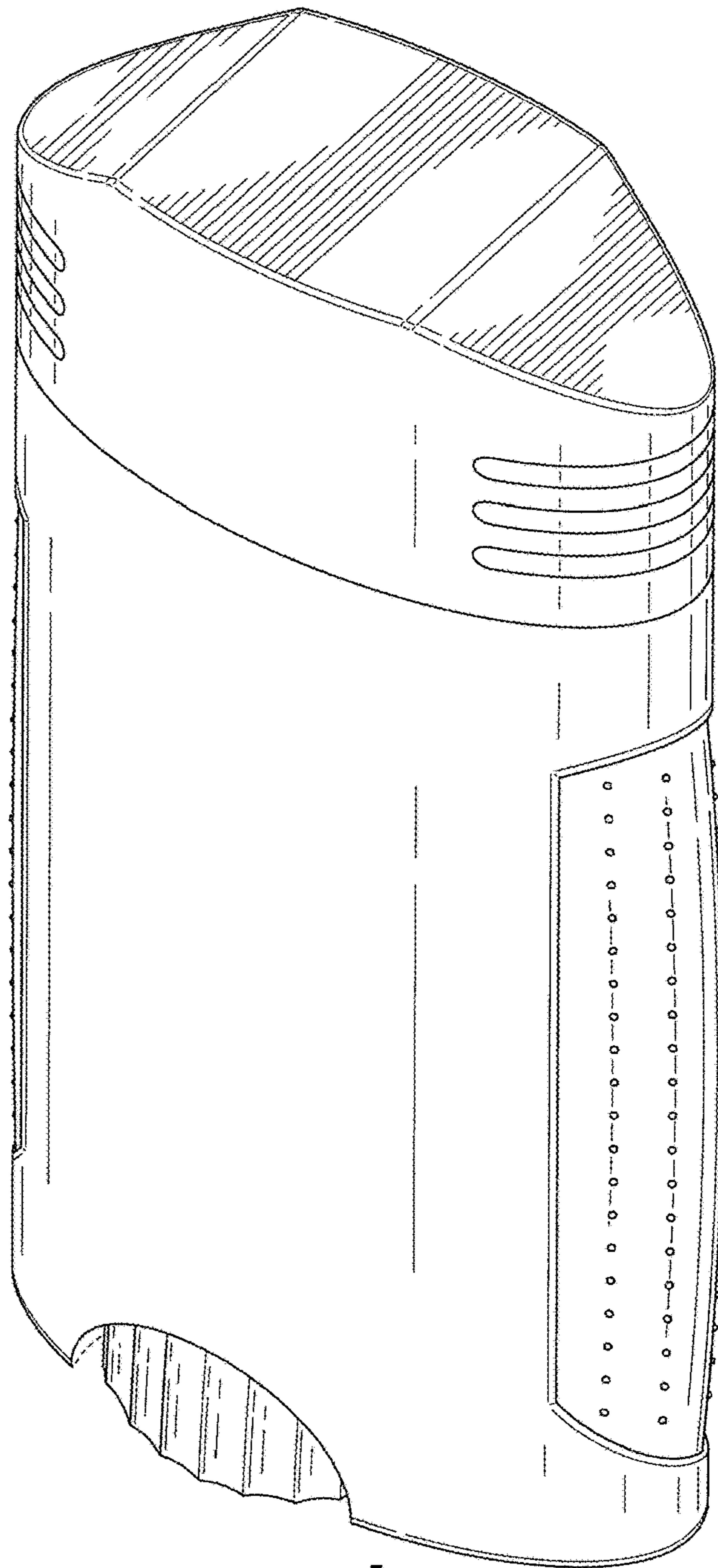

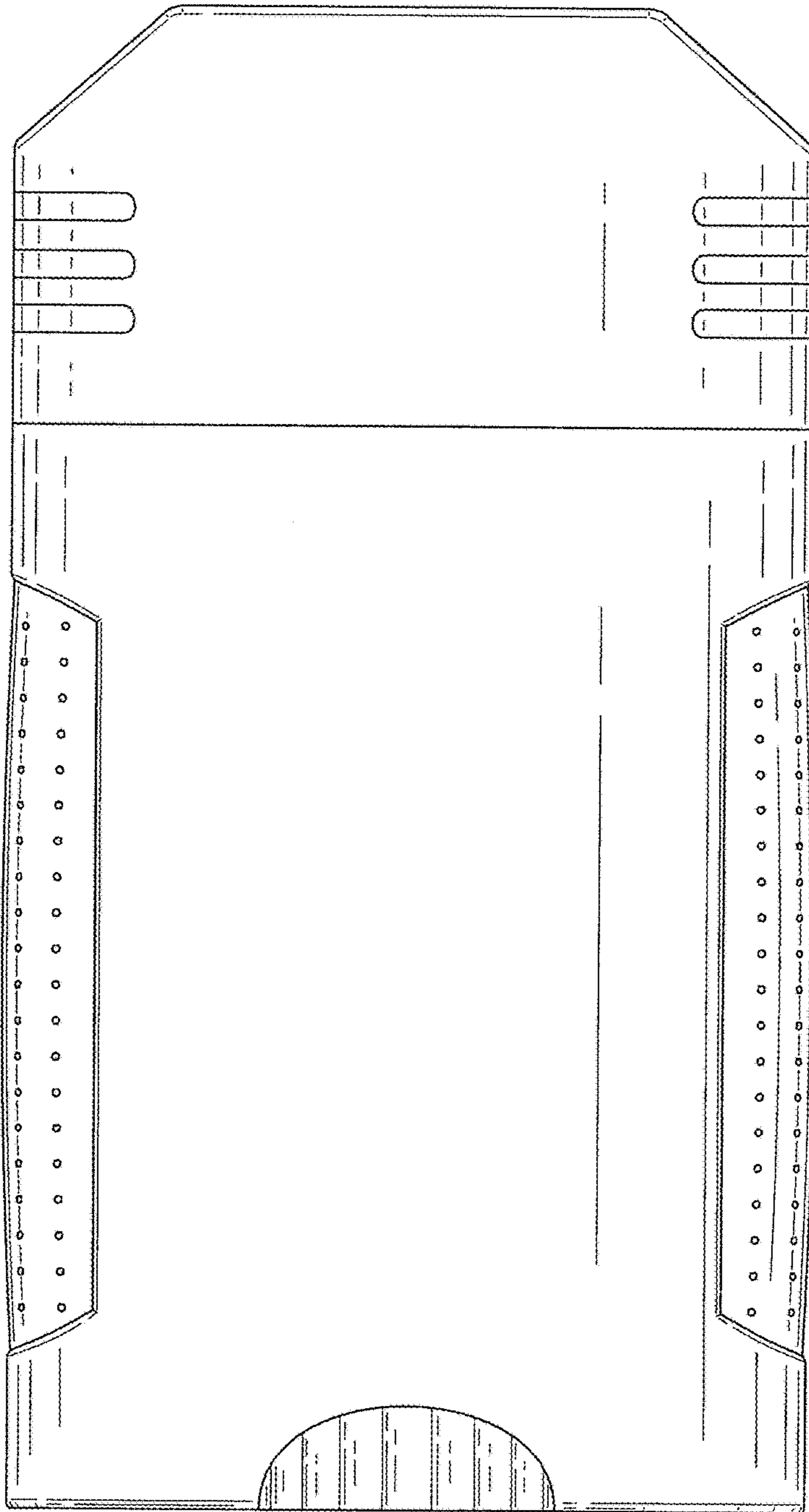

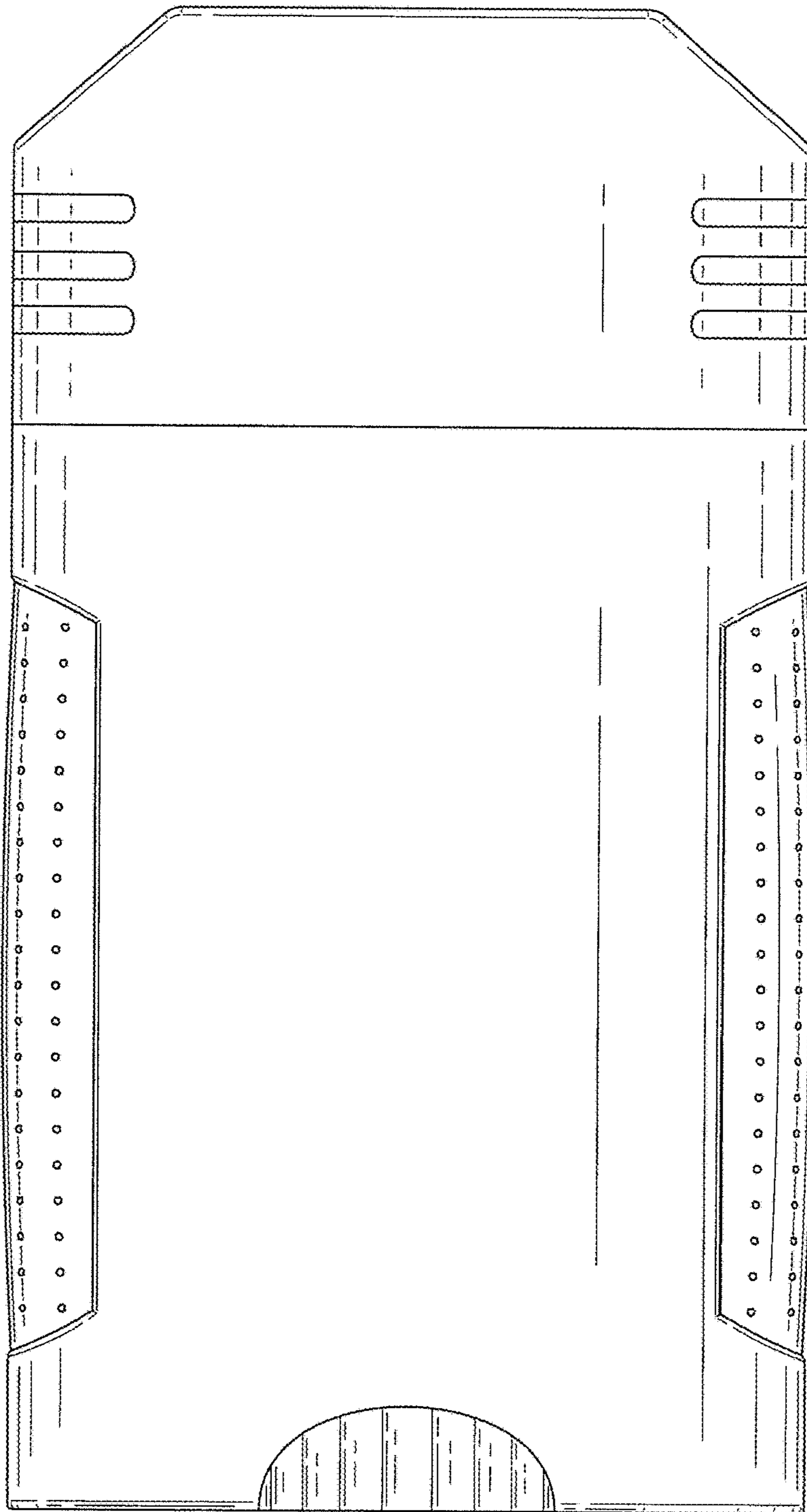

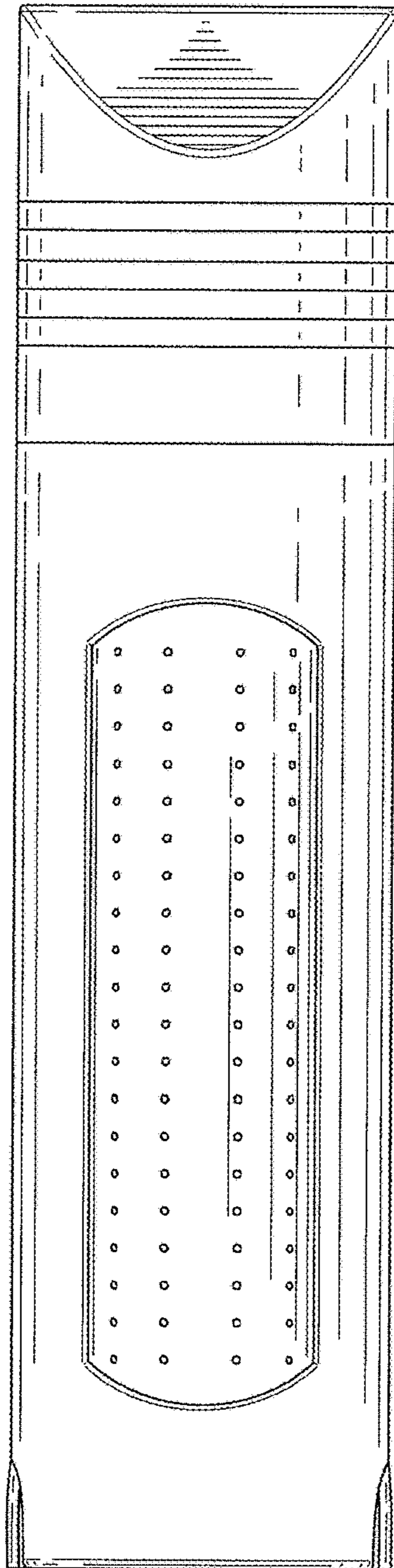

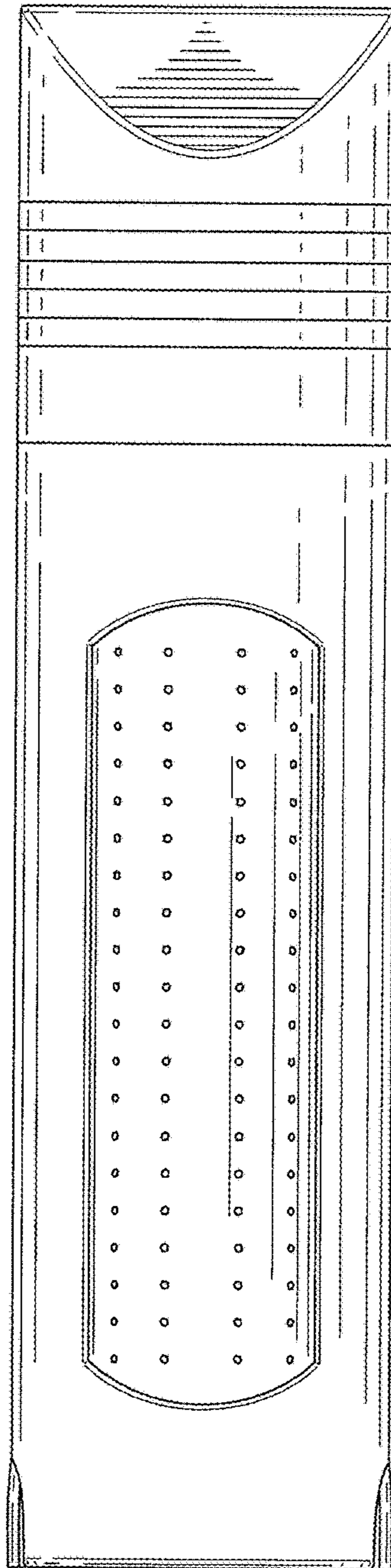

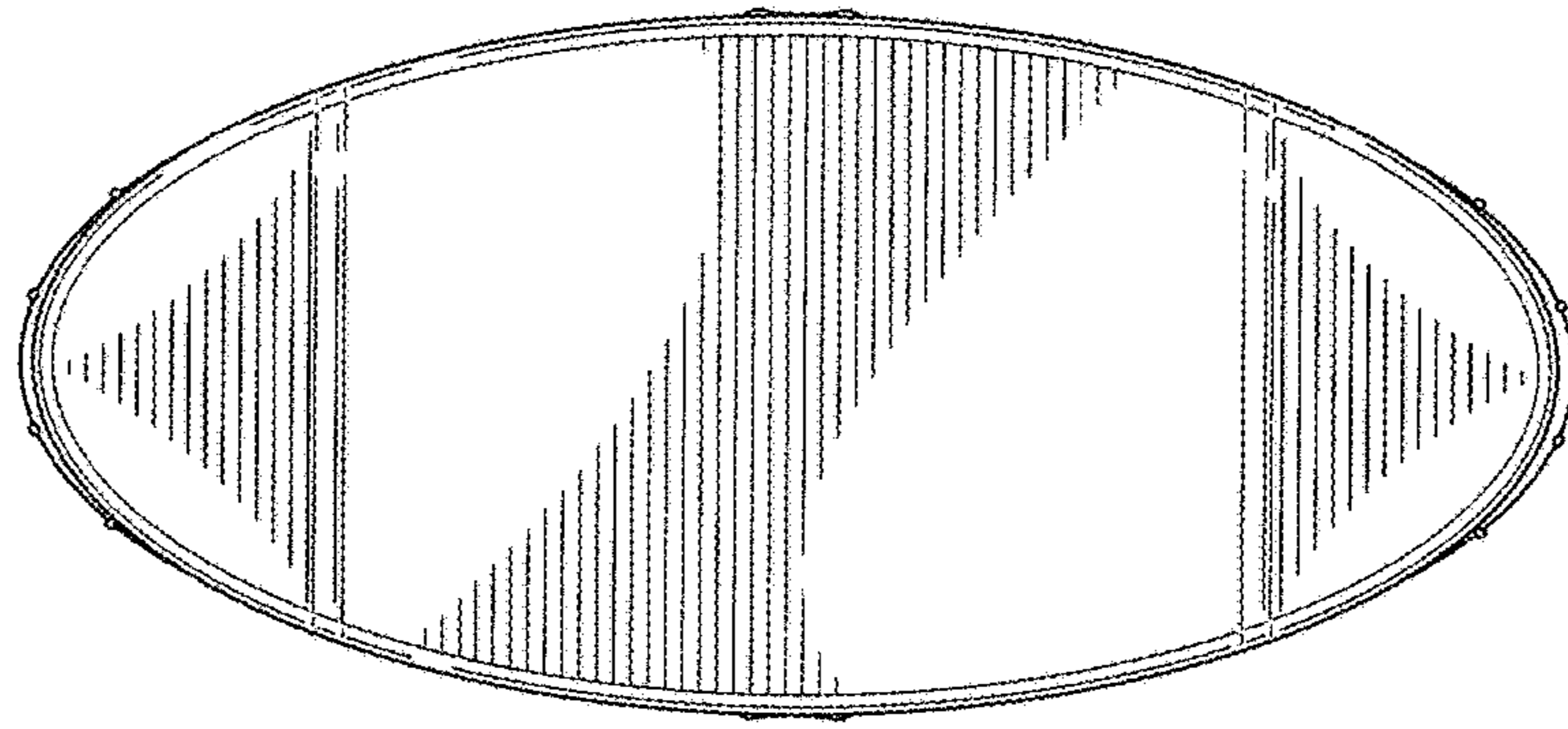

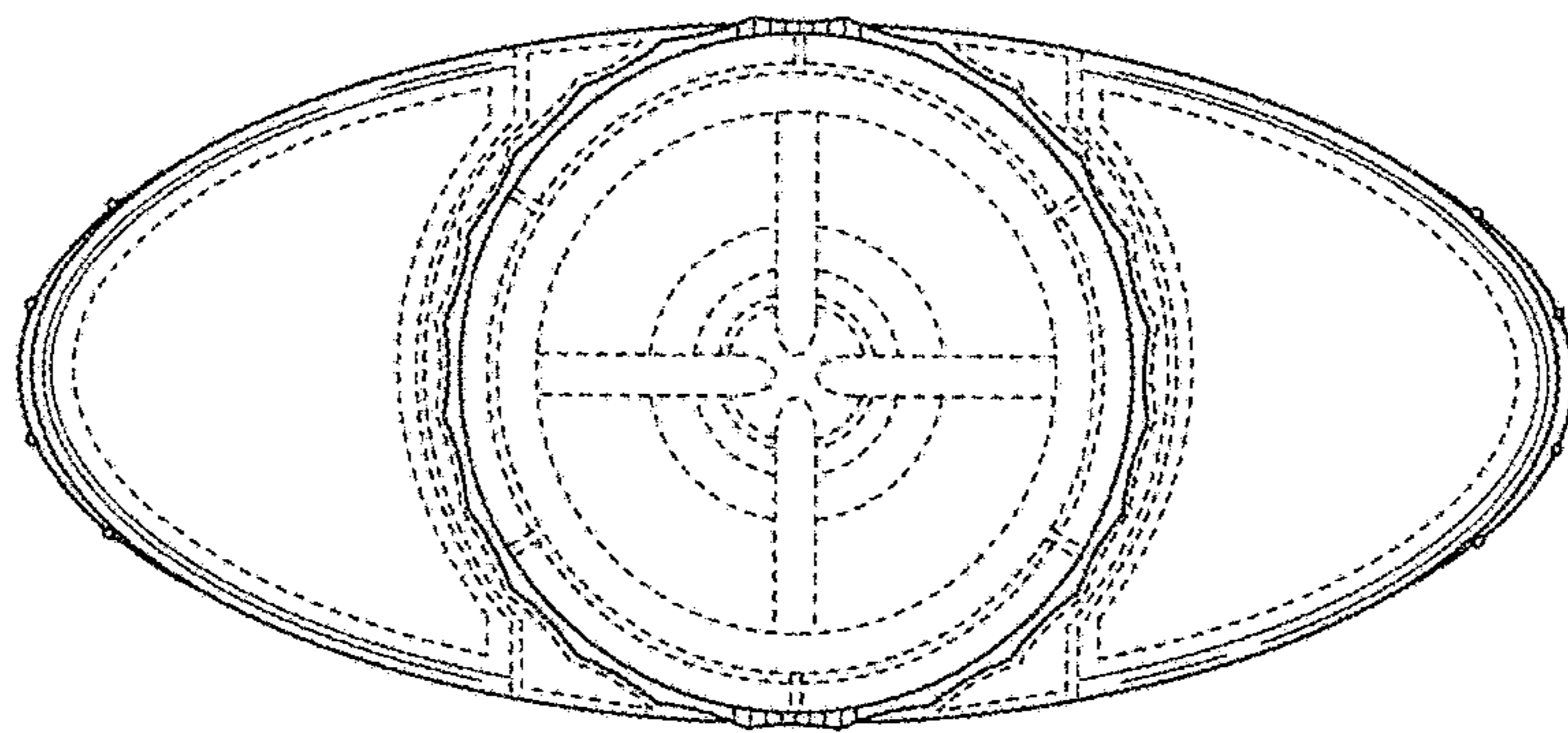
