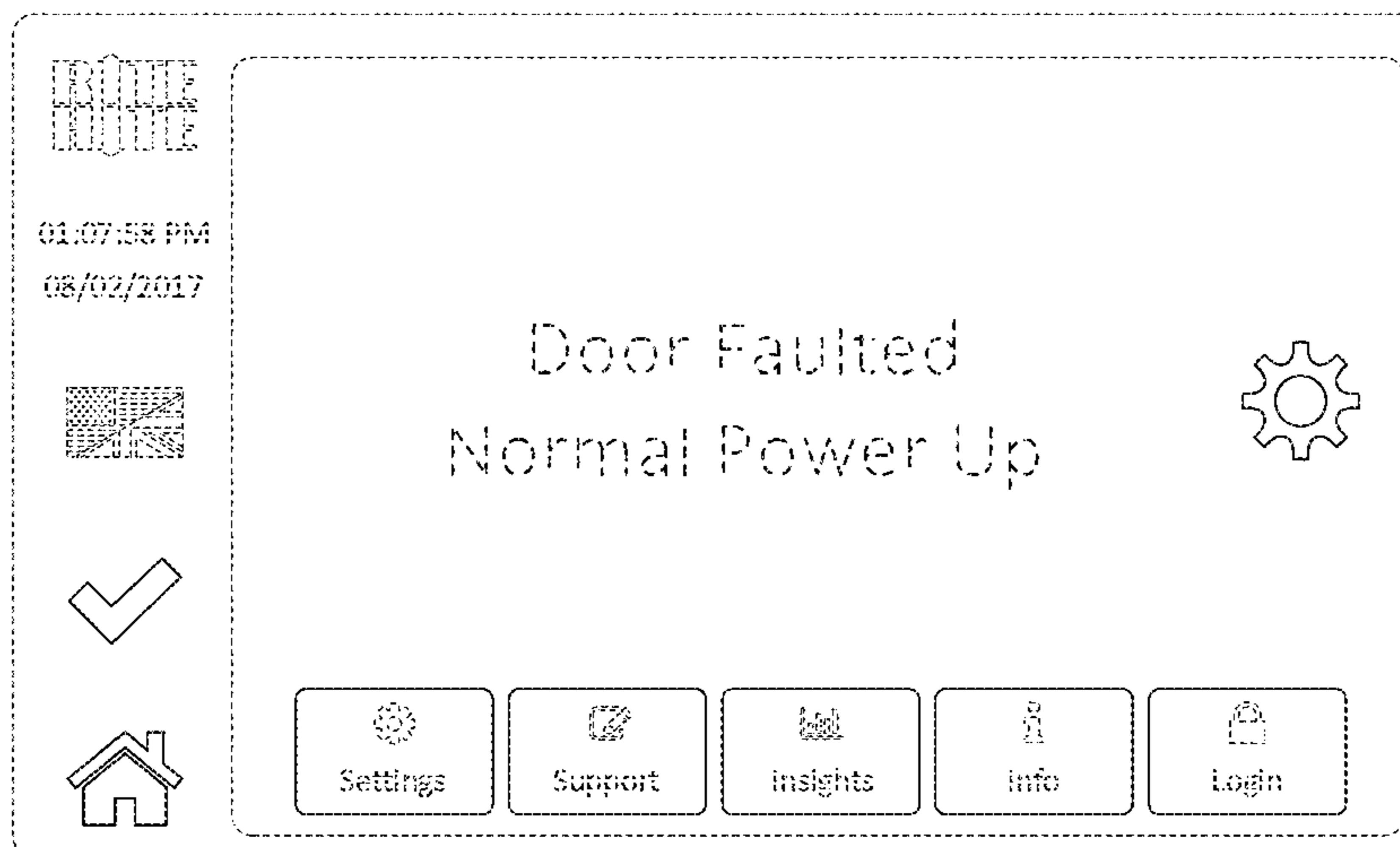
The ornamental design for a “touchscreen display with graphical user interface,” as shown and described.
