(57) **CLAIM**

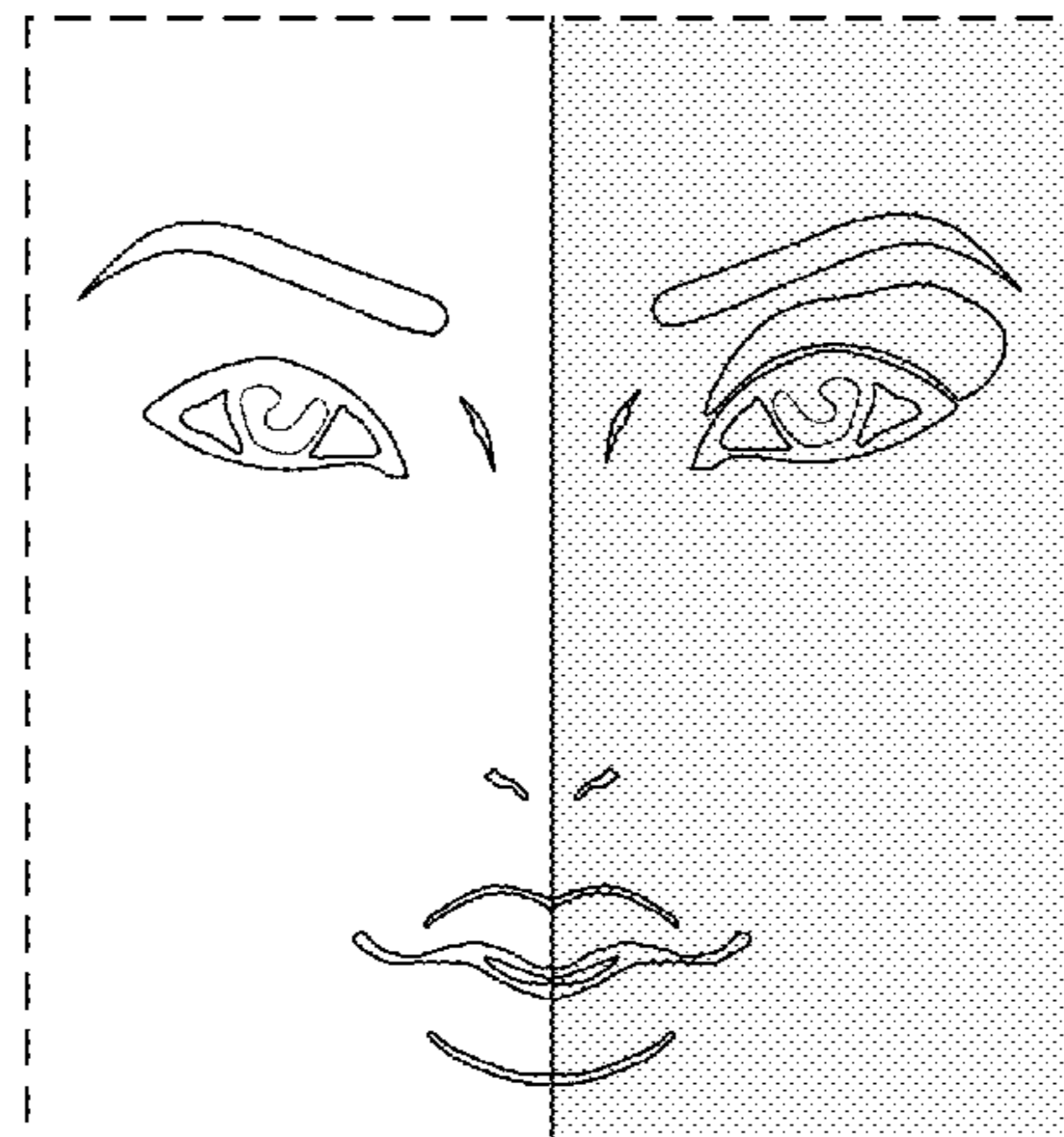
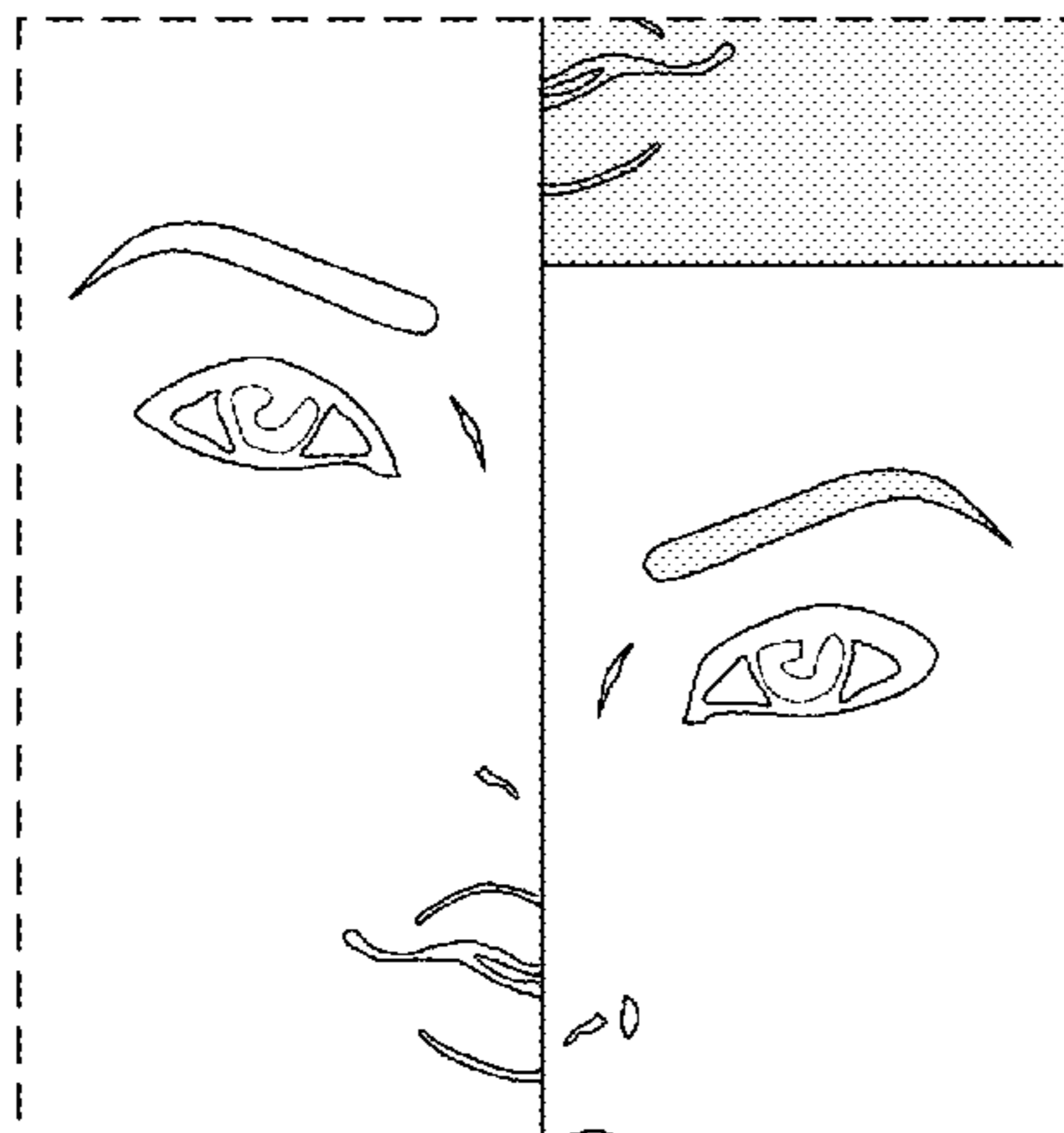
The ornamental design for the display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in the sequence of a display screen or portion thereof with animated graphical user interface showing our new design; FIG. 2 is a front view of a second image thereof; FIG. 3 is a front view of a third image thereof; FIG. 4 is a front view of a fourth image thereof; and, FIG. 5 is a front view of a fifth image thereof.

The dashed broken line rectangle illustrates a display screen or a portion thereof and forms no part of the claimed design. The gray tones illustrate portions of an animated graphical user interface that form no part of the claimed design. The appearance of the animated images sequentially transitions from FIG. 1 to FIG. 5 in a first embodiment, and from FIG. 5 to FIG. 1 in a second embodiment. The process or period in which one image transitions to another forms no part of the claimed design.

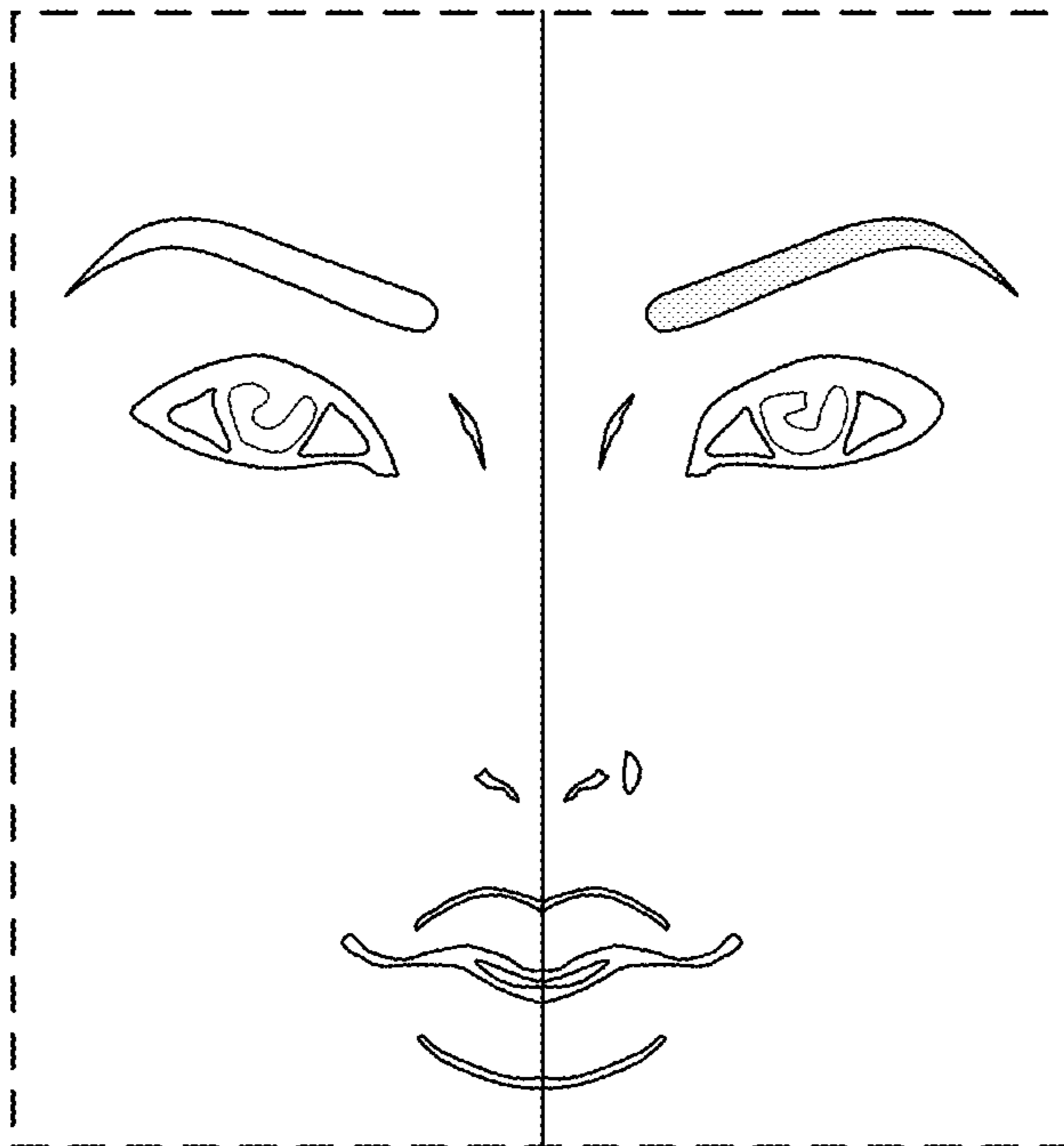

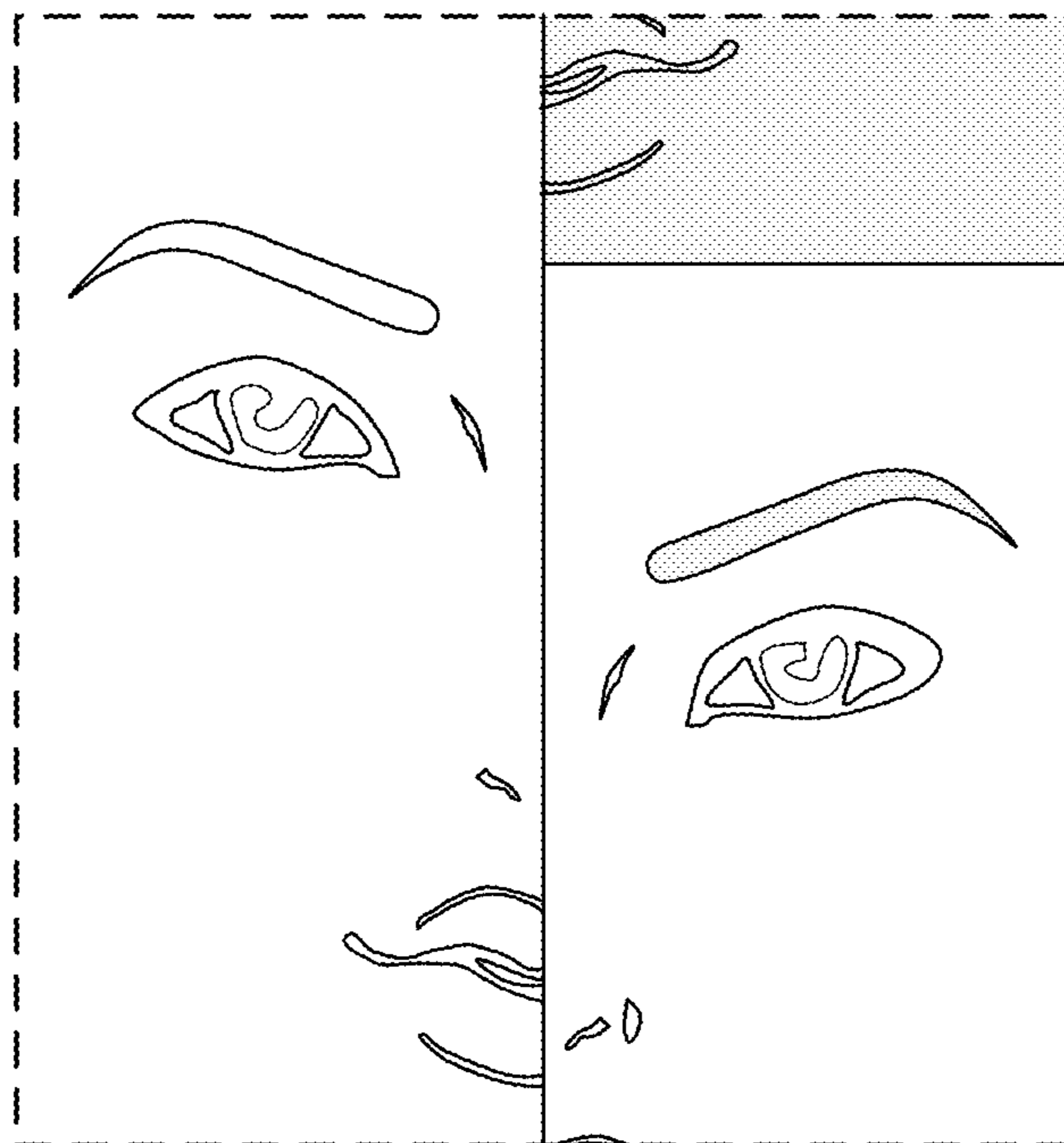

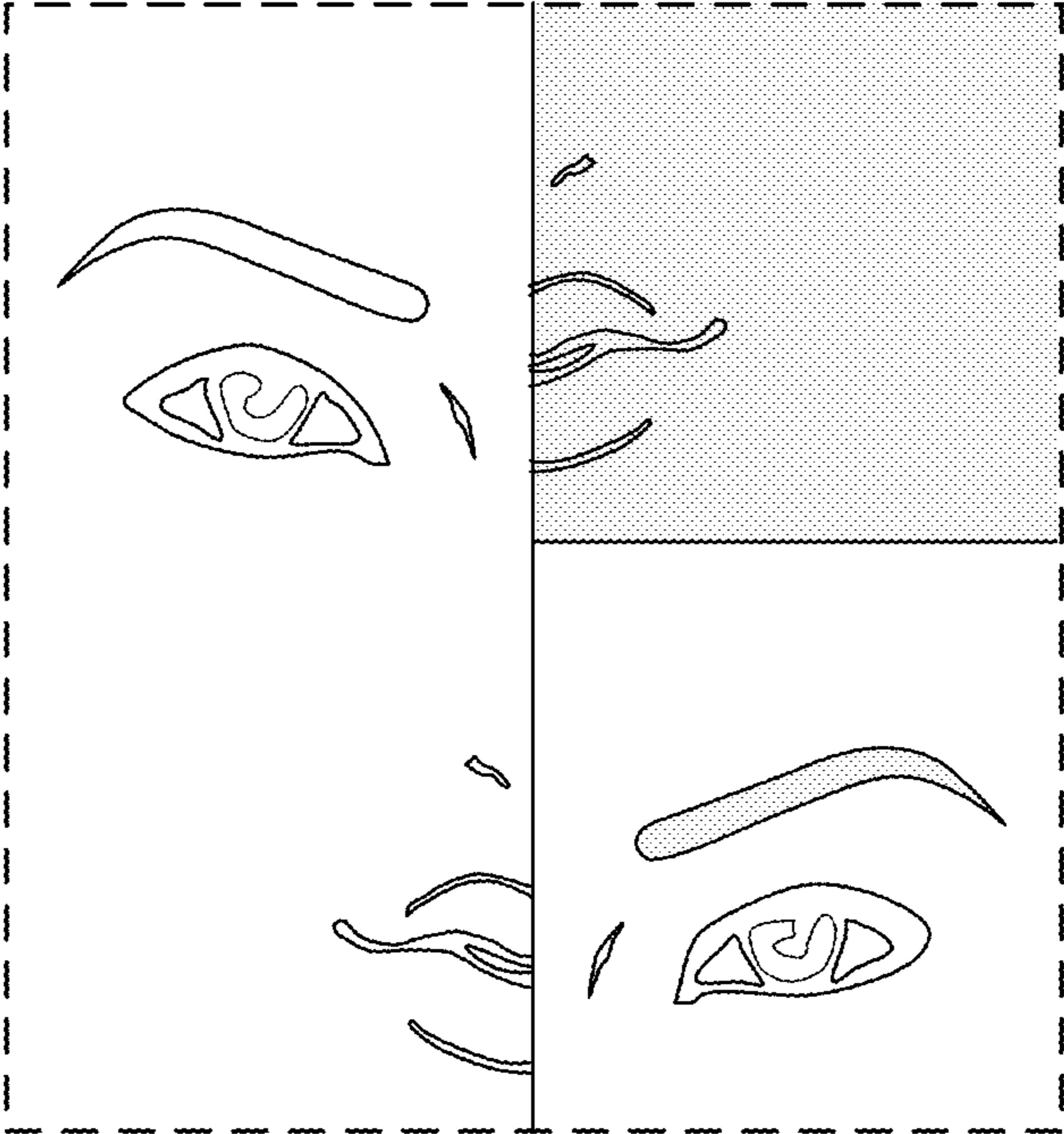

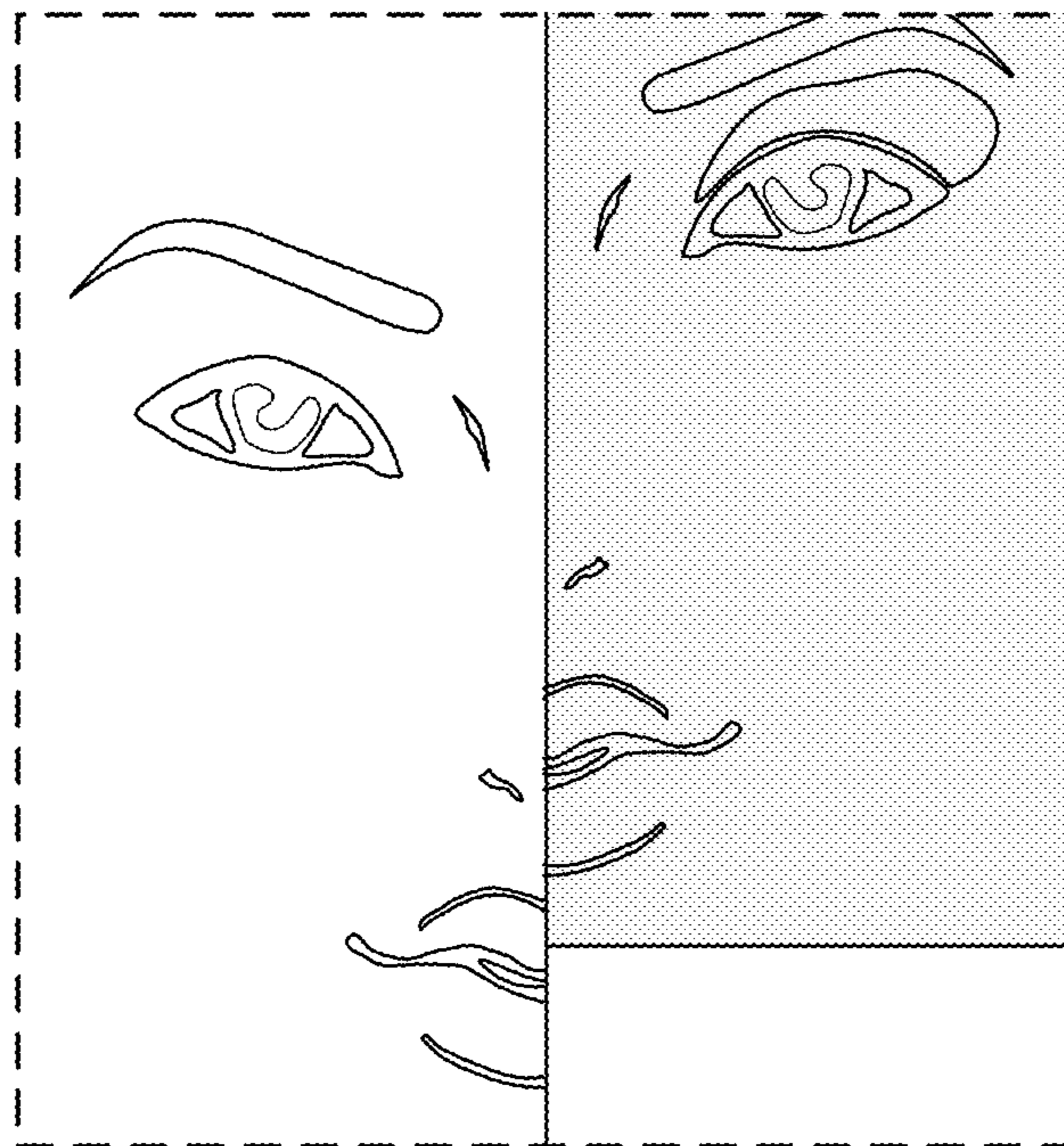
