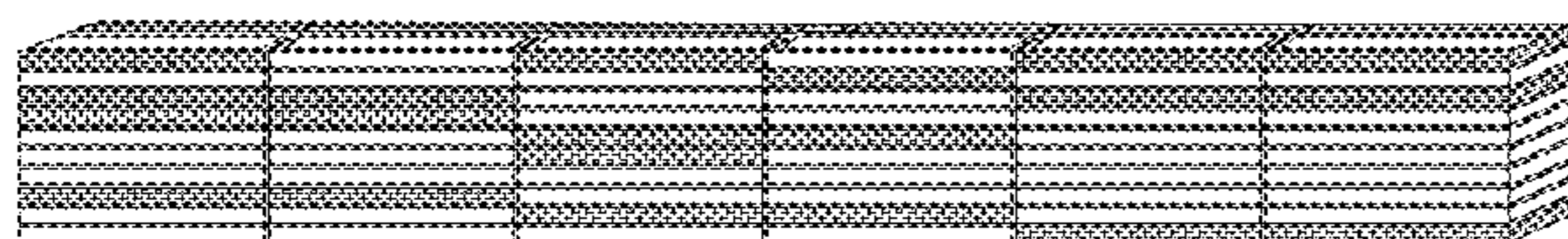

FIG. 13 is the opposite side elevation view thereof;

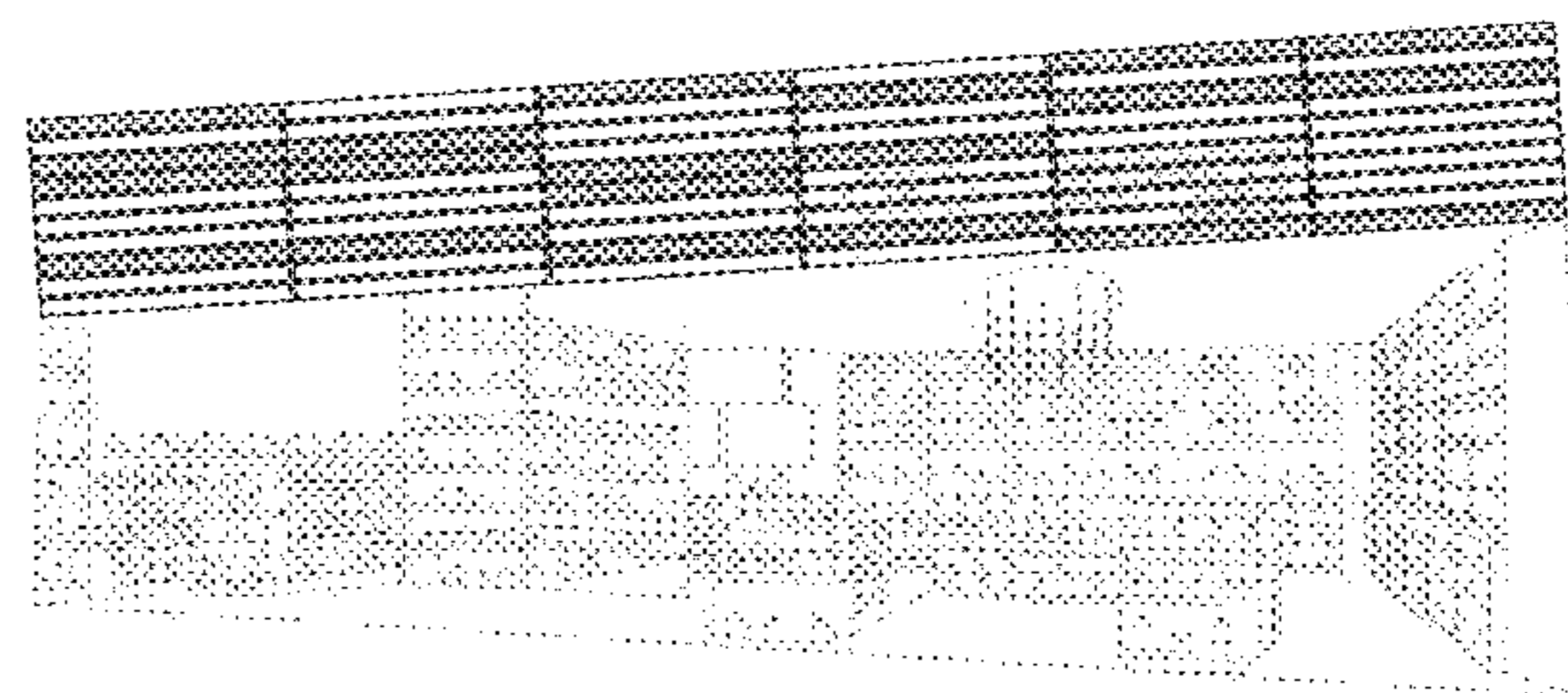
FIG. 14 is a top plan view thereof;

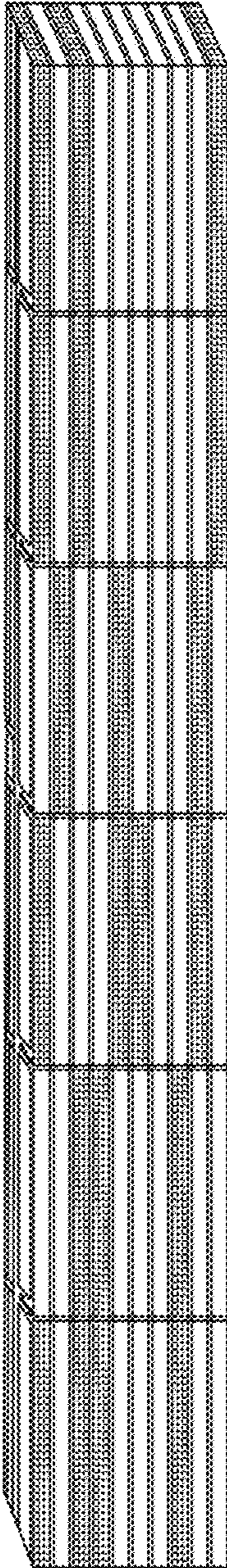

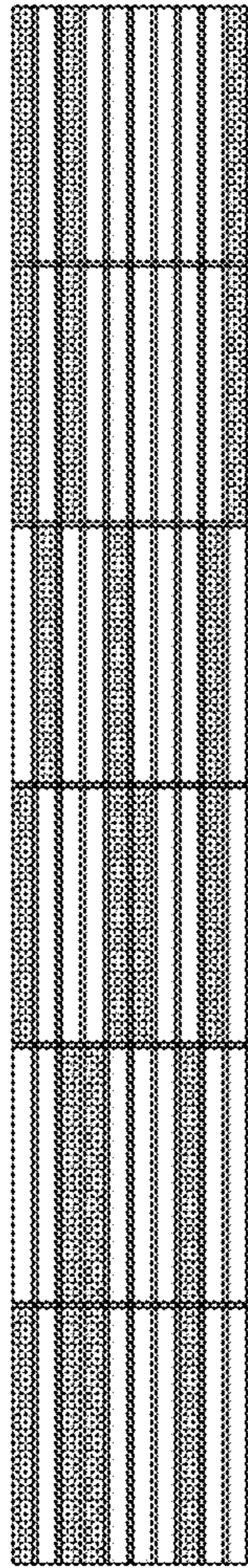

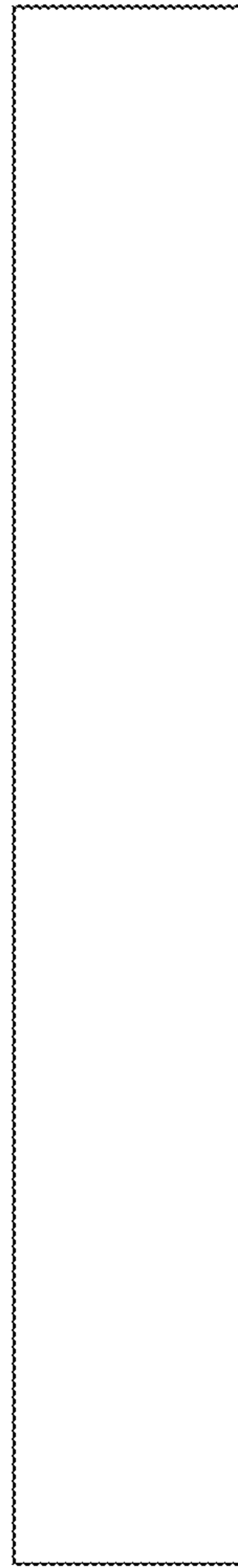

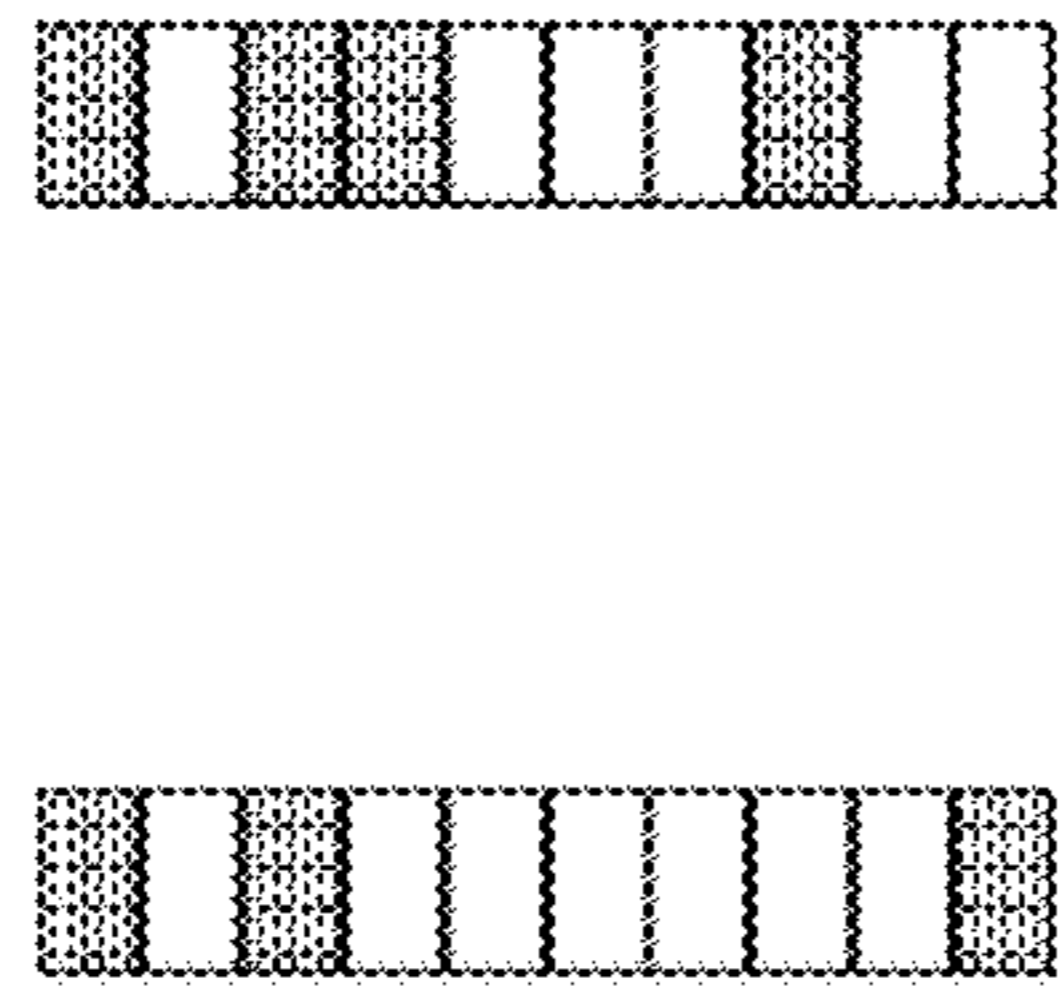


FIG. 4 FIG. 5

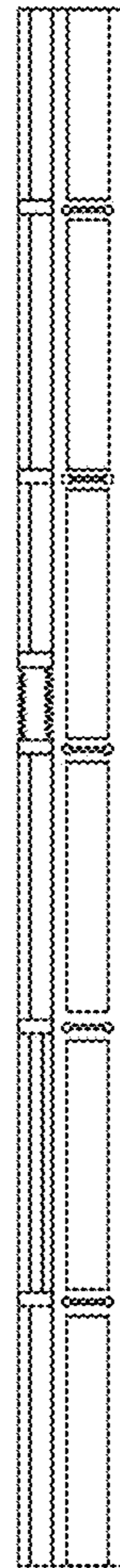

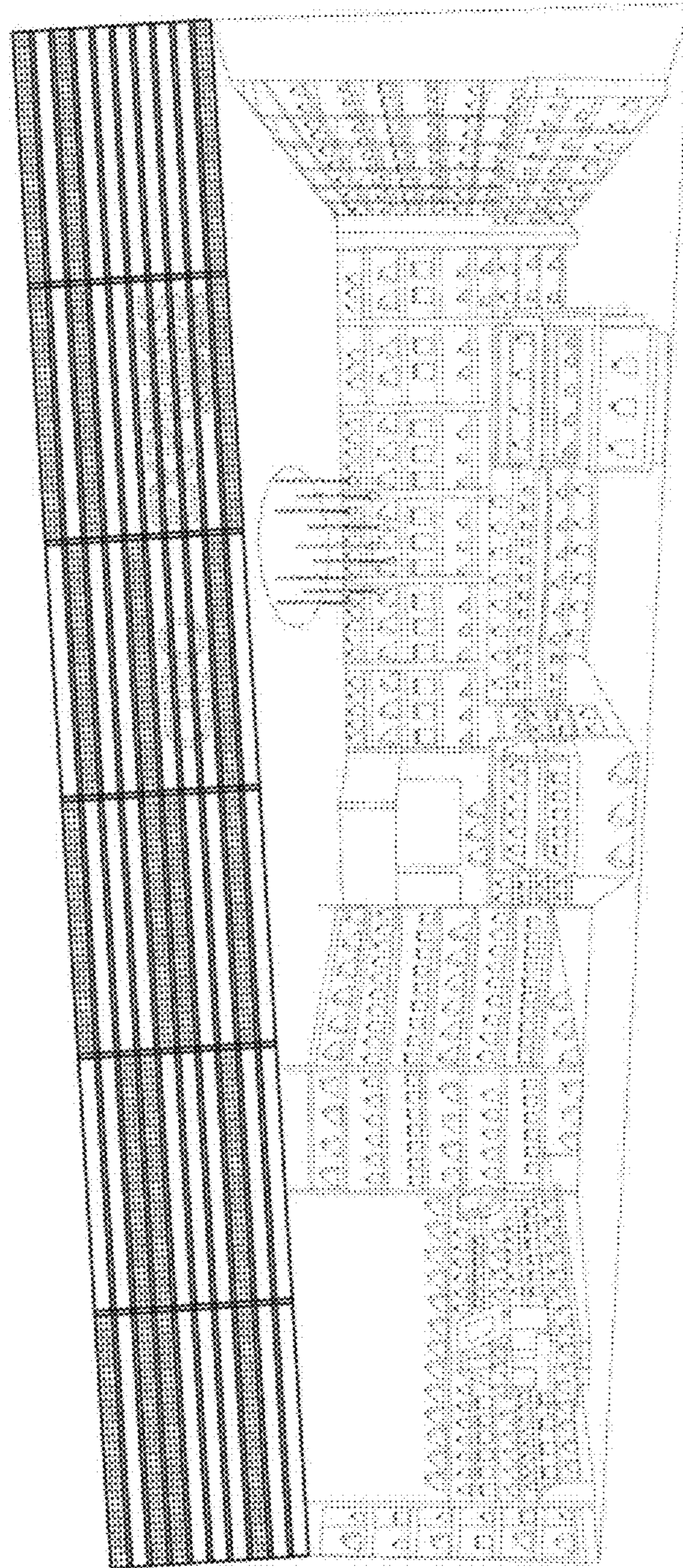

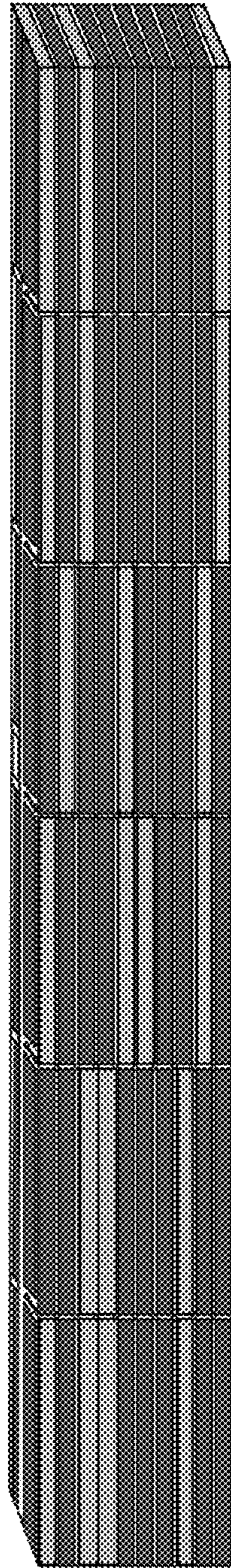

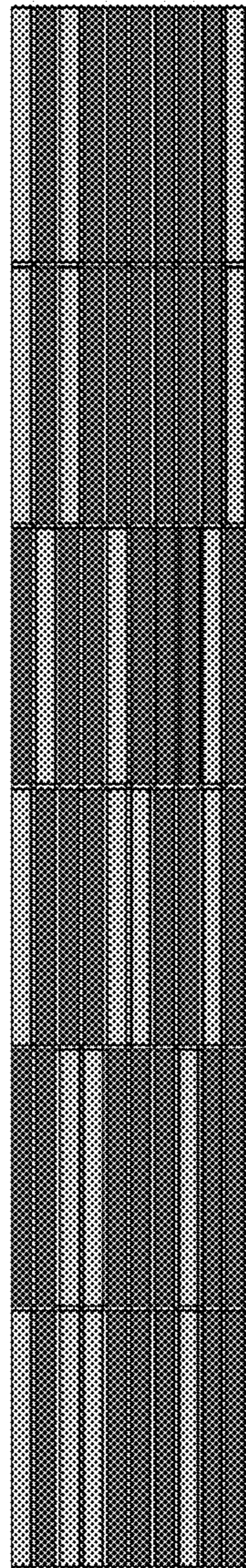

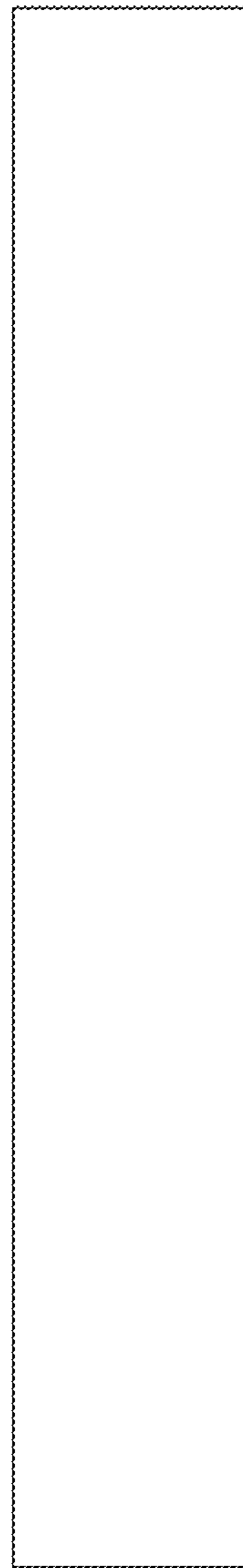

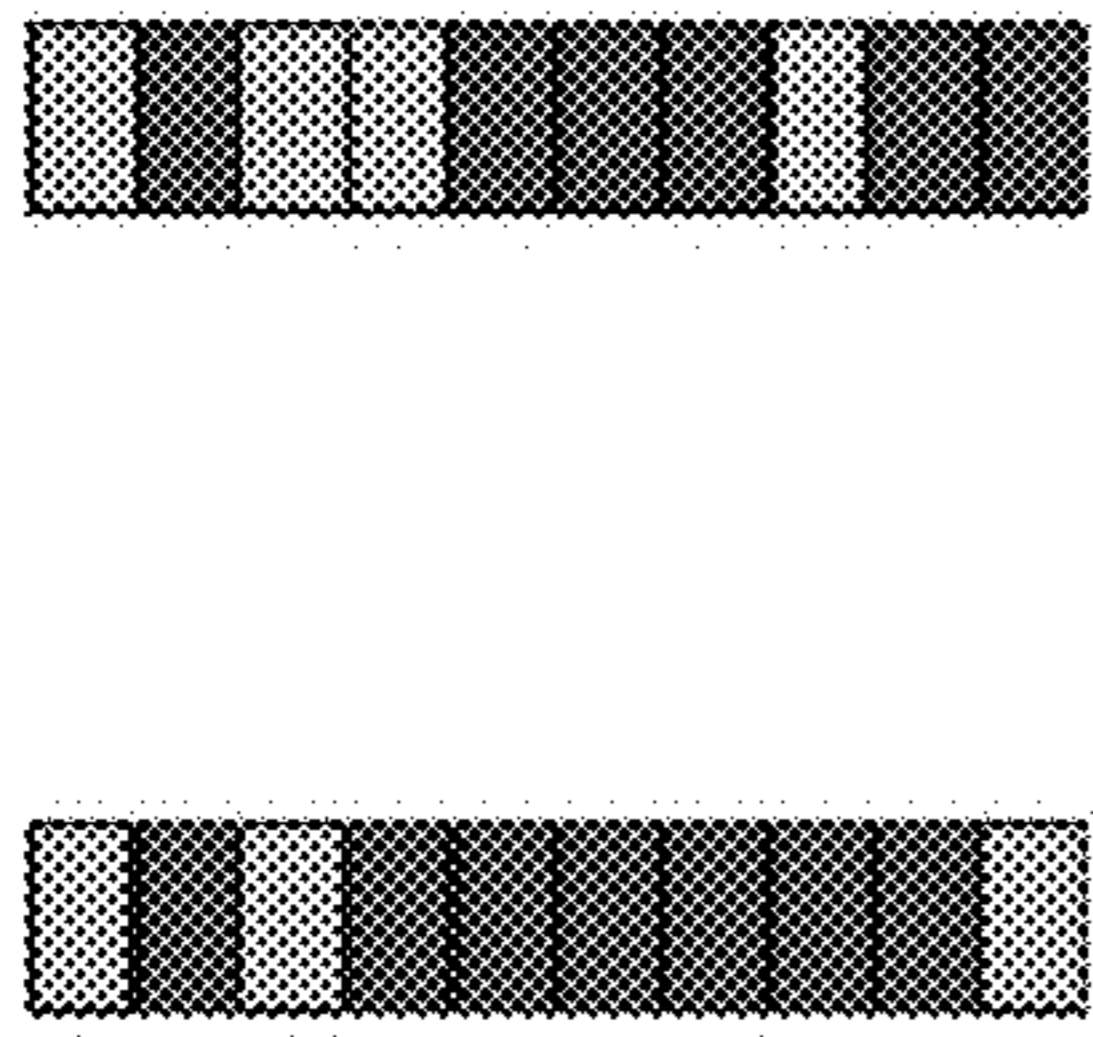


FIG. 12 FIG. 13

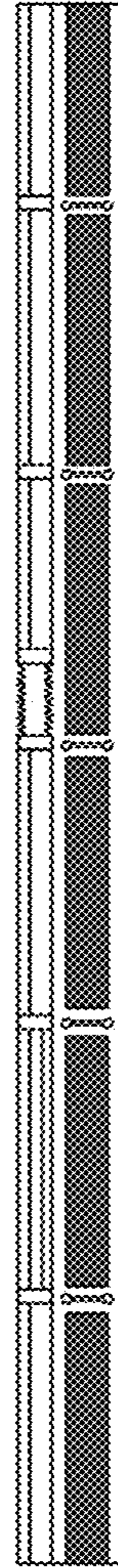

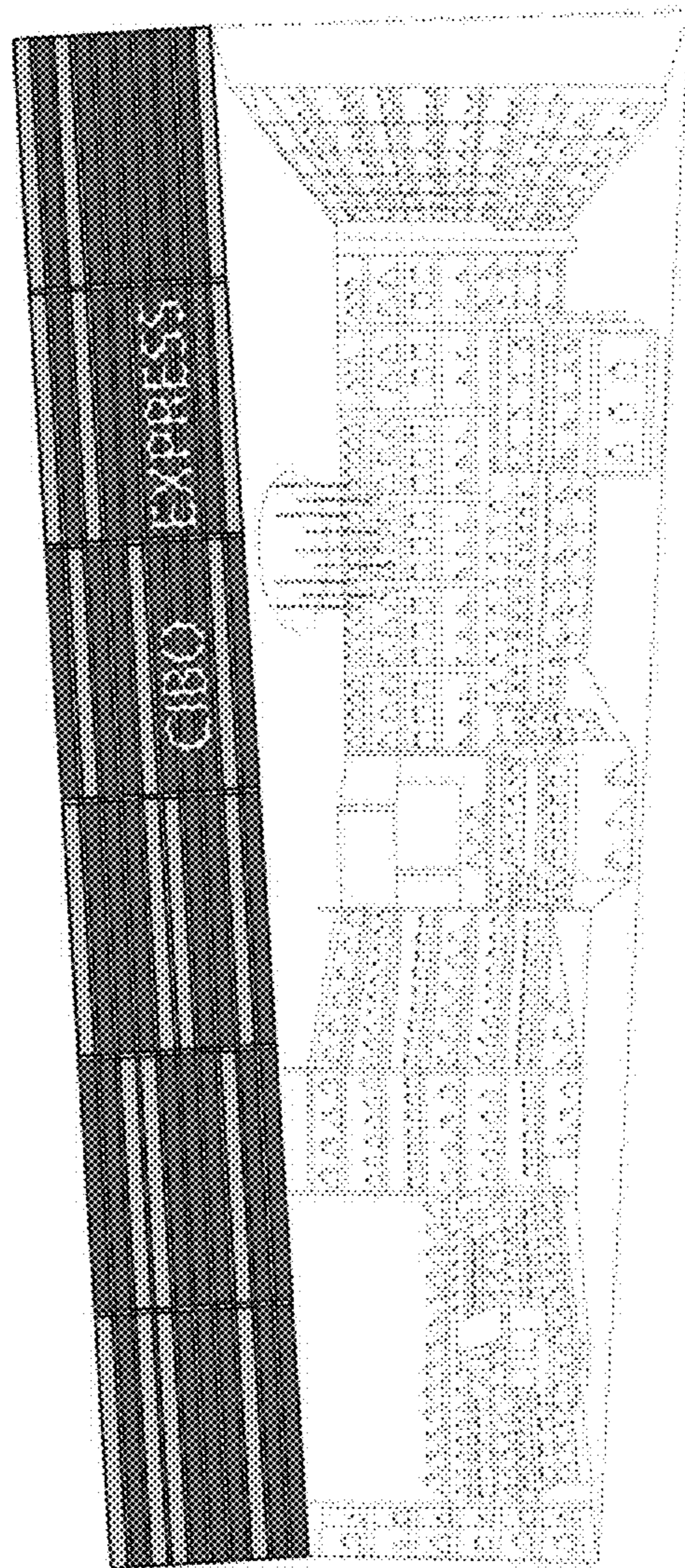
