(57) **CLAIM**

The ornamental design for a portable hand held golf club cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portable hand held golf club cleaner according to the present invention.

FIG. 2 is a side view of the portable hand held golf club cleaner according to the present invention.

FIG. 3 is an exploded perspective view of the portable hand held golf club cleaner of the present invention.

FIG. 4 is an exploded perspective view of the portable hand held golf club cleaner of the present invention.

FIG. 5 is a top perspective view of an alternate embodiment of the portable hand held golf club cleaner according to the present invention.

FIG. 6 is a bottom and front perspective view of the alternate embodiment of the portable hand held golf club cleaner; groove scrapers removed for clarity of illustration; and,

FIG. 7 is a rear perspective view of the alternate embodiment of the portable hand held golf club cleaner; shown without the cap.

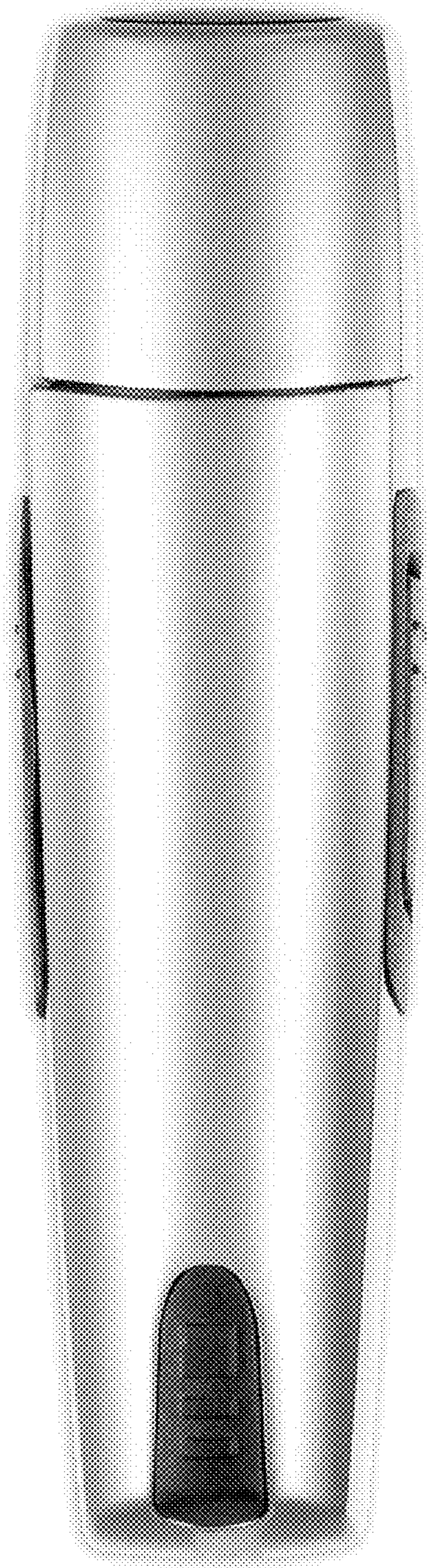

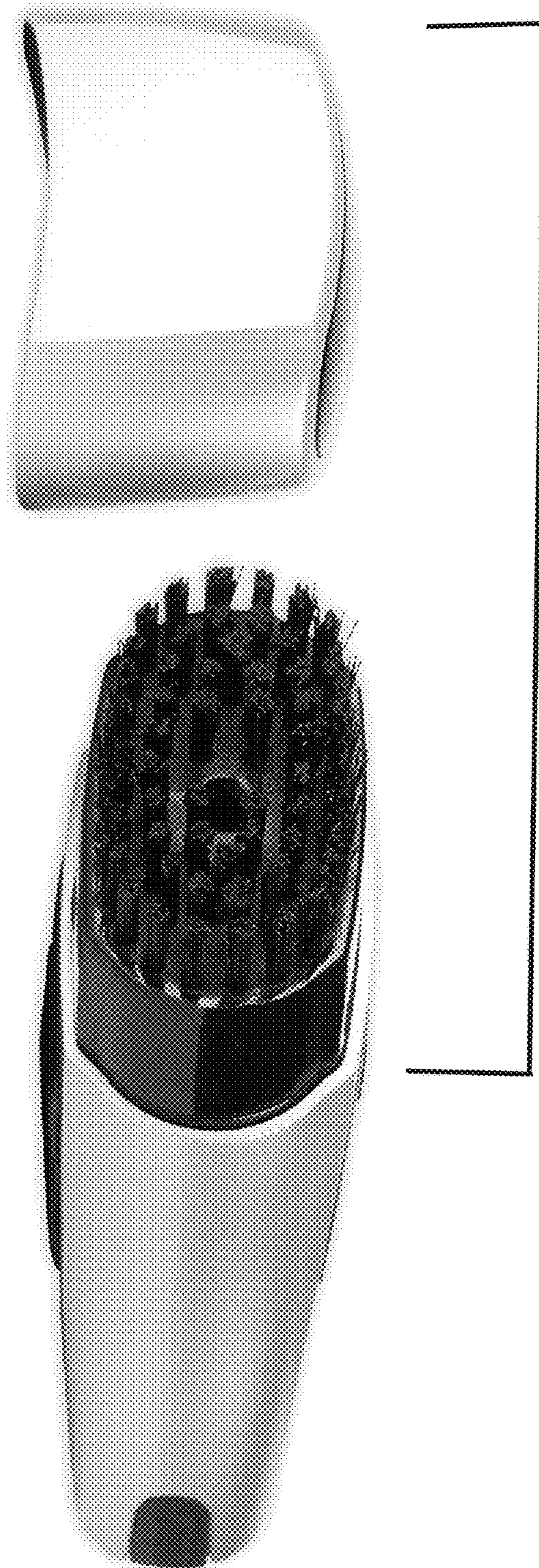

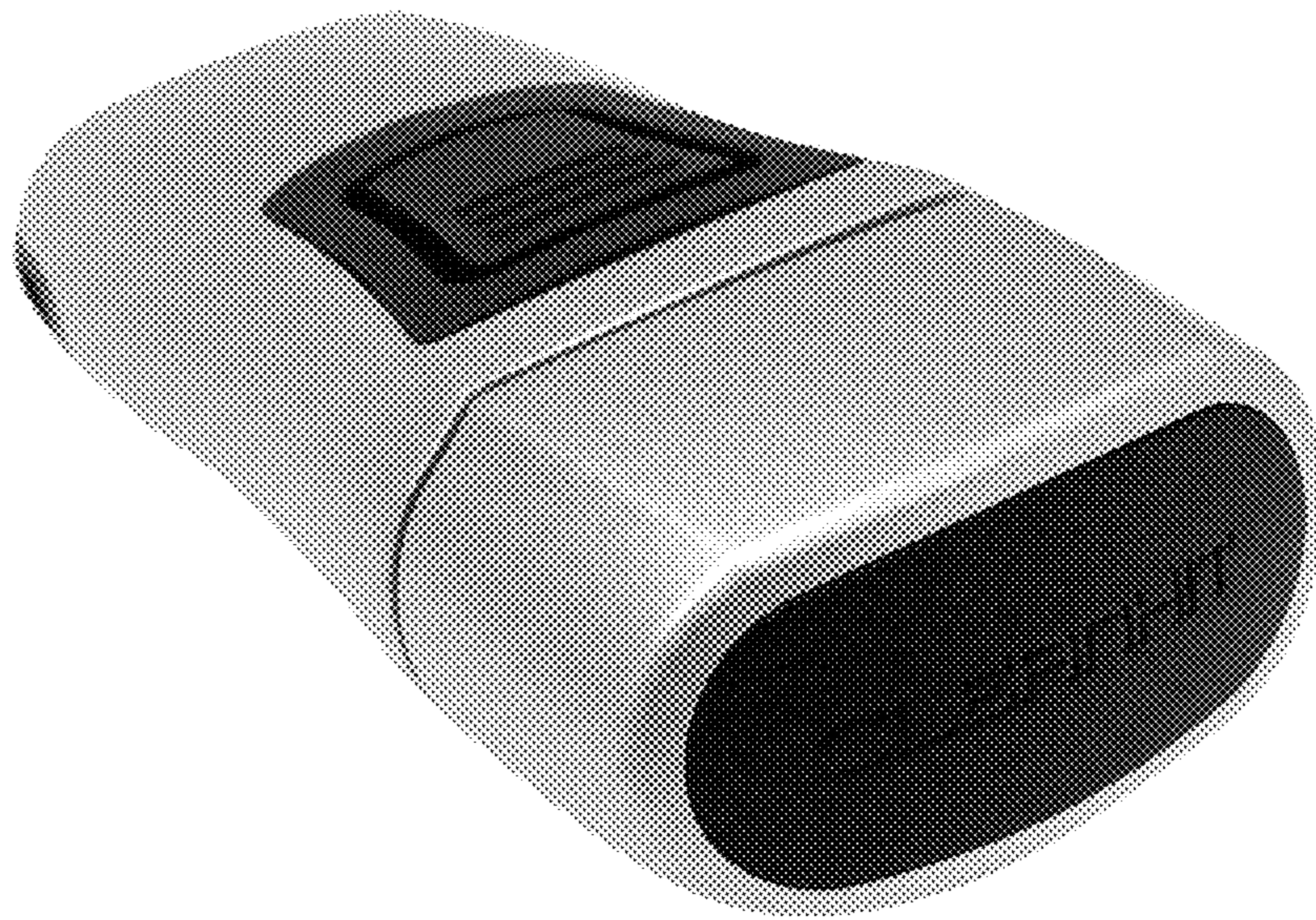
