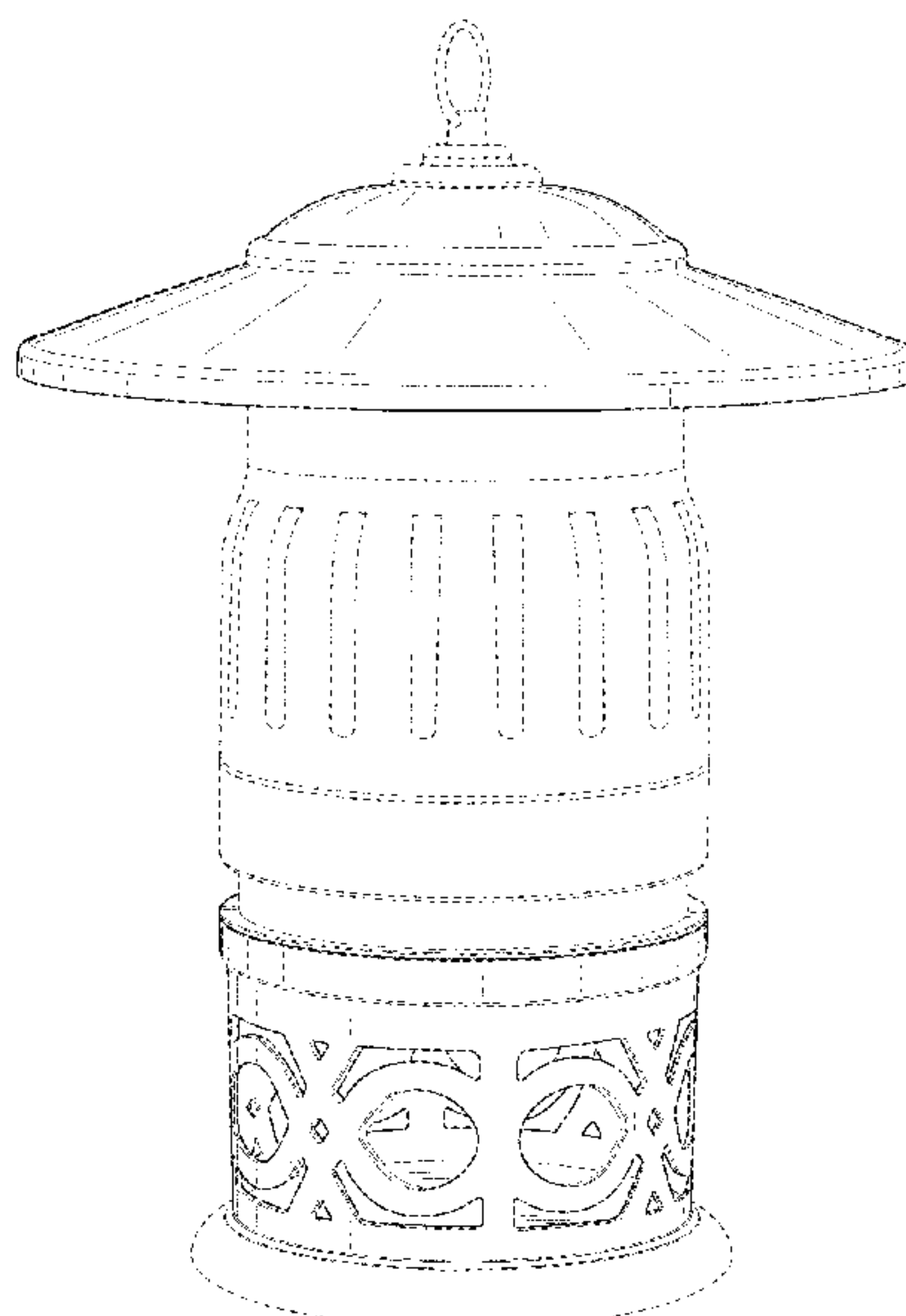
(57) **CLAIM**

The ornamental design for an insect trap housing, substan-
tially as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side isometric view of an insect
trap housing according to the present invention;
FIG. 2 is a right side elevation view of the insect trap
housing of FIG. 1;
FIG. 3 is a left side elevation view of the insect trap housing
of FIG. 1;
FIG. 4 is a rear elevation view of the insect trap housing of
FIG. 1;
FIG. 5 is a front elevation view of the insect trap housing of

FIG. 6 is a bottom plan view of the insect trap housing of

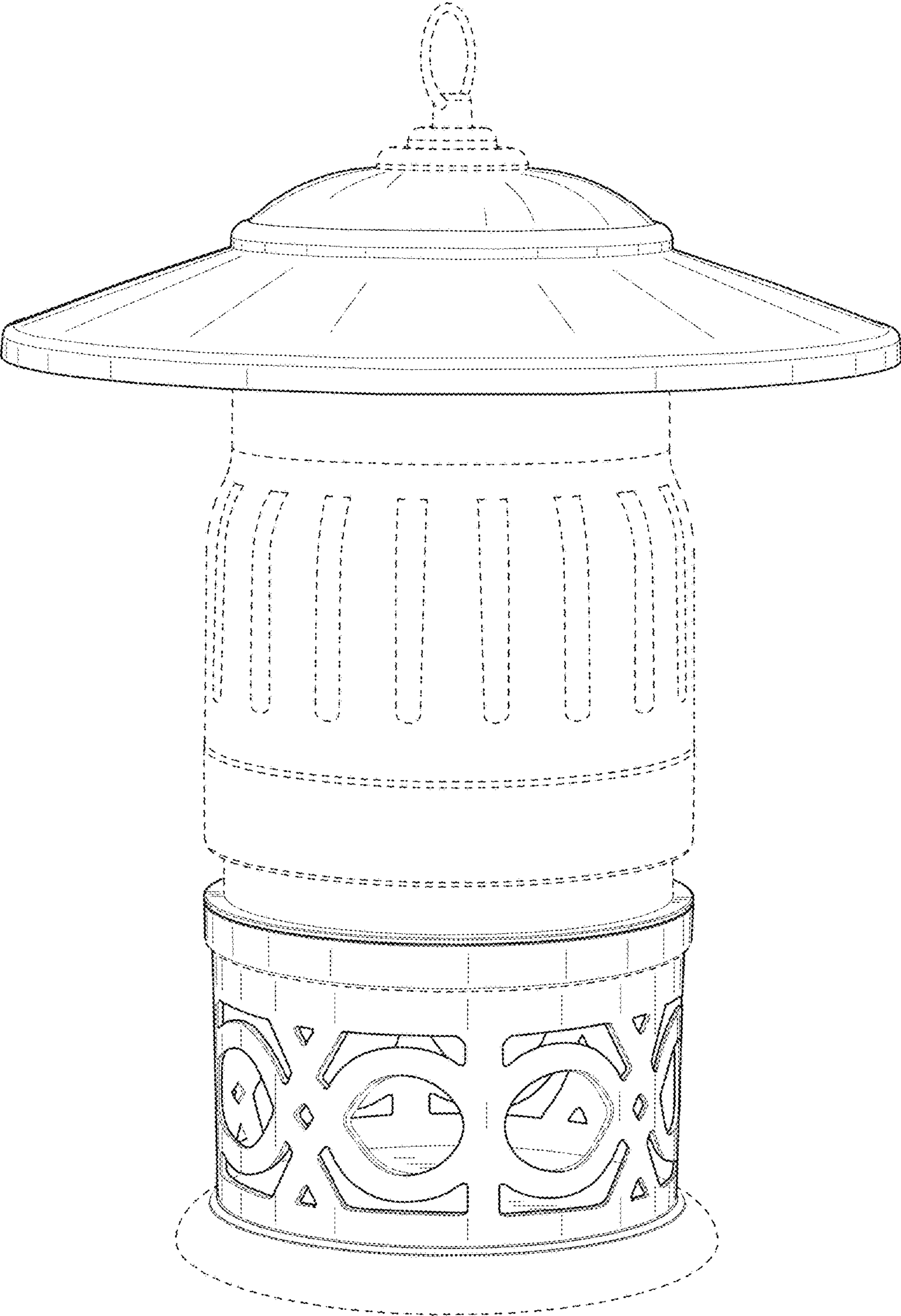

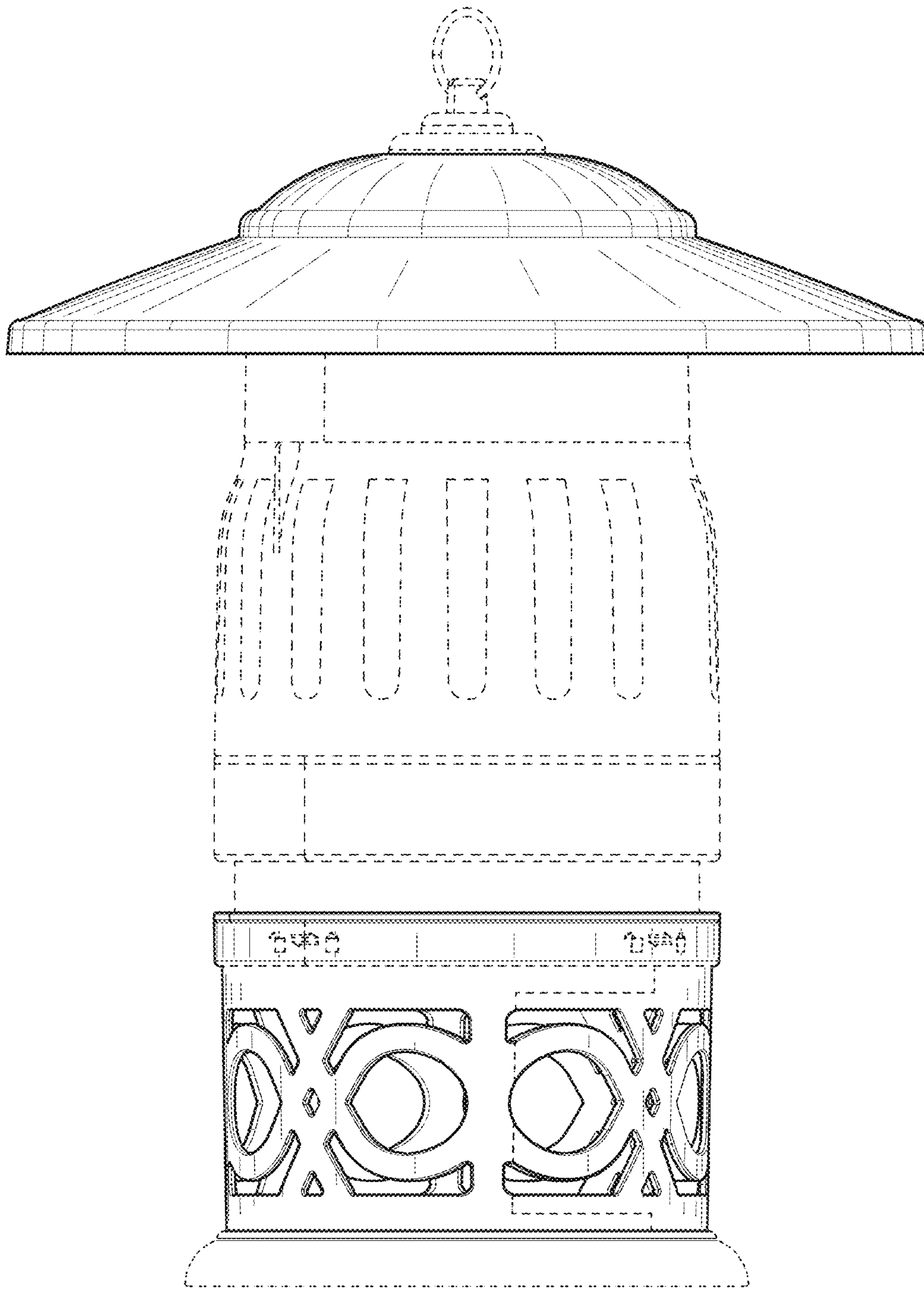

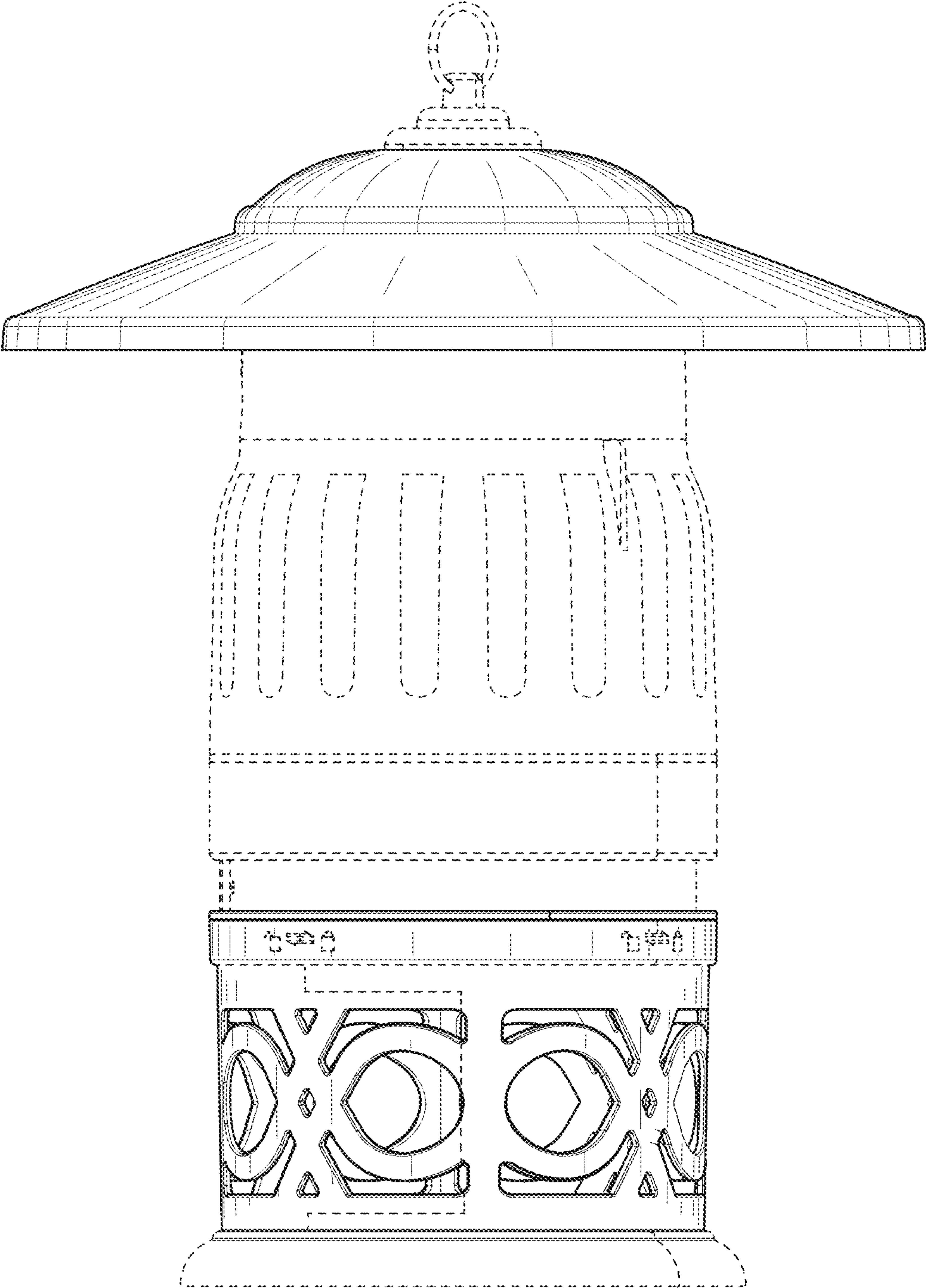

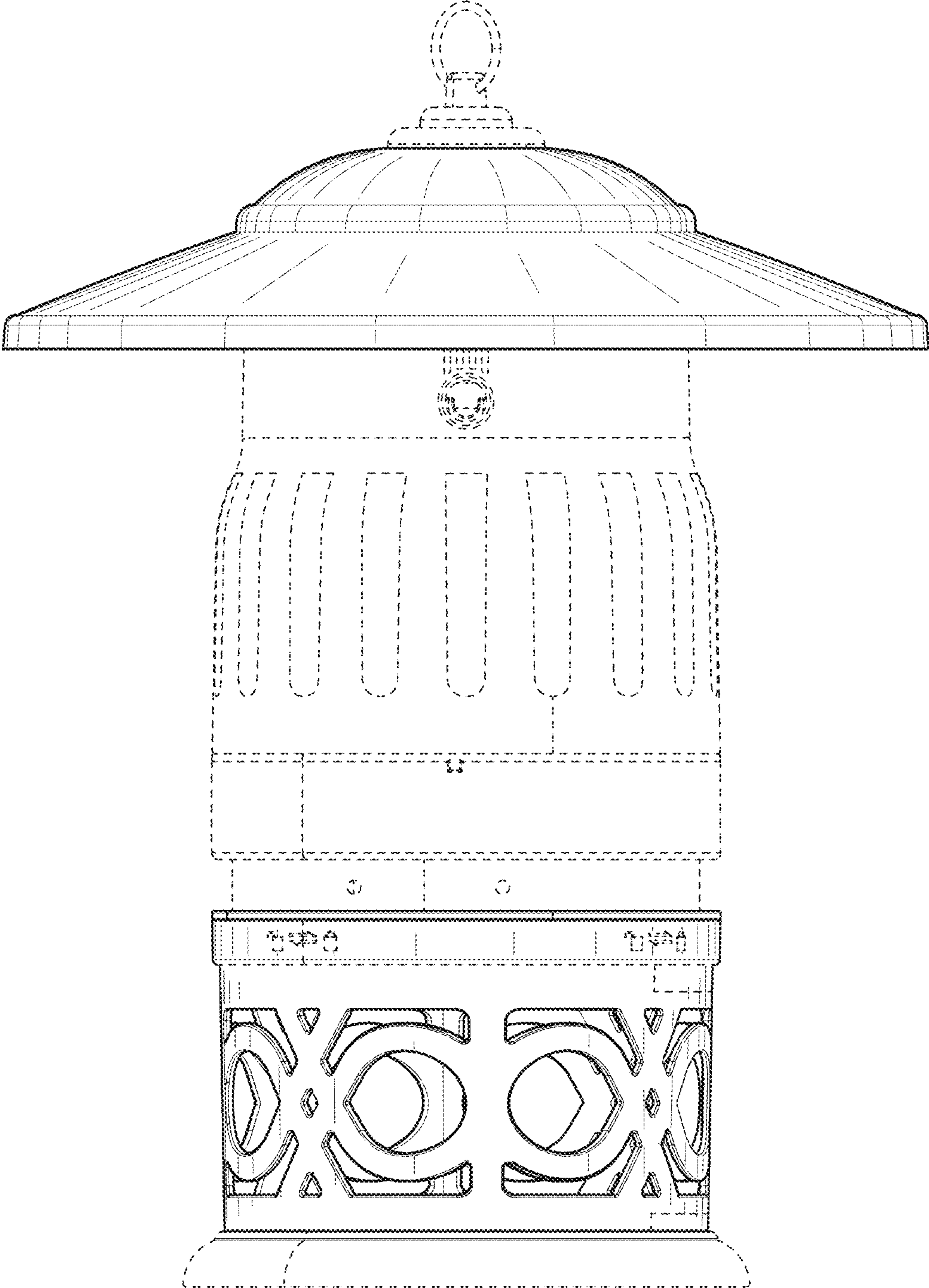

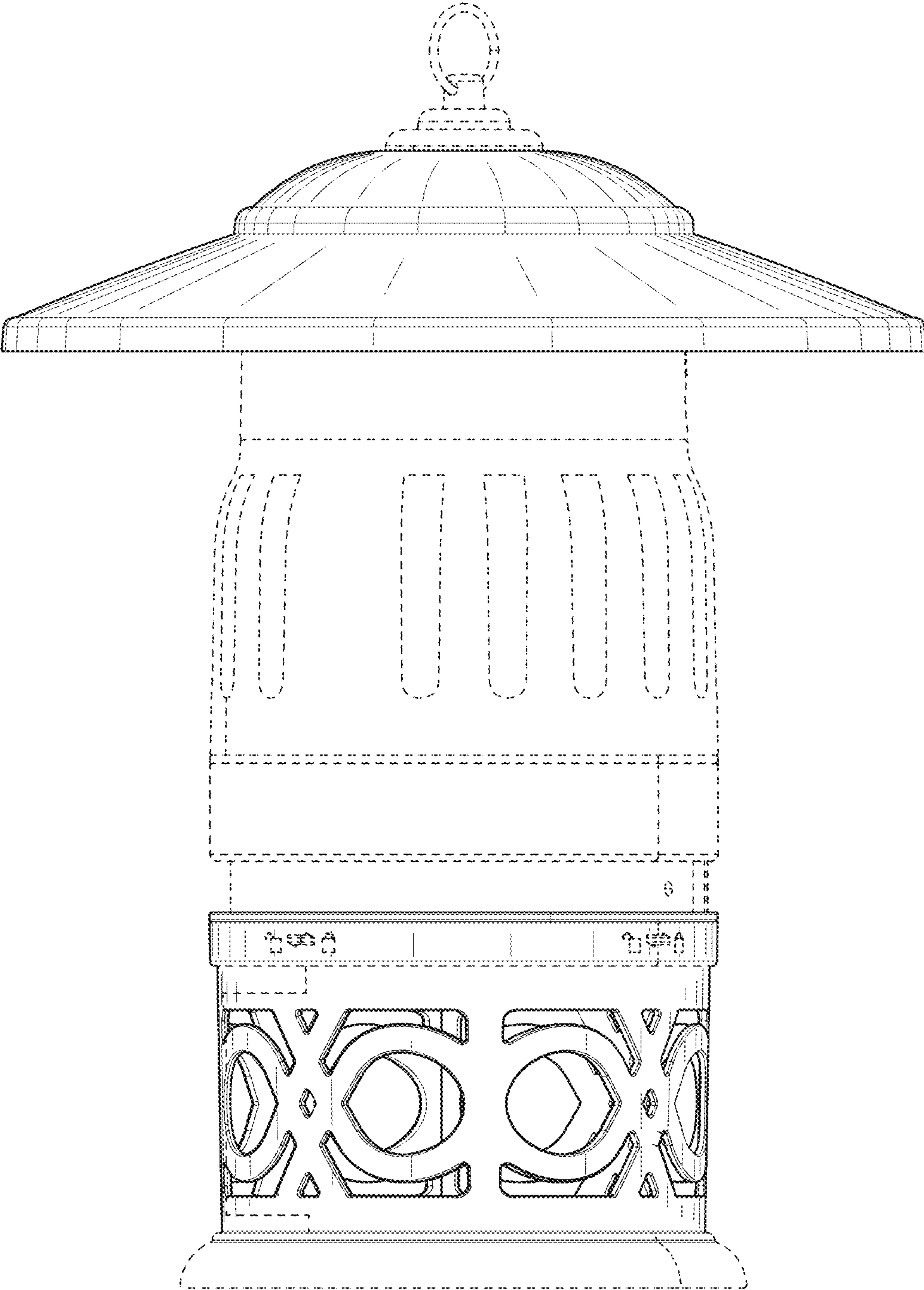

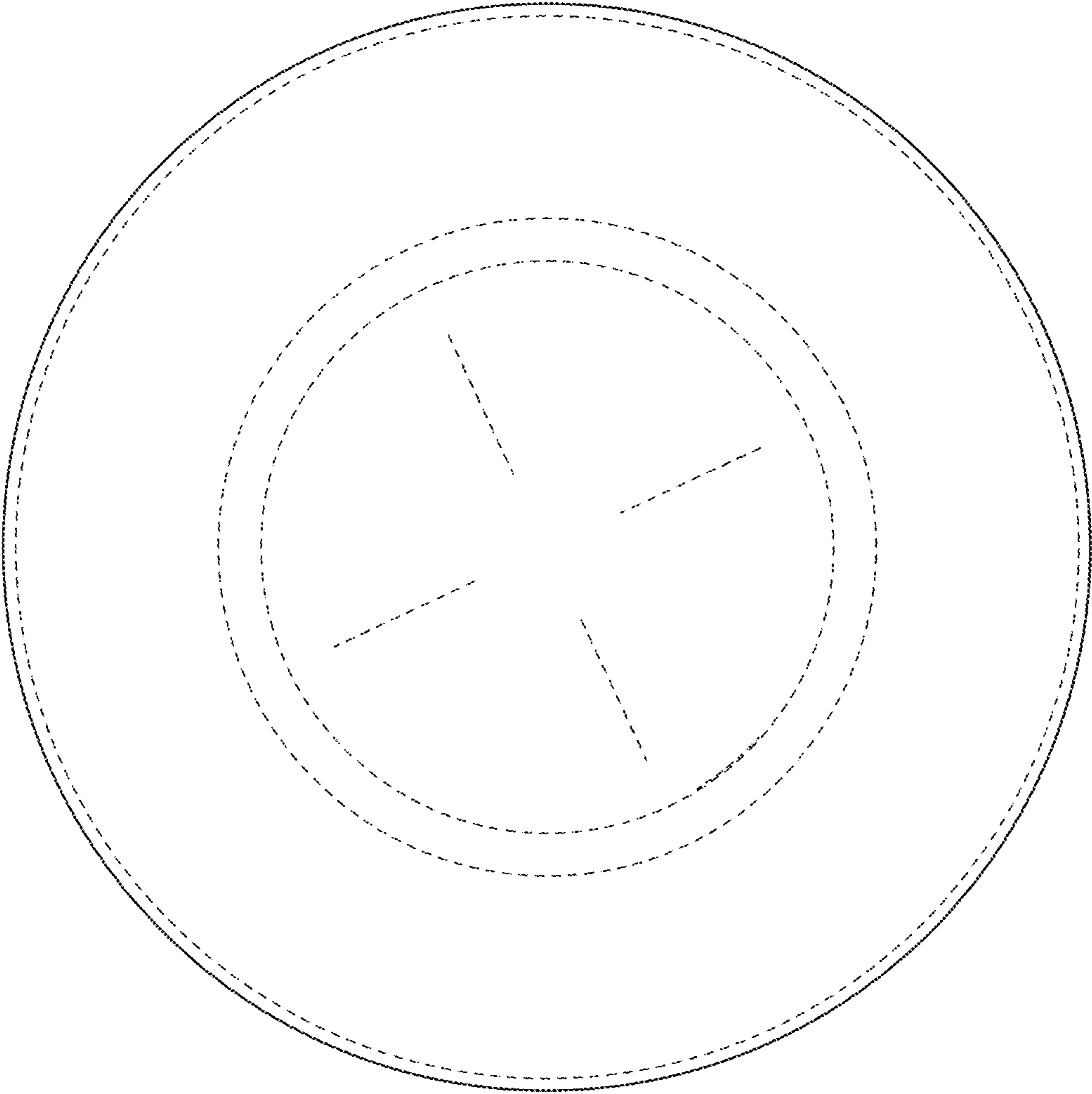

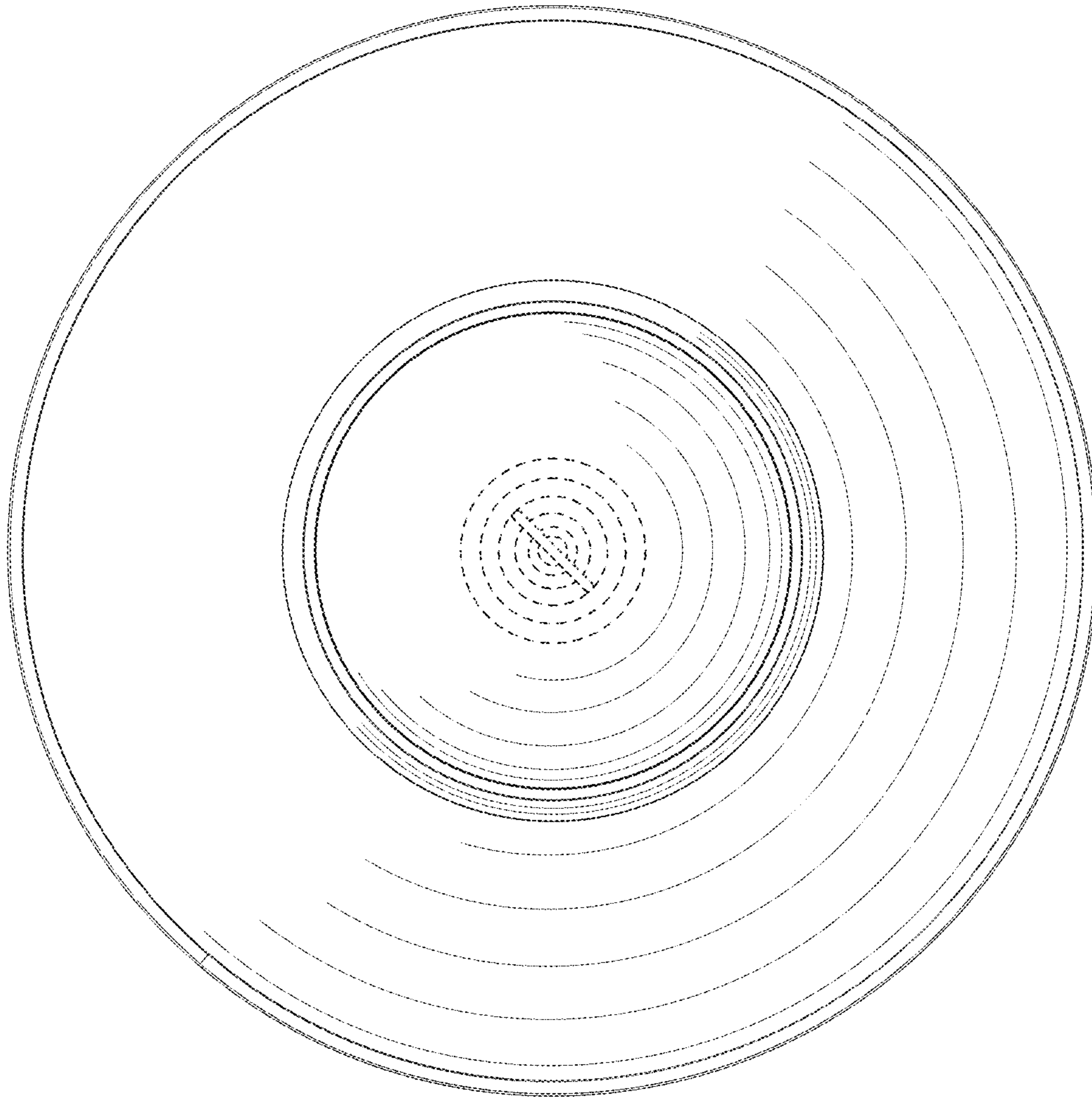
