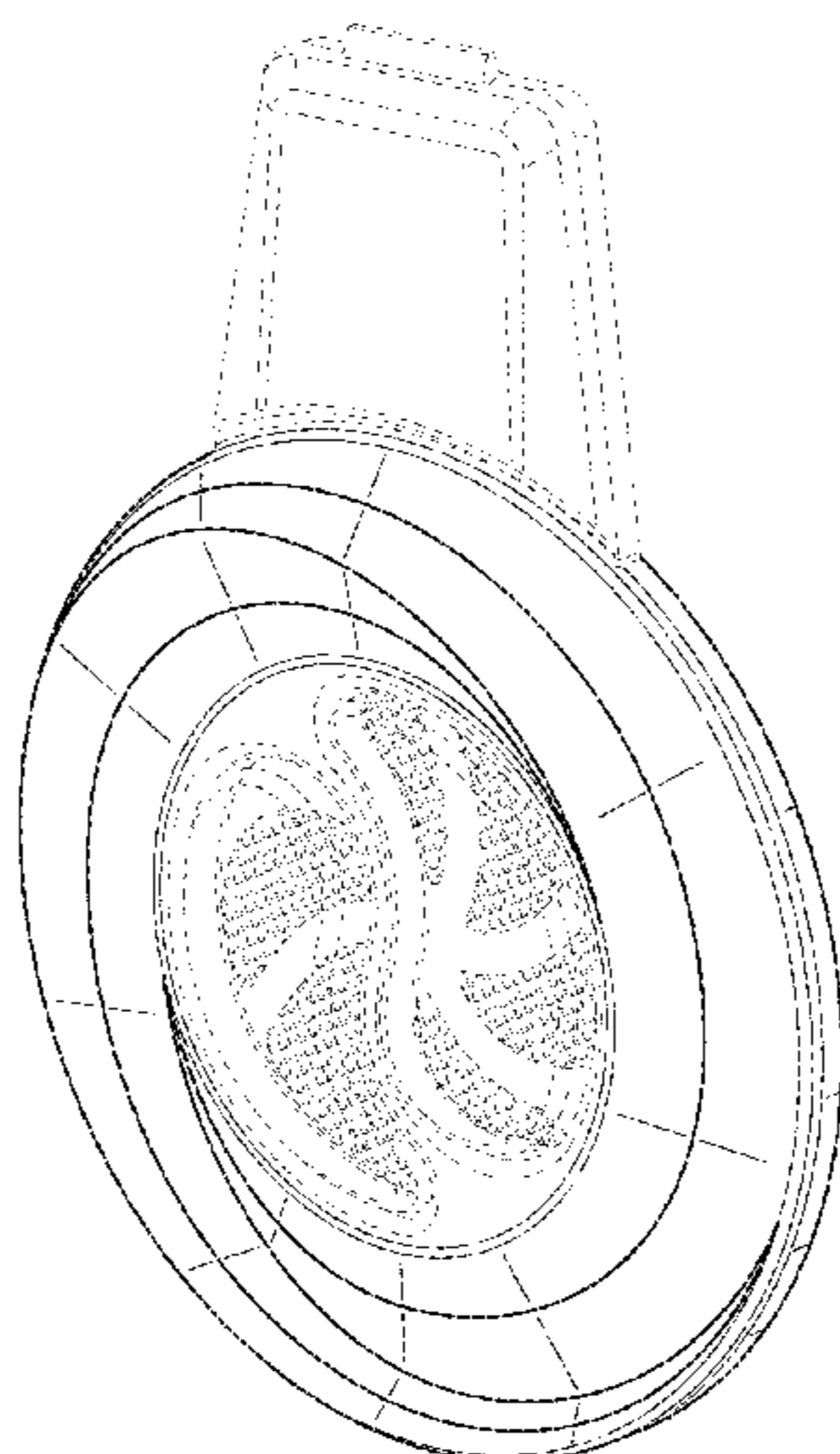

FIG. 1 is a perspective view of our new design for a
container dispenser;
FIG. 2 is a top plan view thereof;

FIG. 5 is a right side elevation view thereof;
FIG. 6 is a back elevation view of FIG. 4; and,

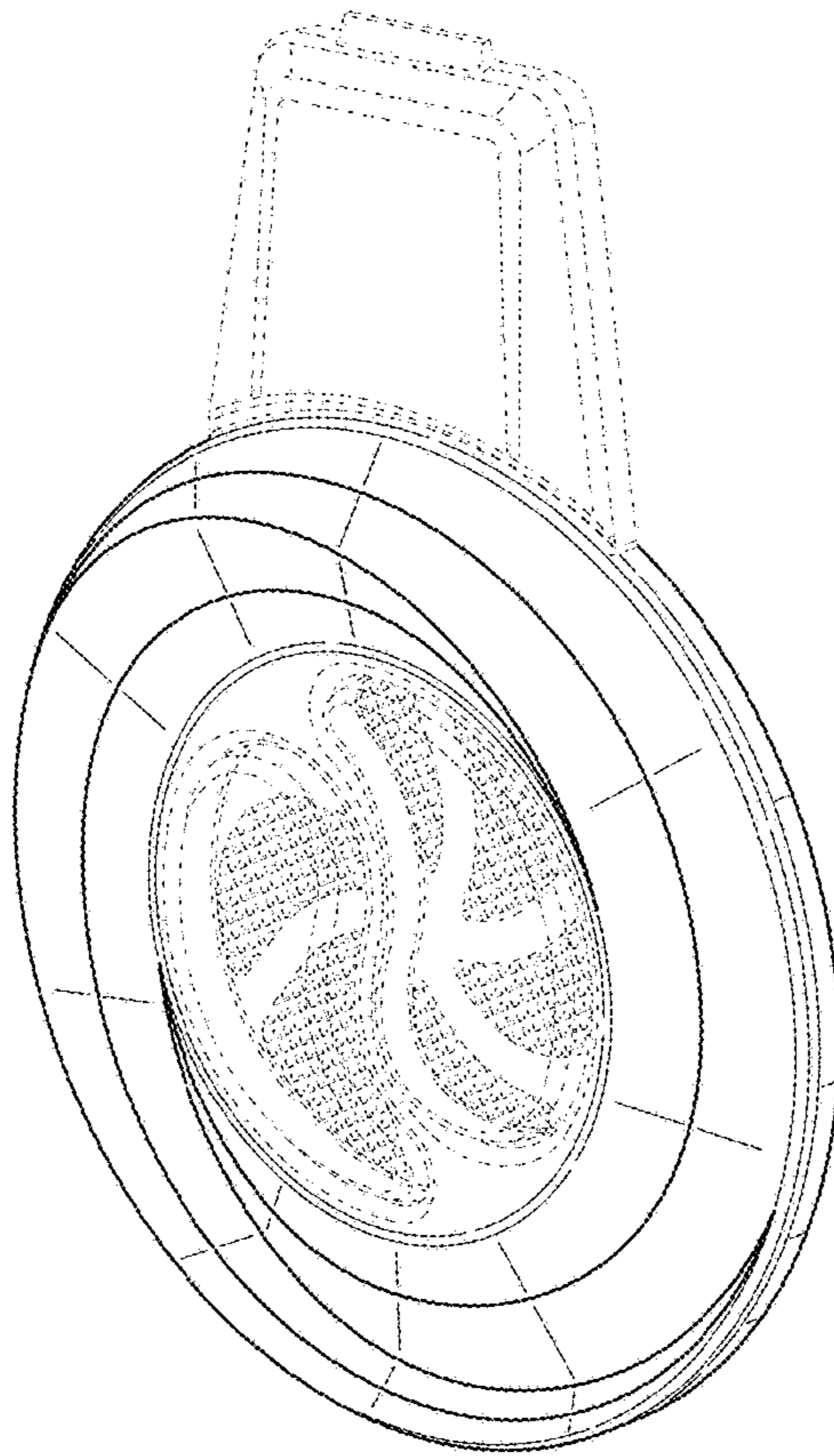

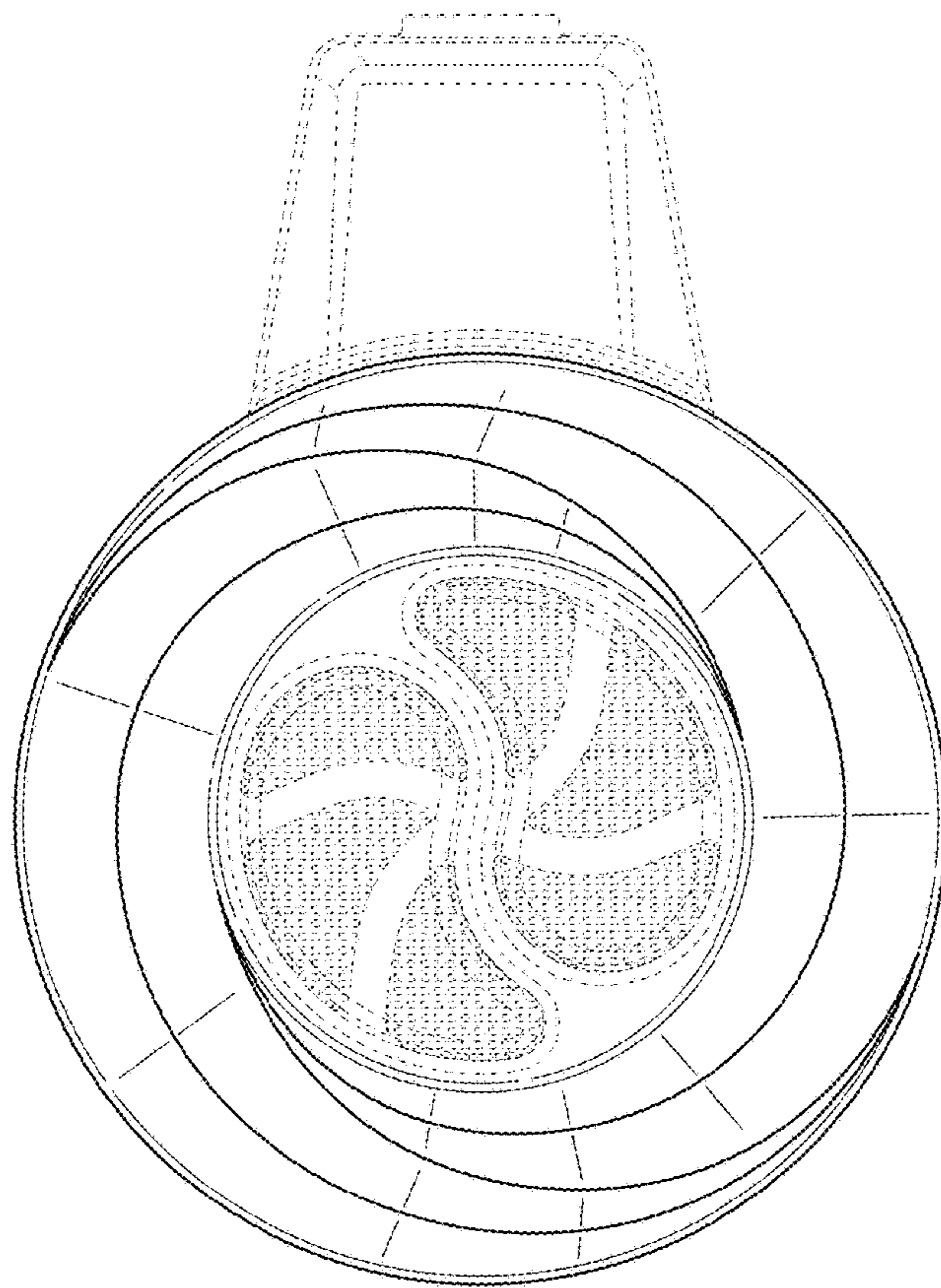

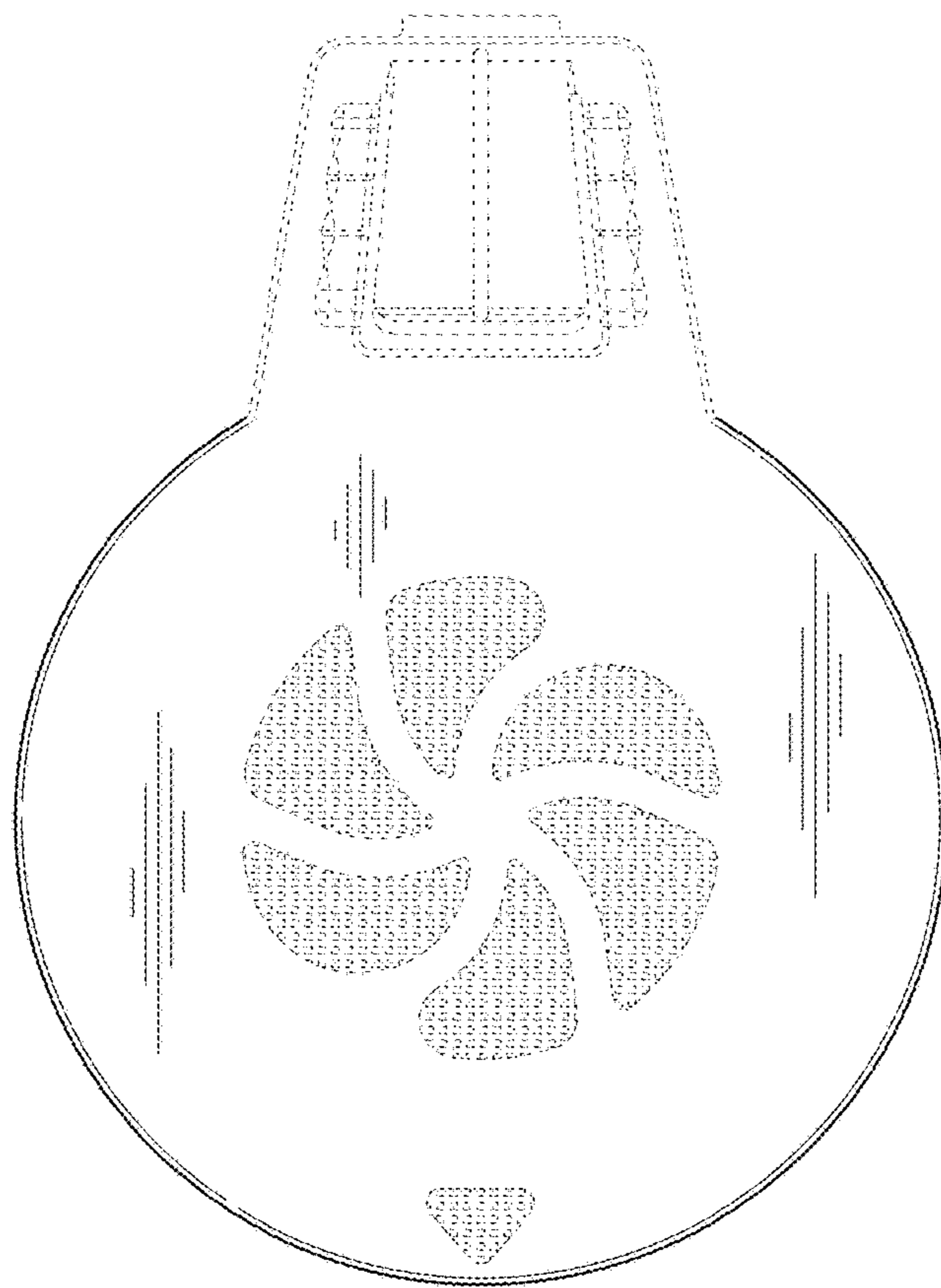

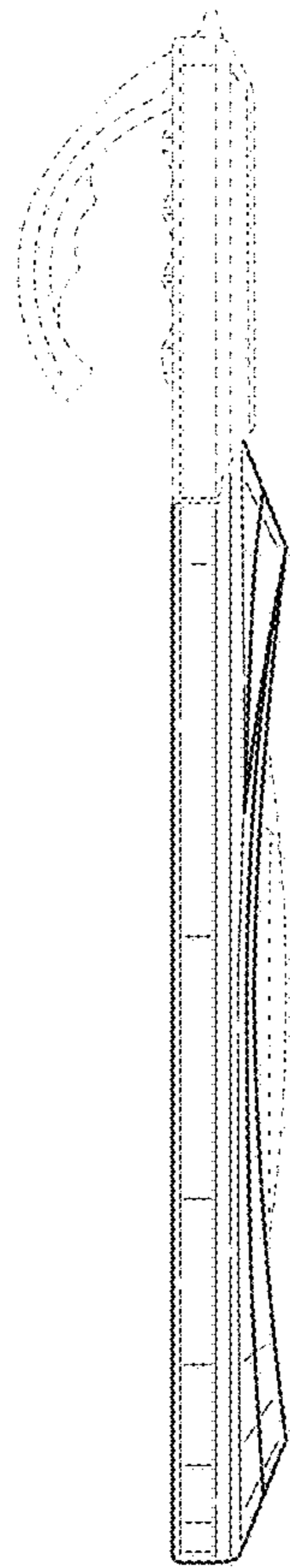

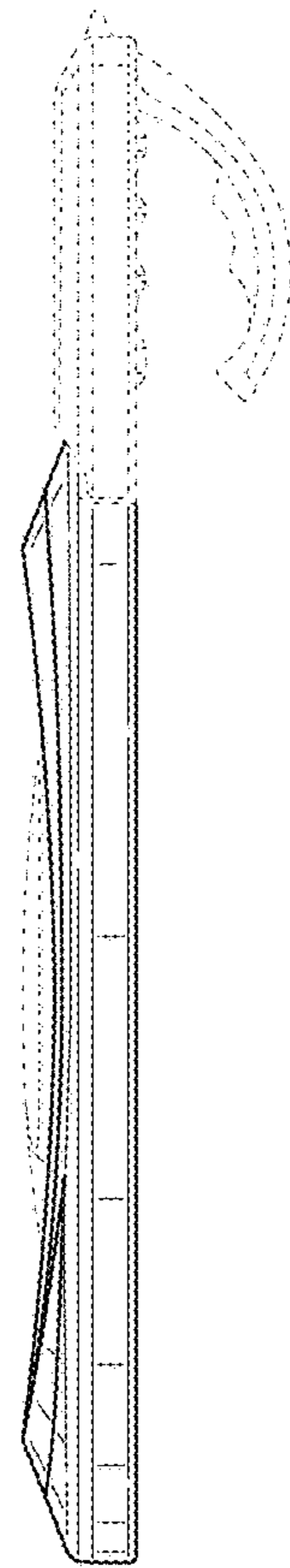

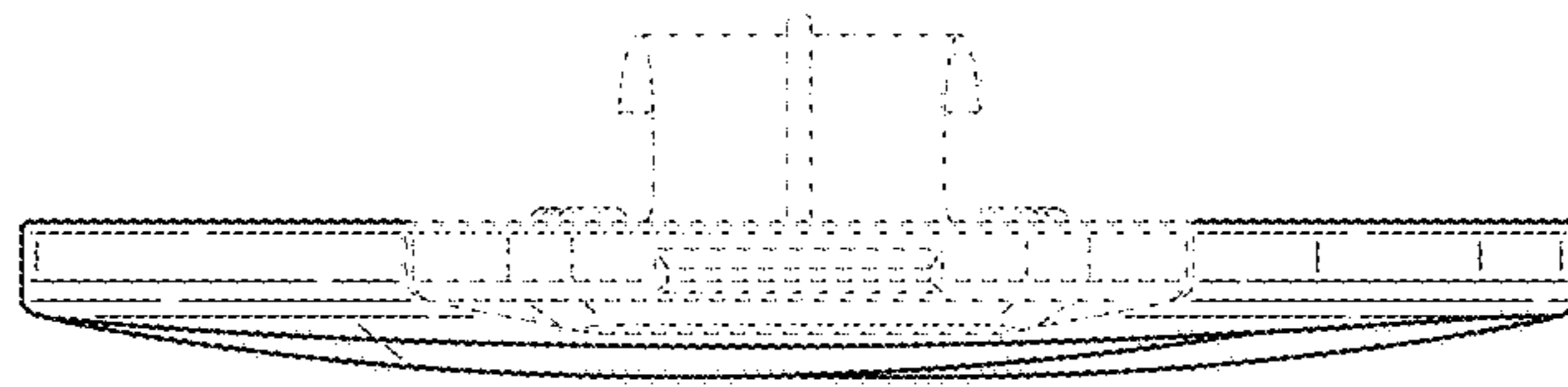

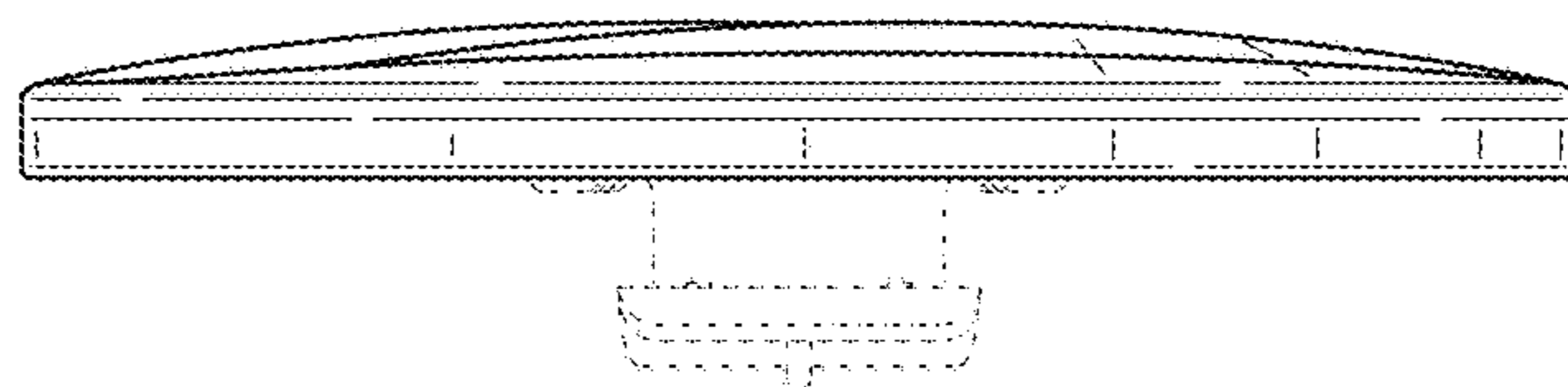
