We claim the ornamental design for grill scraper, as shown and described.

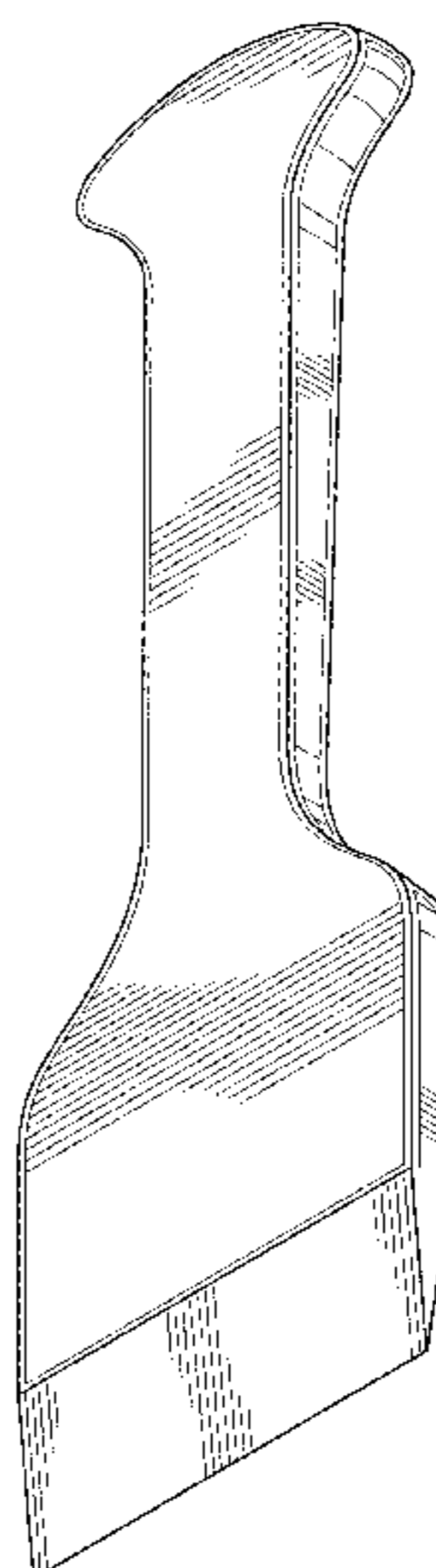

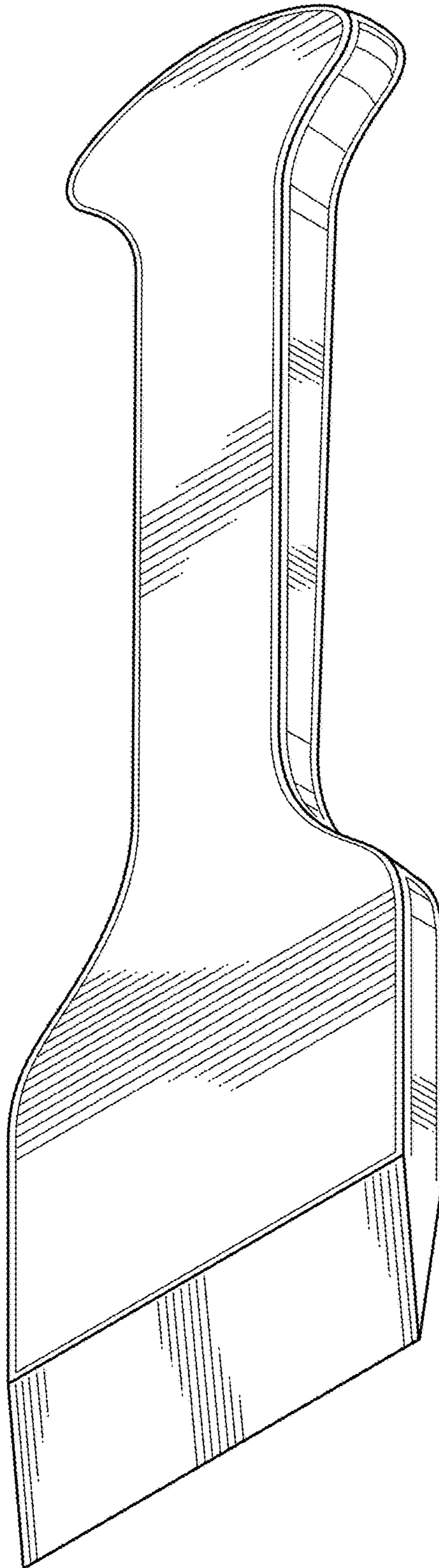

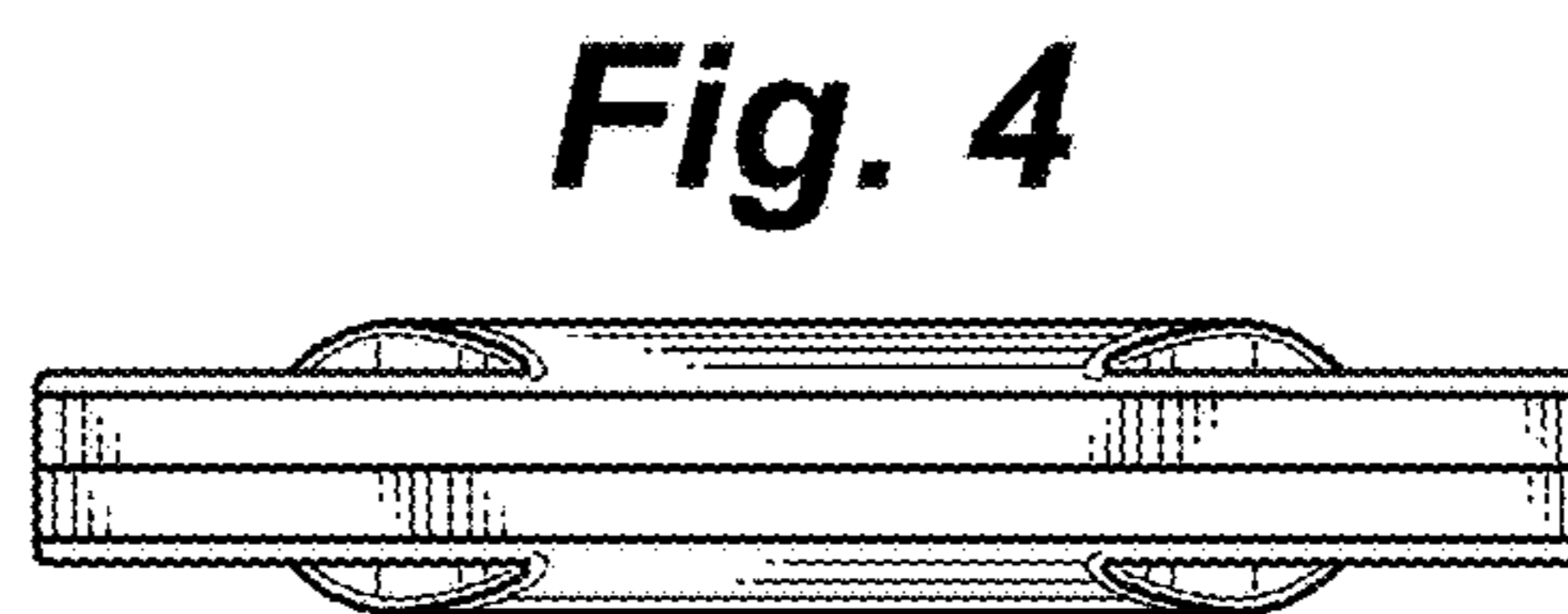
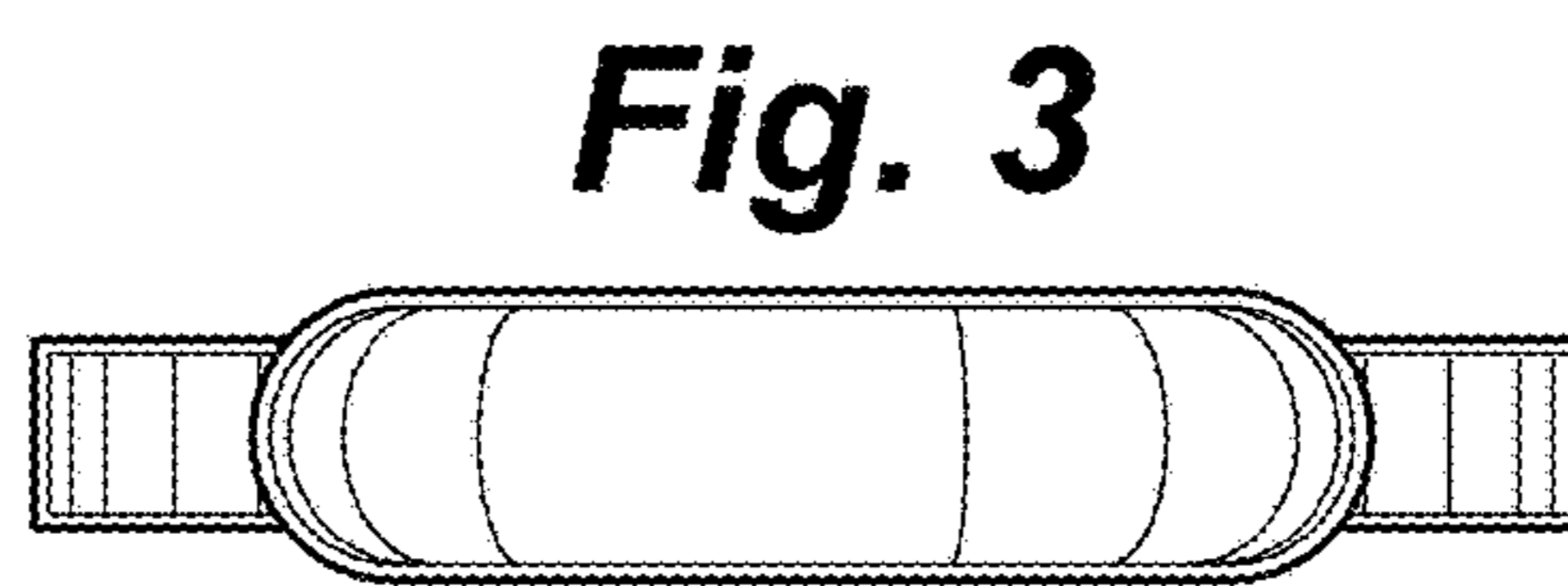
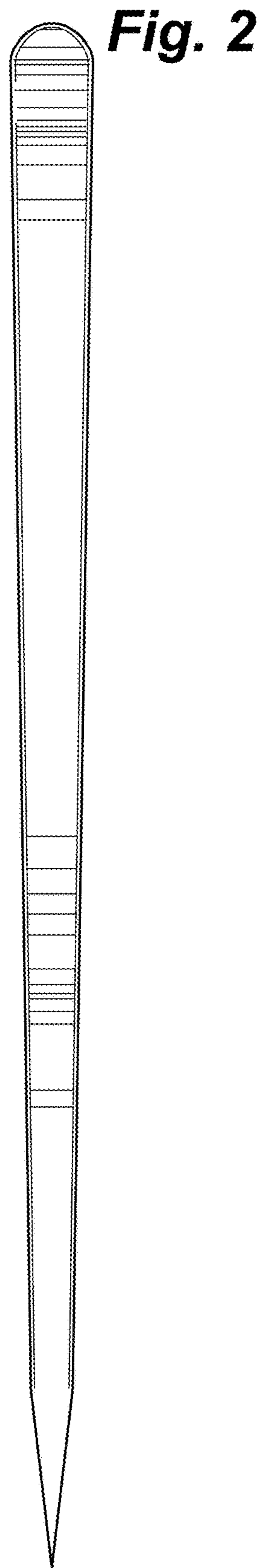
