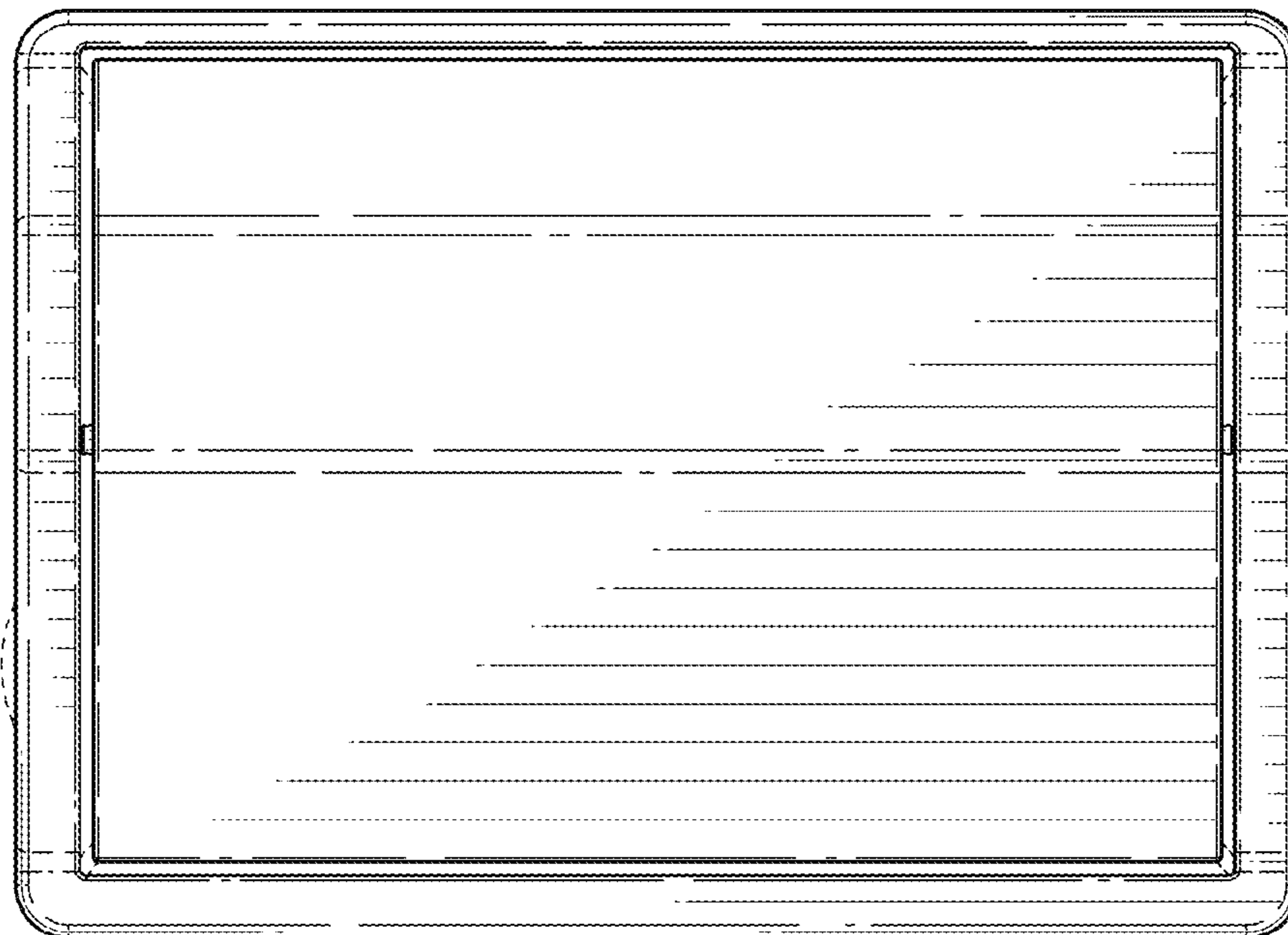
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of the combined garbage and recyclables receptacle.

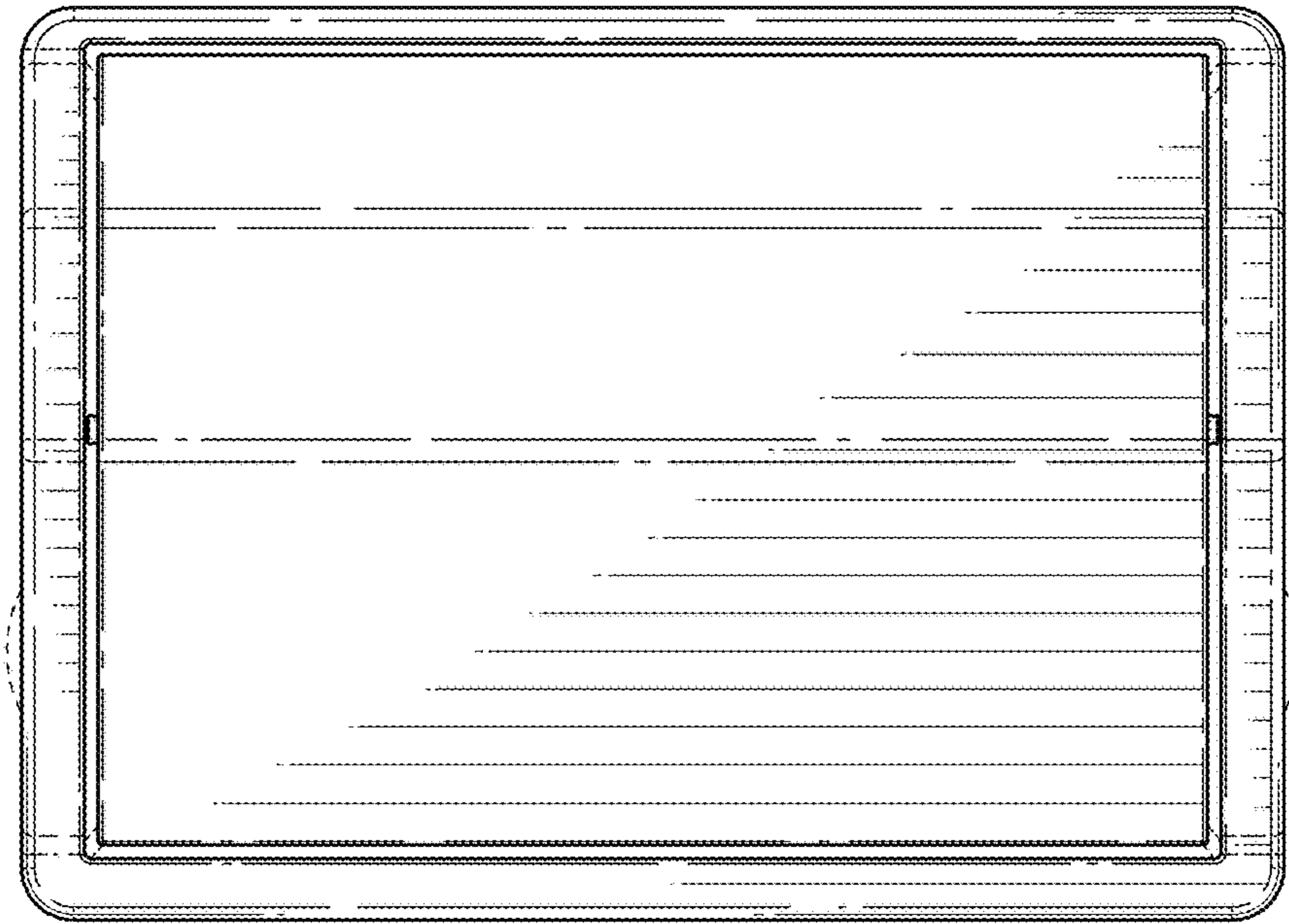

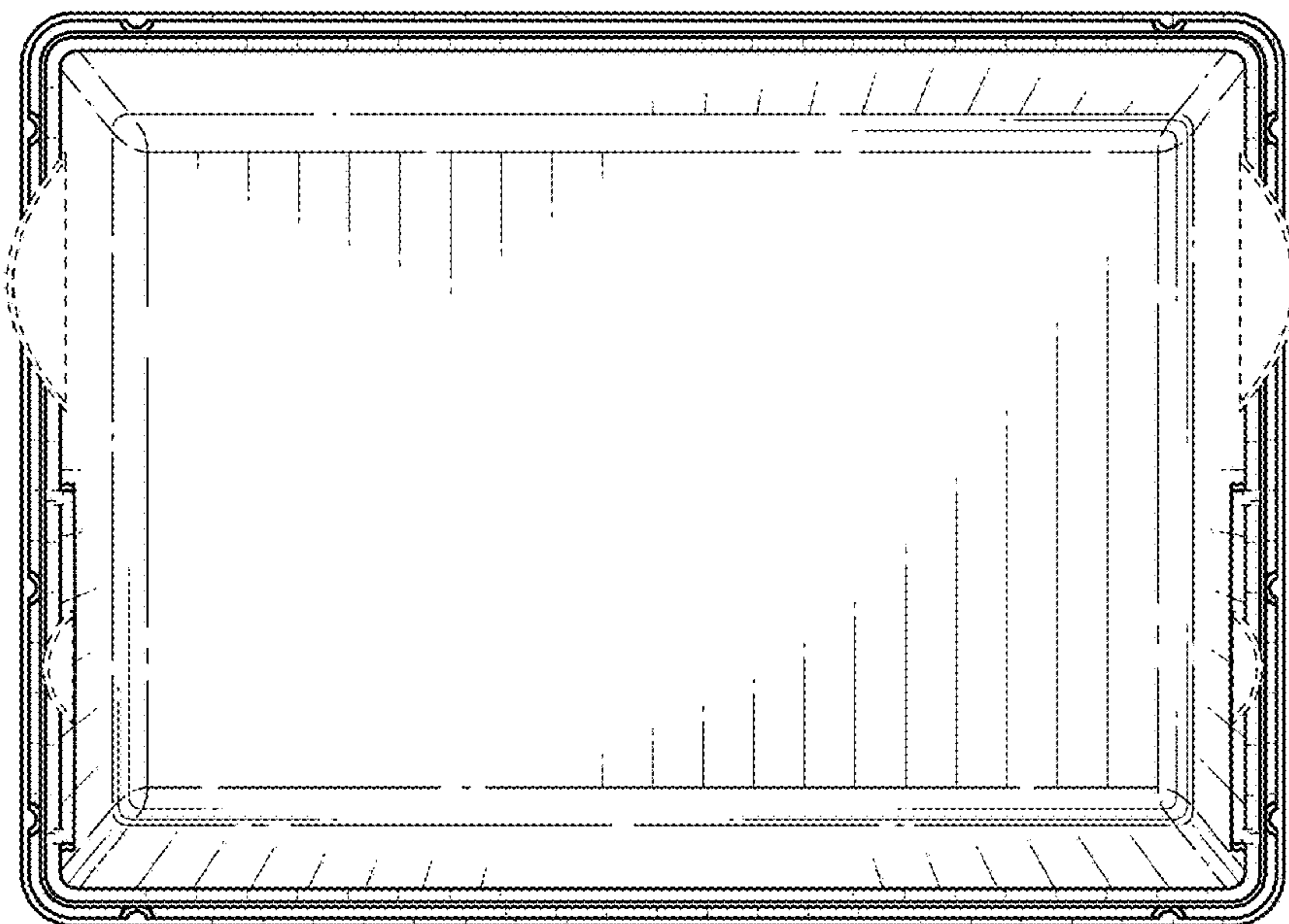

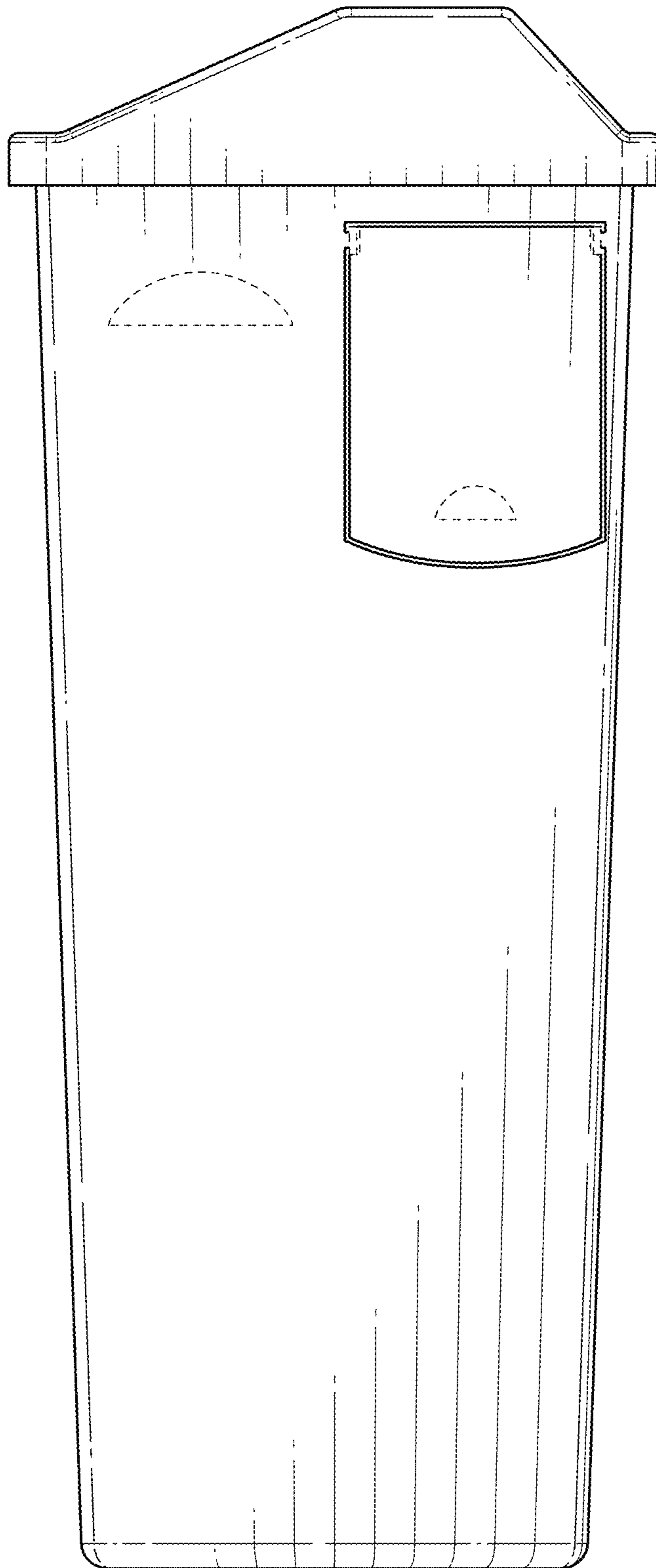

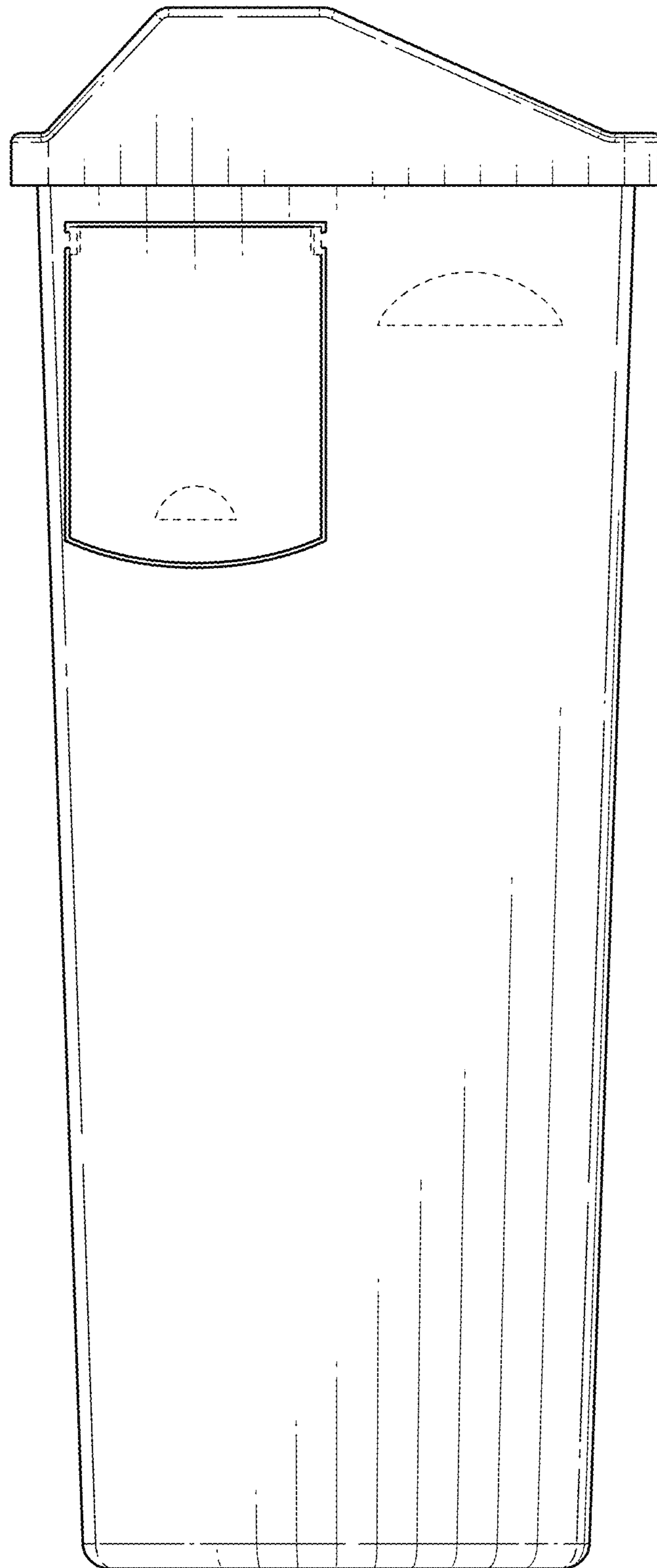

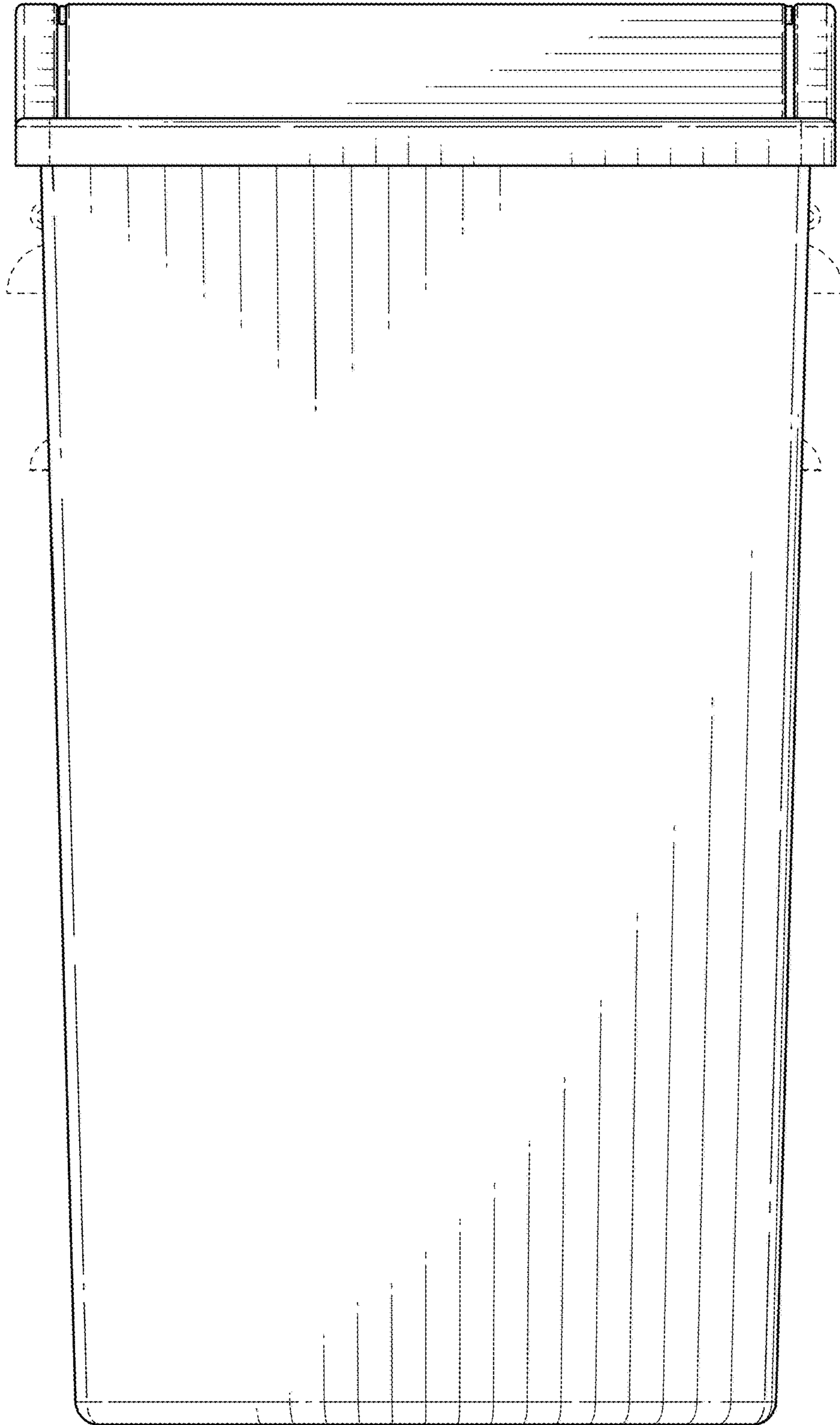

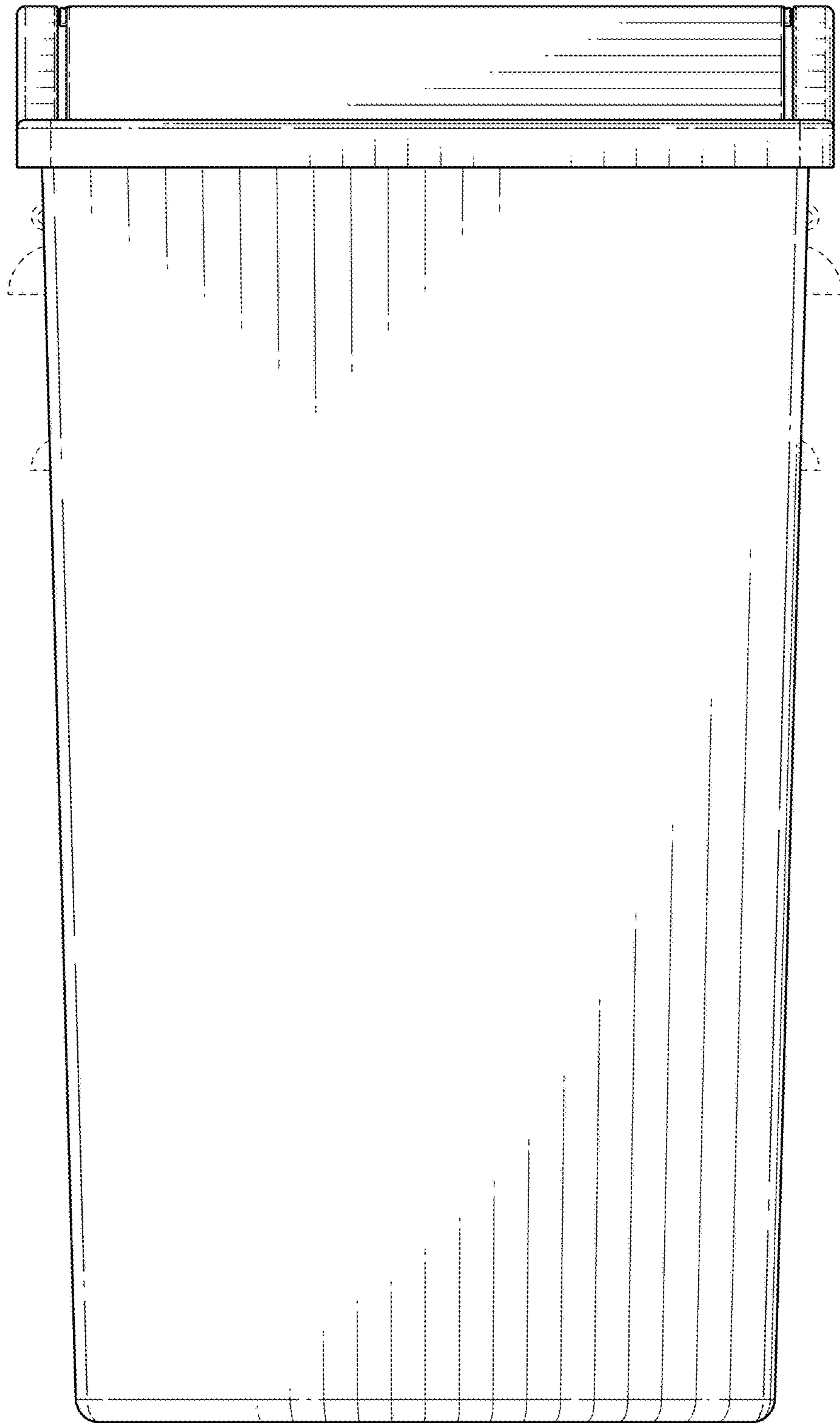

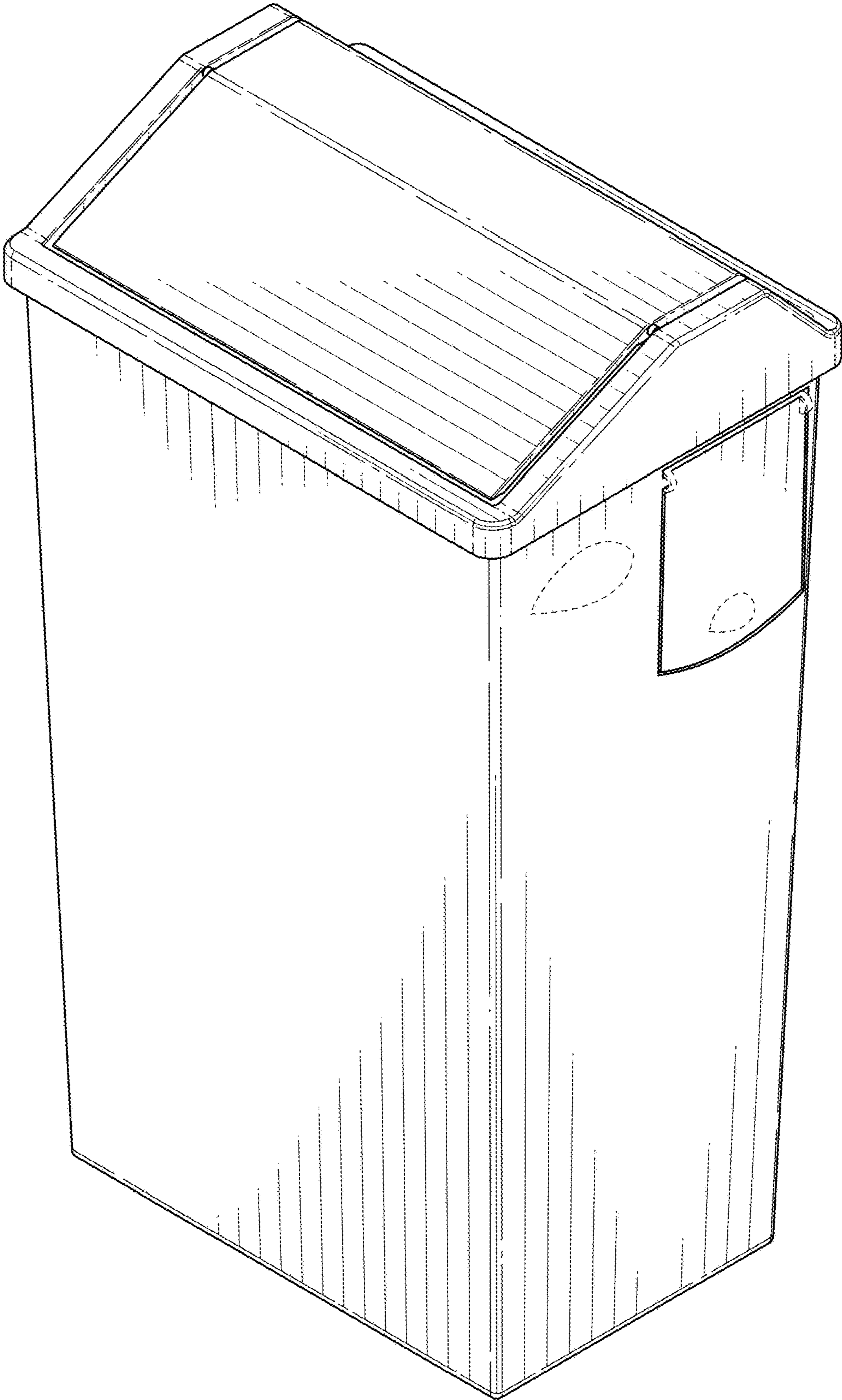

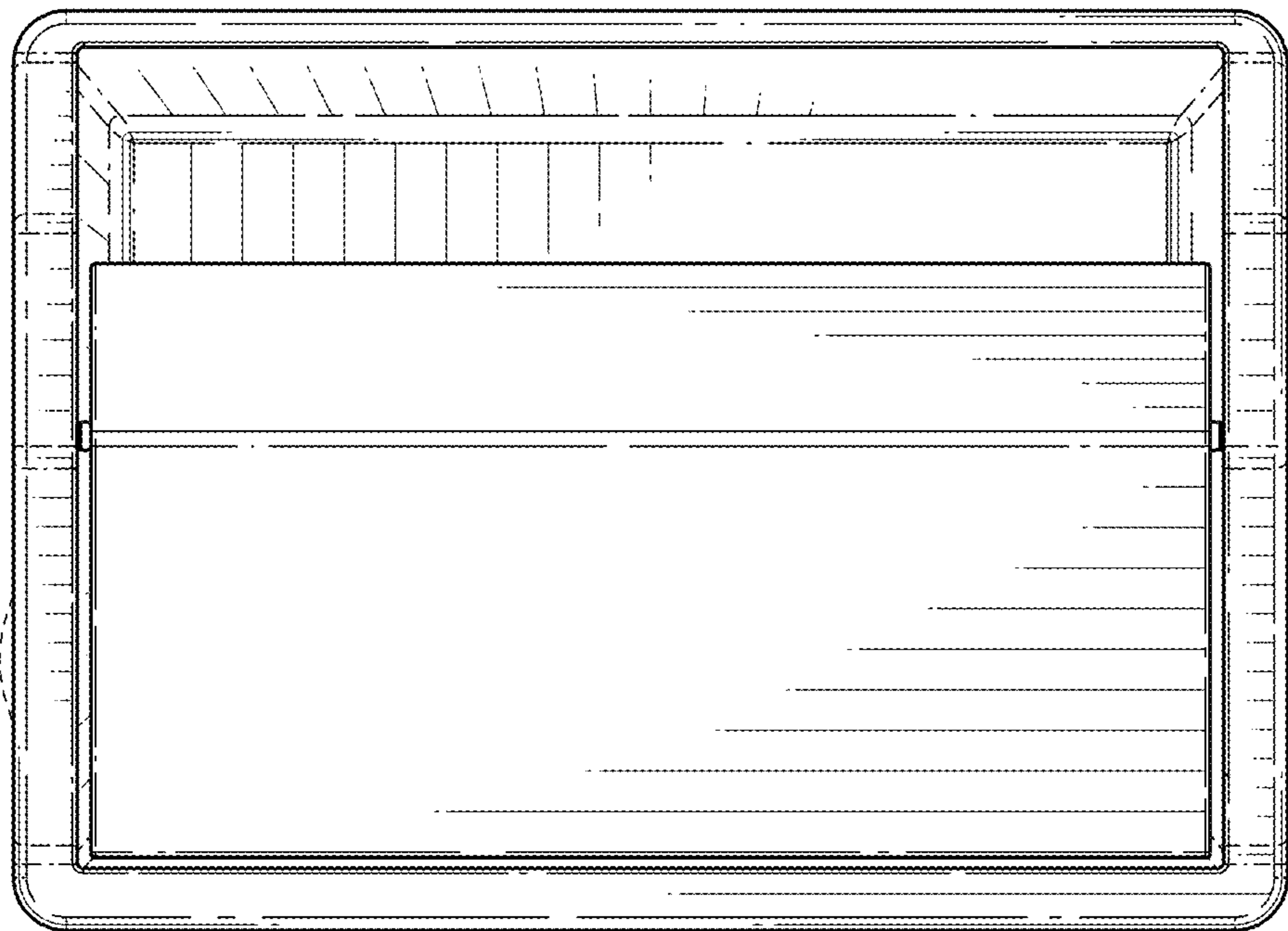

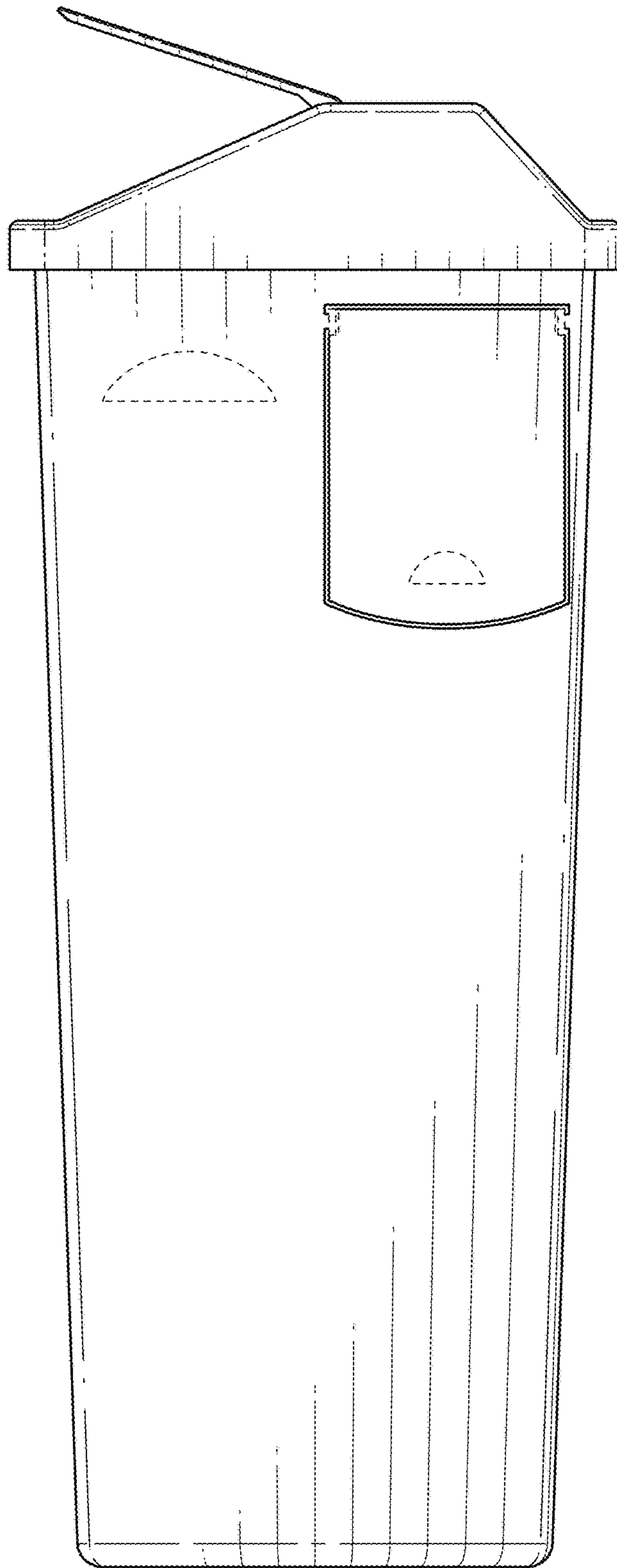

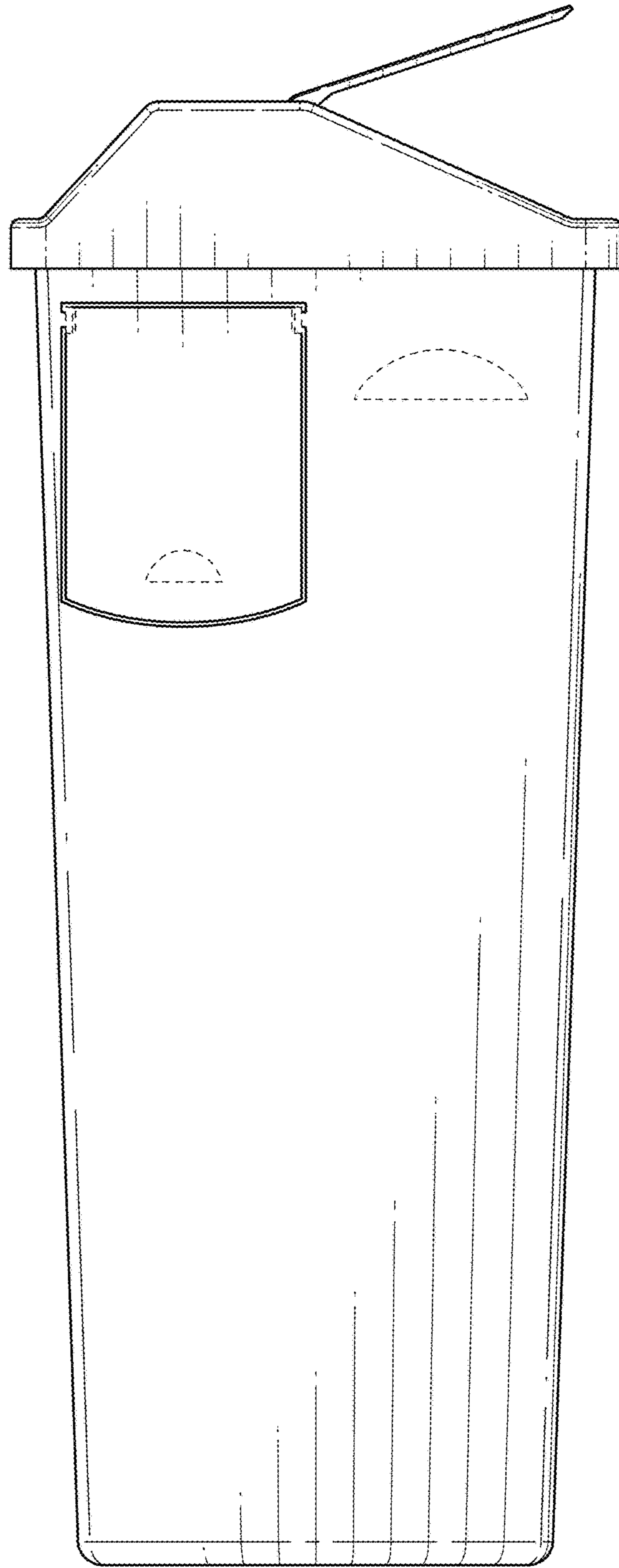

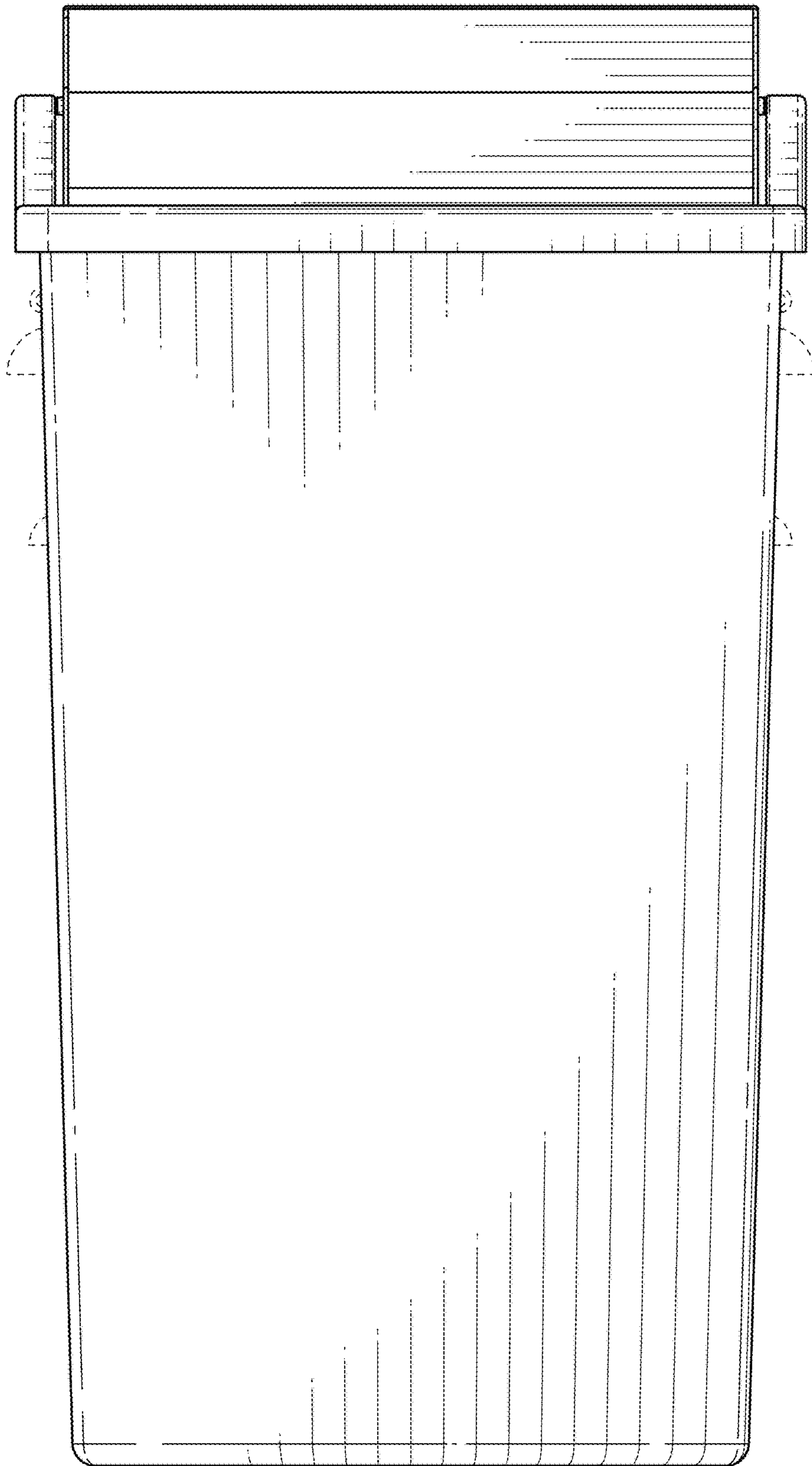

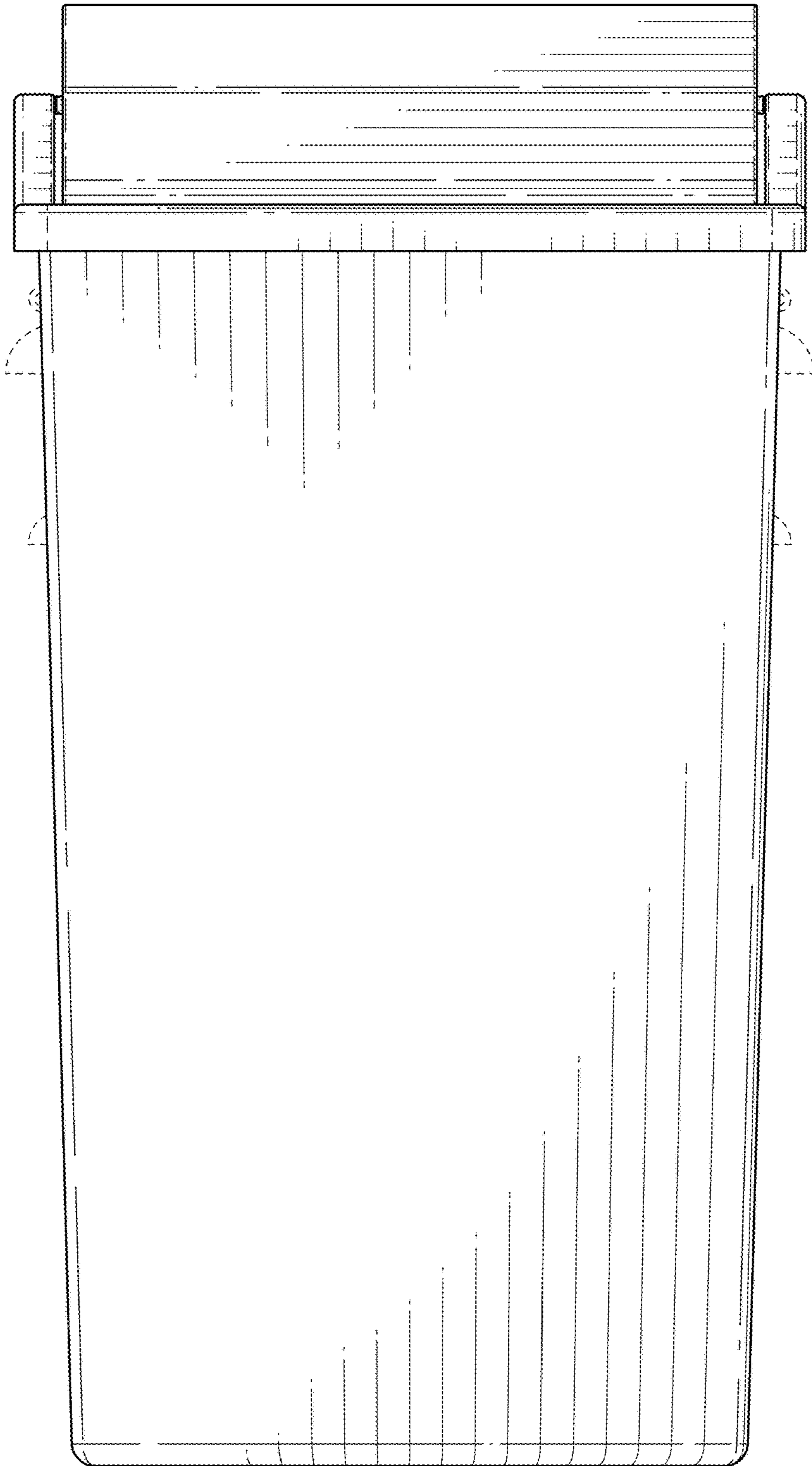

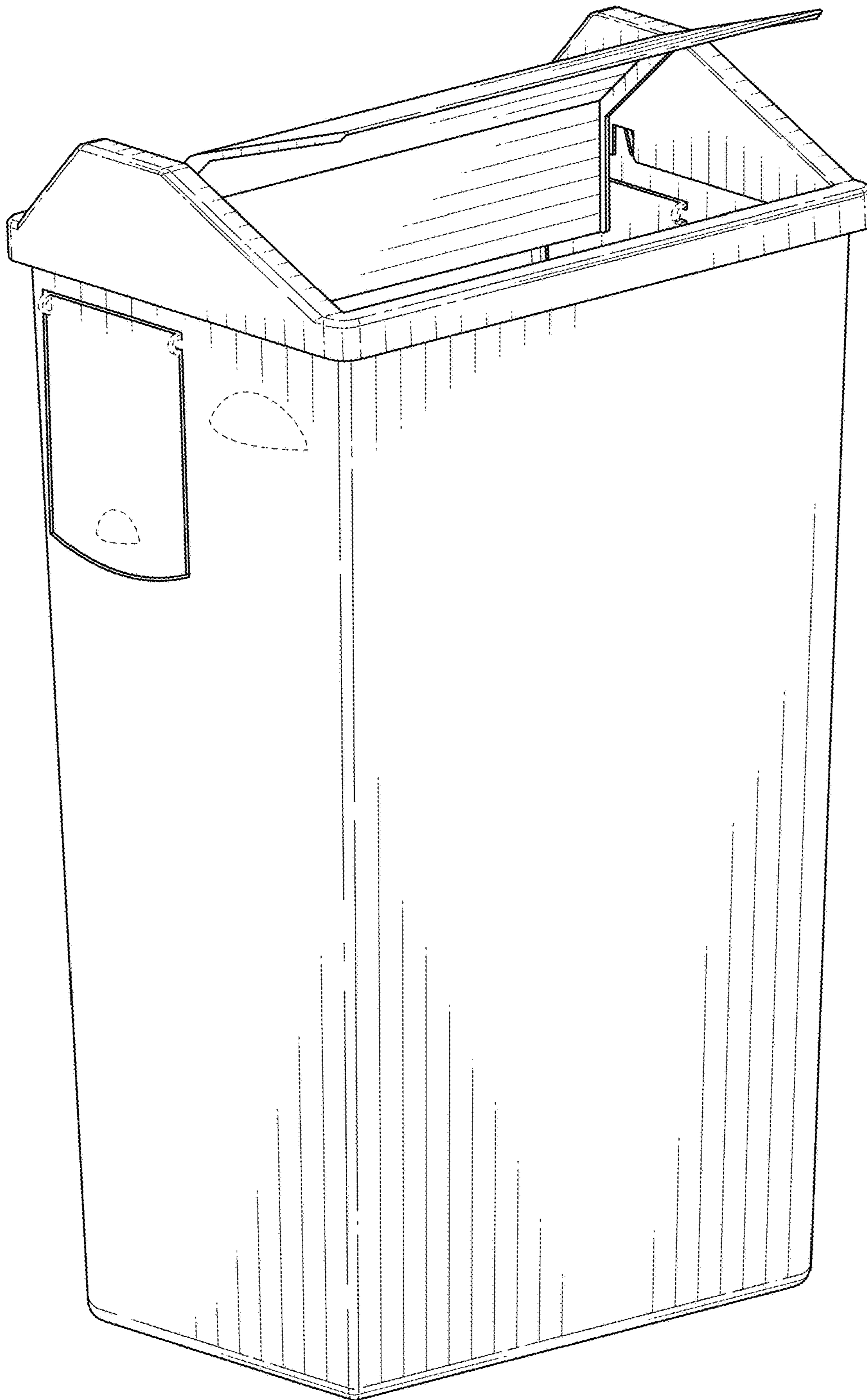

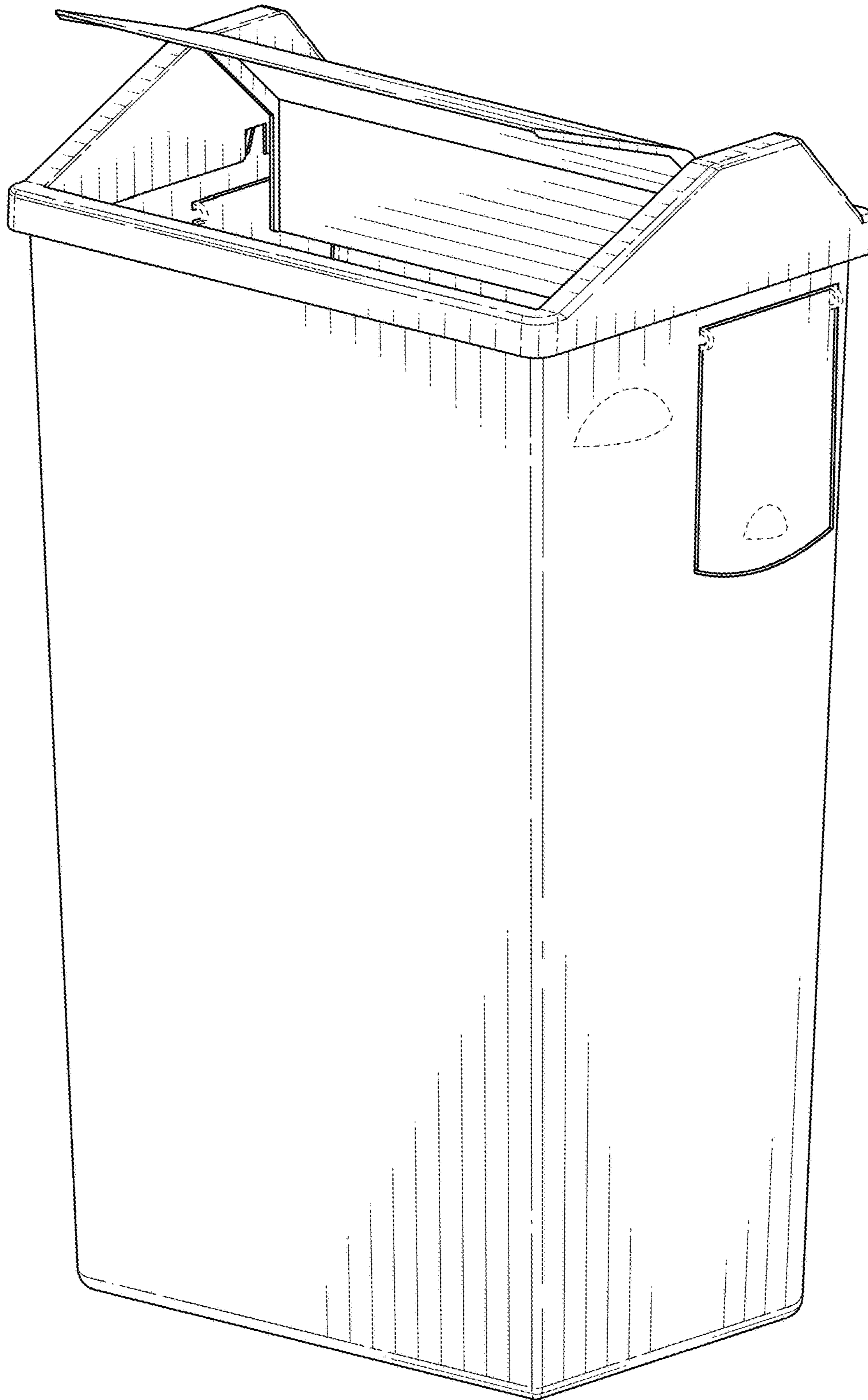
