

We claim the ornamental design for a holster, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a holster showing our new design;
FIG. 2 is an opposite side elevation view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof; and,
FIG. 5 is a bottom plan view thereof.
FIGS. 1-3 include broken lines indicating subject matter forming no part of the claimed design.








