The ornamental design for a card dispensing wallet.

**DESCRIPTION**

FIG. 1 is a top, front perspective view of a card dispensing wallet shown in a closed configuration.

FIG. 2 is a top, rear perspective view of a card dispensing wallet shown in FIG. 1.

FIG. 3 is a rear elevational view of the invention shown in FIG. 1.

FIG. 4 is a left side elevational view of the invention shown in FIG. 1.

FIG. 5 is a front elevational view of the invention shown in FIG. 1.

FIG. 6 is a right side elevational view of the invention shown in FIG. 1.

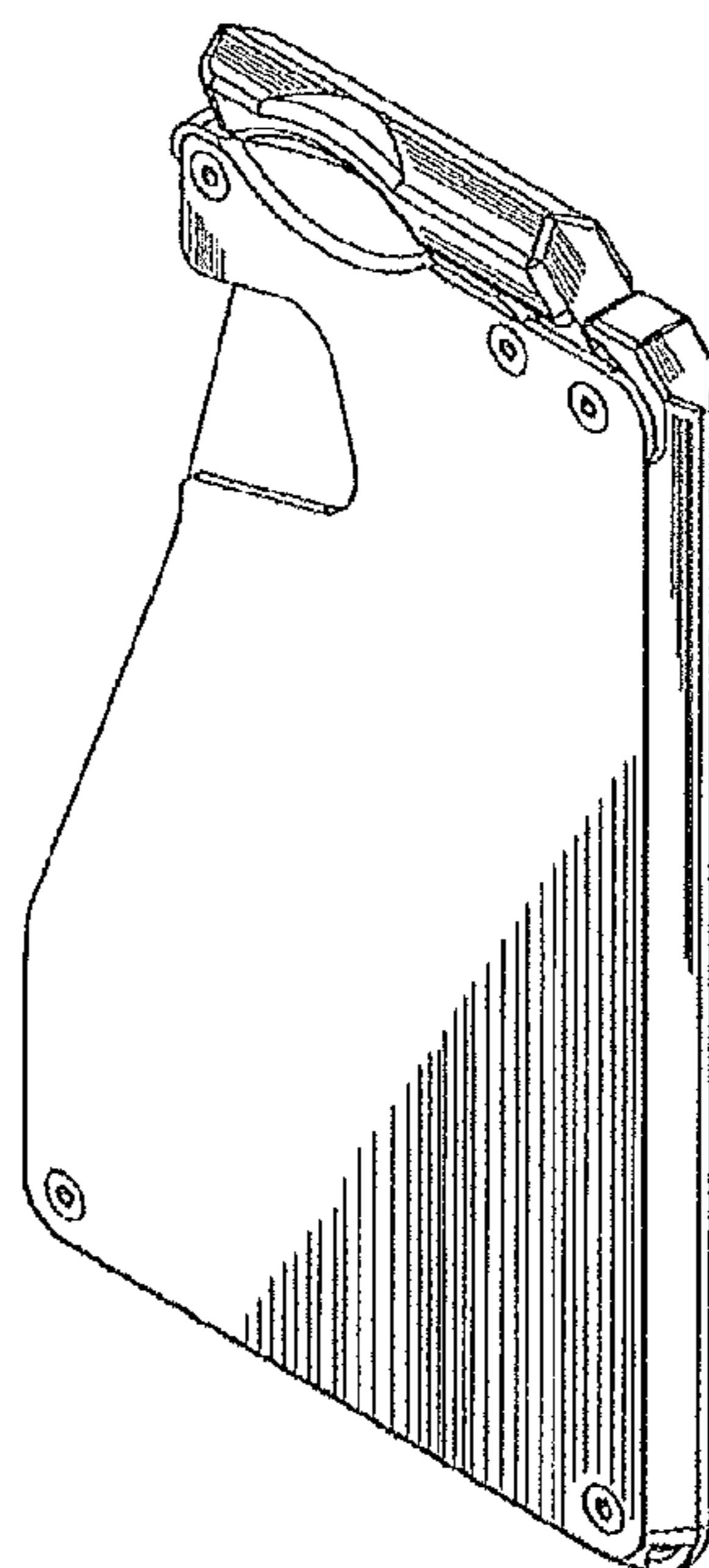
FIG. 7 is a top, plan view of the invention shown in FIG. 1.

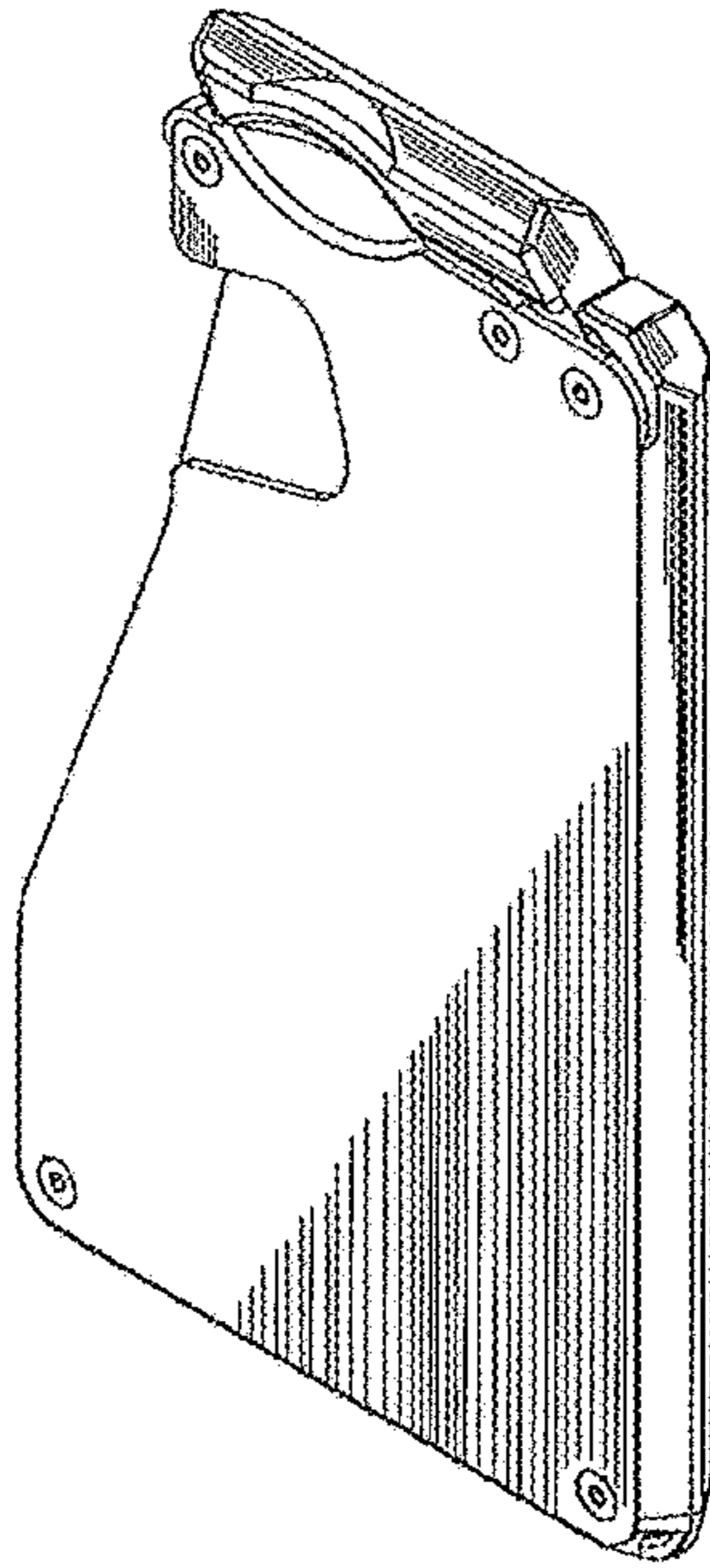

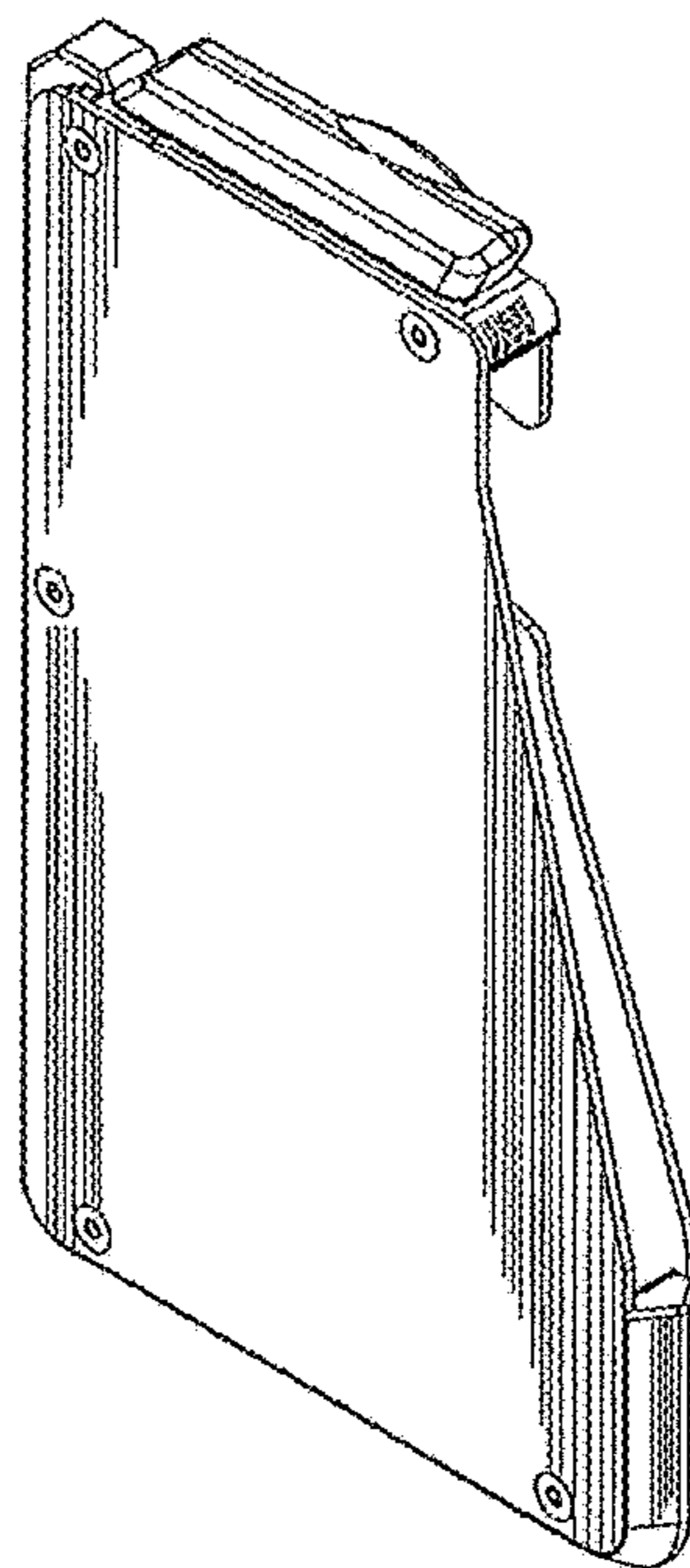

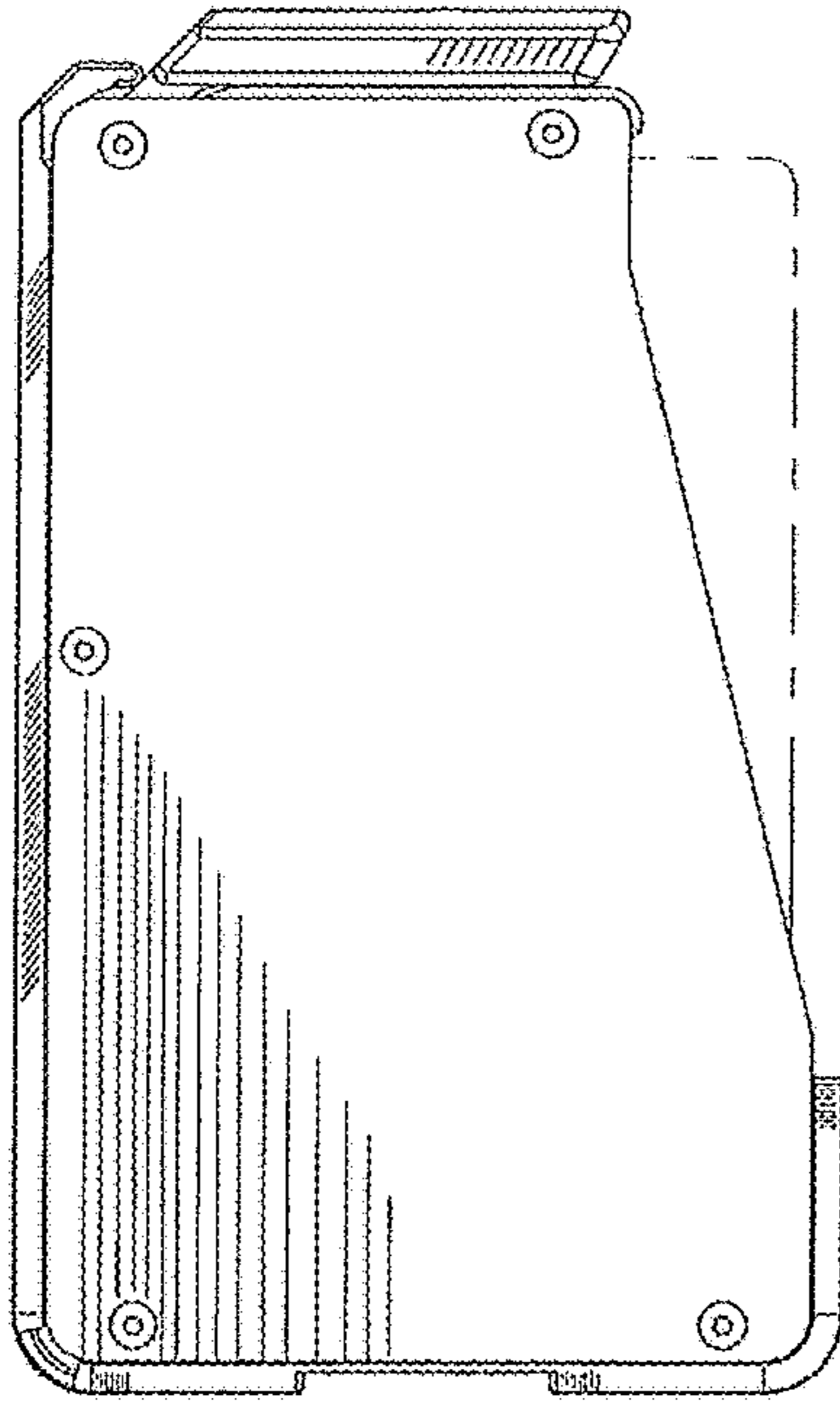

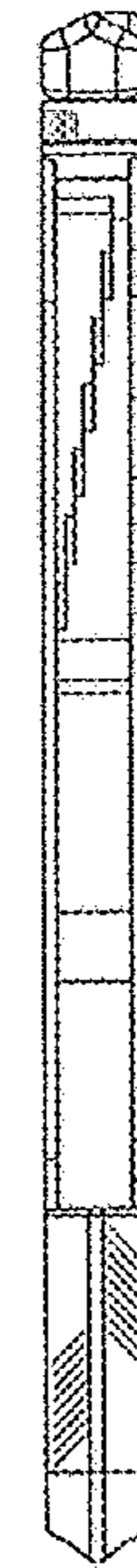

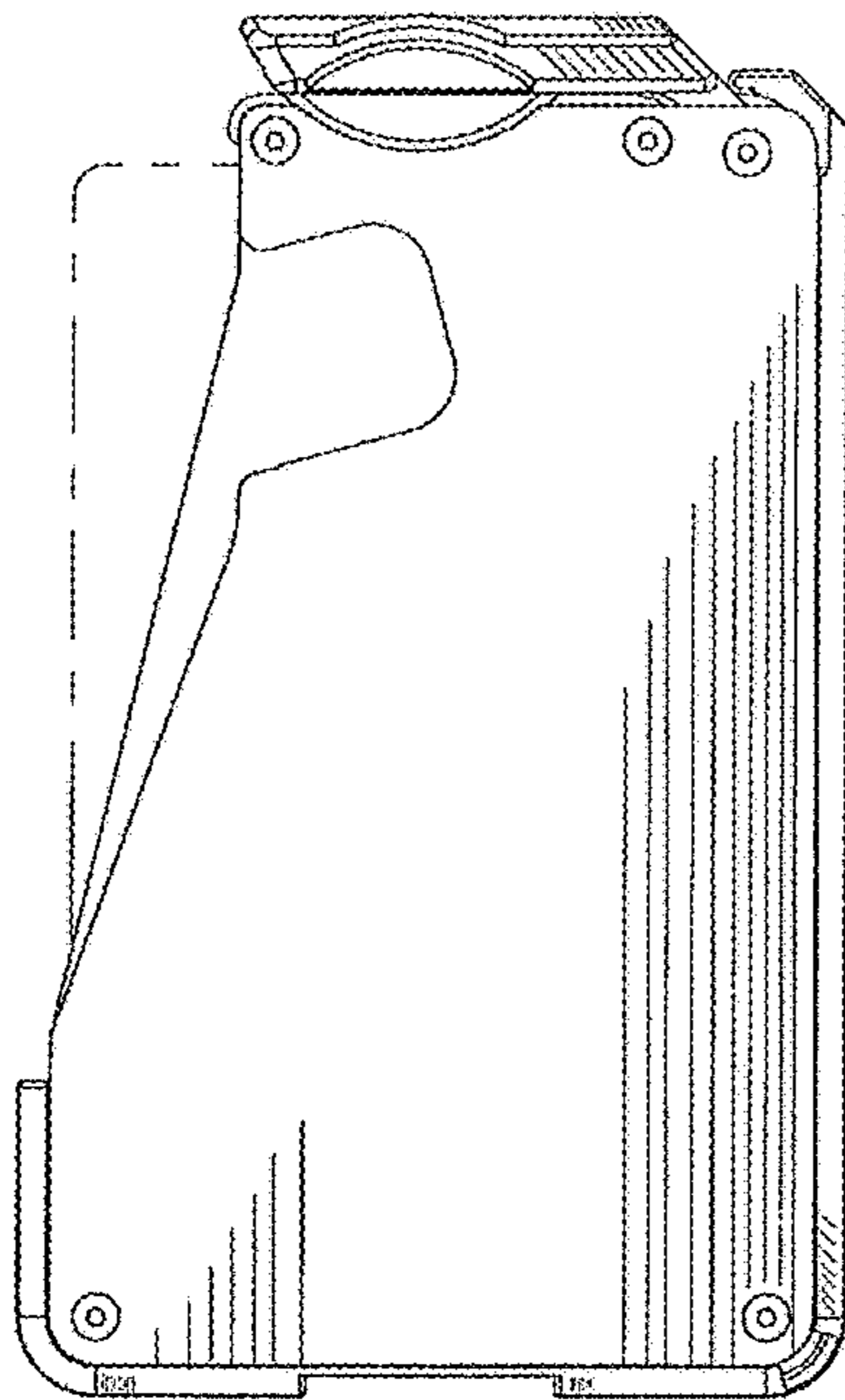

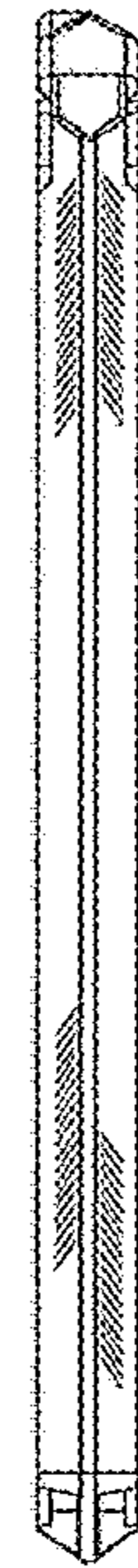

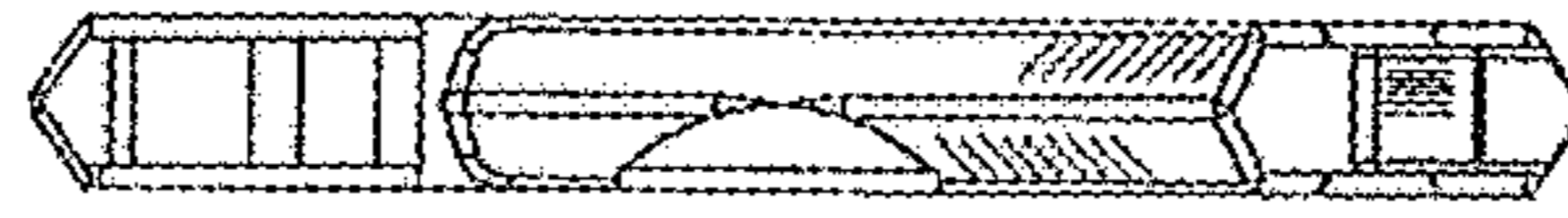

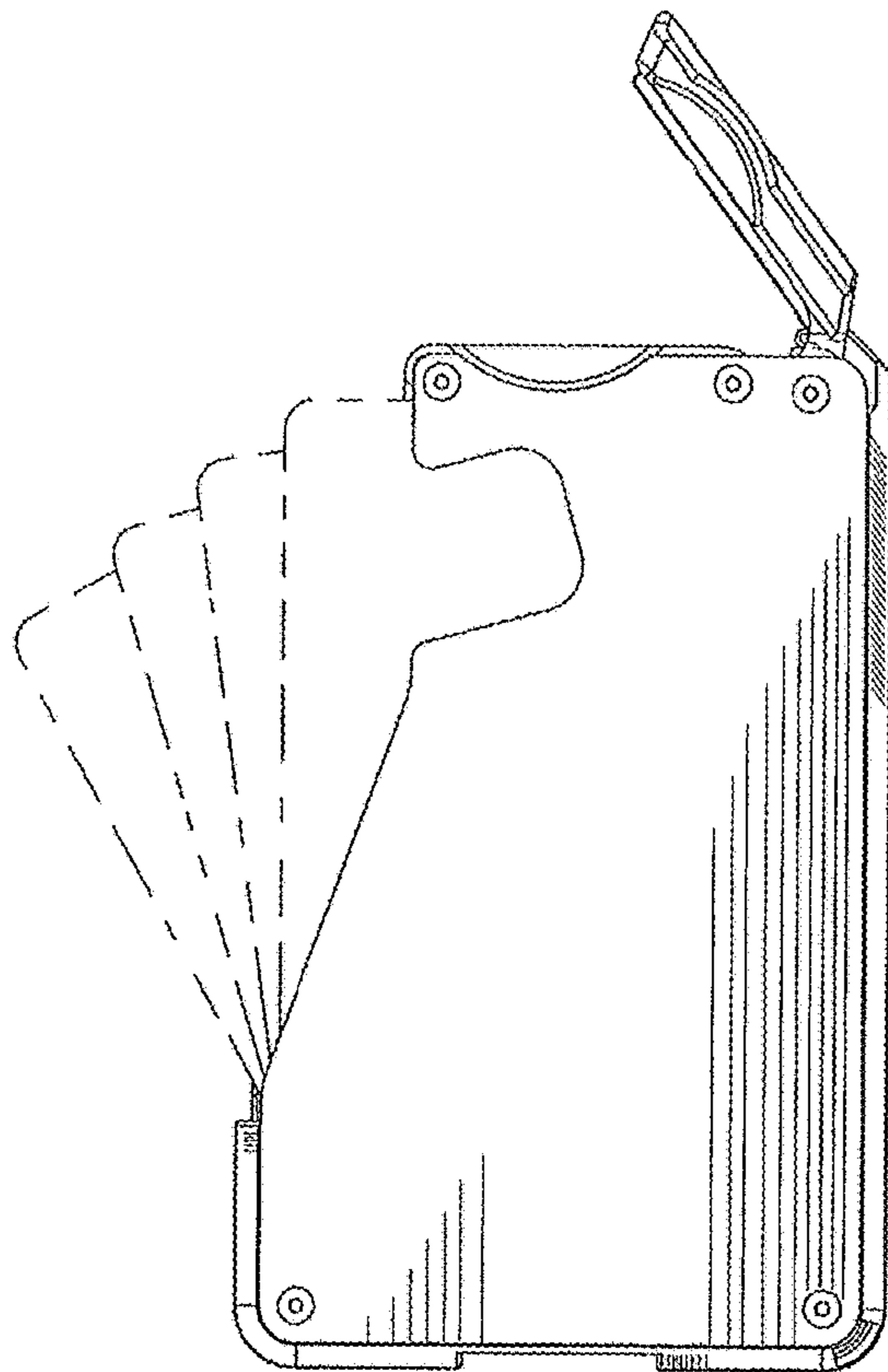
