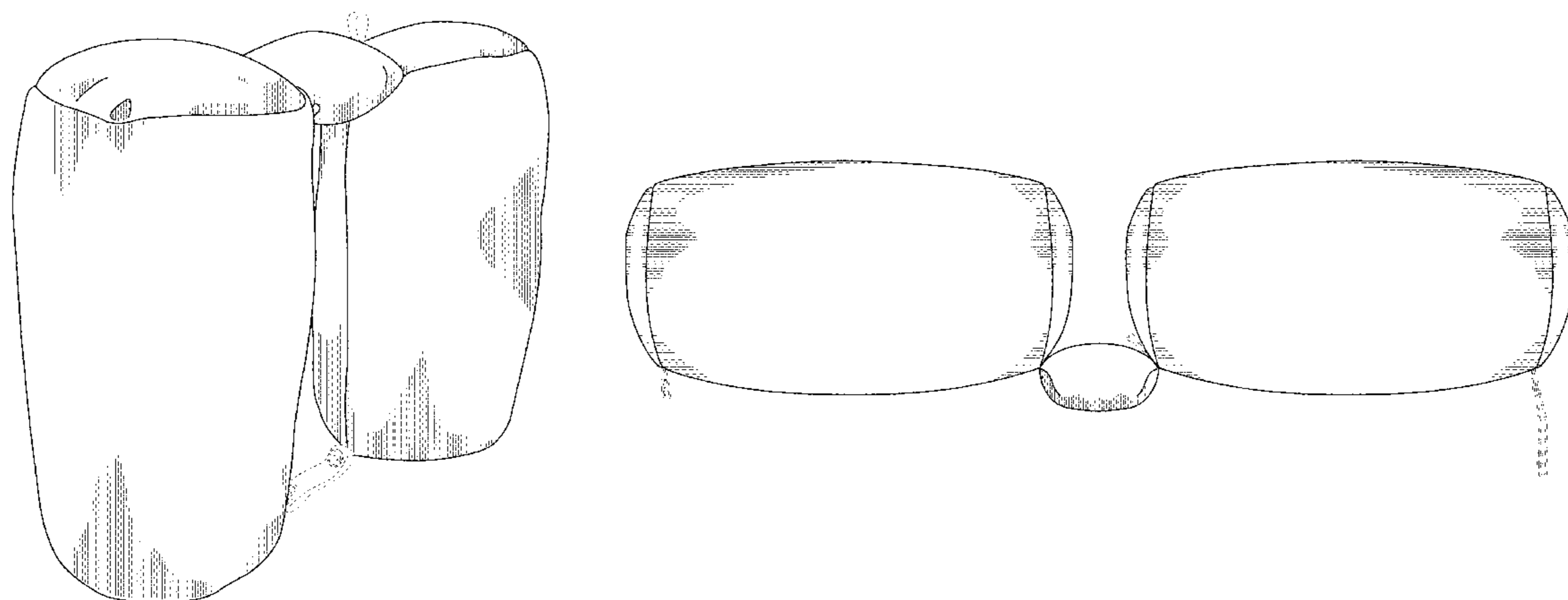
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper perspective view of a pillow showing my new design;

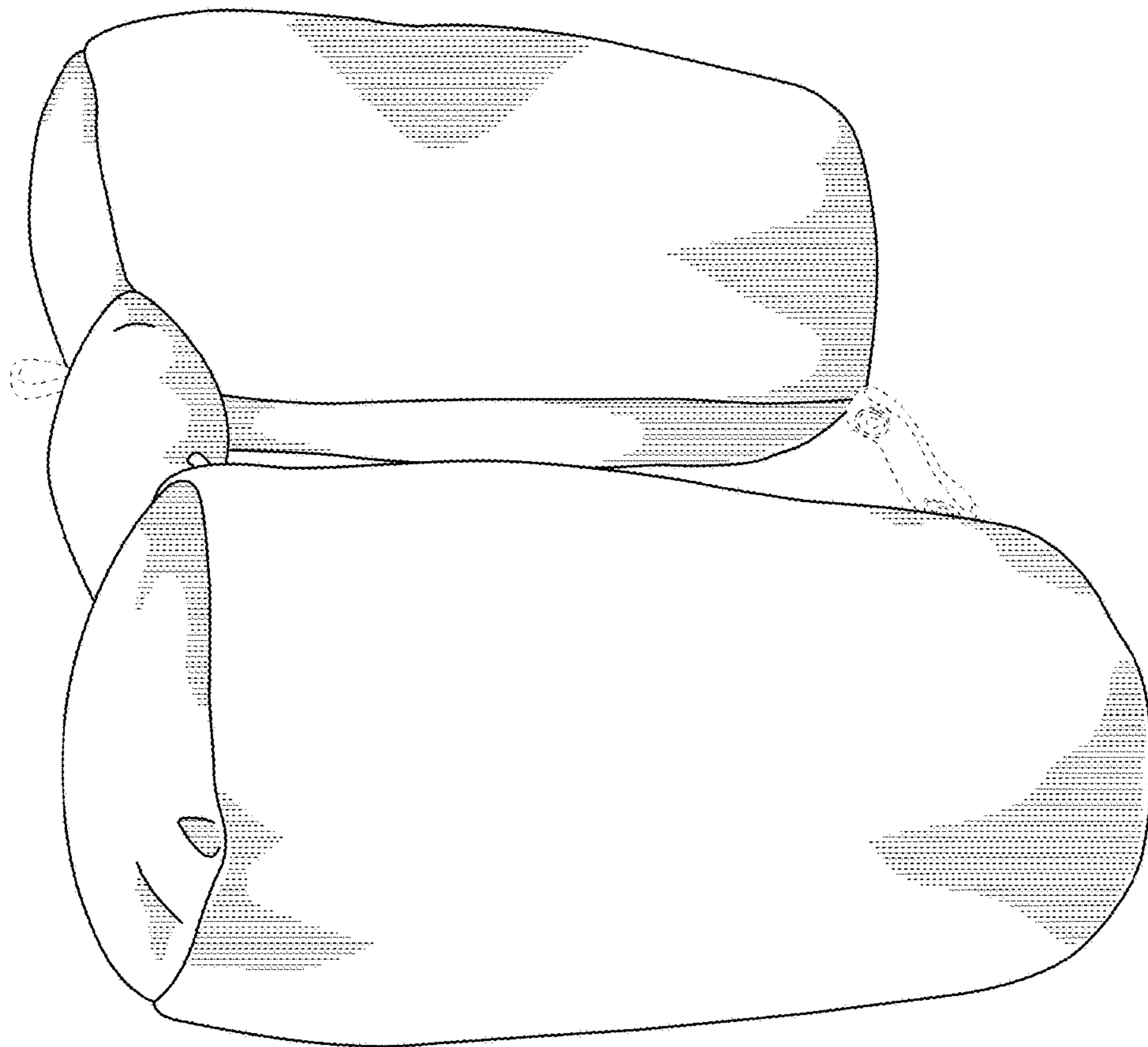

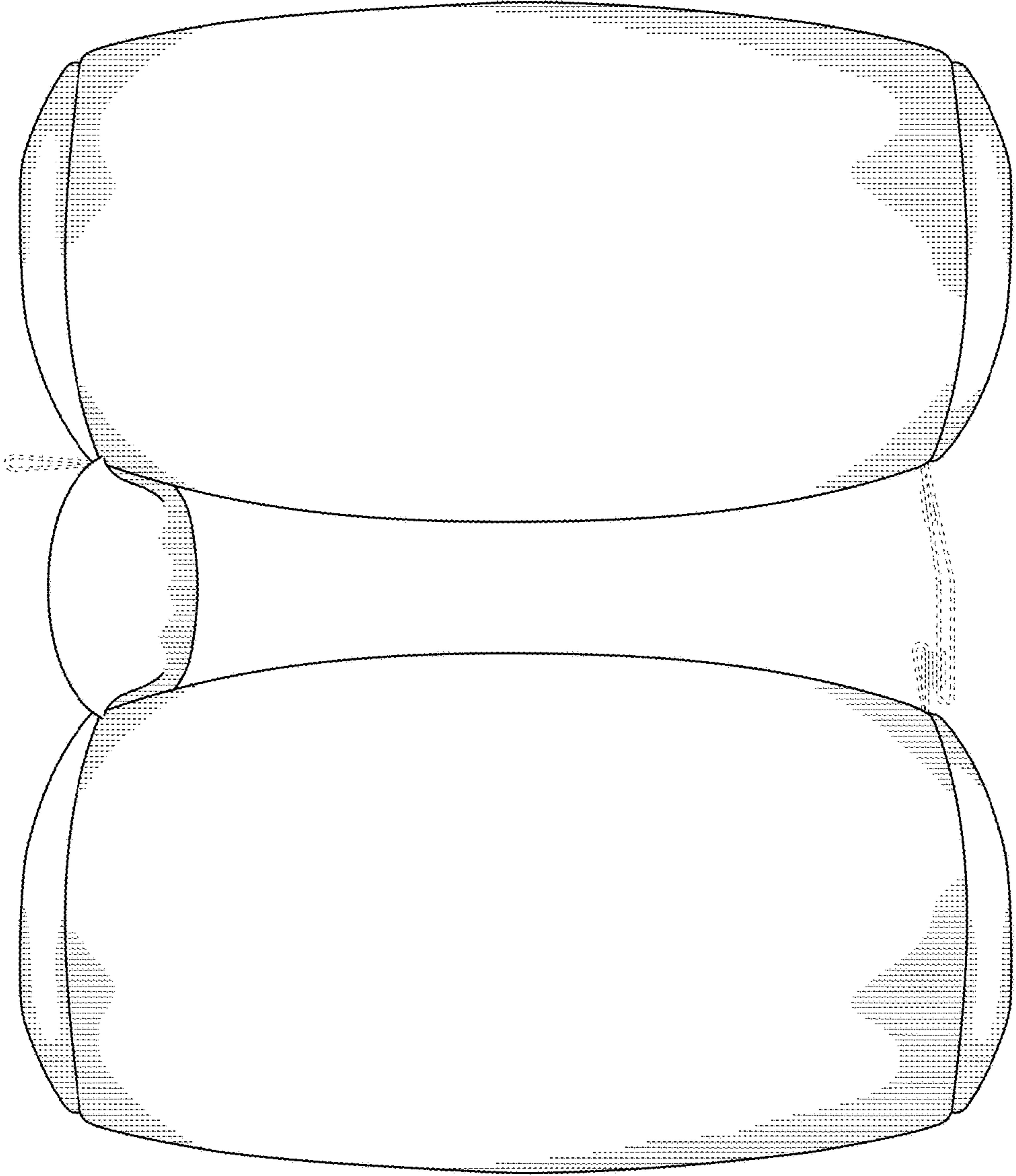

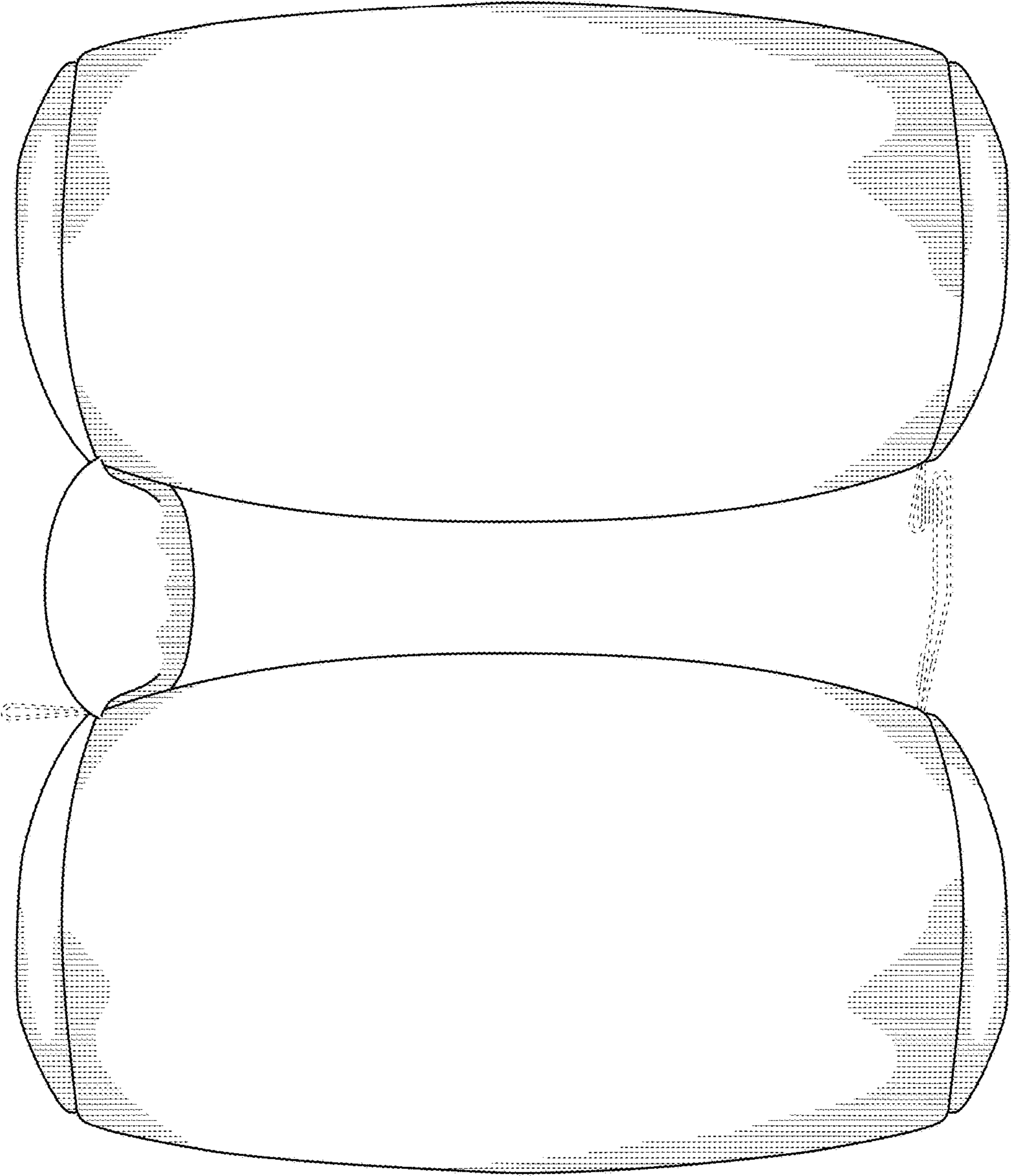

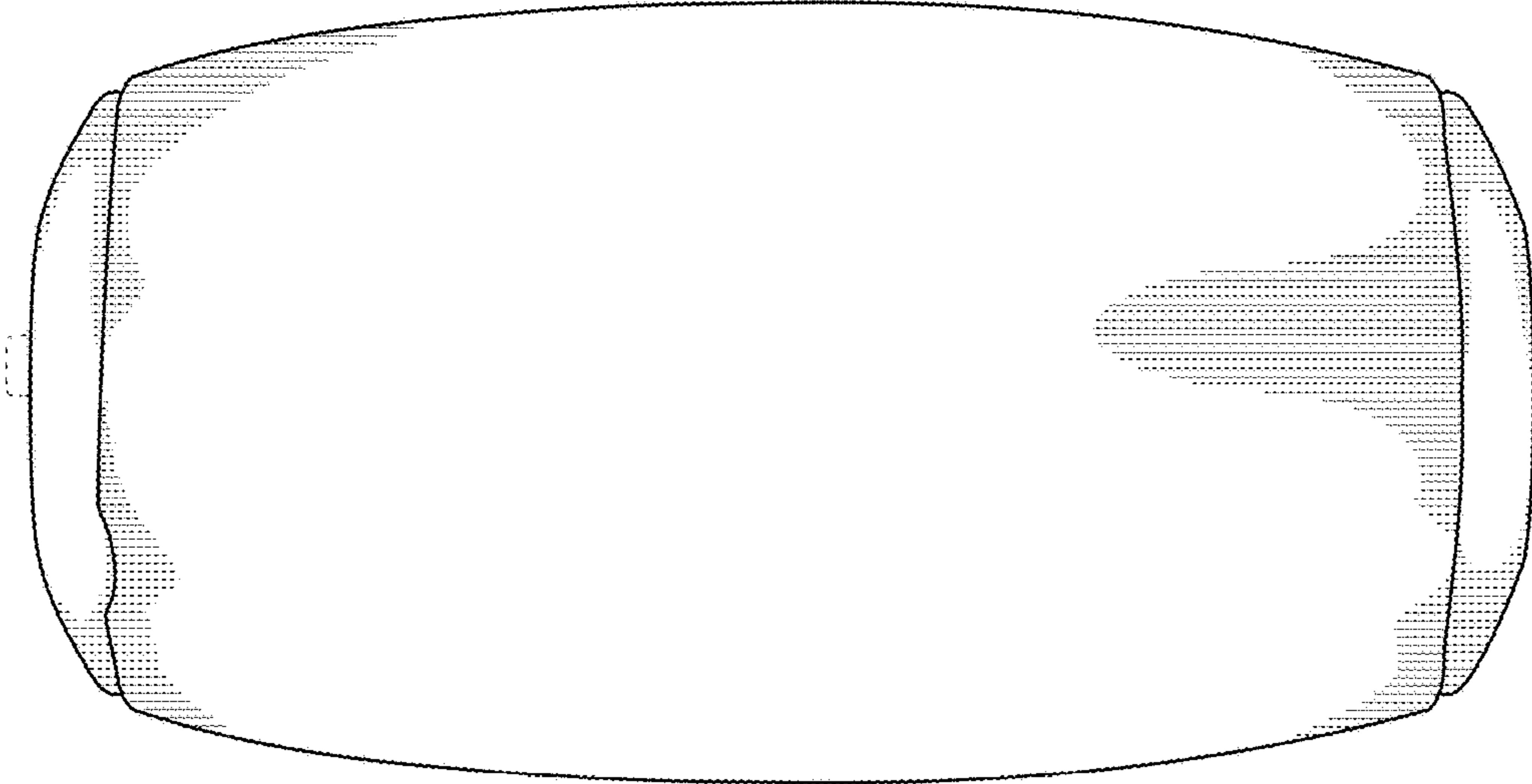

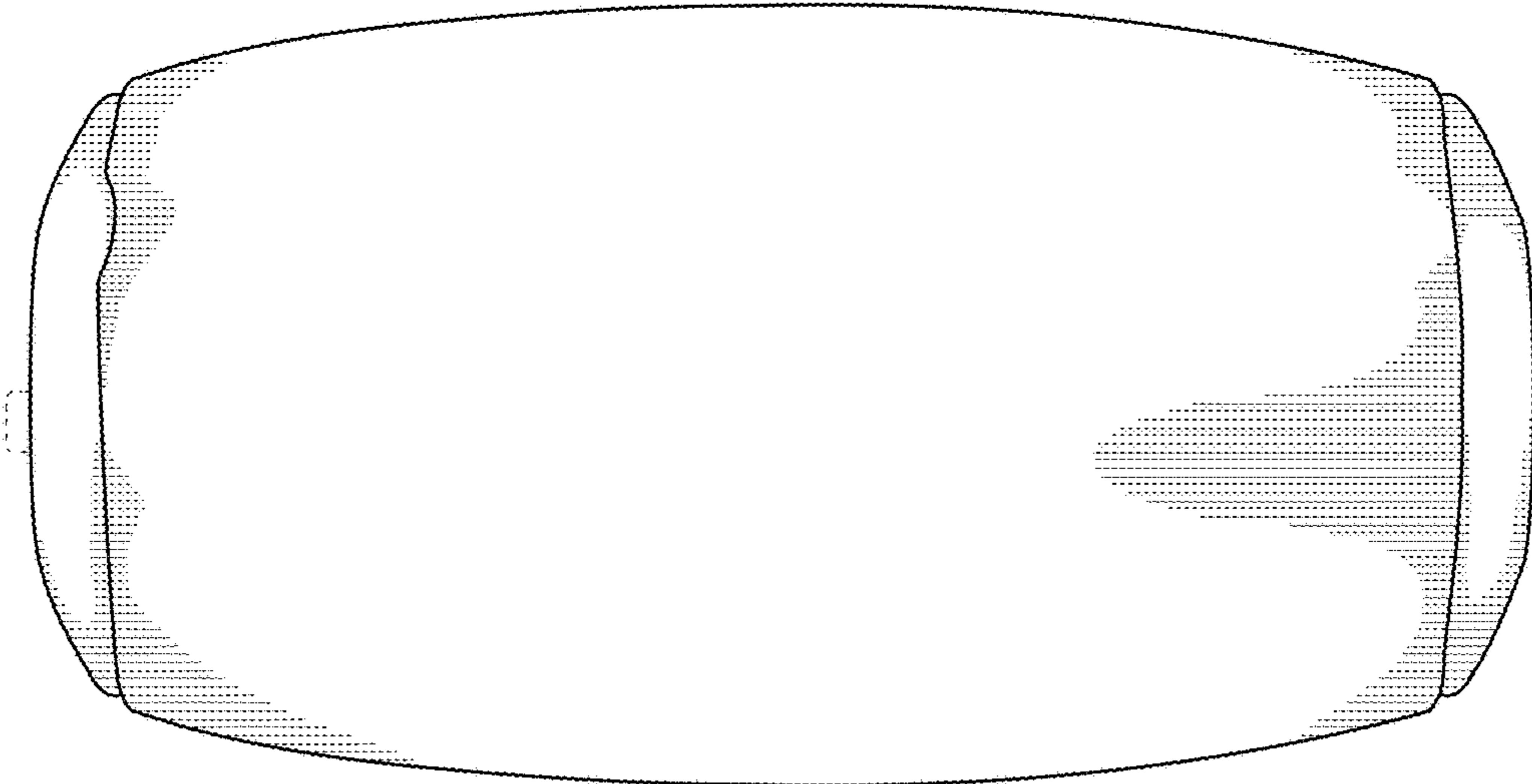

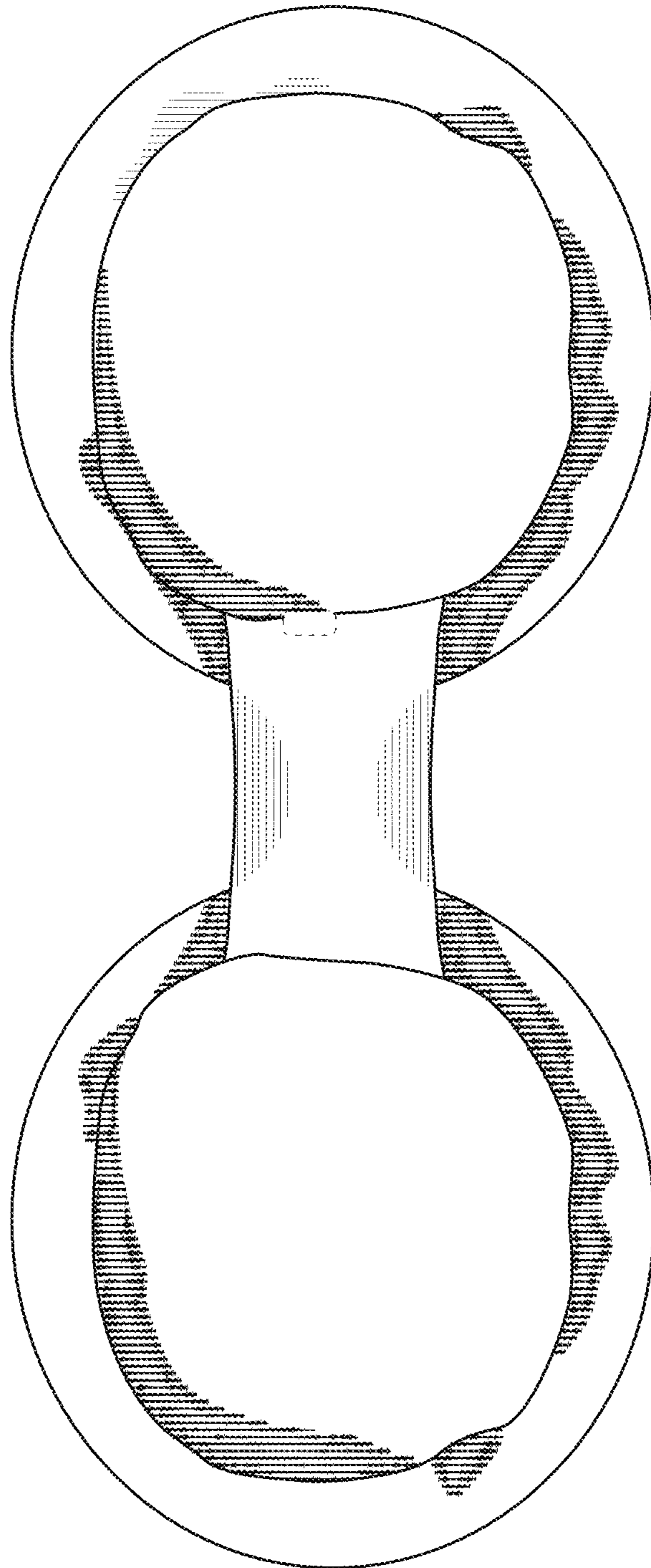

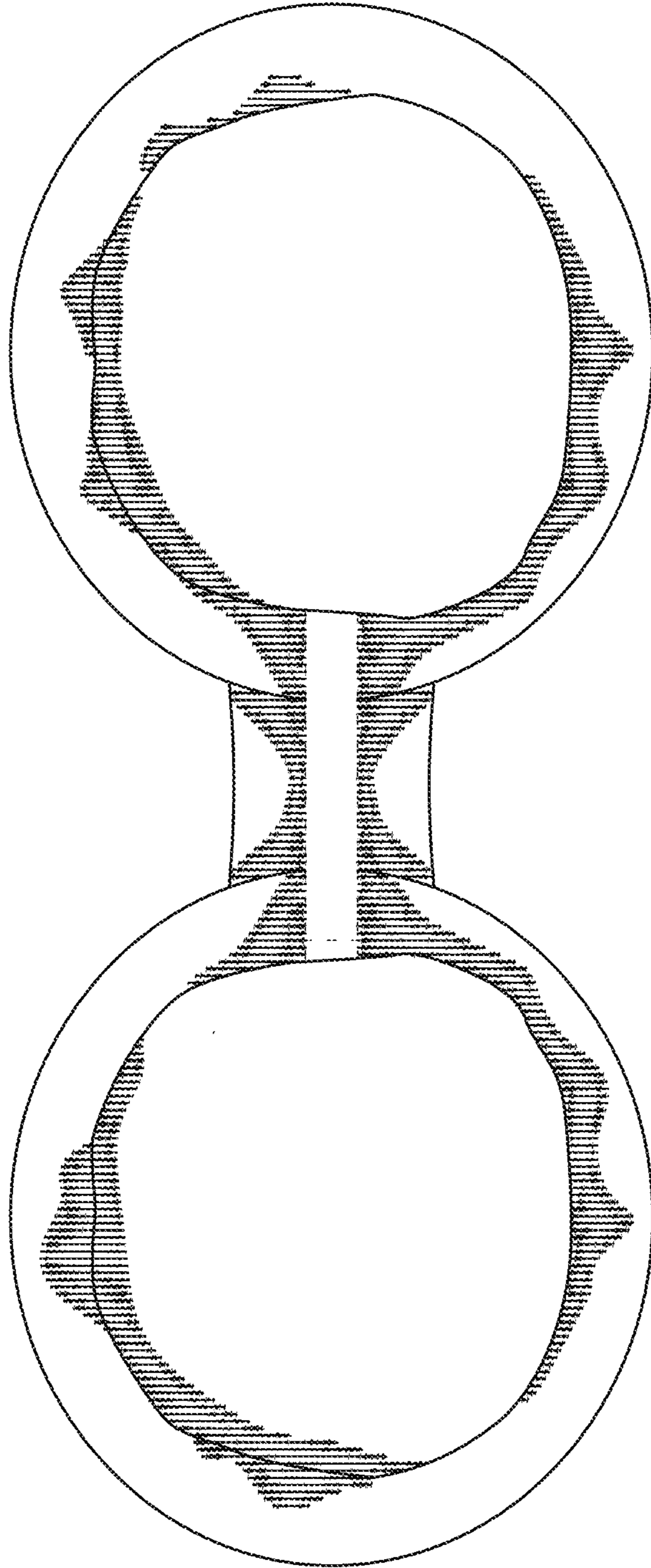

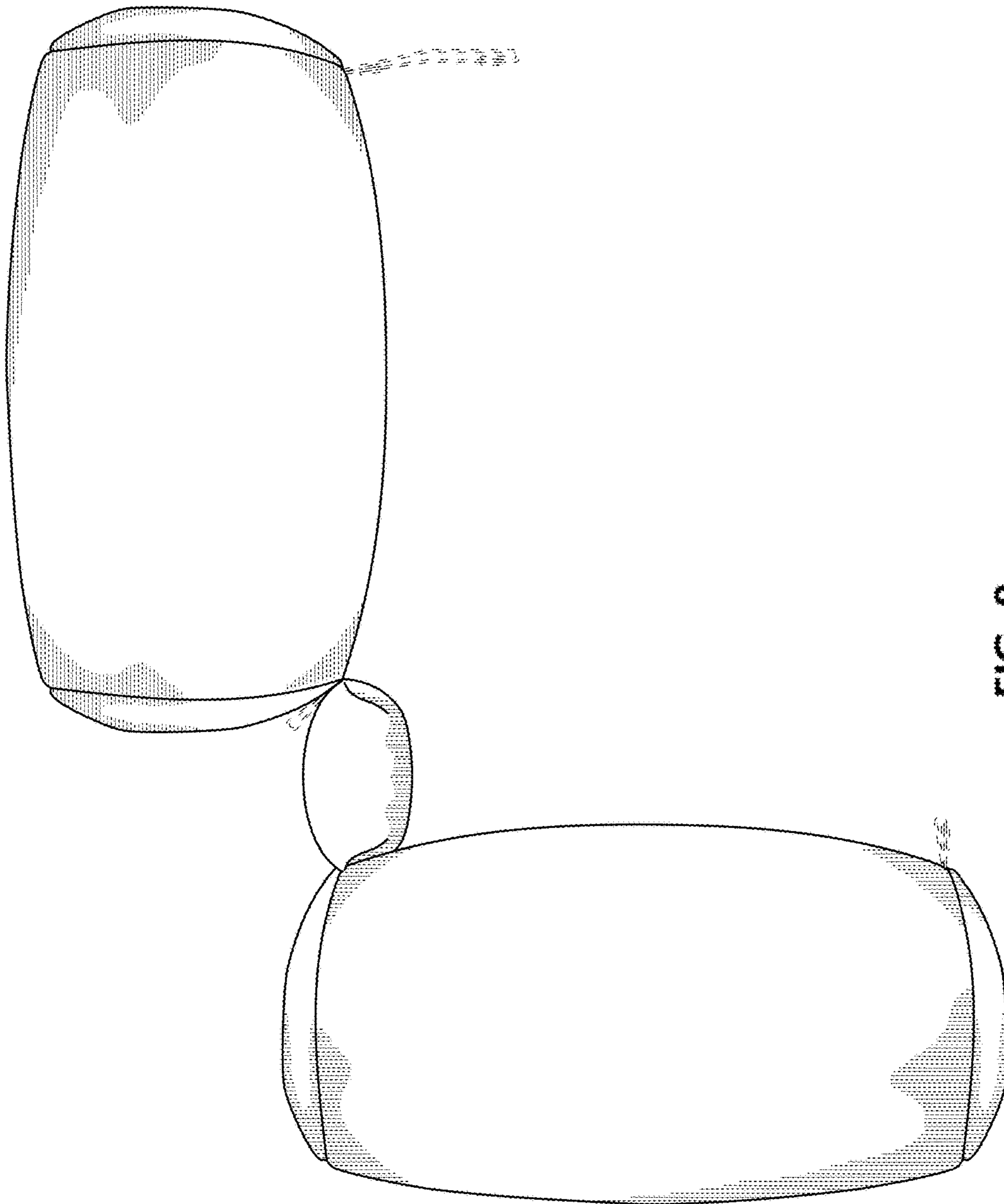

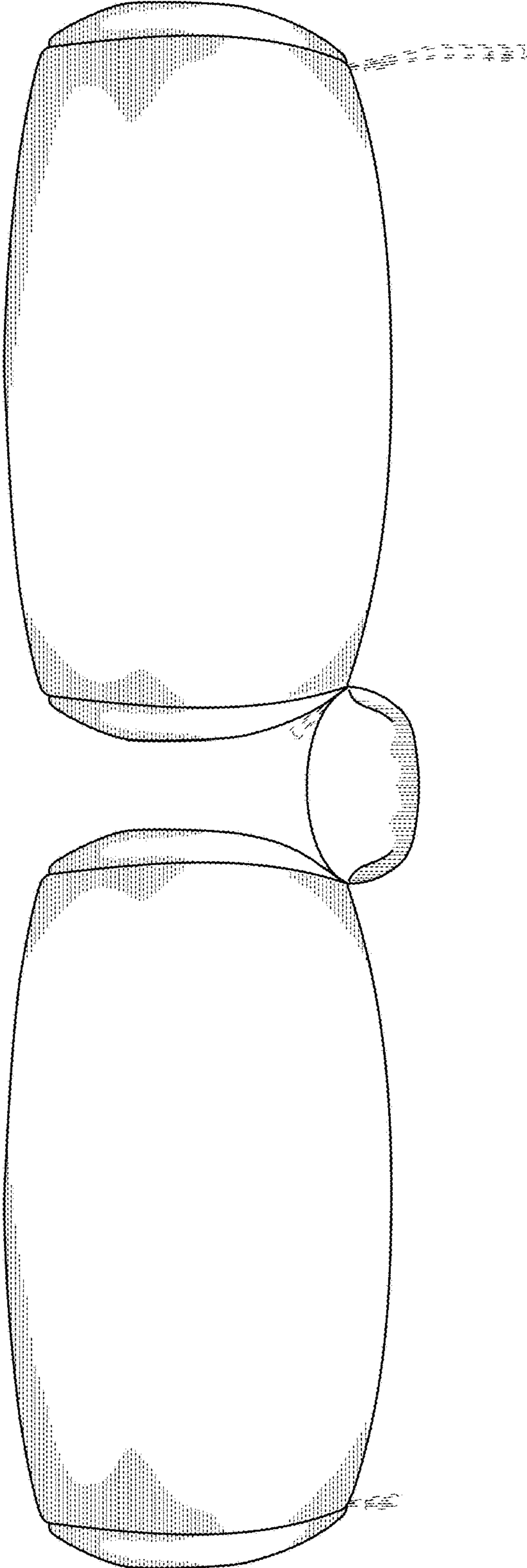
