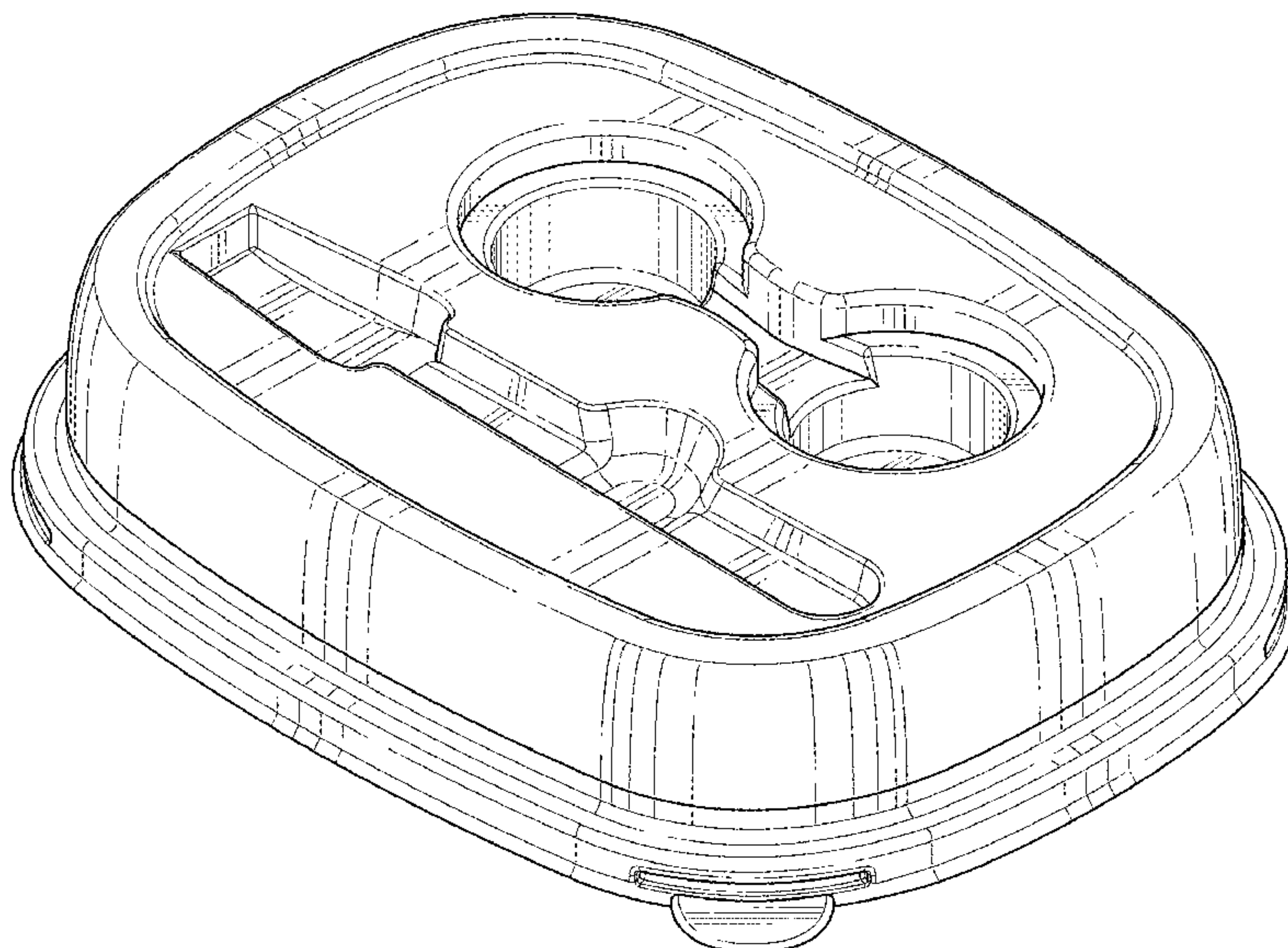
CLAIM

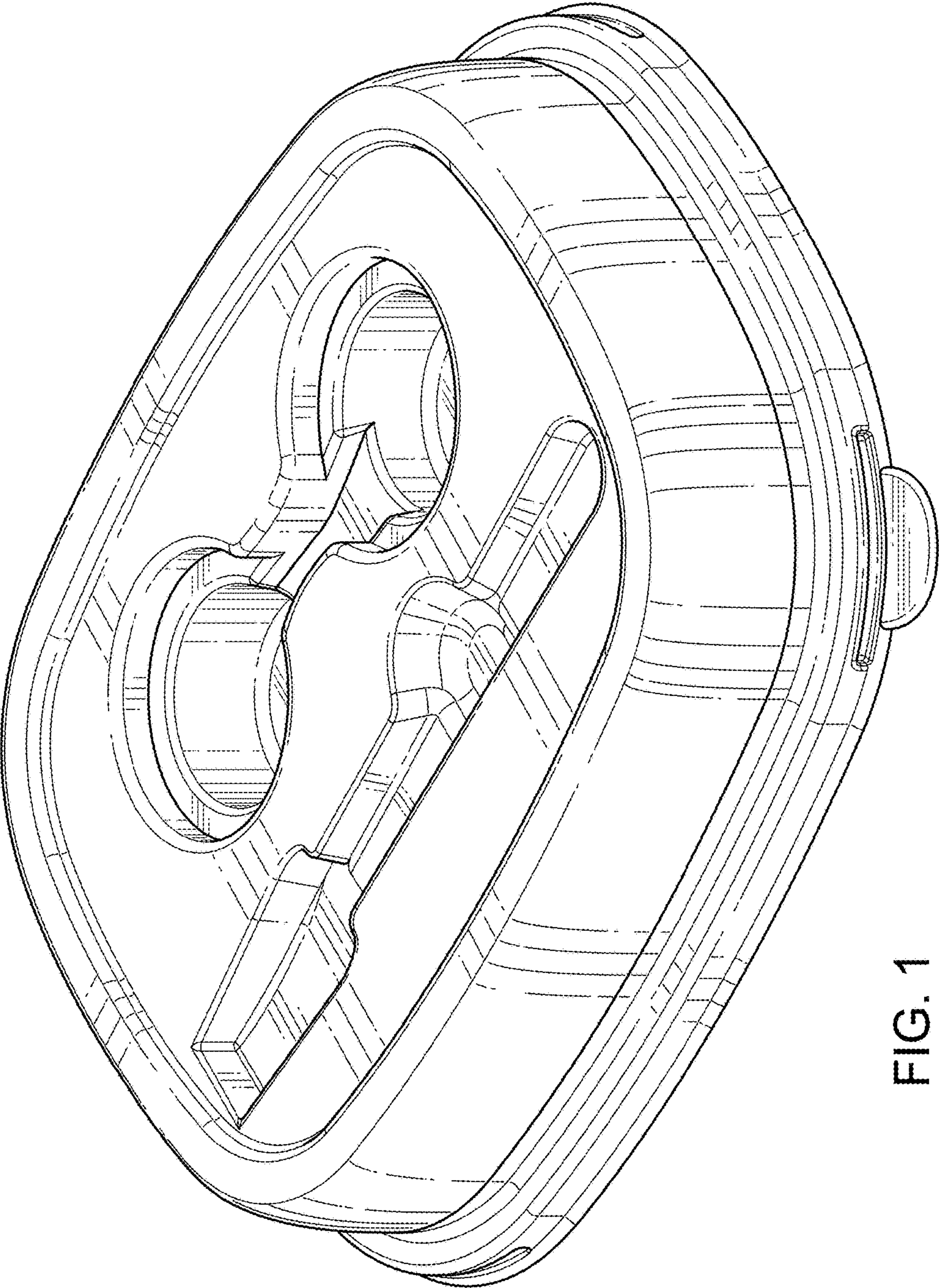

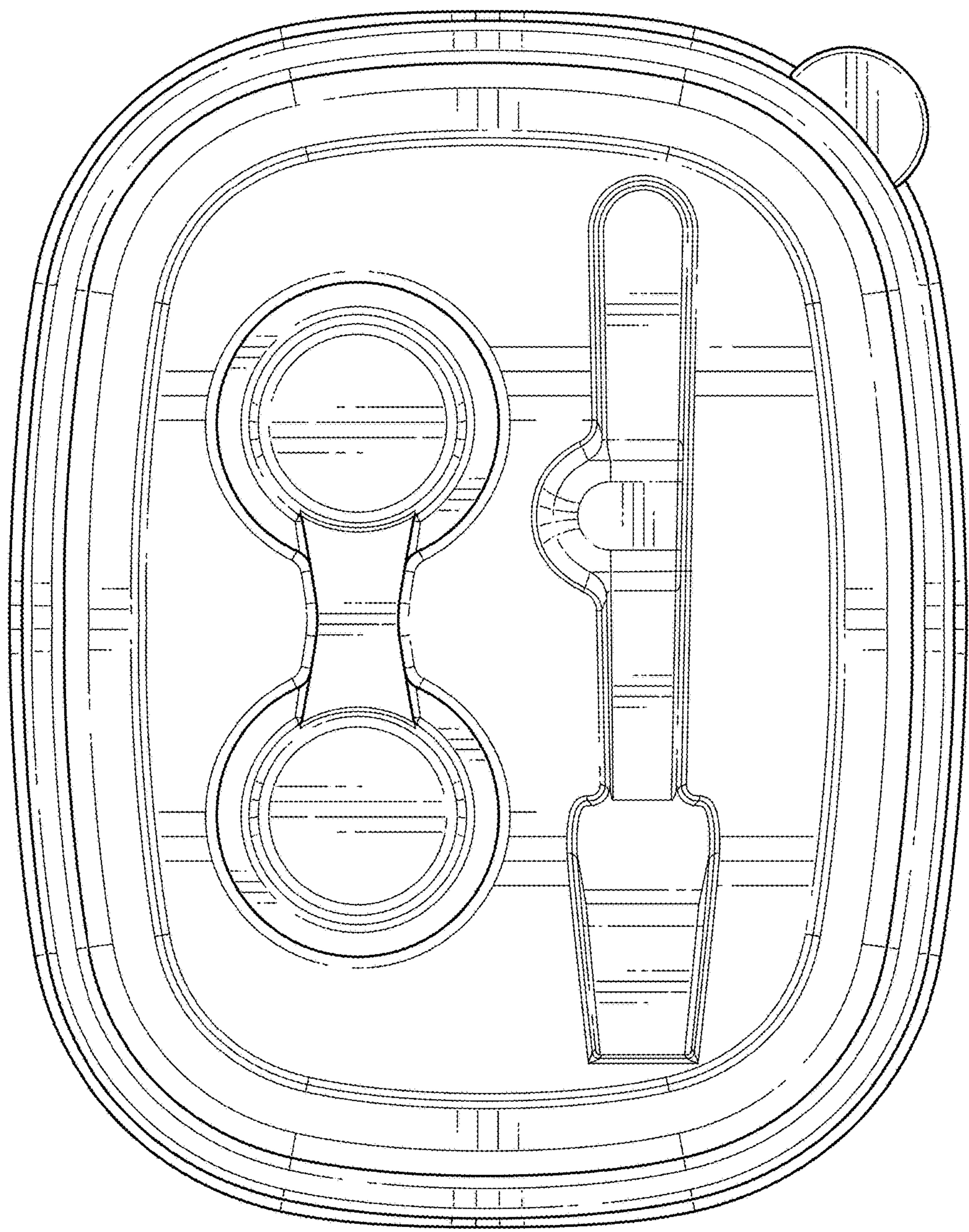

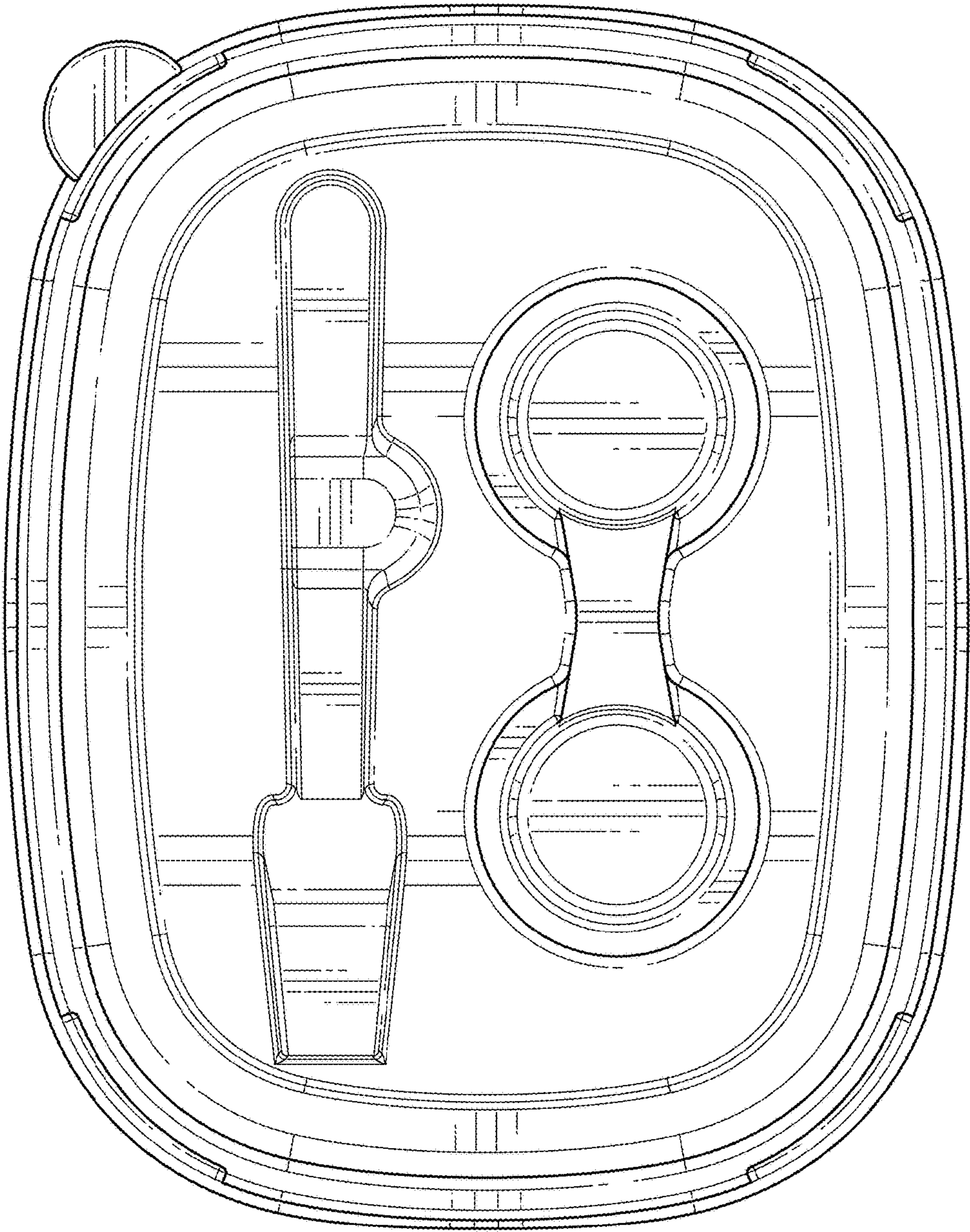

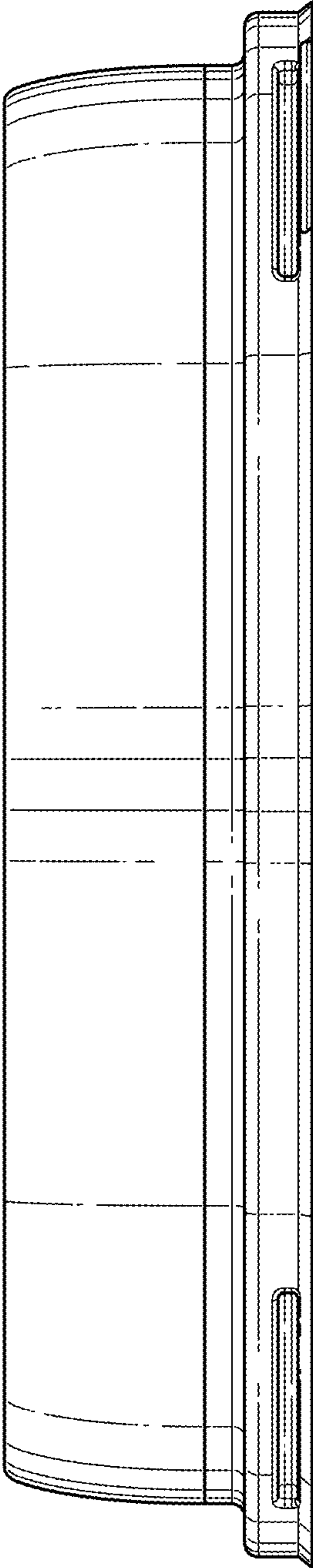

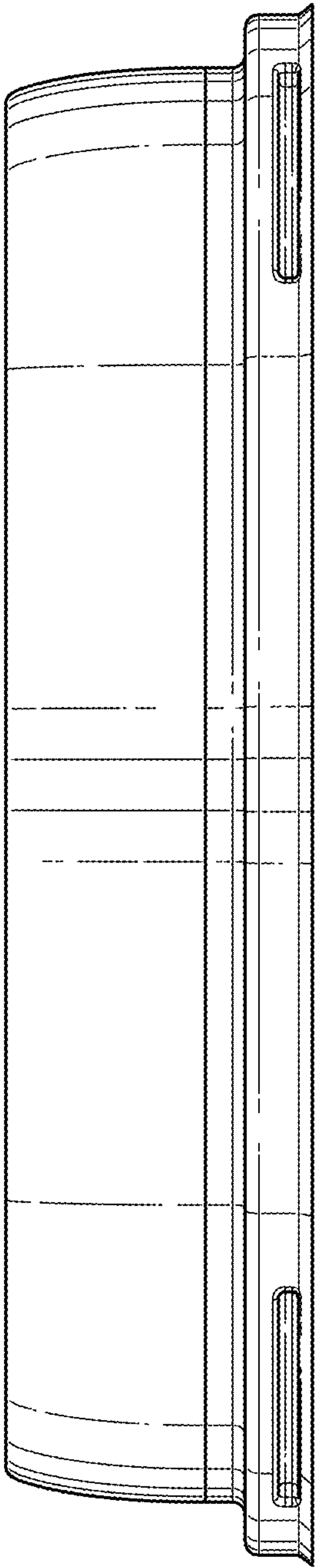

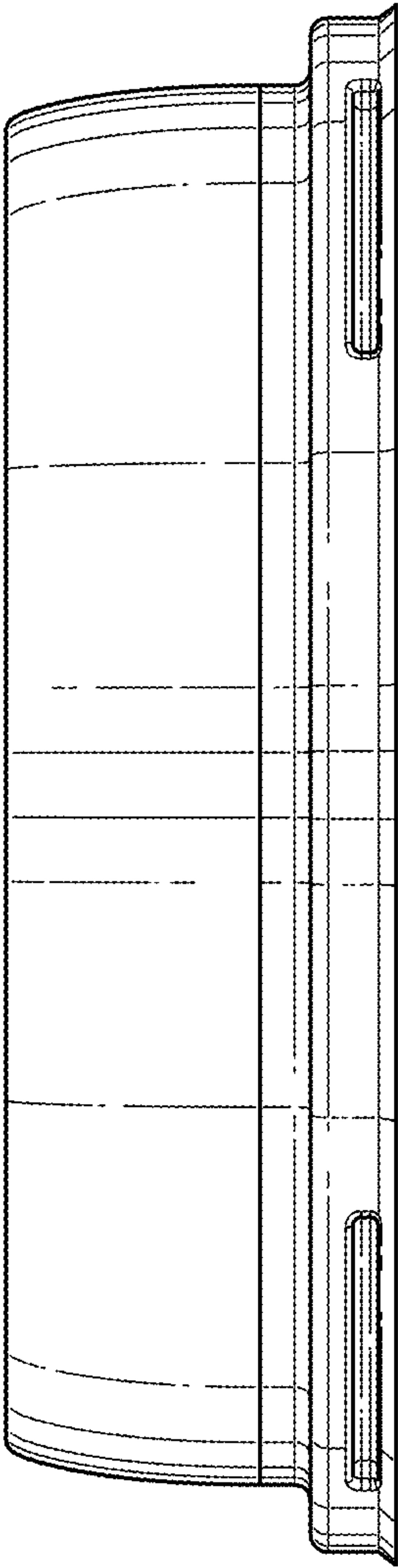

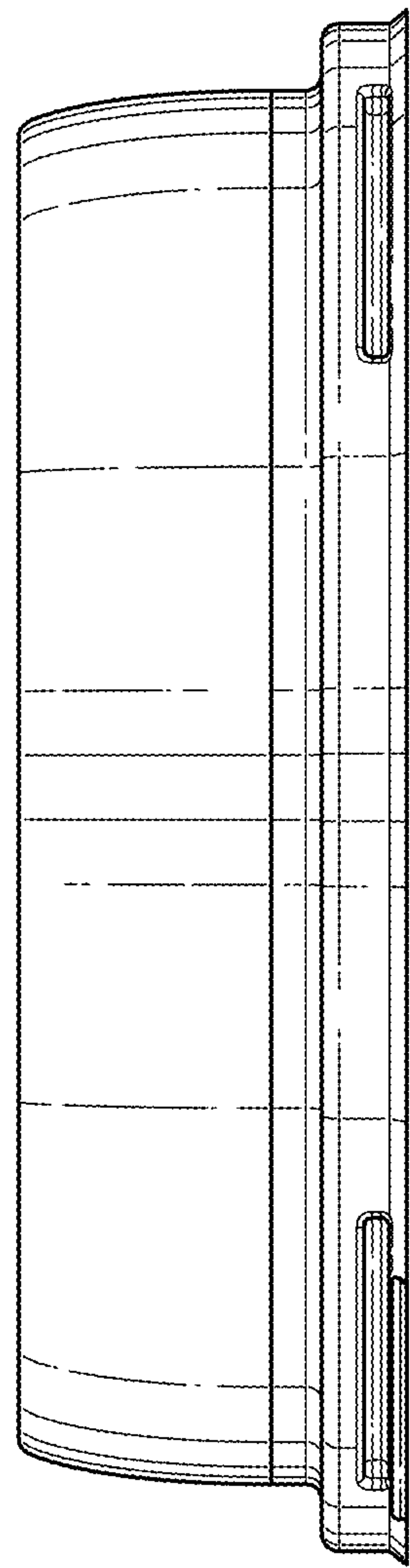
