The ornamental design for a container apparatus, as shown and described.

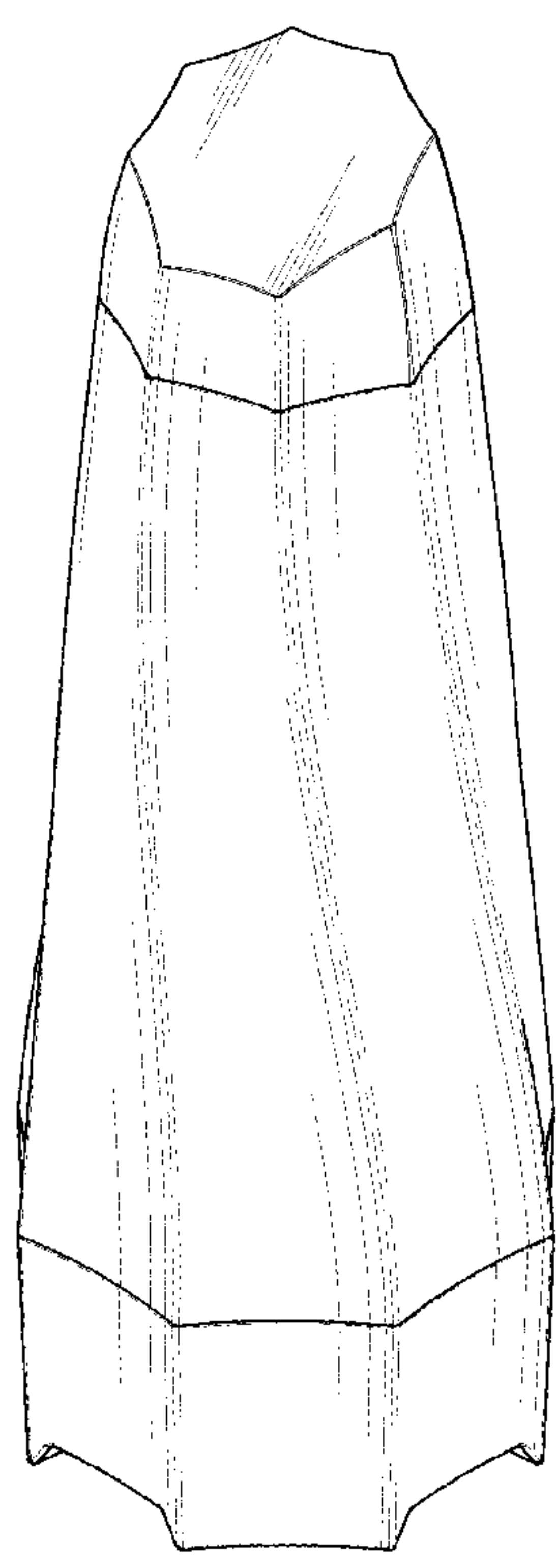
DESCRIPTION

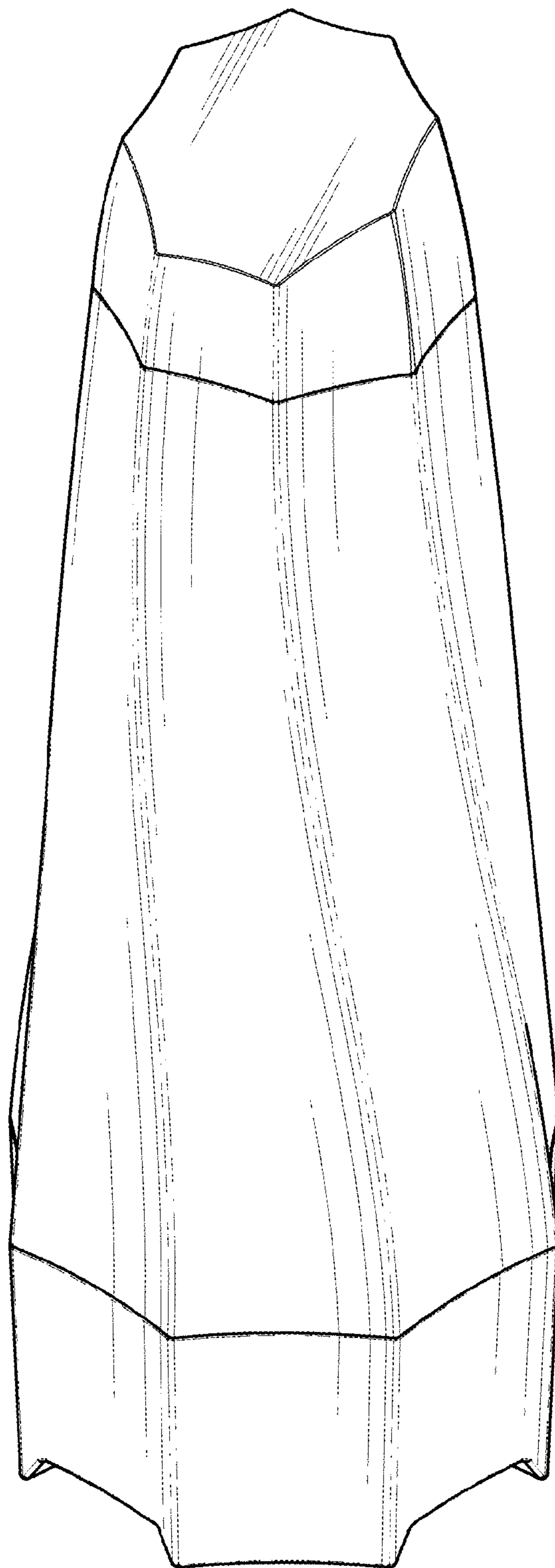

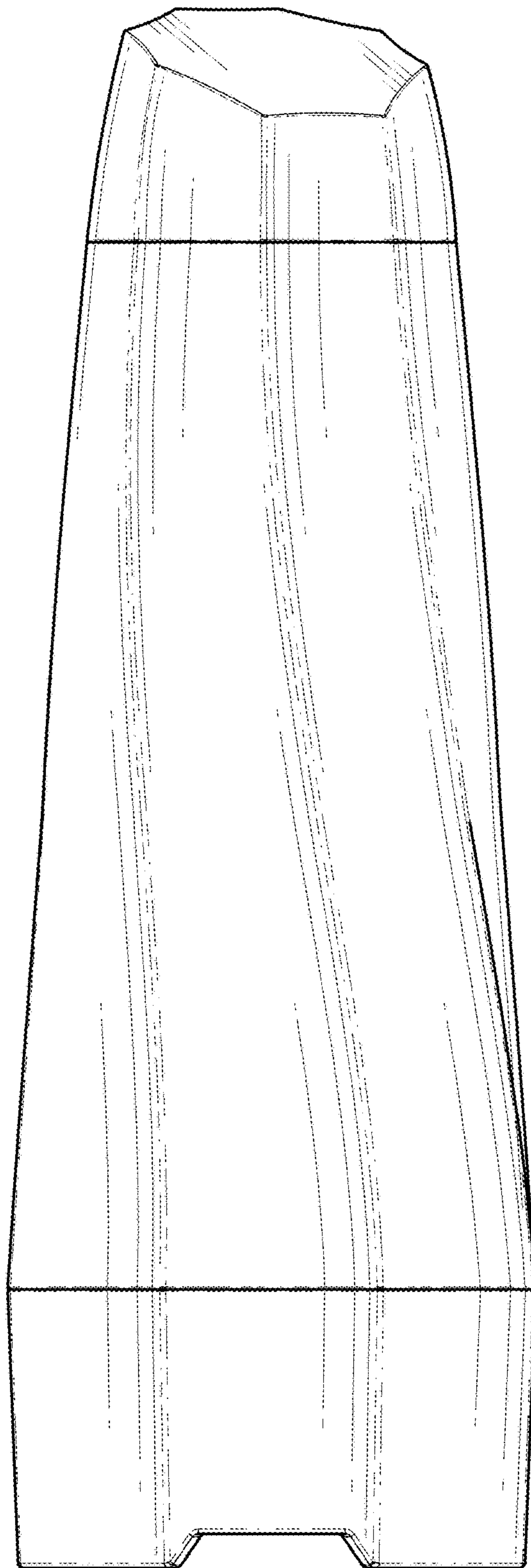

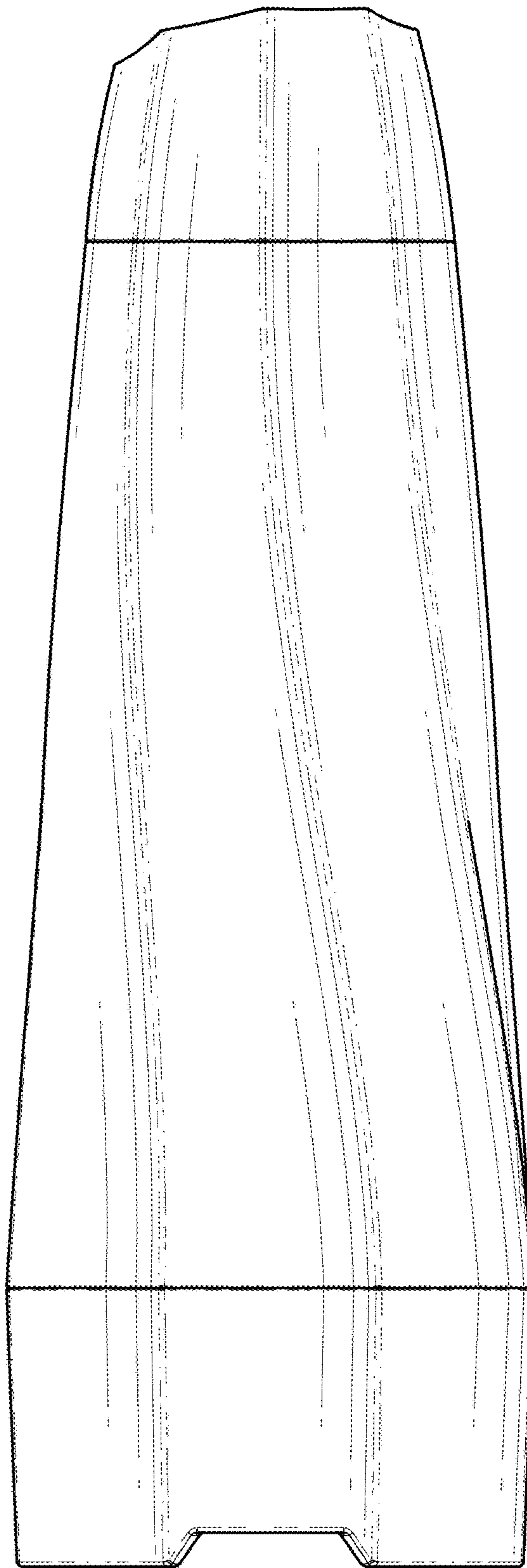

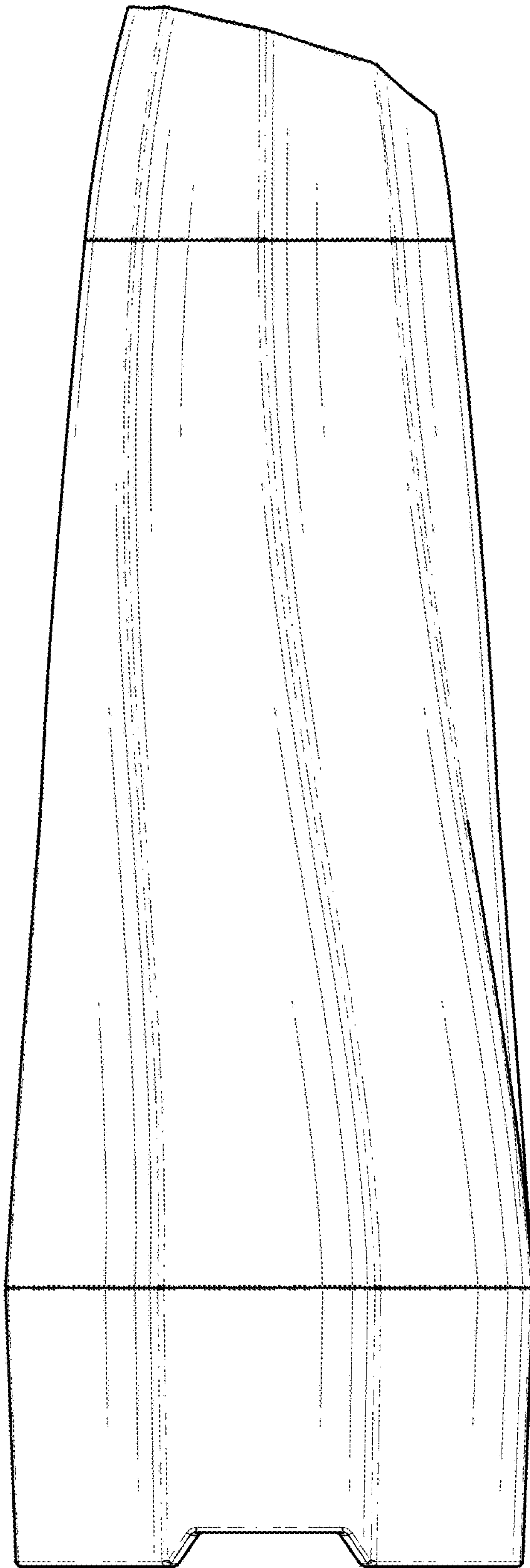

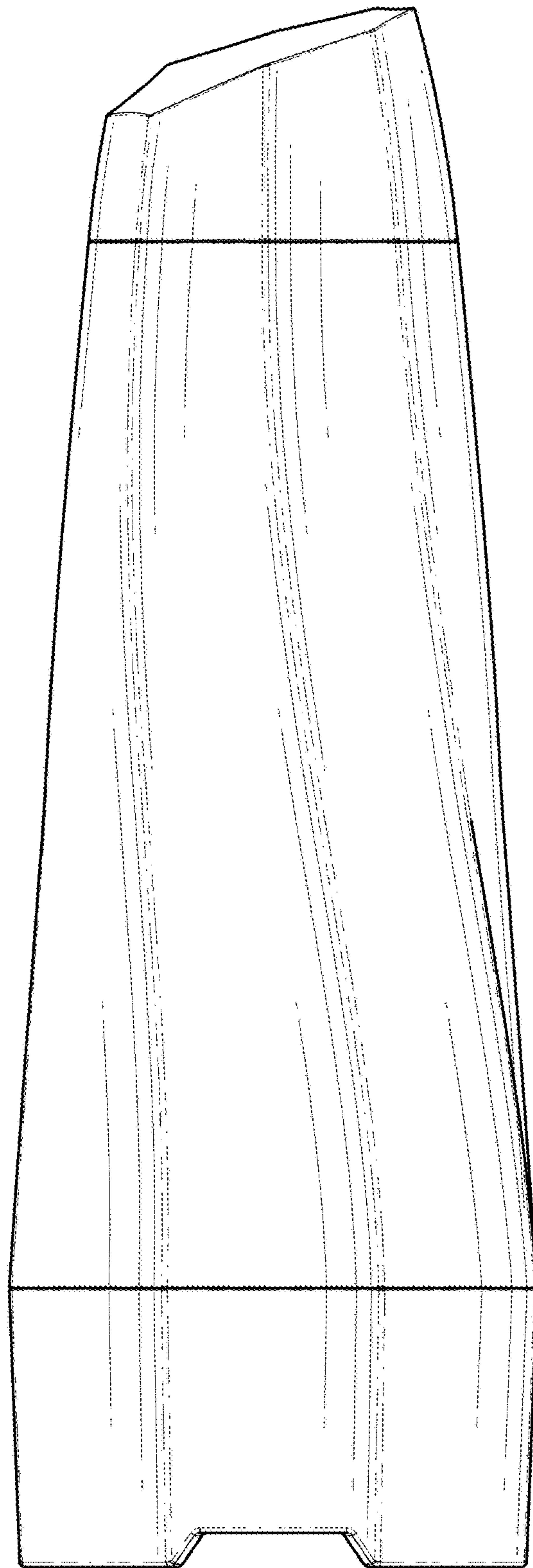

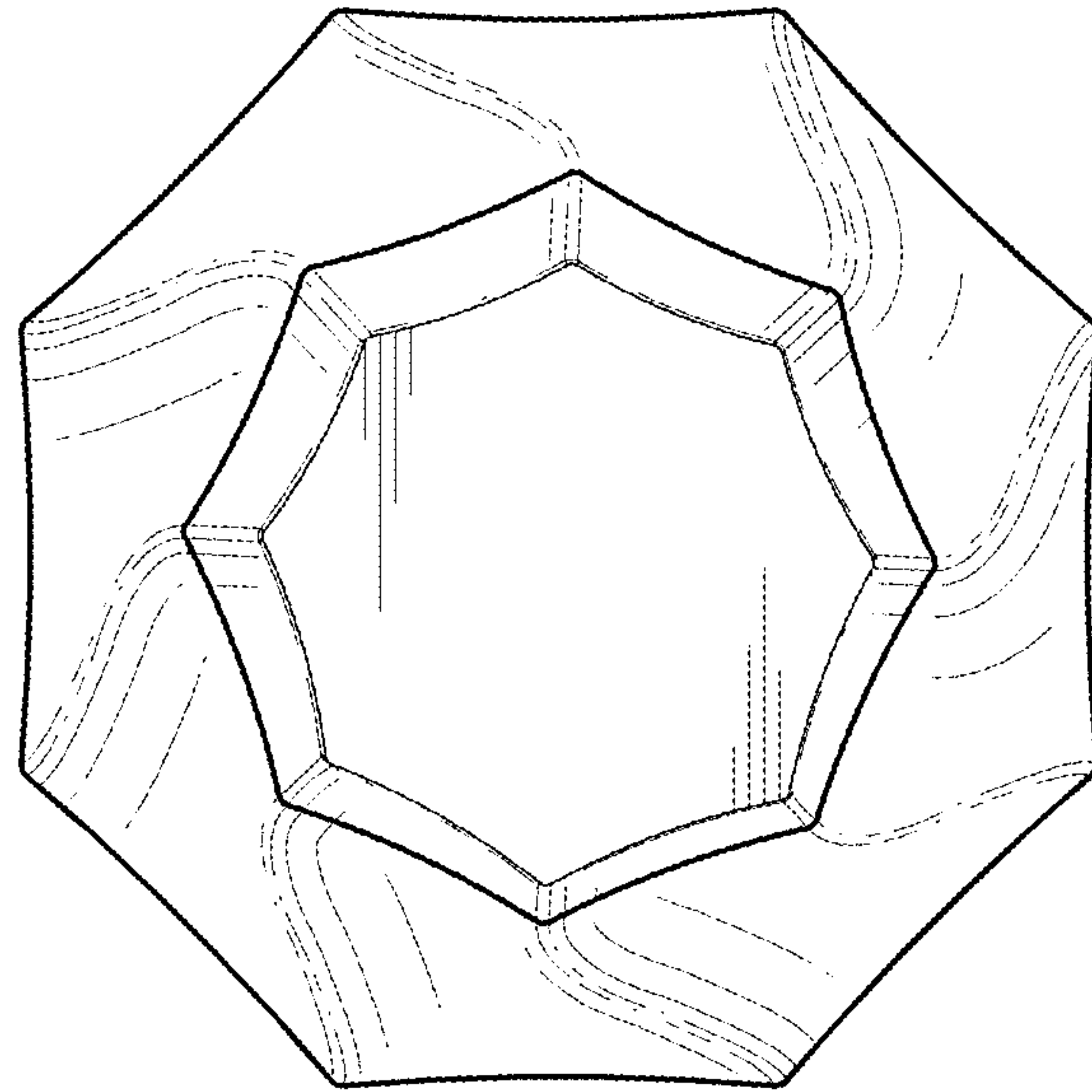

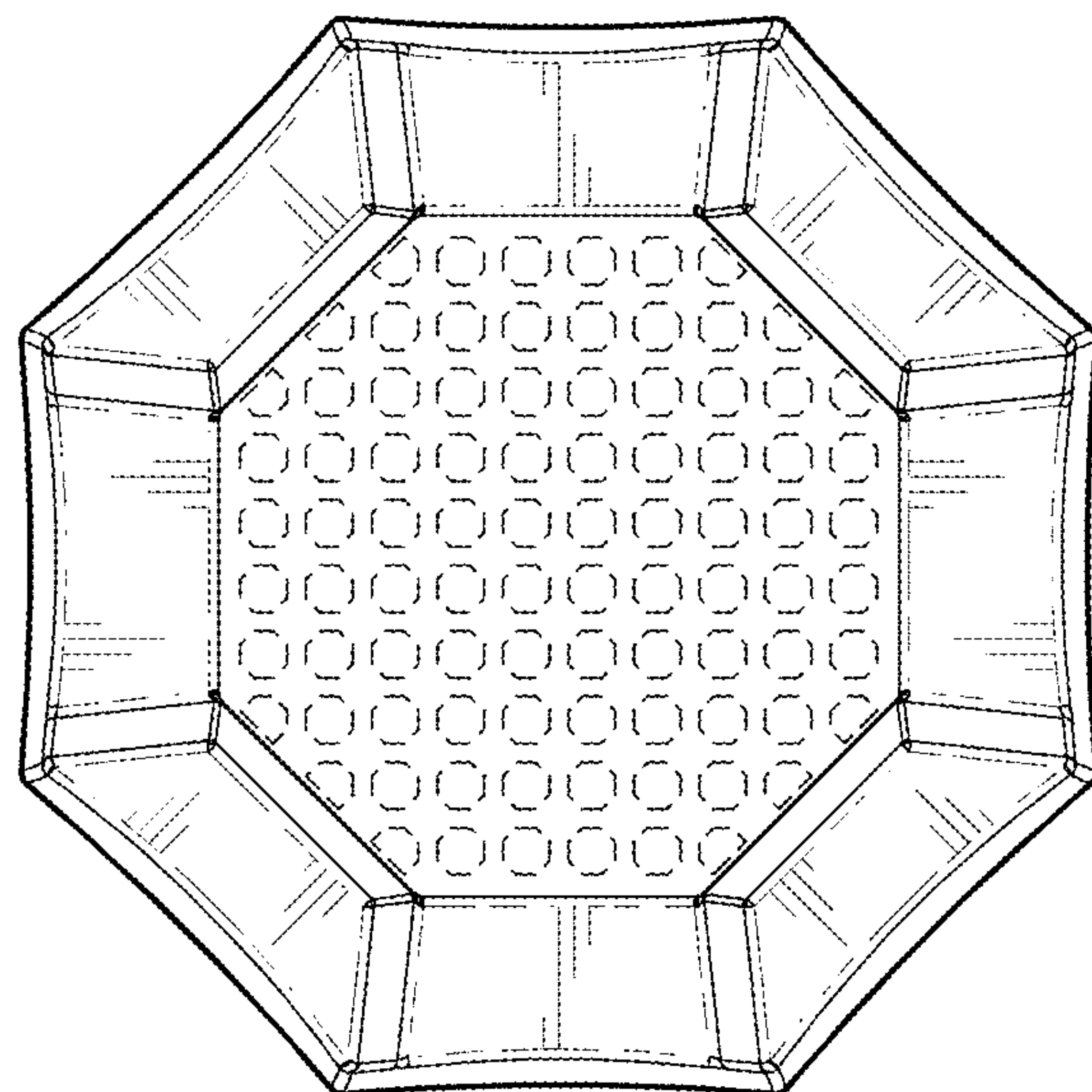
