FIG. 5 is a rear elevational view of the invention.

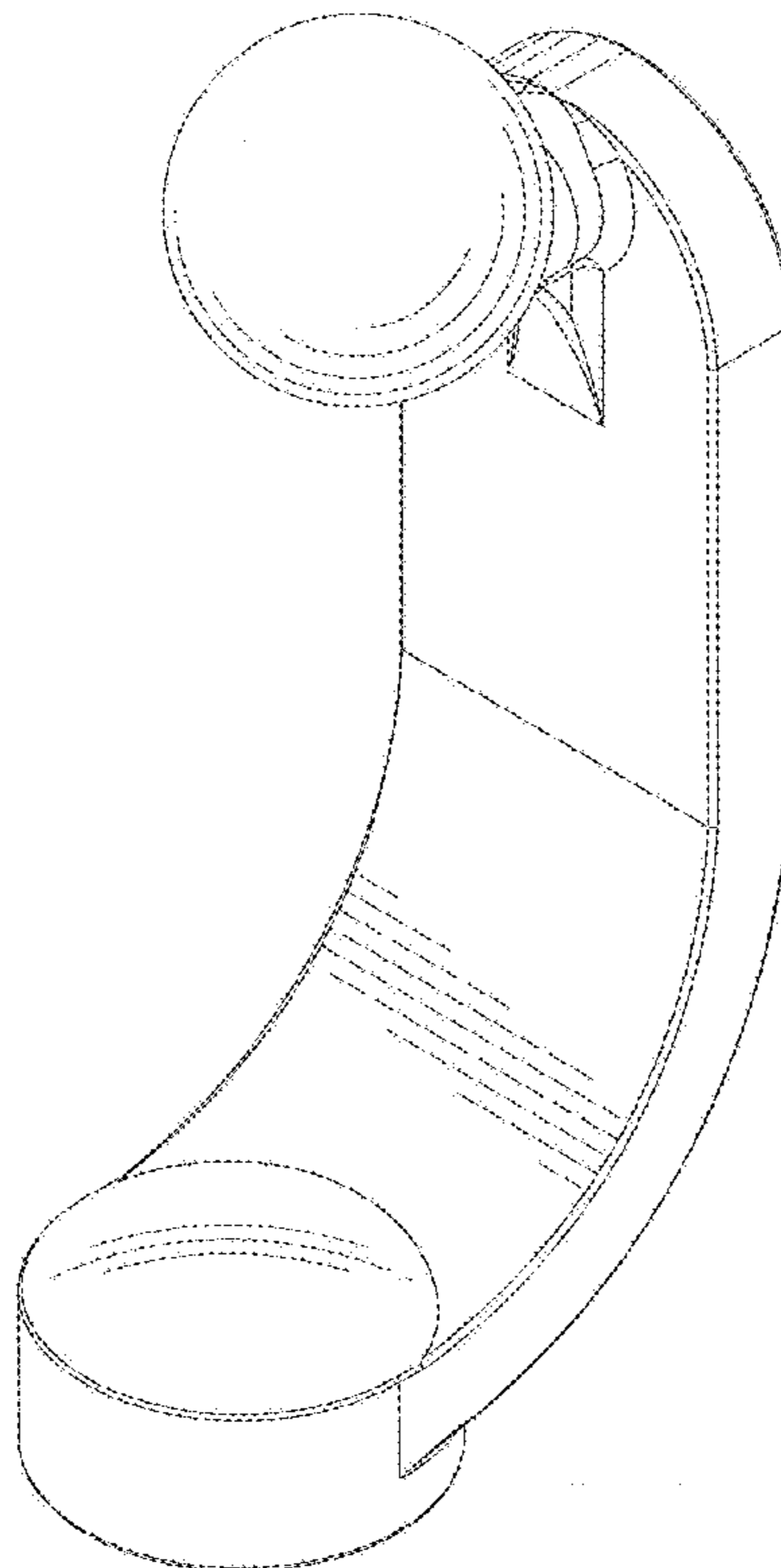
FIG. 6 is a left side view of the invention.

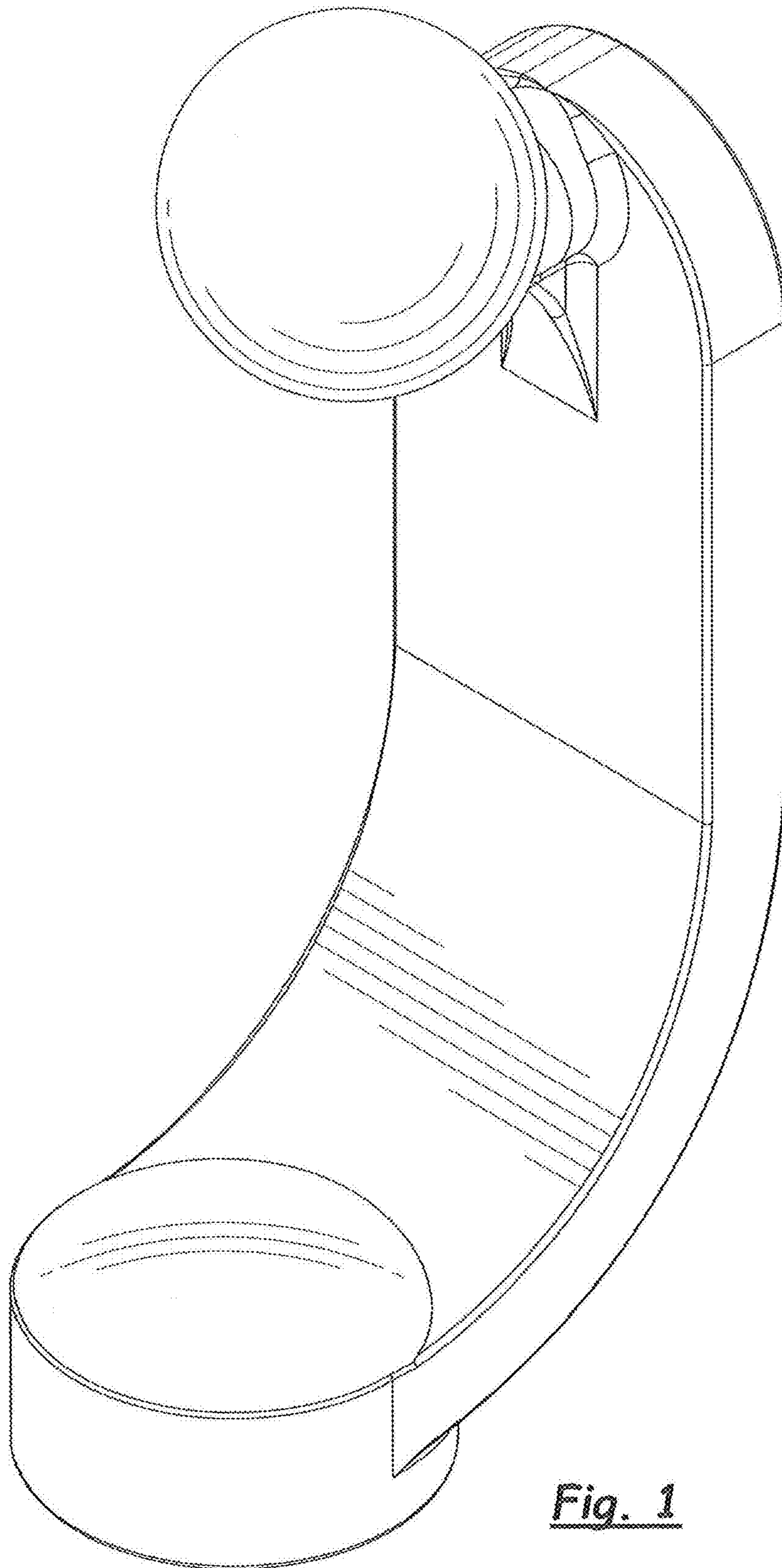

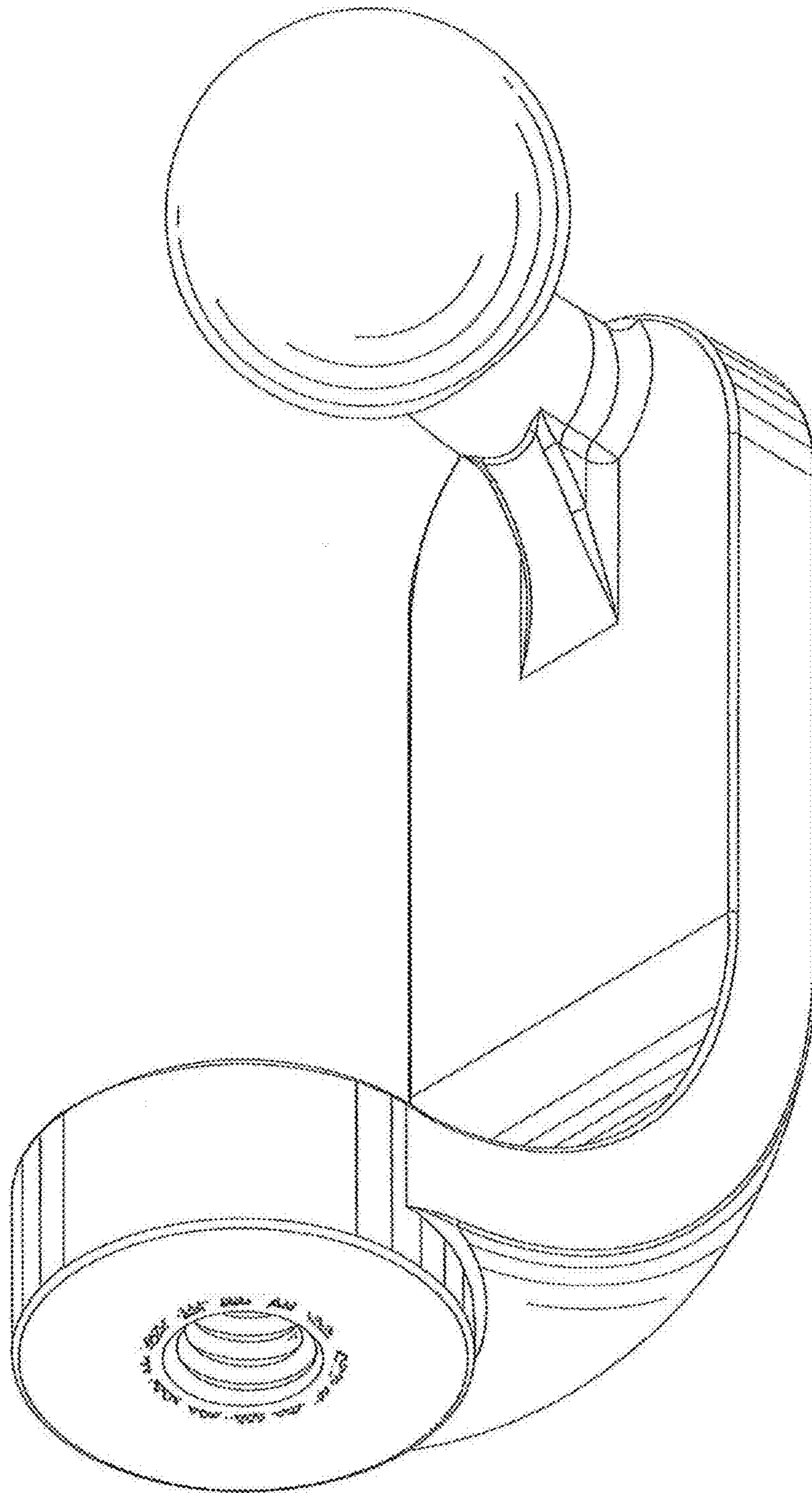

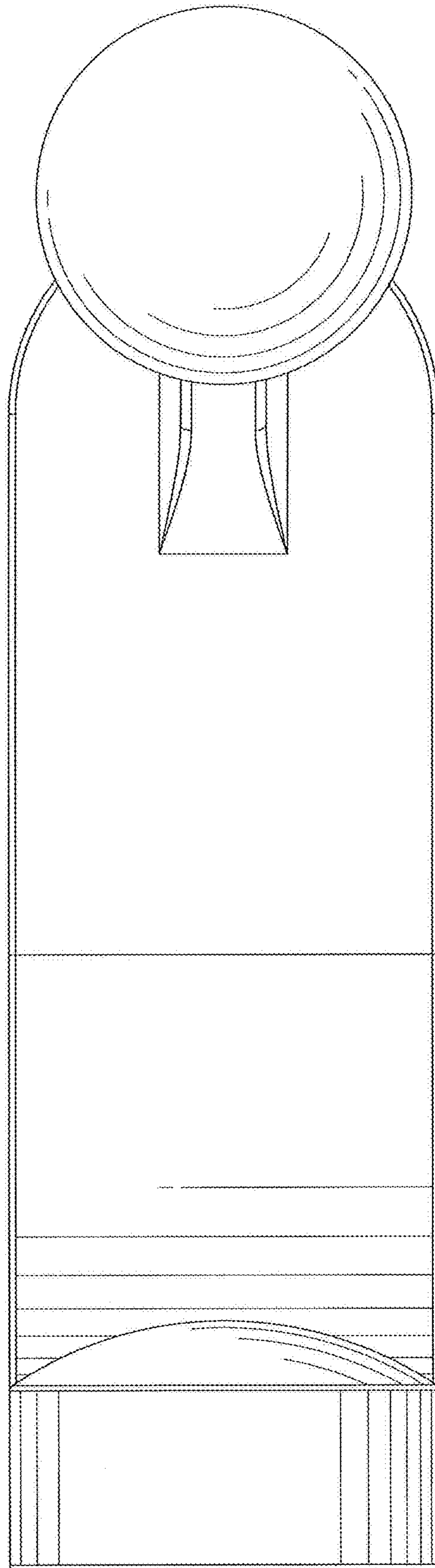

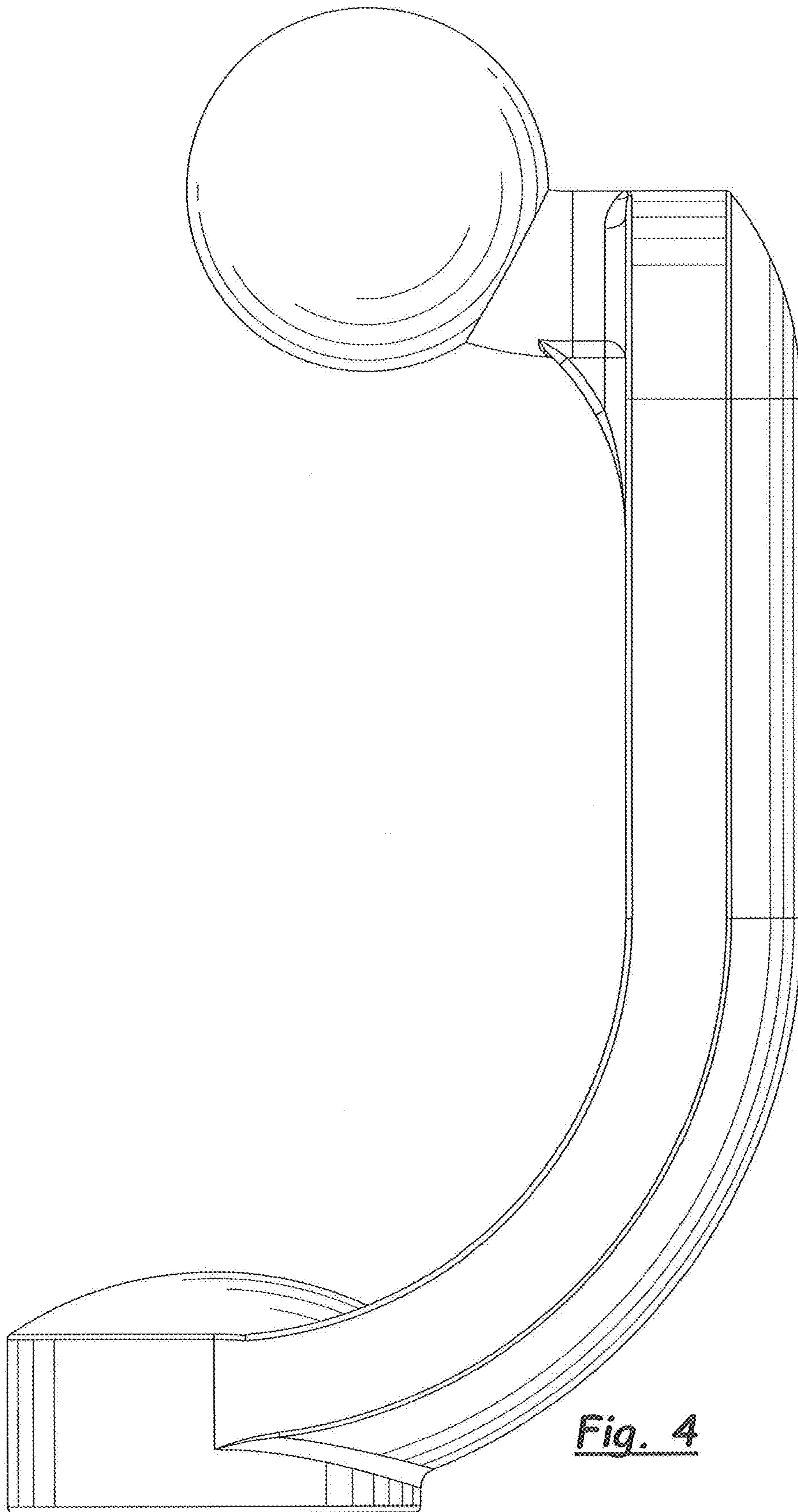

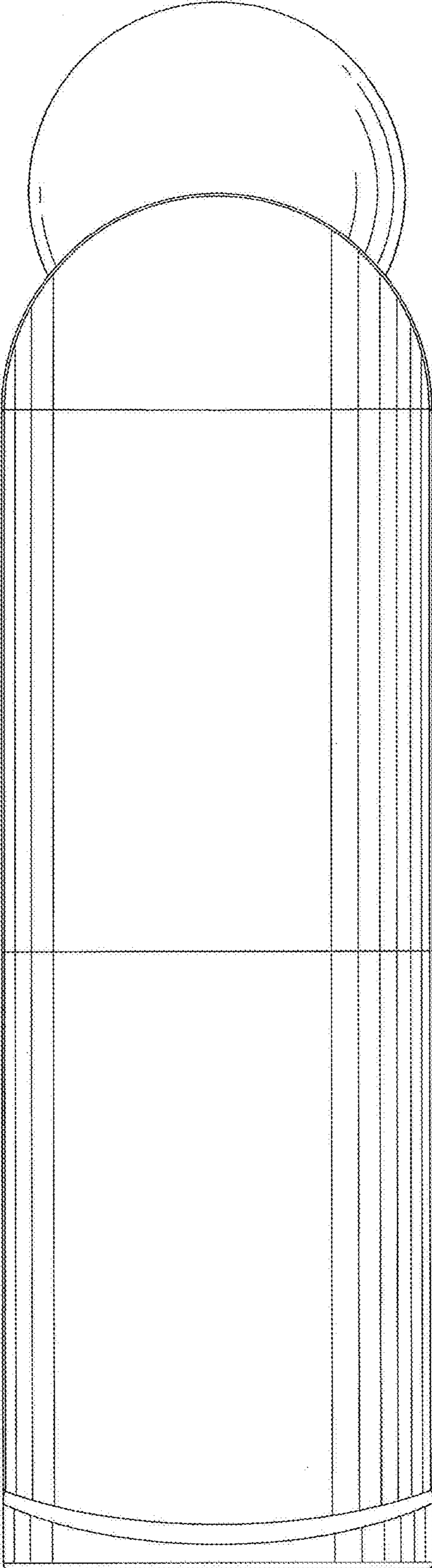

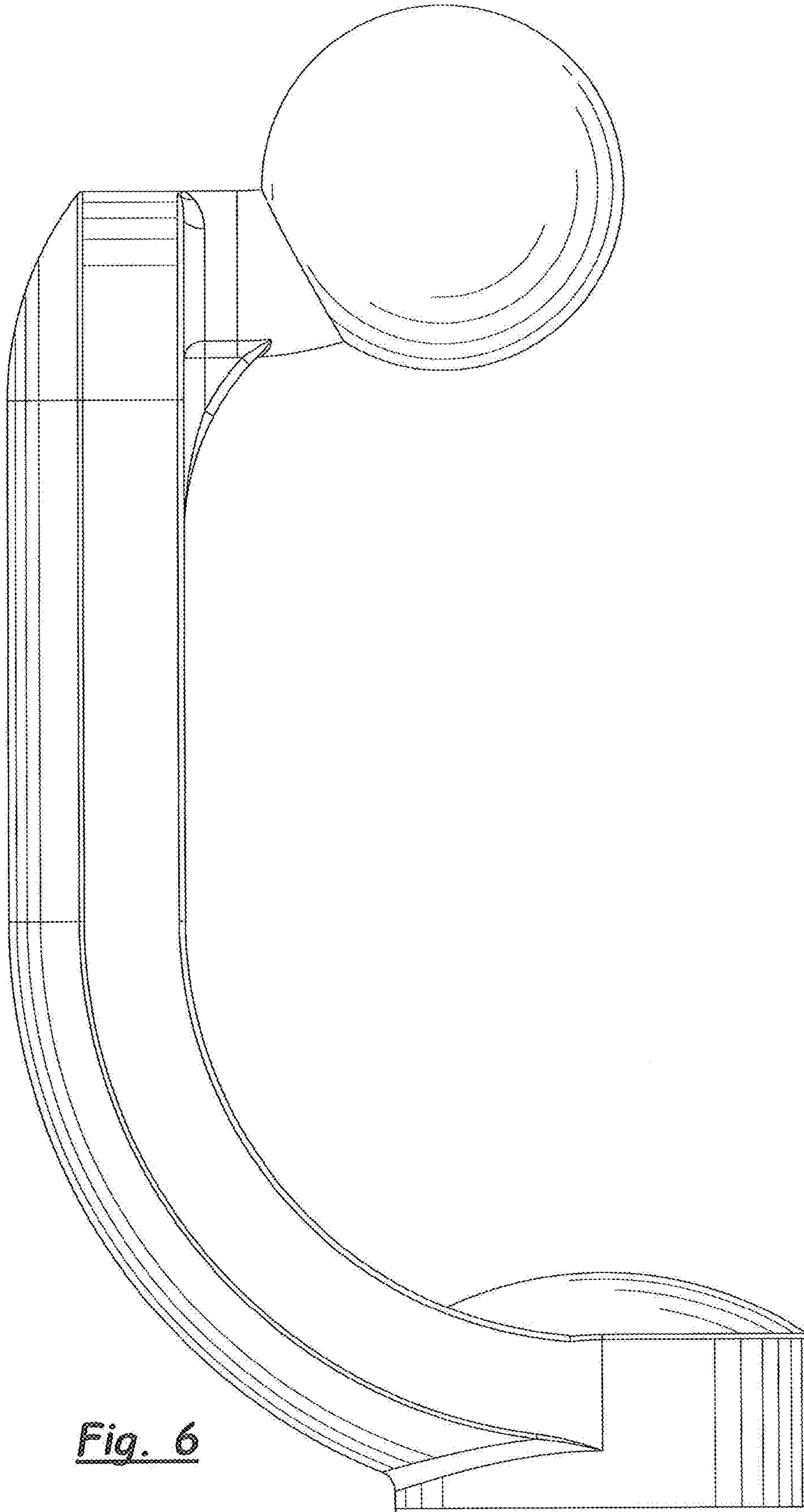

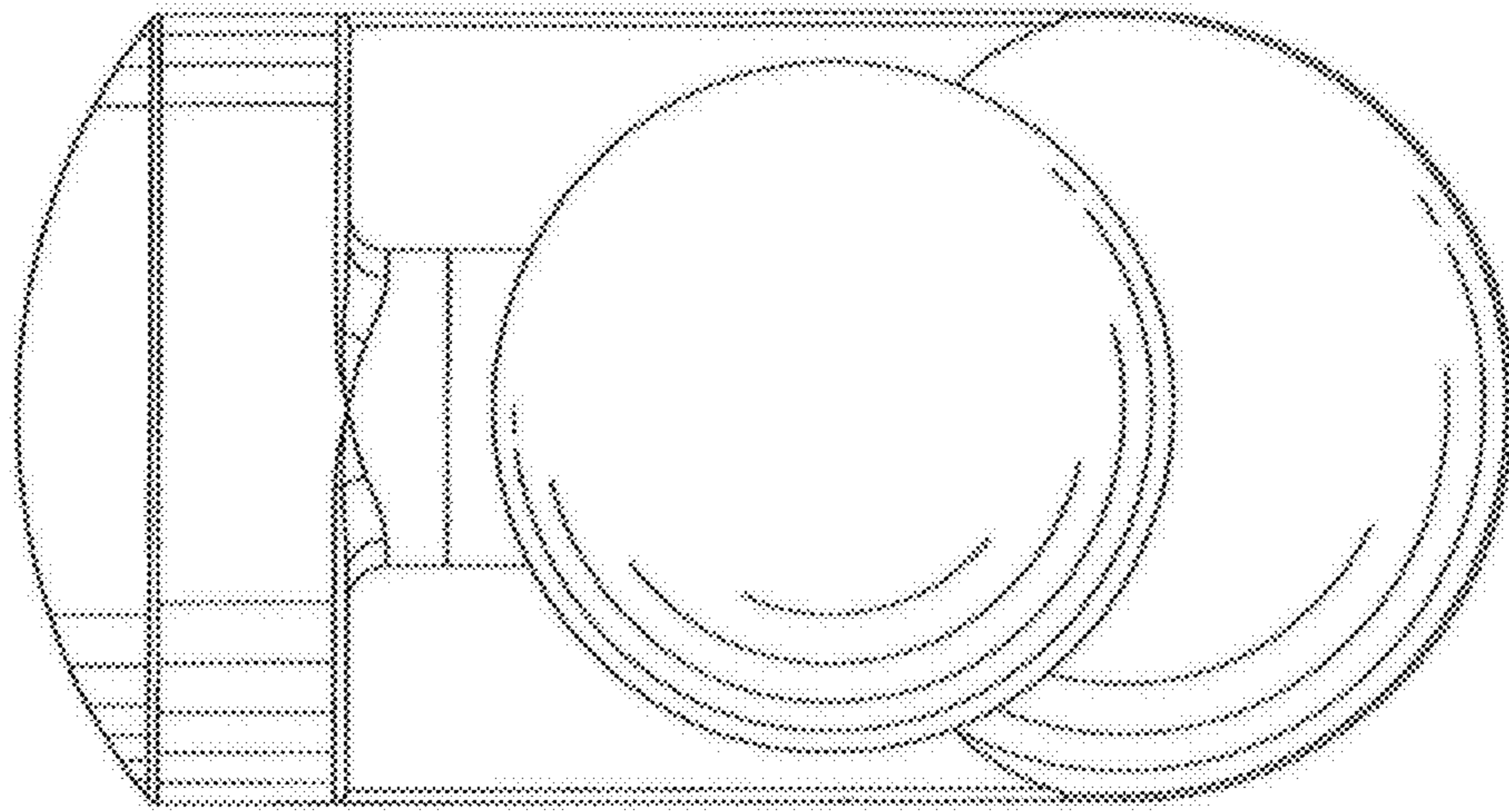

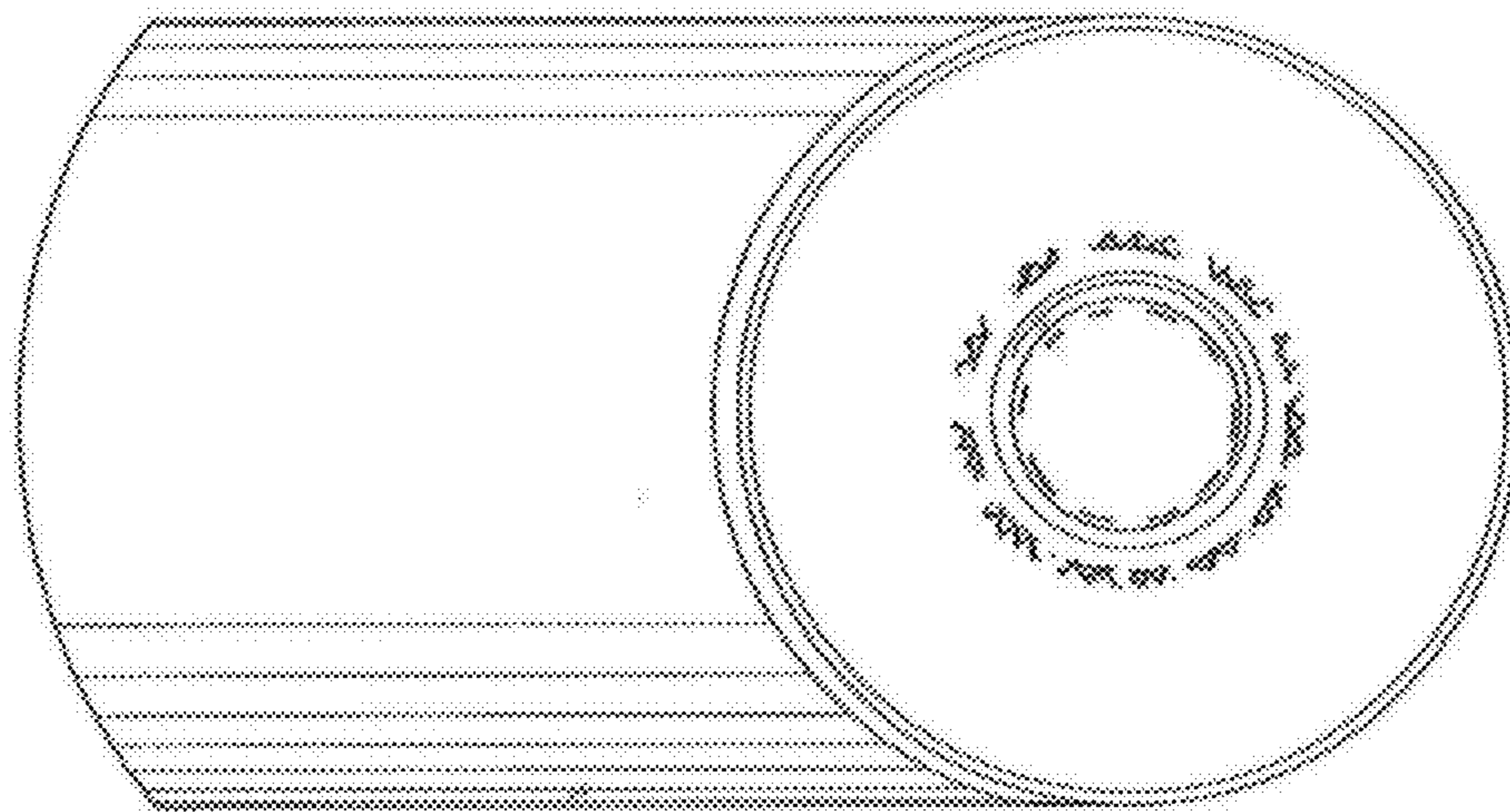
