FIG. 1 is a perspective view of an ornamental design for a boat carton;
FIG. 2 is a right side view thereof;

FIG. 5 is a bottom view thereof;
FIG. 6 is a rear end view thereof;
FIG. 7 is a front end view thereof; and,
