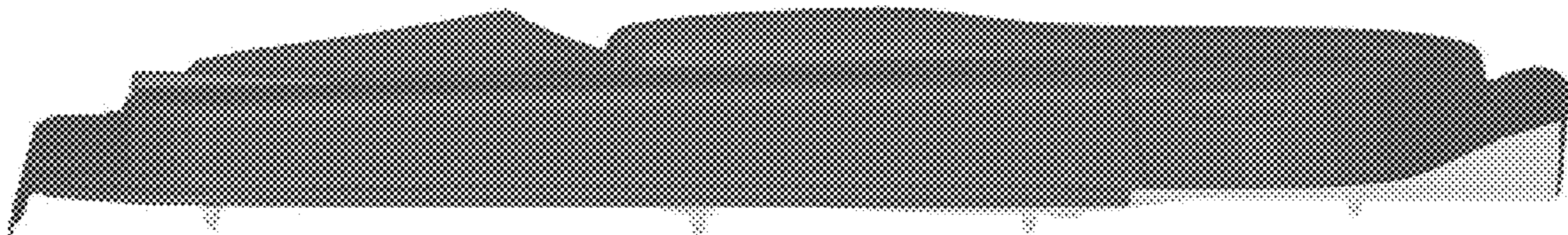
FIG. 1 is a perspective view of an interior door panel for an automobile showing our new design;

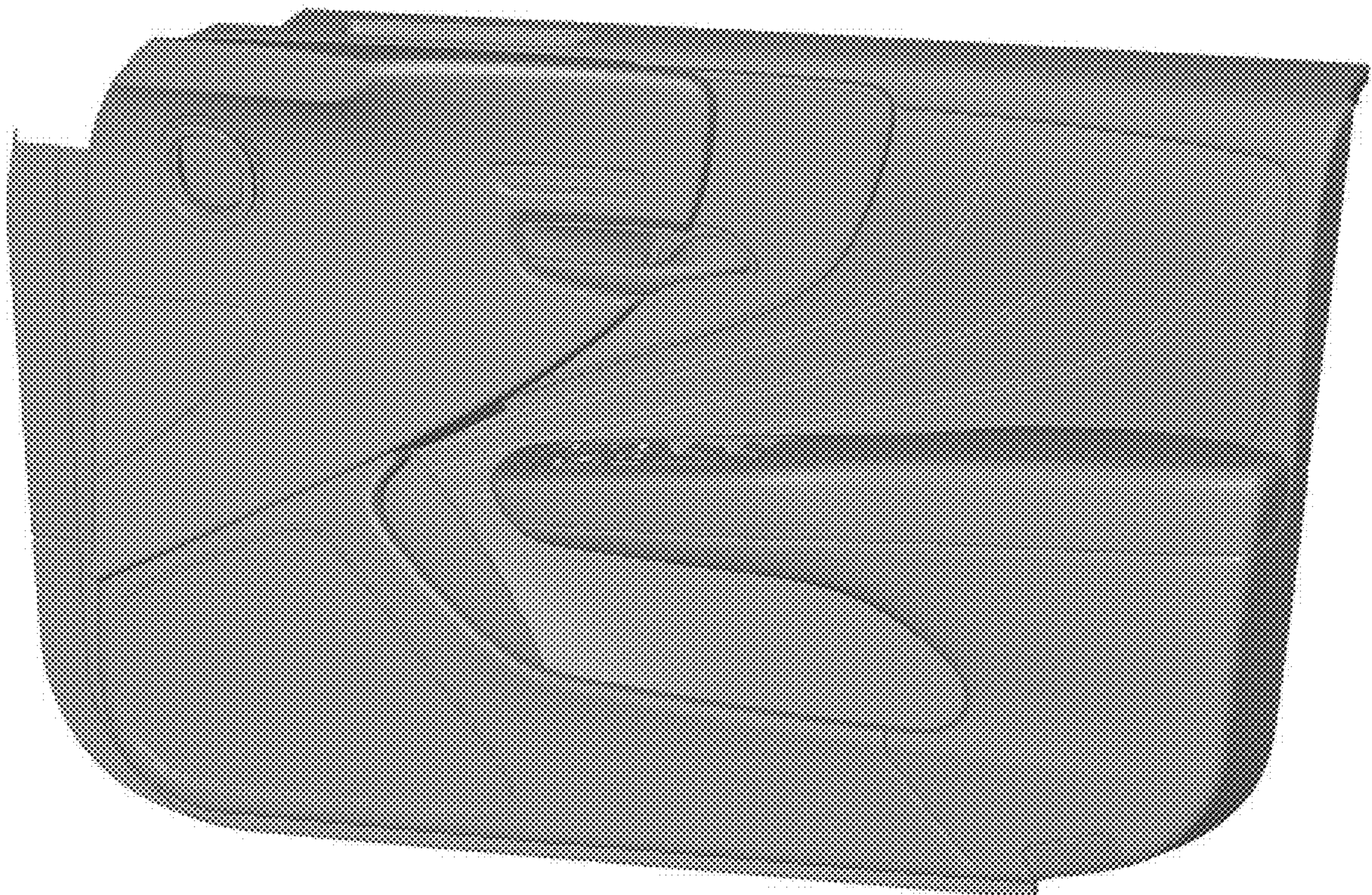

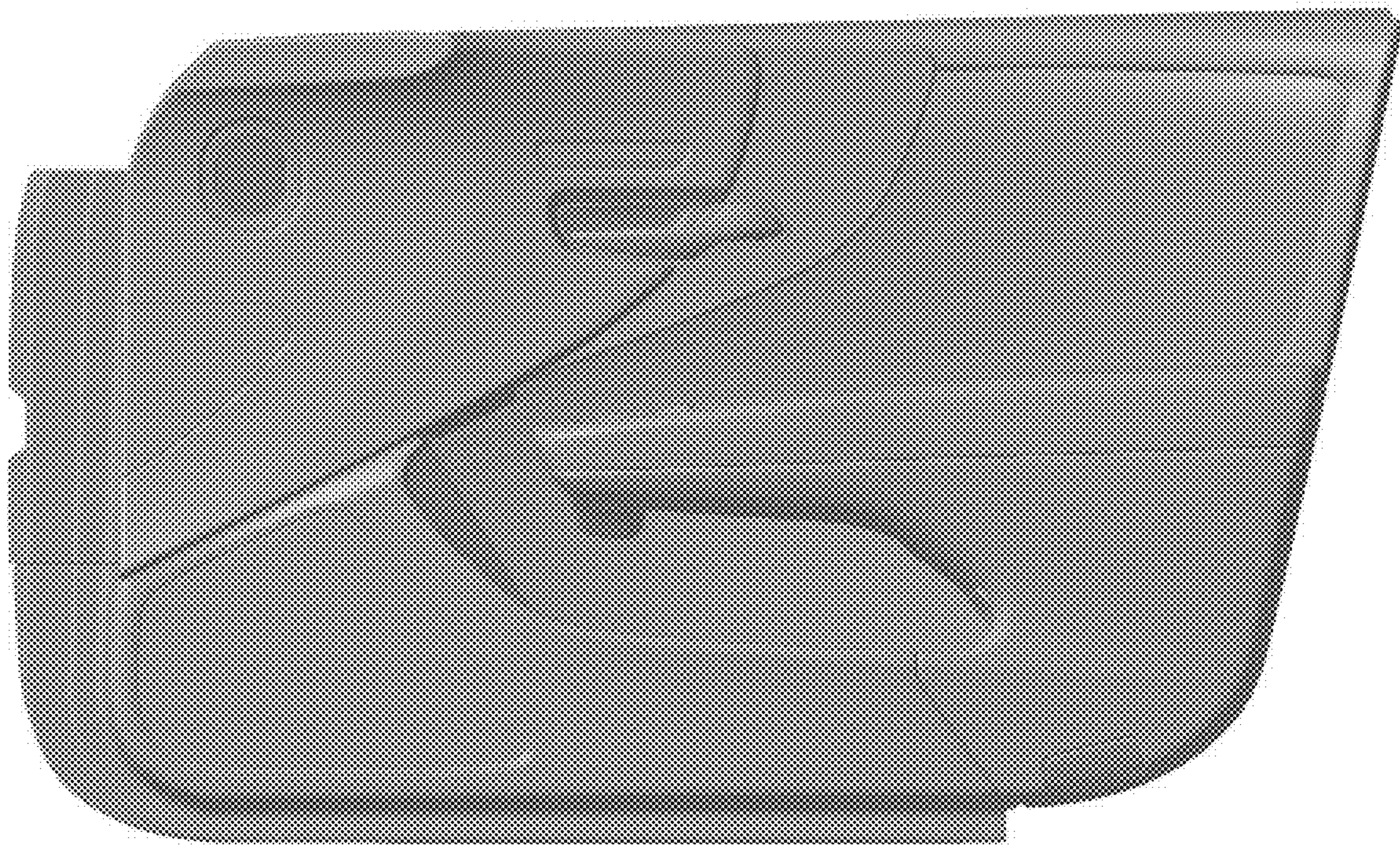

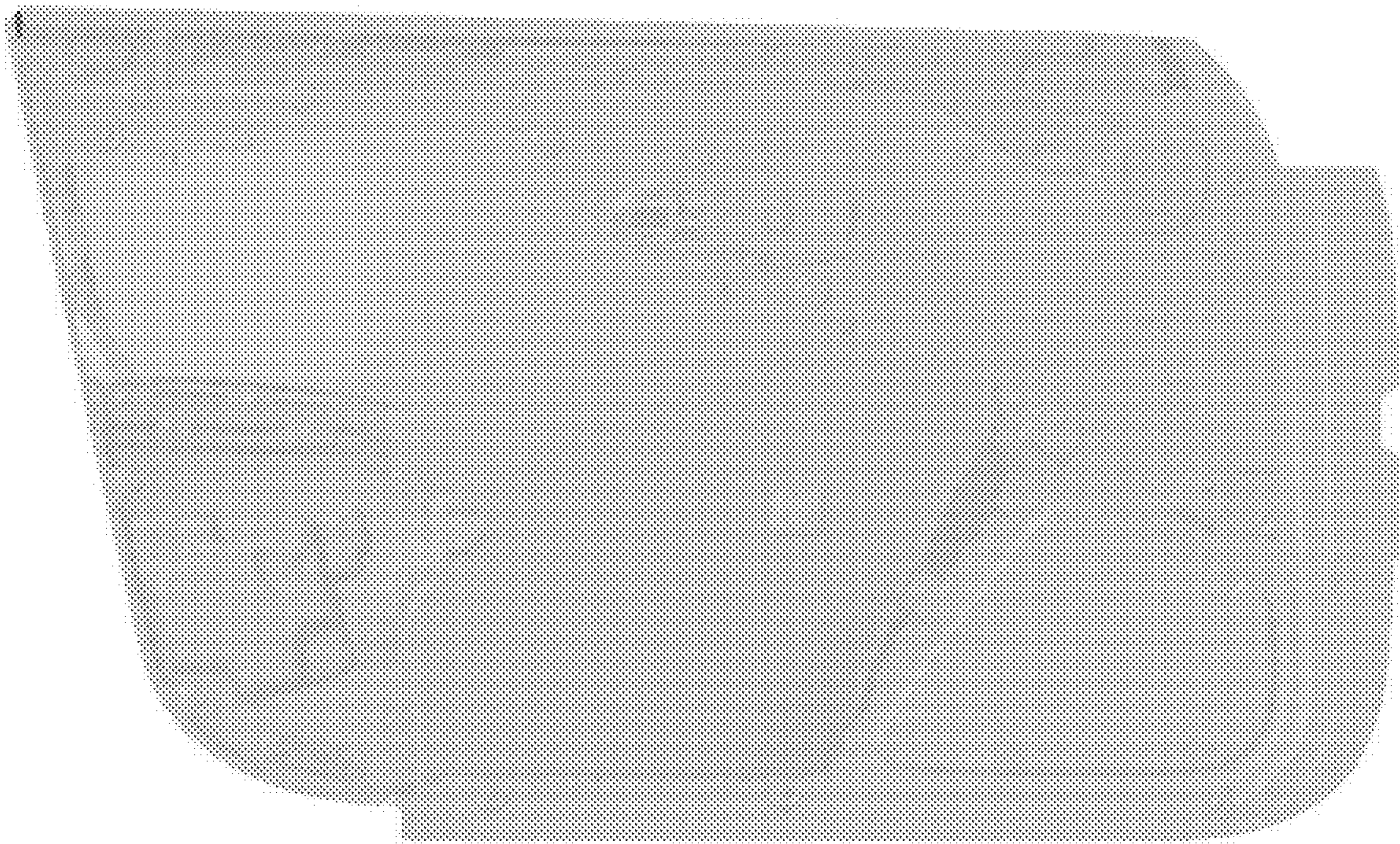

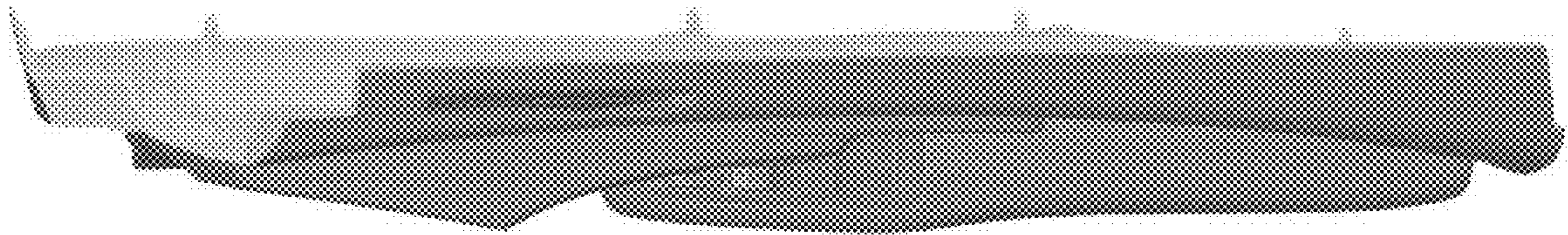

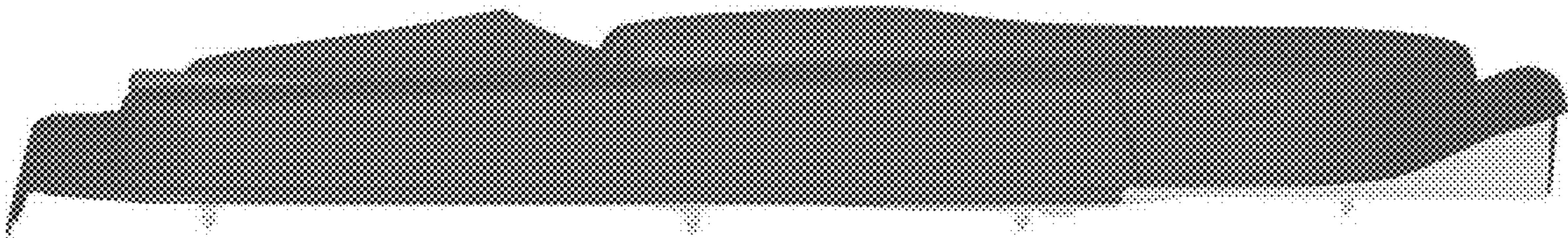

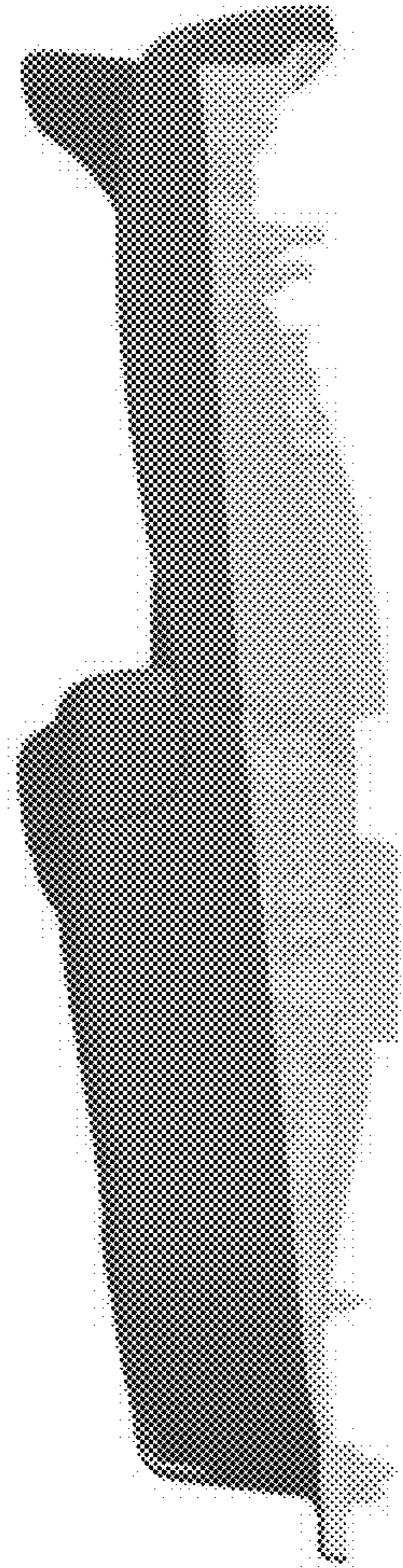

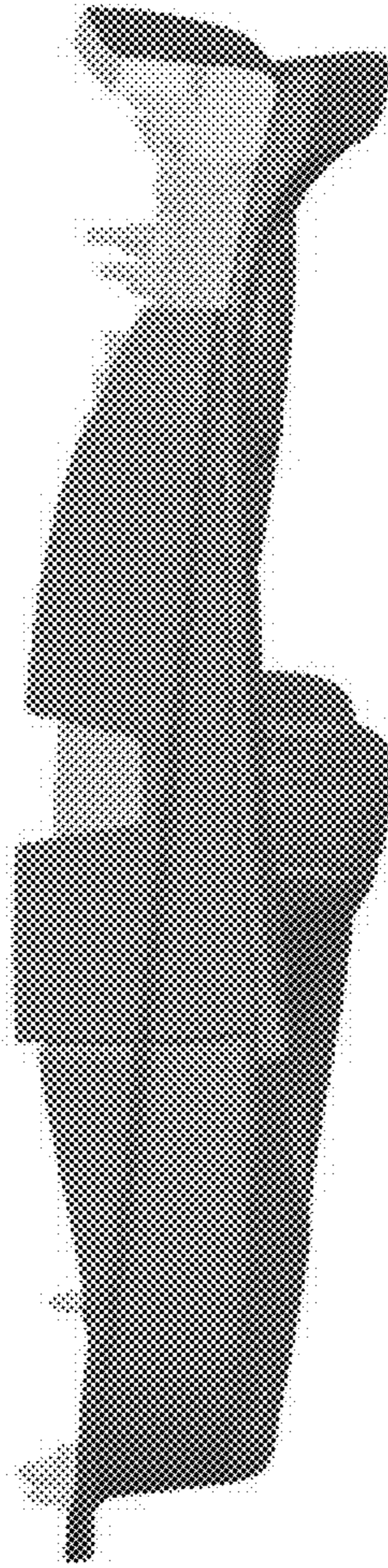
