DESCRIPTION

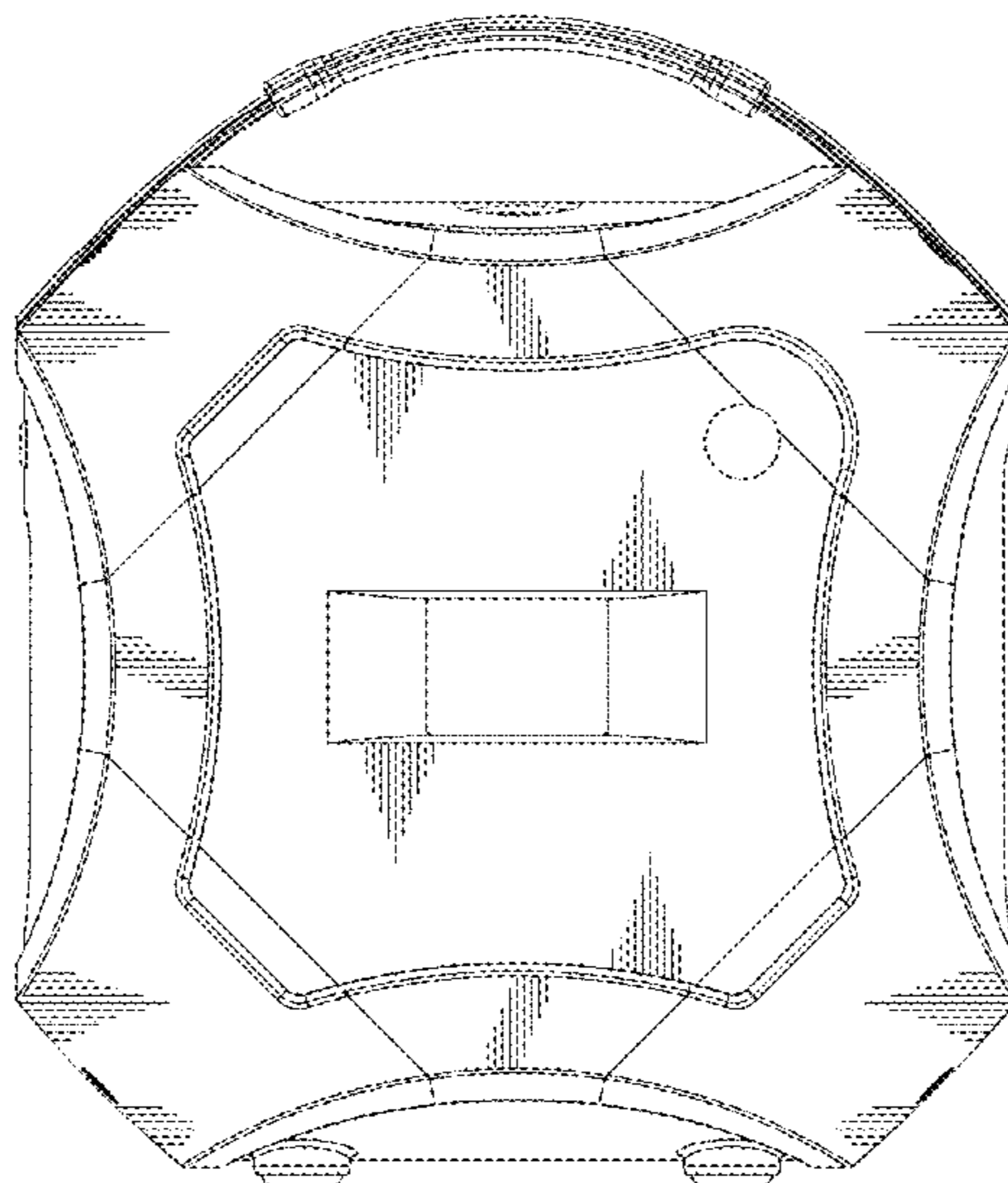
FIG. 1 is a front elevational view of a portable charger, showing our new design;

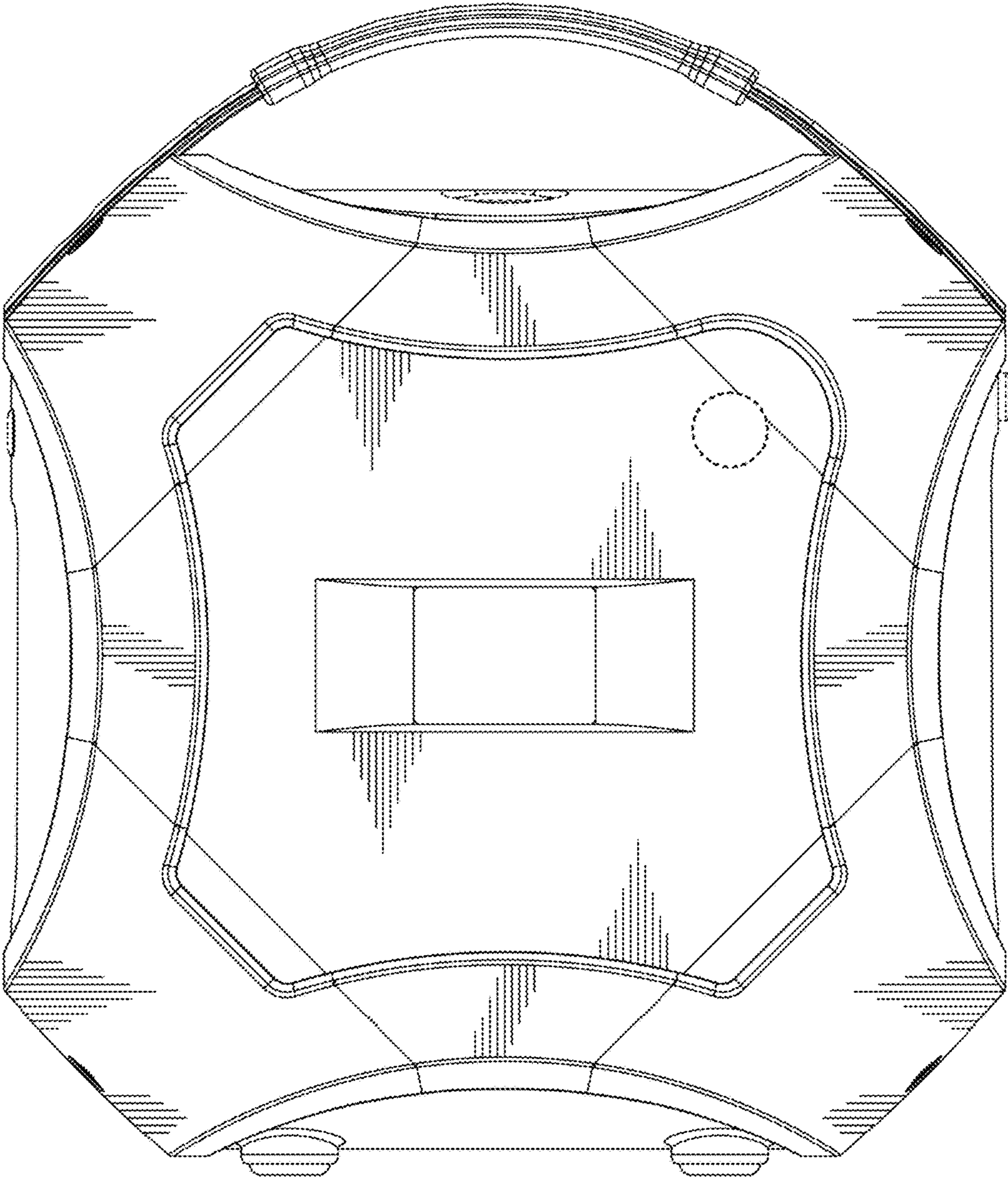

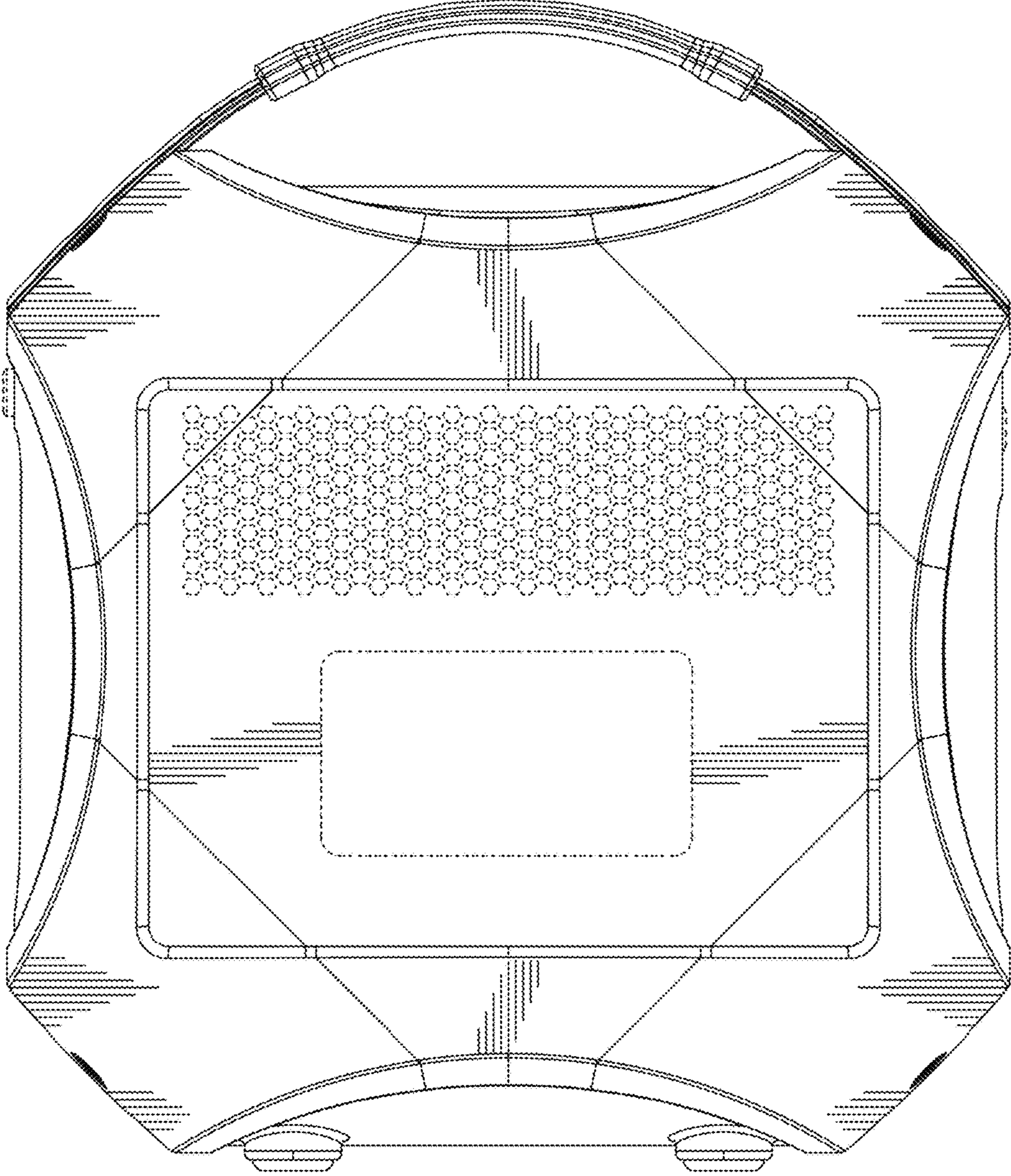

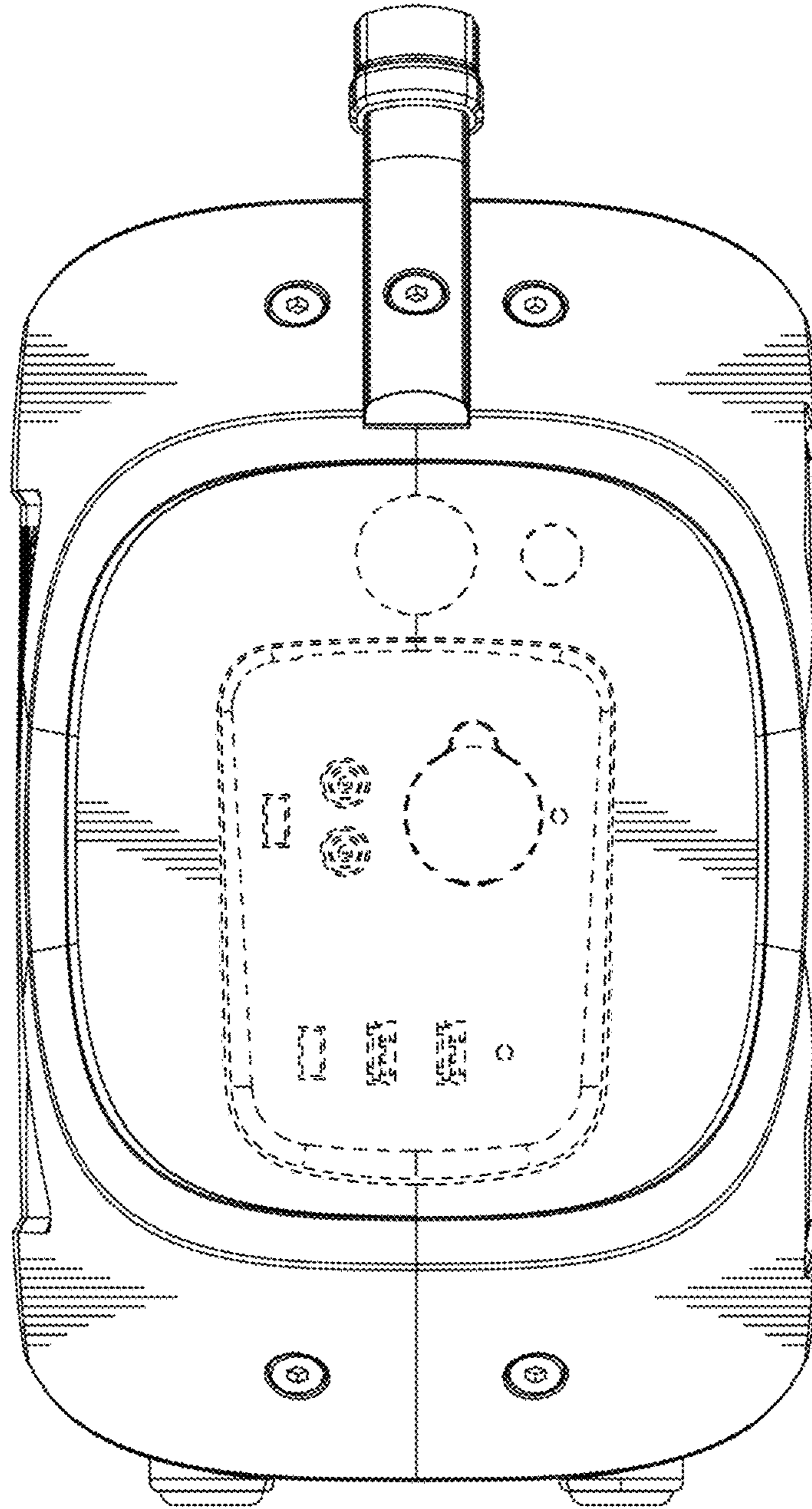

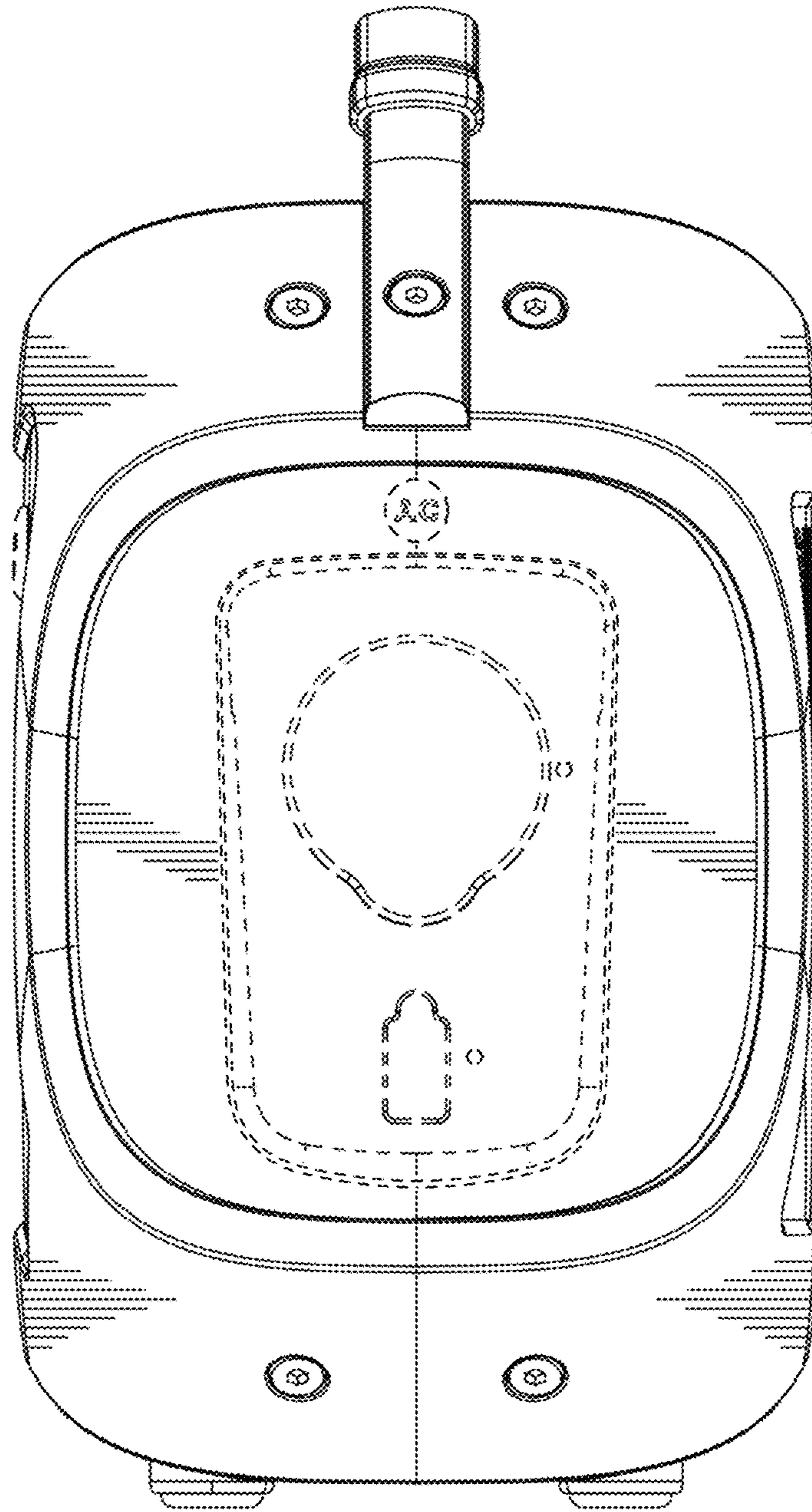

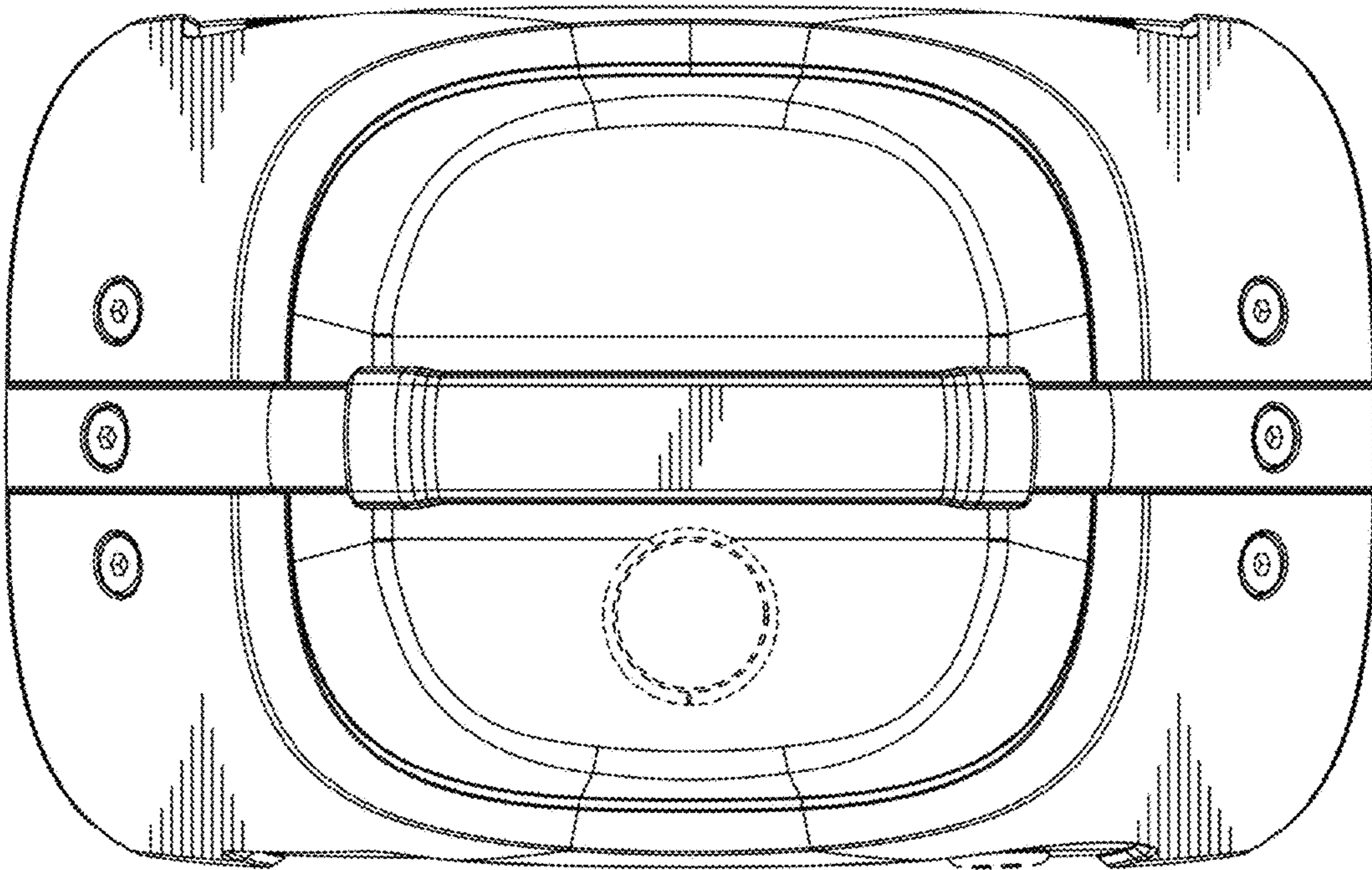

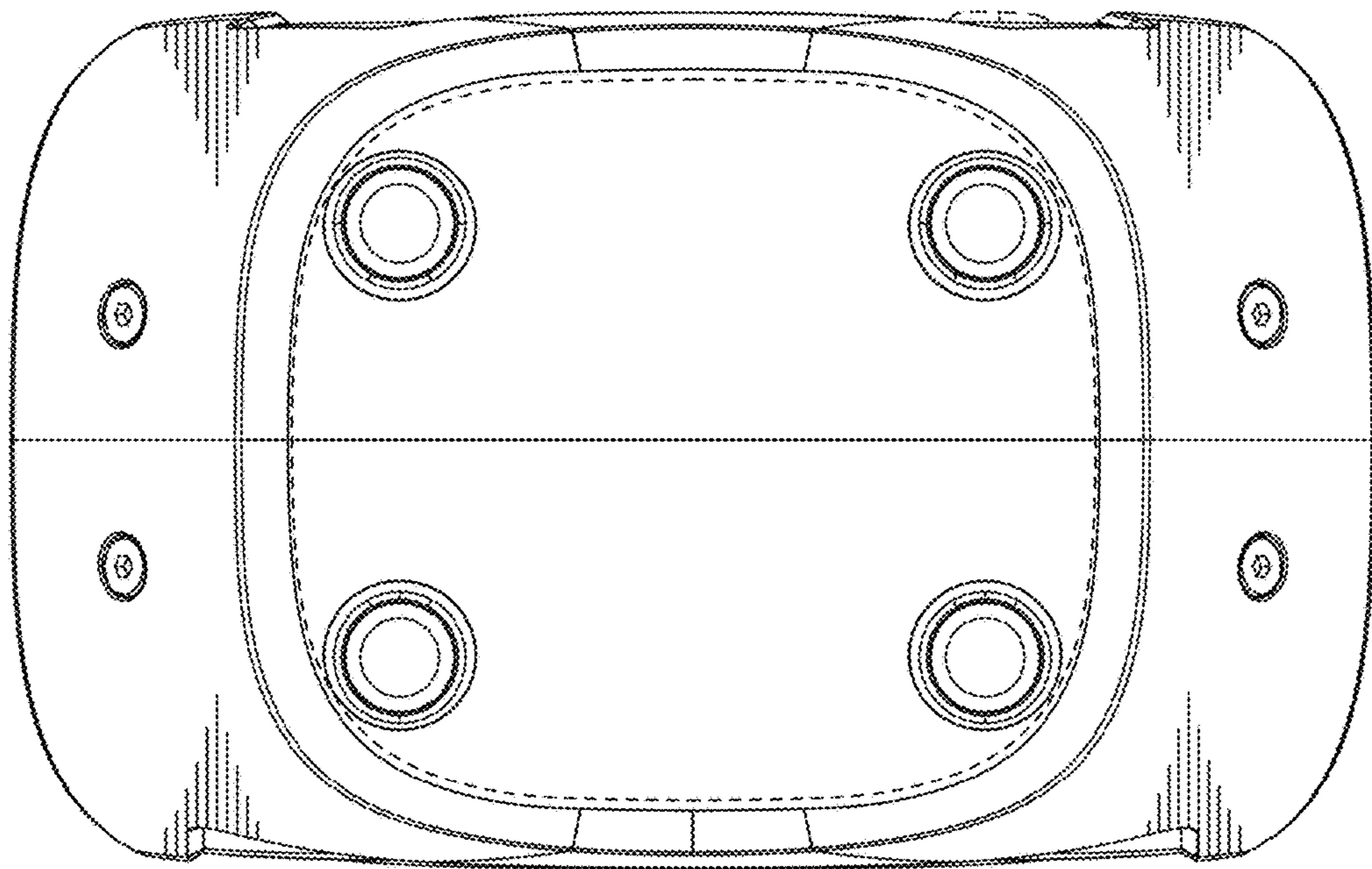
