(57) **CLAIM**

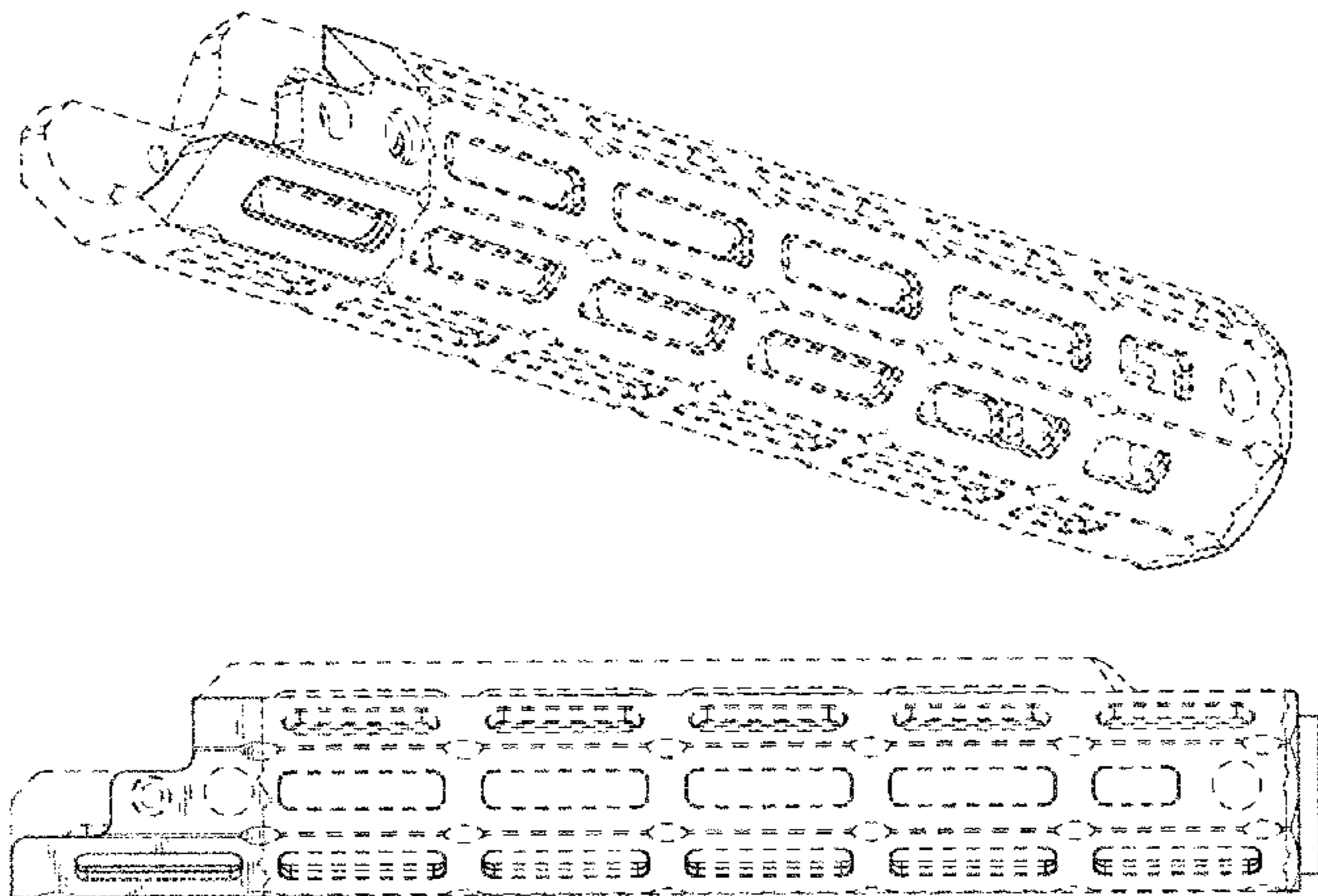
The ornamental design for a firearm hand guard, substantially as shown and described.

**DESCRIPTION**

FIG. 1 forward lower left perspective view of a firearm hand guard according to the present invention; FIG. 2 is a right side elevation view of the firearm hand guard shown in FIG. 1; FIG. 3 is a left side elevation view of the firearm hand guard shown in FIG. 1; FIG. 4 is a bottom plan view of the firearm hand guard shown in FIG. 1; FIG. 5 is a top plan view of the firearm hand guard shown in FIG. 1; FIG. 6 is a rear elevation view of the firearm hand guard shown in FIG. 1; and, FIG. 7 is a front elevation view of the firearm hand guard shown in FIG. 1.

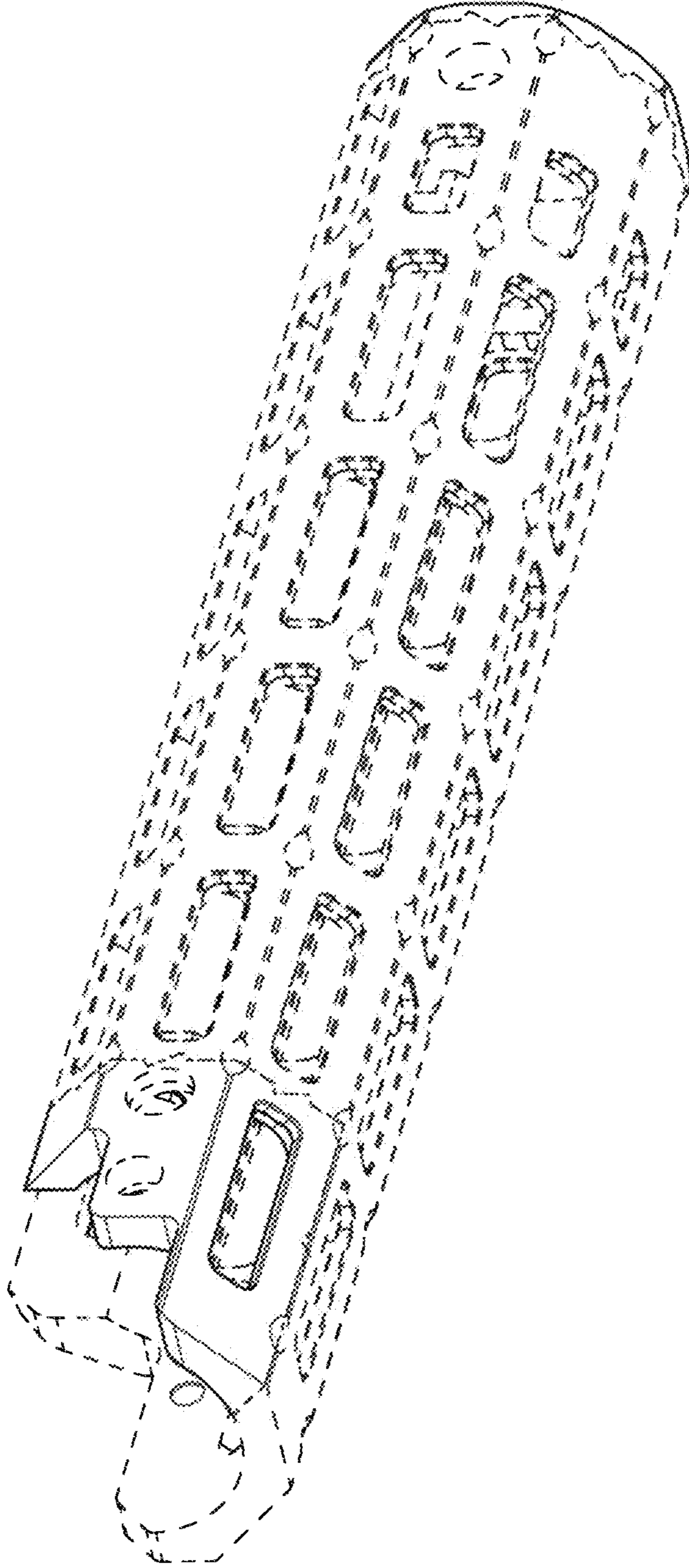

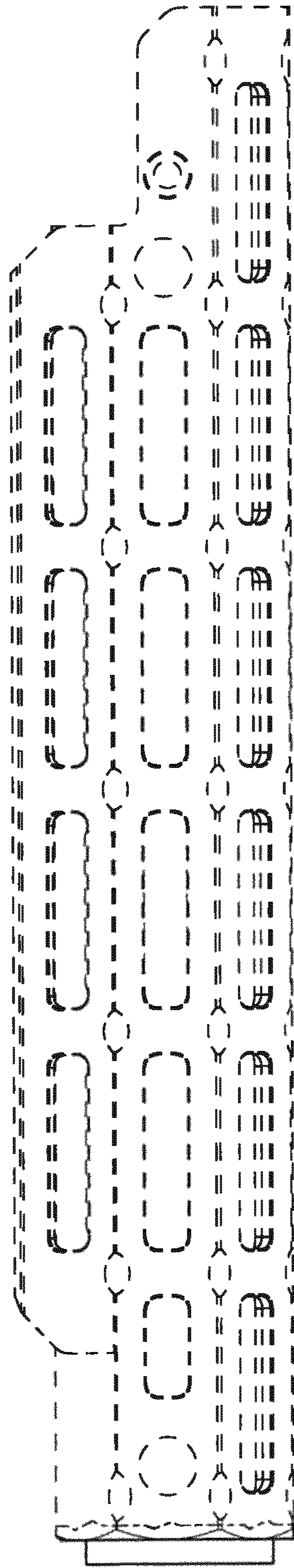

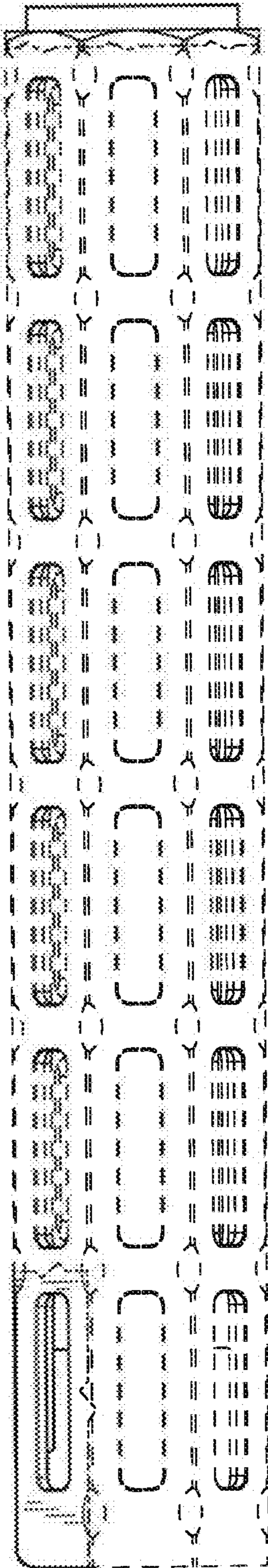

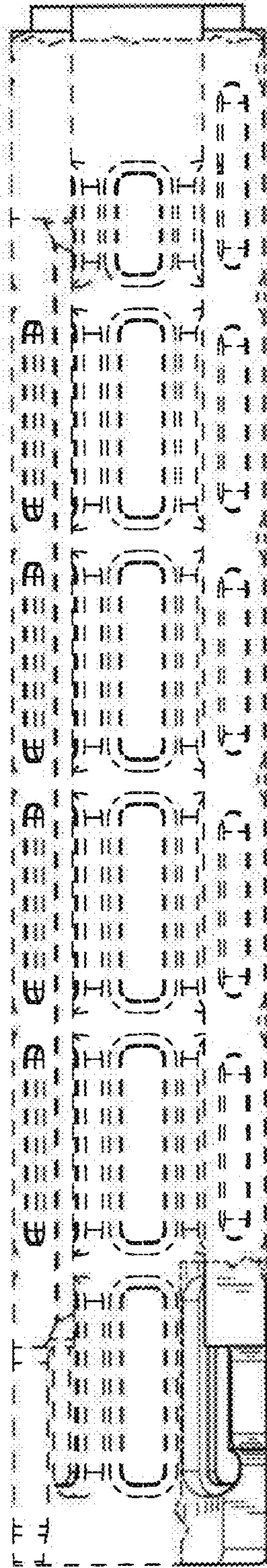

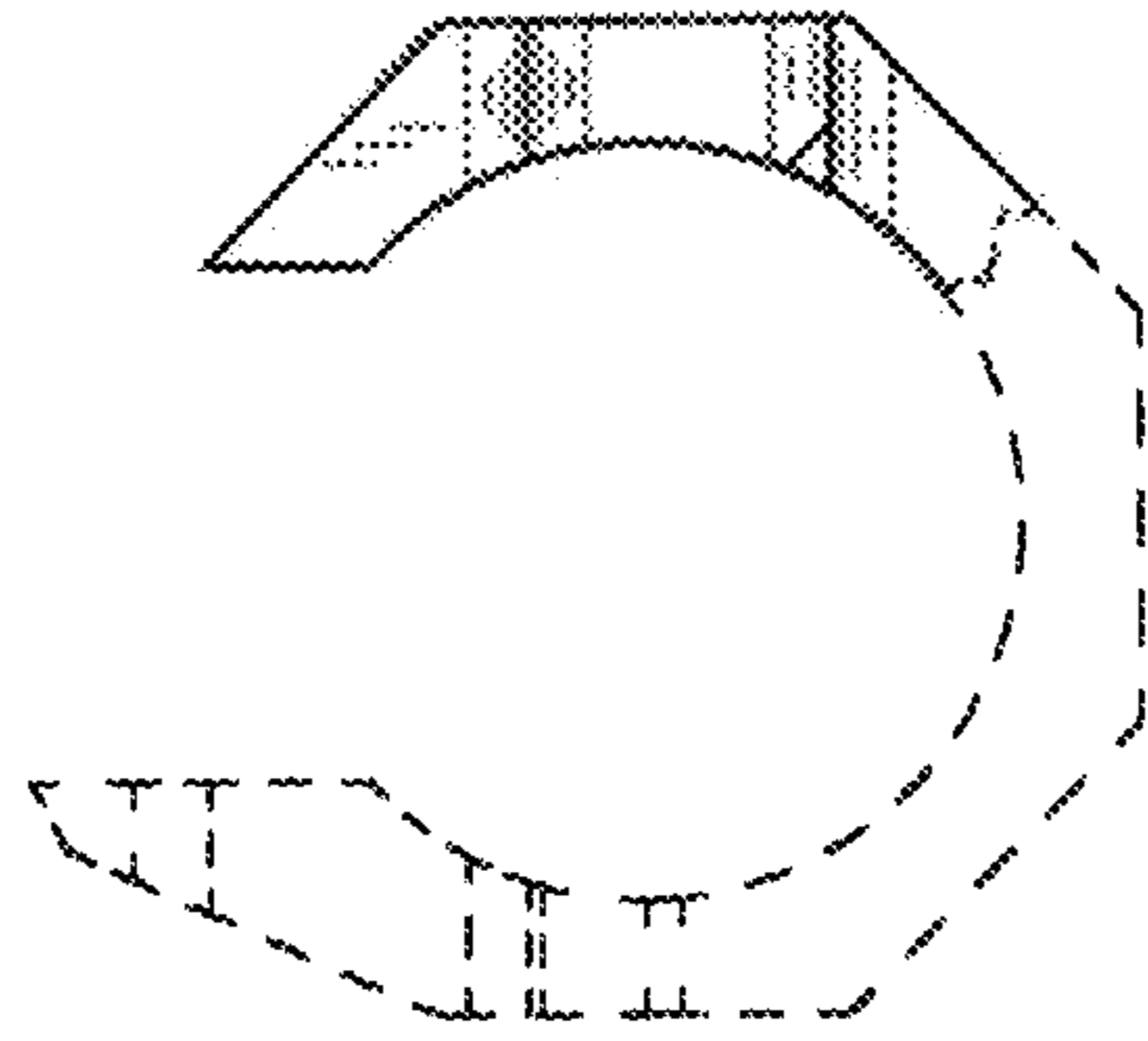

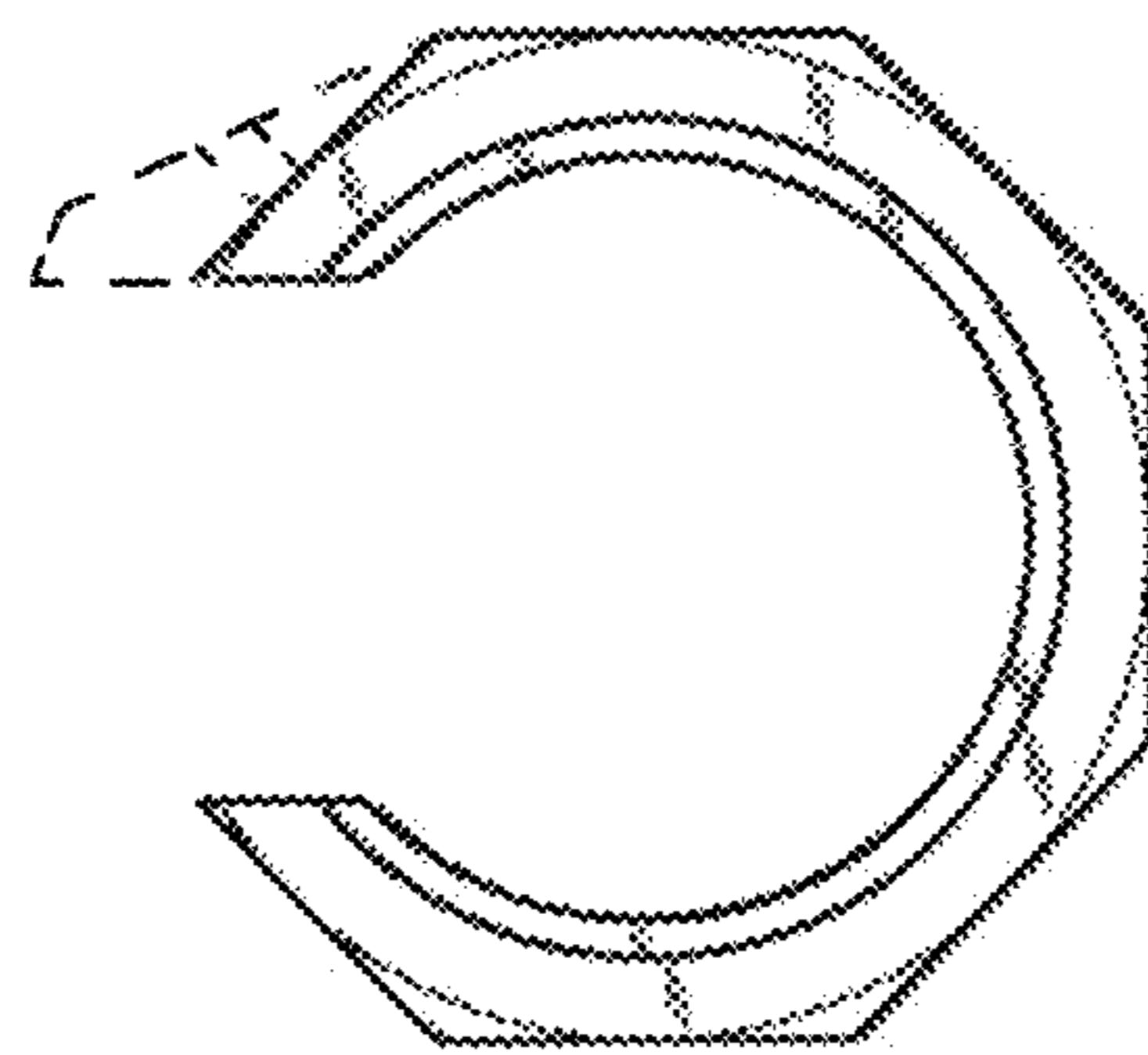
