**DESCRIPTION**

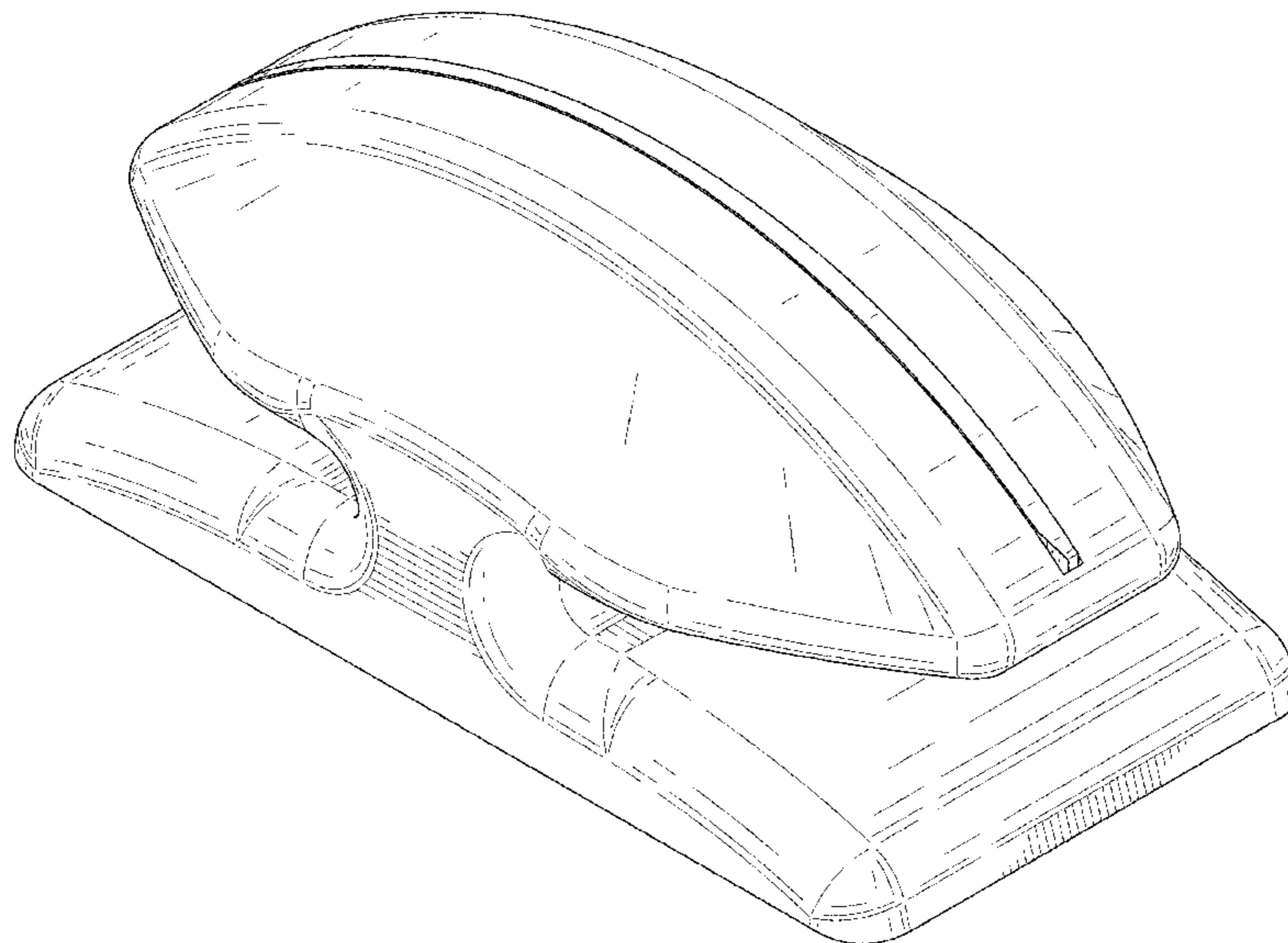
FIG. 1 is a top perspective view of a flat mount cutting element shown in accordance with my new design;

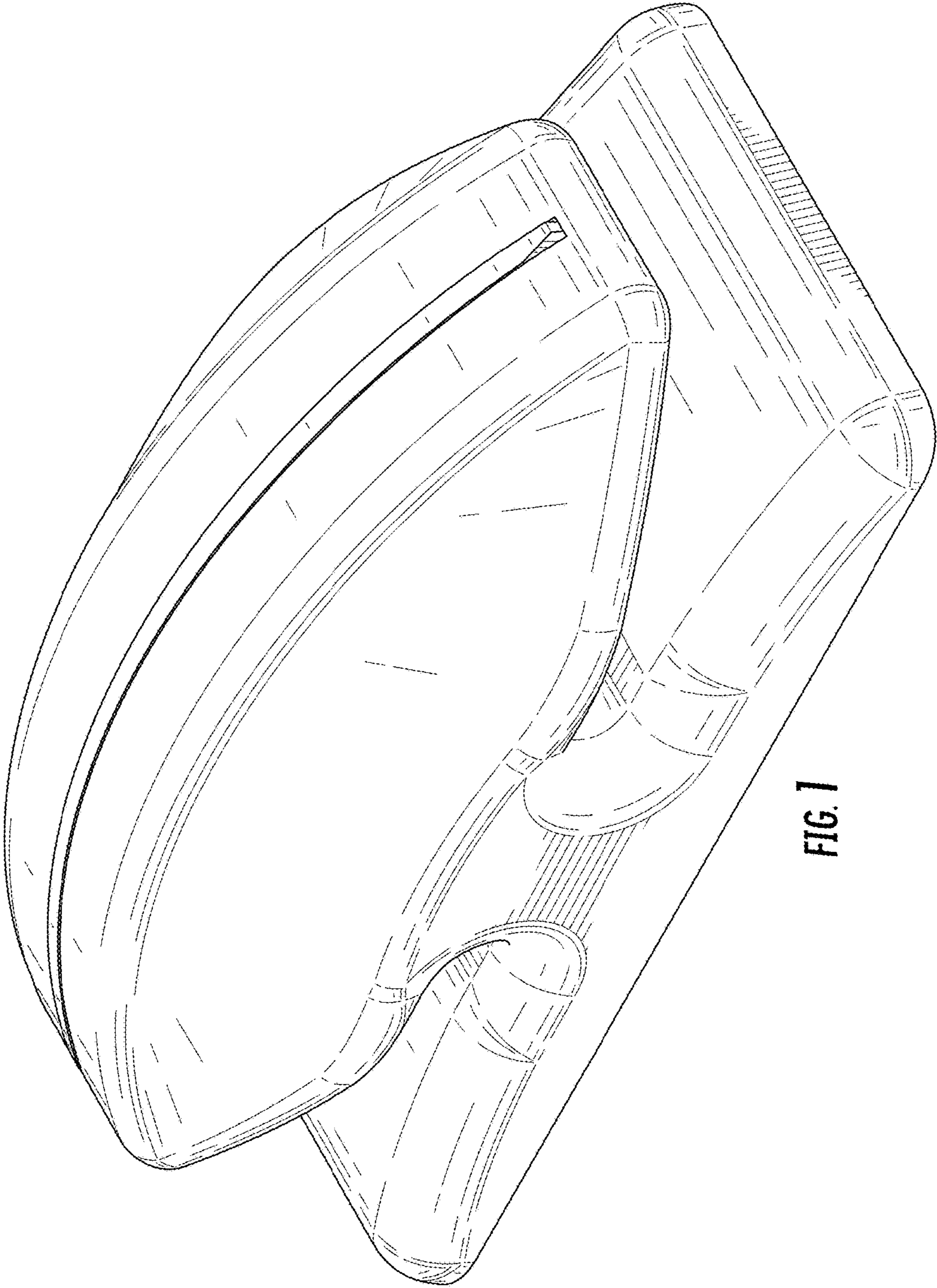

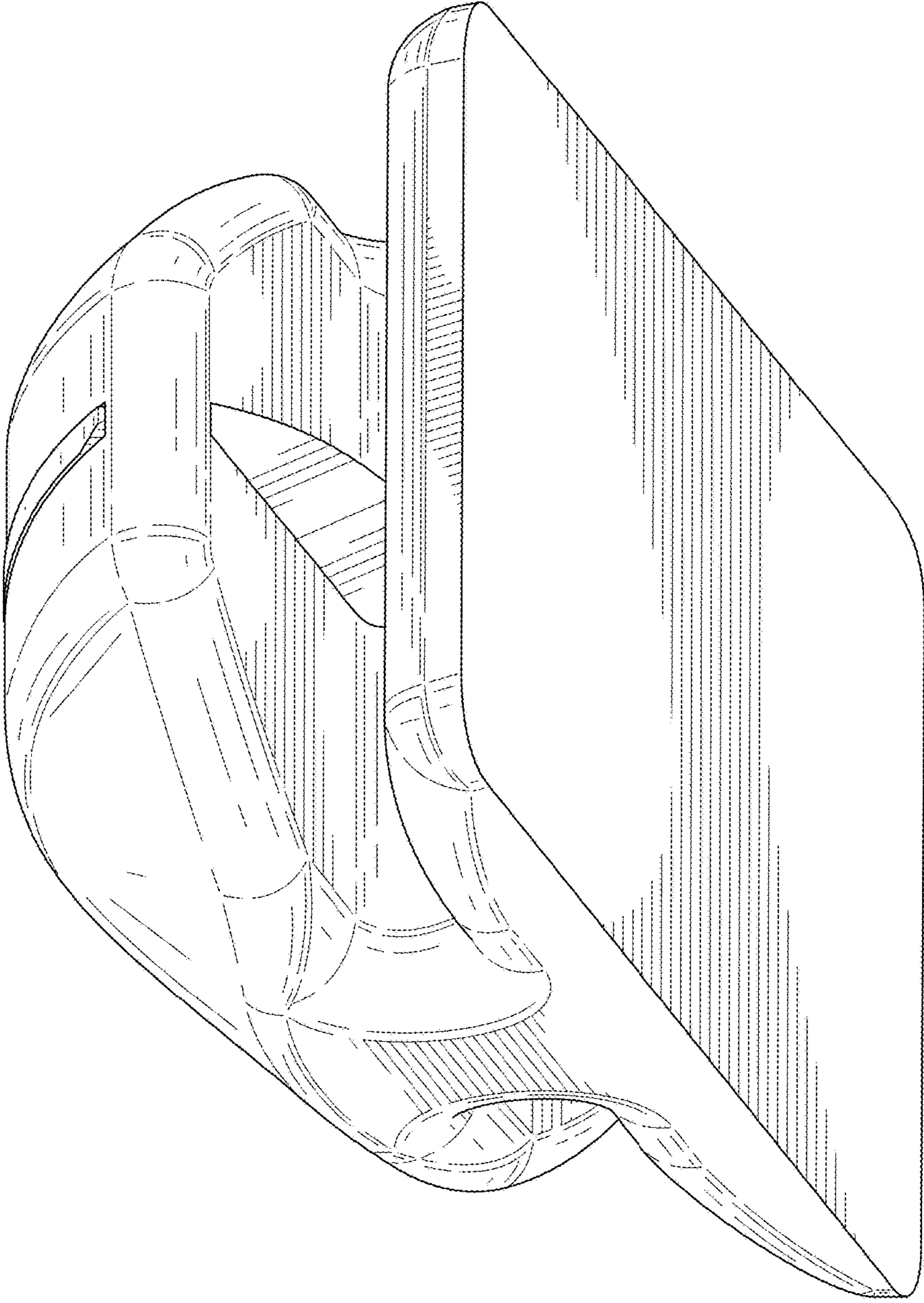

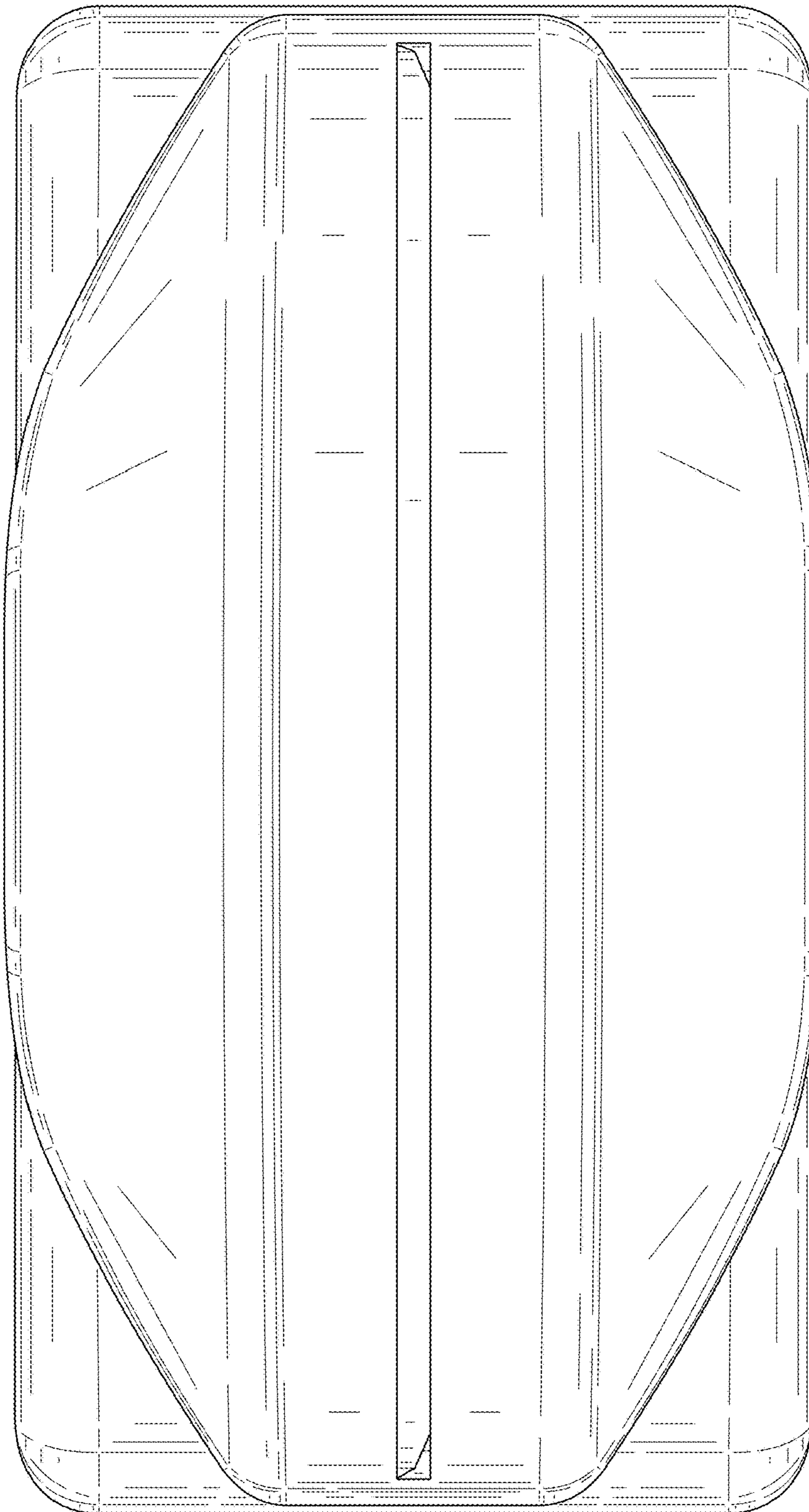

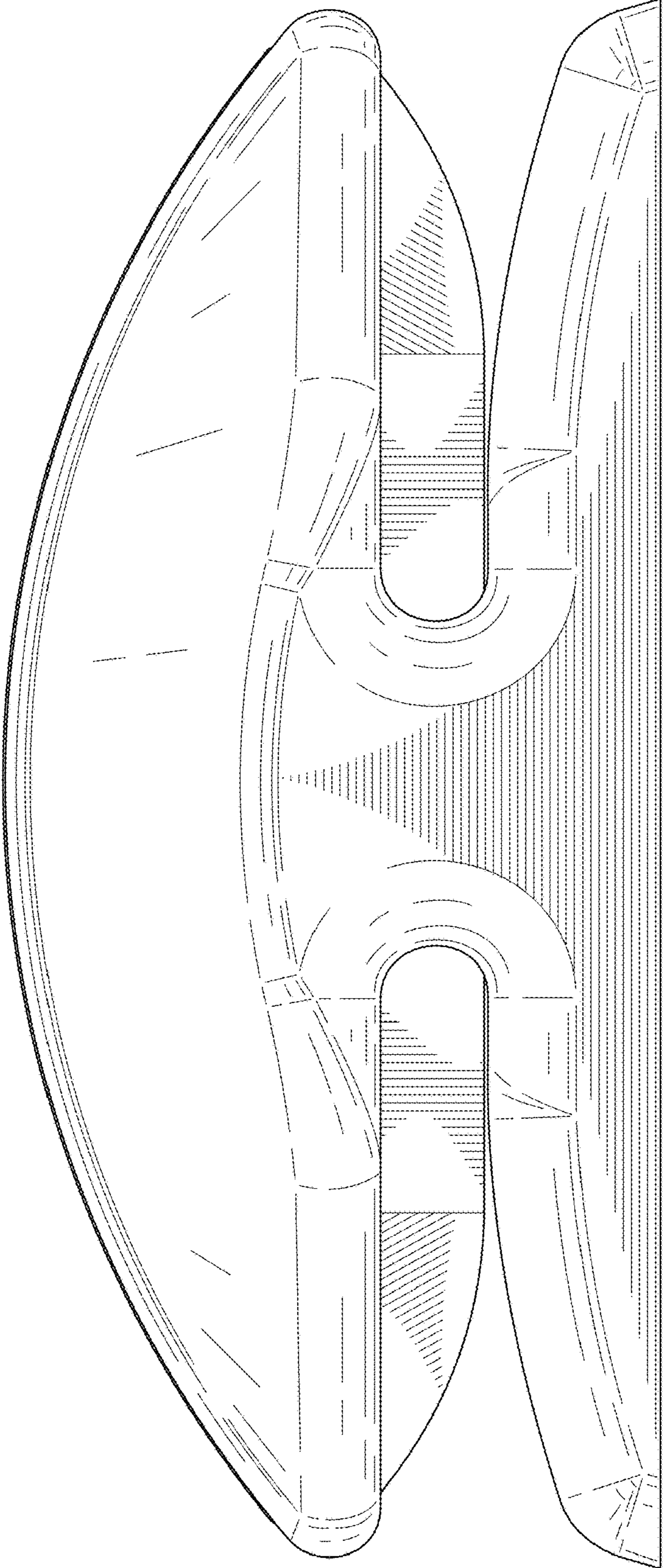

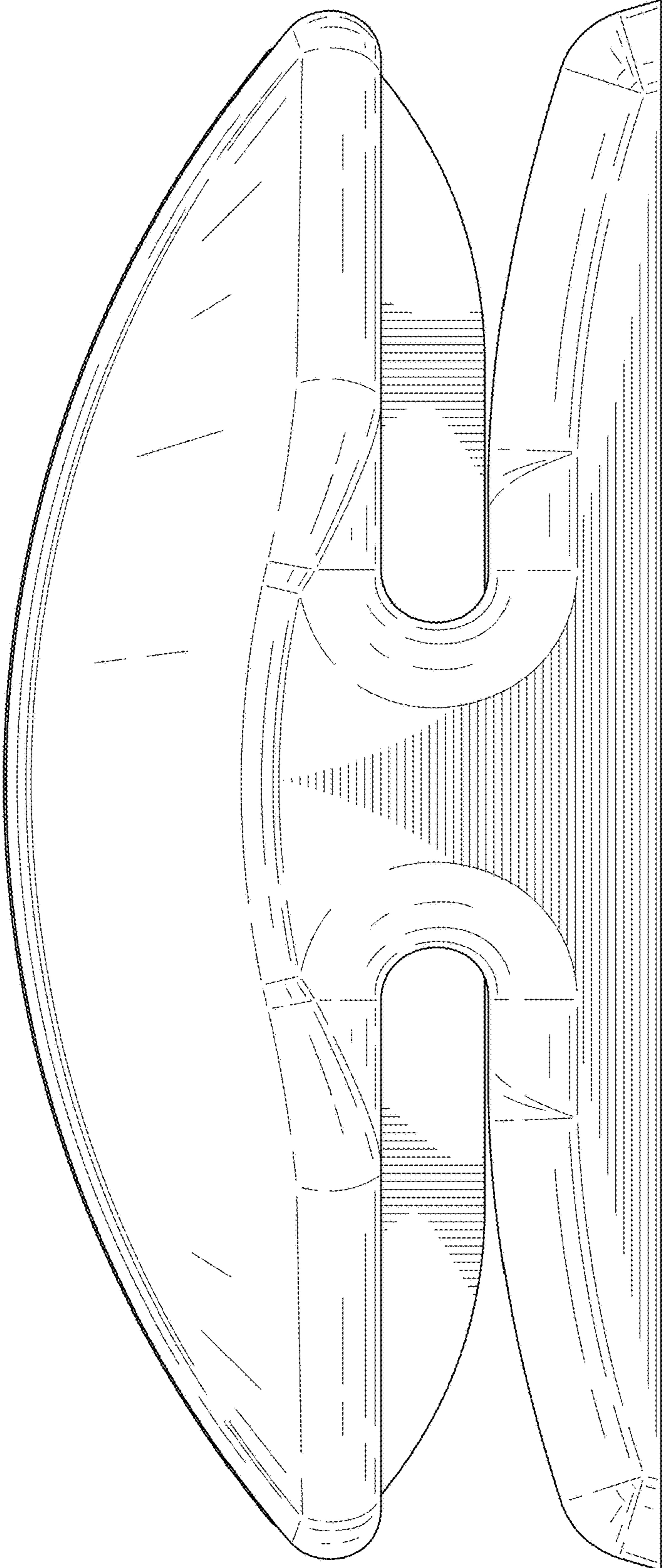

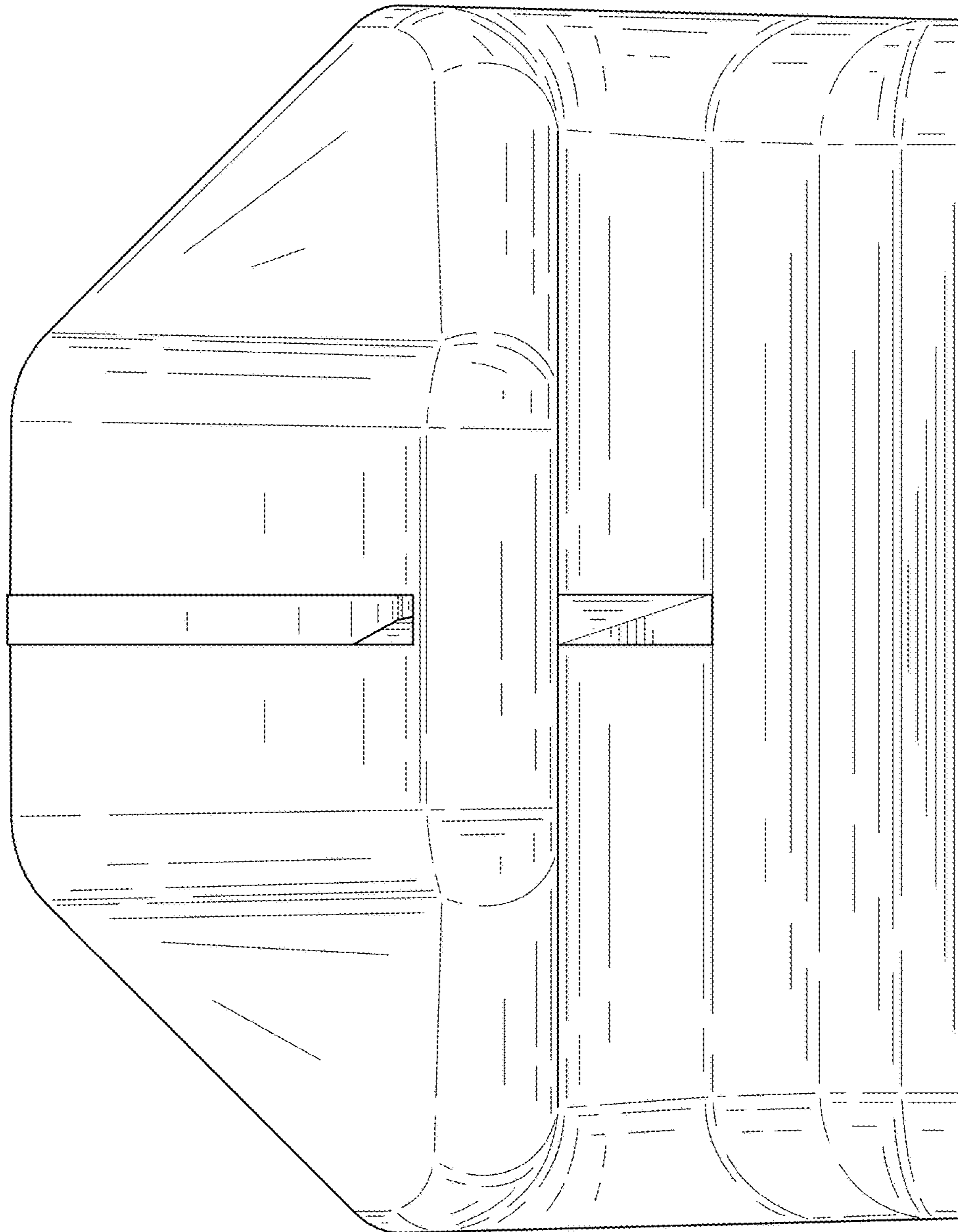

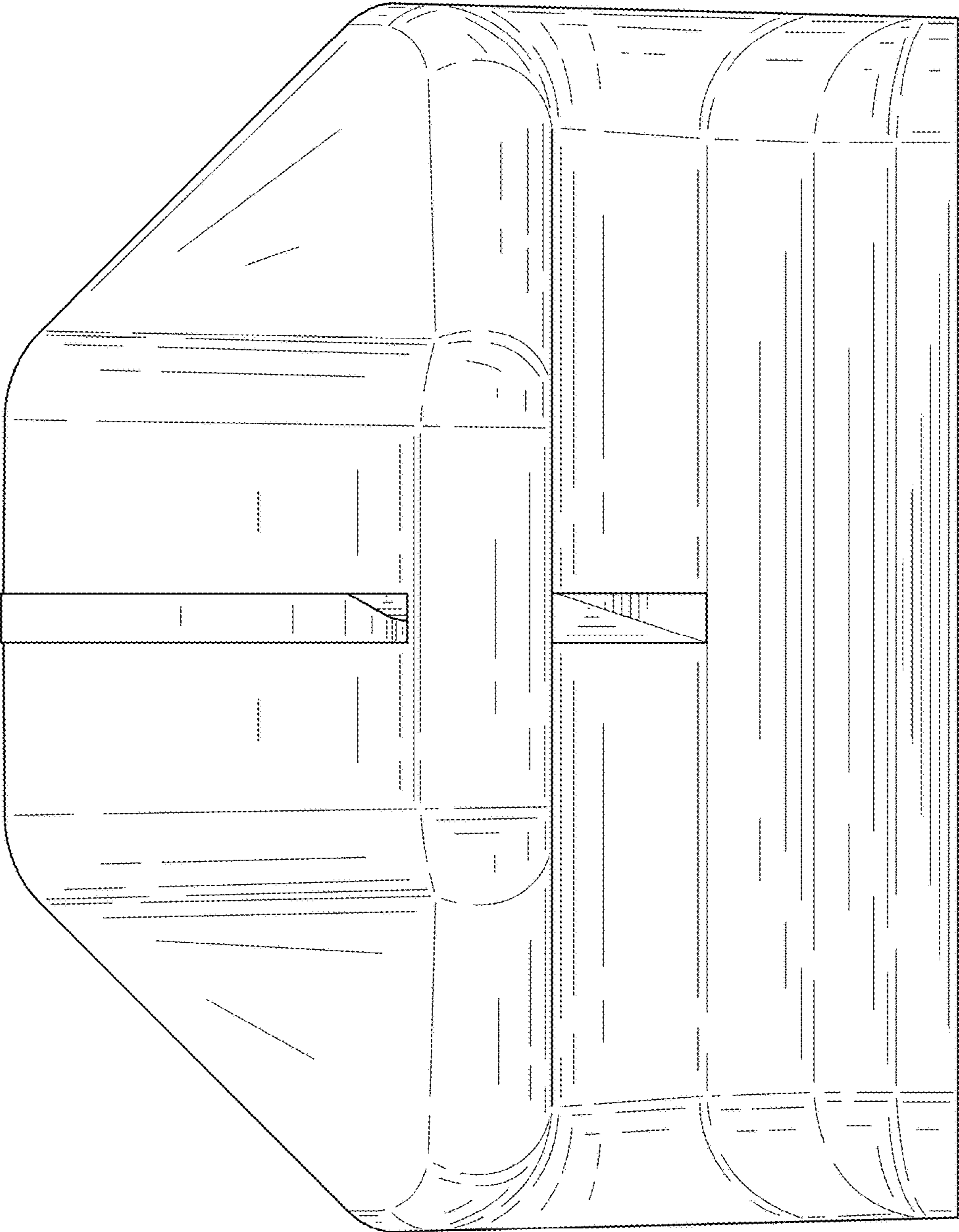
