FIG. 6 is a top plan view of the air freshener lidded cup of the present invention; and,

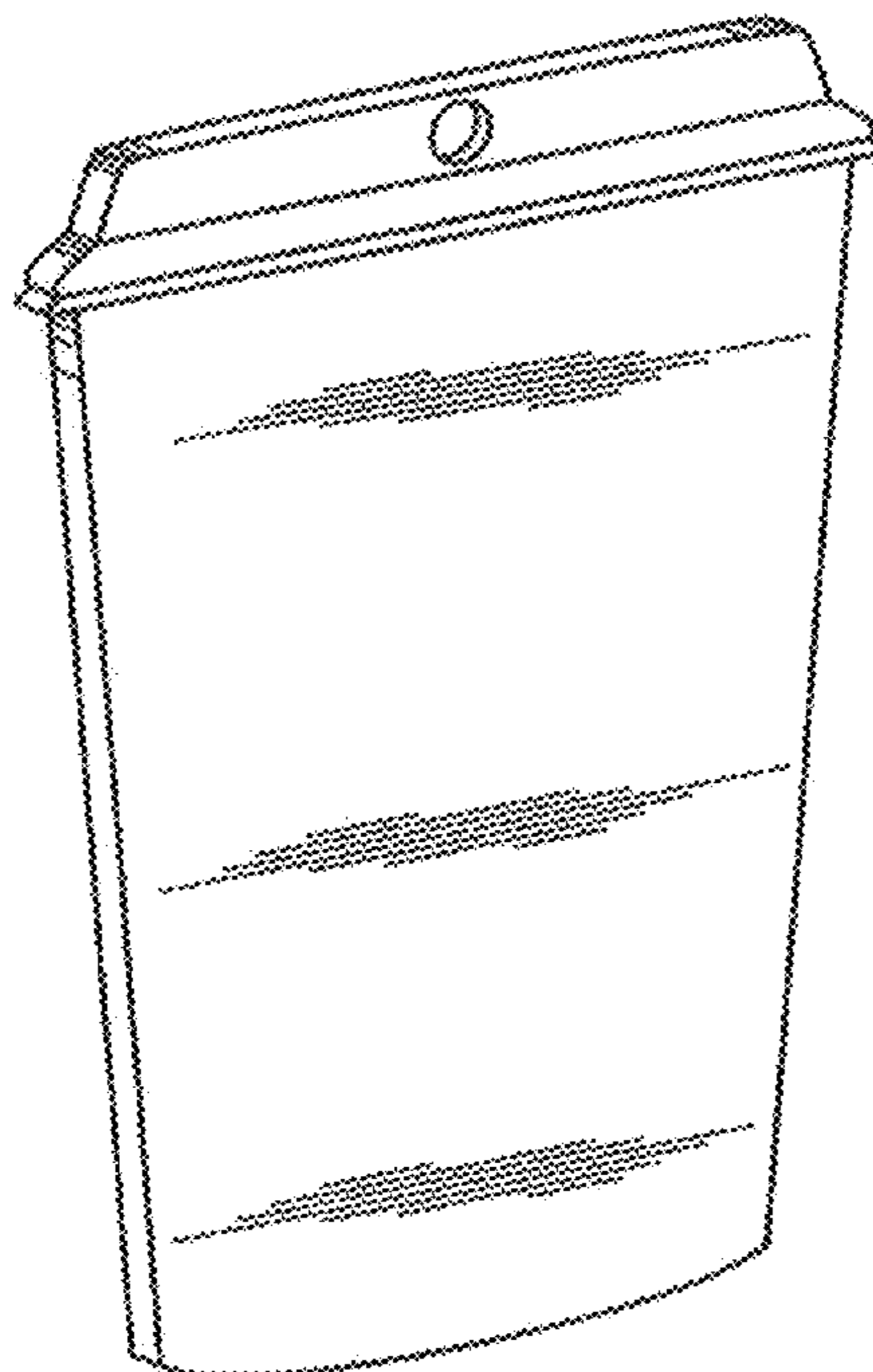
FIG. 7 is a bottom plan view-of the air freshener lidded cup of the present invention.

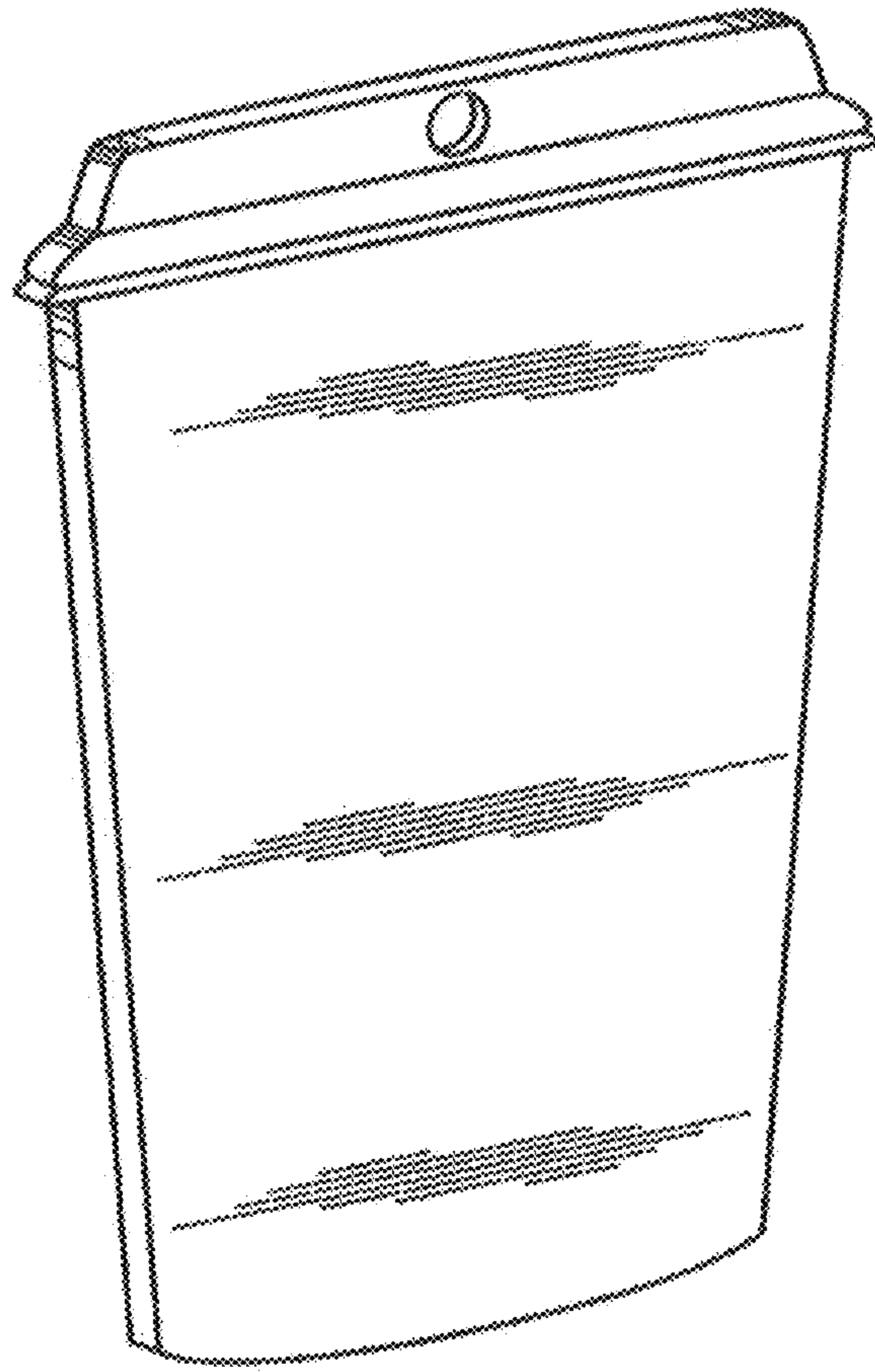

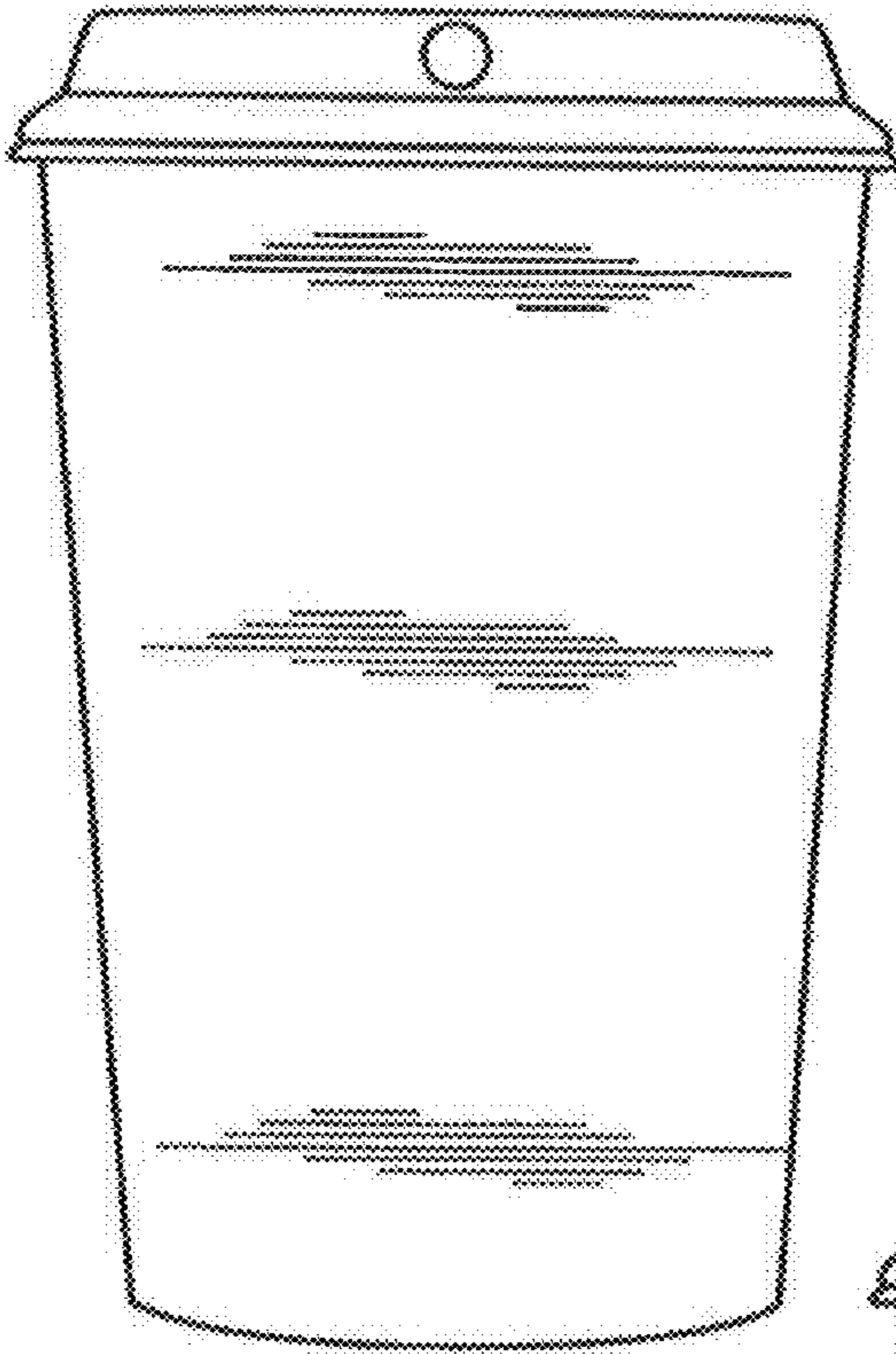

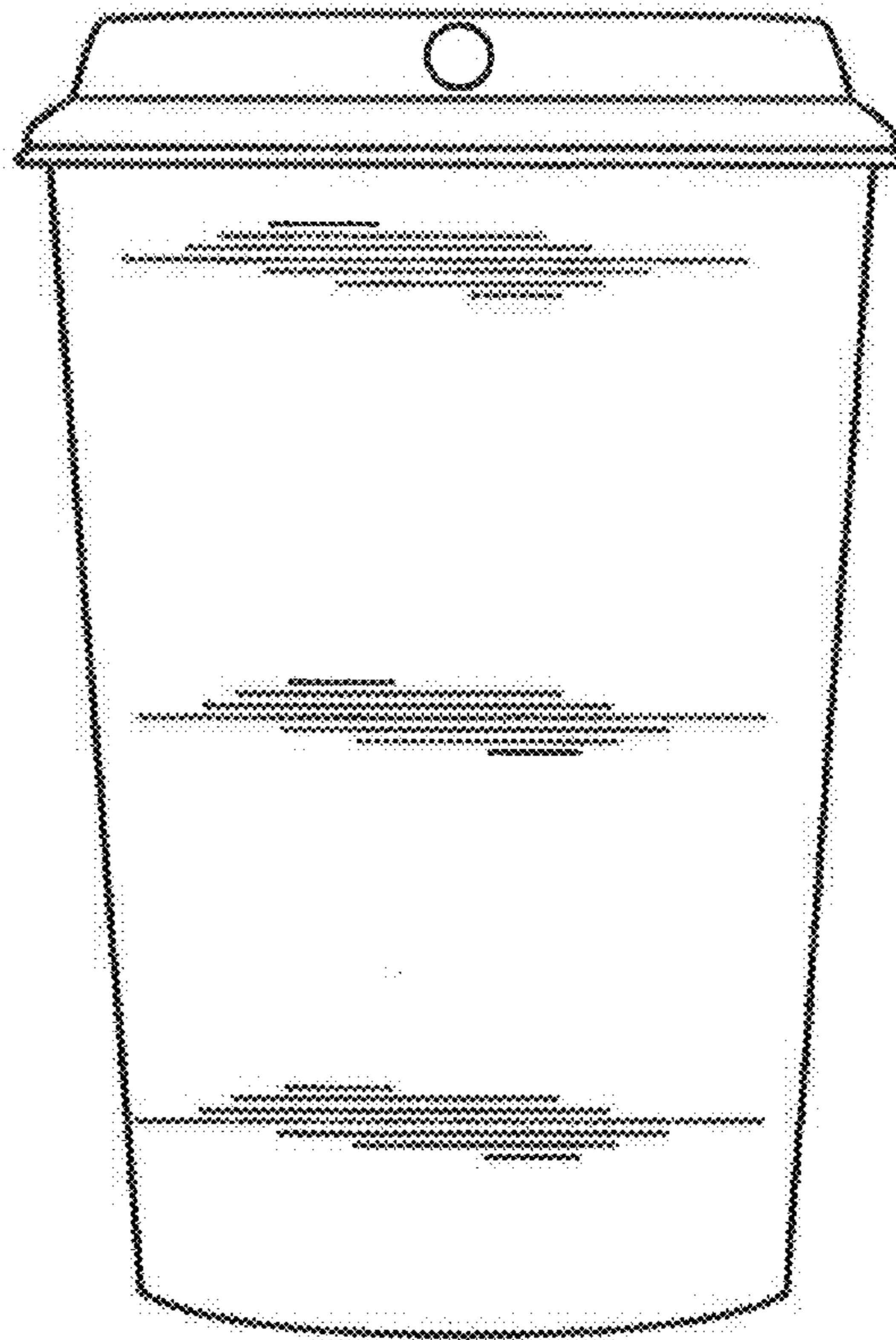

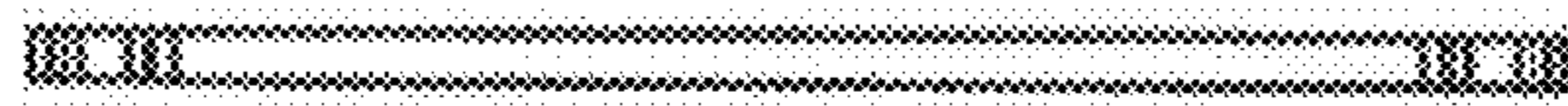

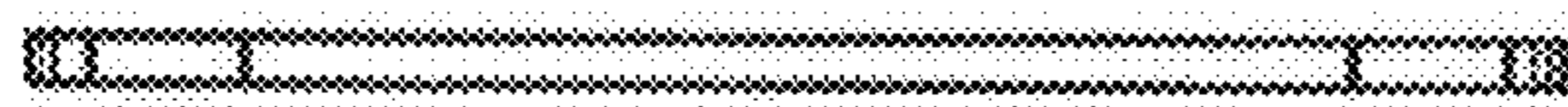
