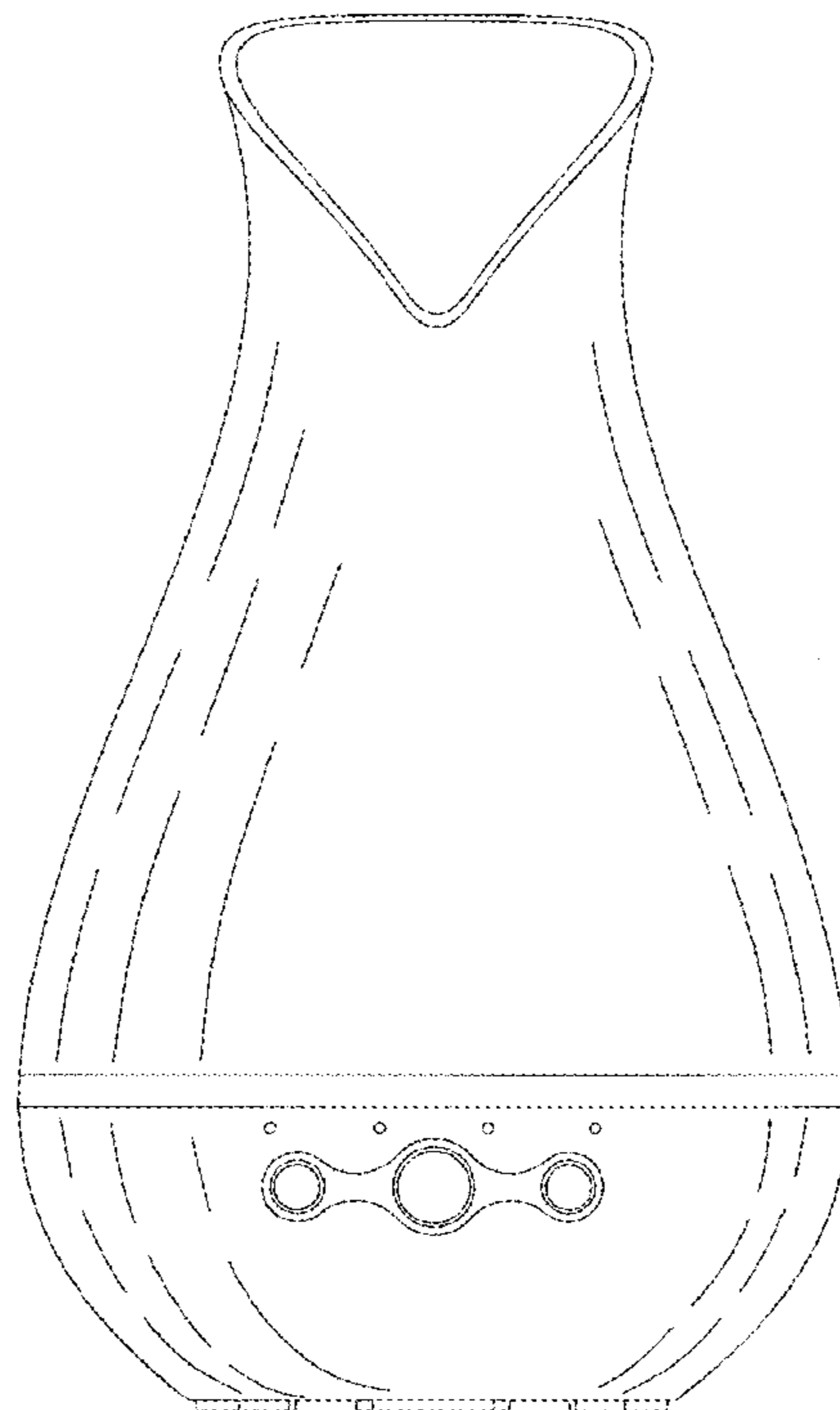
(57) **CLAIM**

The ornamental design for a aromatherapy diffuser in the shape of a vase, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a aromatherapy diffuser in the shape of a vase showing my new design; FIG. 2 is a rear elevation view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The features shown in broken lines in the various figures are shown for illustrating environmental structure and form no part of the claimed design.

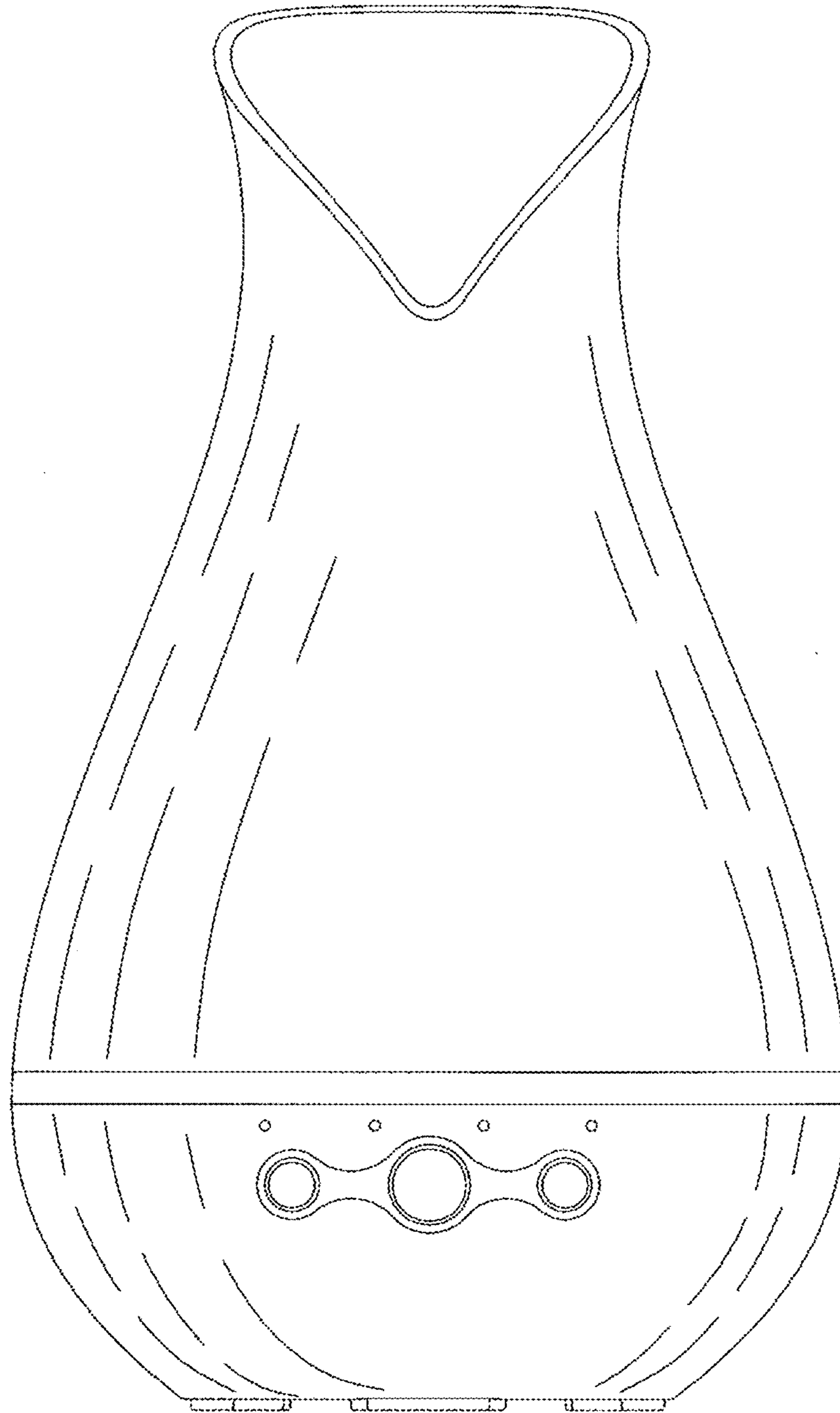

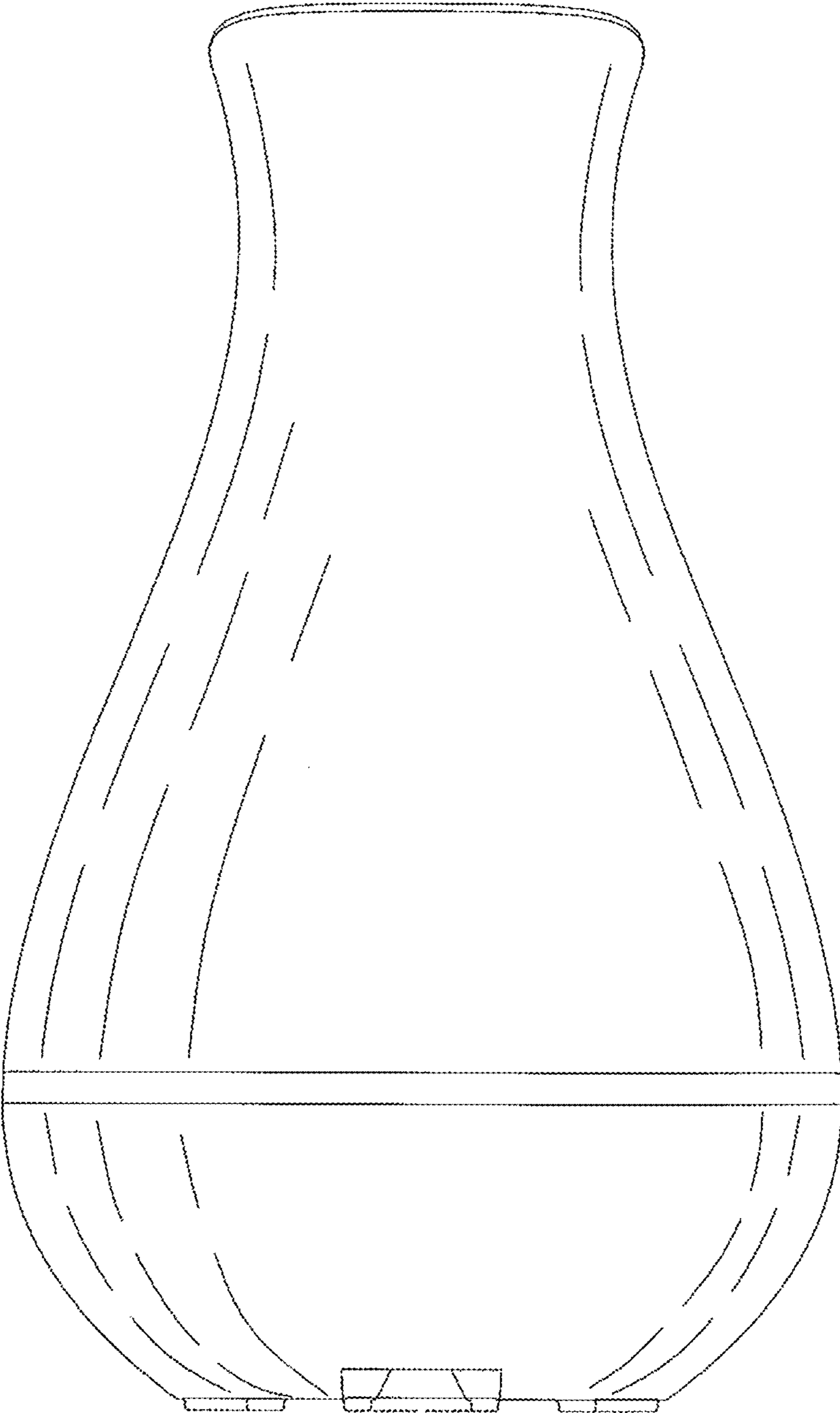

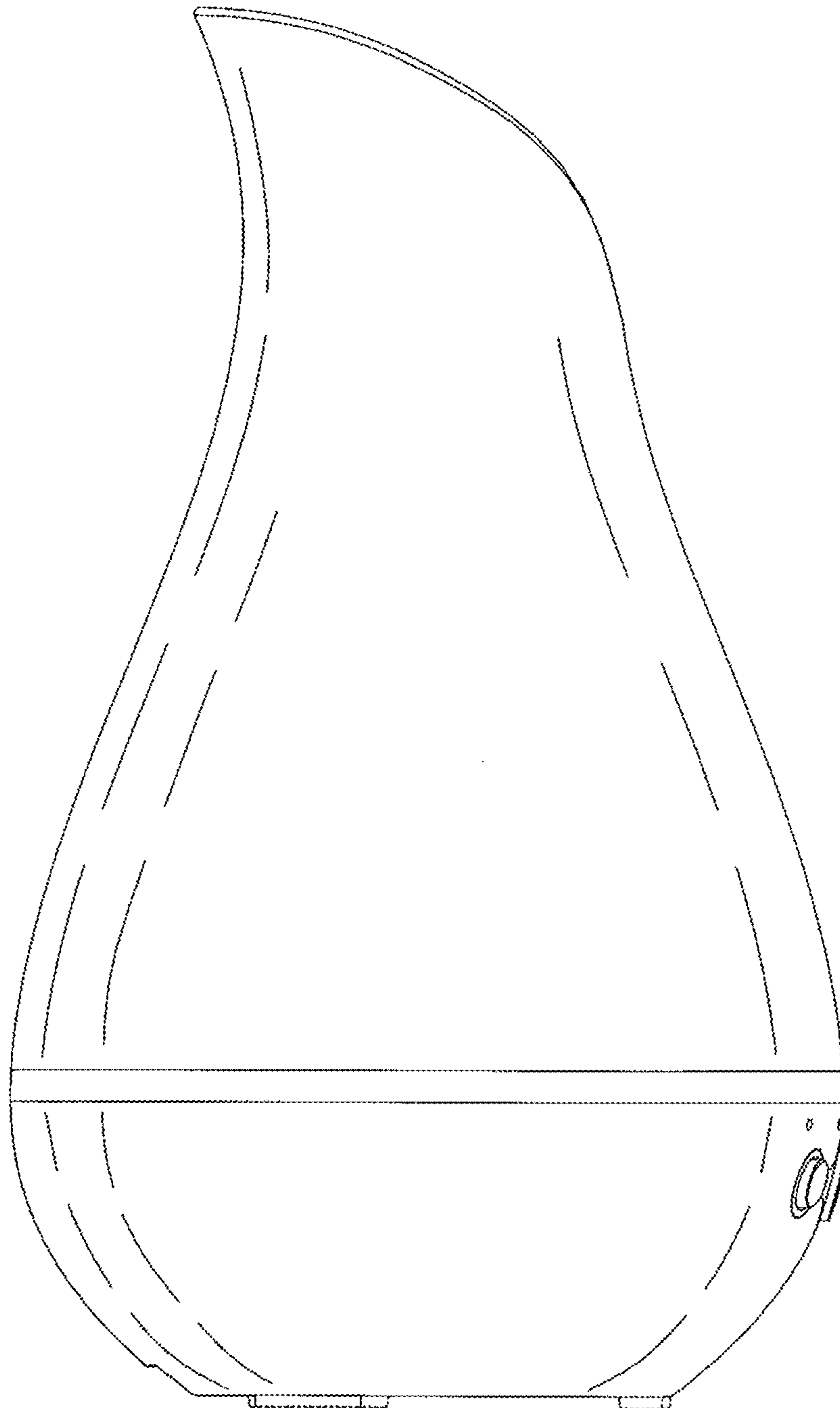

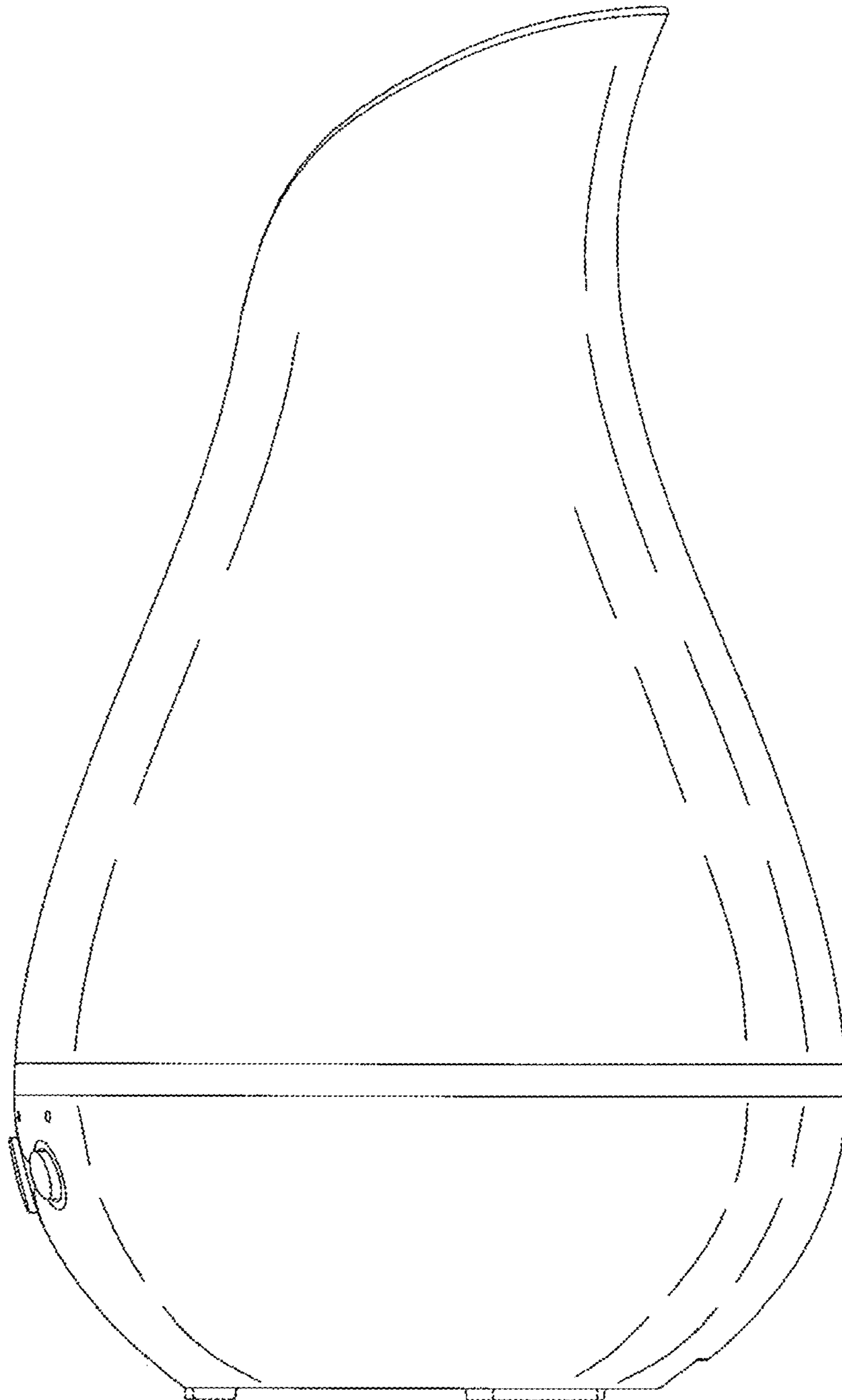

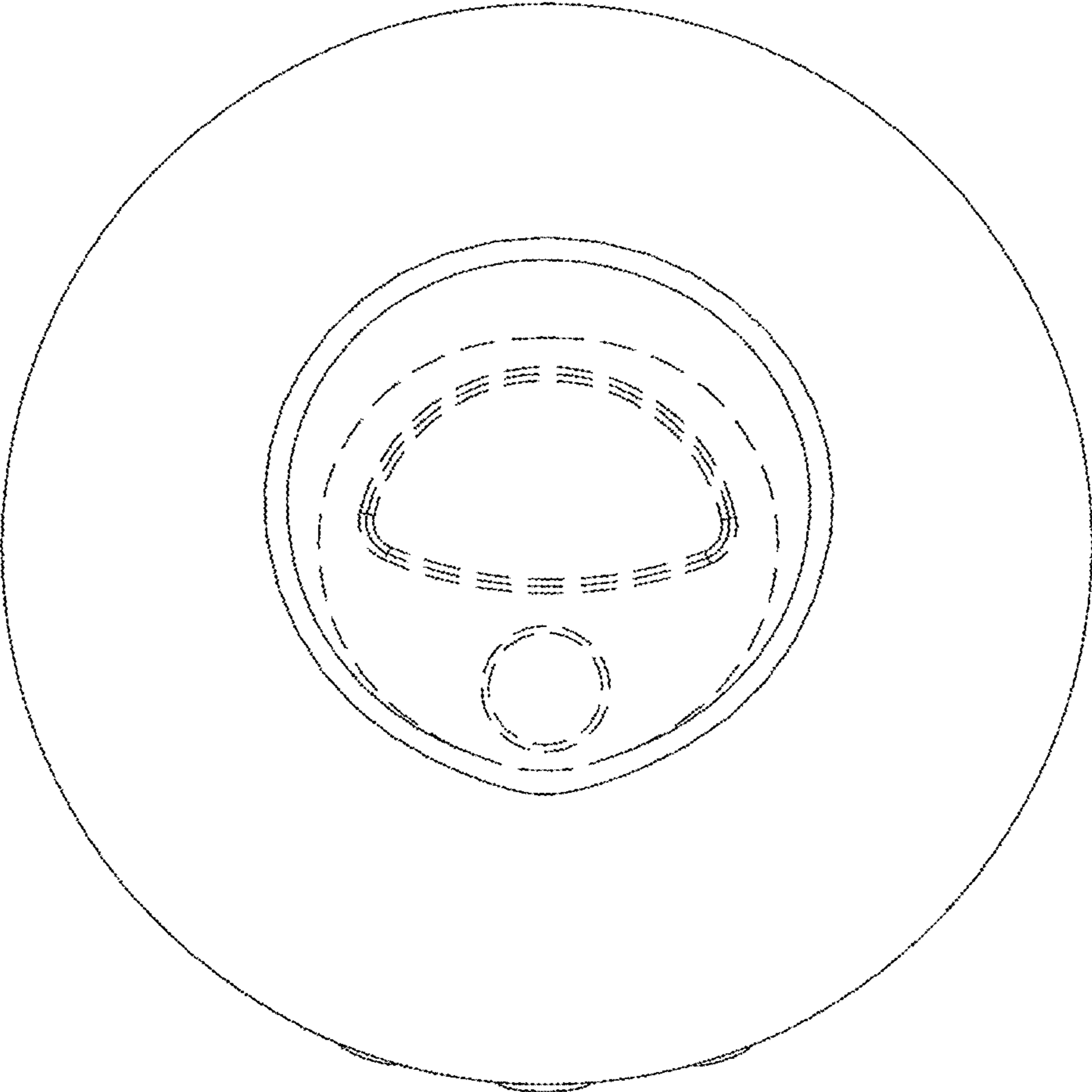

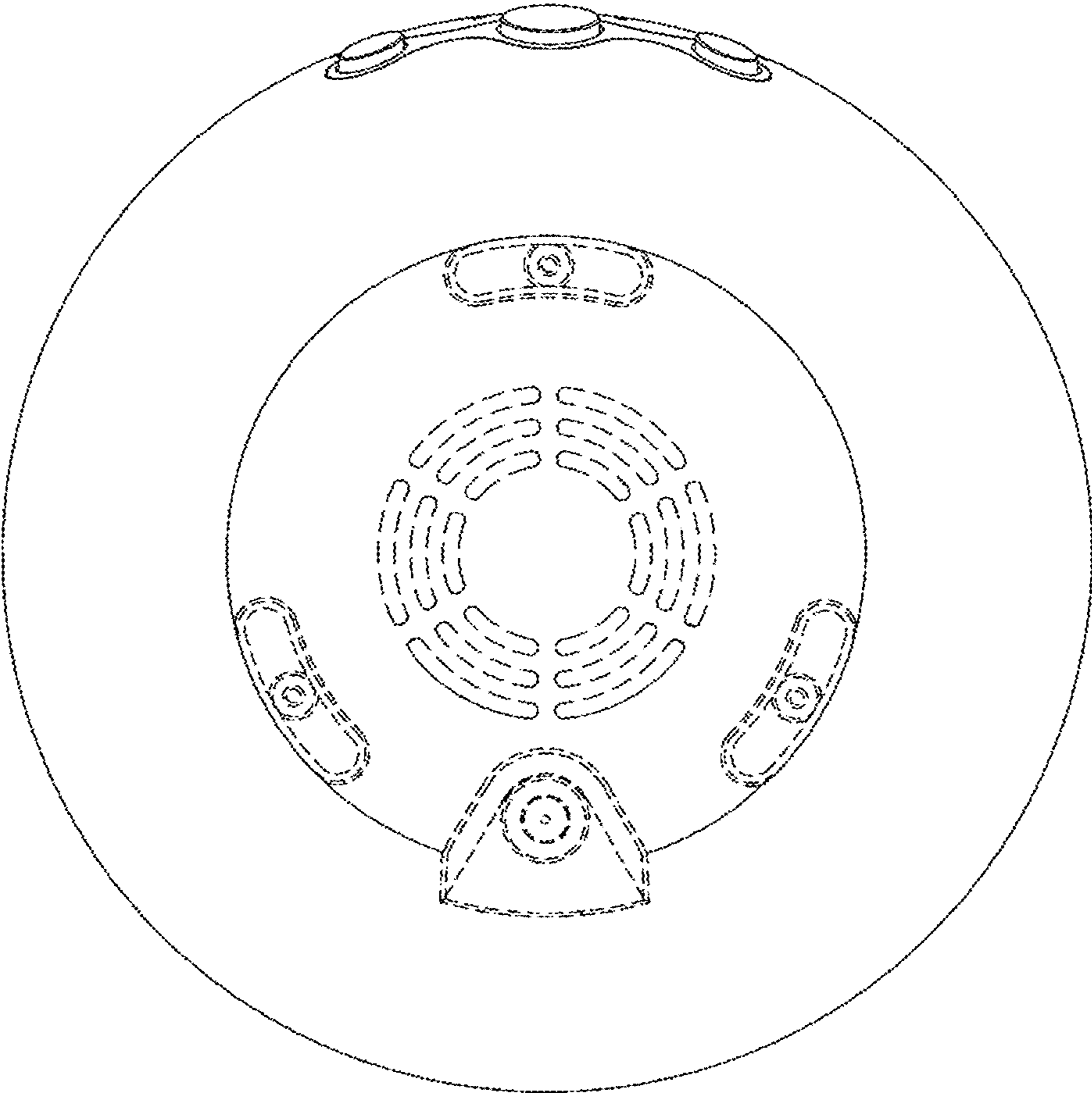
