(57) **CLAIM**

The ornamental design for a window component extrusion,
as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a window component extrusion according to the present disclosure.

FIG. 2 is a left side view of the window component extrusion of FIG. 1.

FIG. 3 is a right side view of the window component extrusion of FIG. 1.

FIG. 4 is a rear view of the window component extrusion of FIG. 1.

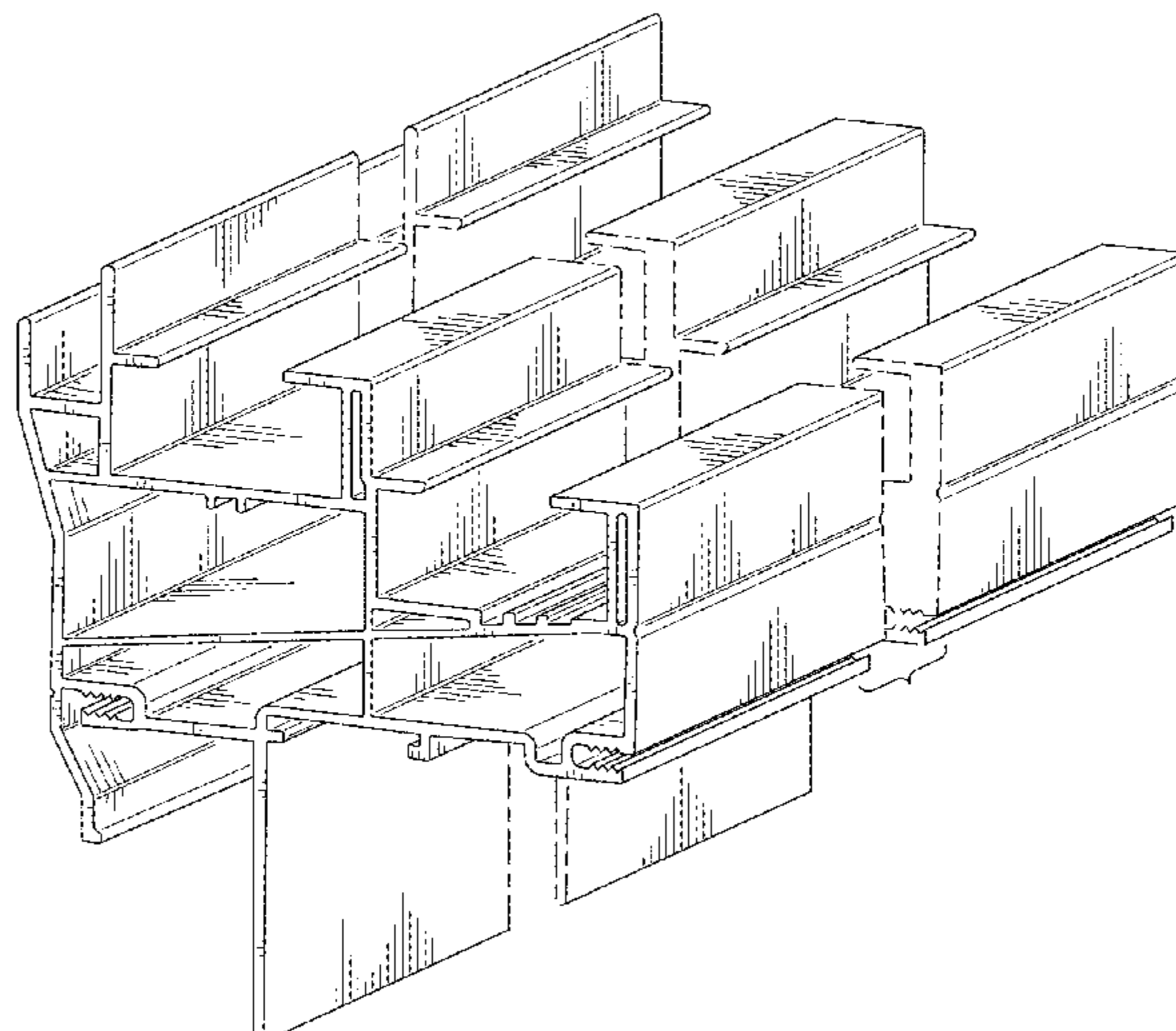
FIG. 5 is a front view of the window component extrusion of FIG. 1.

FIG. 6 is a top view of the window component extrusion of FIG. 1; and,

FIG. 7 is a bottom view of the window component extrusion of FIG. 1.

The window component extrusion is shown with two parallel dash-dot break lines that represent the bounds of the claim. The appearance of any portion of the window component extrusion between the break lines forms no part of the claimed design.

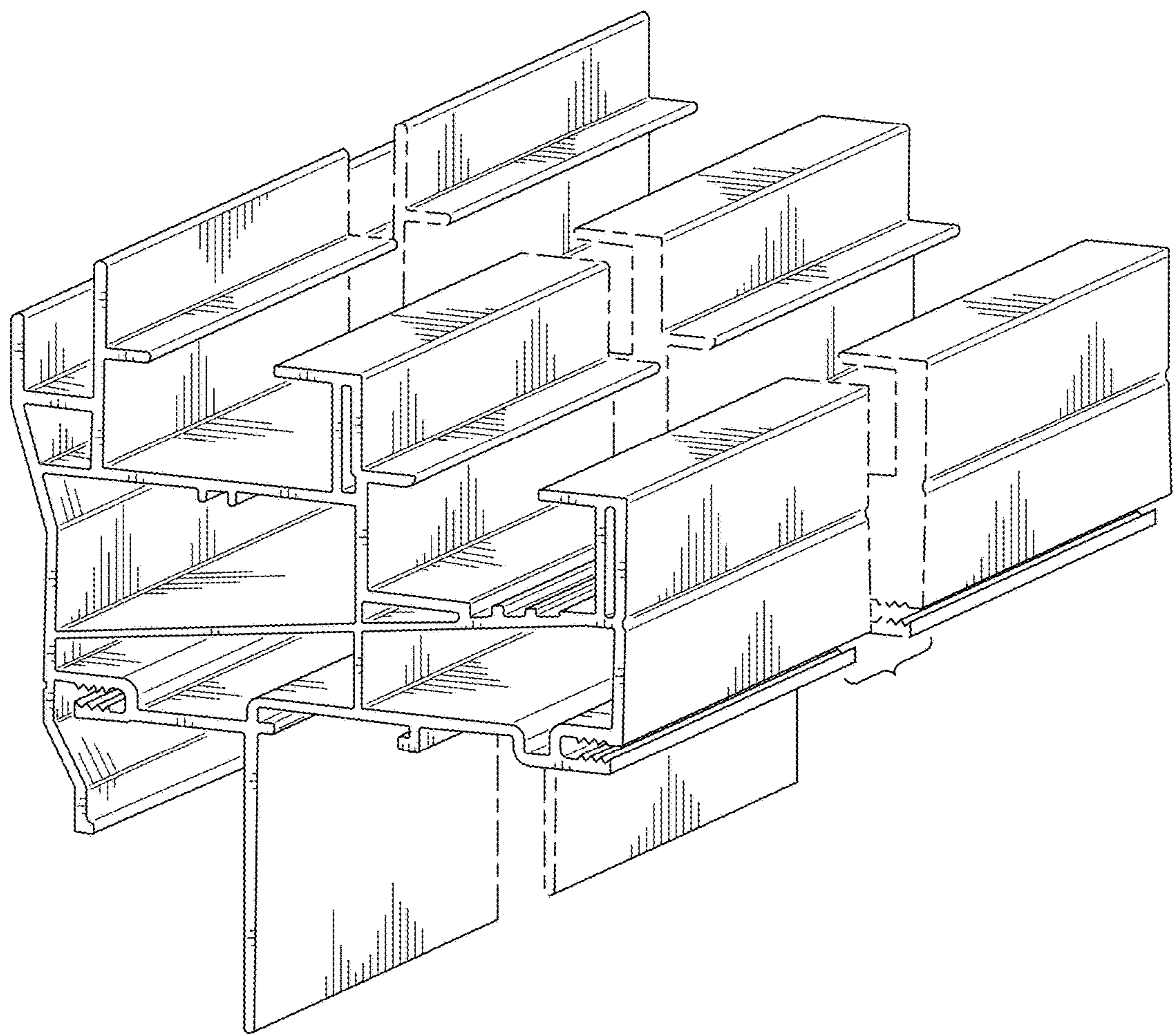

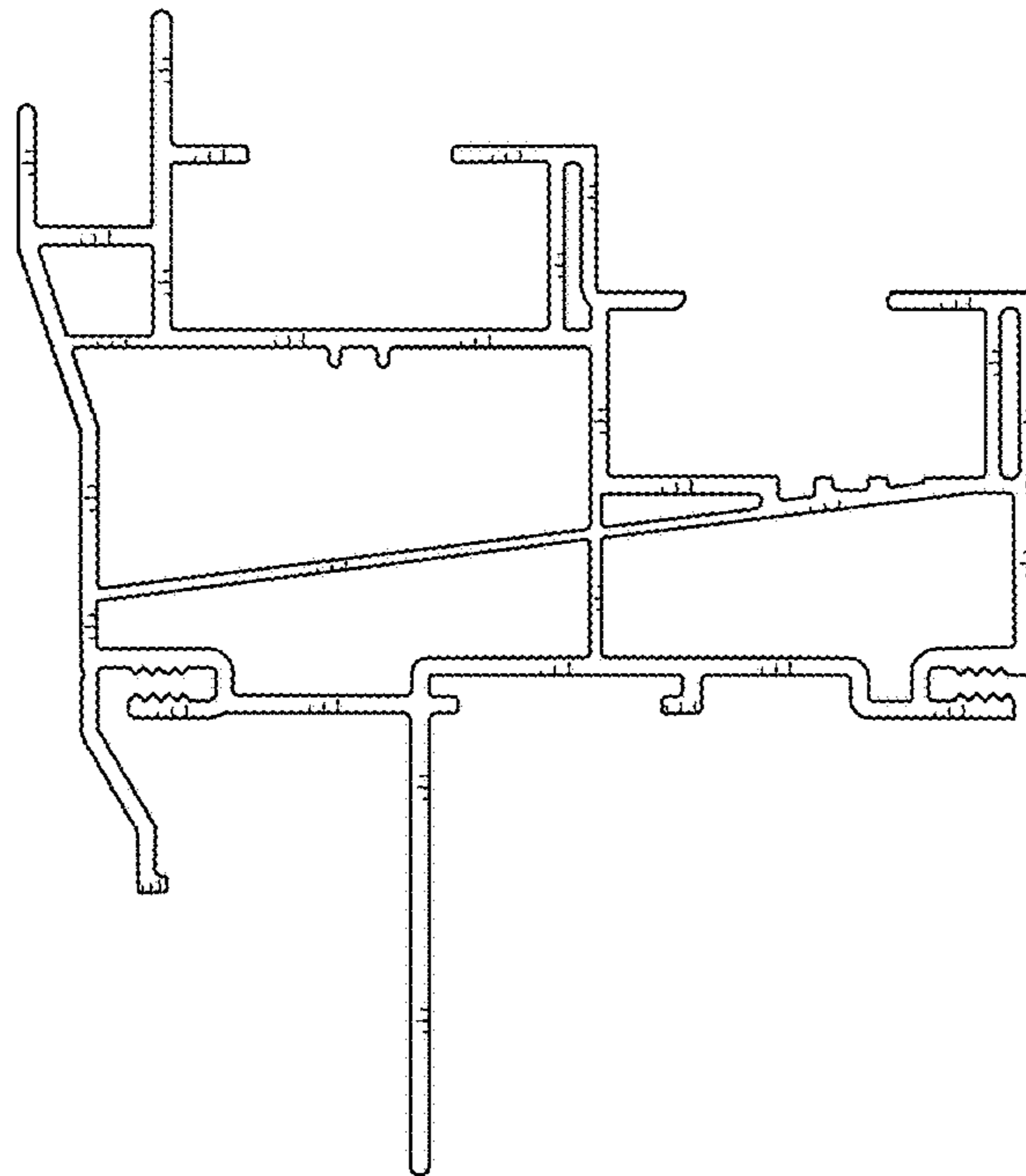

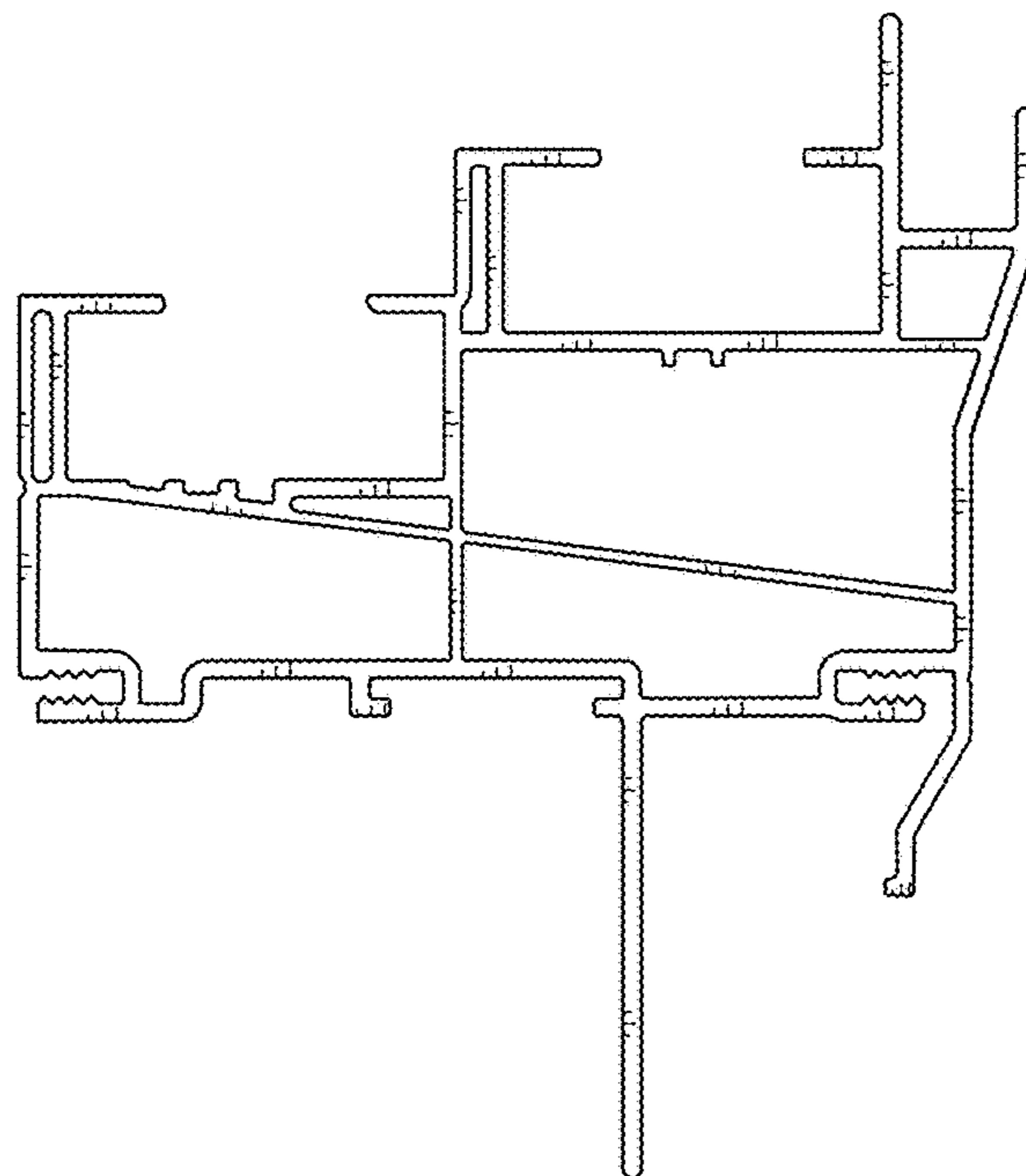

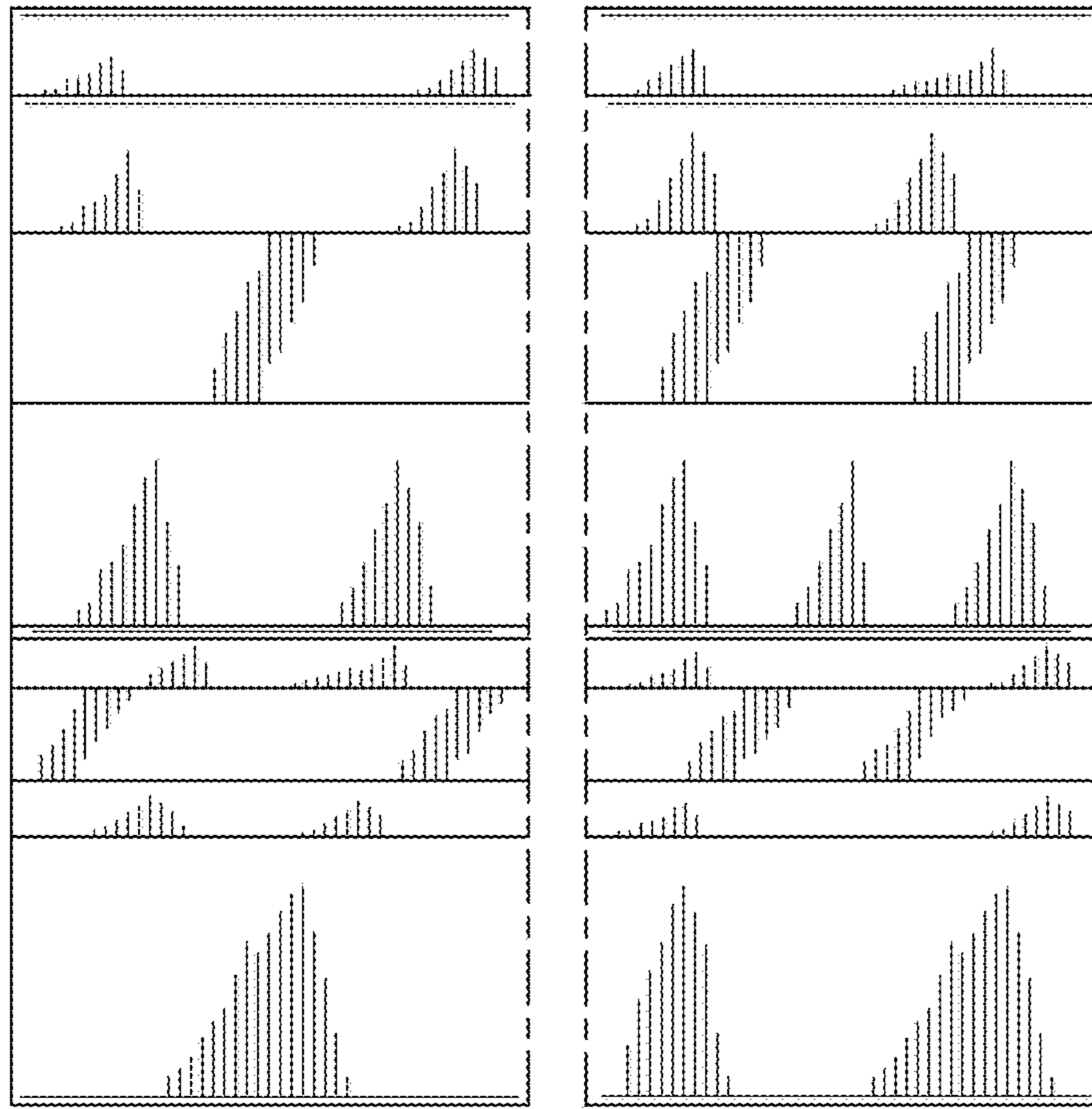

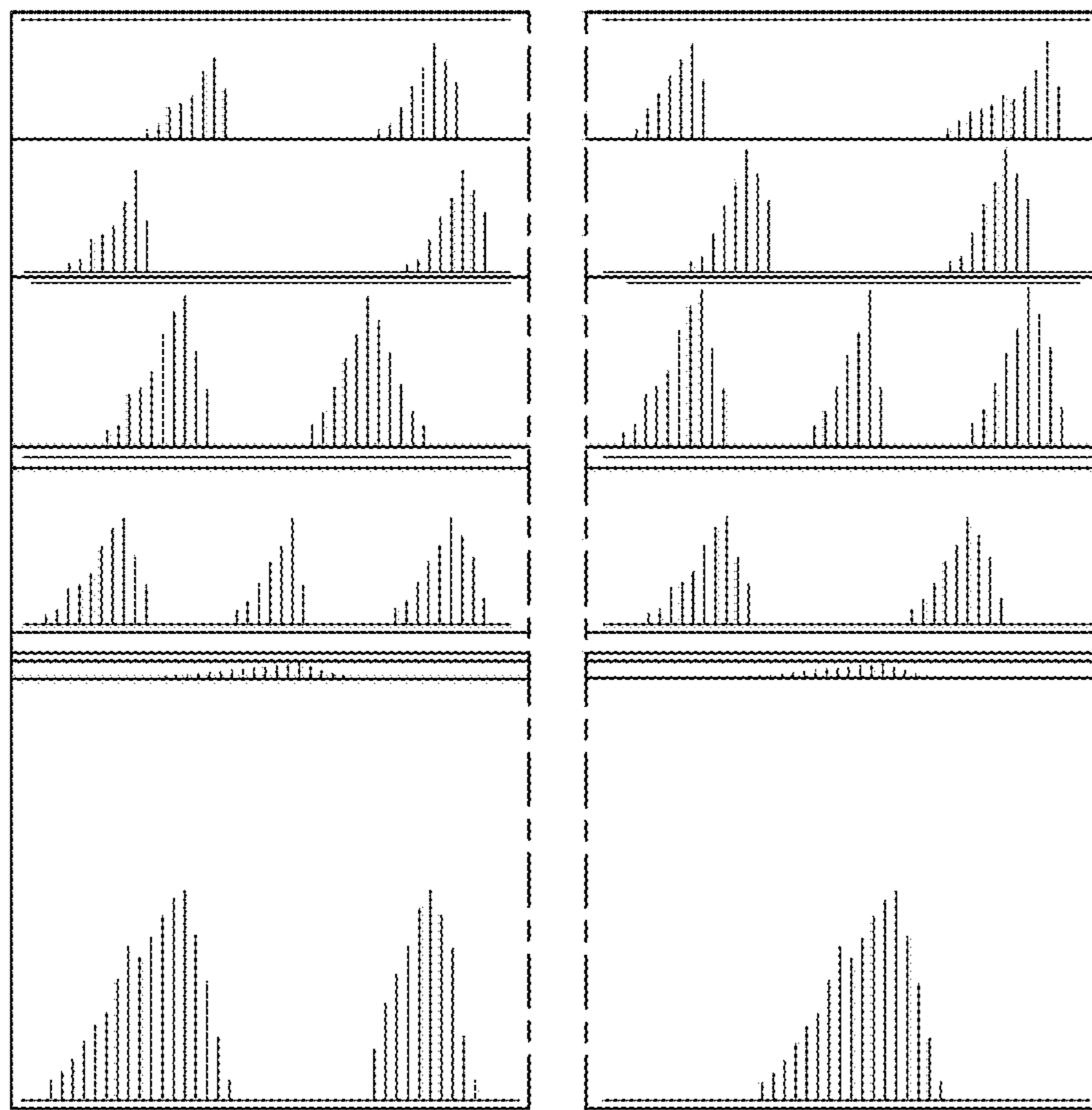

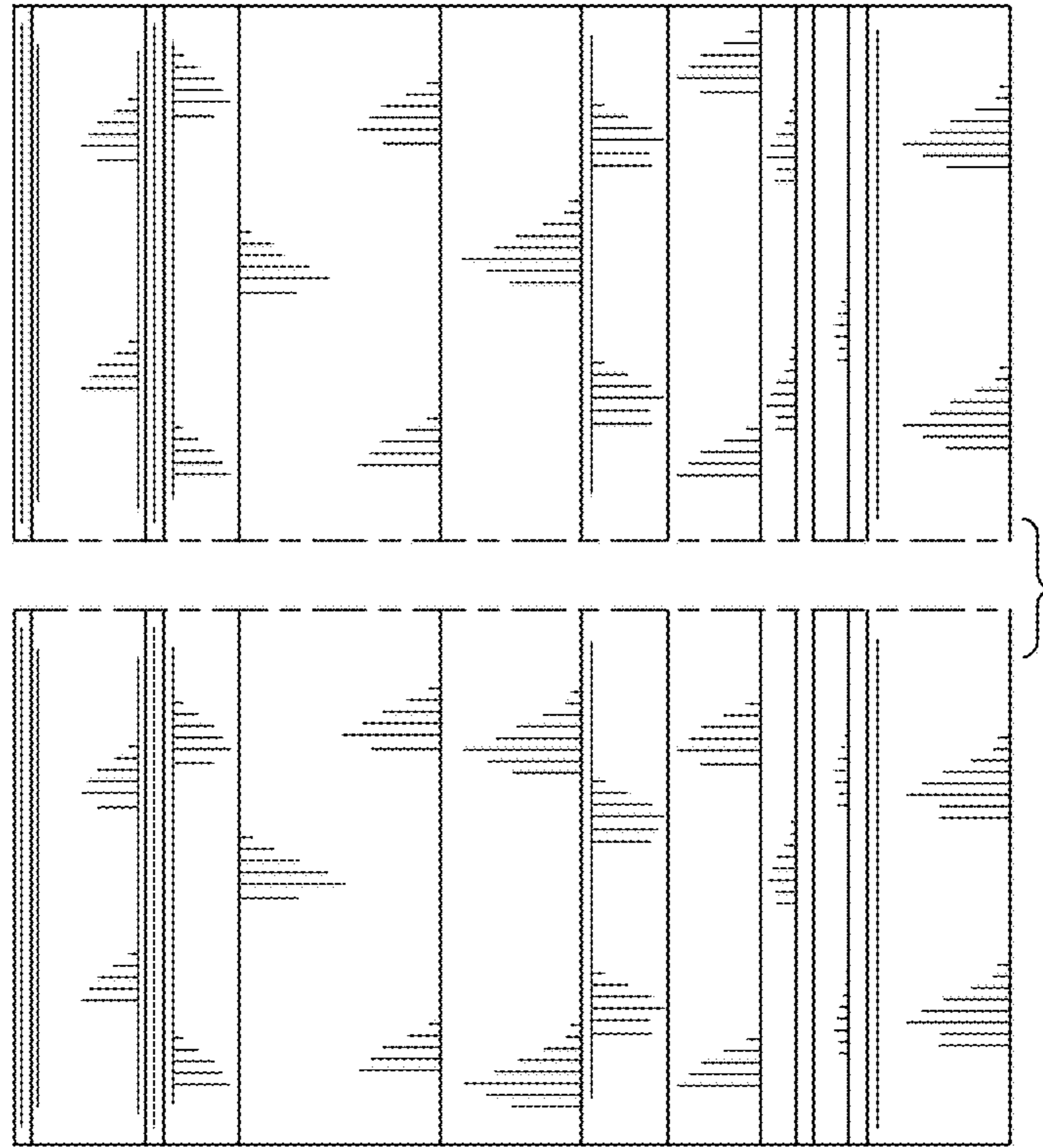

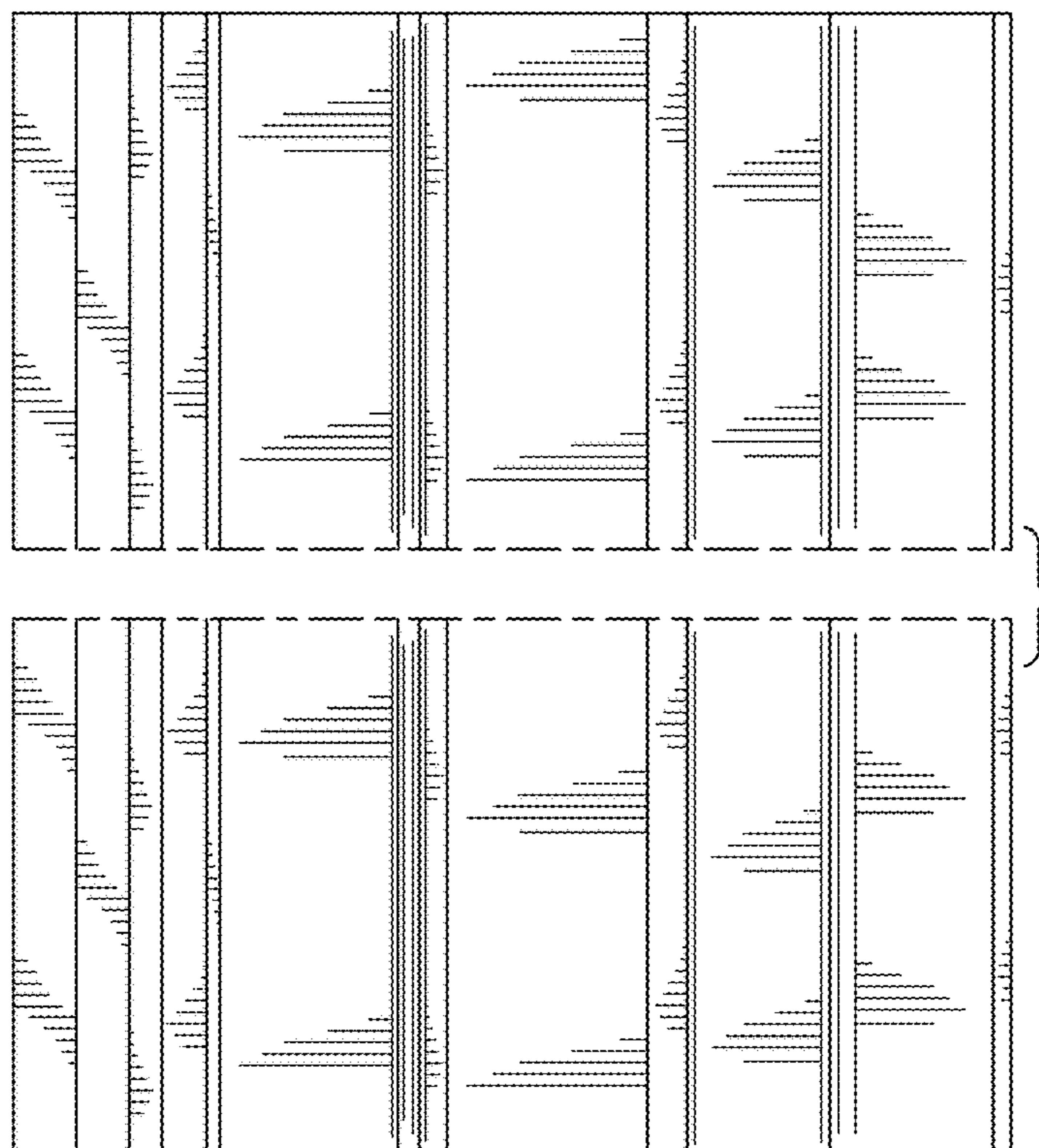
