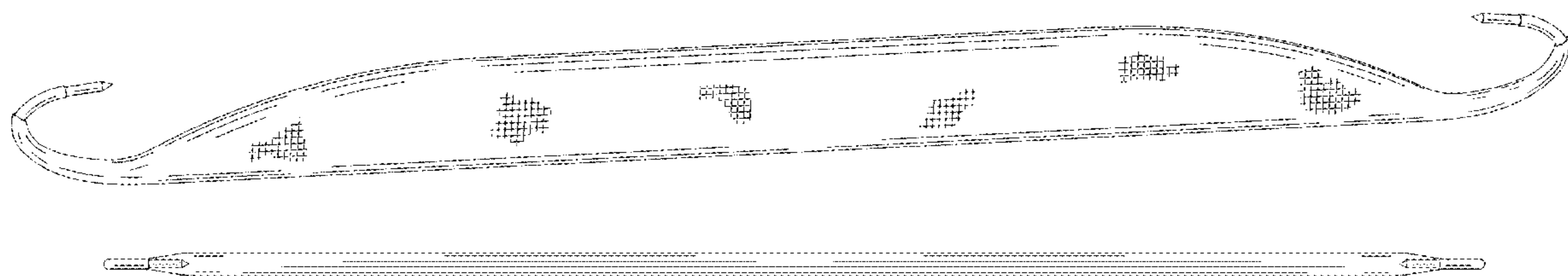
CLAIM

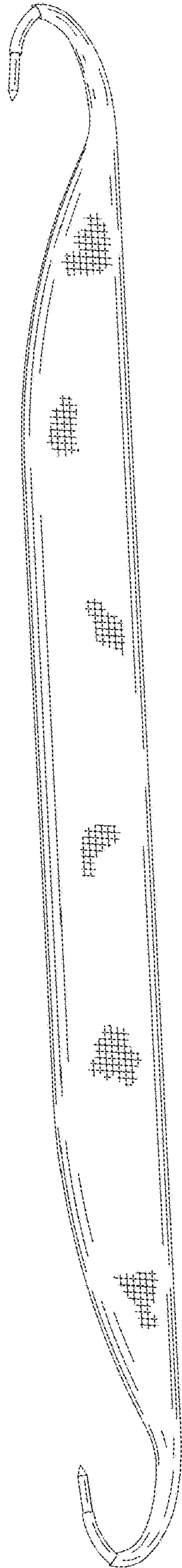

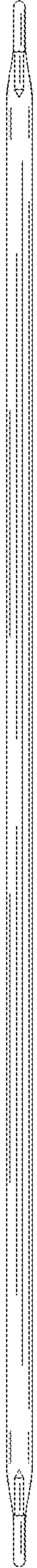

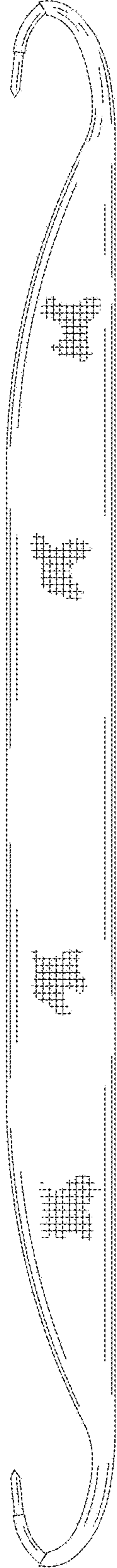

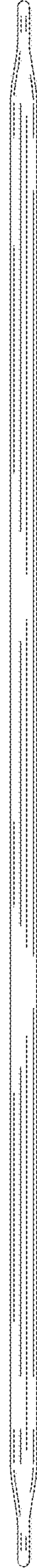

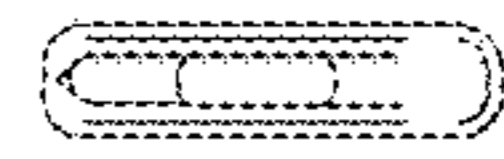
