**DESCRIPTION**

FIG. 10 is a front view thereof.

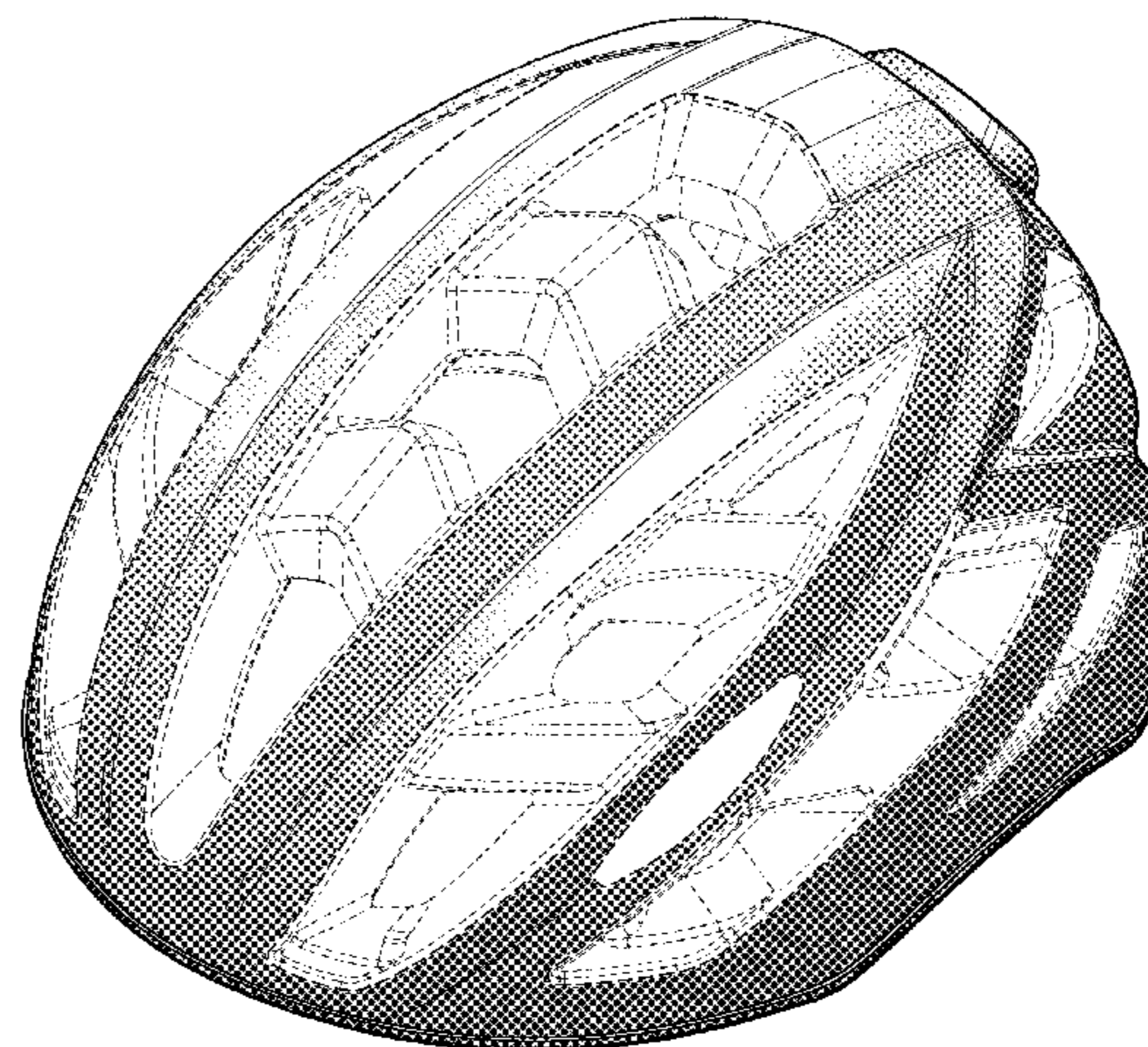
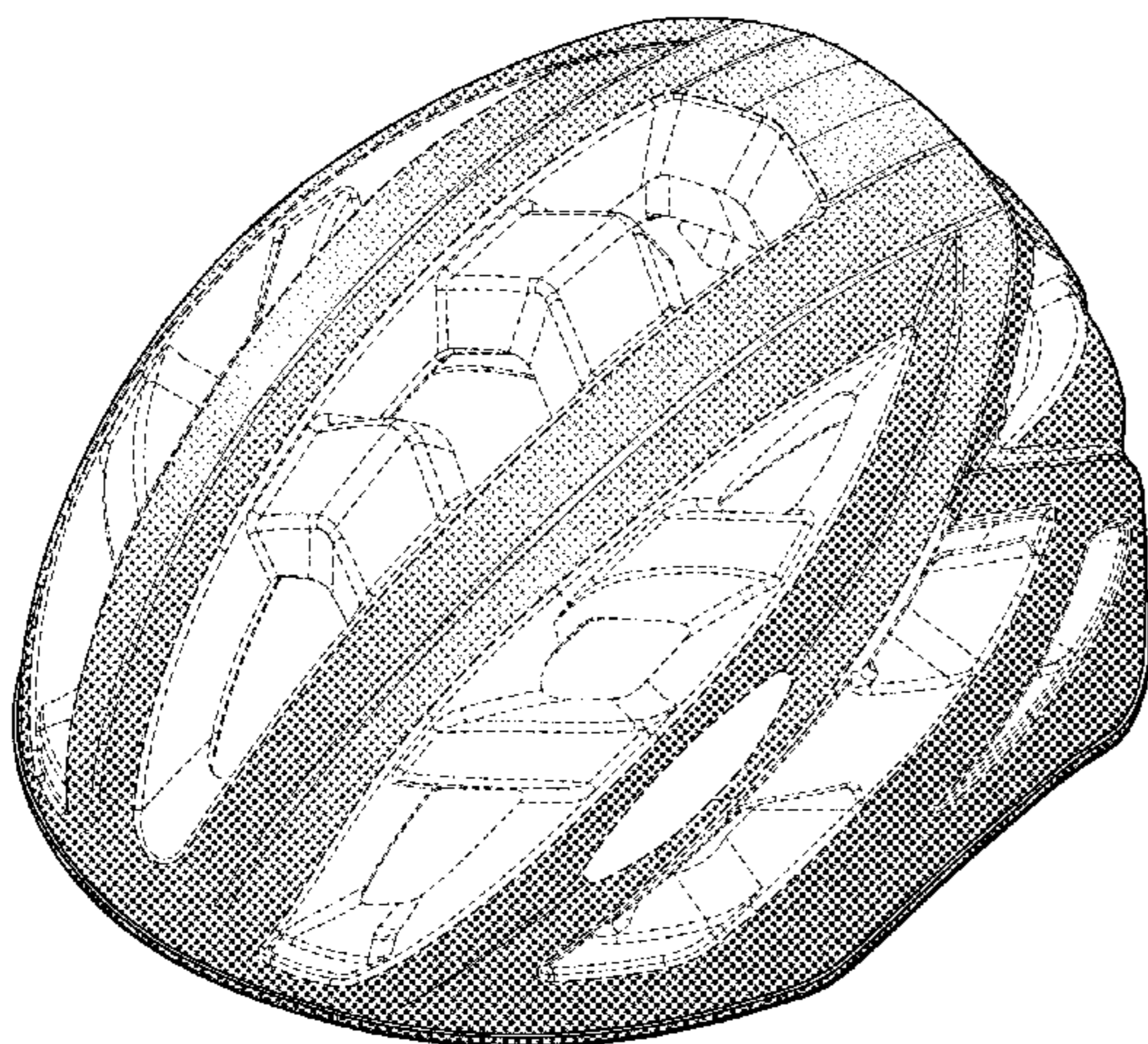
FIG. 11 is a back view thereof.

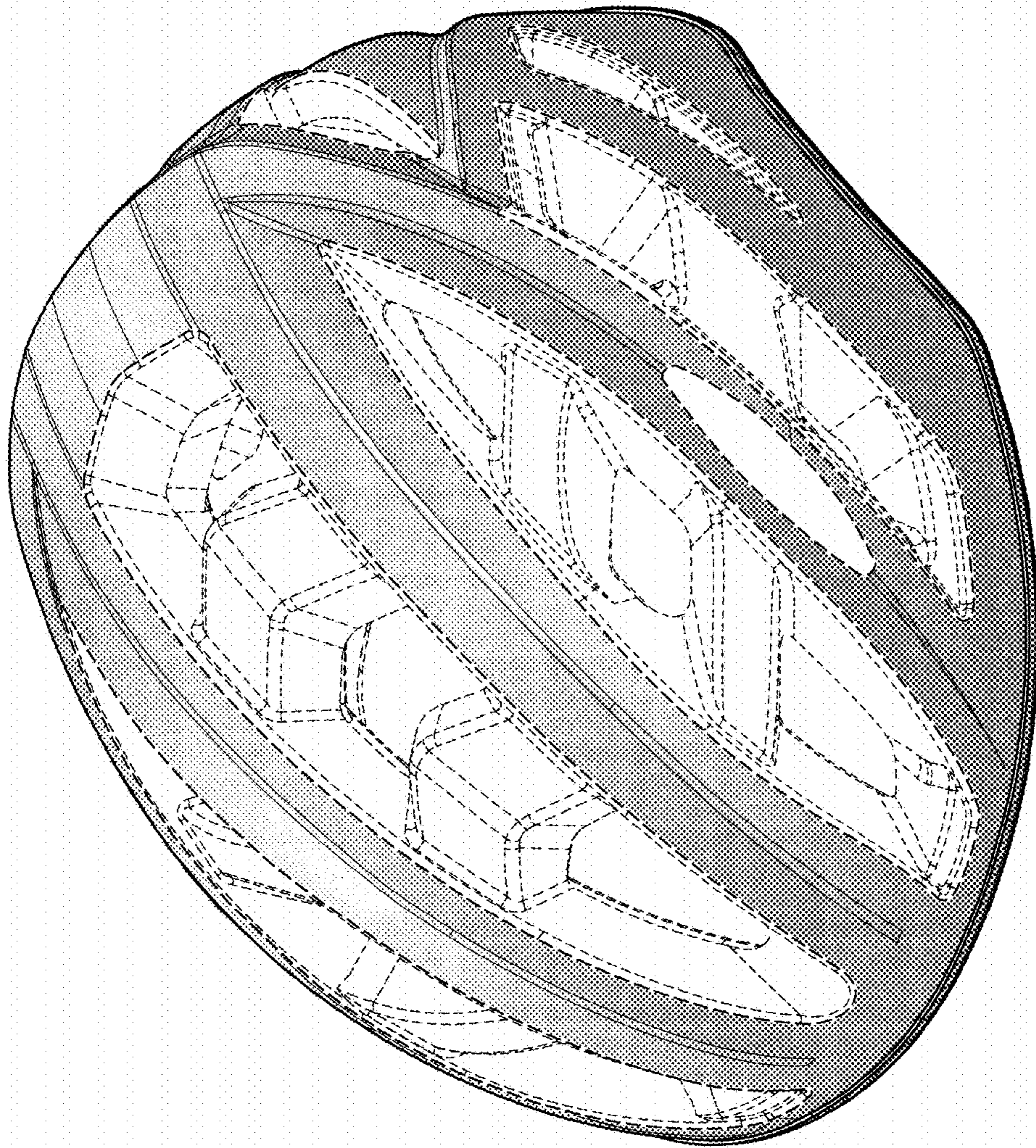

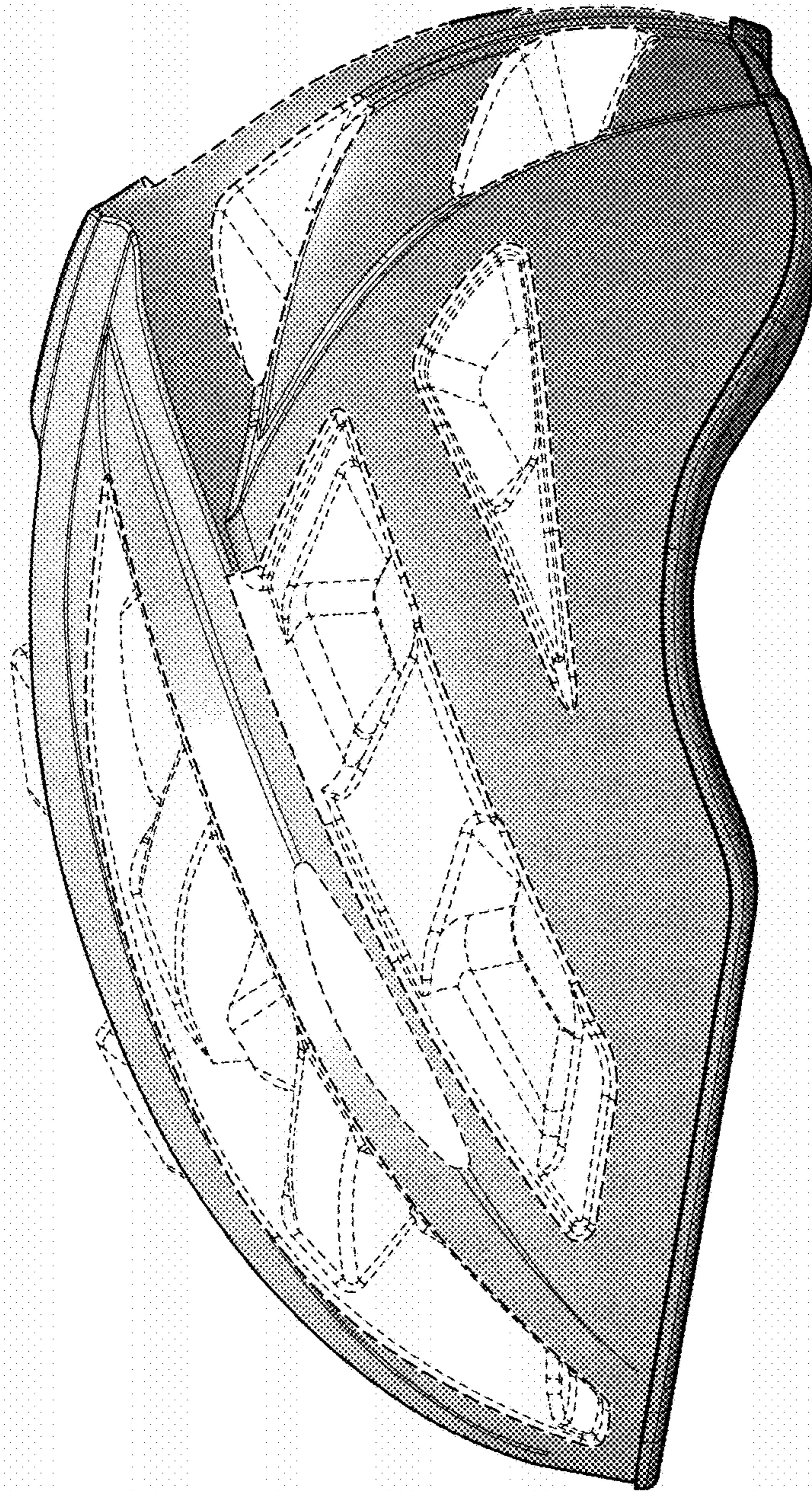

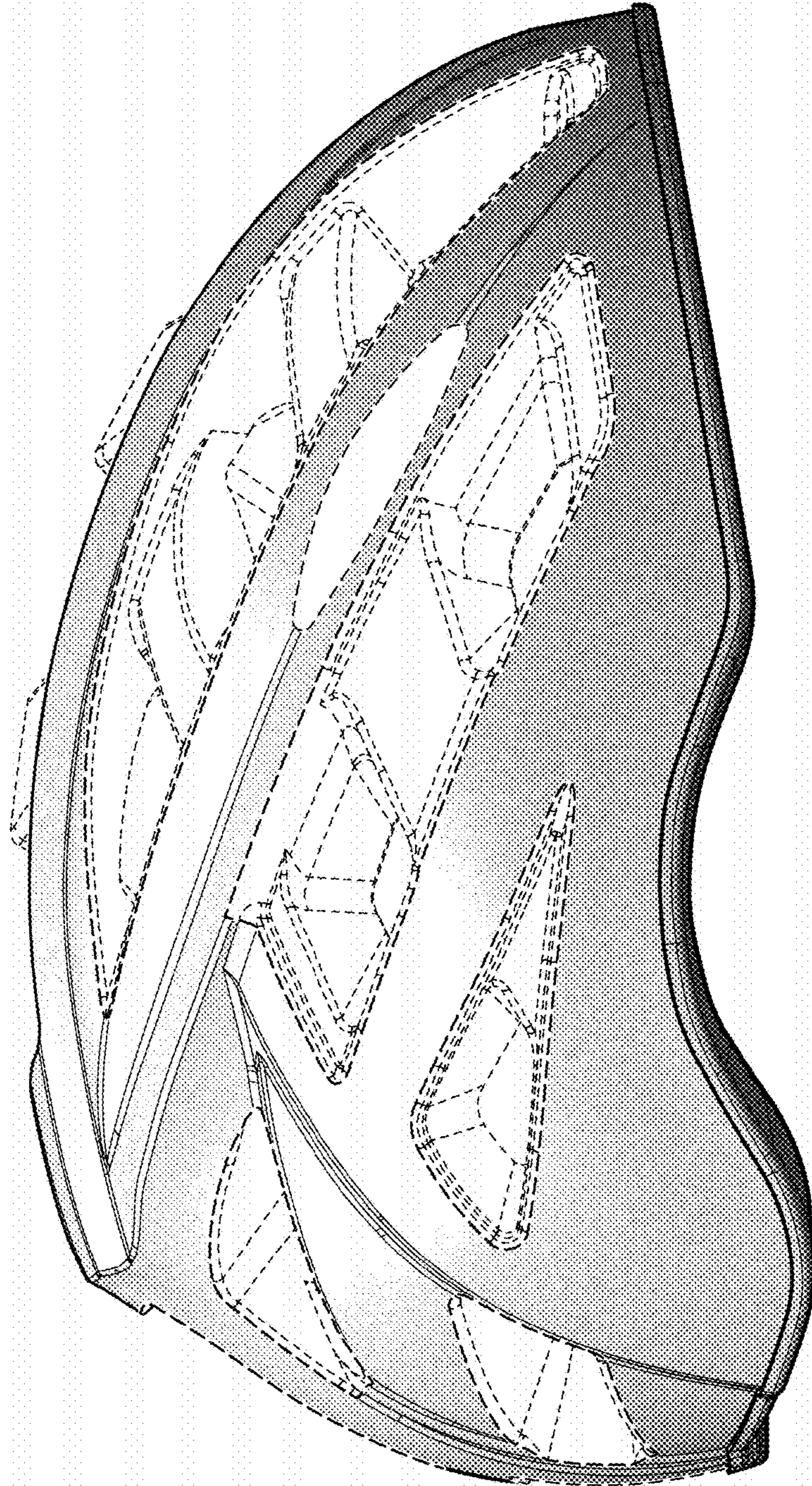

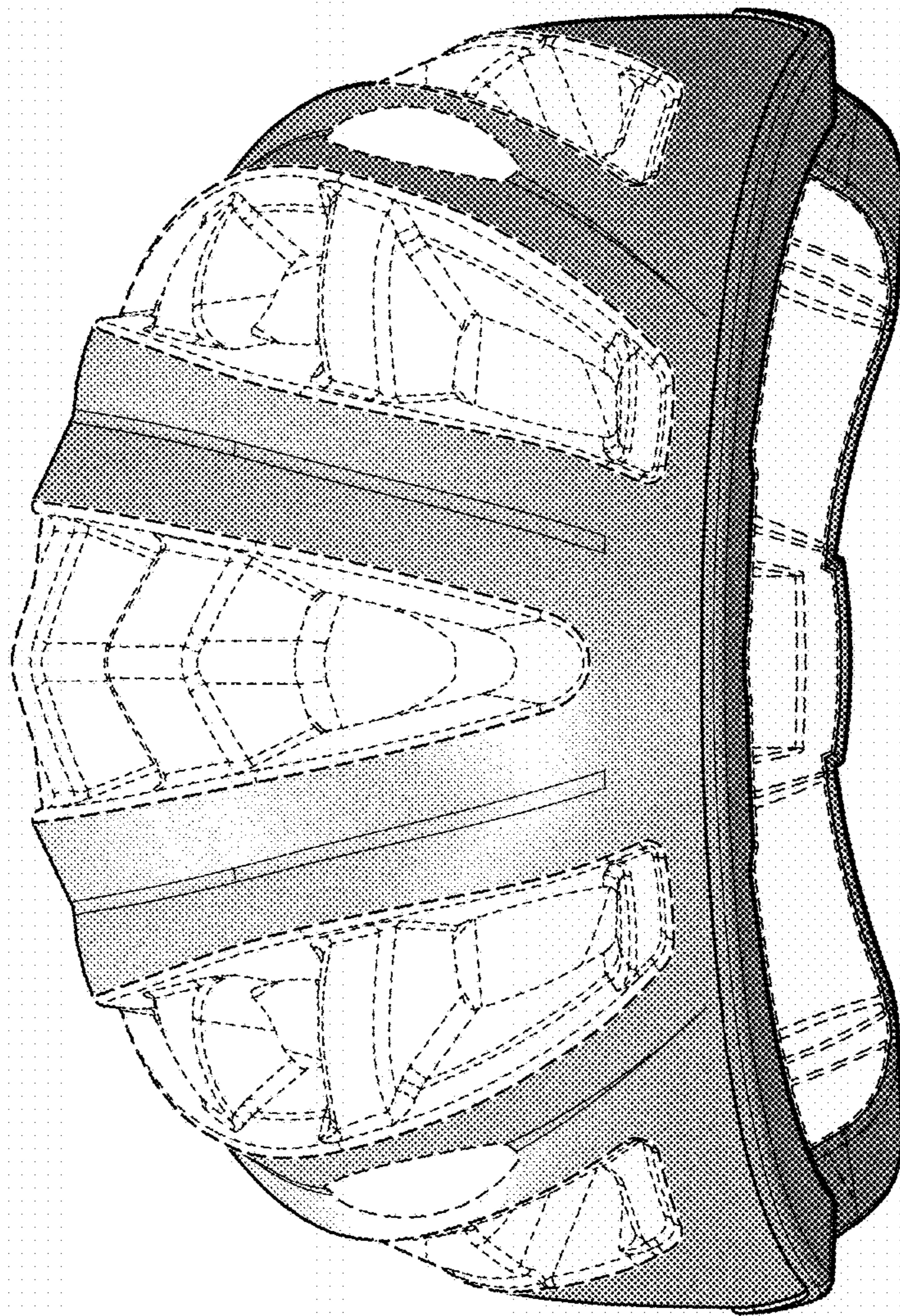

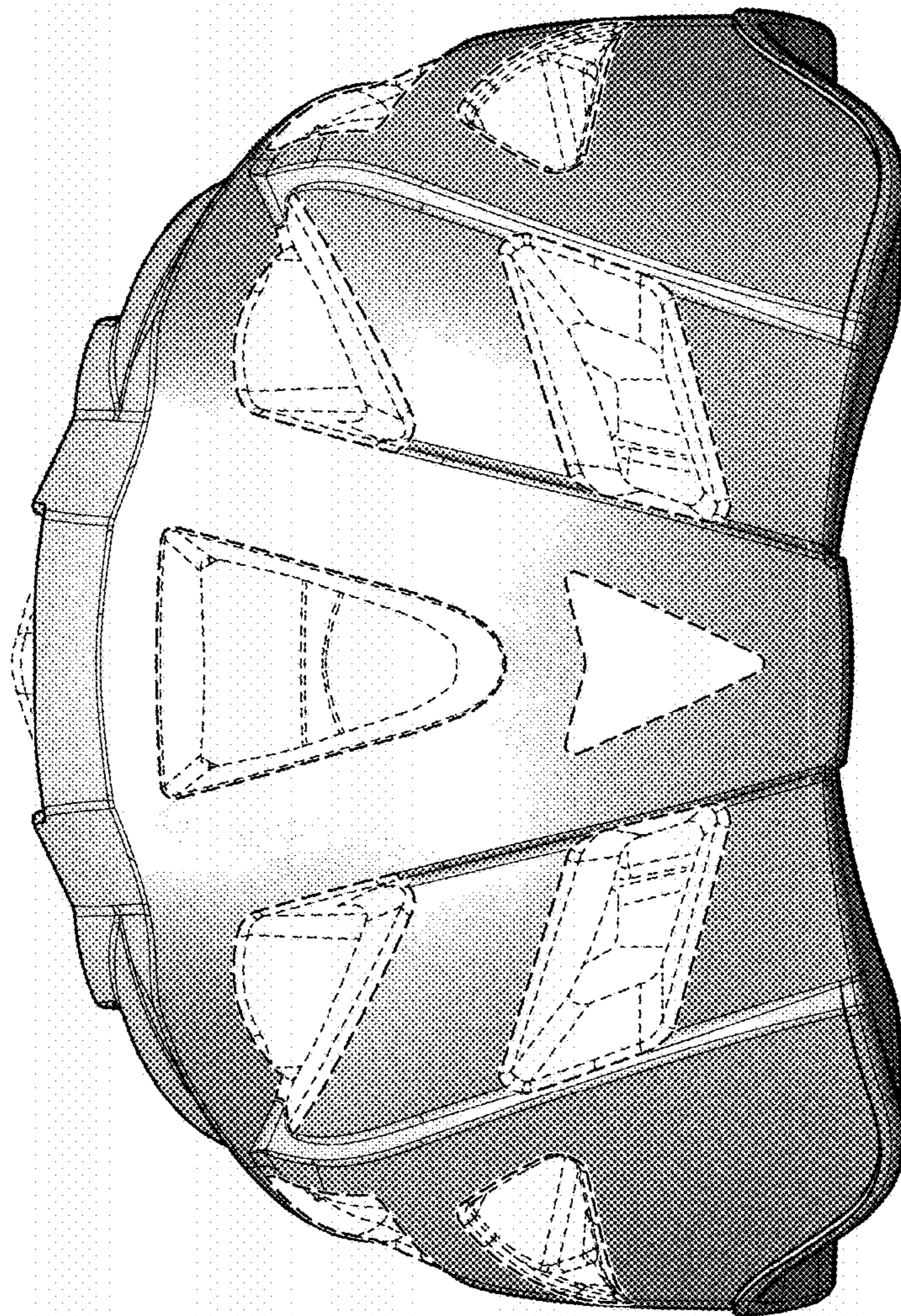

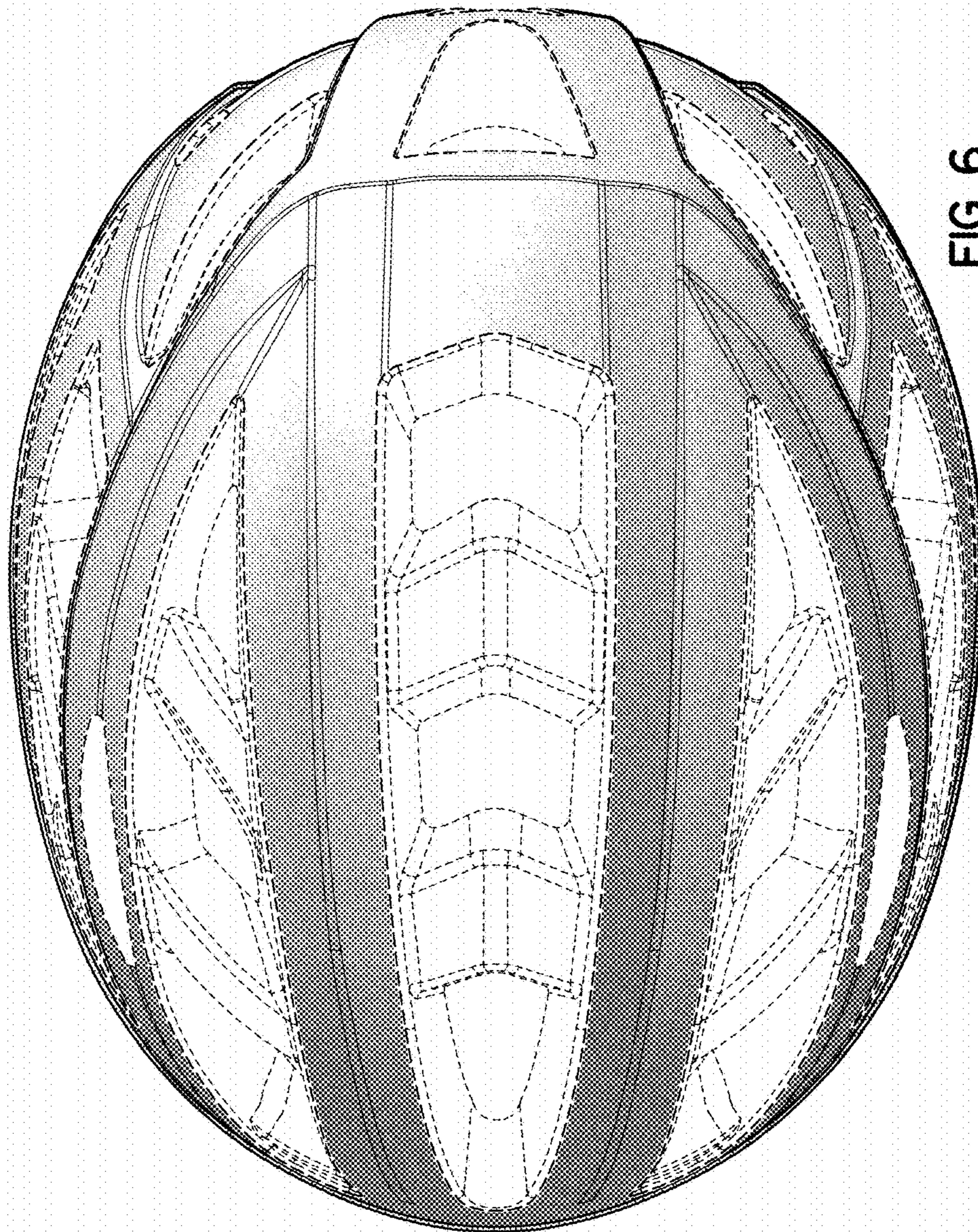

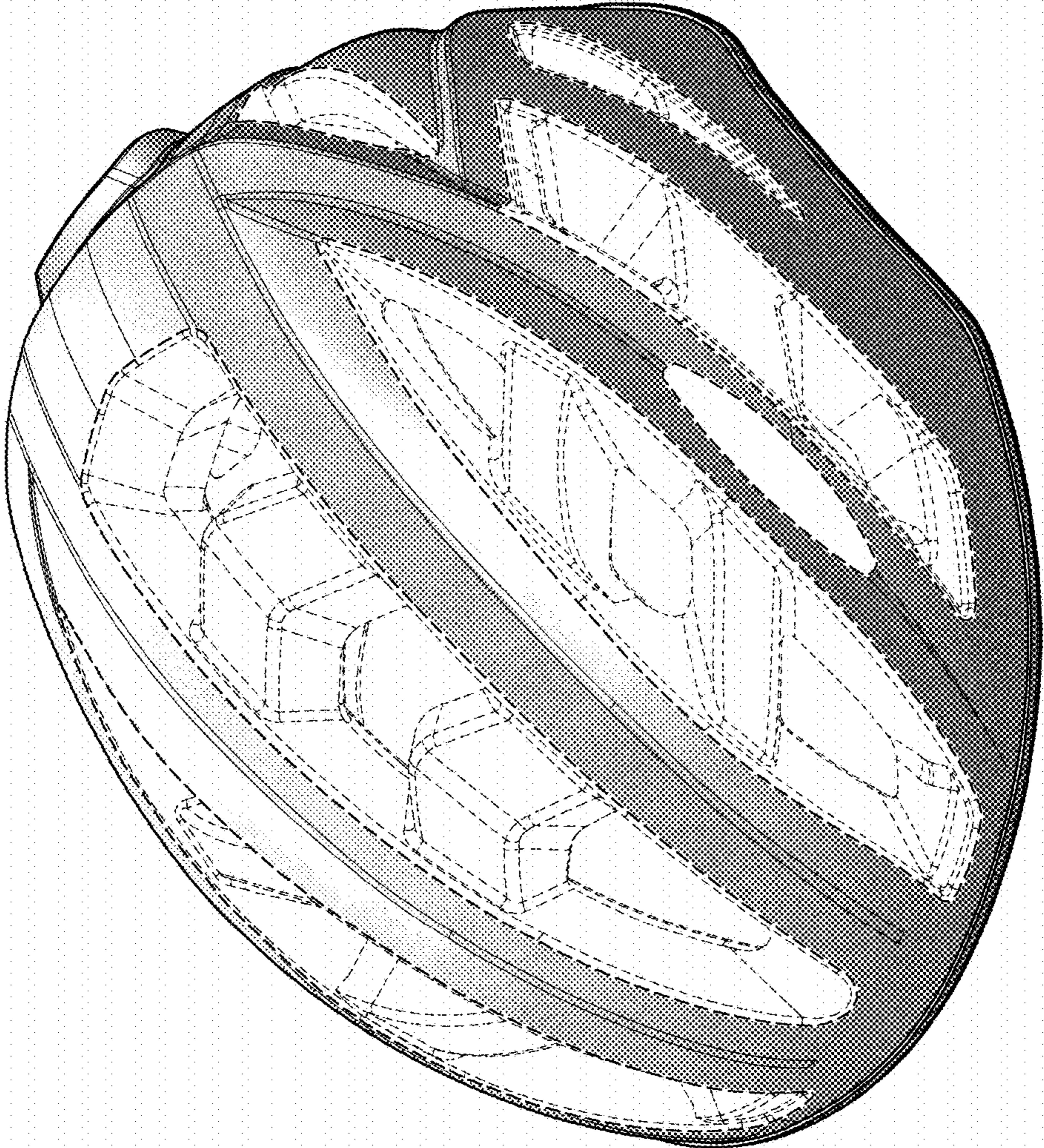

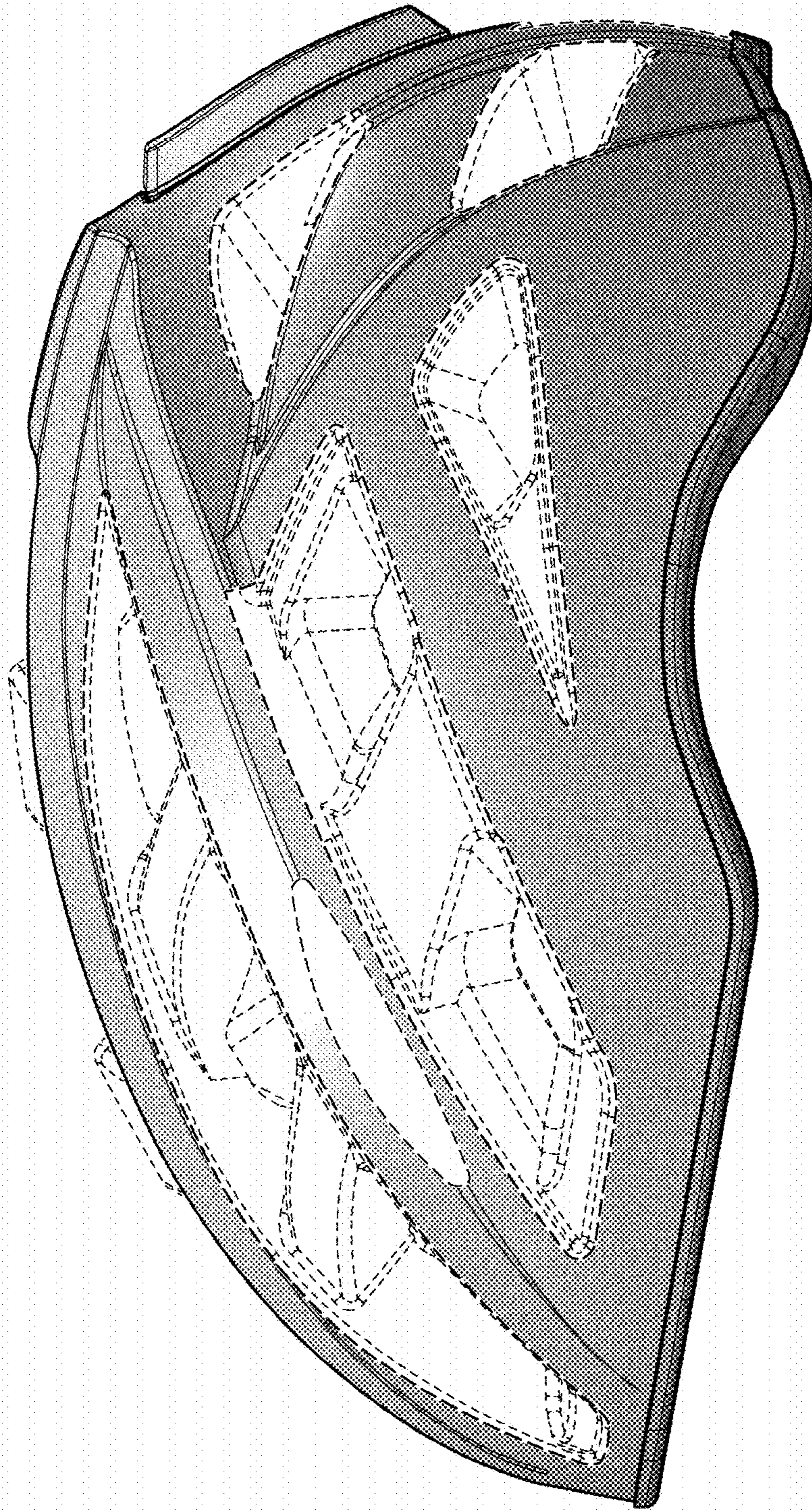

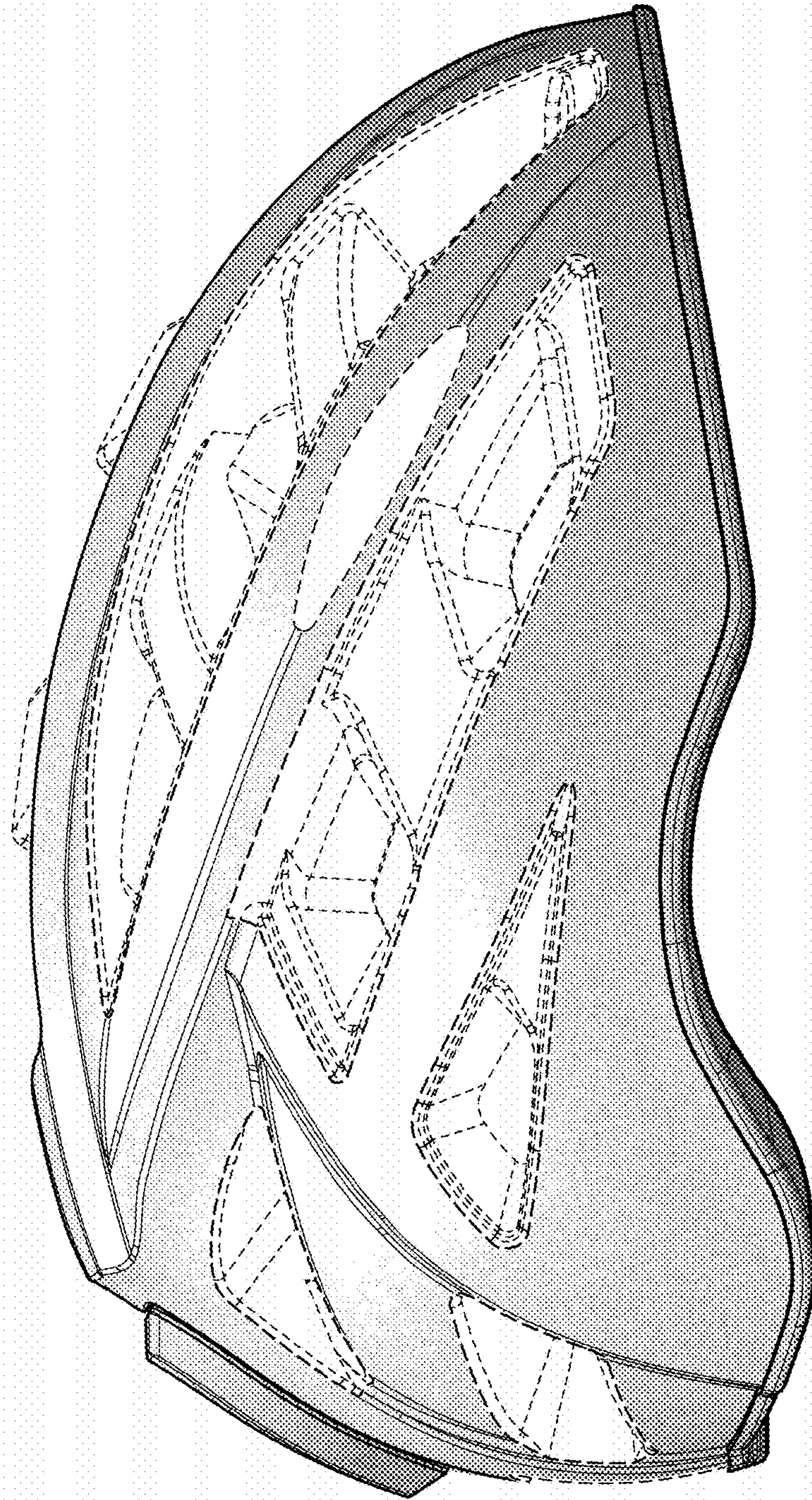

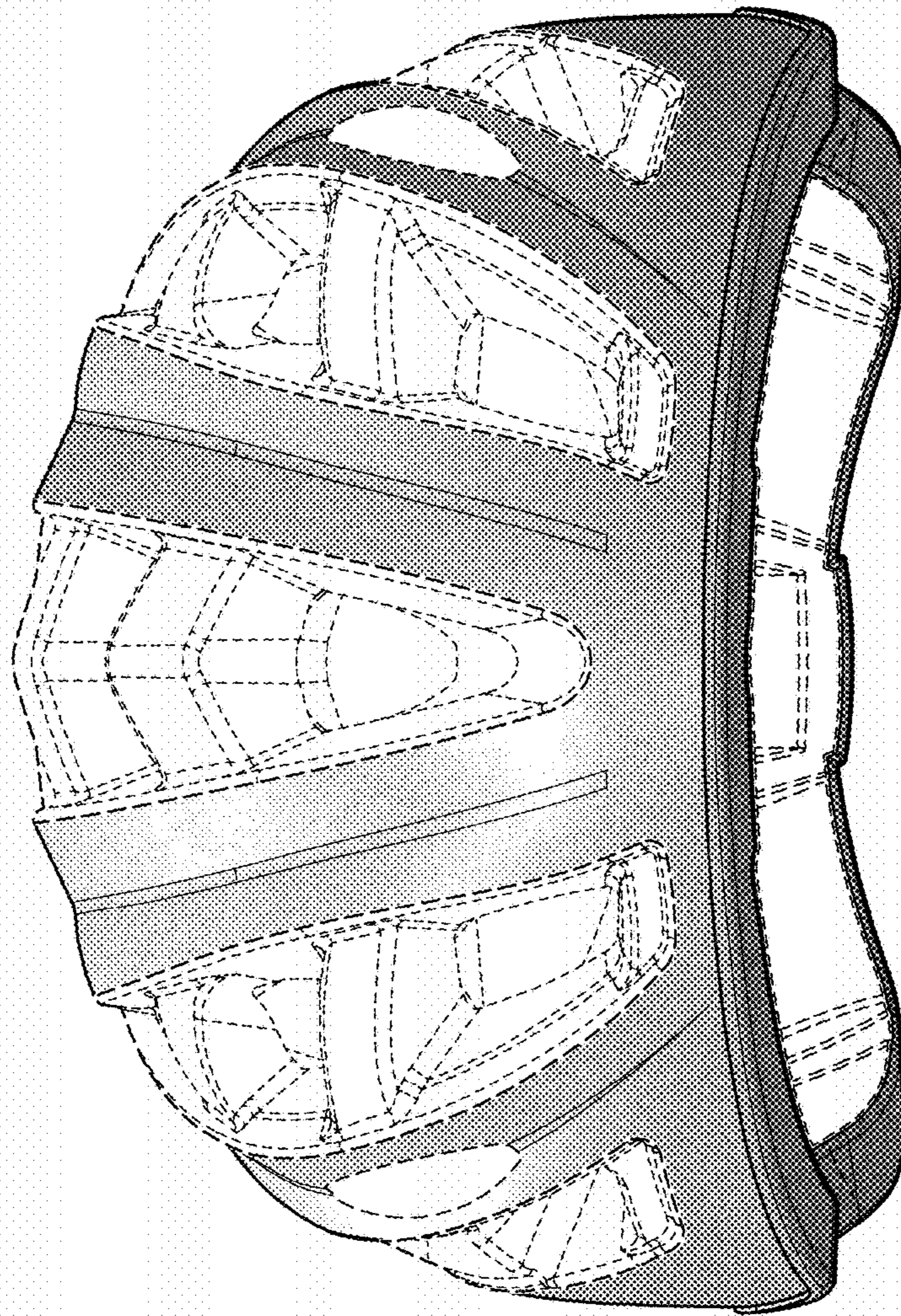

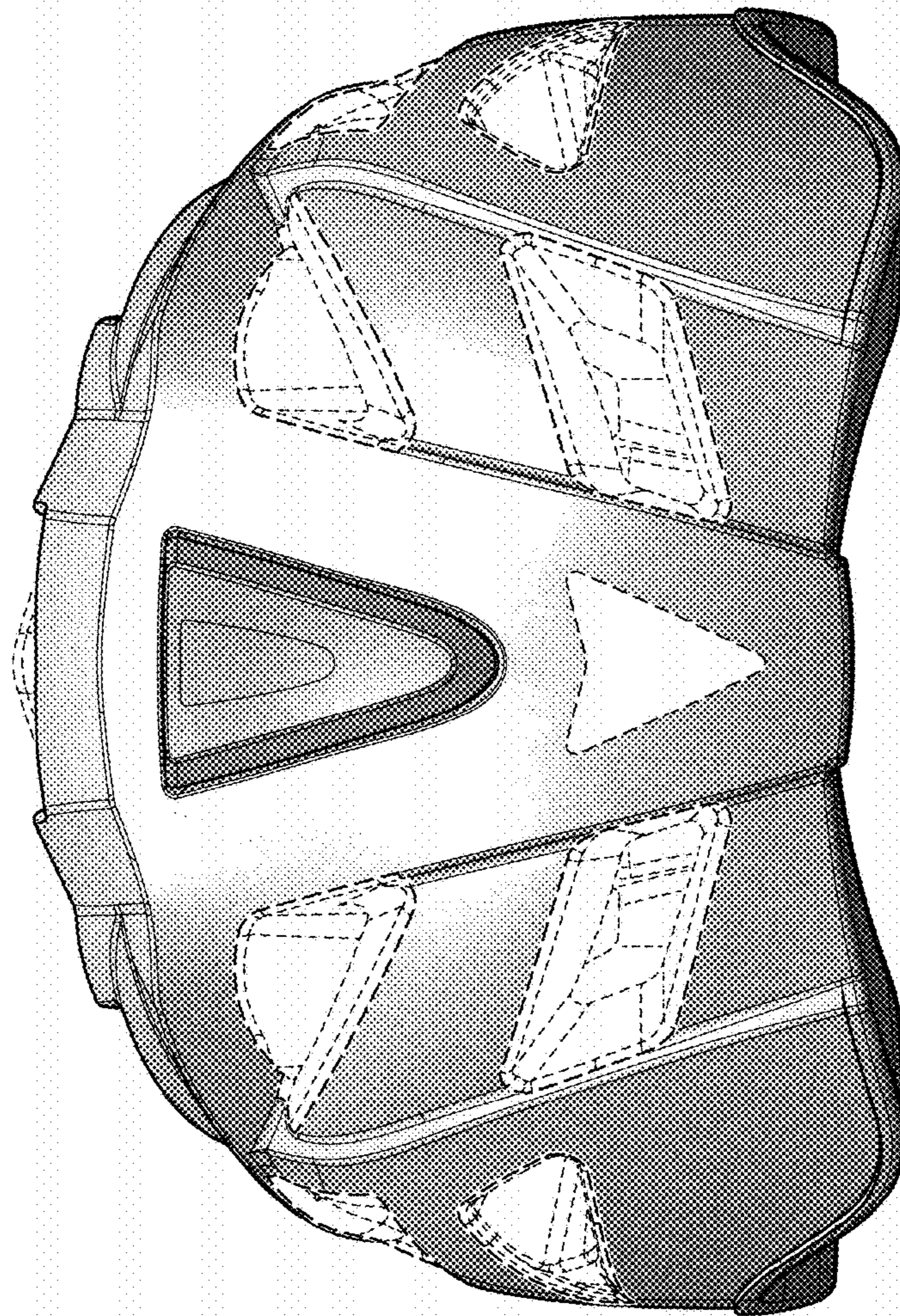

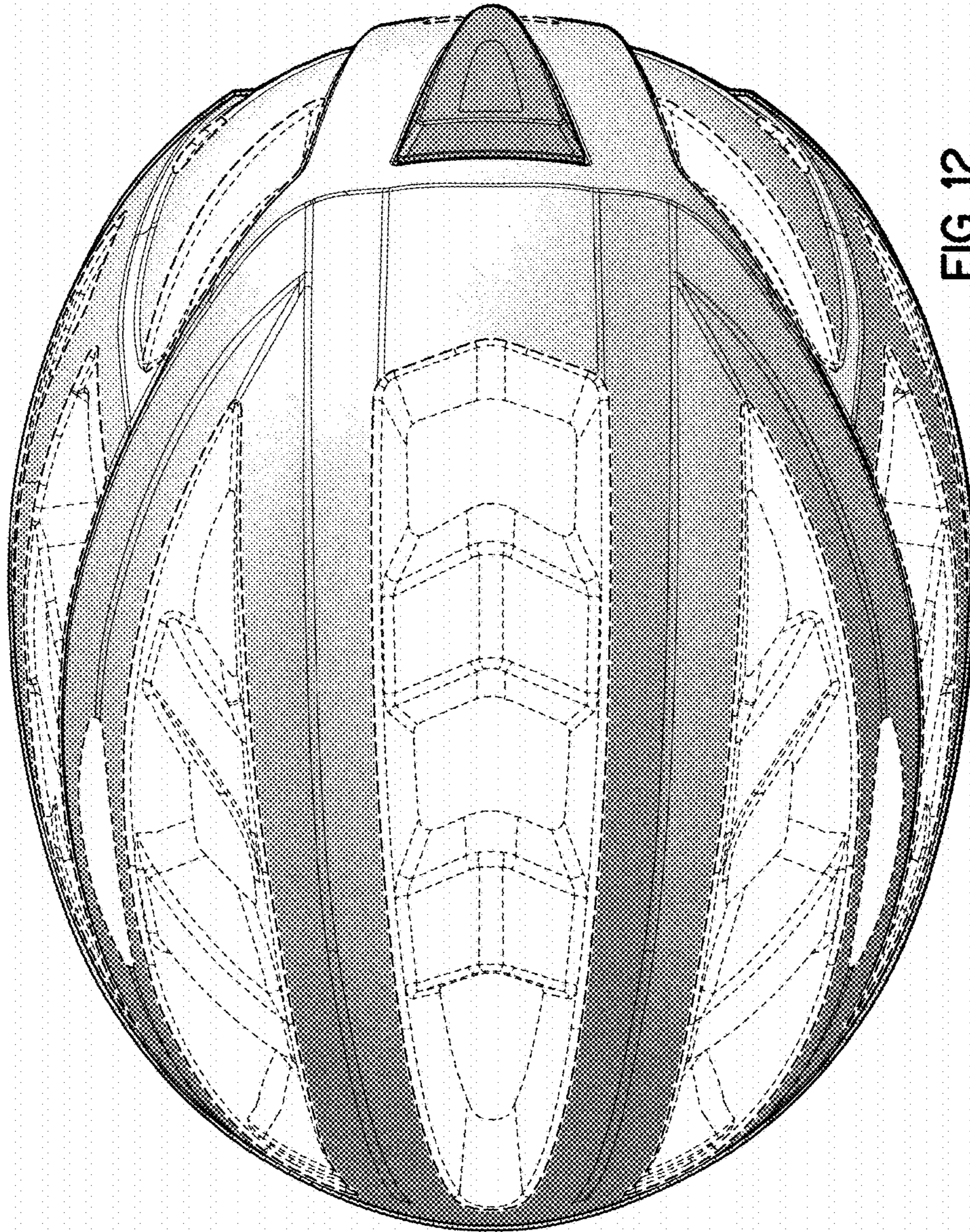

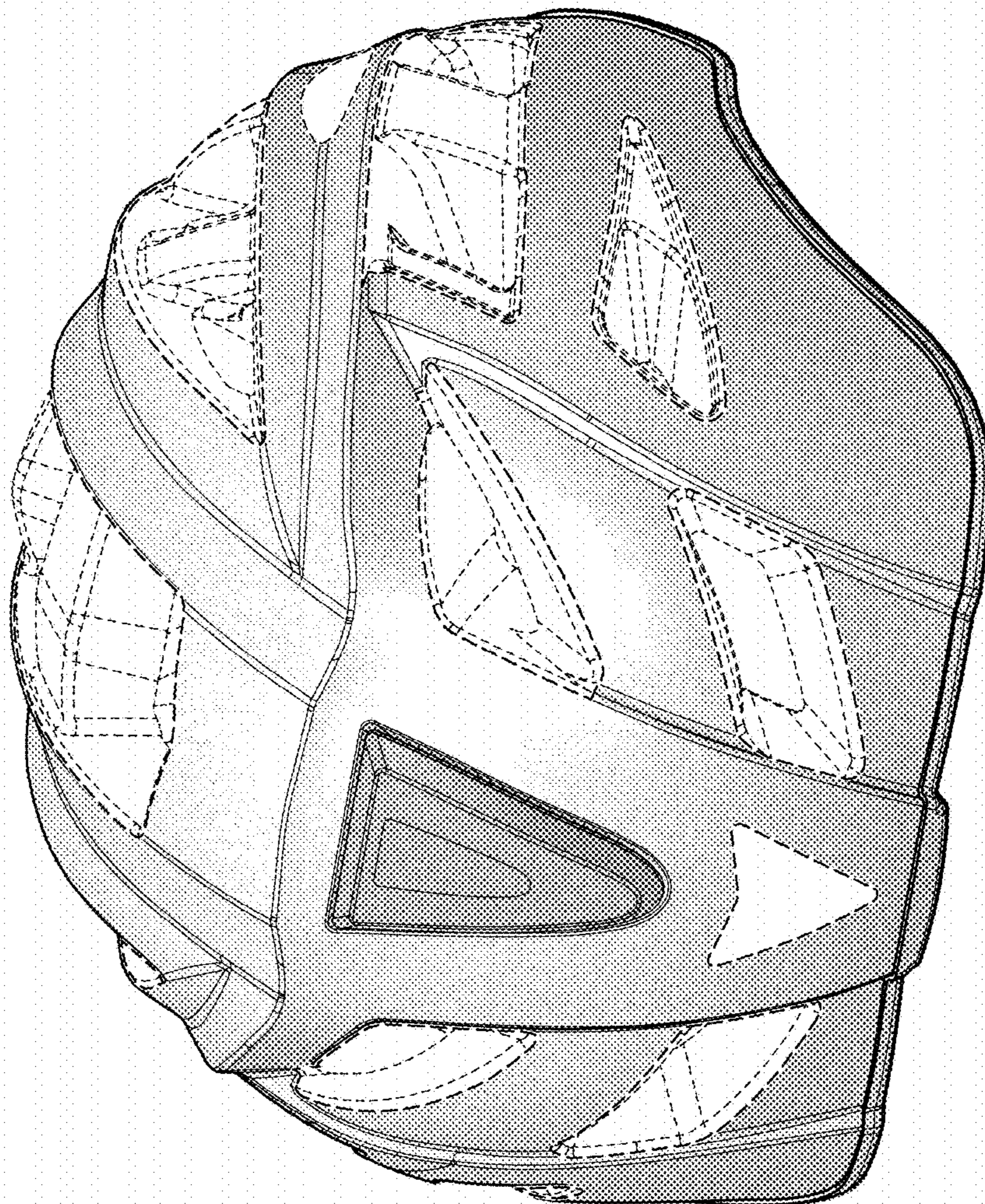
