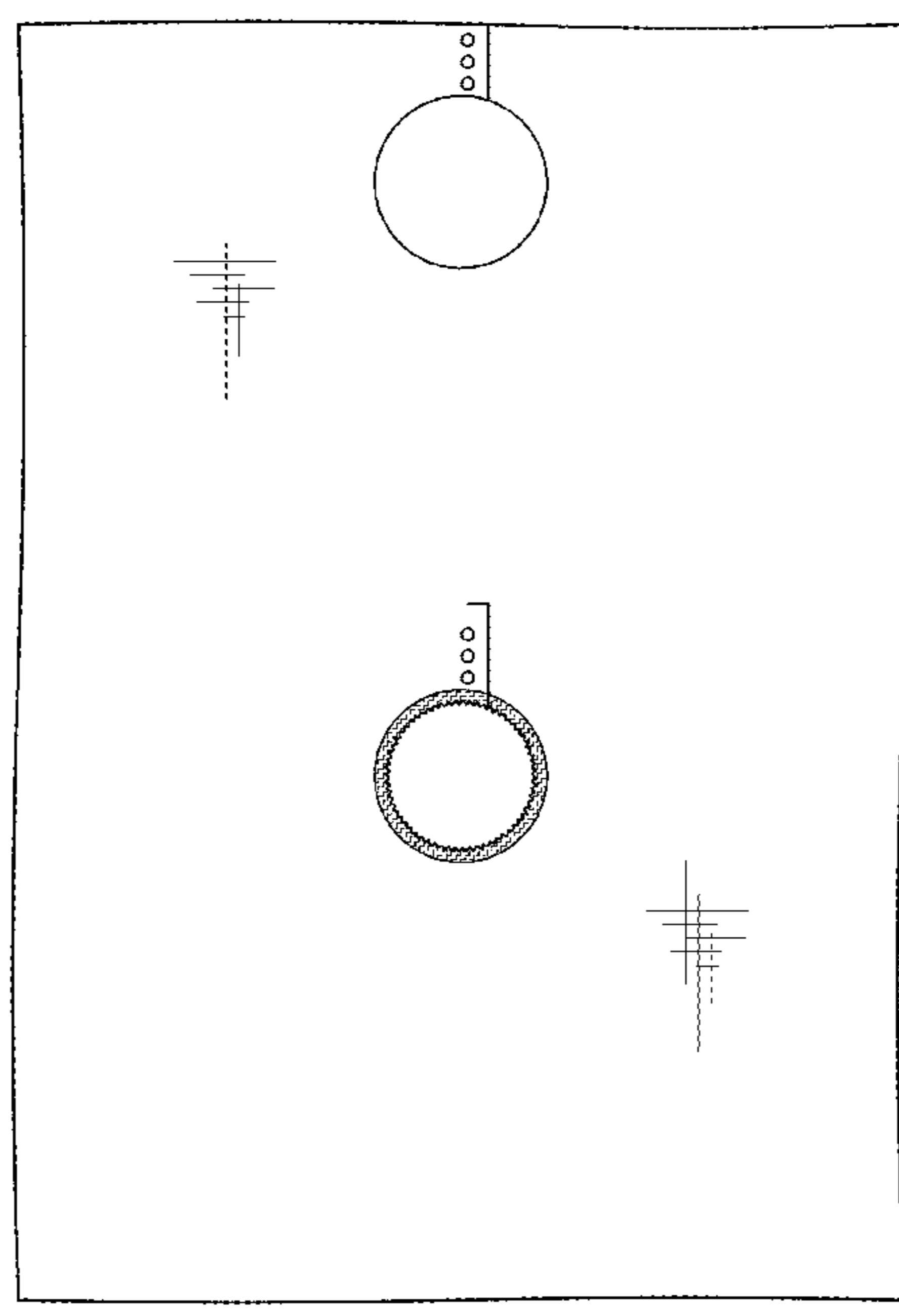

DESCRIPTION

FIG. 1 is a front view of a parent-child hairdresser cape showing my new design;
FIG. 2 is a rear view of the parent-child hairdresser cape;
FIG. 3 is a left side view of the parent-child hairdresser cape, a right side view being a mirror image thereof;

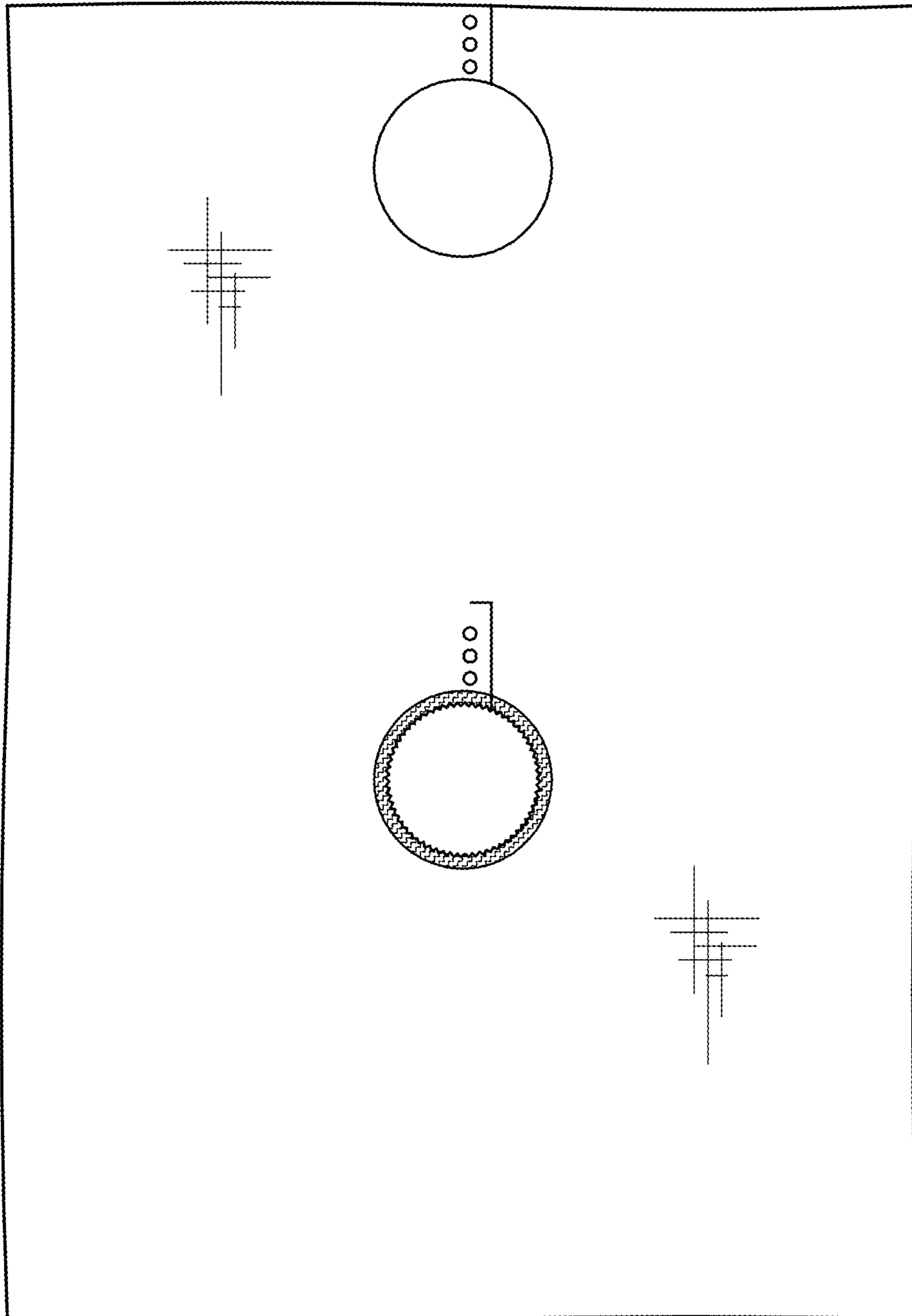

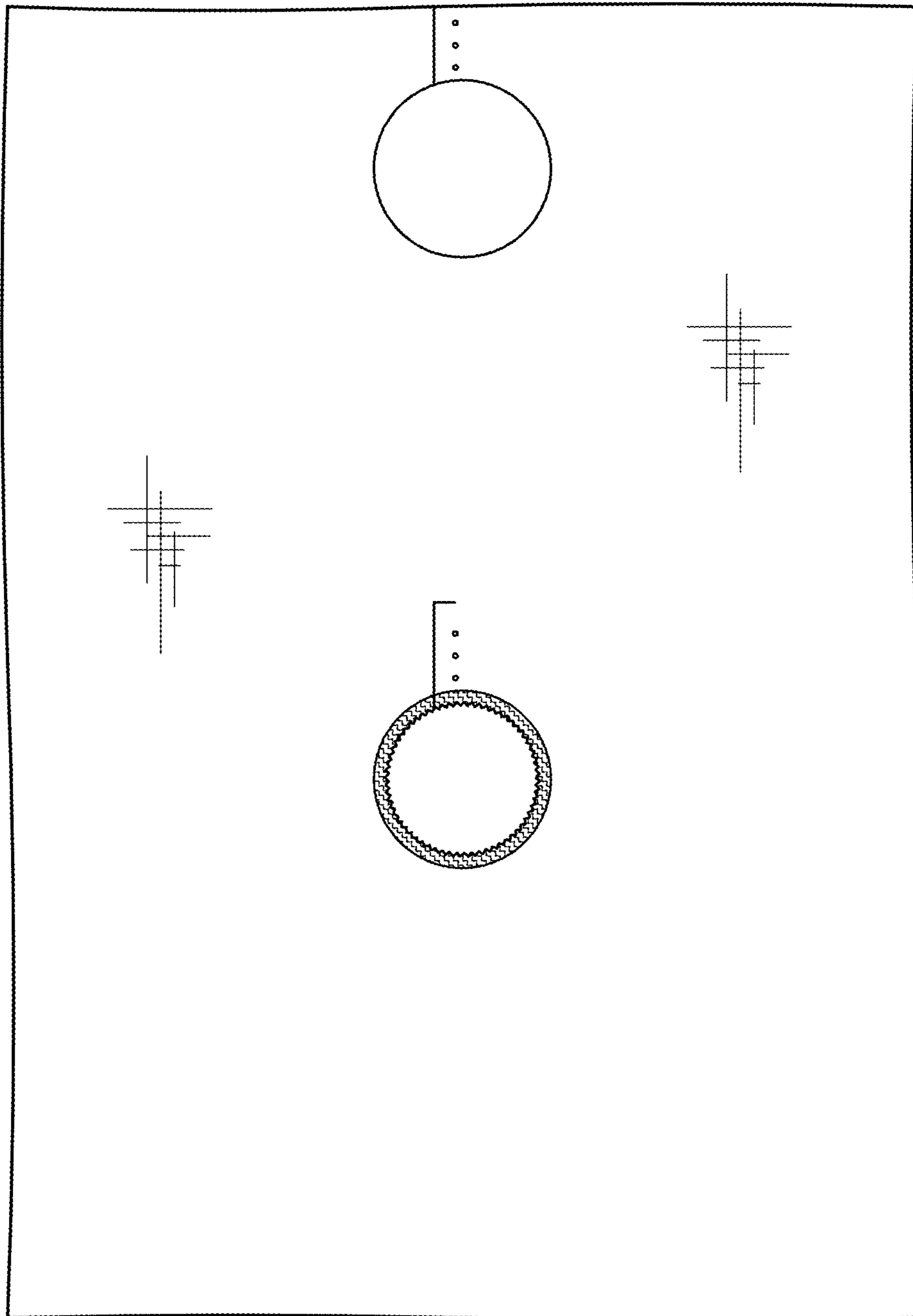
