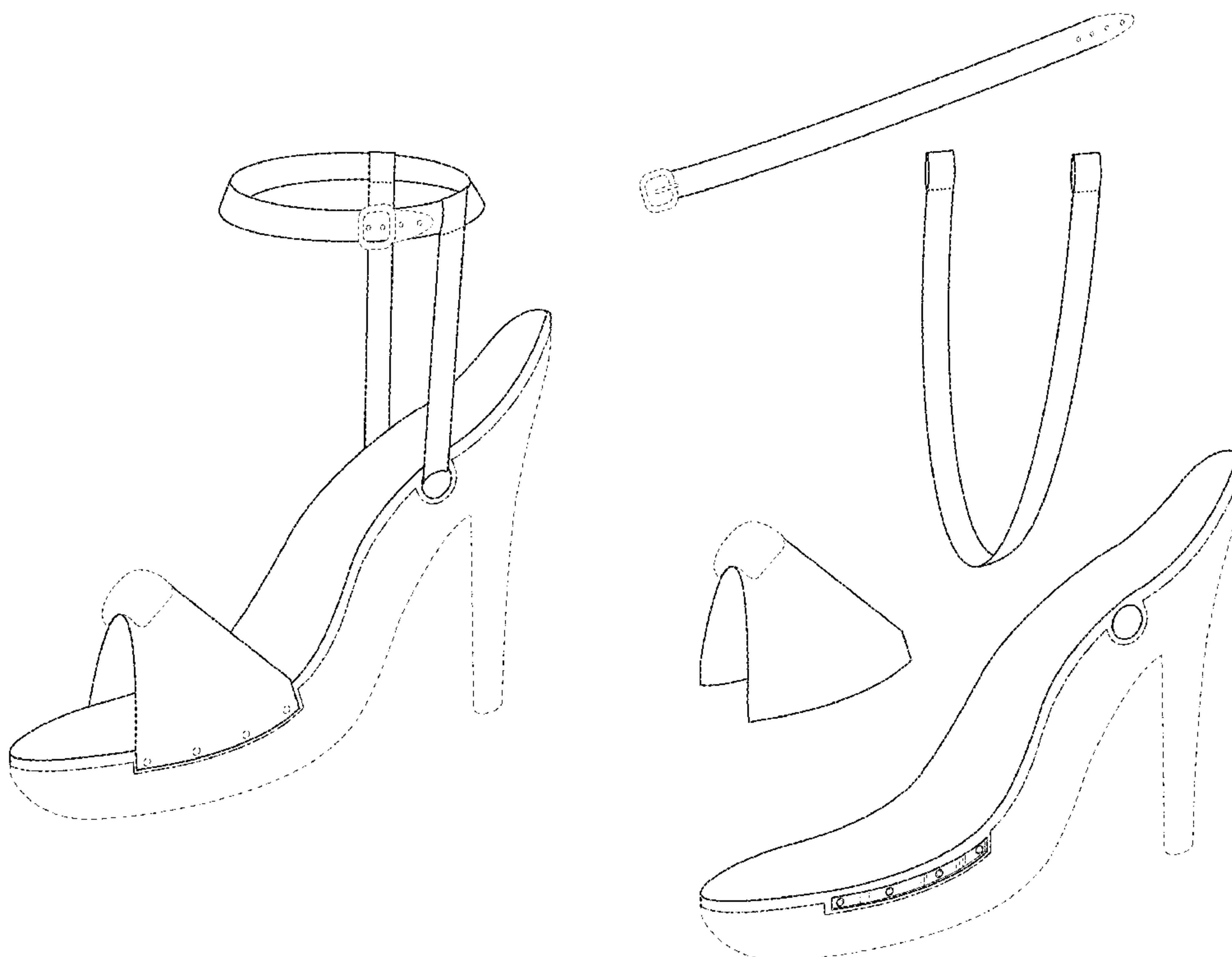
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the interchangeable shoe showing my new design;

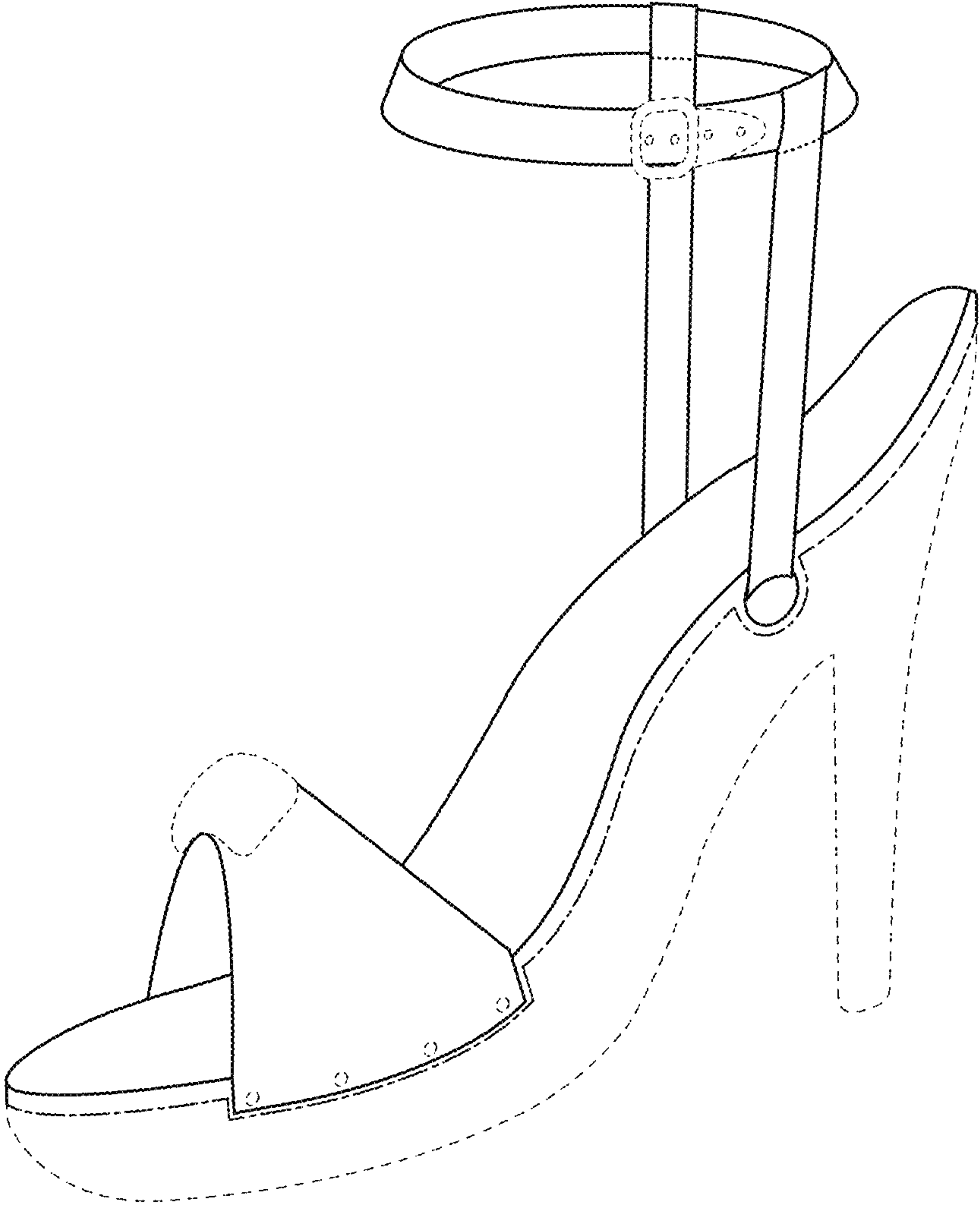

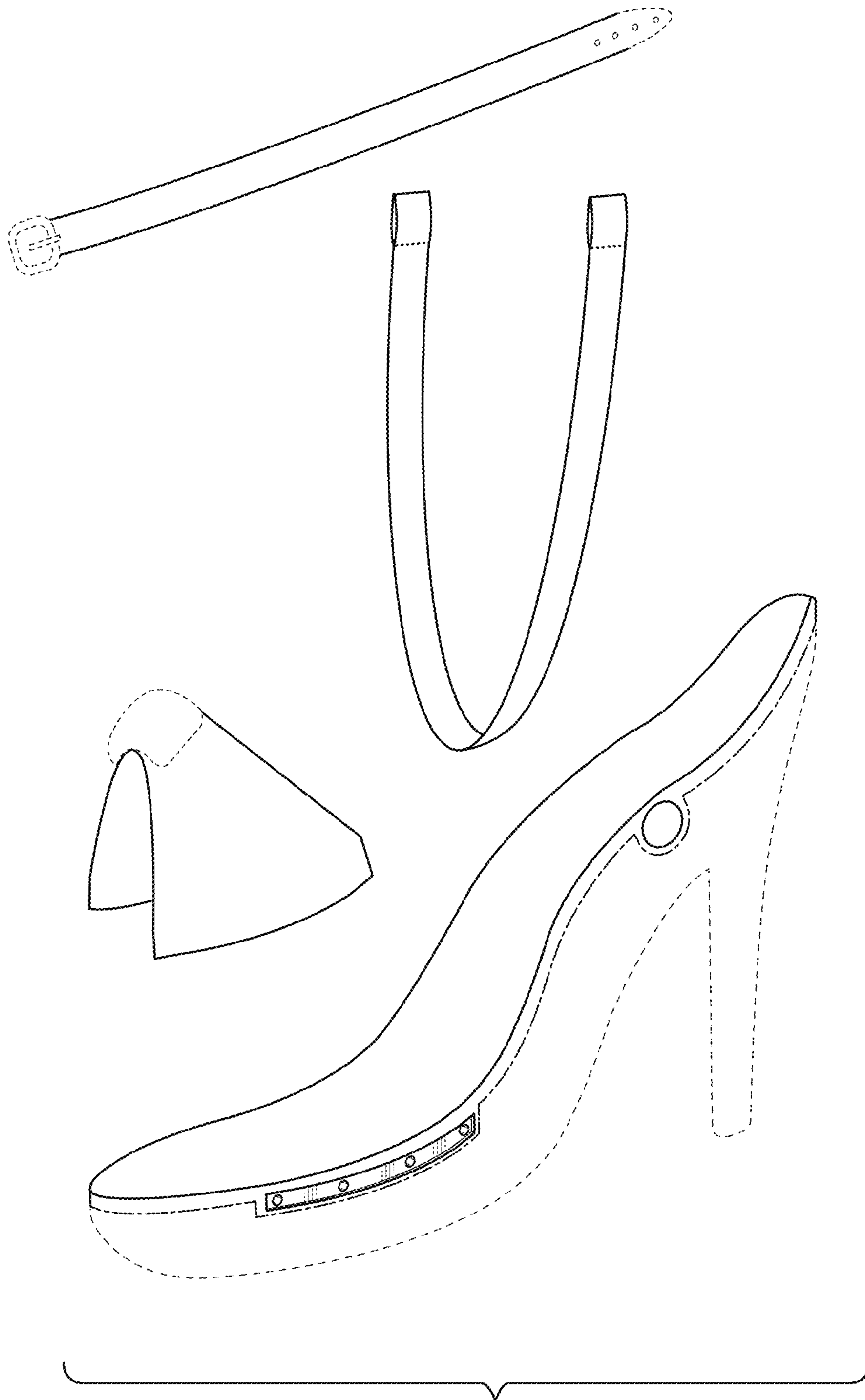

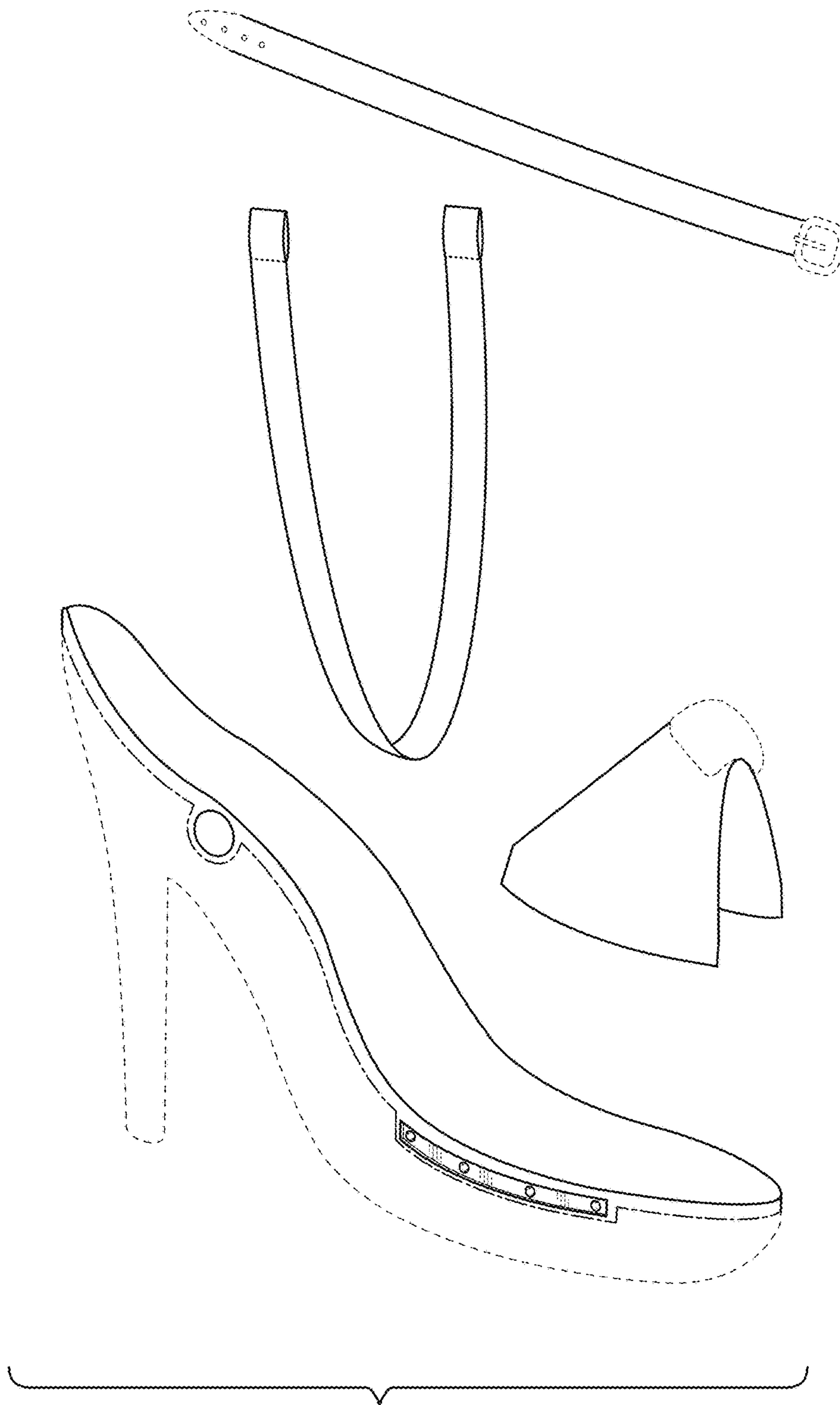

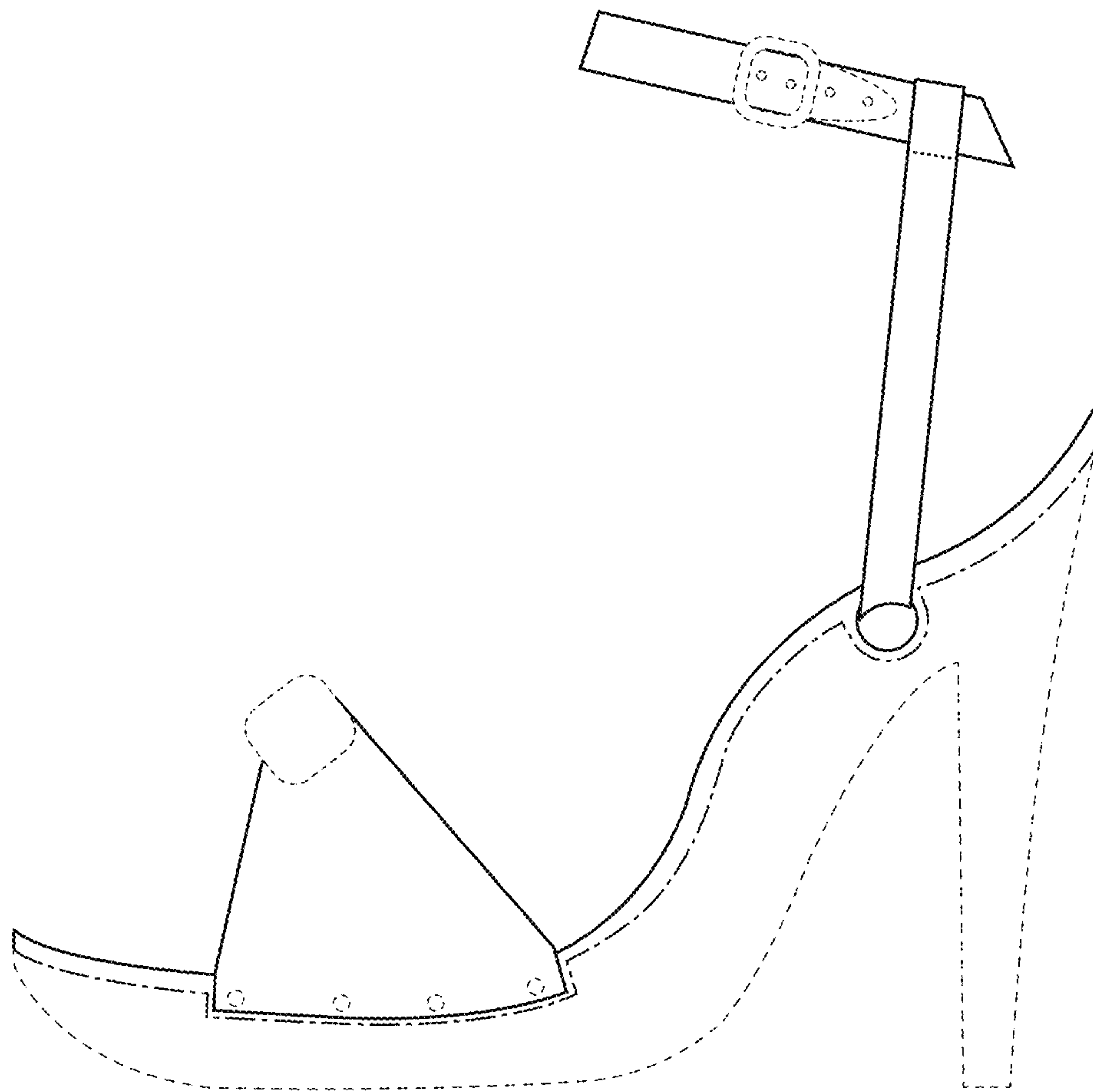

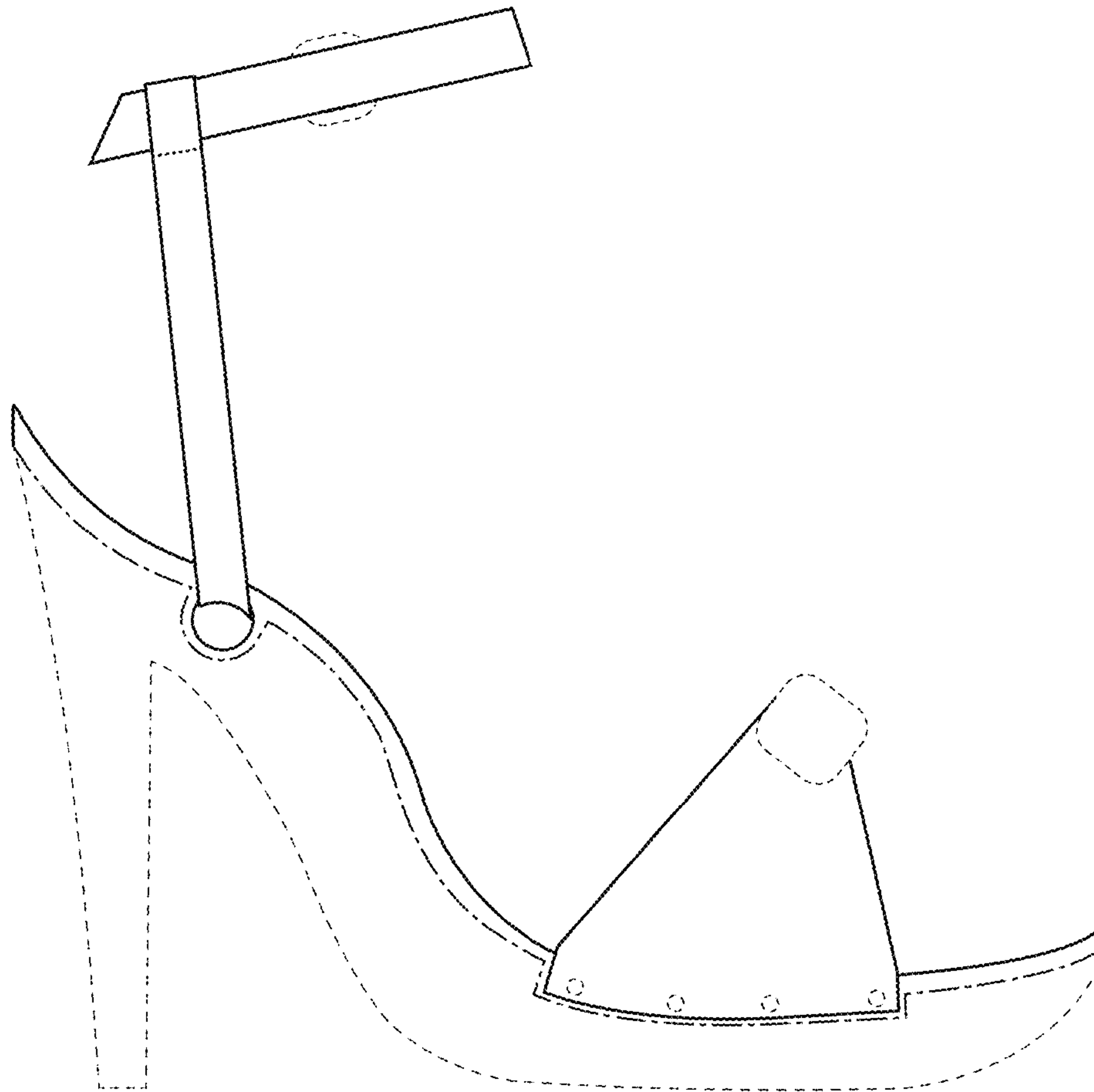

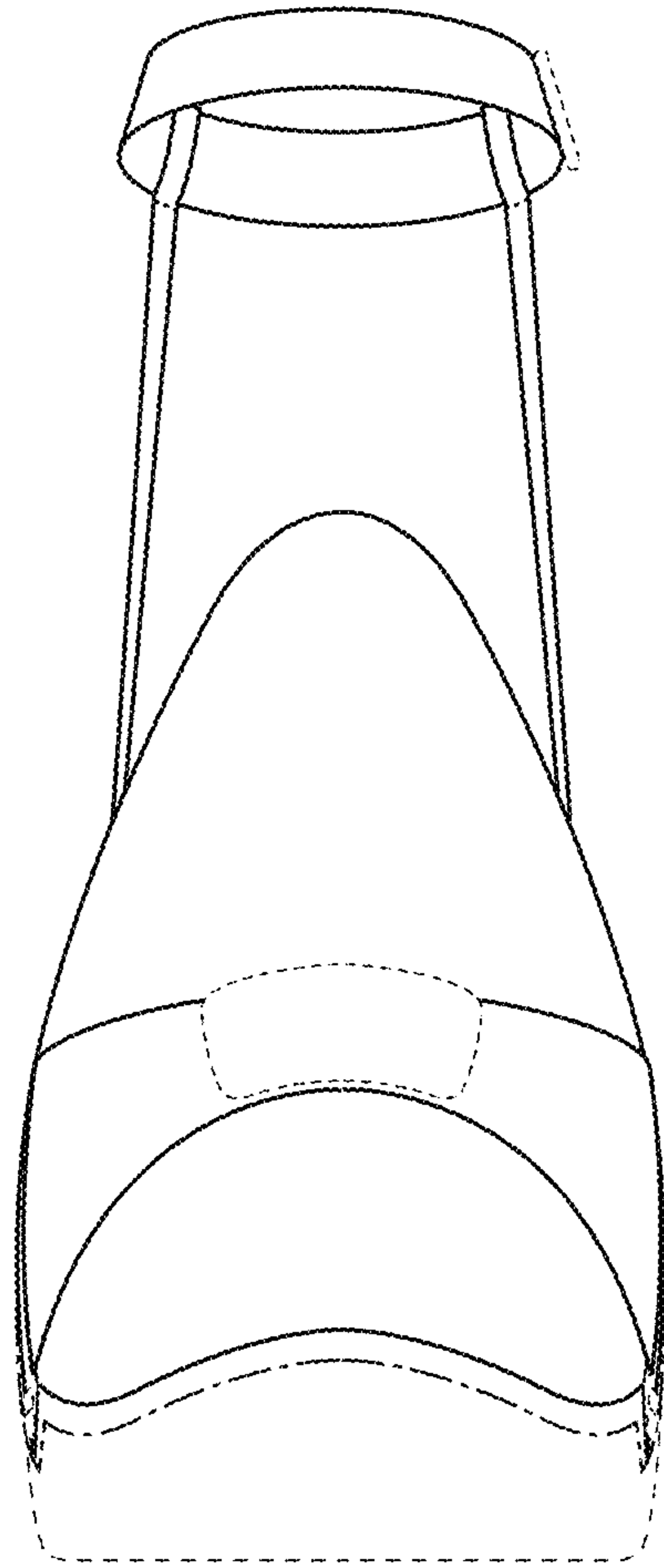

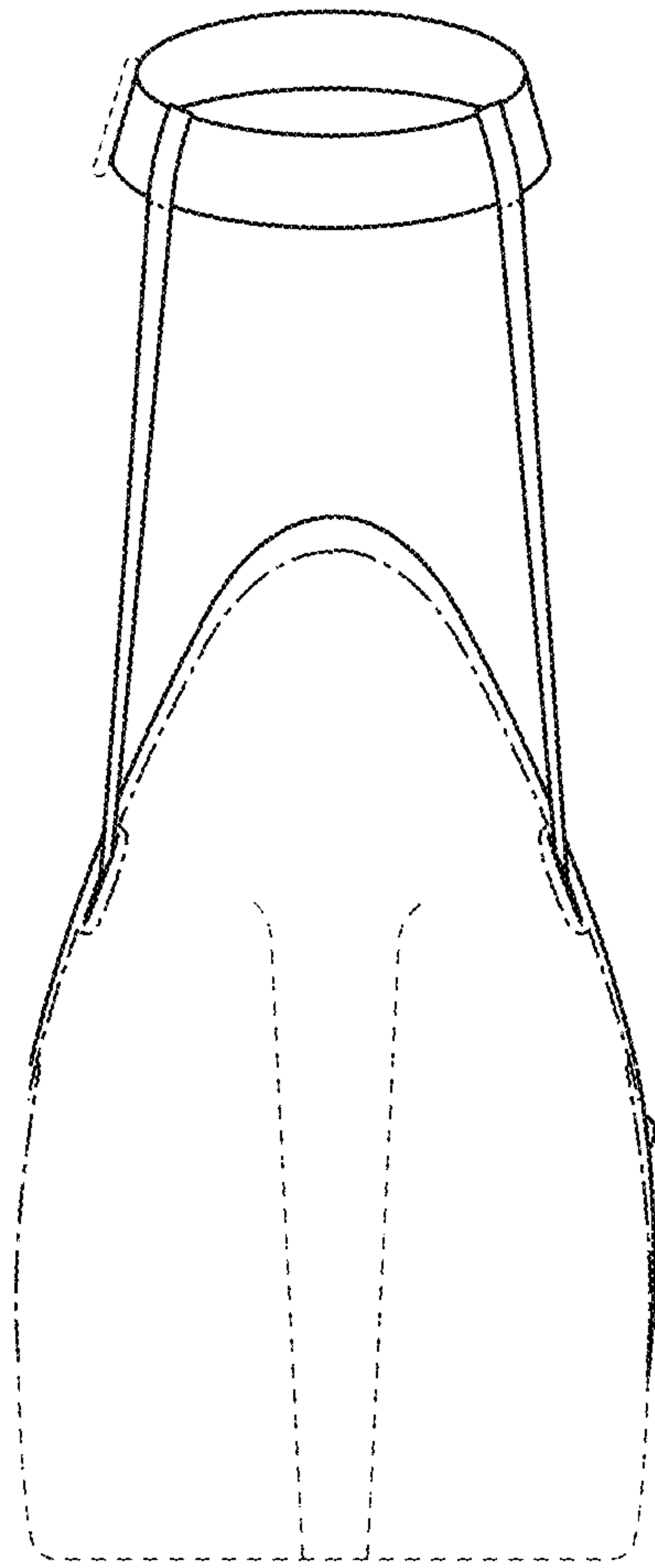

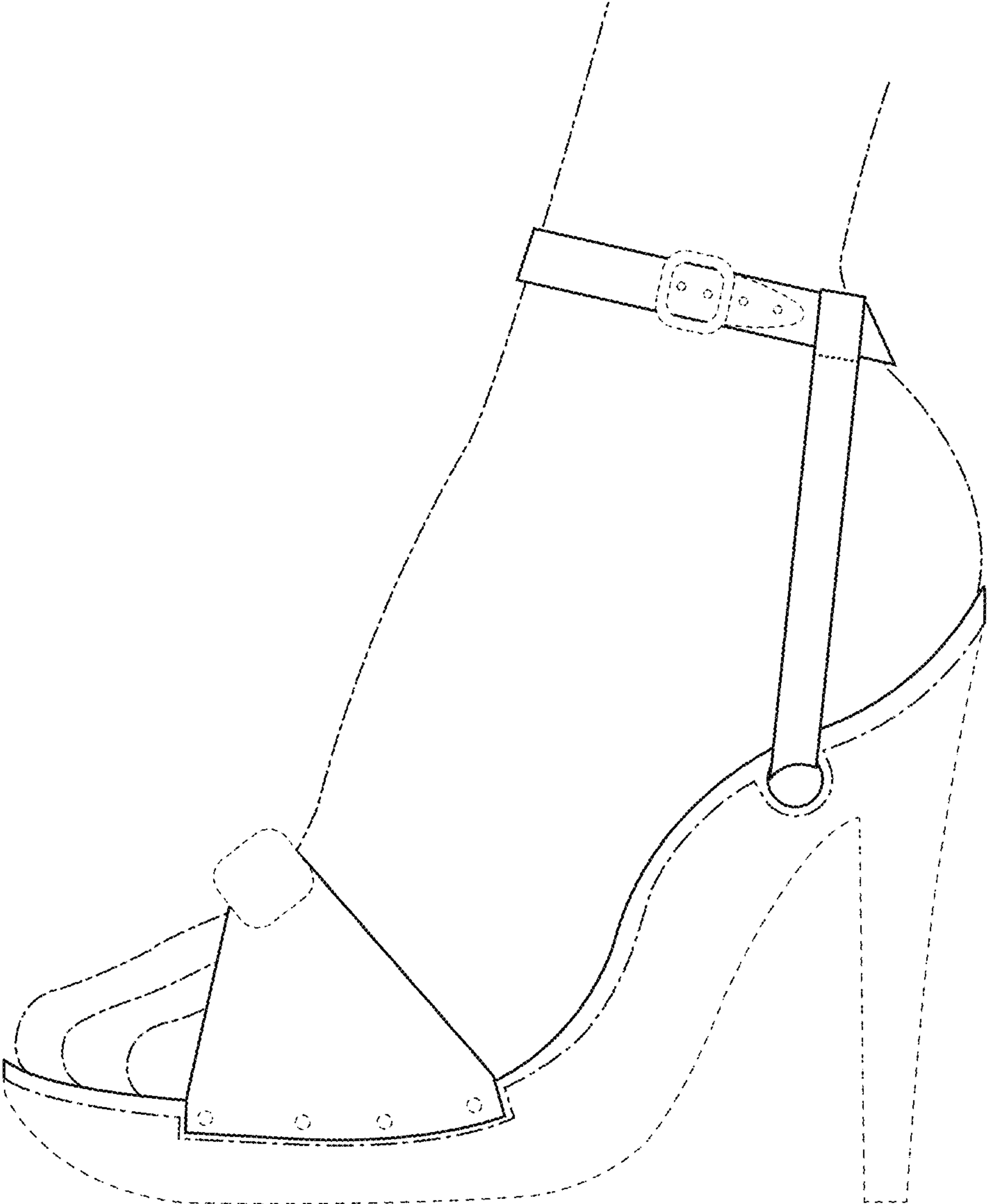
