 FIG. 7 is a bottom plan view of the toothbrush having tongue cleaner.

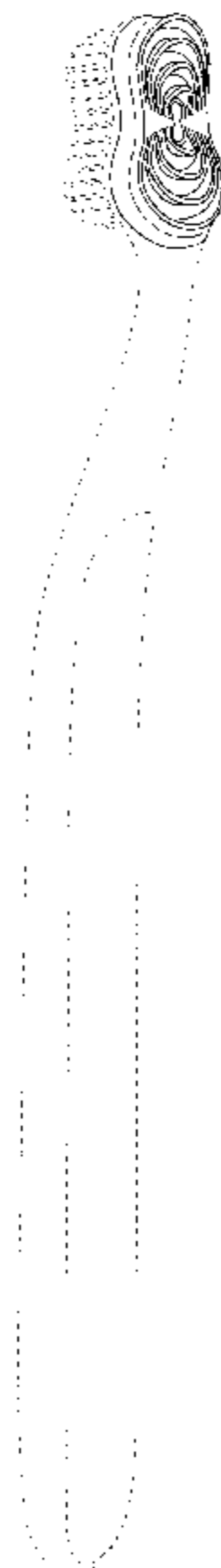

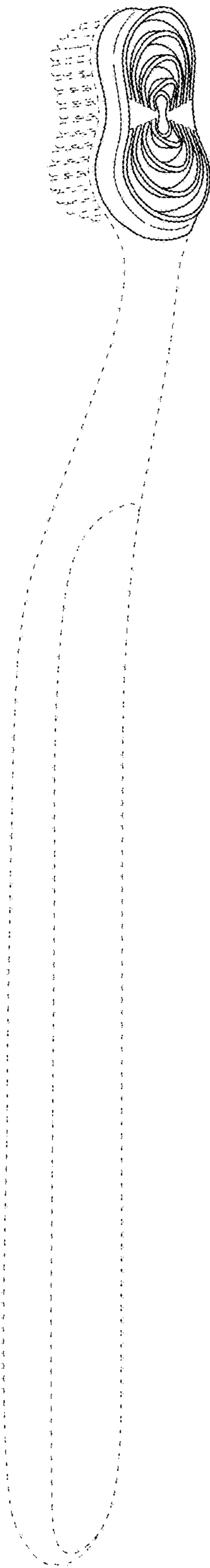

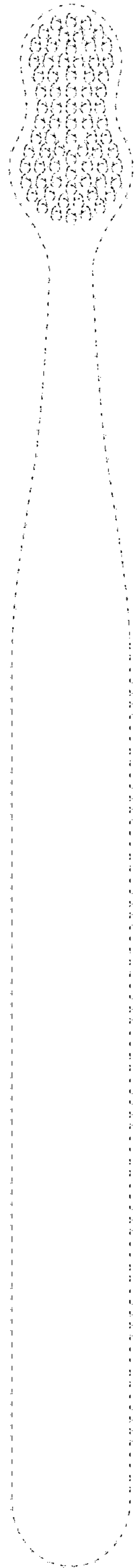

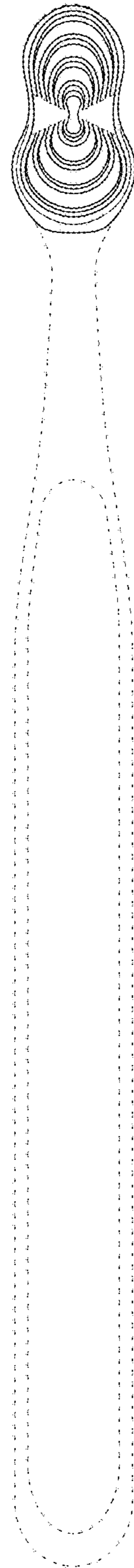

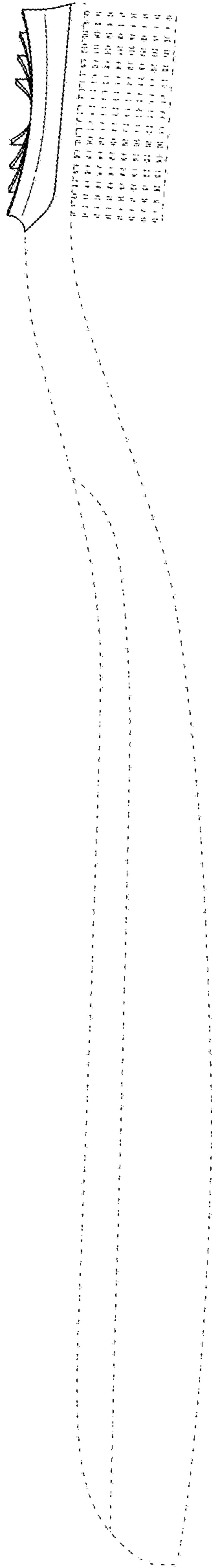

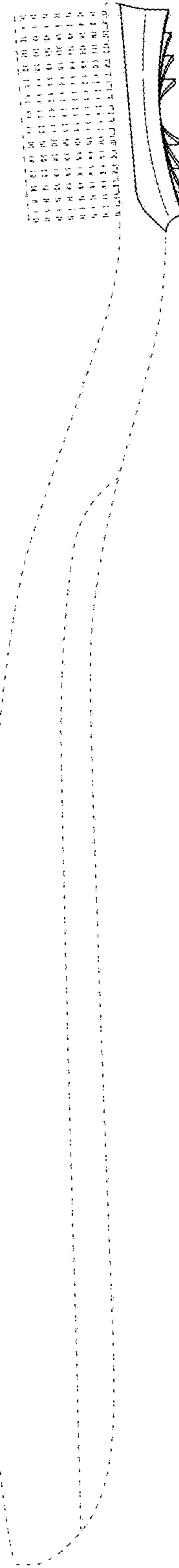

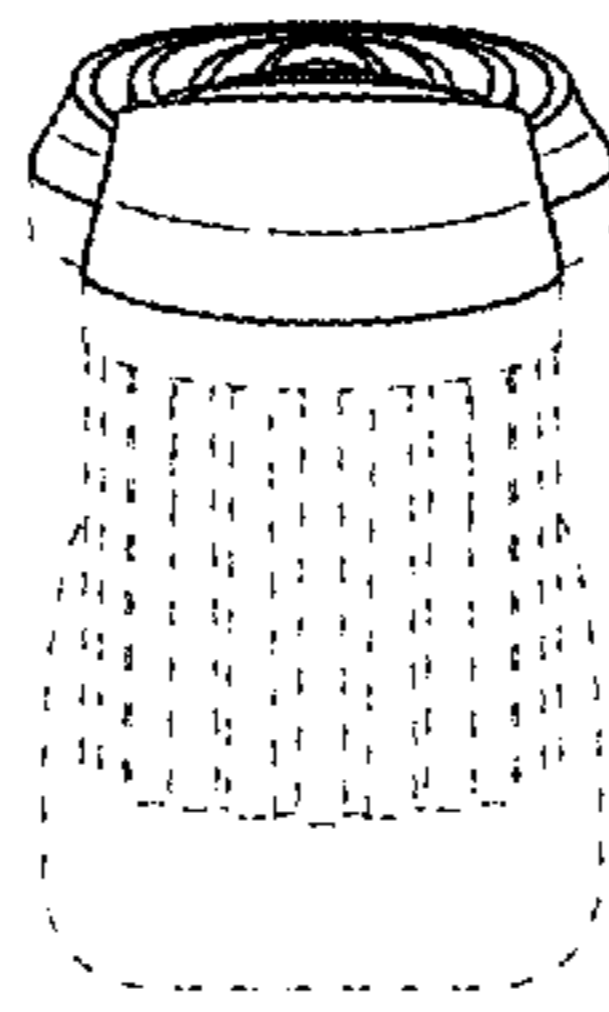

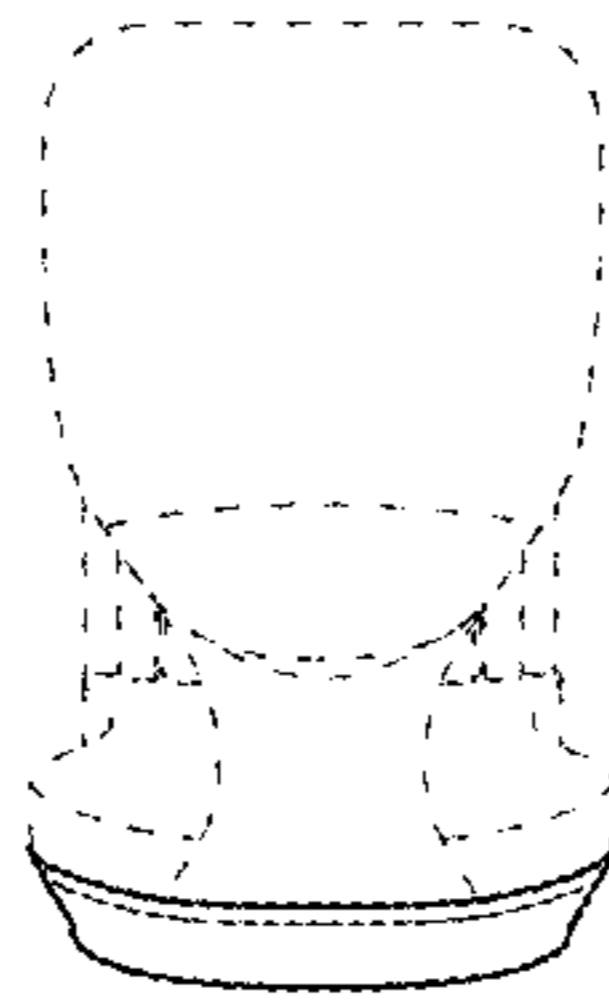
