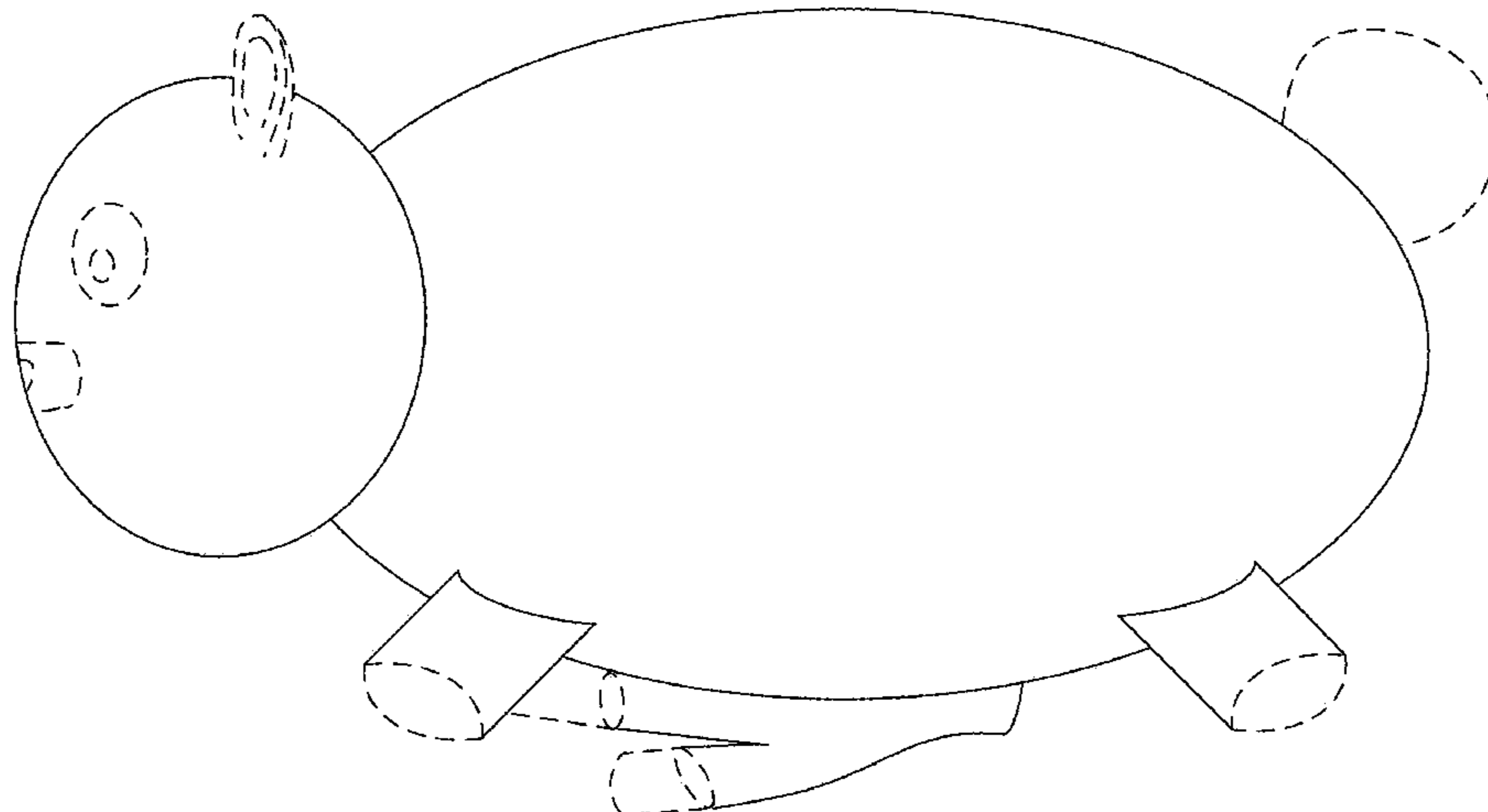
(57) **CLAIM**

The ornamental design for a hand pillow, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a hand pillow; FIG. 2 is a right side view of the hand pillow; FIG. 3 is a top view of the hand pillow; FIG. 4 is a bottom view of the hand pillow; FIG. 5 is a rear view of the hand pillow; and, FIG. 6 is front view of the hand pillow. The dash type broken lines in the Figures are for the purpose of illustrating unclaimed portions of the hand pillow and form no part of the claimed design.

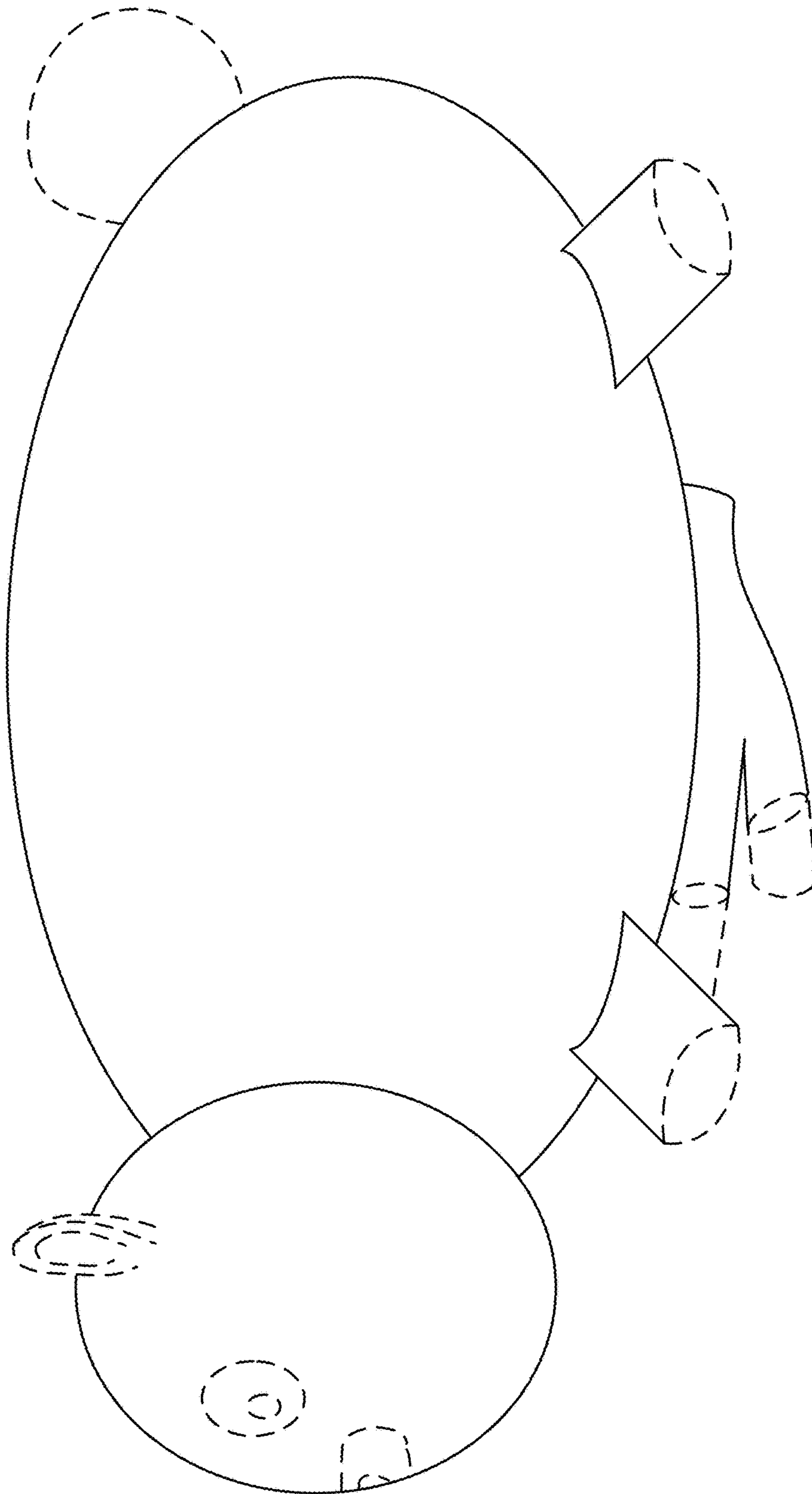

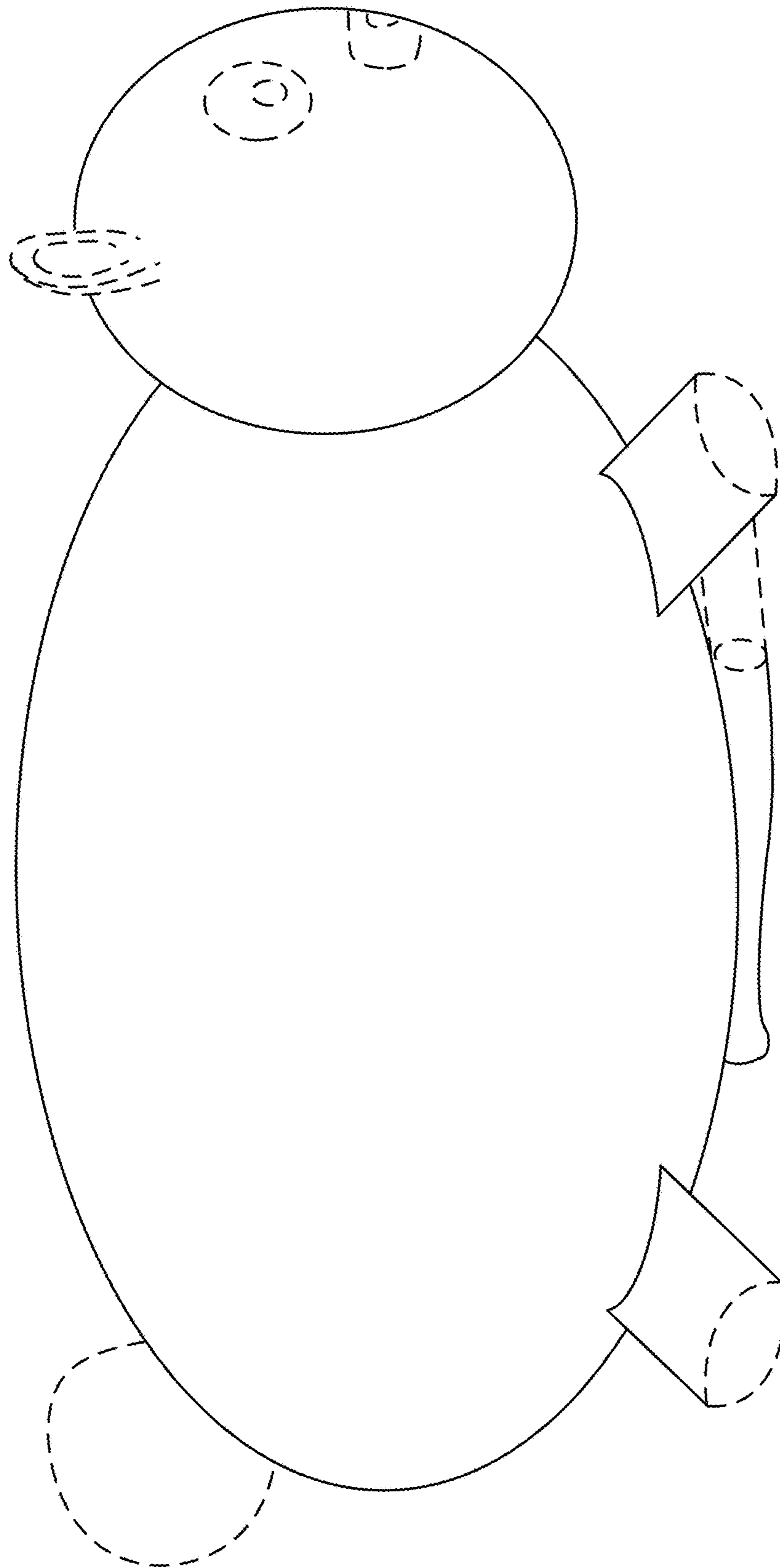

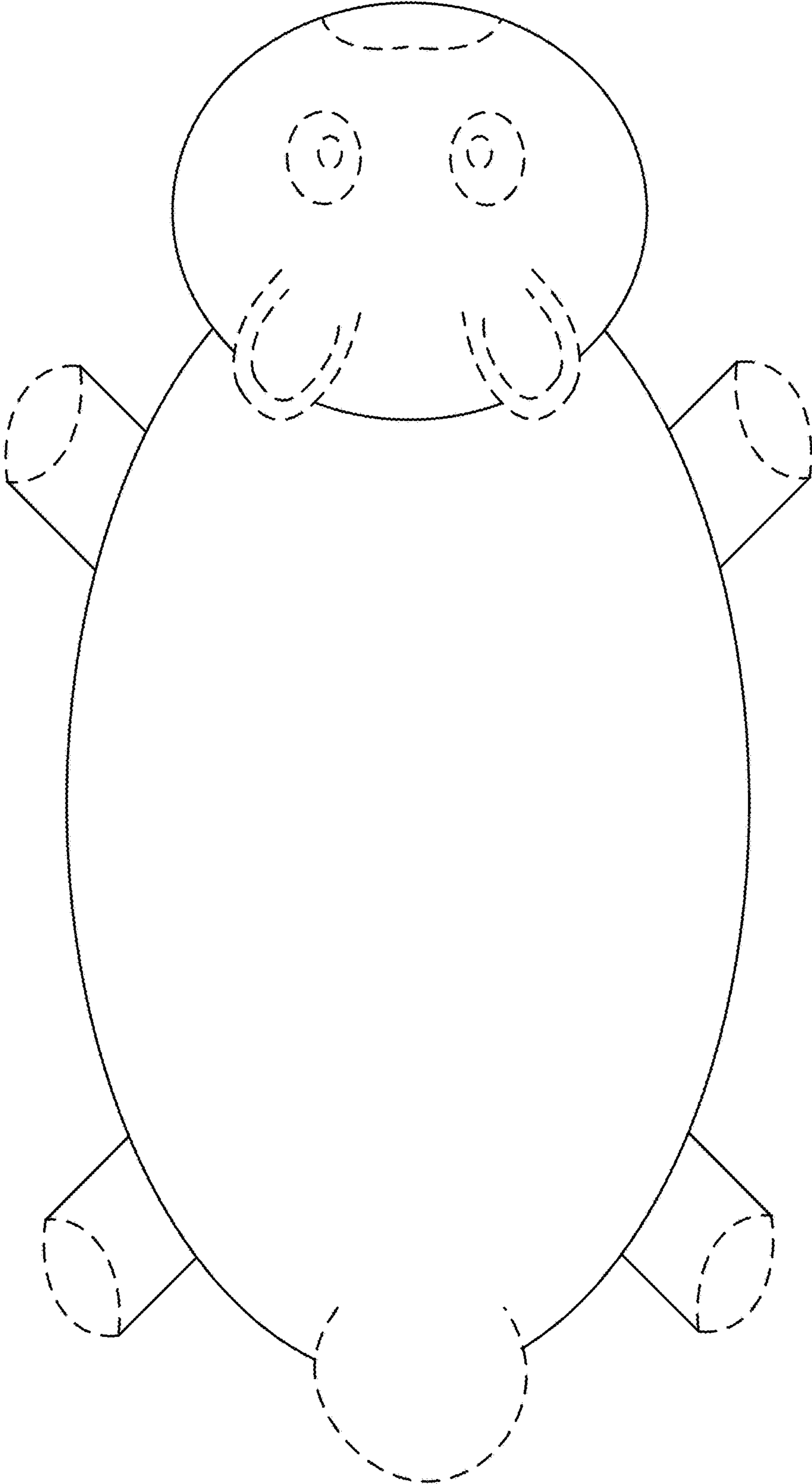

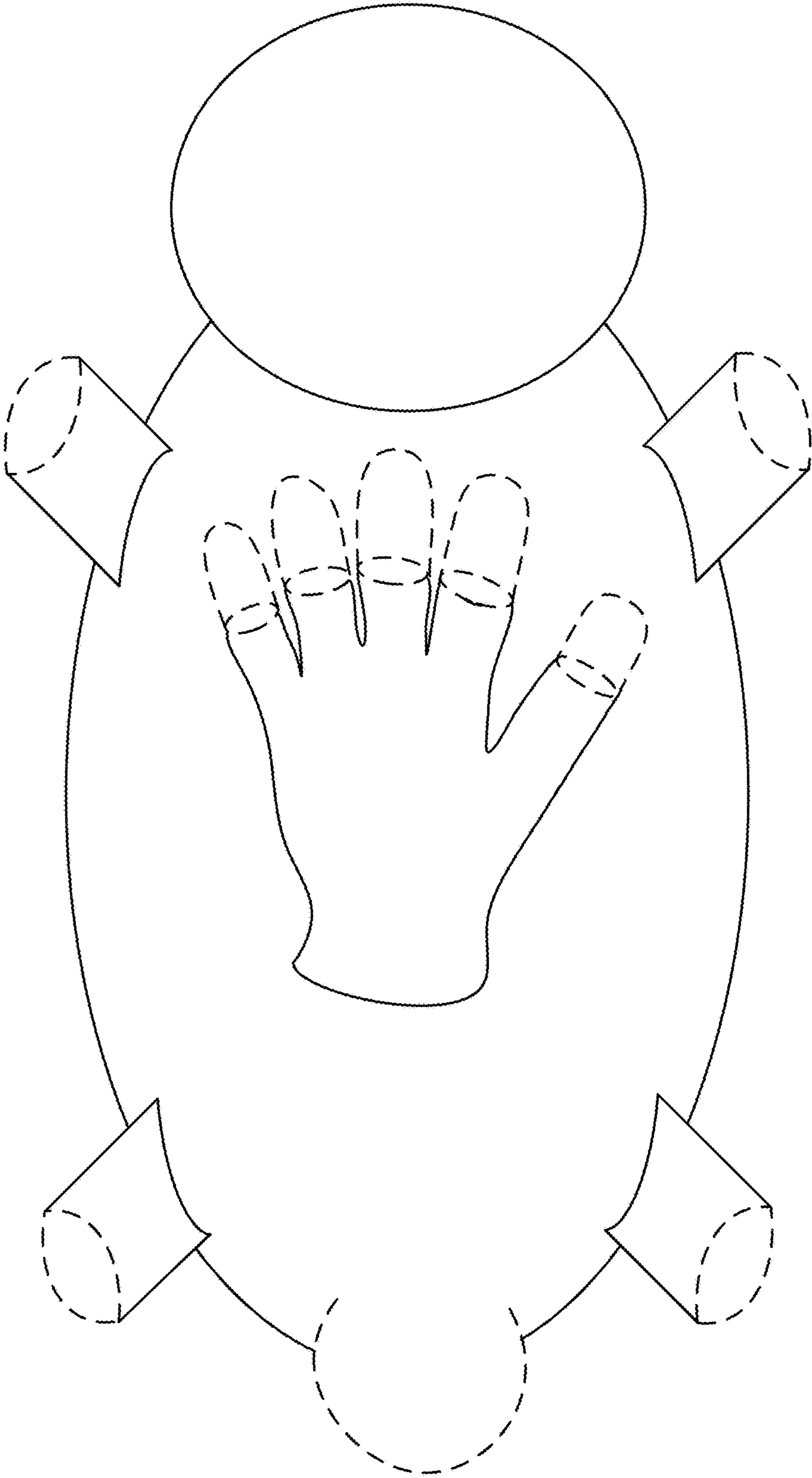

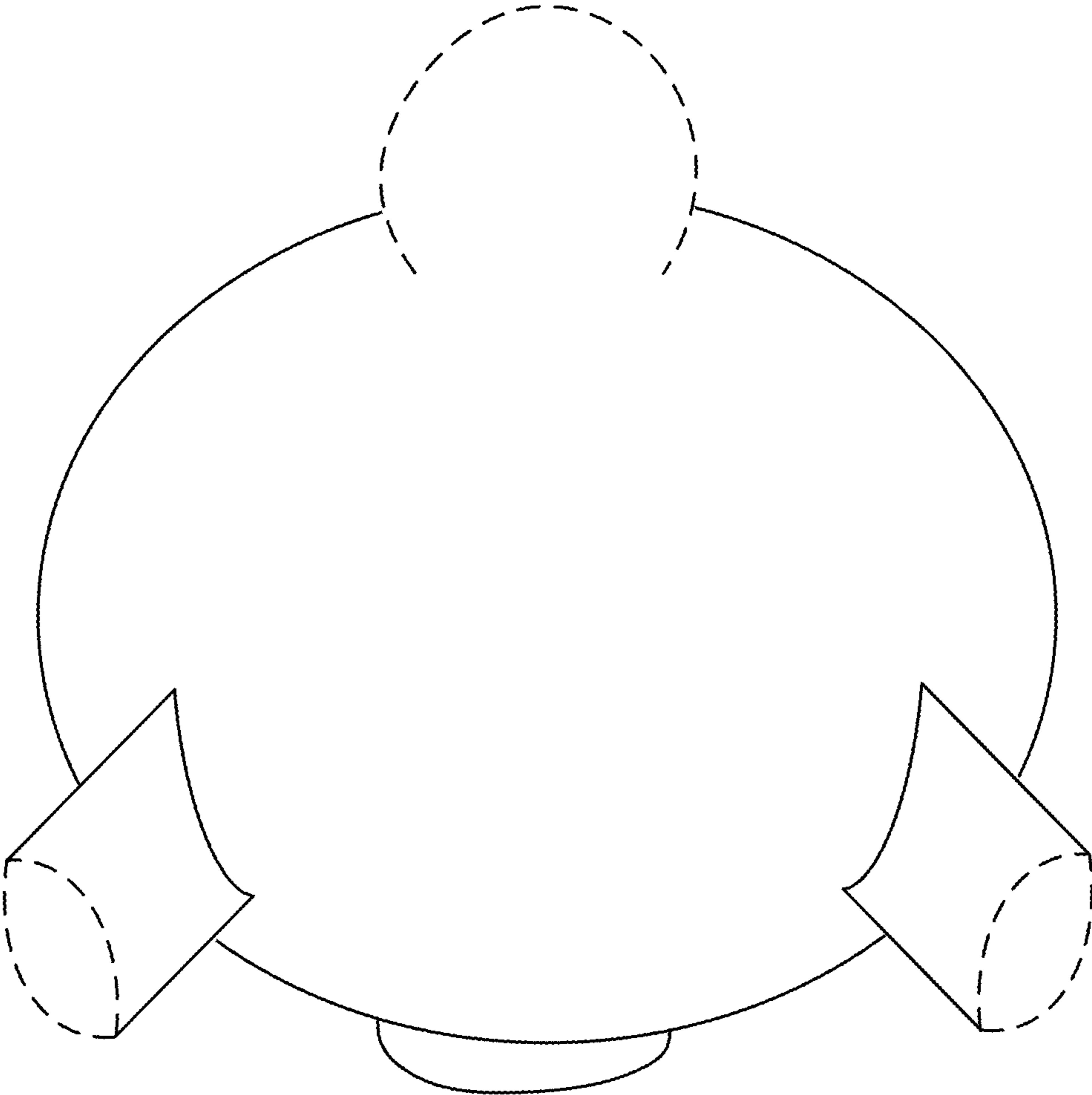

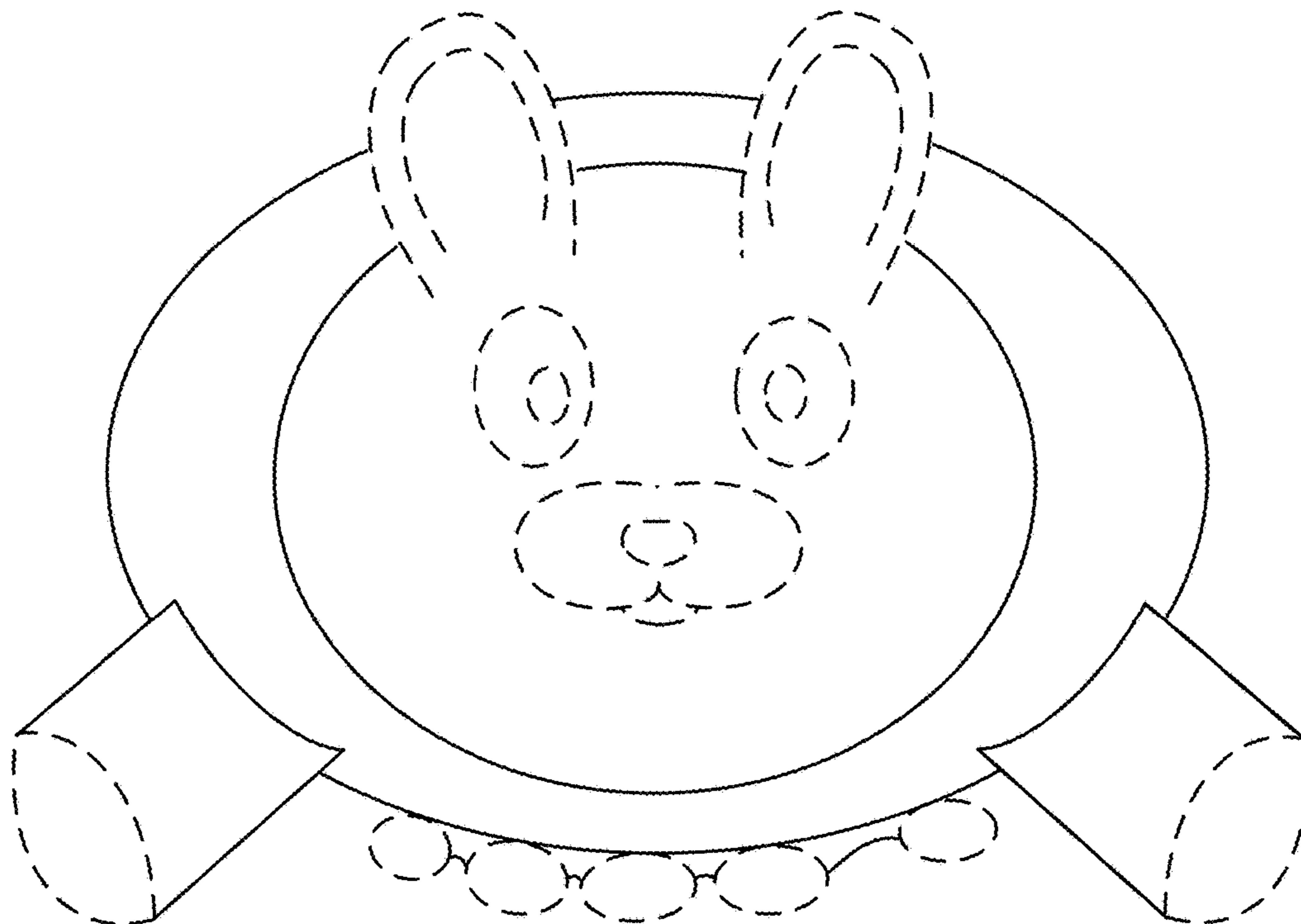
