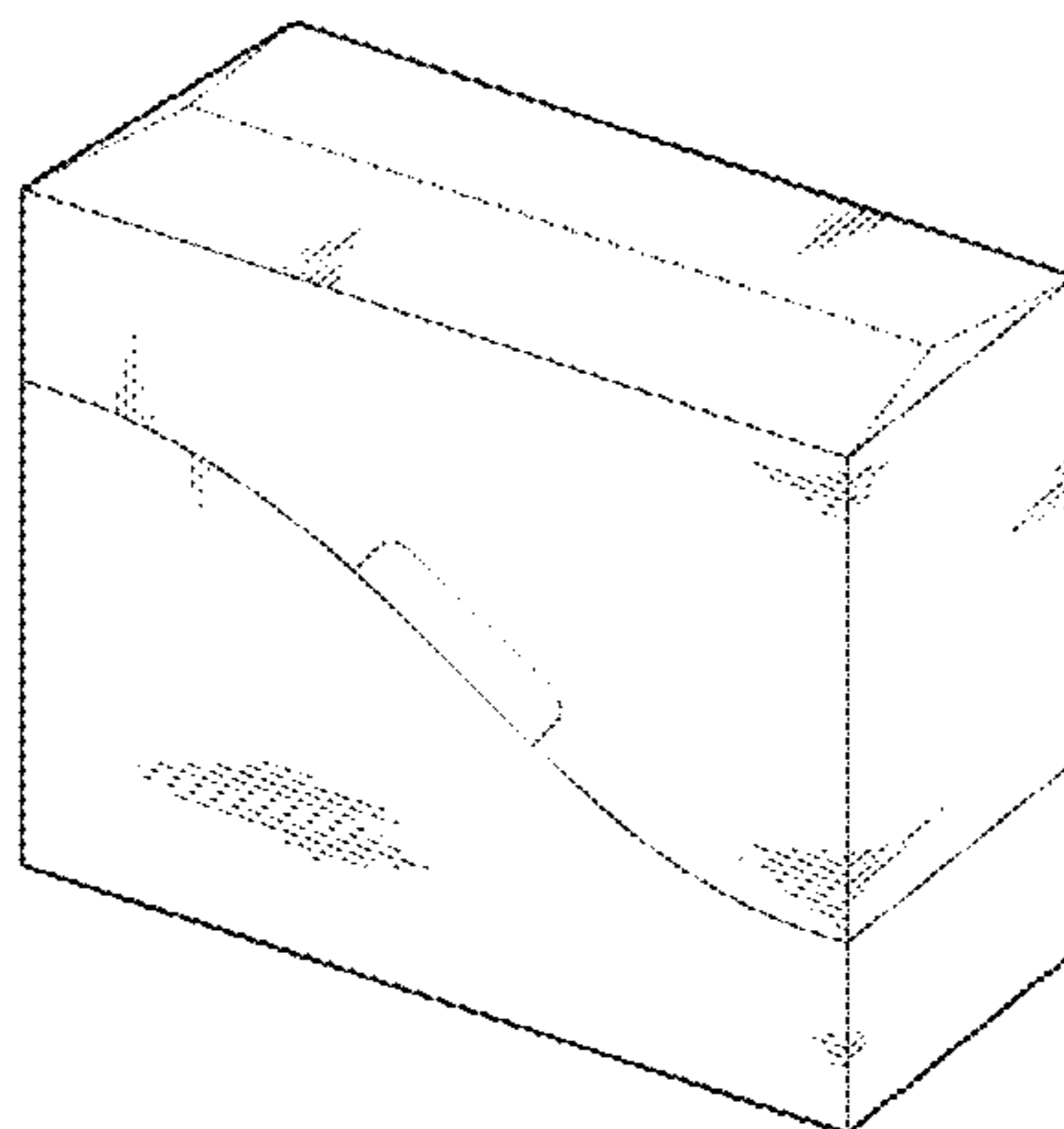
The ornamental design for packaging, as shown and described.

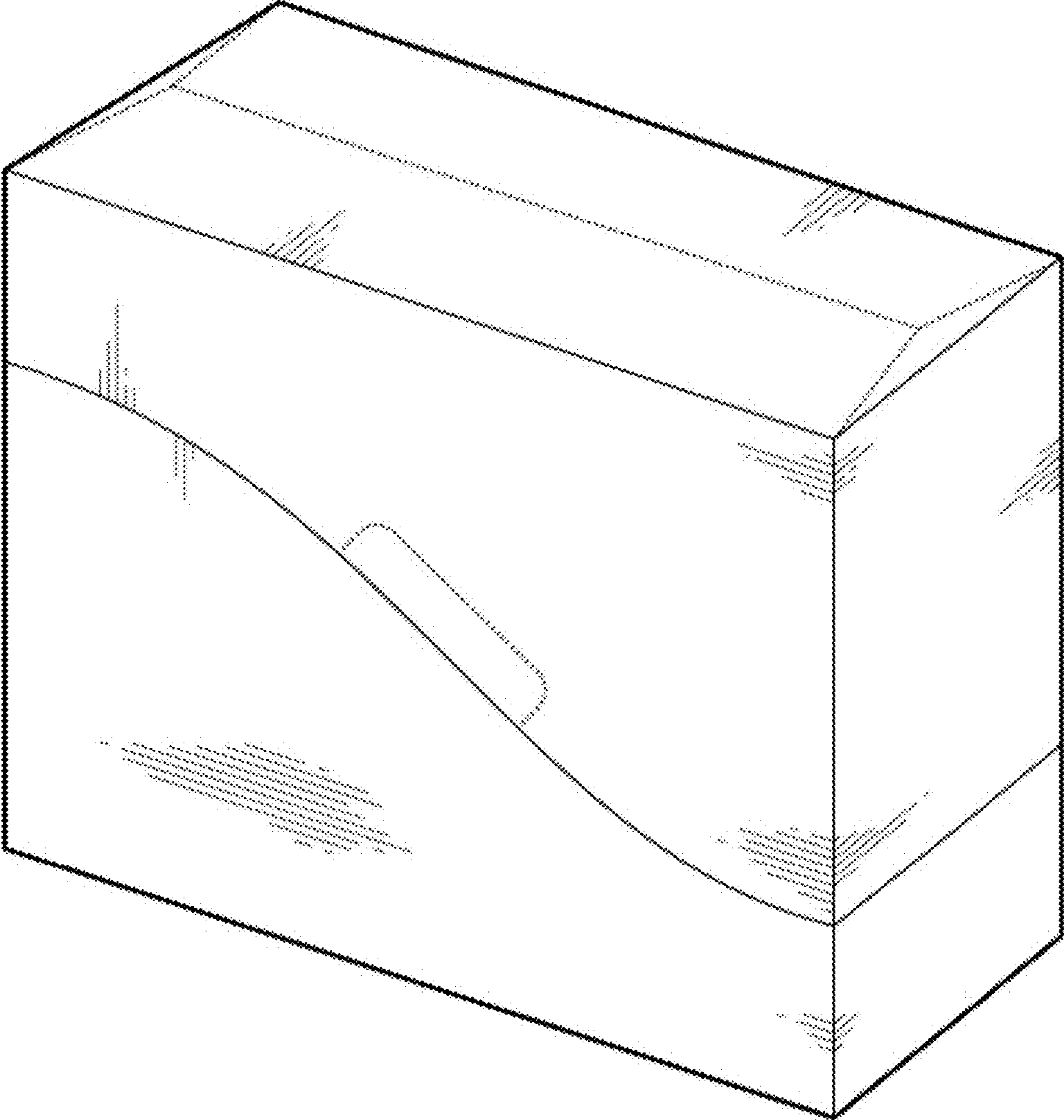

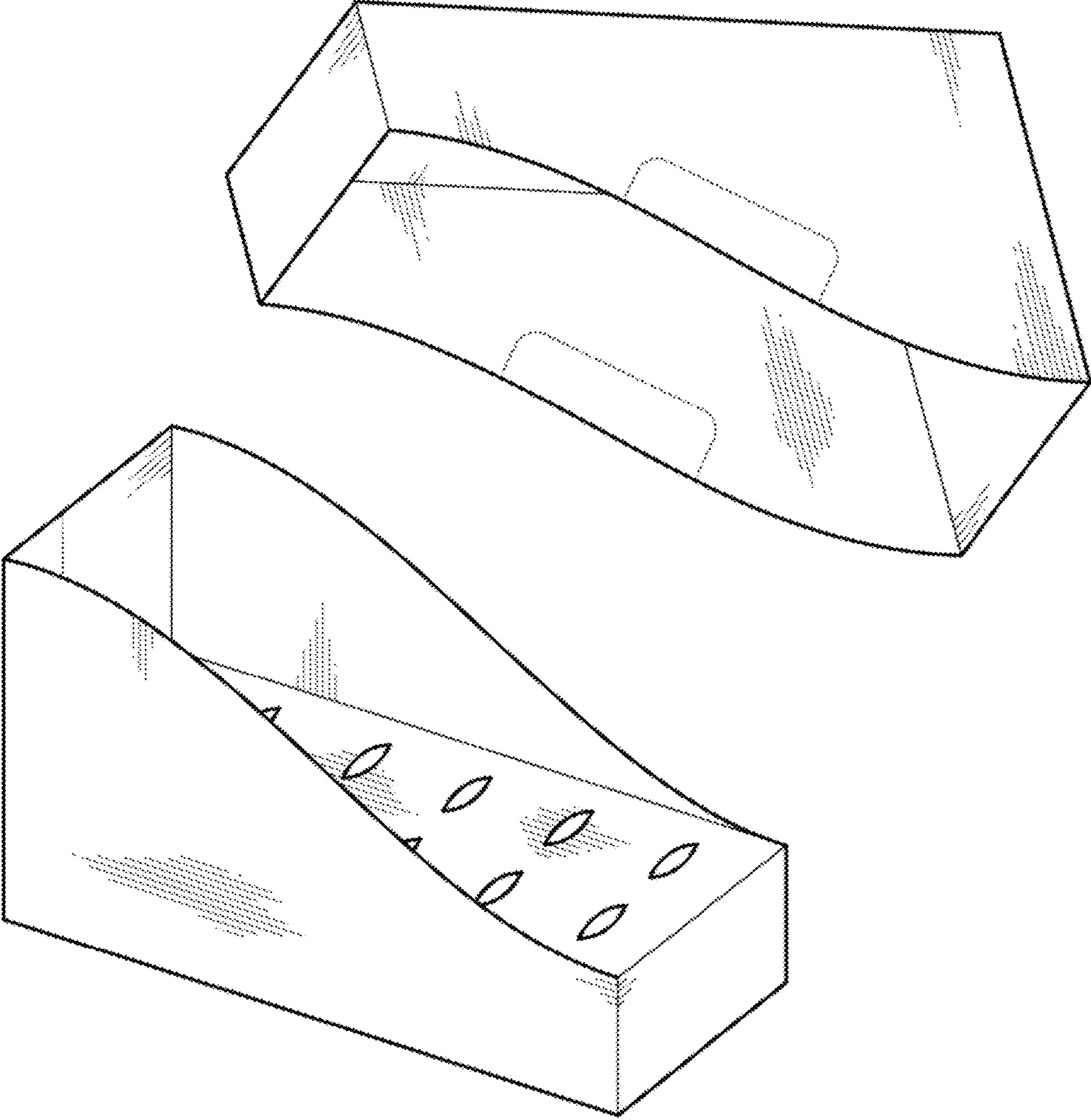

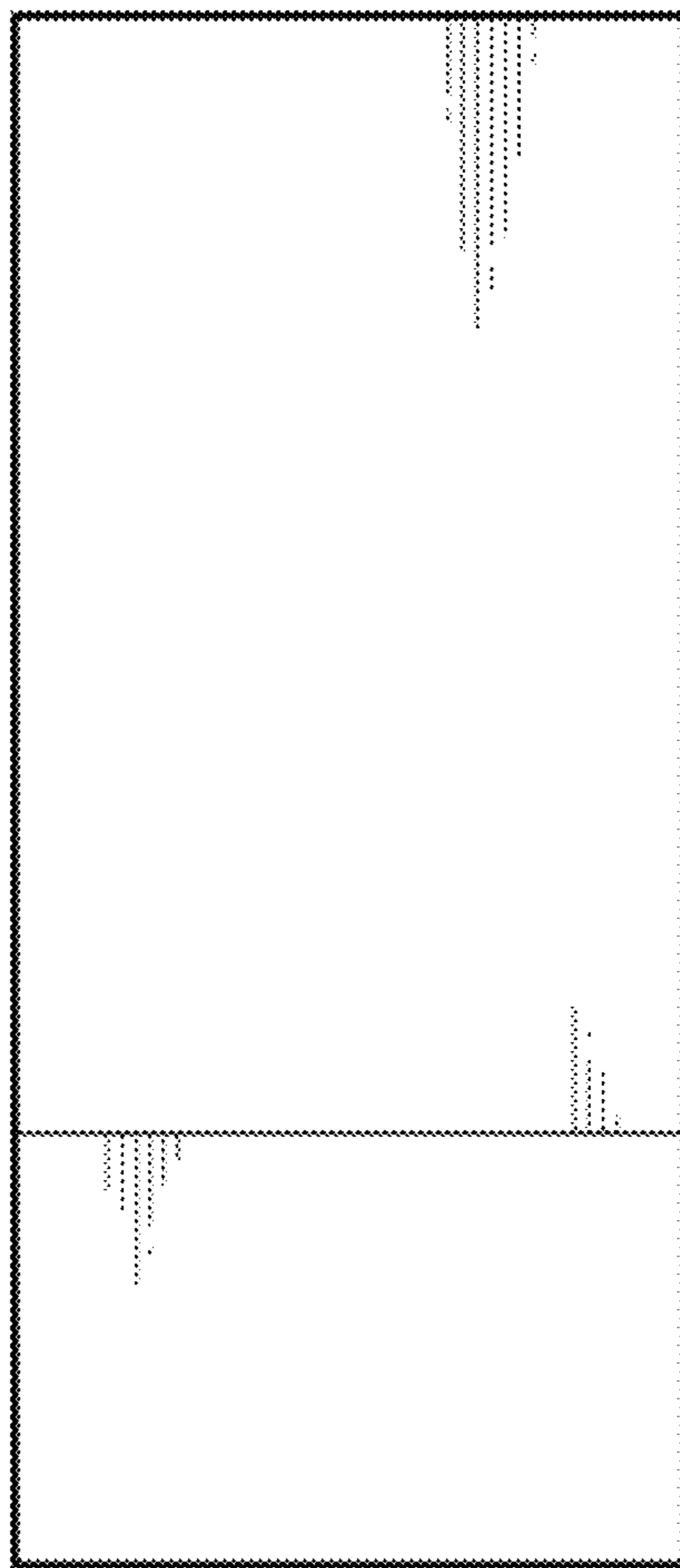

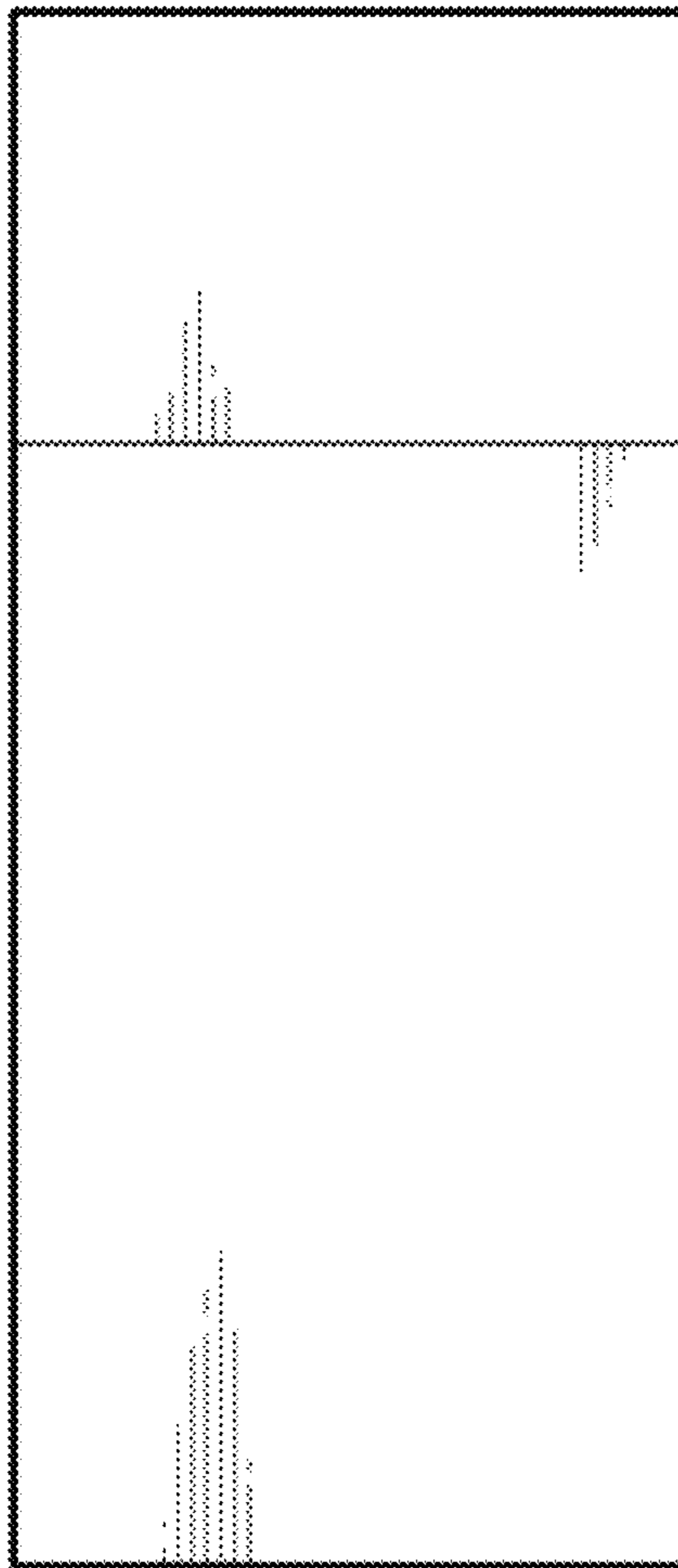

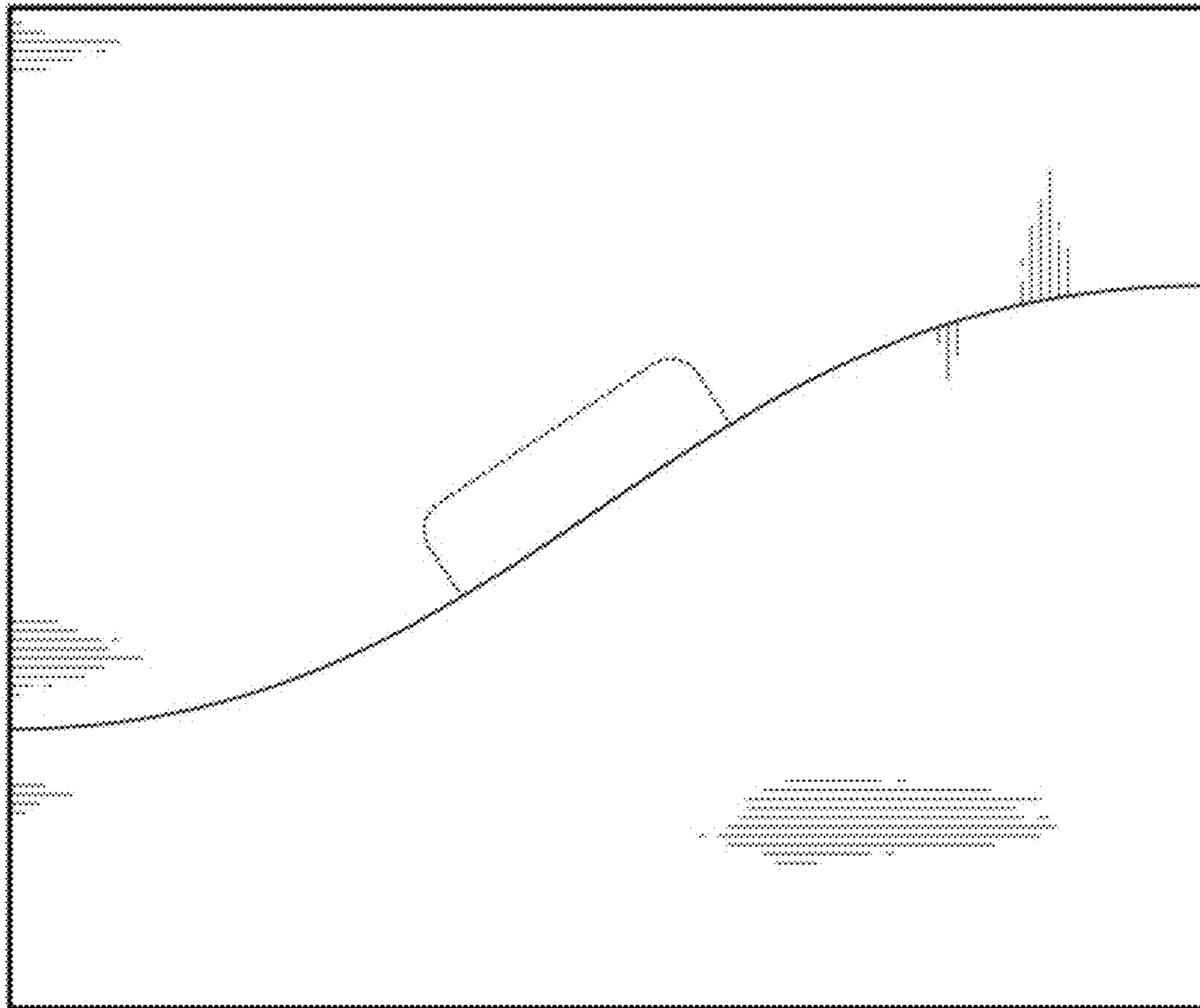

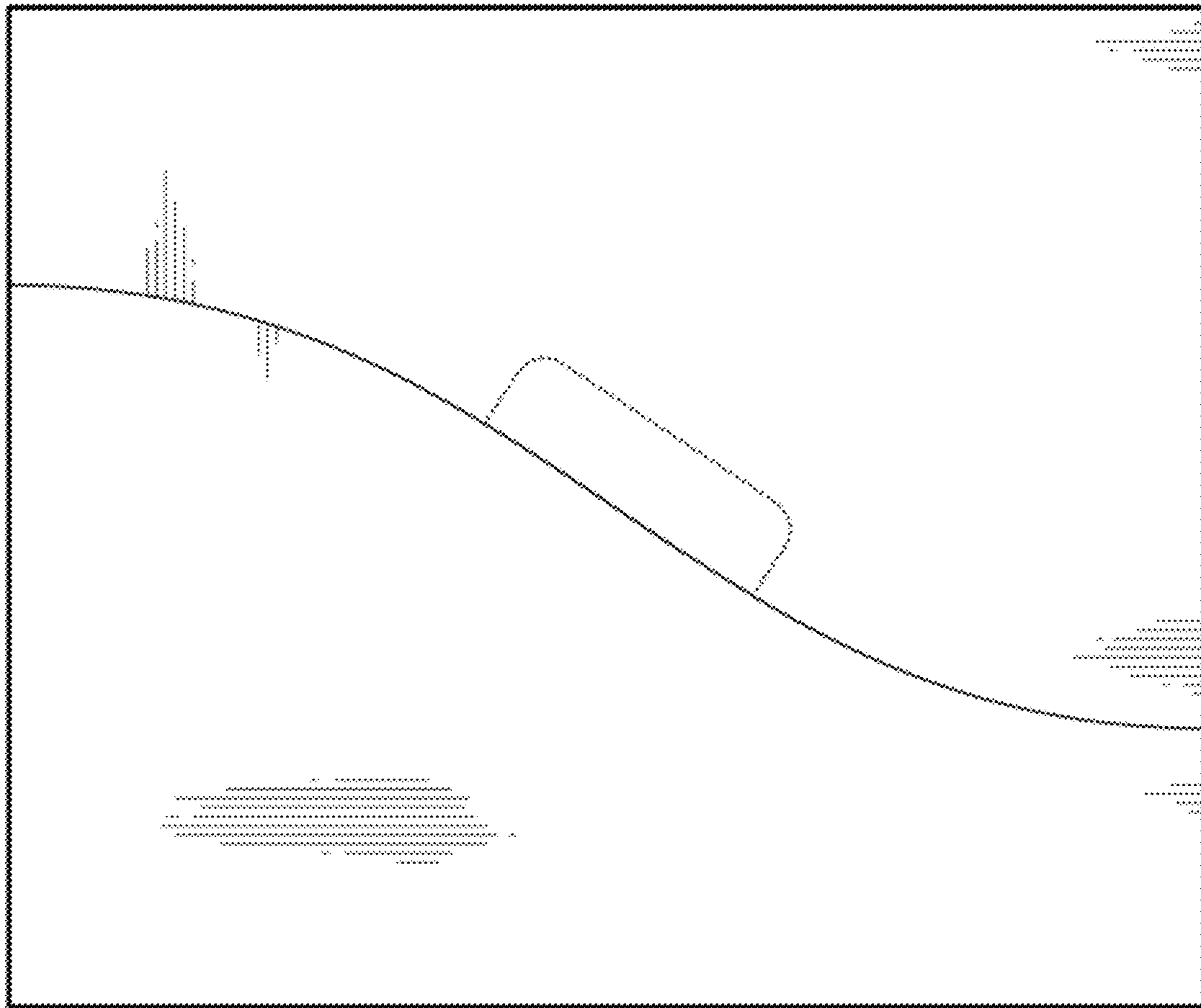

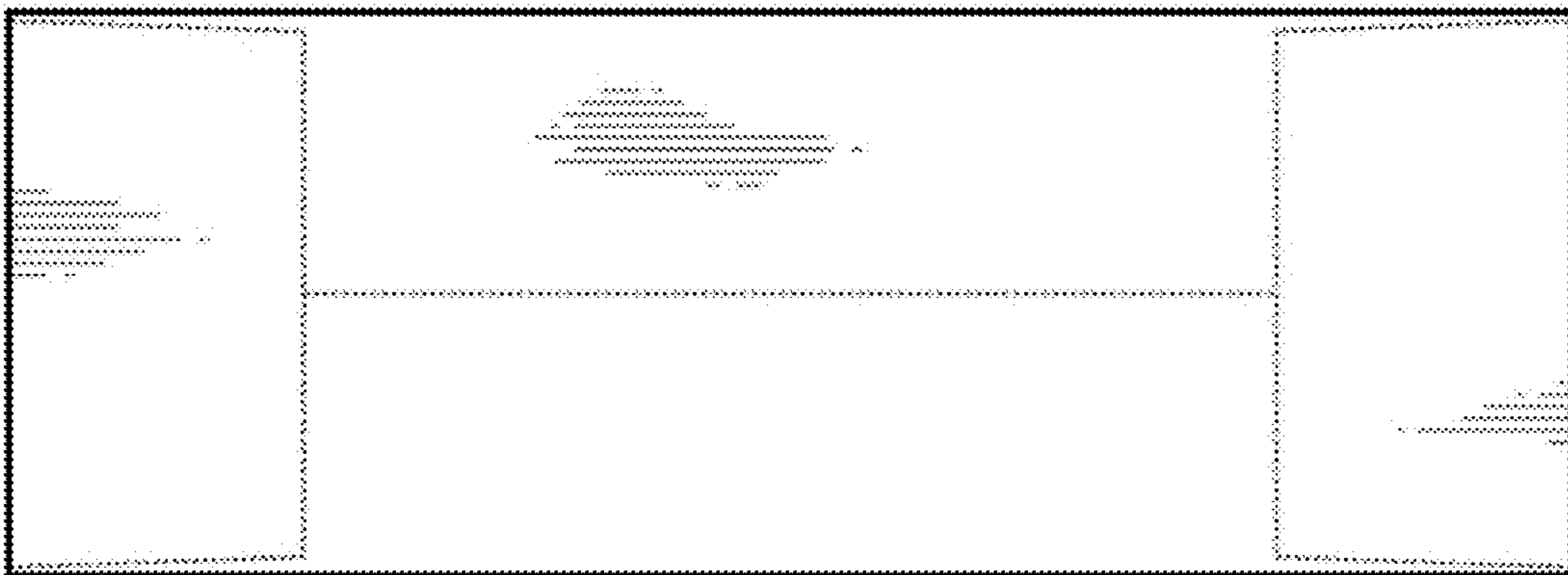

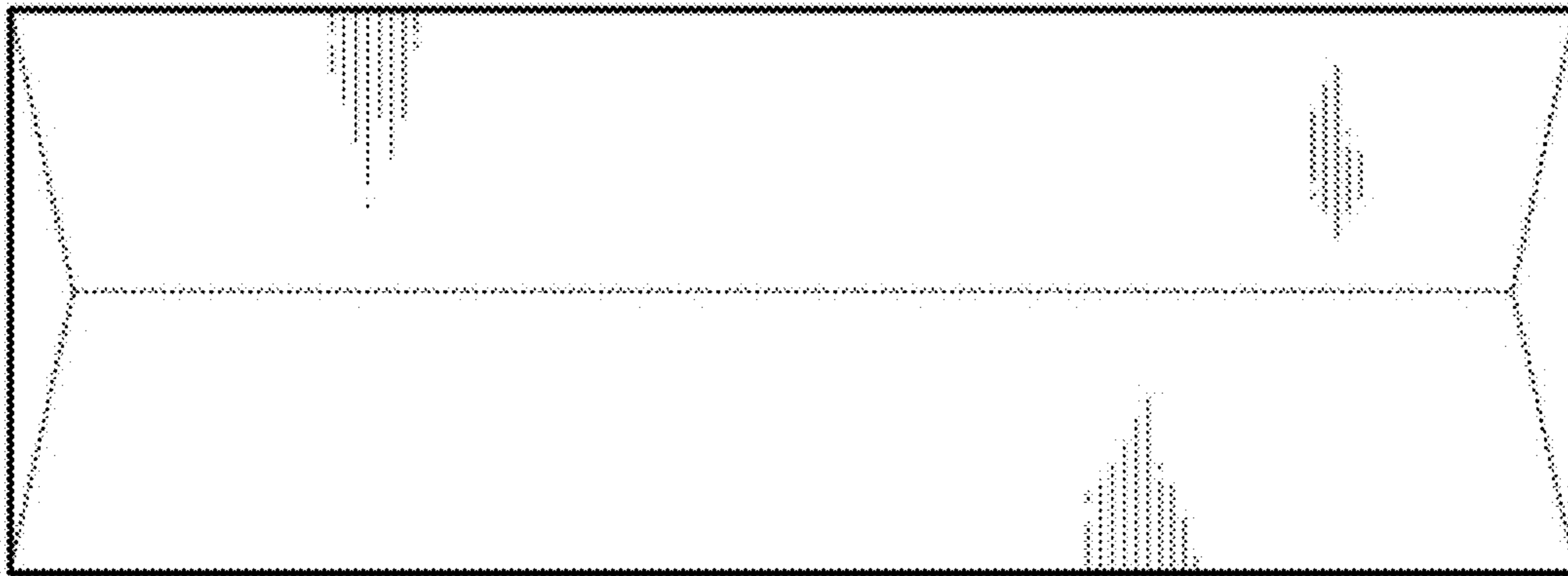

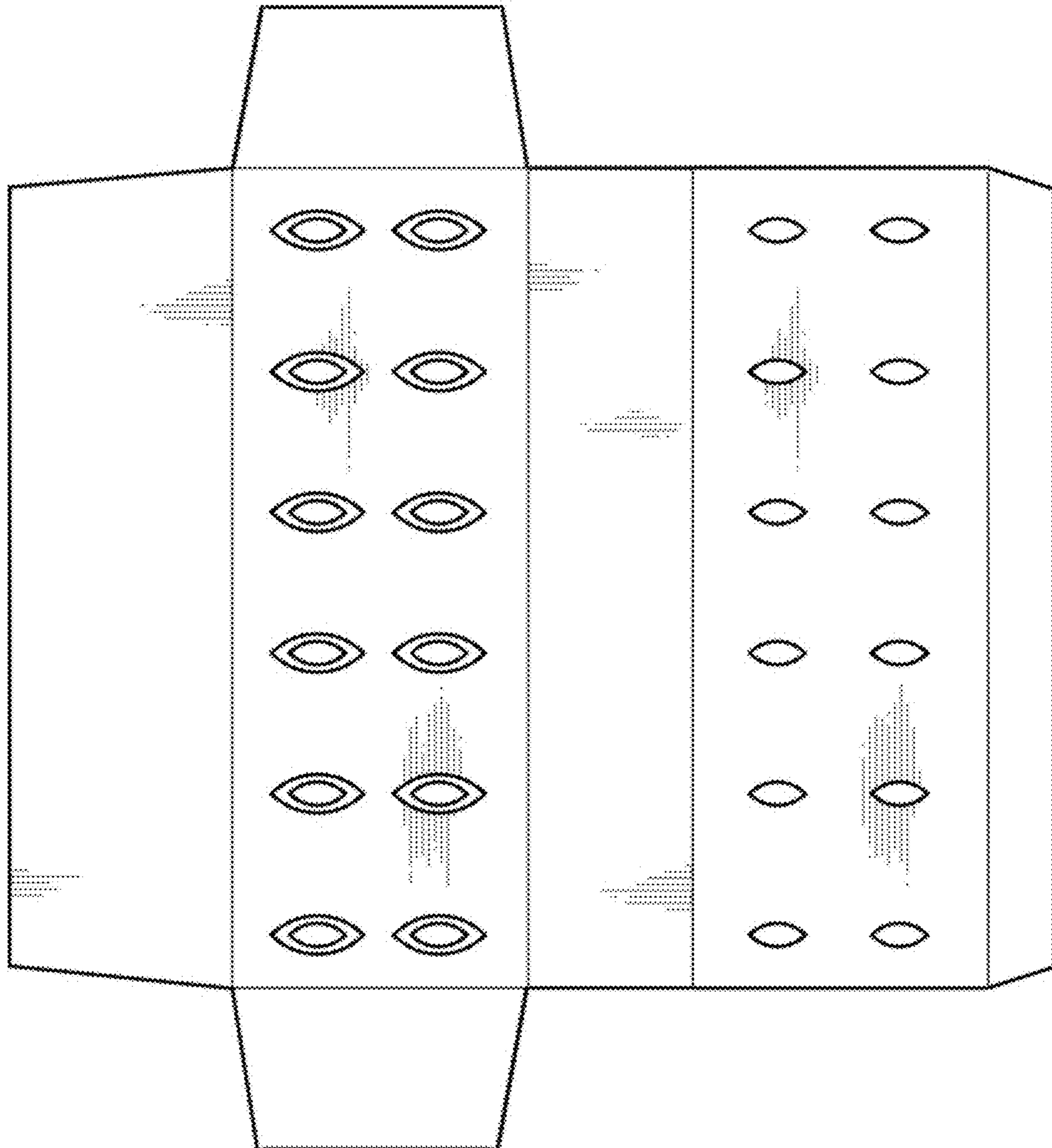

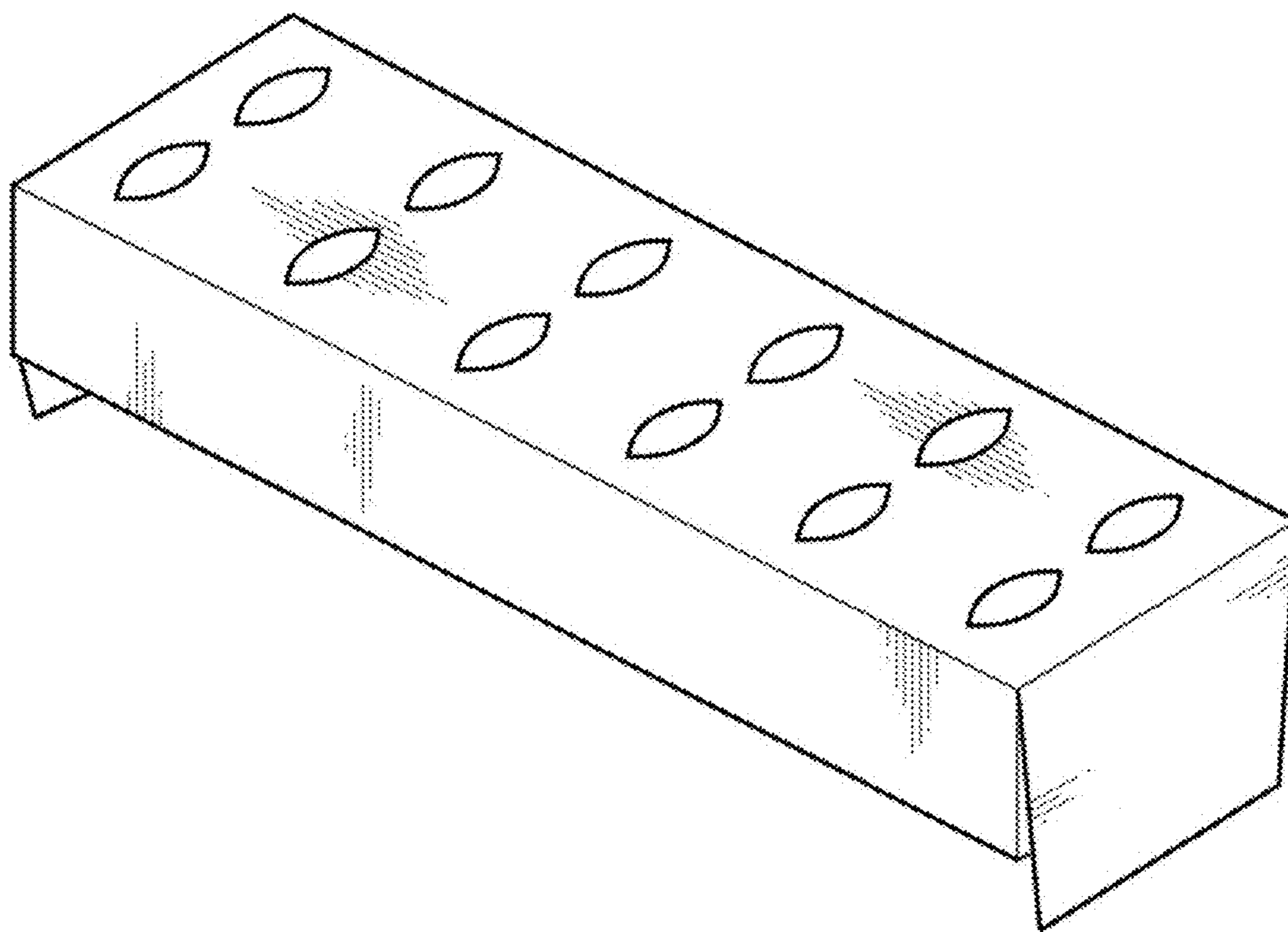

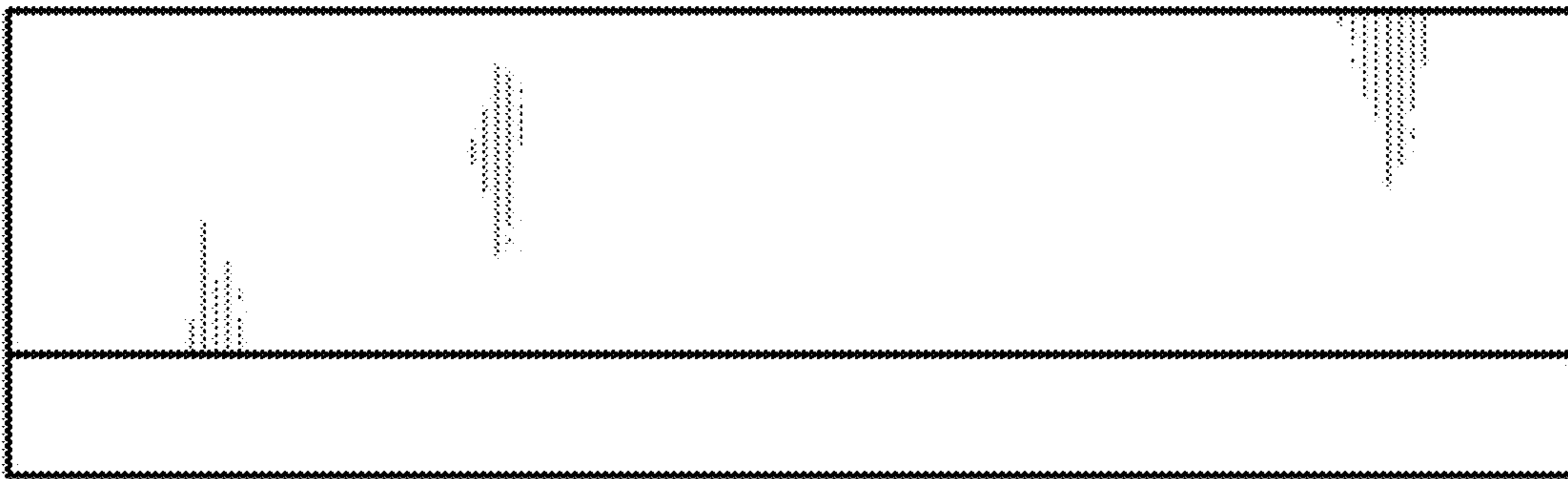

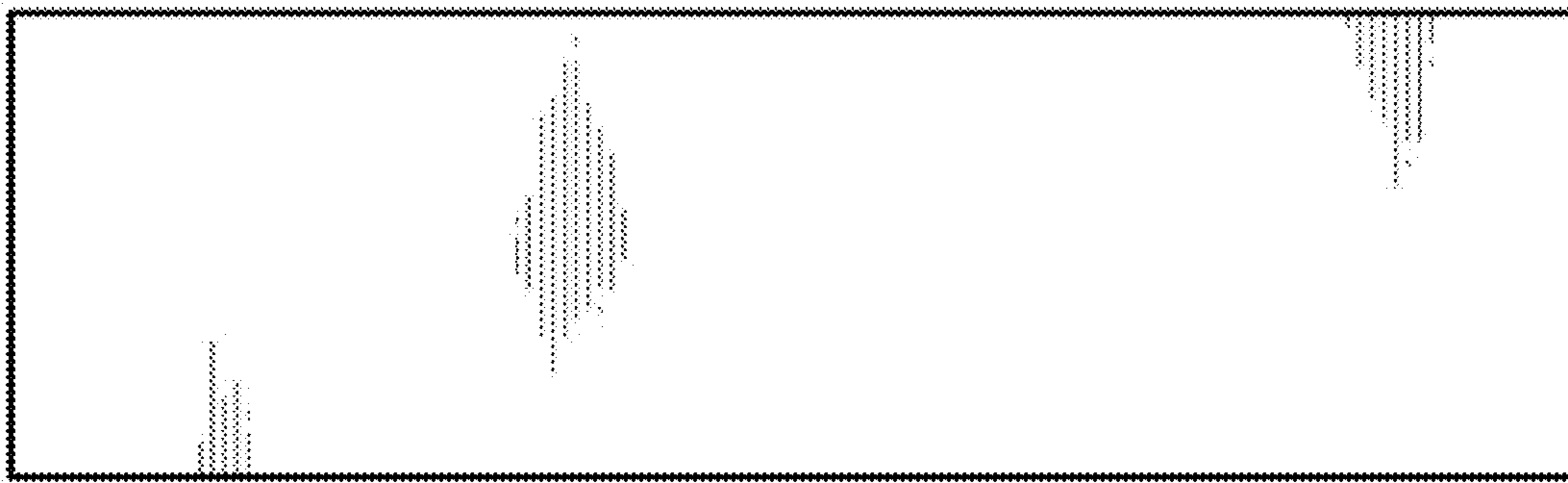

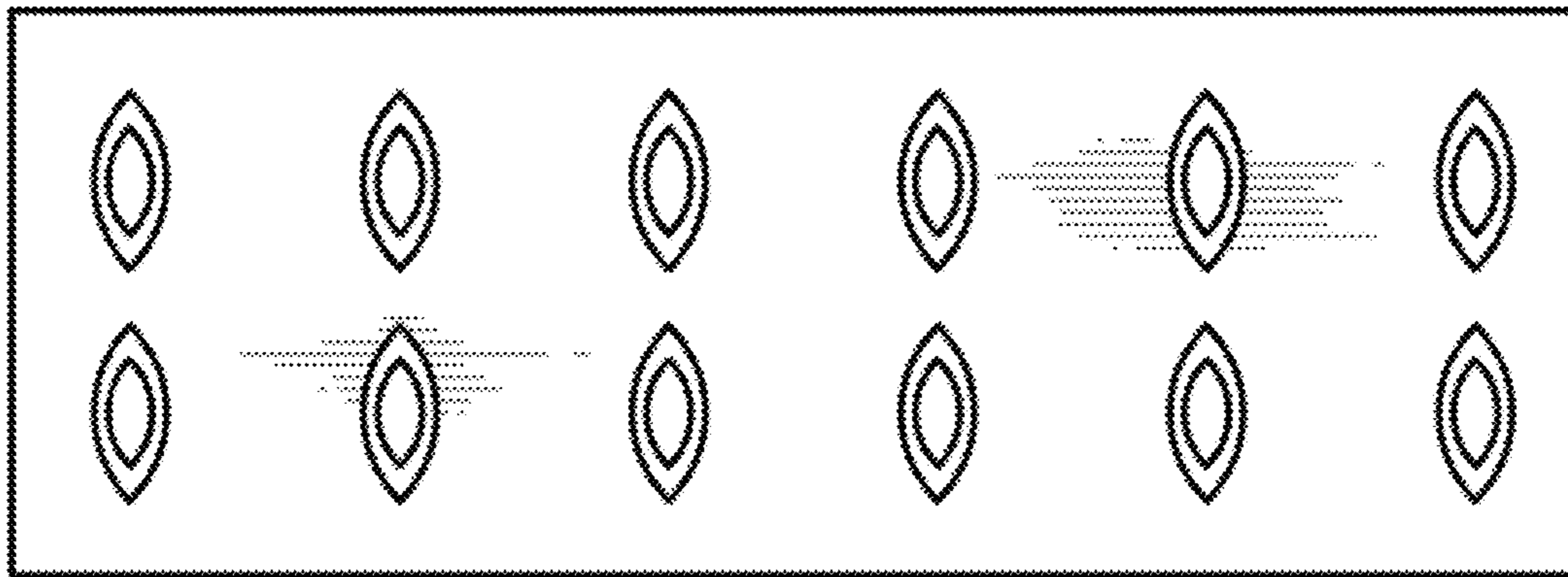
