DESCRIPTION

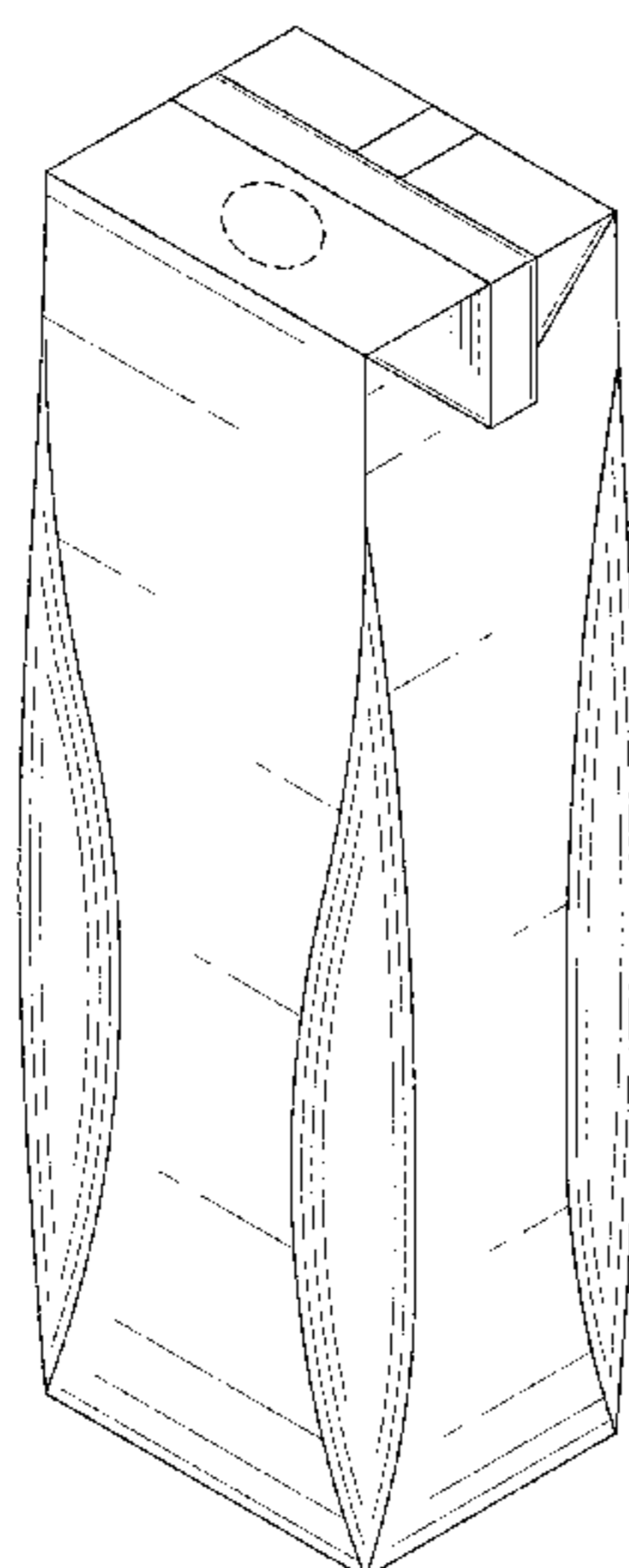
FIG. 1 is a front view thereof;

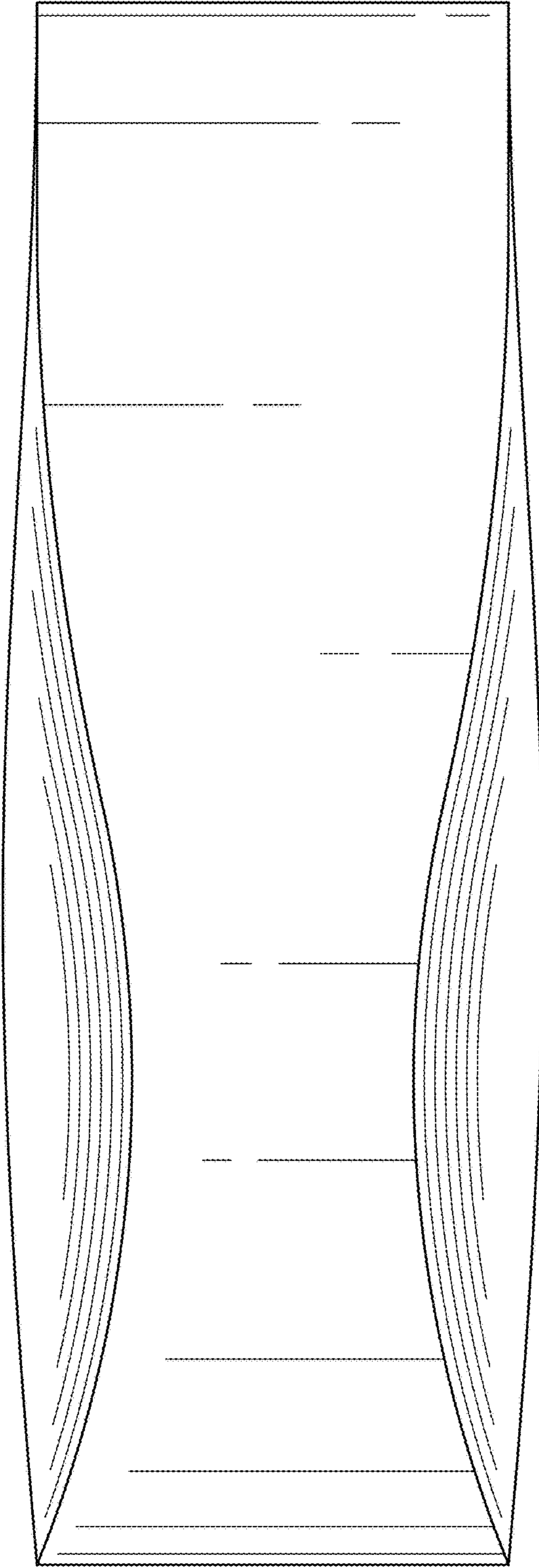

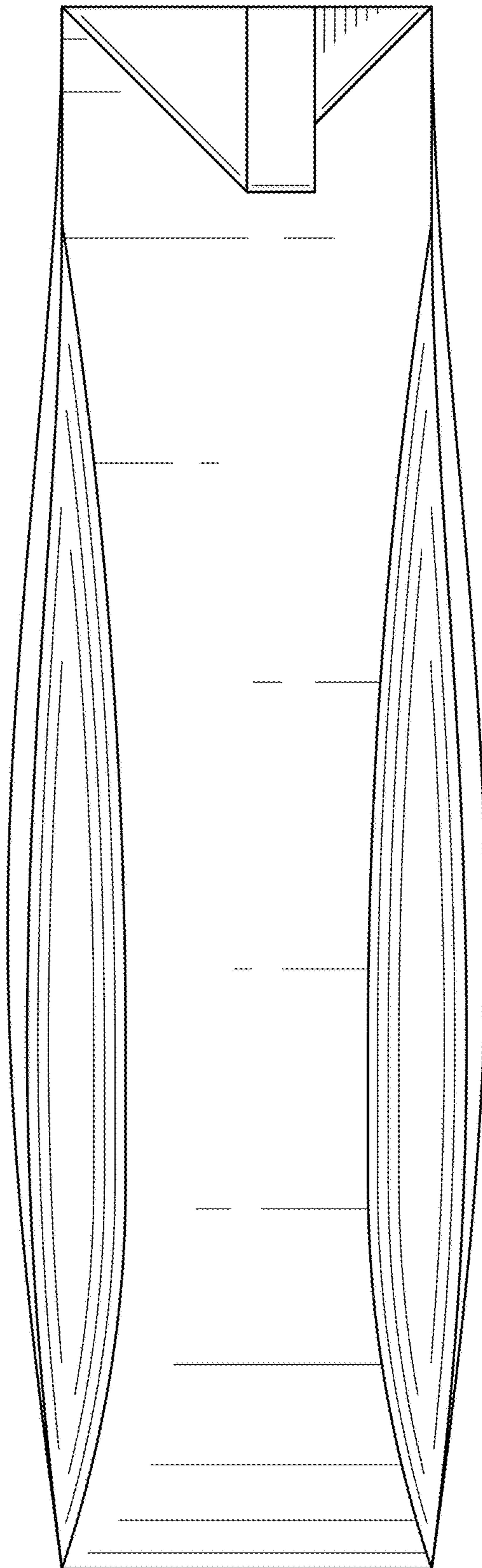

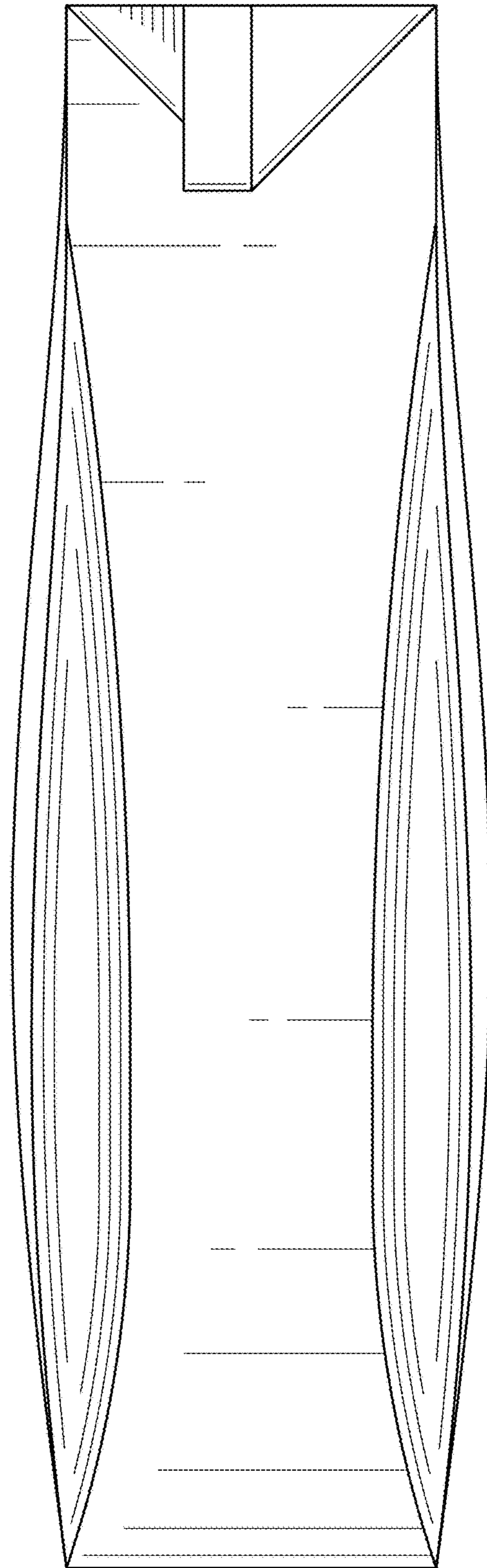

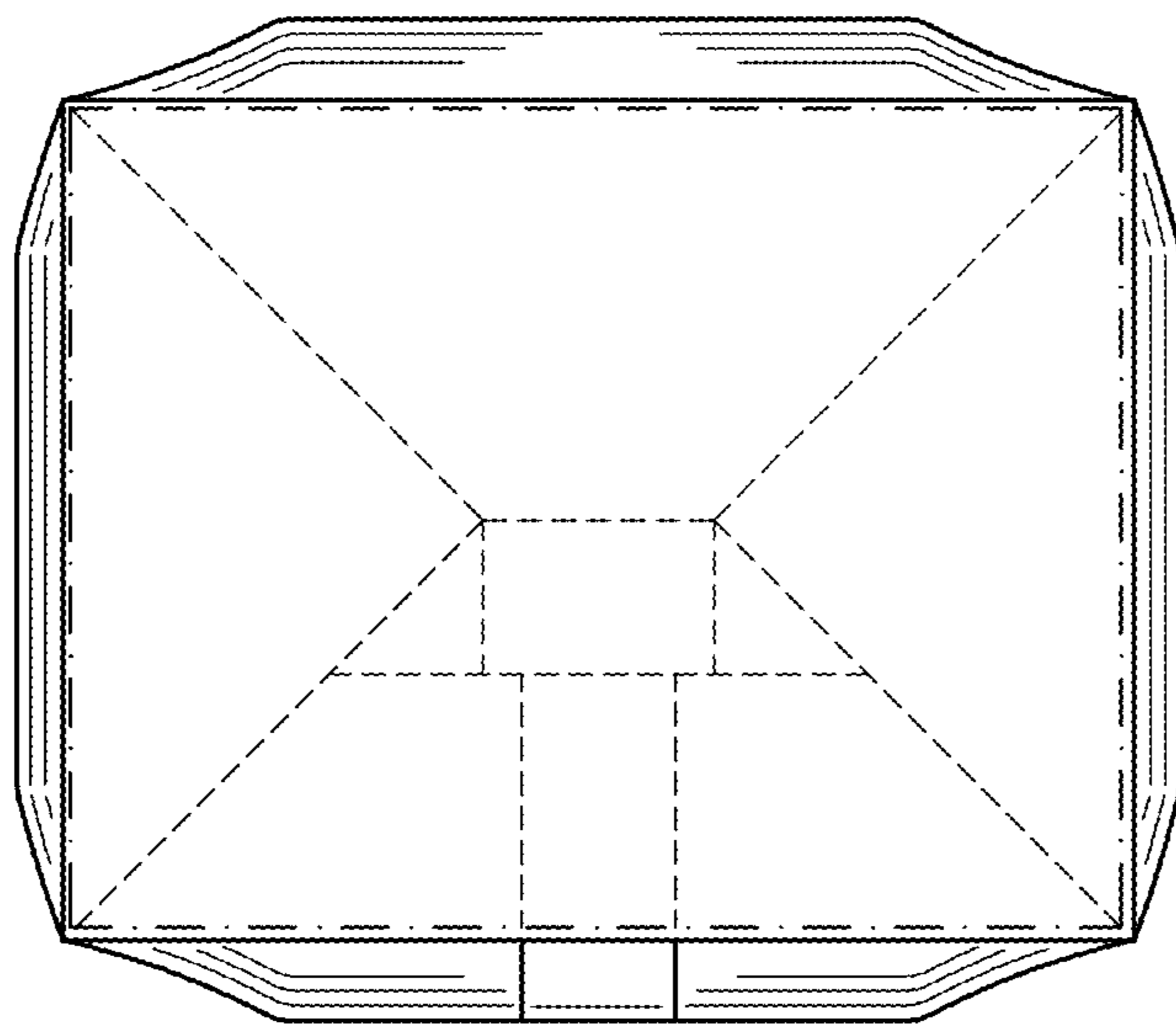

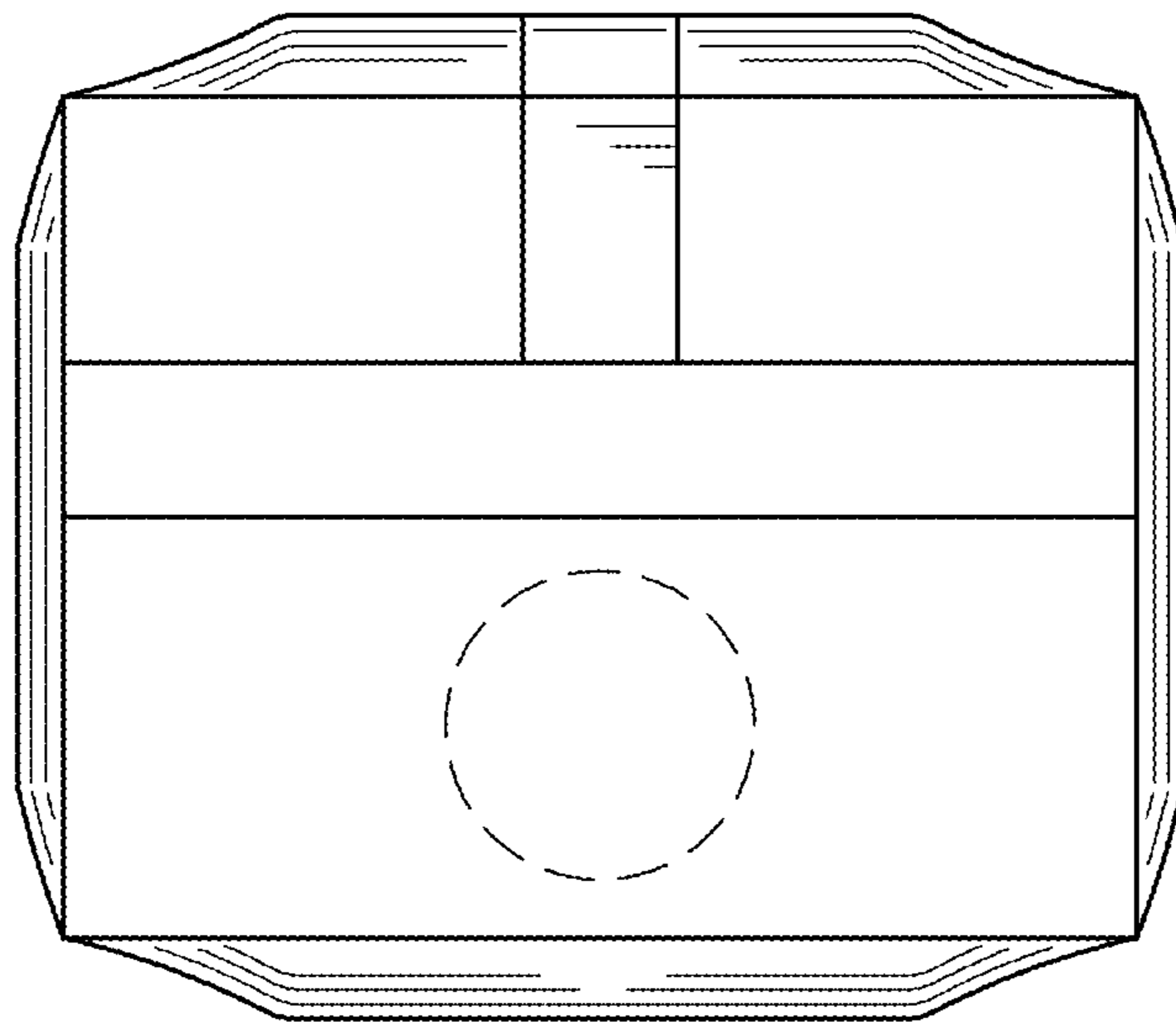

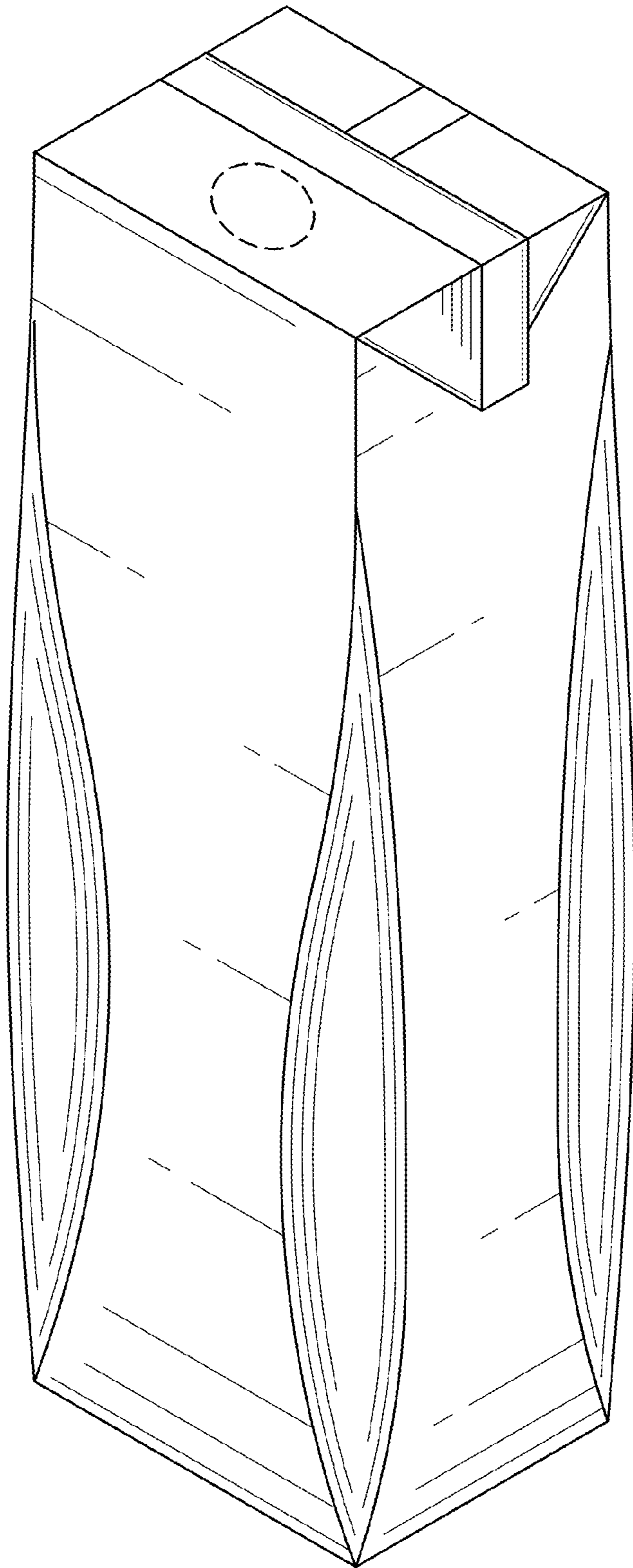

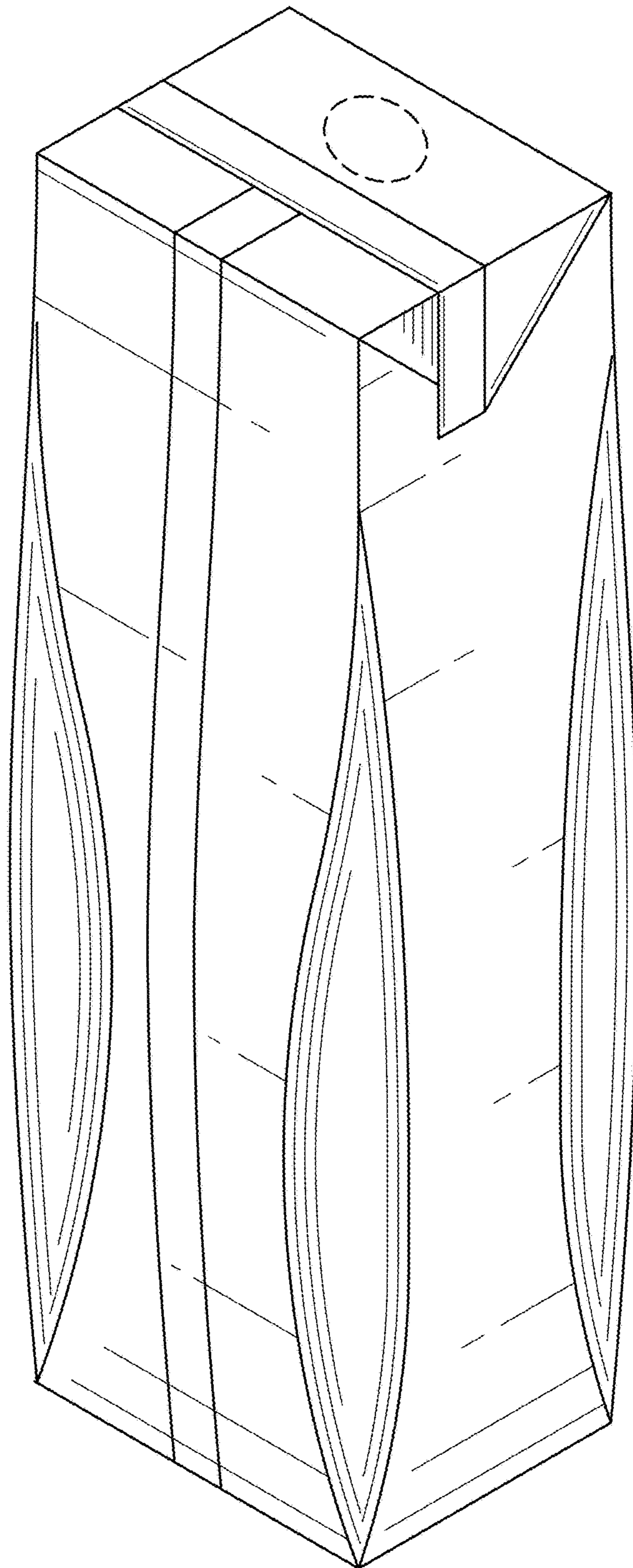
