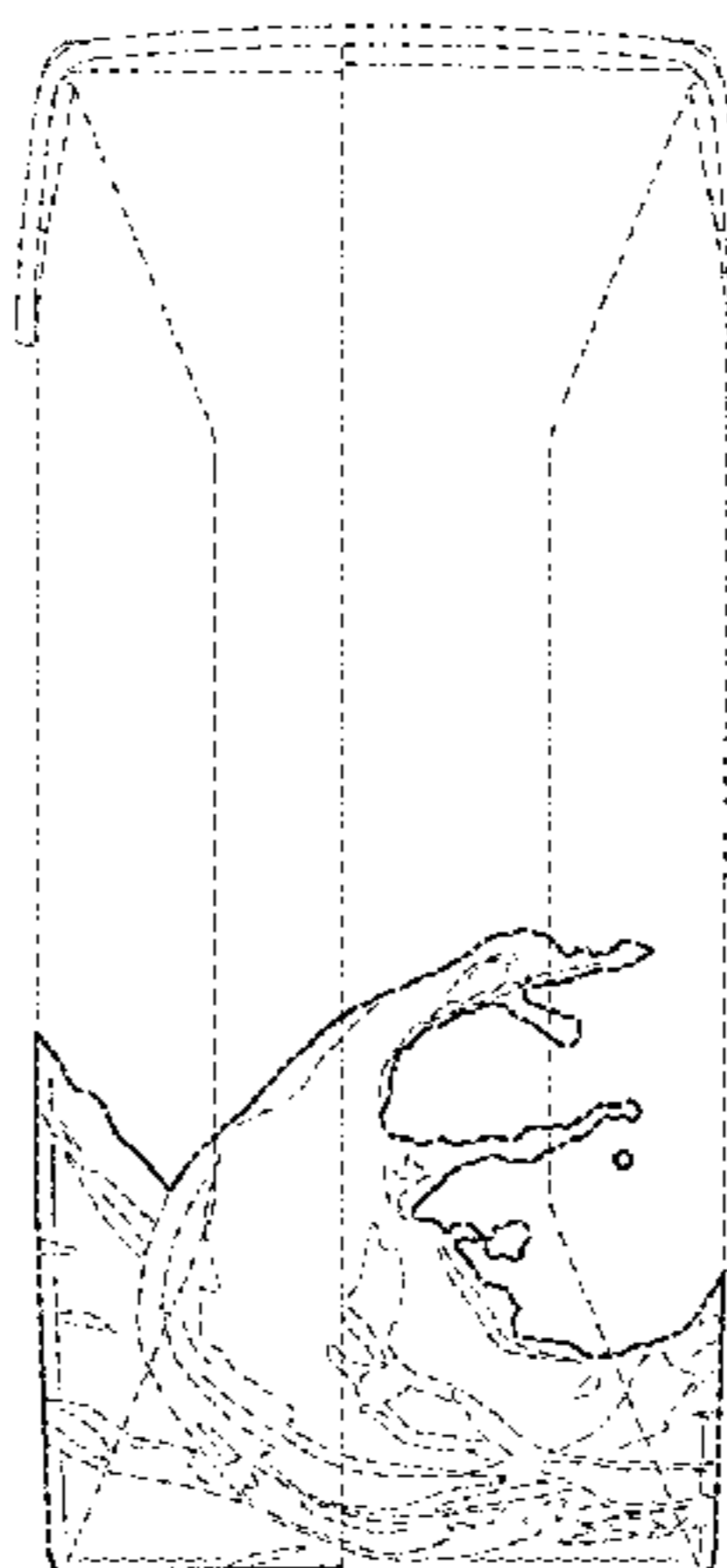
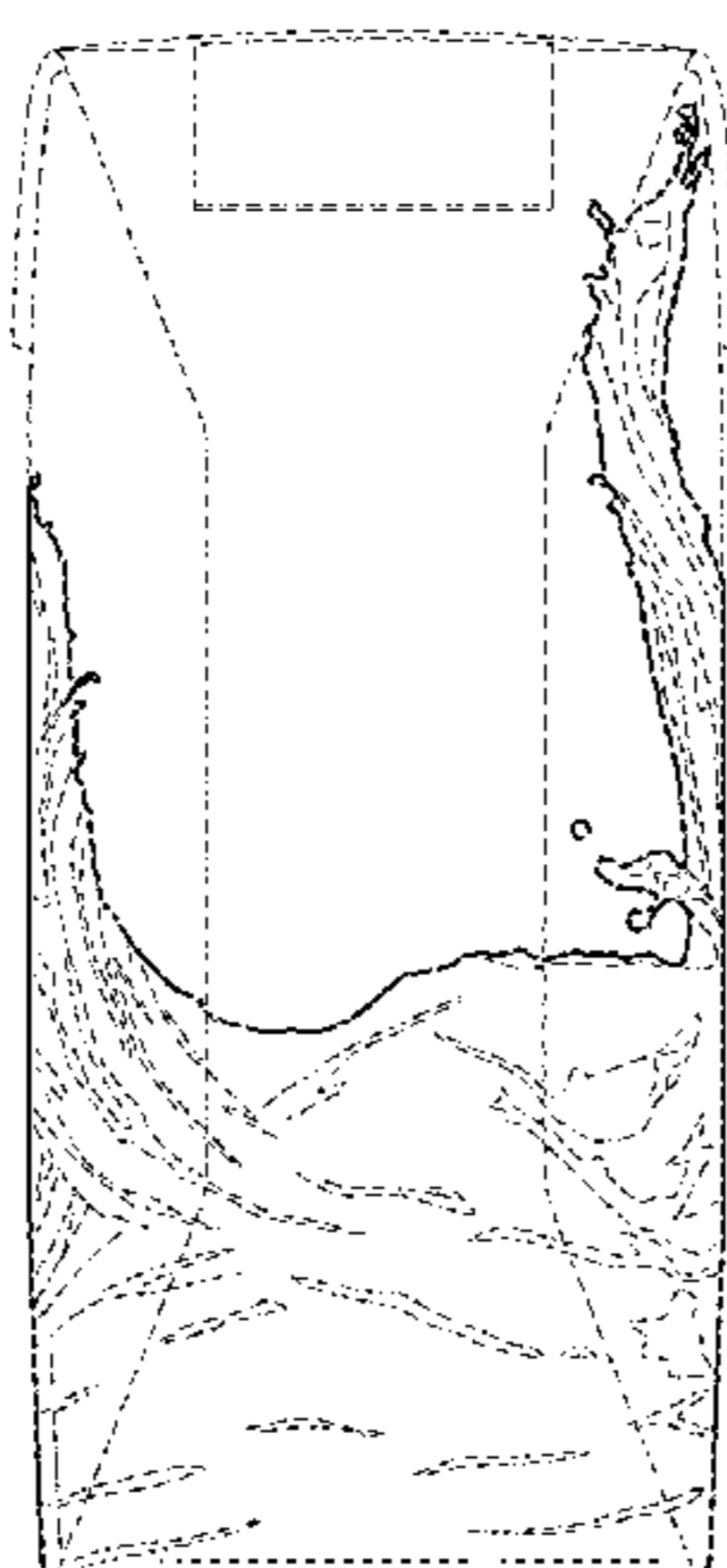
(57) **CLAIM**

I claim the ornamental design for a surface ornamentation for a container, as shown and described.

**DESCRIPTION**

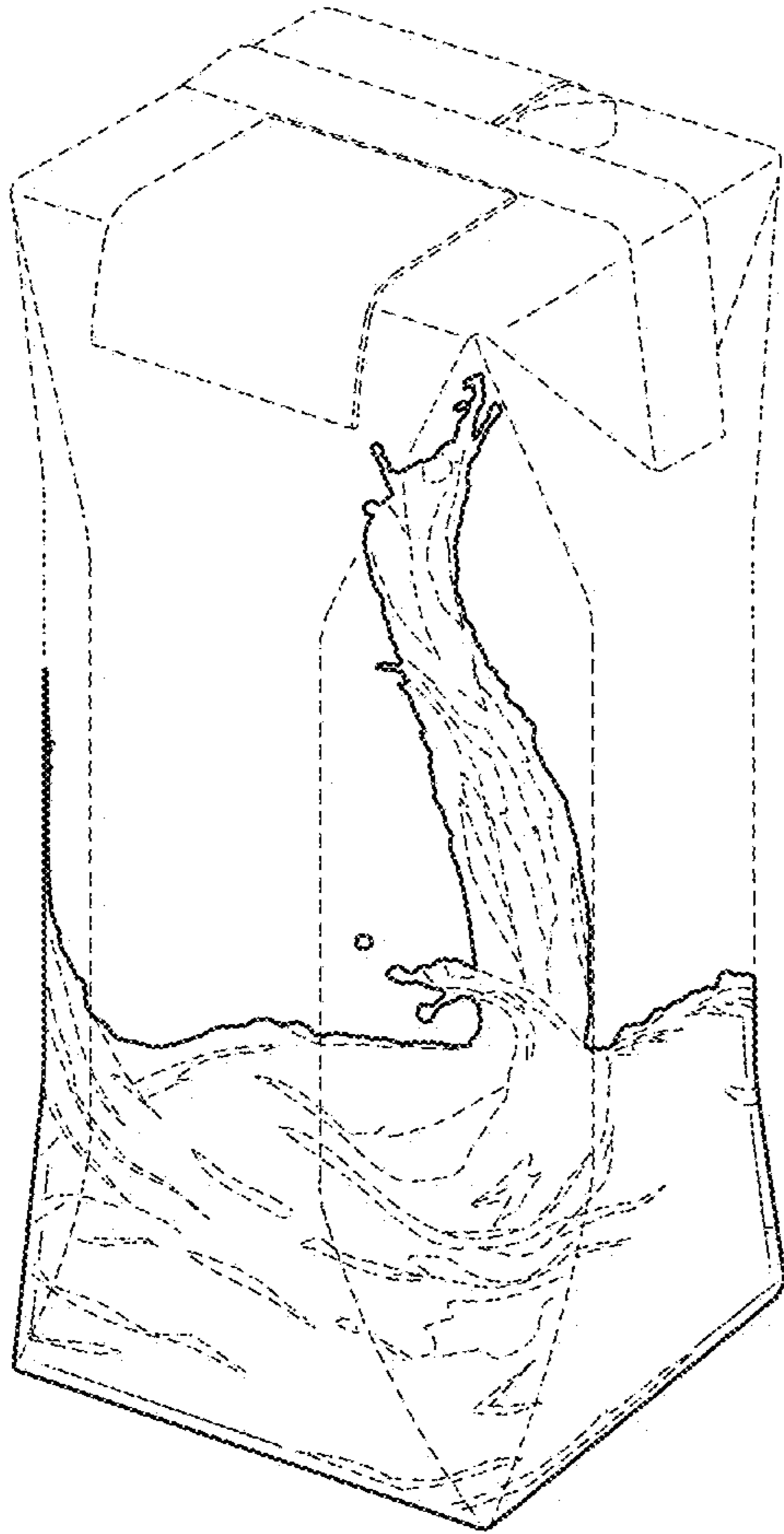
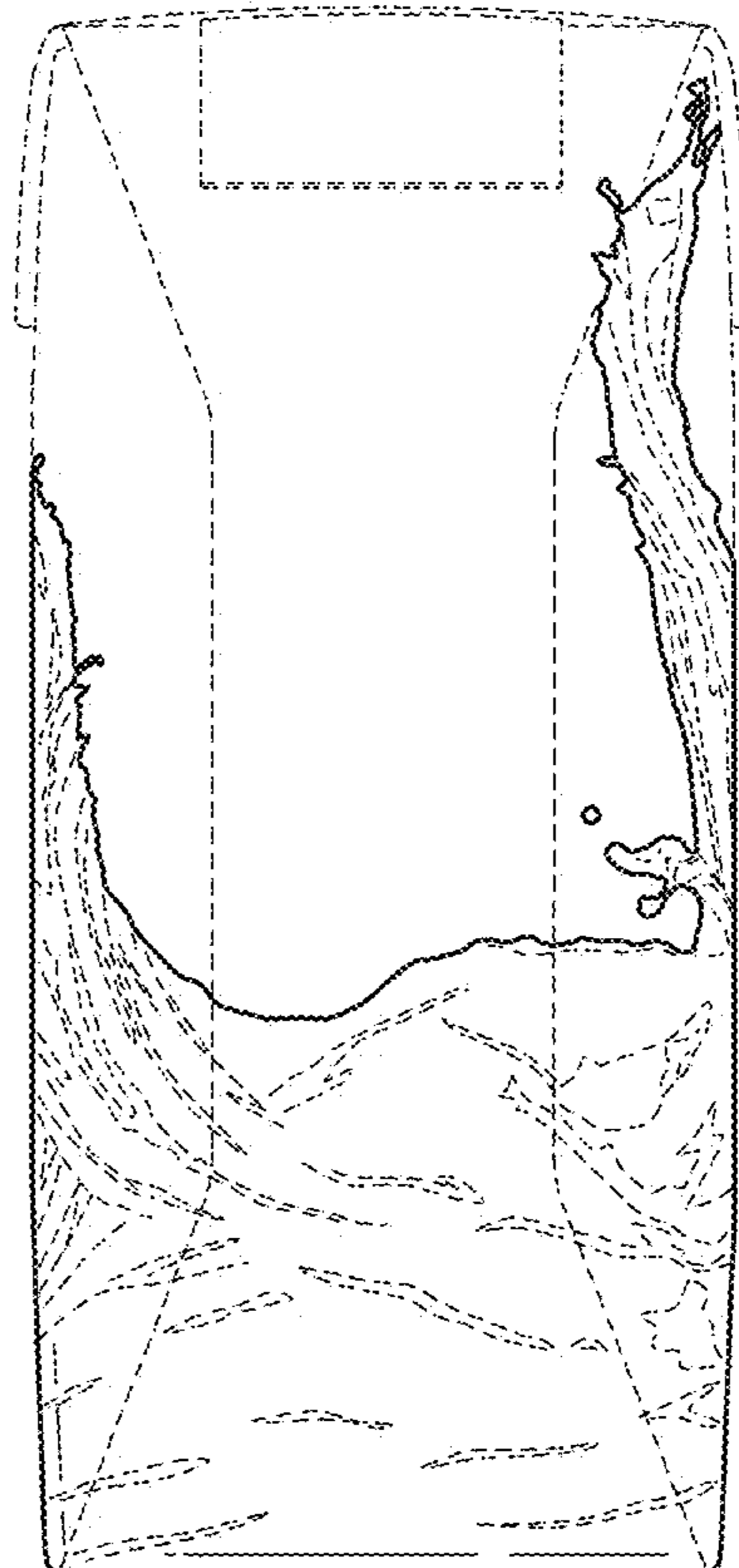

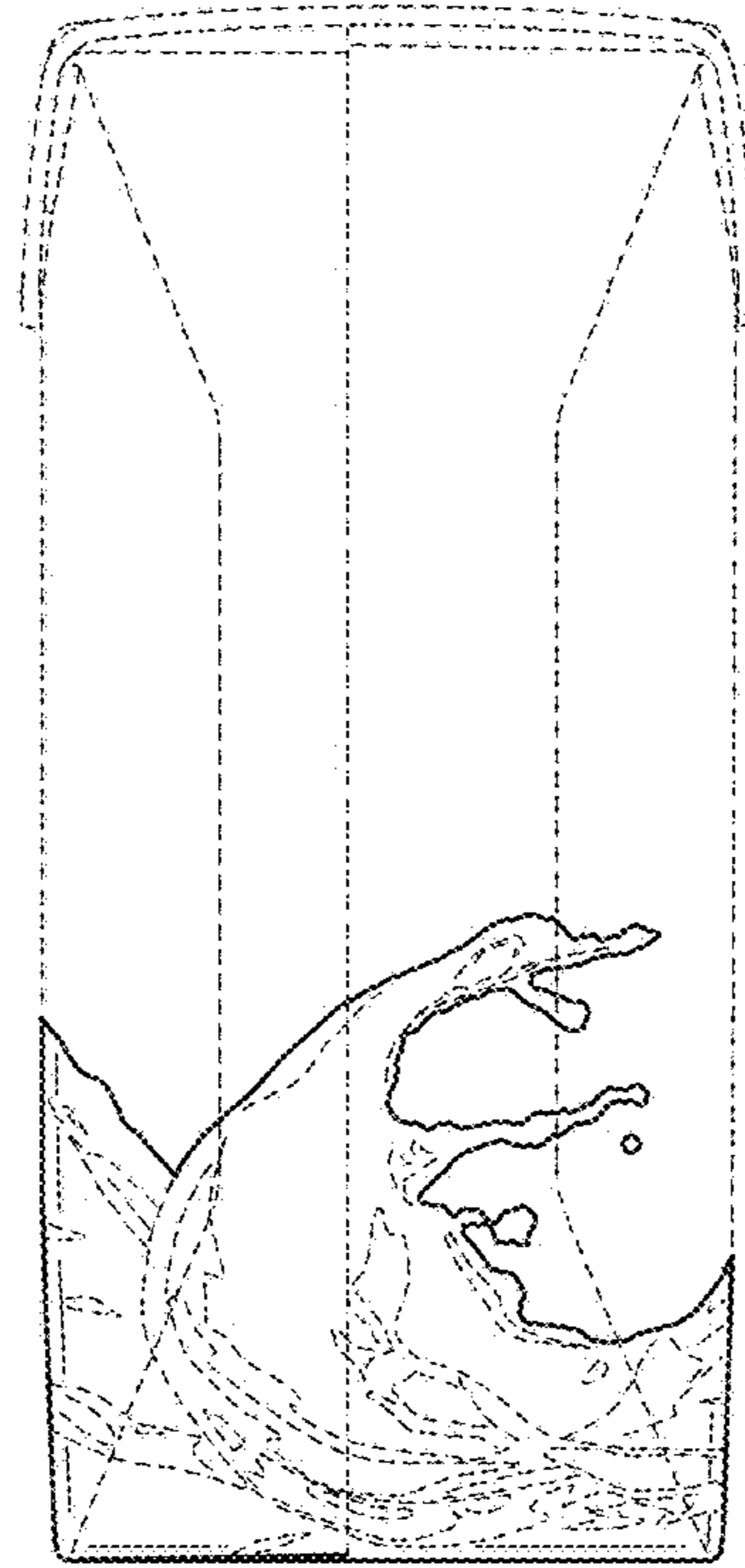

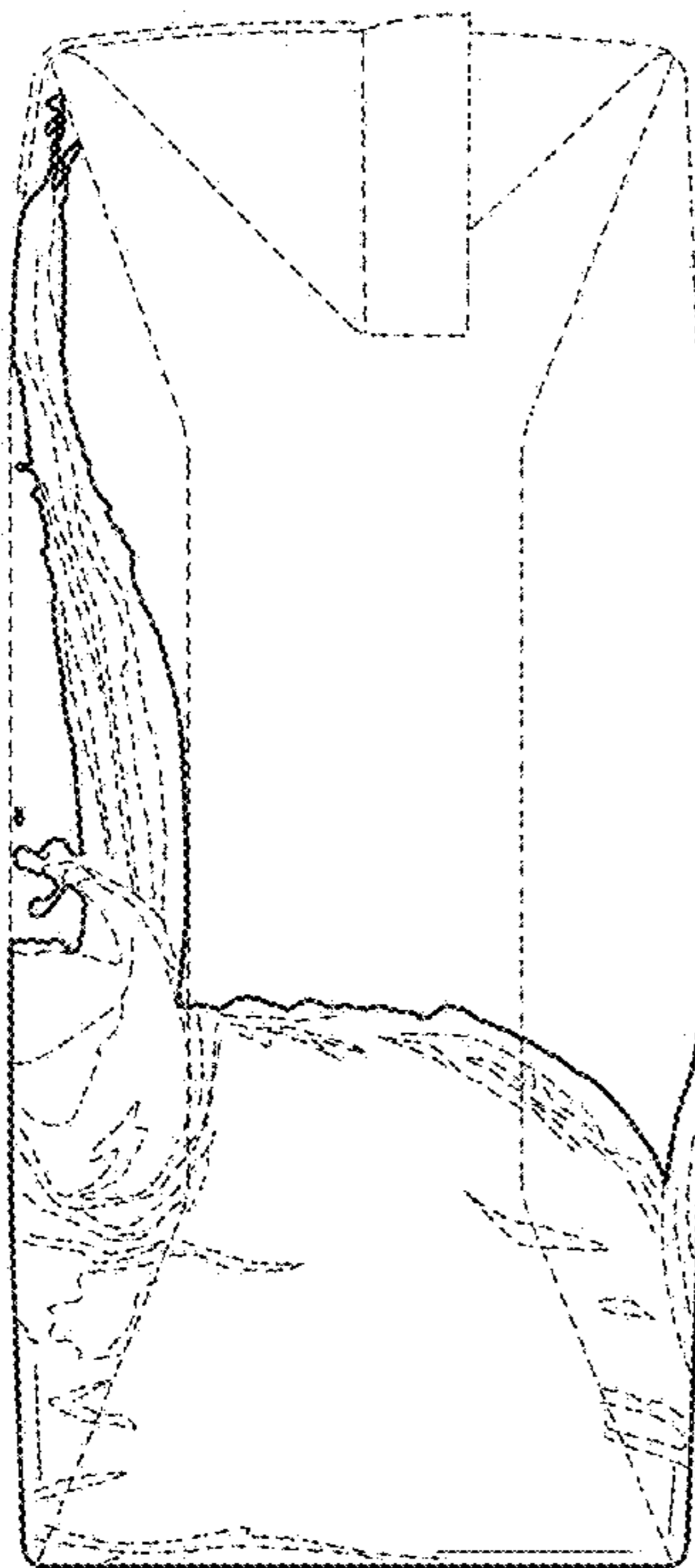

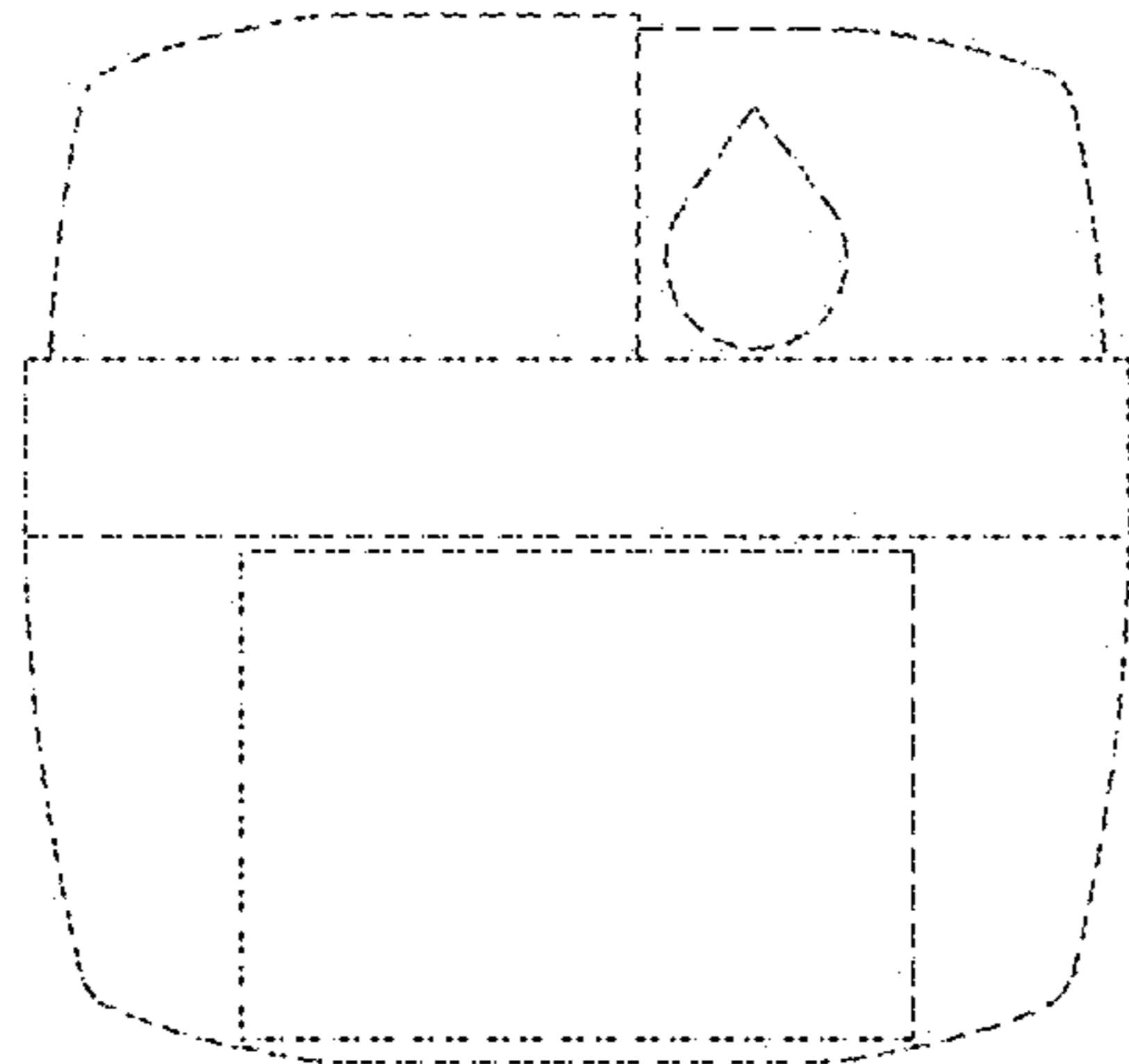

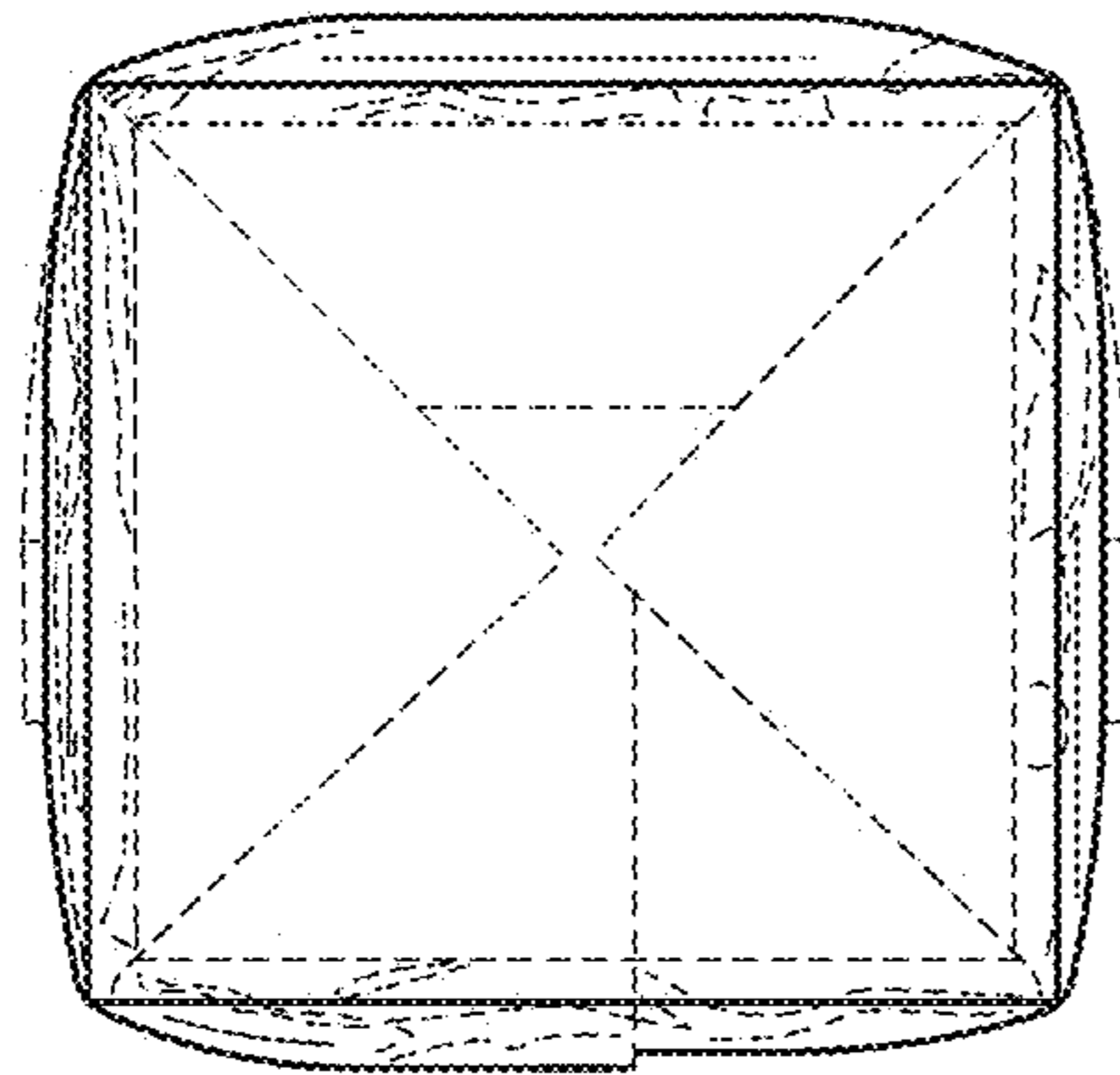

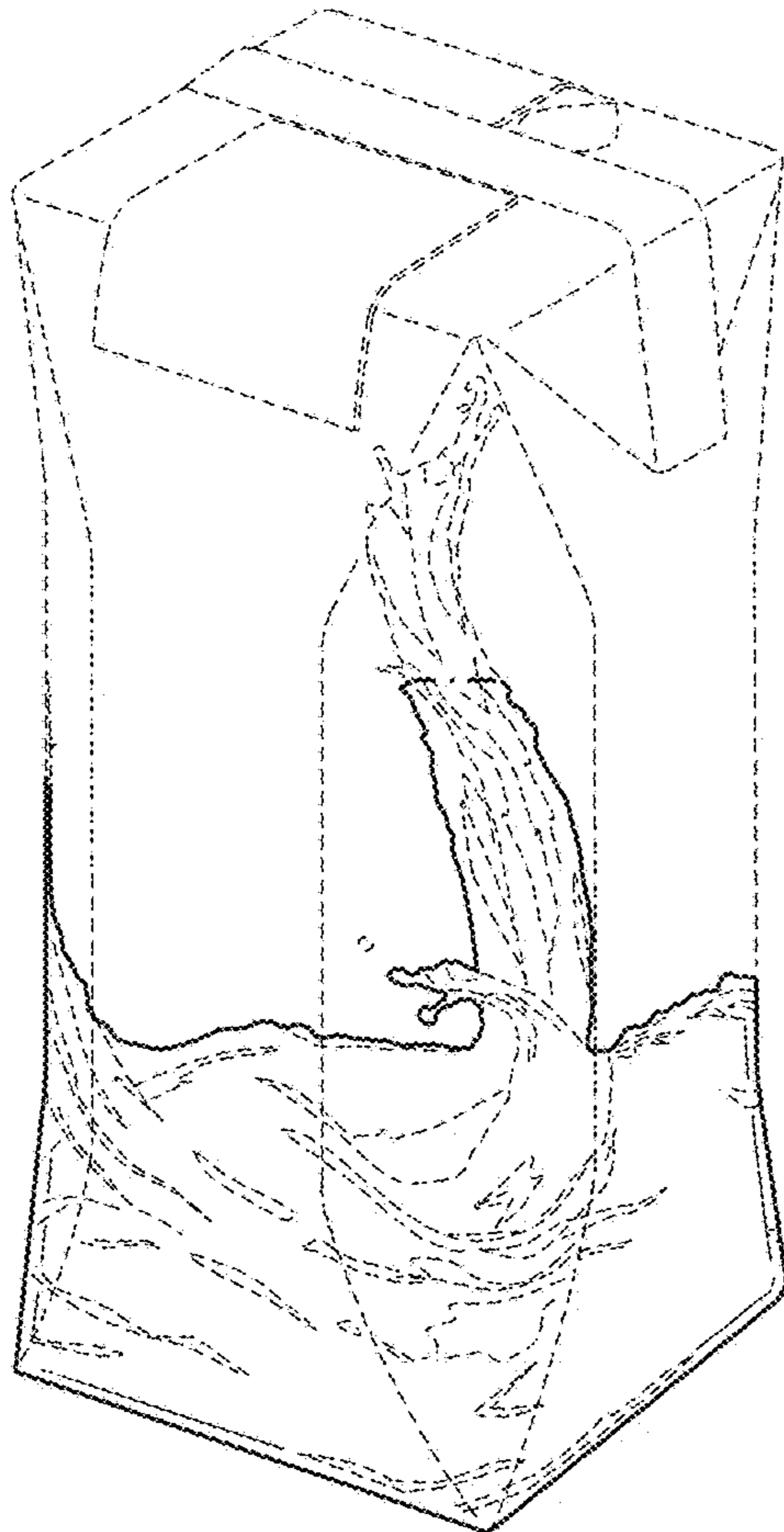

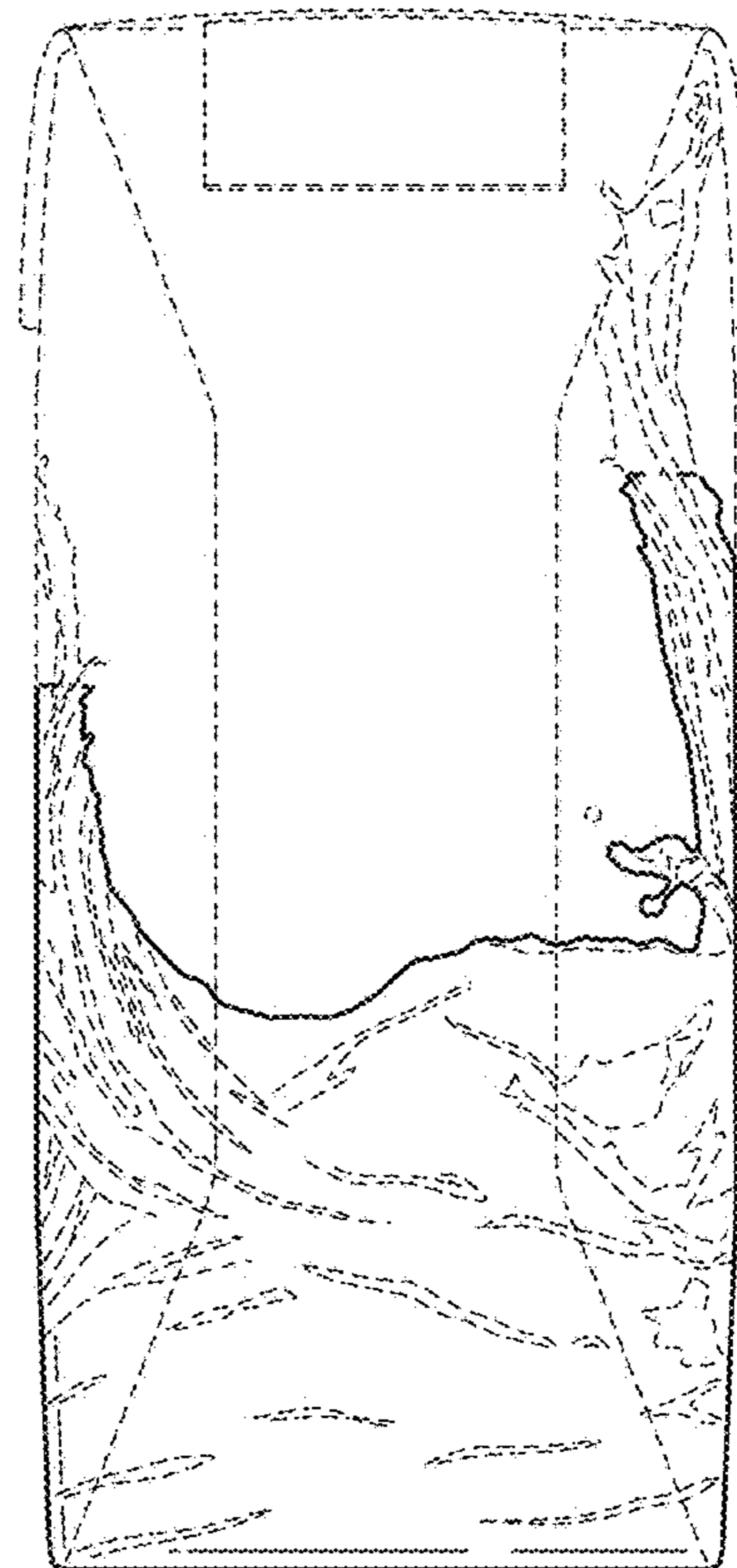

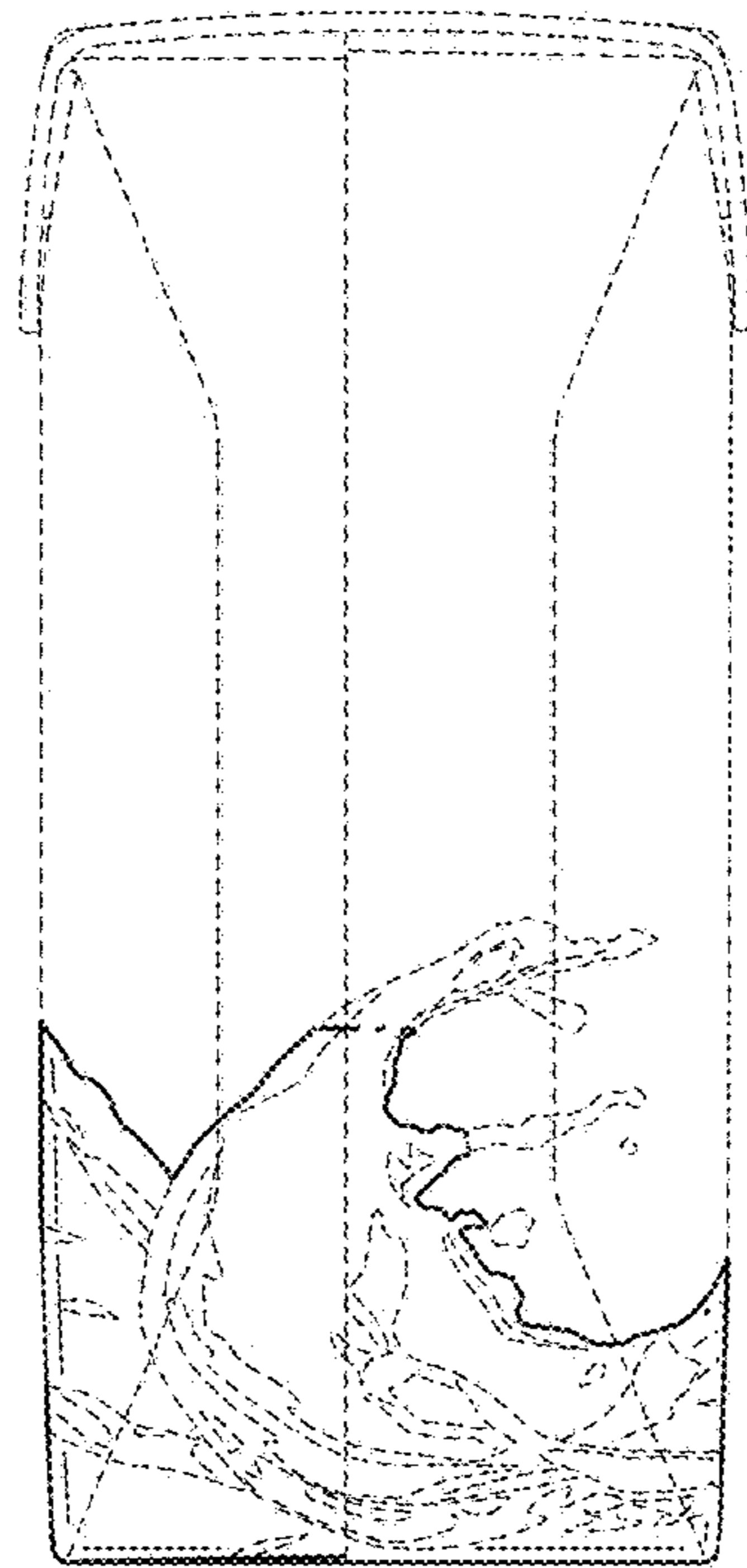

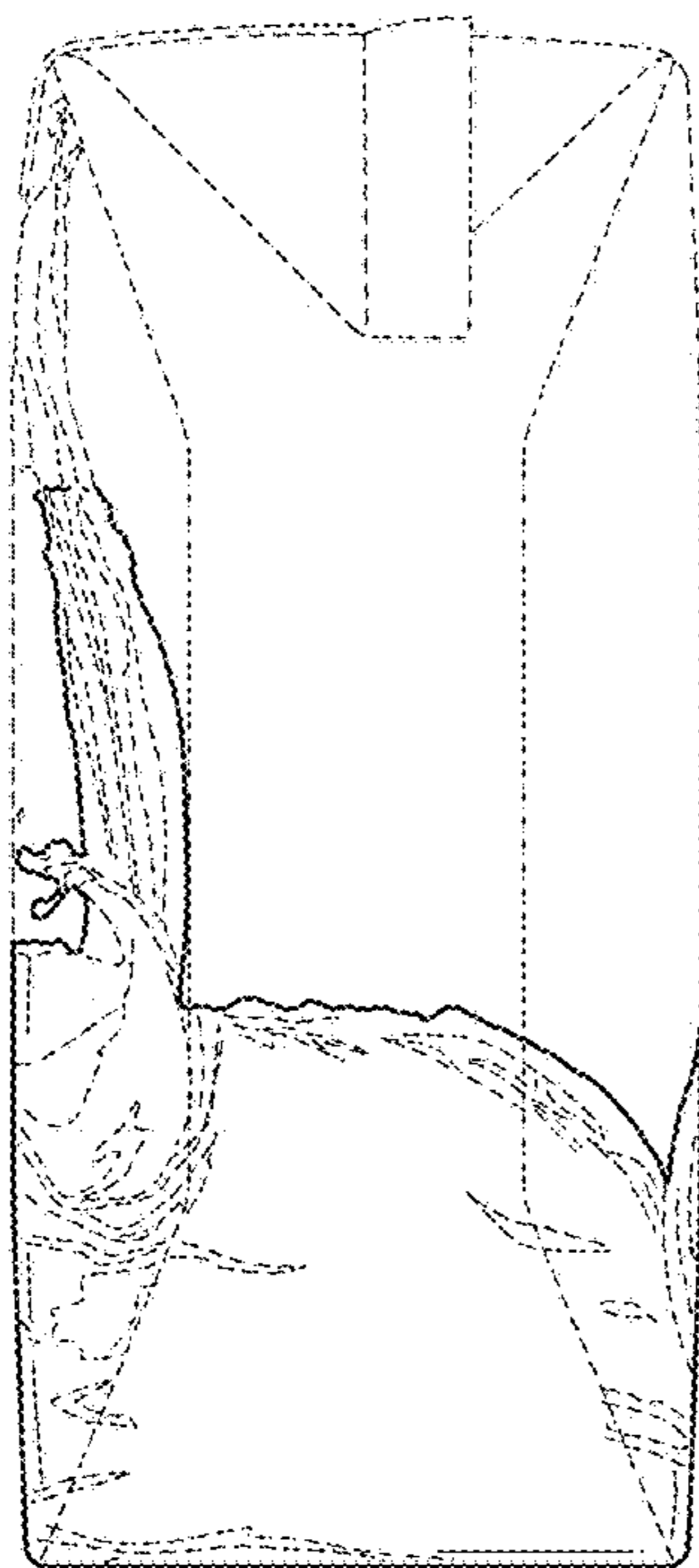

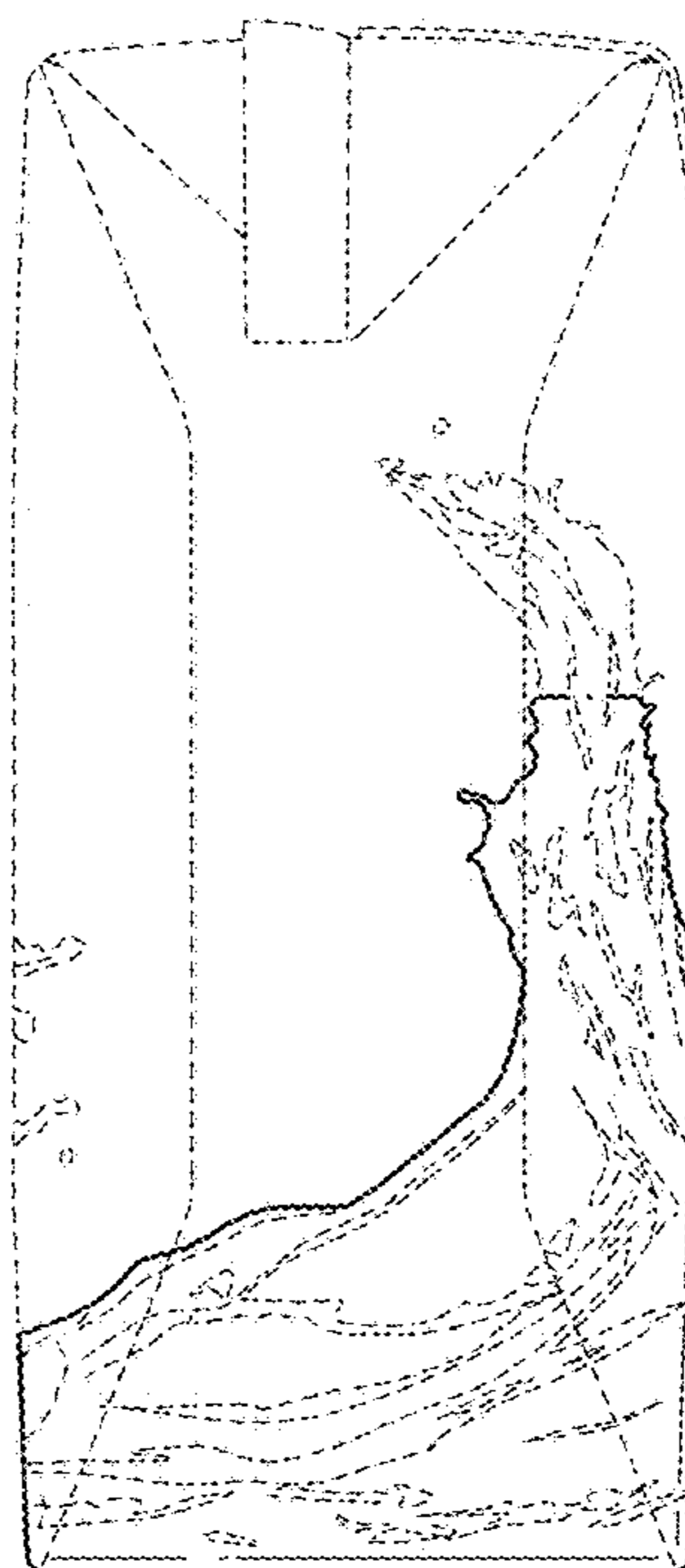

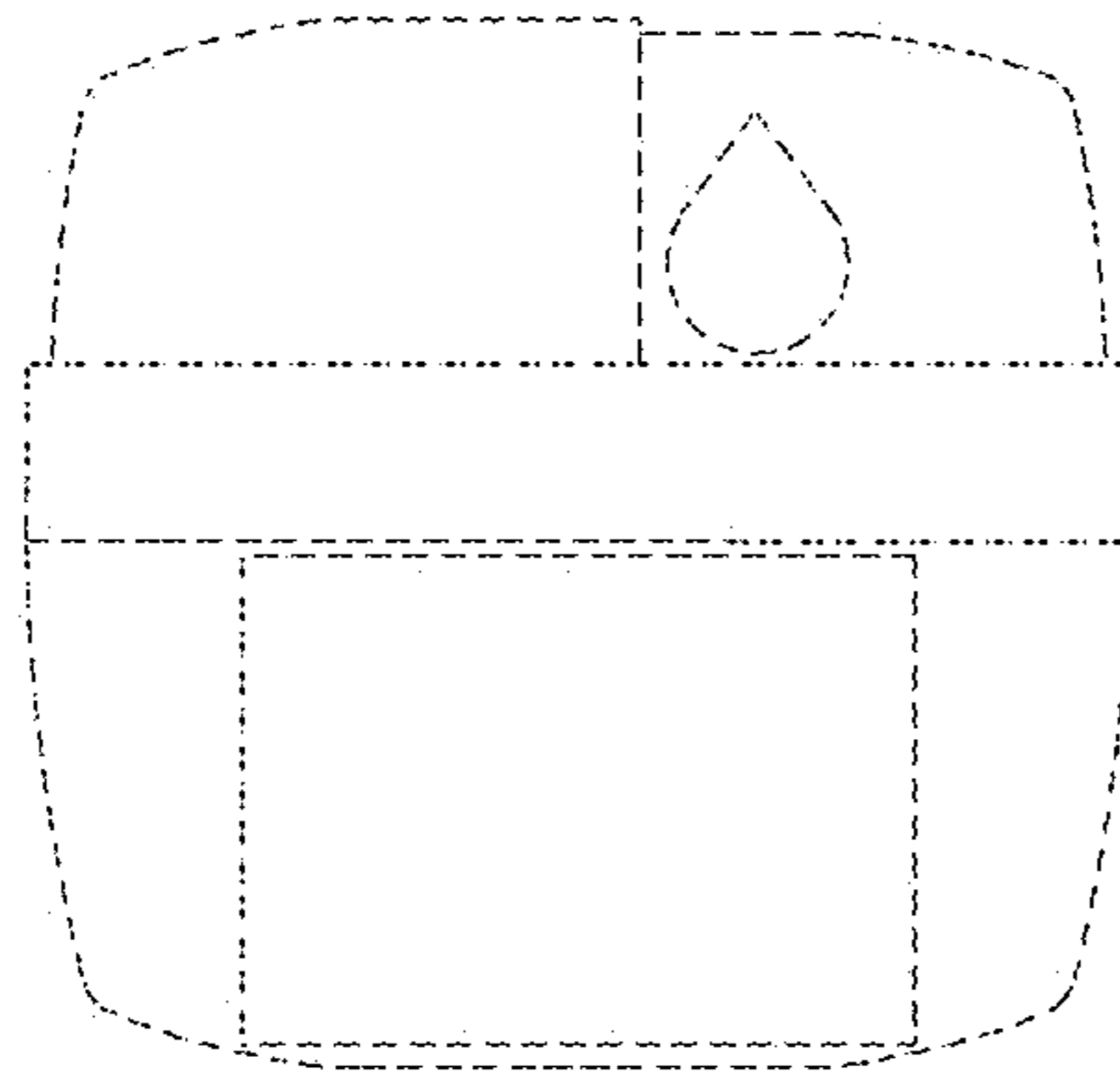

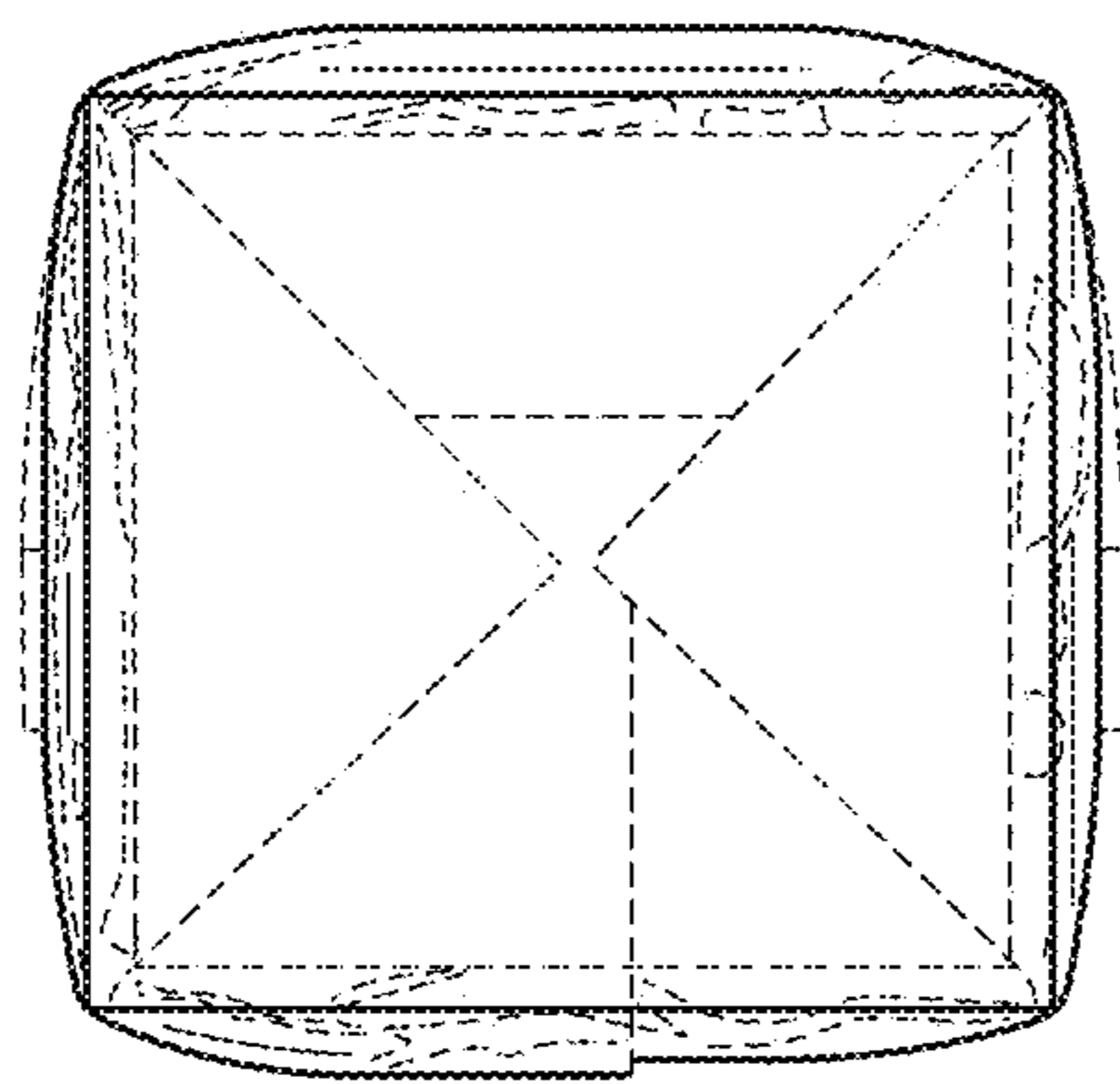

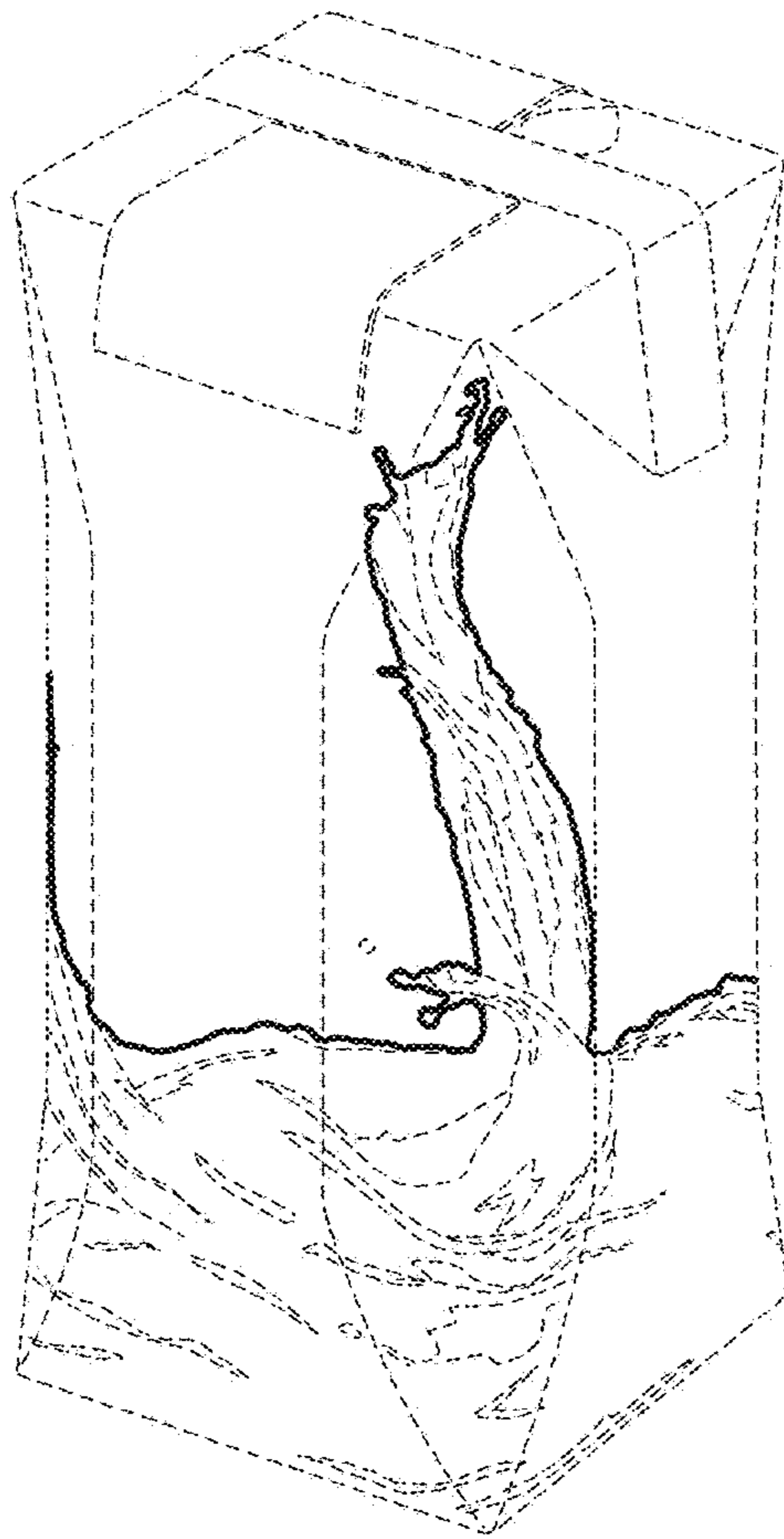
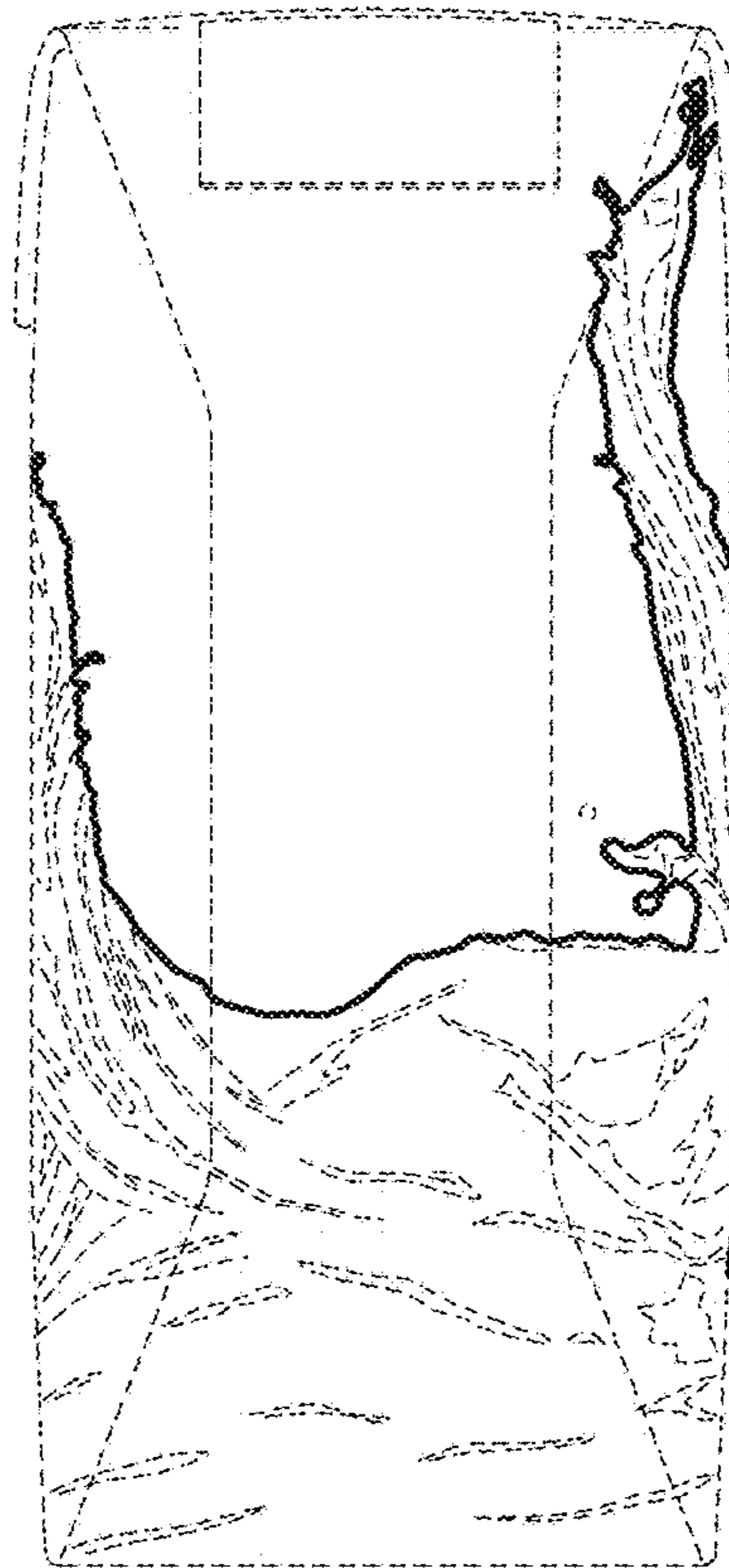

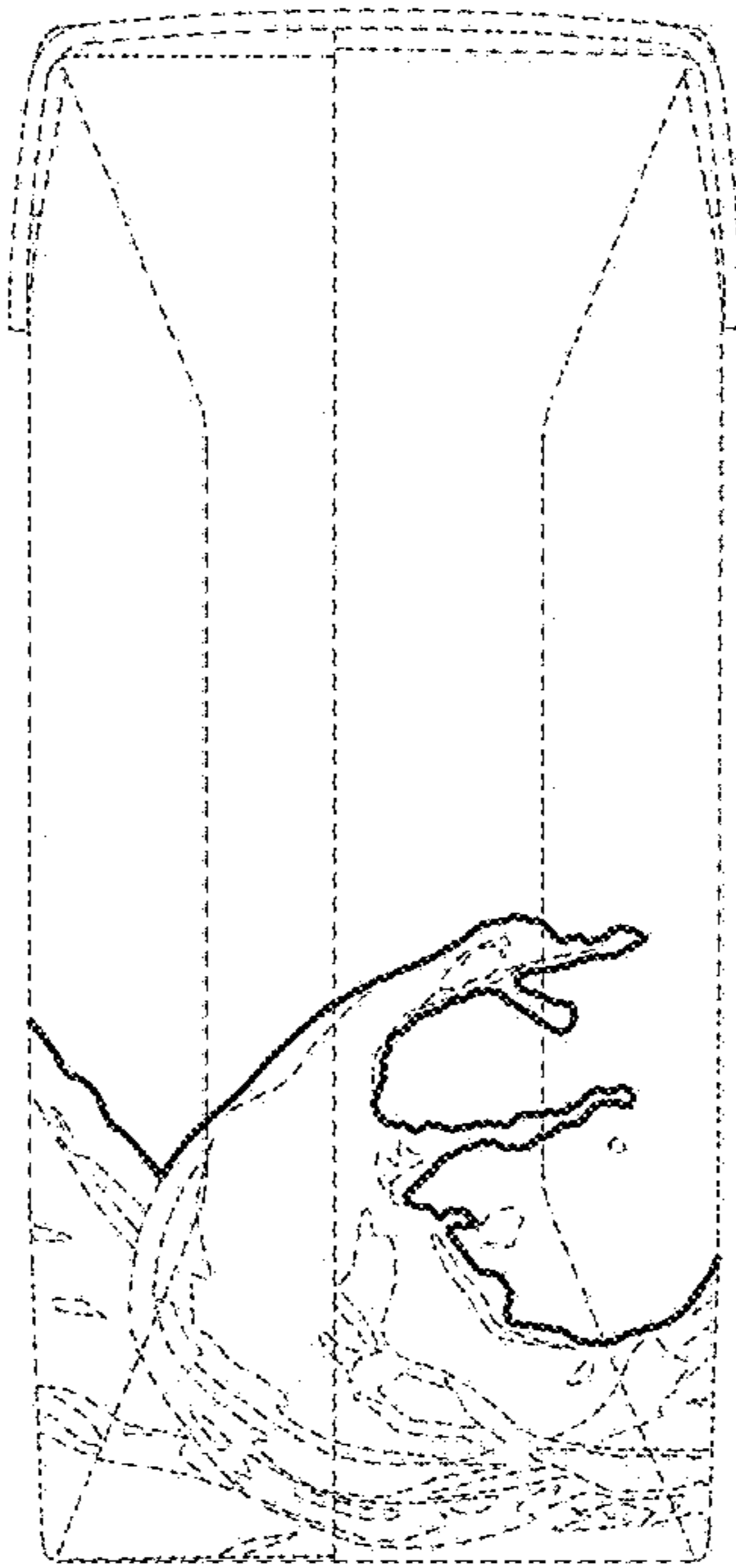

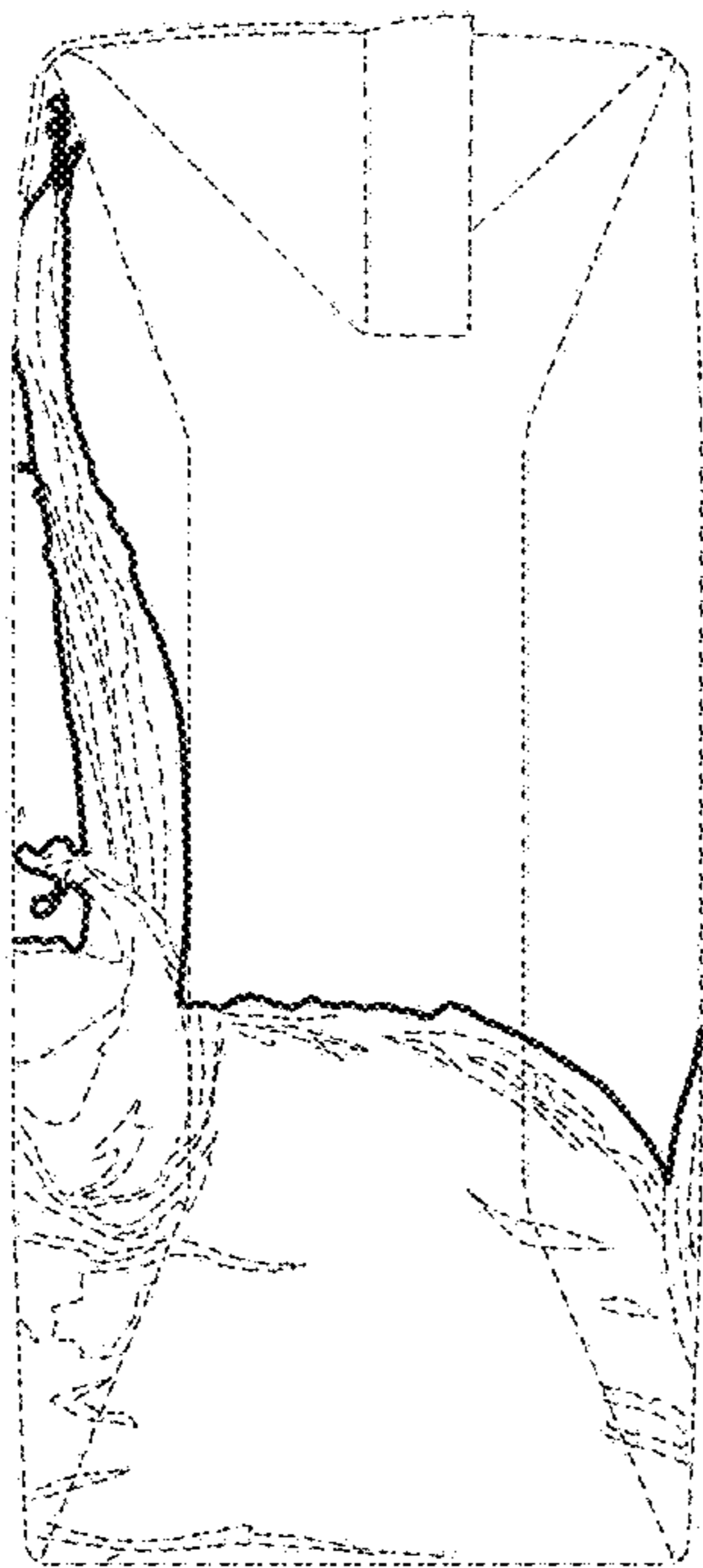

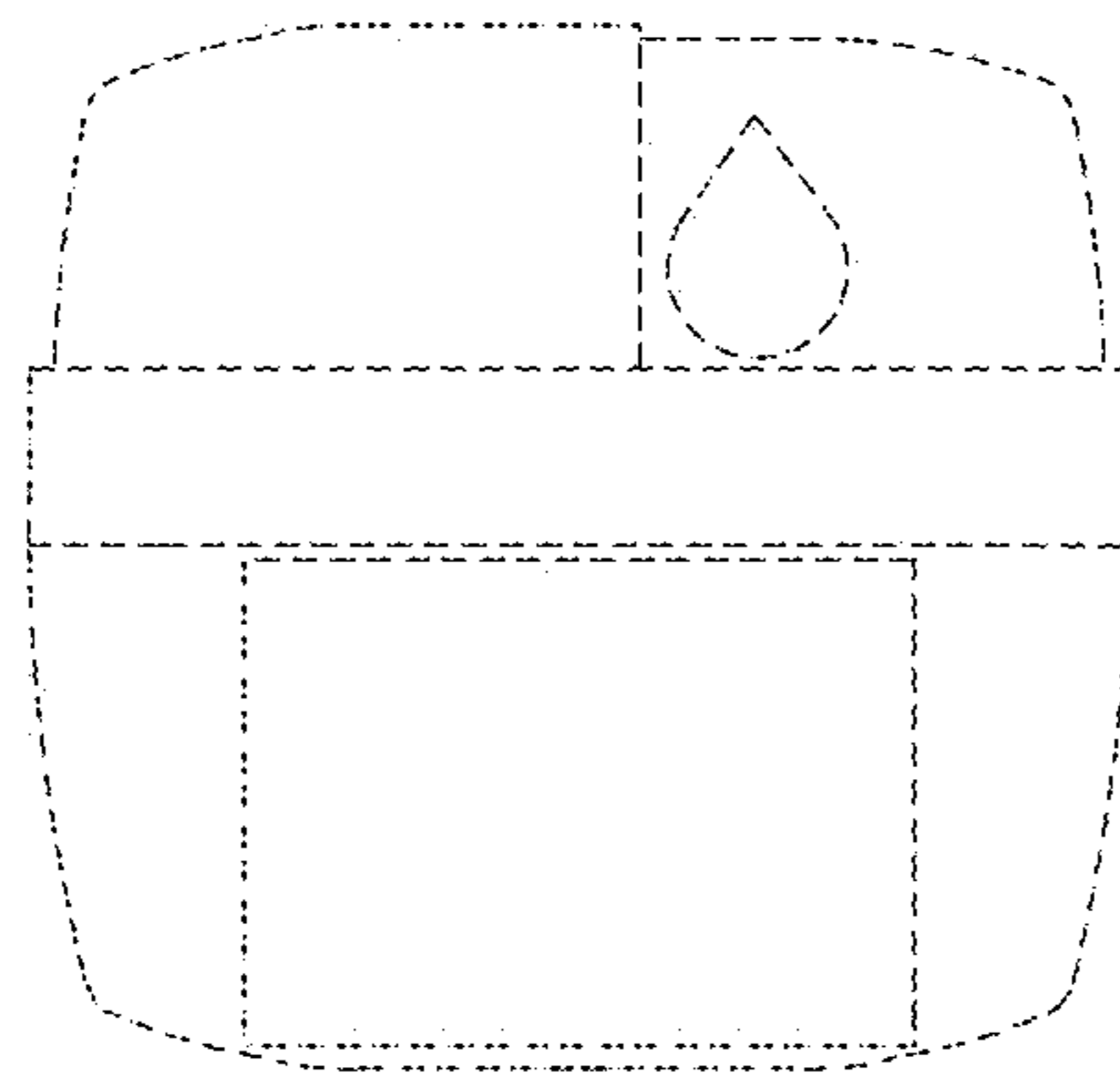

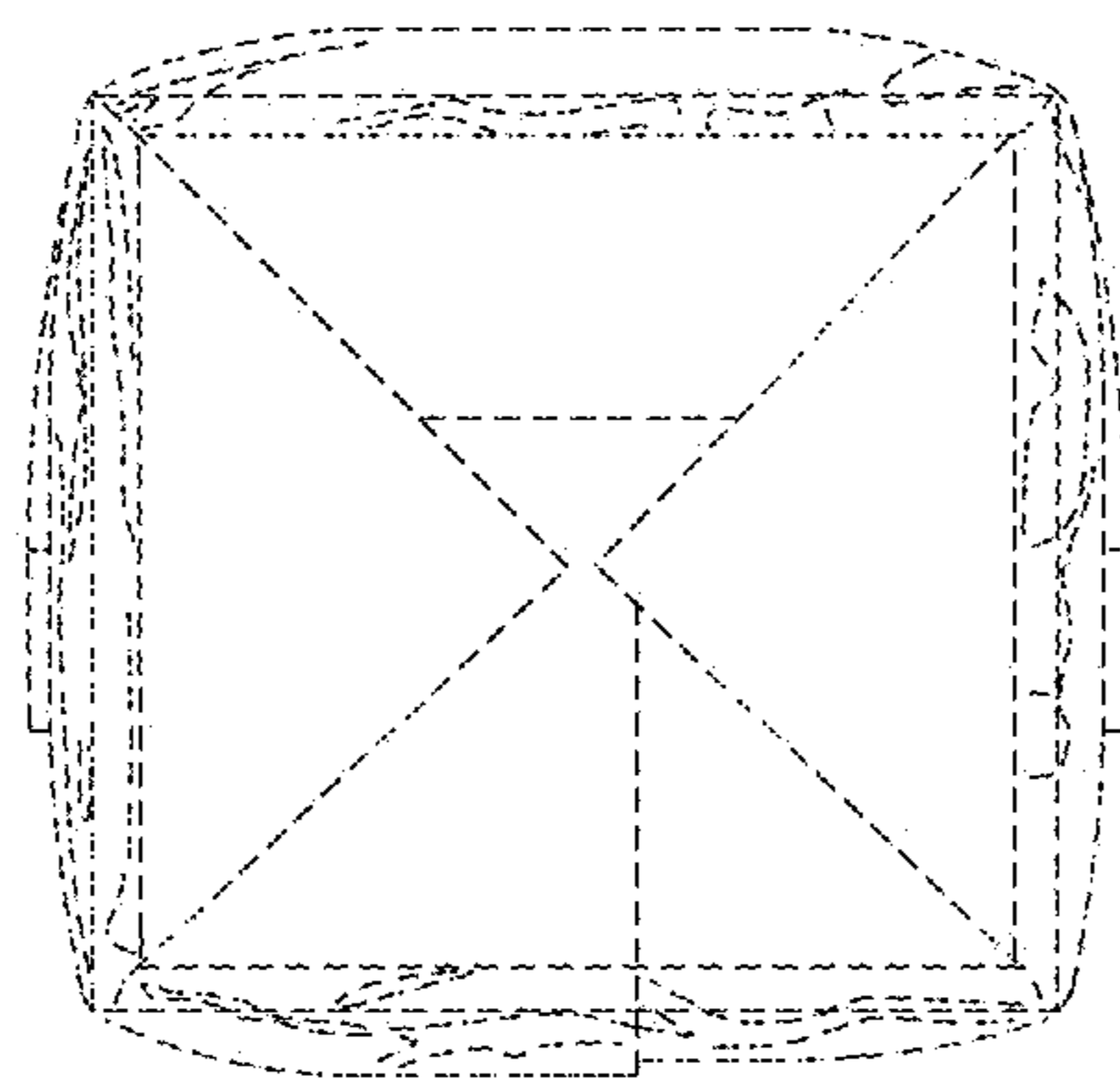

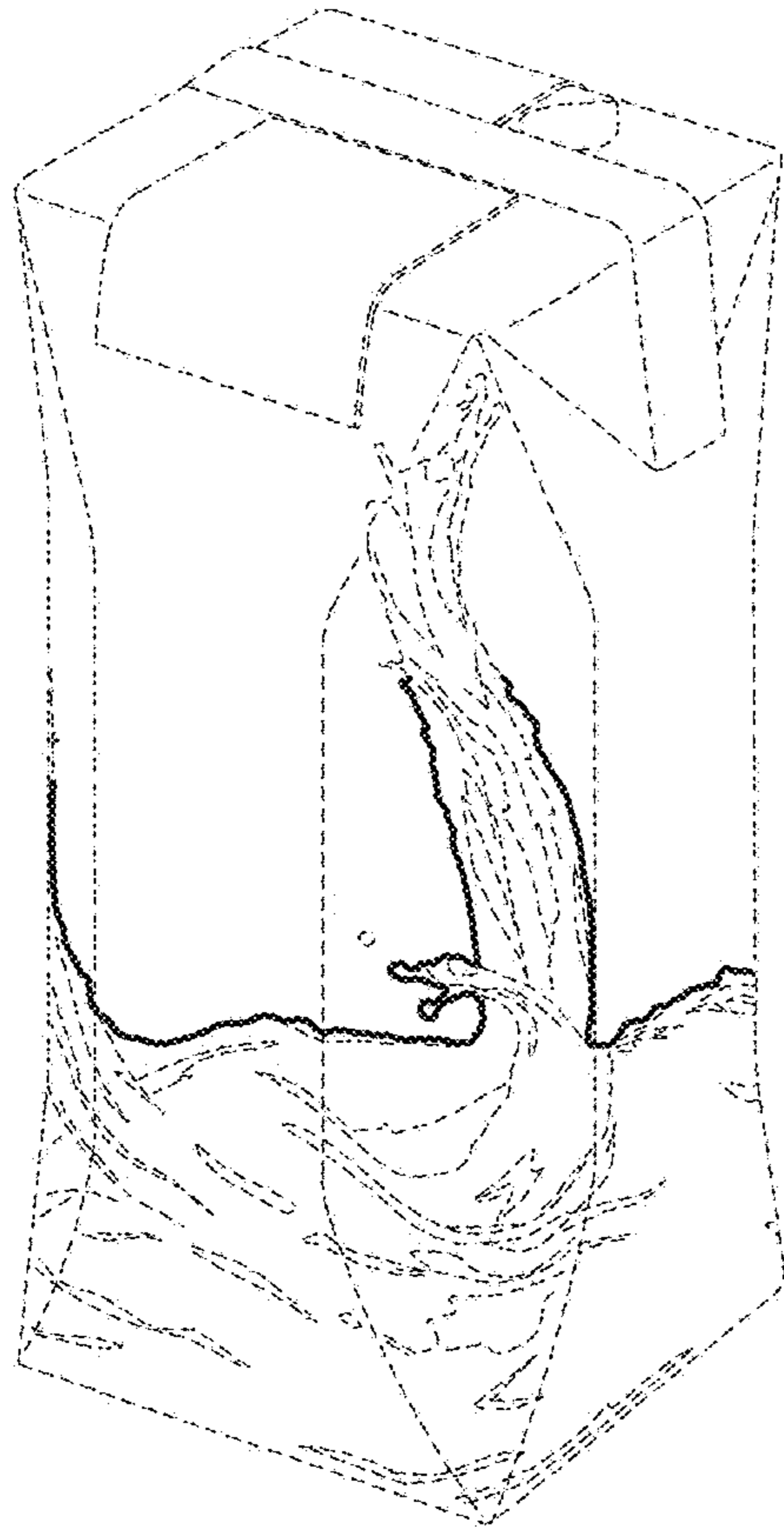

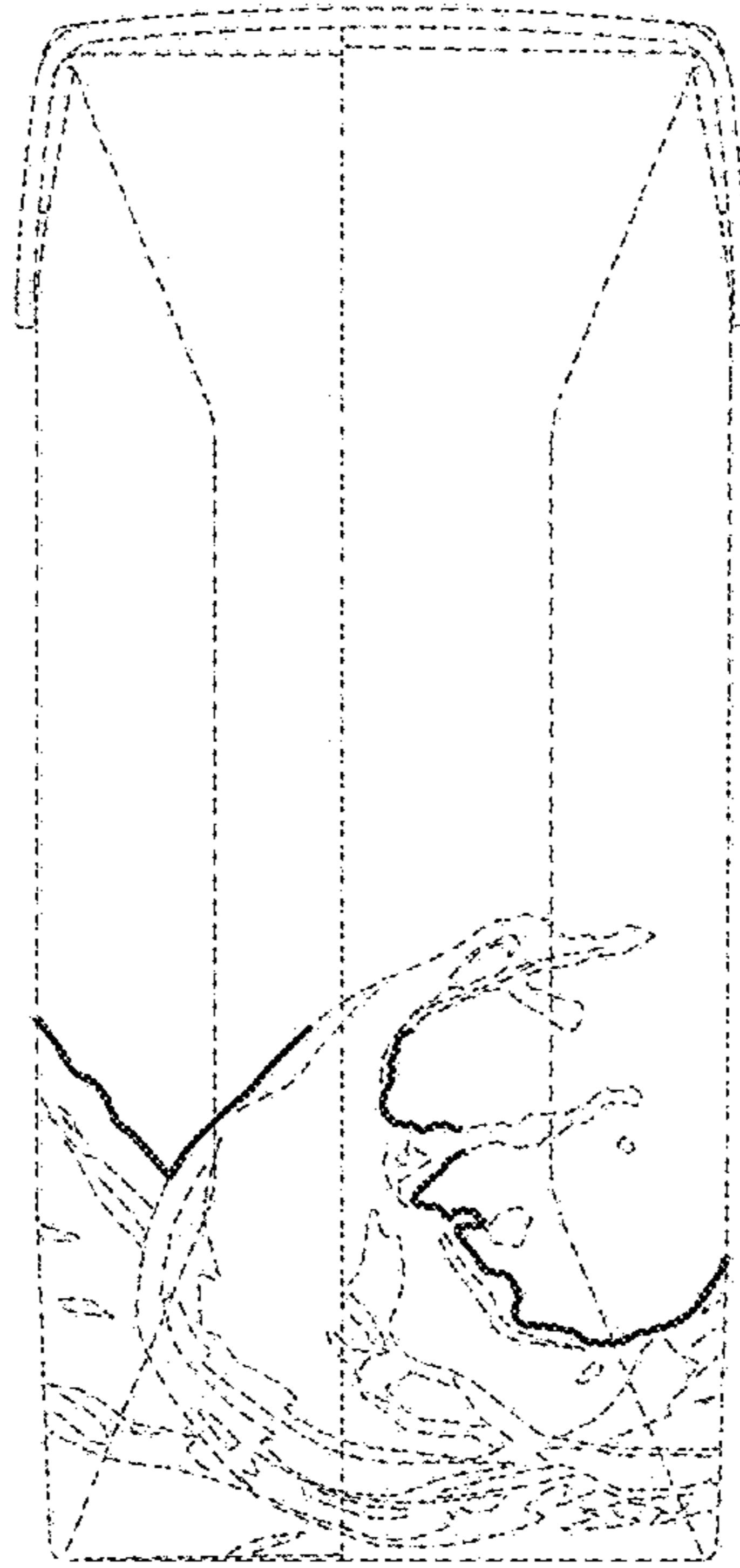

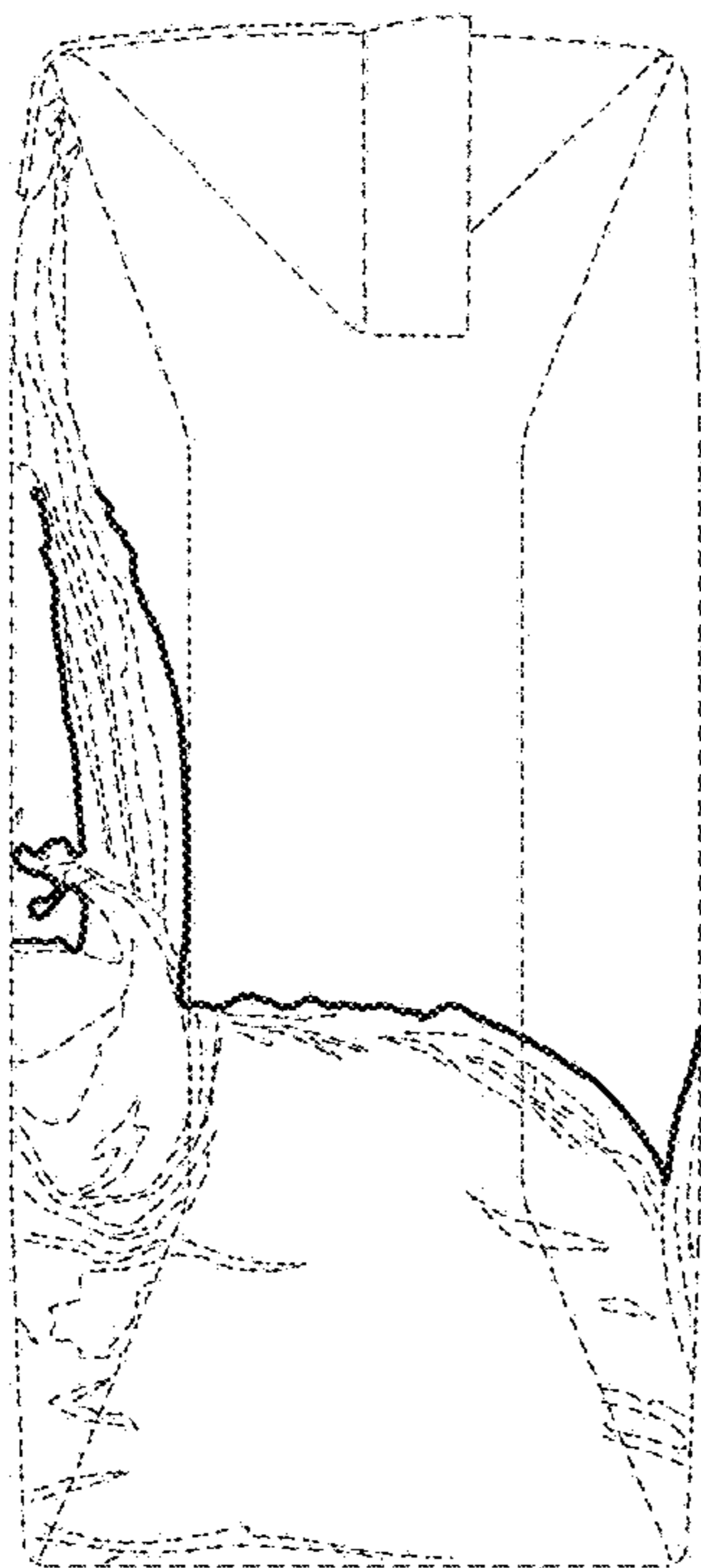

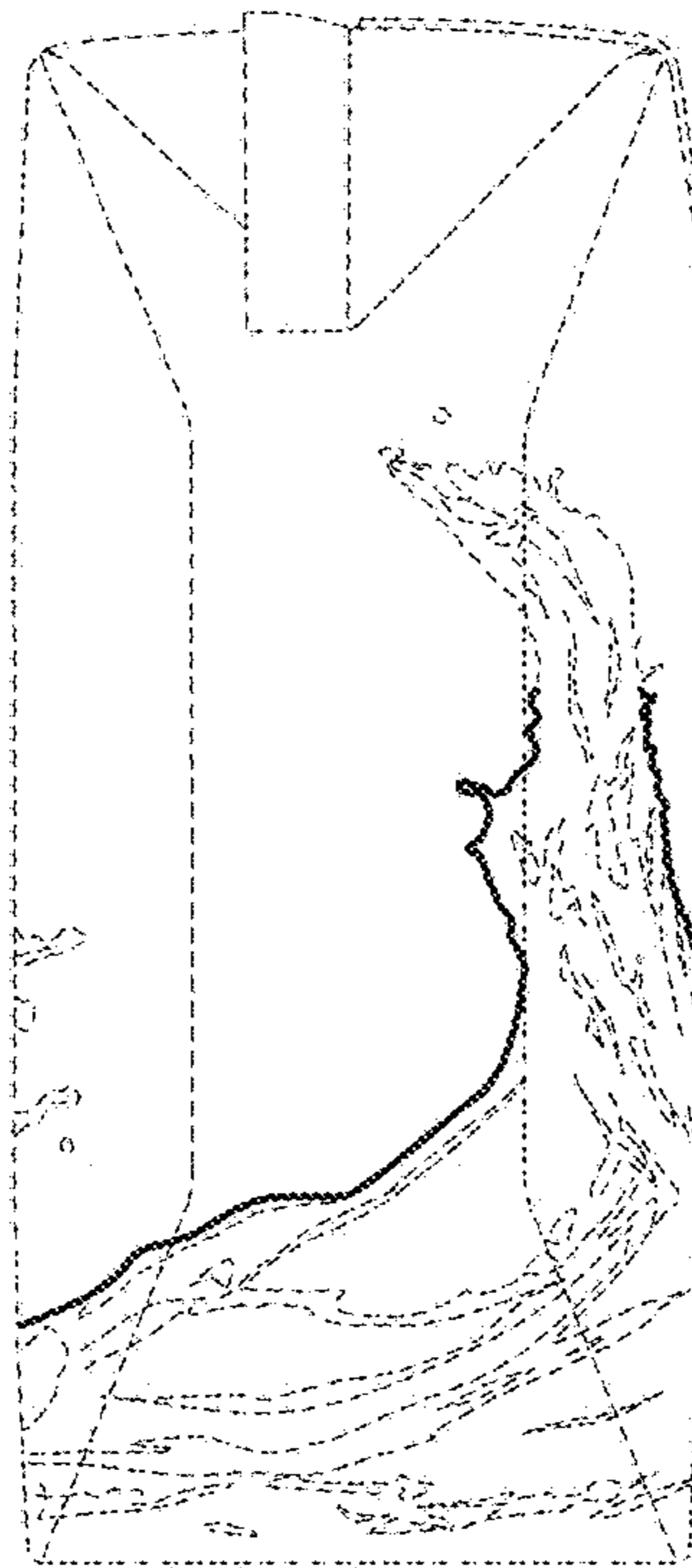

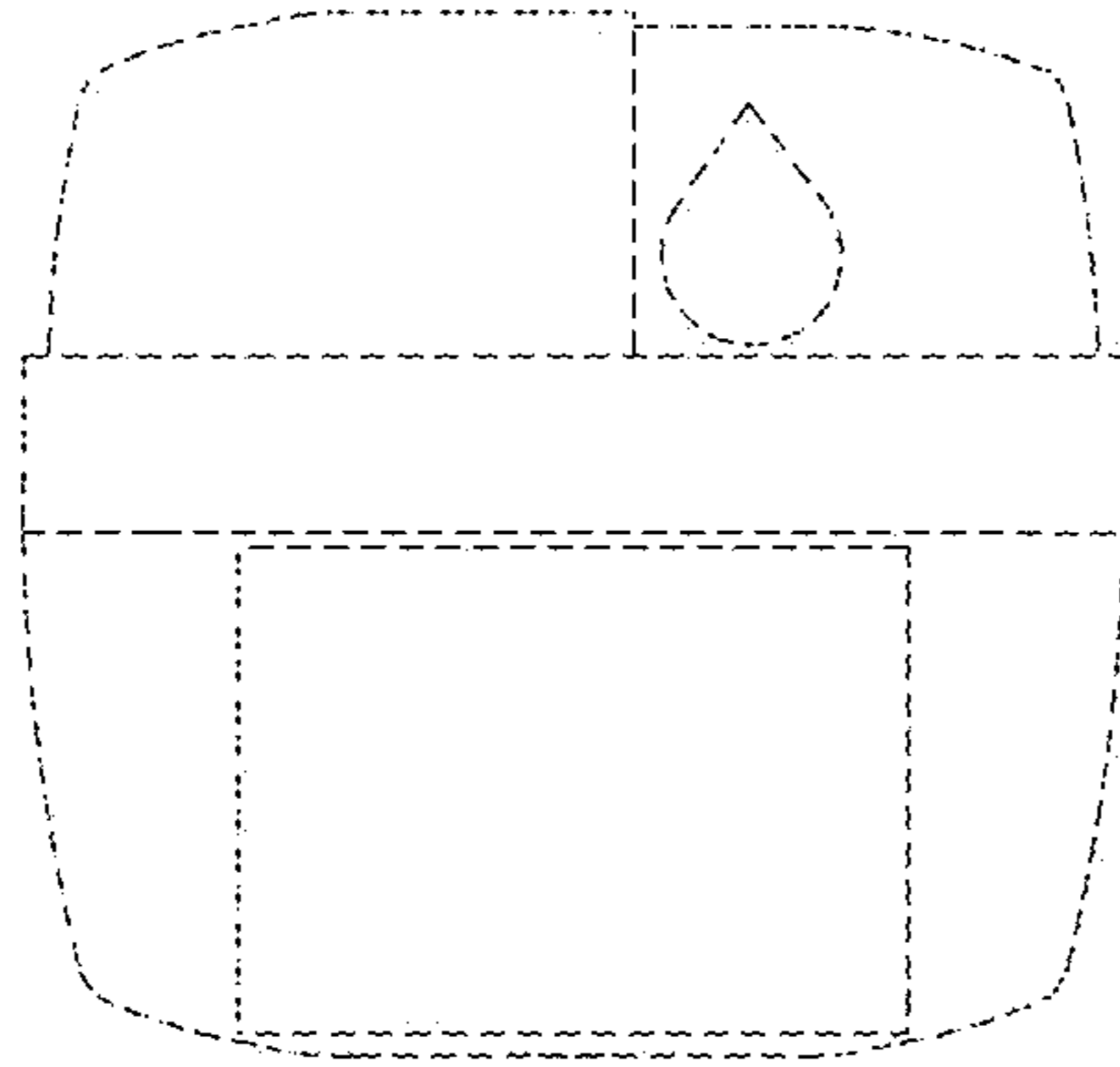

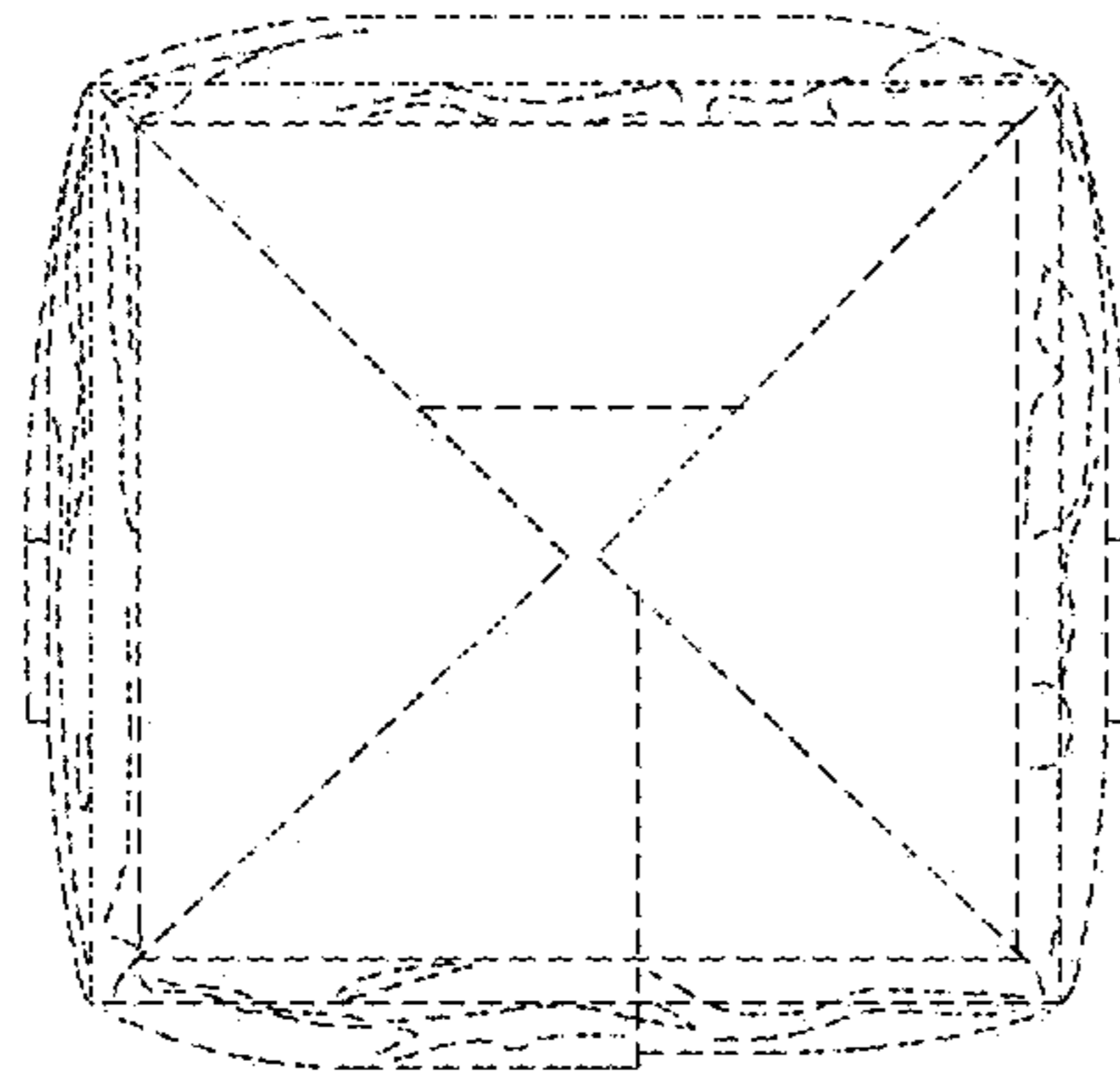
