(57) **CLAIM**

We claim the ornamental design for a pocket case for mobile communications devices with carrying compartment for credit card sized items, as shown and described.

DESCRIPTION

FIG. 1 is a back plan view of a pocket case for mobile communications devices with carrying compartment for credit card sized items.

FIG. 2 is a front plan view thereof.

FIG. 3 is a back perspective view thereof.

FIG. 4 is a back perspective view thereof, the side being the side opposite of the side shown in FIG. 3.

FIG. 5 is a back perspective view thereof.

FIG. 6 is a back perspective view thereof, the side being the side opposite of the side shown in FIG. 5.

FIG. 7 is a side elevation view thereof.

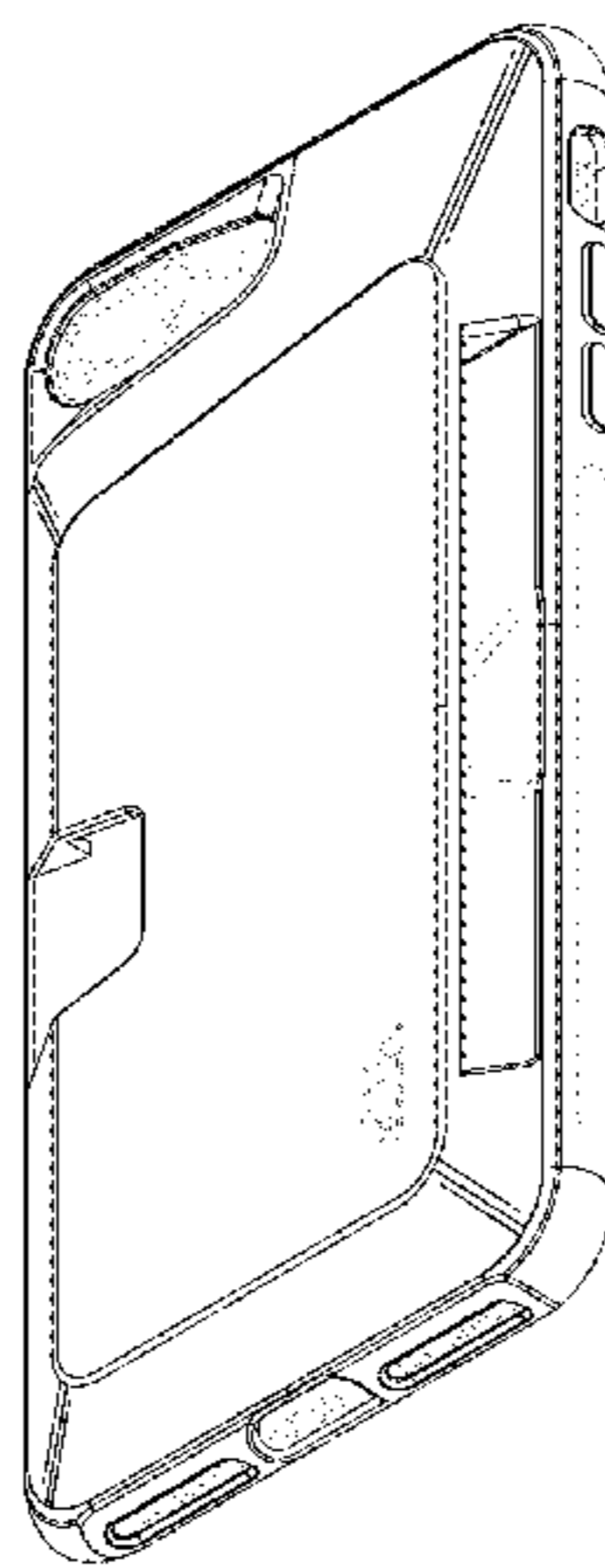
FIG. 8 is side elevation view thereof, the side being the side opposite of the side shown in FIG. 7.

FIG. 9 is a bottom elevation view thereof; and,

FIG. 10 is a top elevation view thereof.

The broken lines forming the word “silk” in the back views of FIGS. 1 and 3-6 define boundaries of the claimed design and form no part of the claimed design. The broken lines forming elongated ovals in the side views of FIGS. 3-8 define boundaries of the claimed design and form no part of the claimed design. The broken lines inside the pocket area of the back views of FIGS. 3 and 6 define boundaries of the claimed design and form no part of the claimed design. The remaining broken lines disclose the environment related to the claimed design, specifically elements of a mobile communications device disposed within the claimed design of a pocket case for a mobile

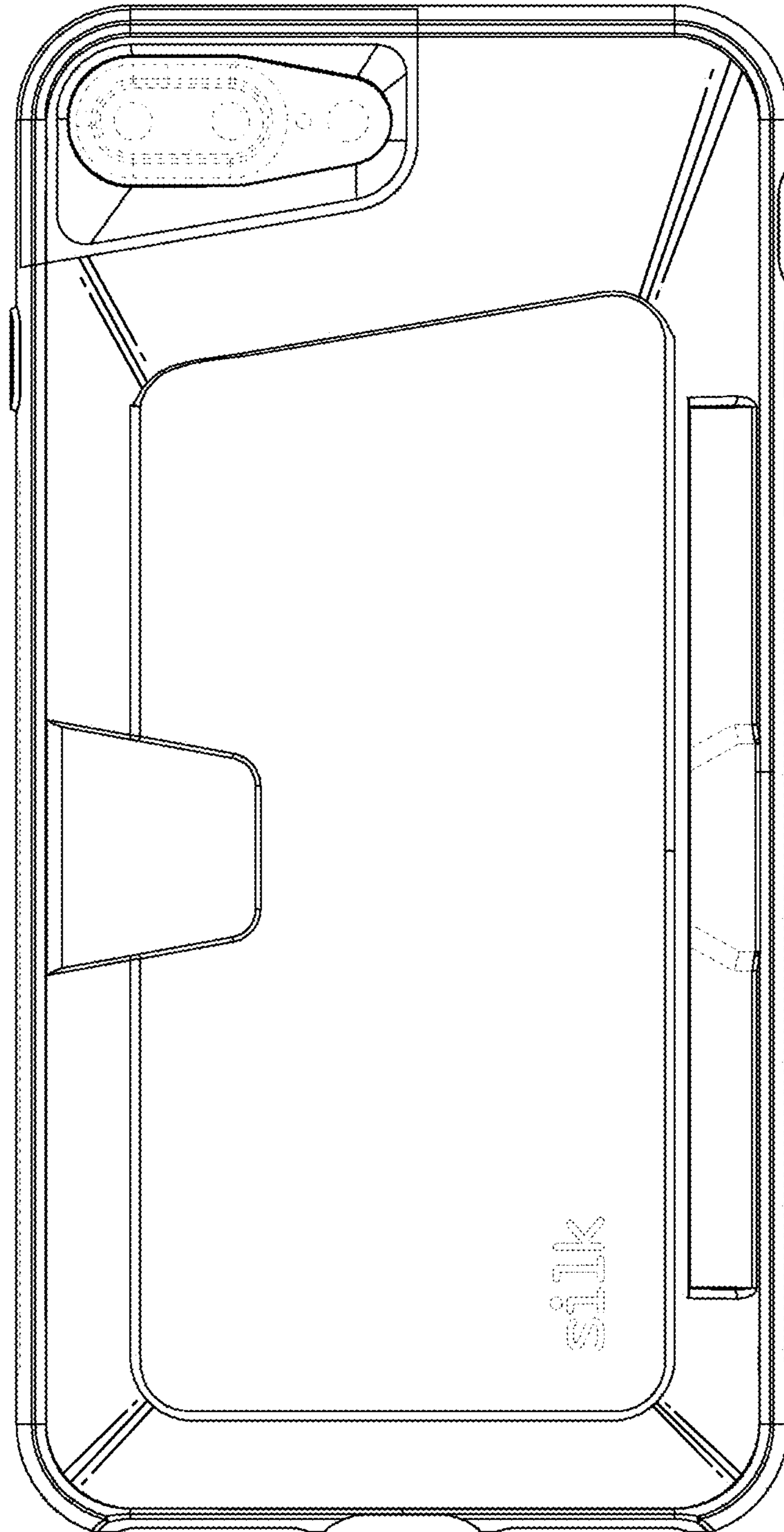

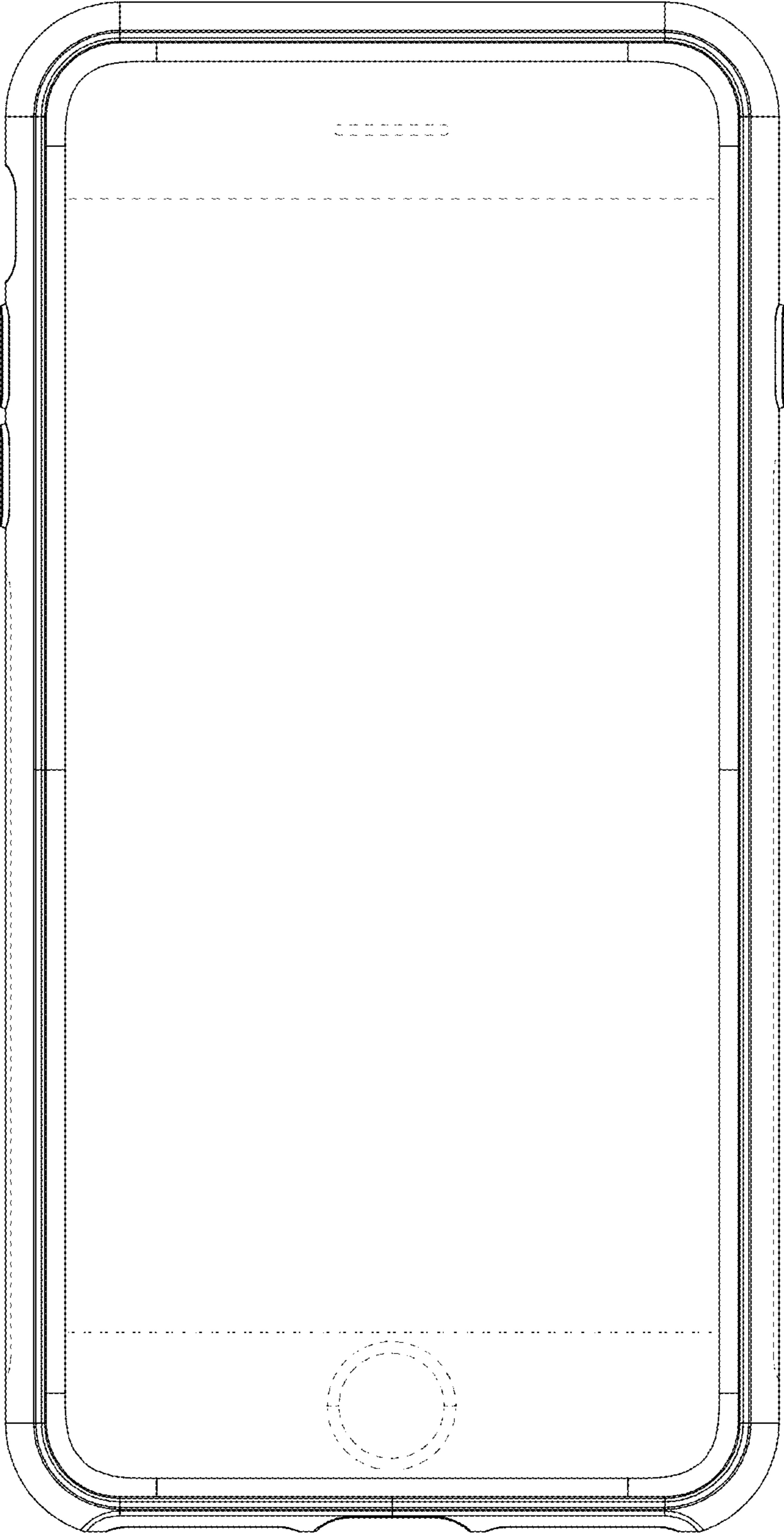

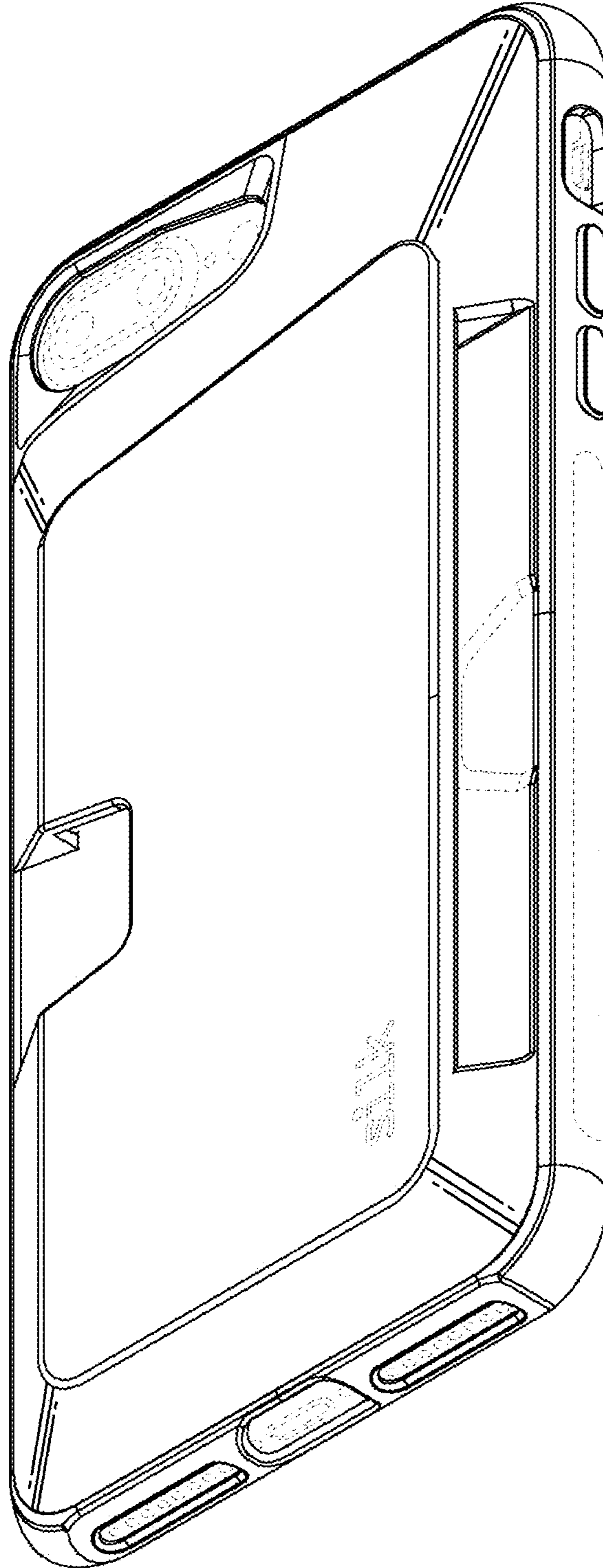

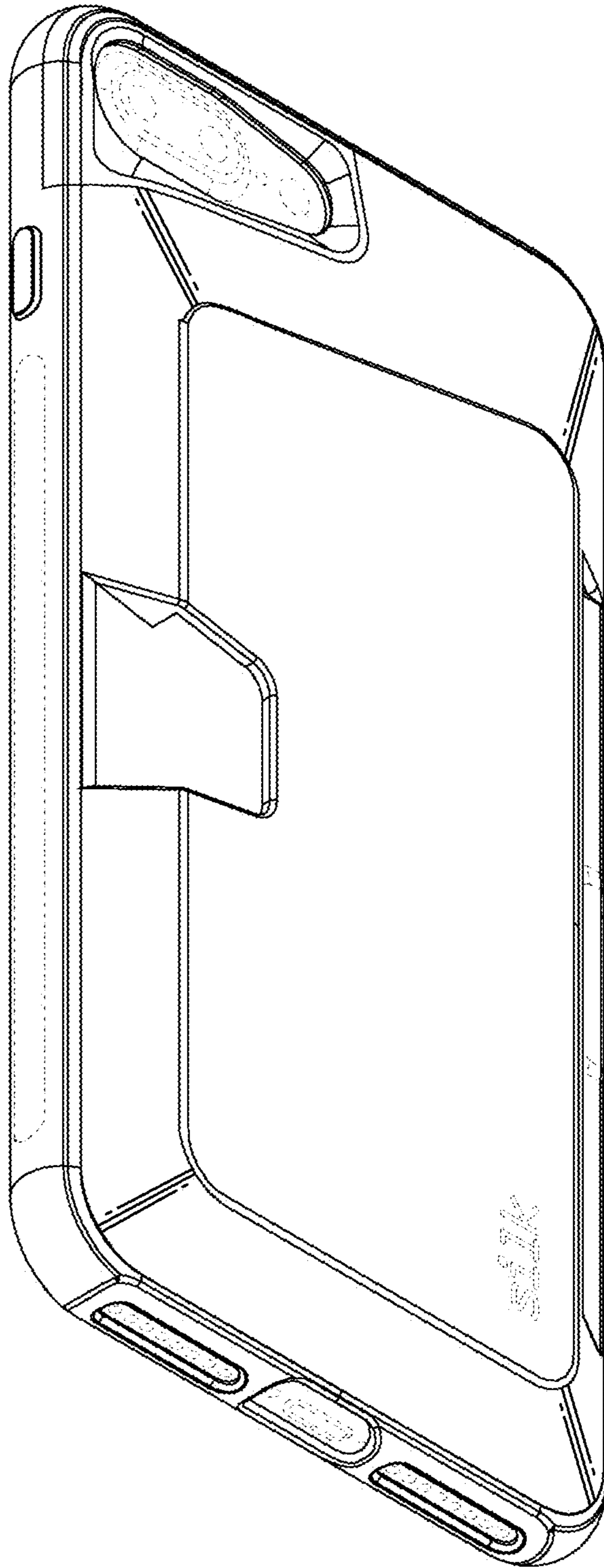

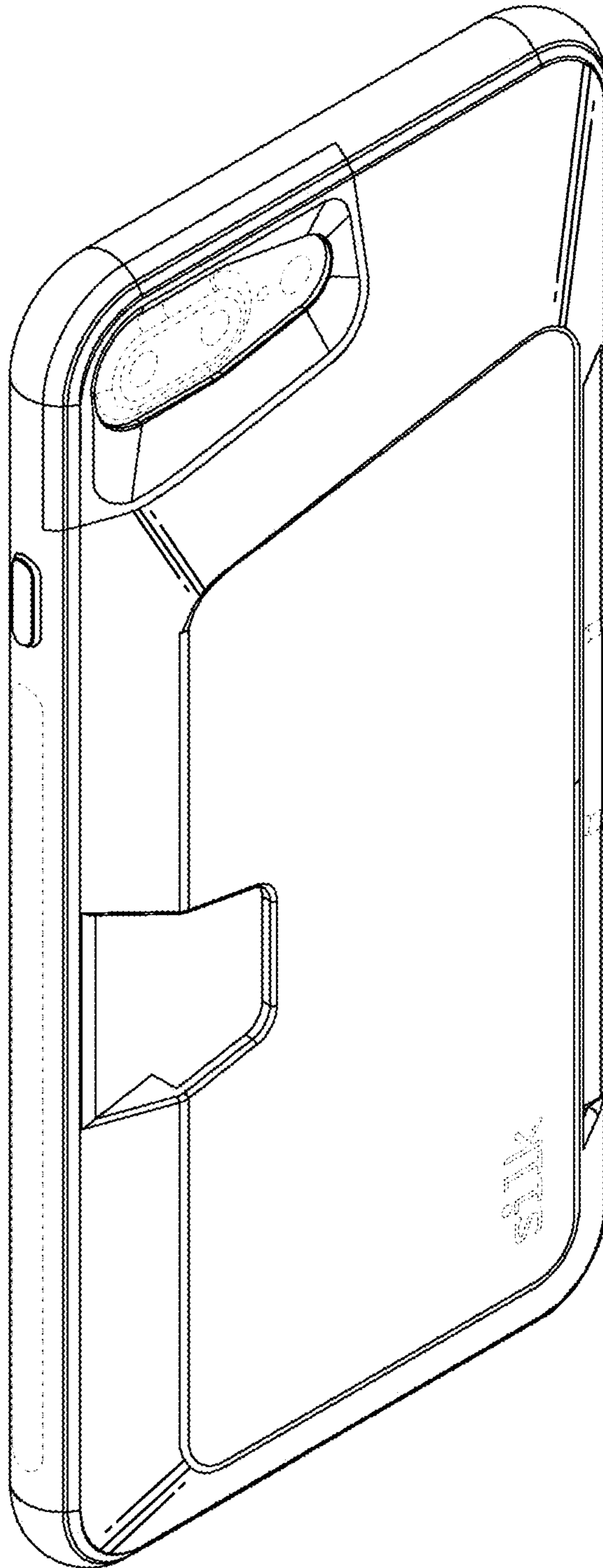
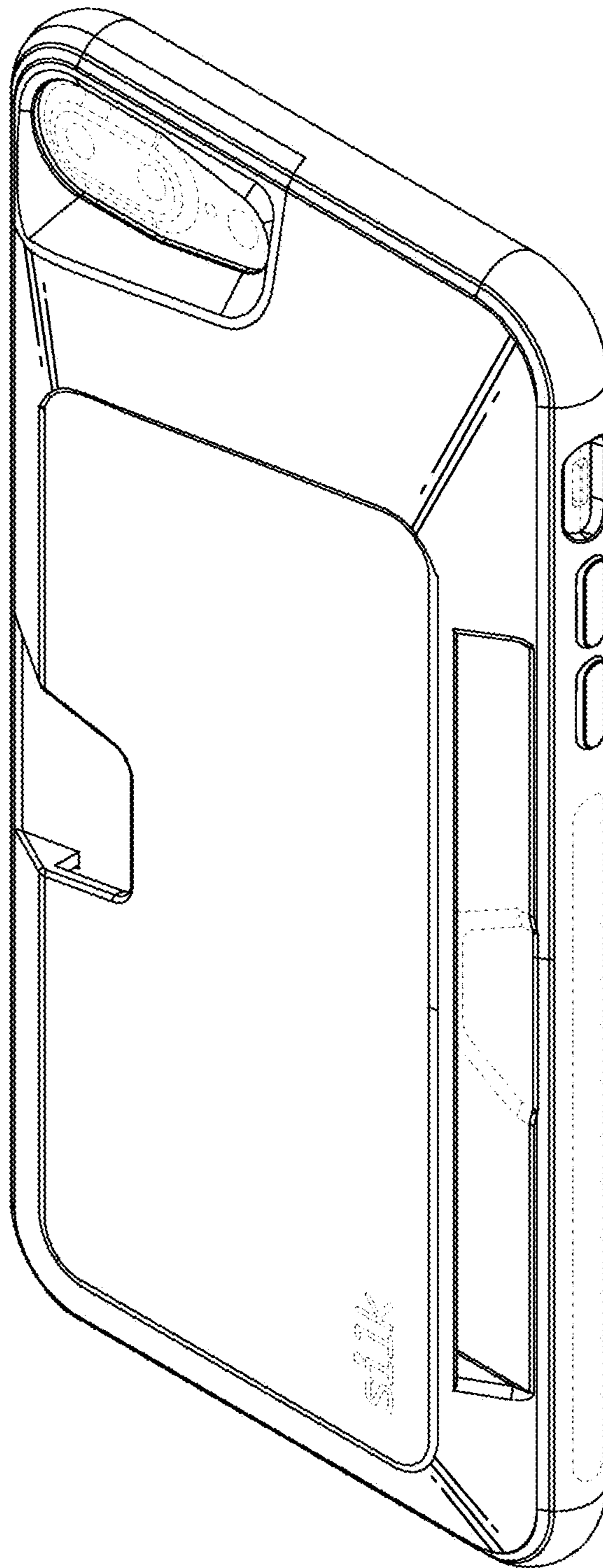

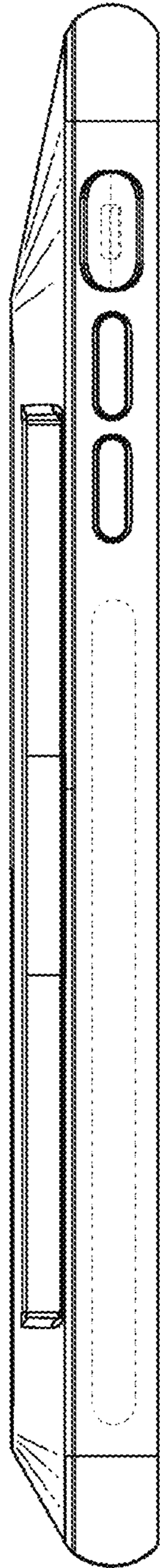

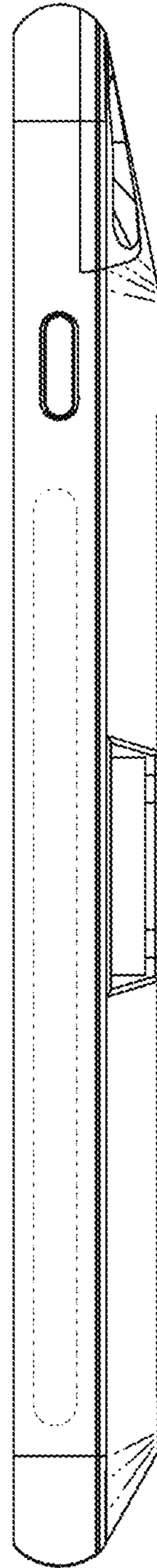

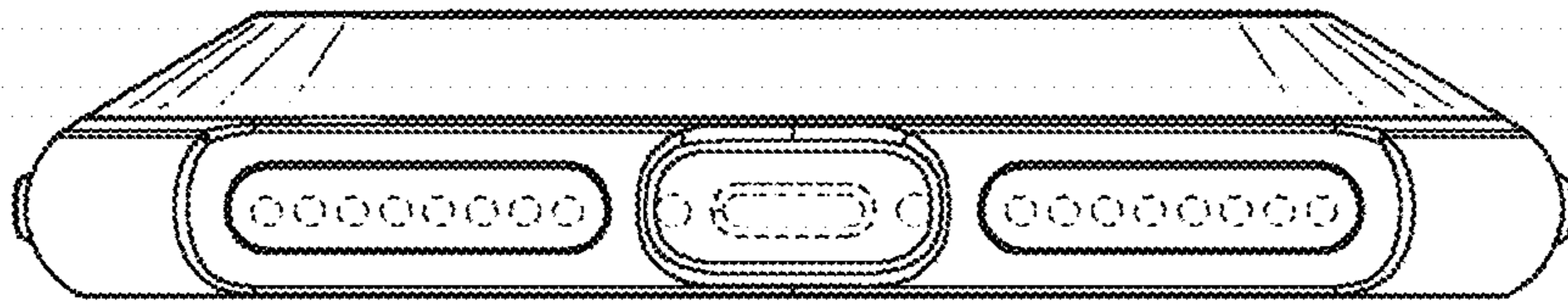
