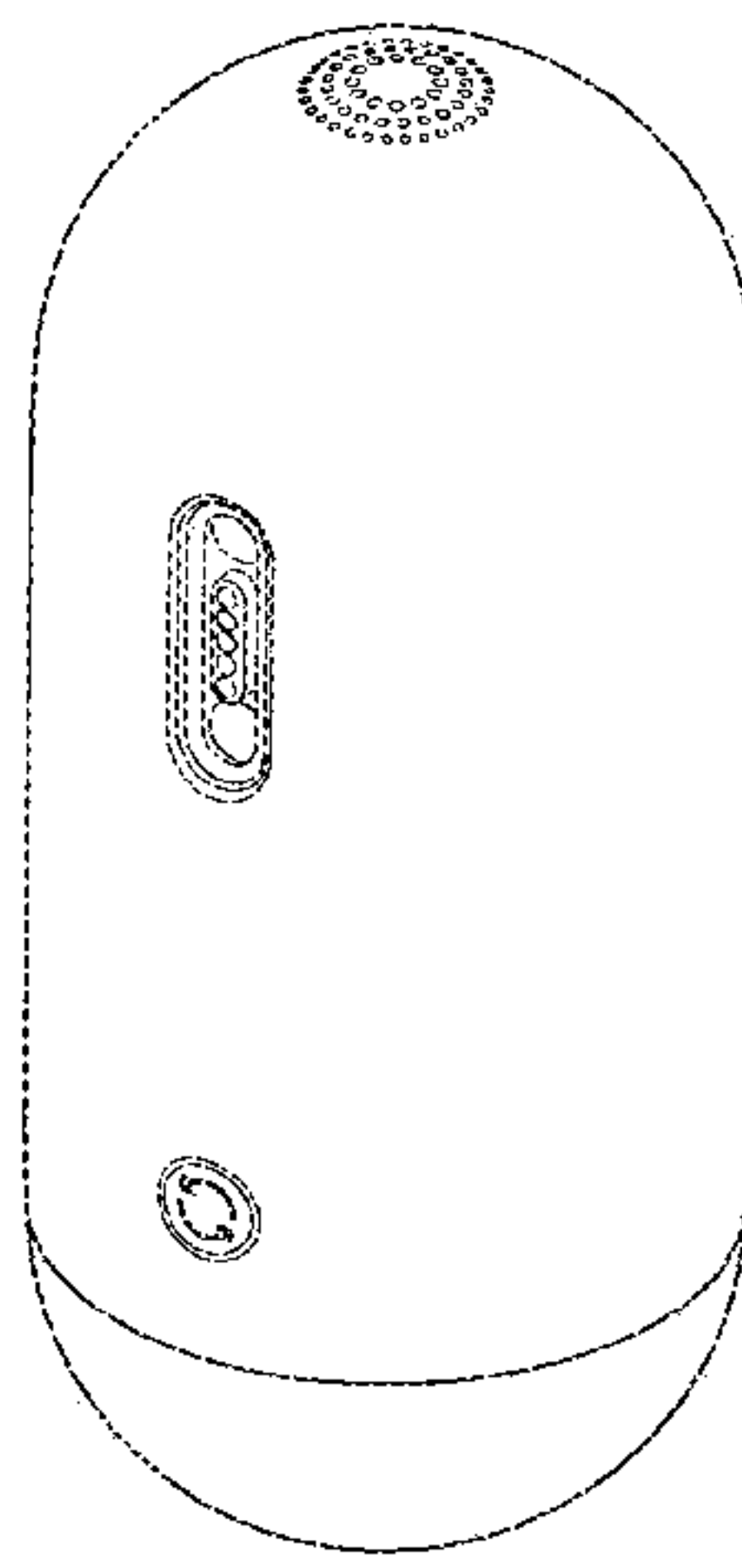
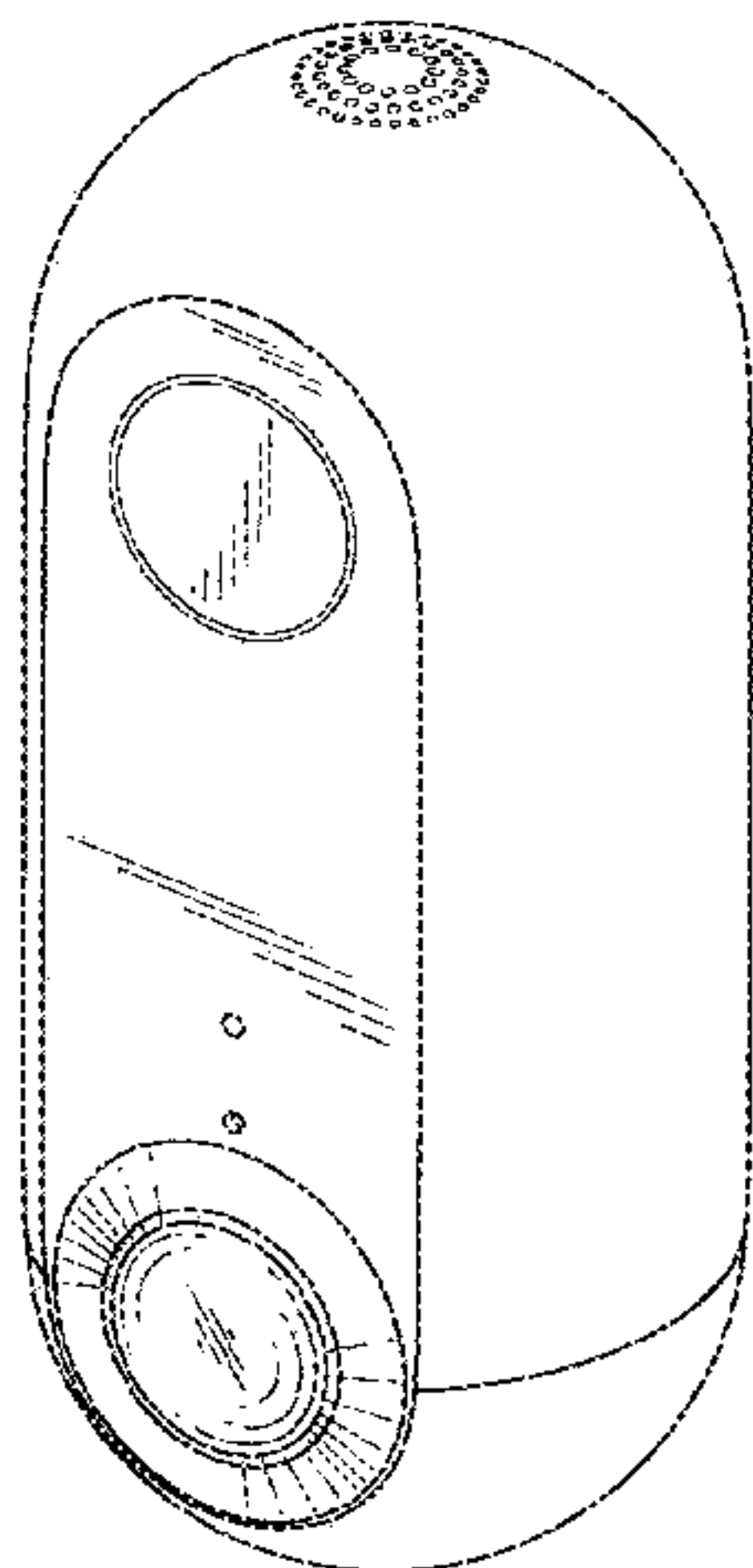
(57) **CLAIM**

What is claimed is the ornamental design for a security monitoring device, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of a security monitoring device showing the new design;
FIG. 2 is a rear, left perspective view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a left view thereof;
FIG. 6 is a right view thereof;
FIG. 7 is a rear view thereof; and,
FIG. 8 is a bottom view thereof.
The broken lines shown in FIG. 8 depict portions of the security monitoring device that form no part of the claimed design.

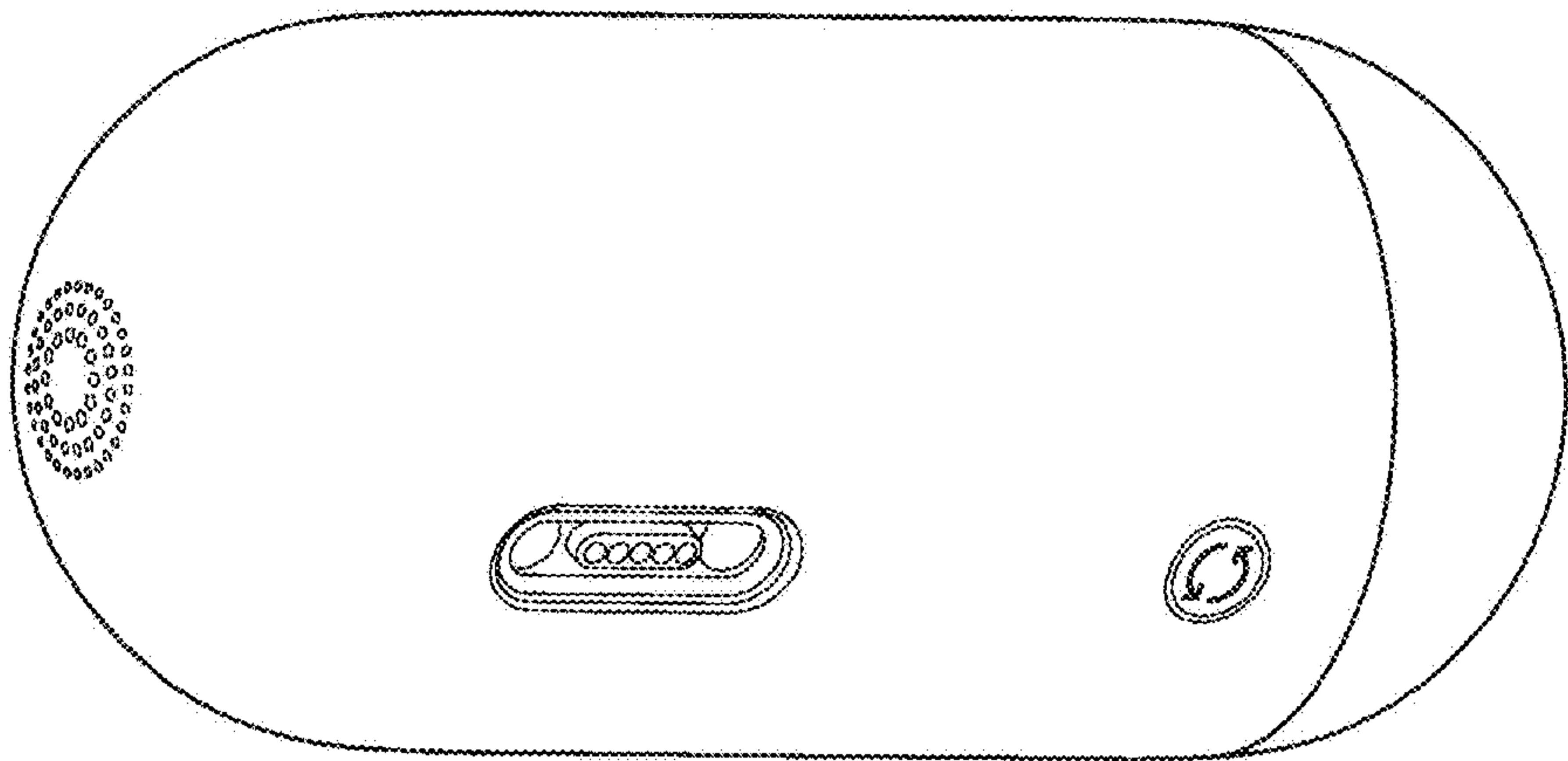

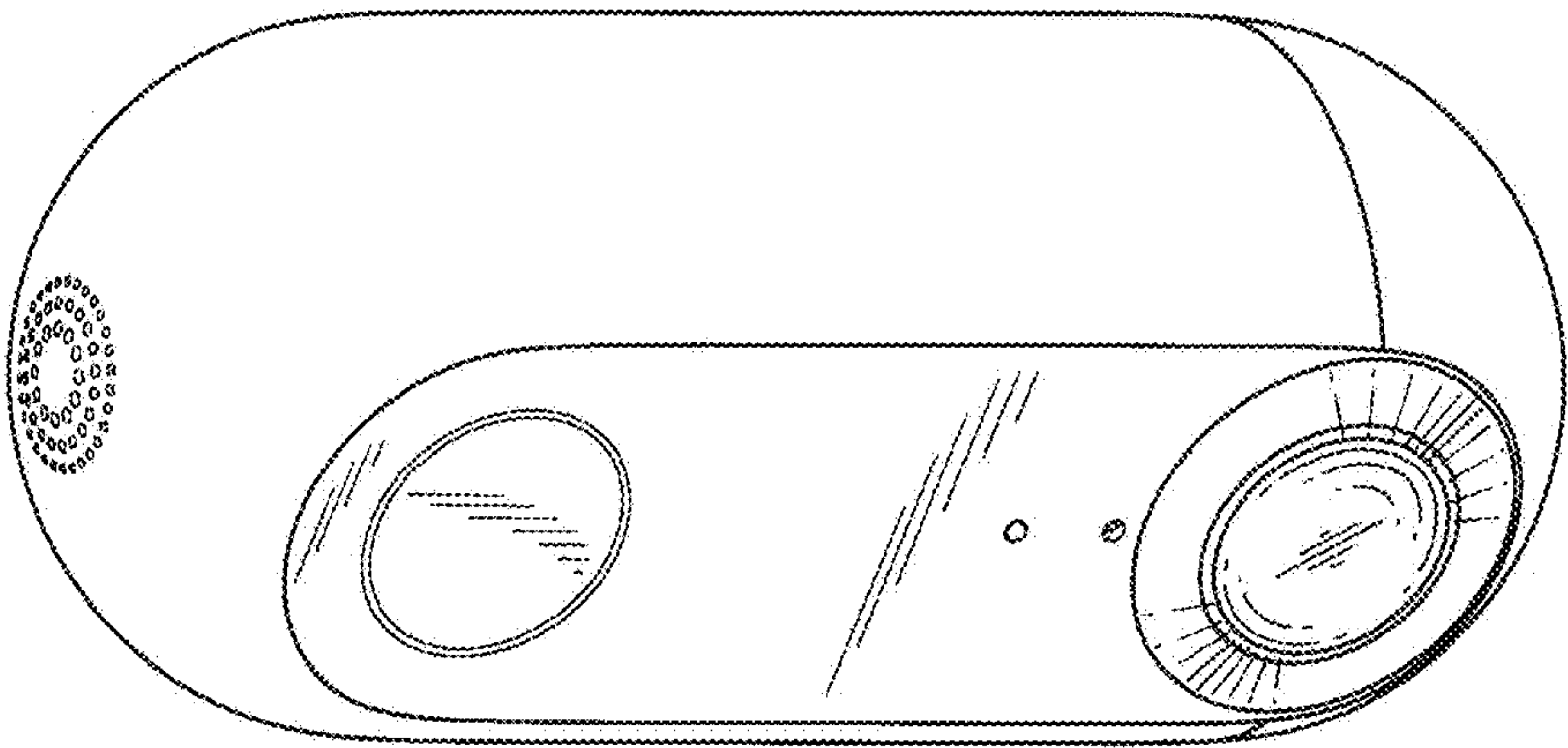

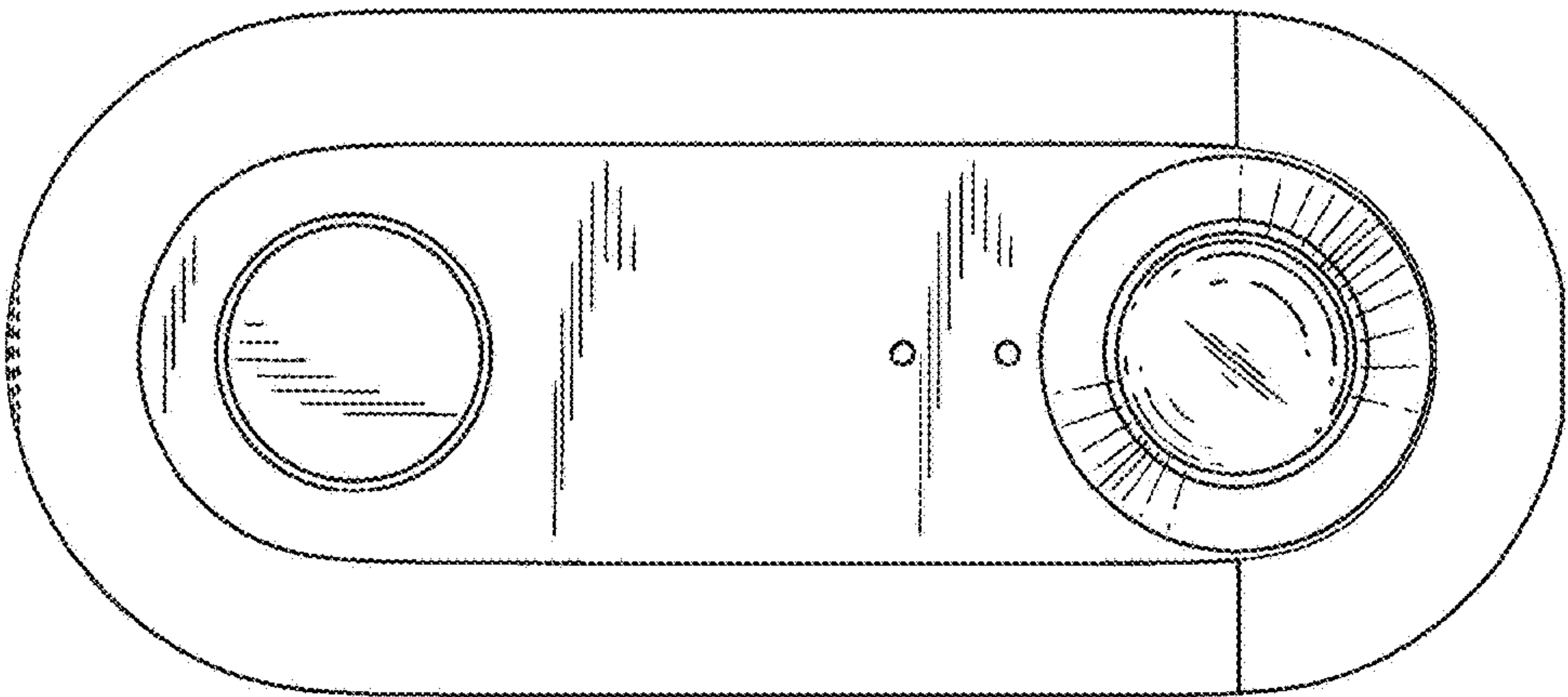

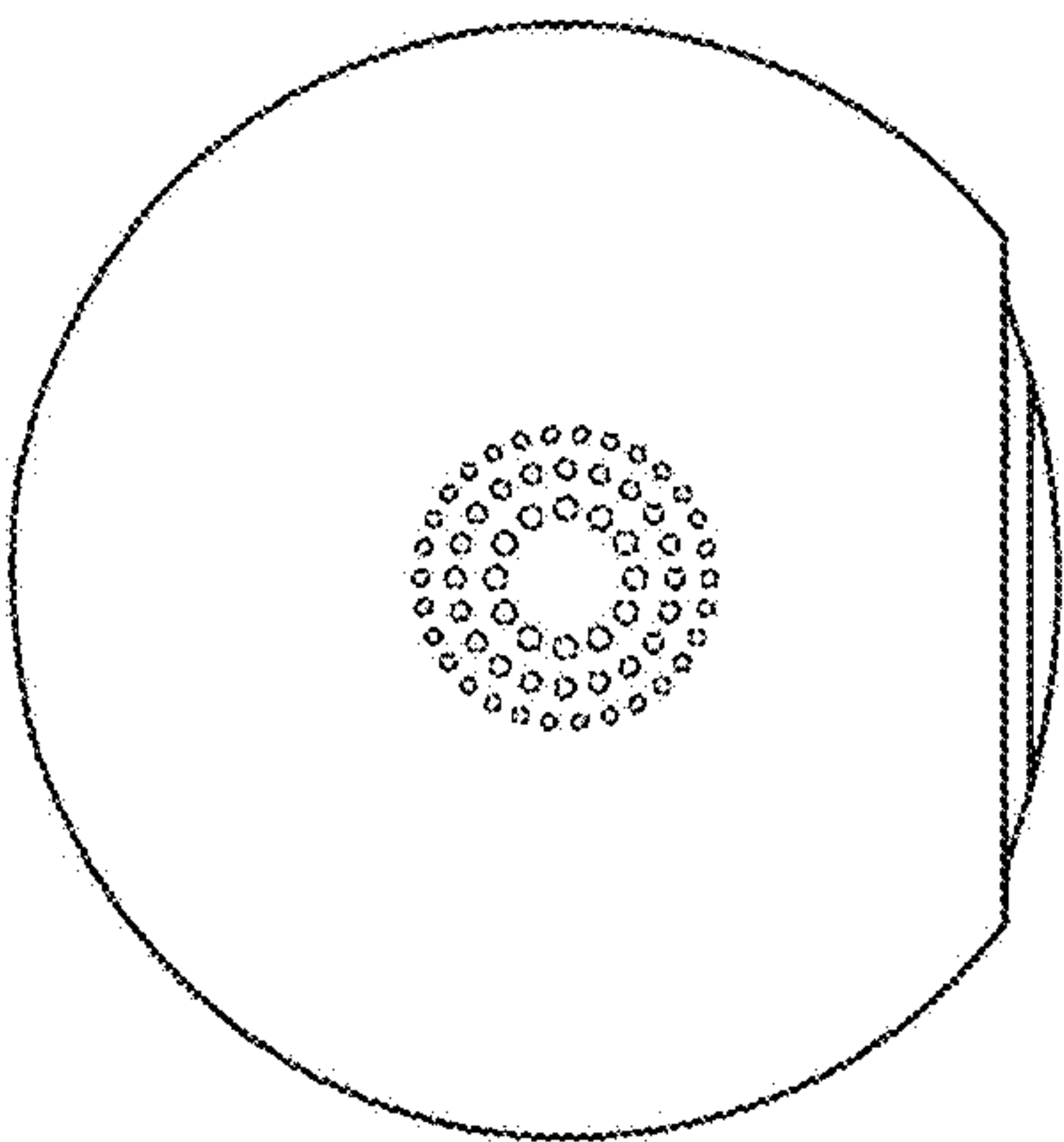

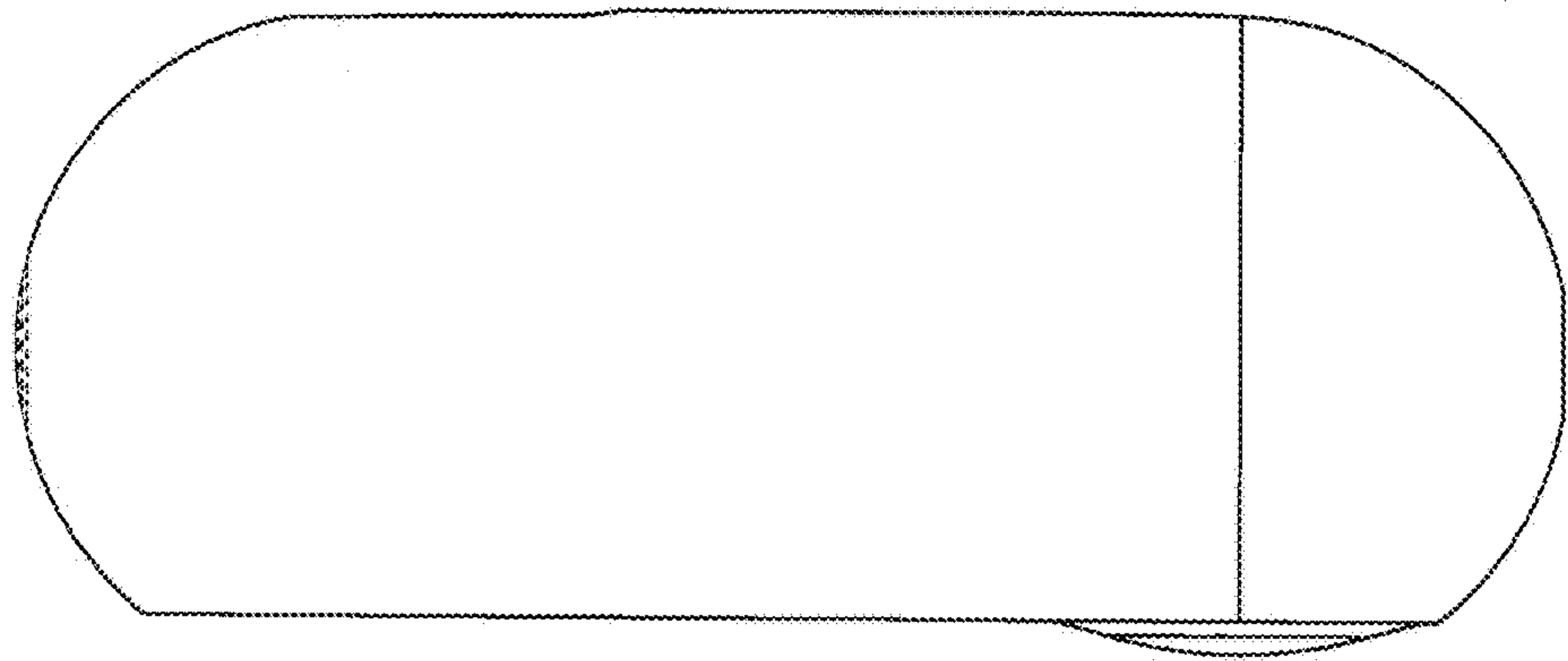

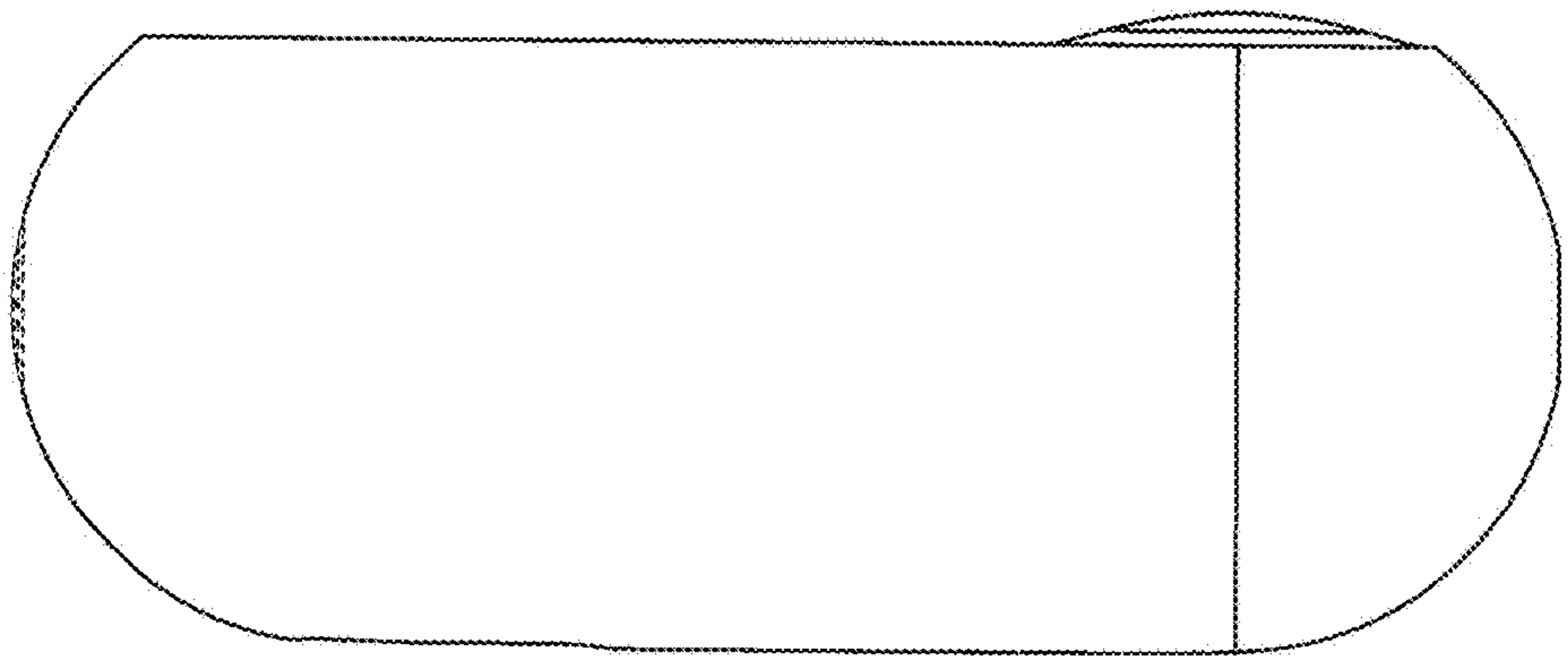

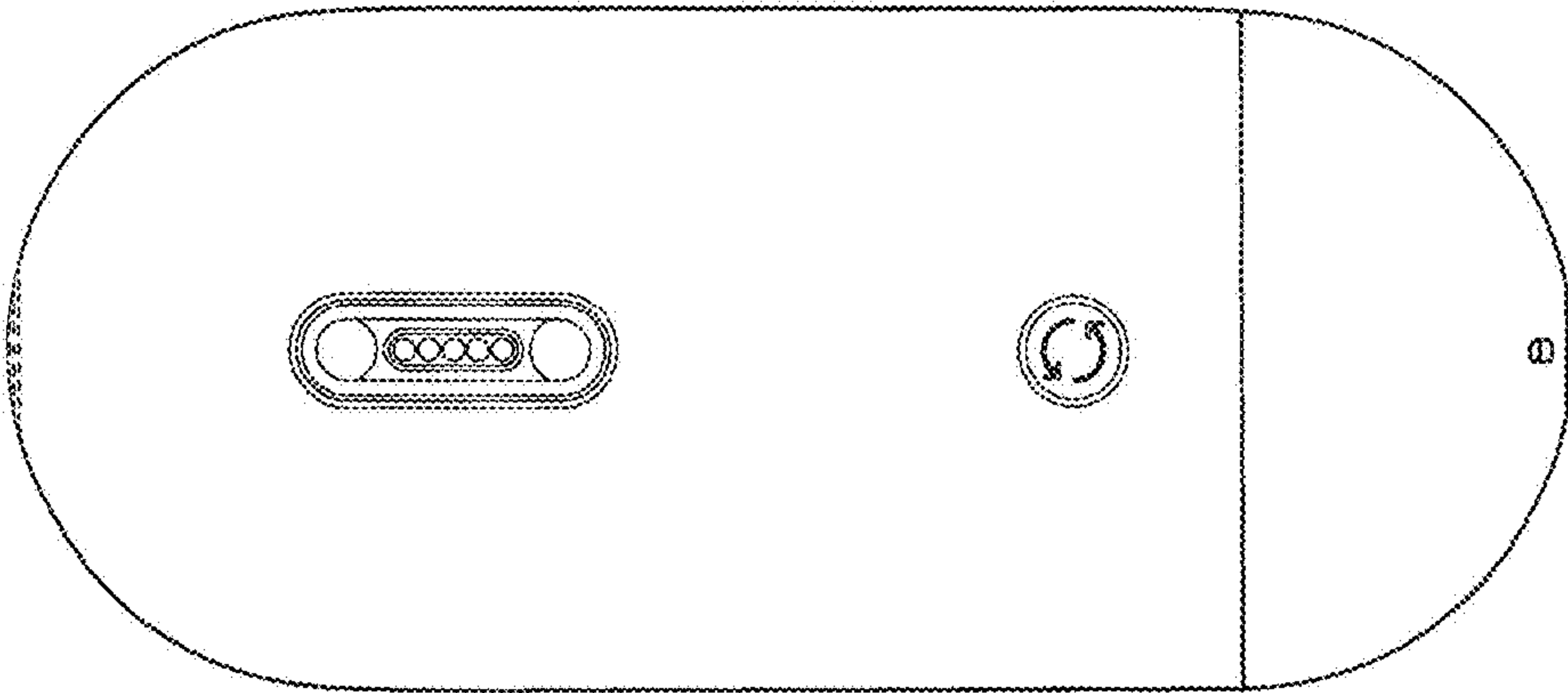

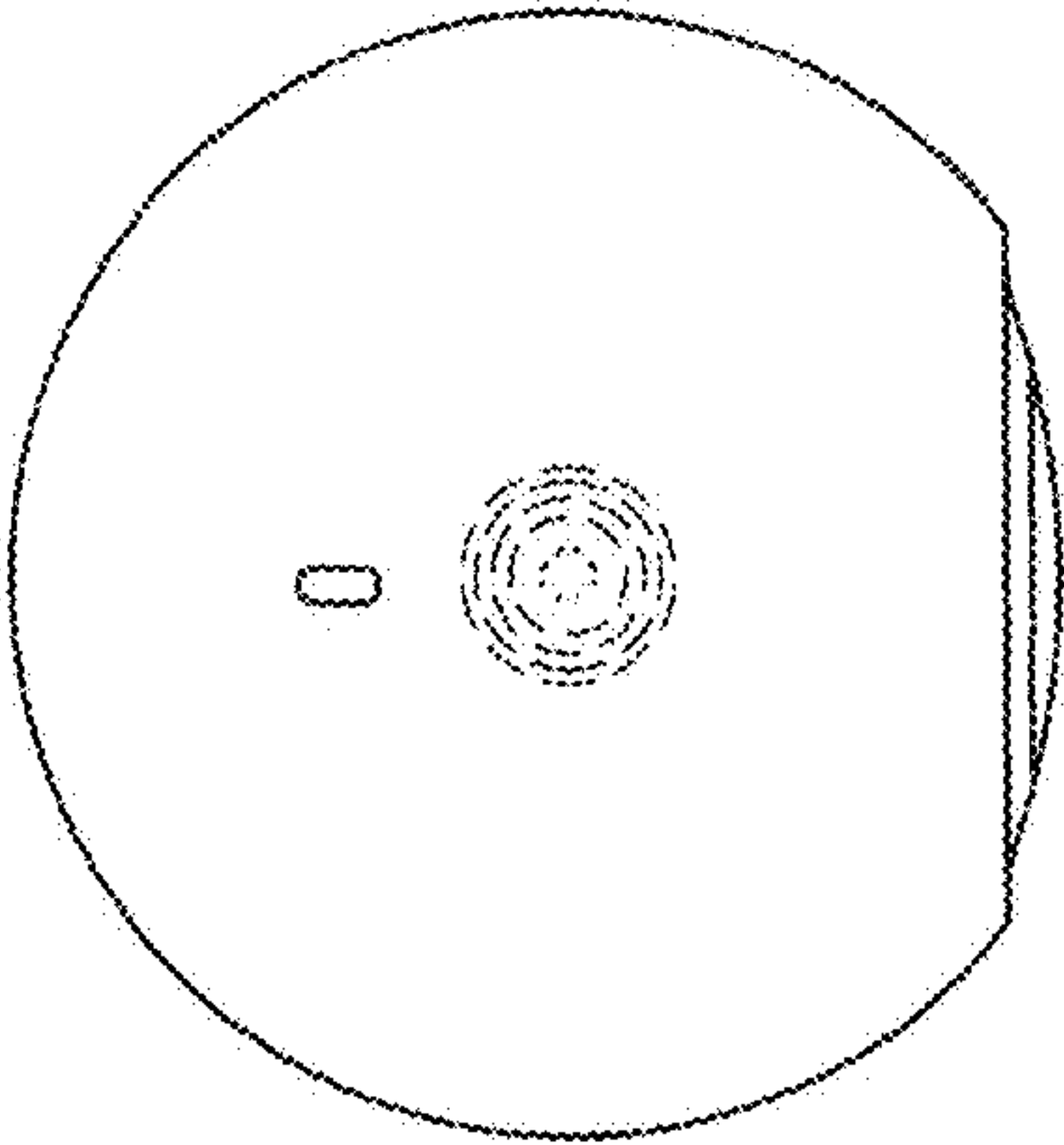
