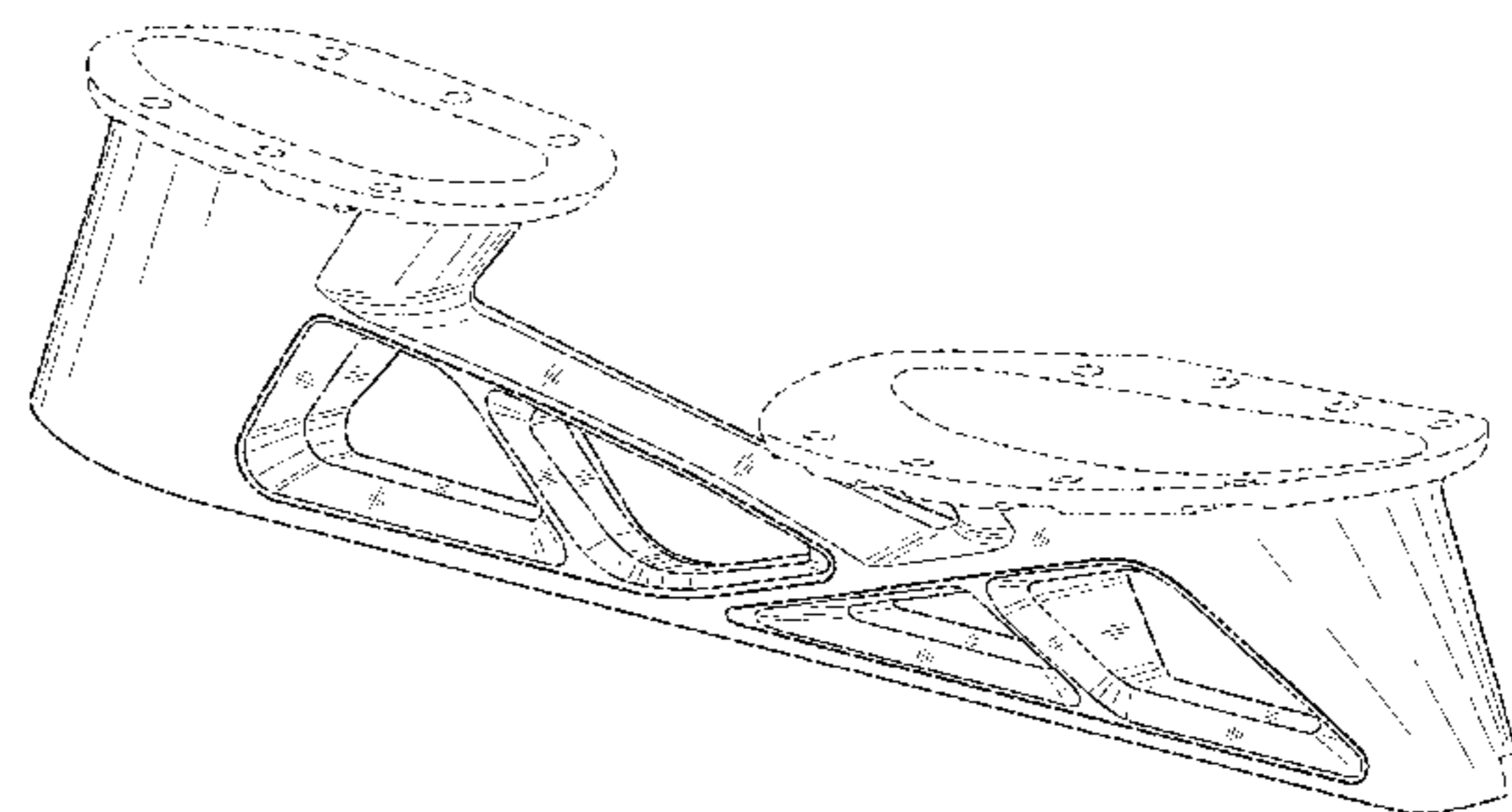
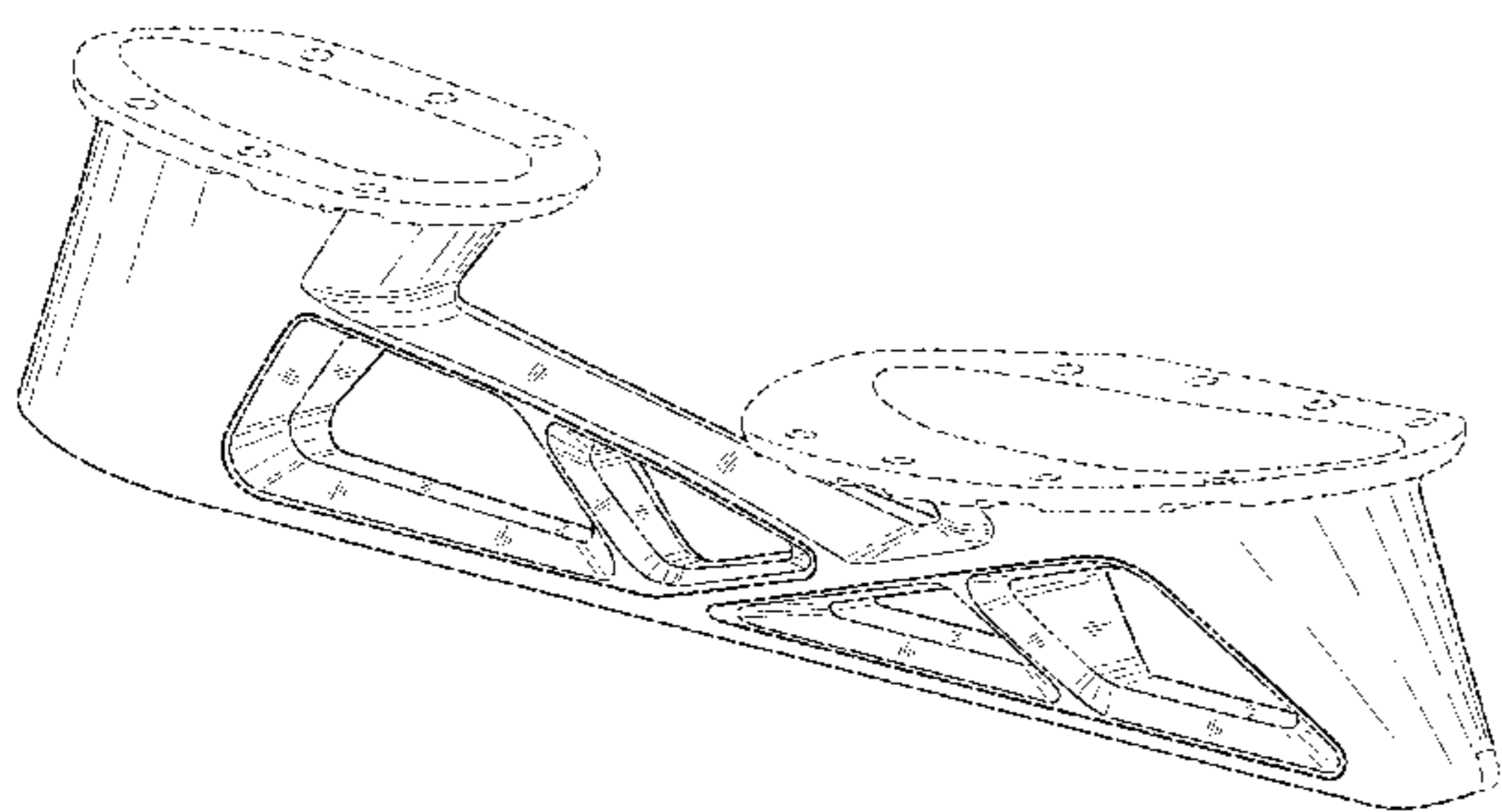
(57) **CLAIM**

I claim the ornamental design for a blade holder for an ice skate, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a blade holder for an ice skate in accordance with a first embodiment of the design; FIG. 2 is another perspective view of the blade holder of FIG. 1; FIG. 3 is a lateral side elevation view of the blade holder of FIG. 1; FIG. 4 is a medial side elevation view of the blade holder of FIG. 1; FIG. 5 is a front end view of the blade holder of FIG. 1; FIG. 6 is a rear end view of the blade holder of FIG. 1; FIG. 7 is a perspective view of a blade holder for an ice skate in accordance with a second embodiment of the design; FIG. 8 is another perspective view of the blade holder of FIG. 7; FIG. 9 is a lateral side elevation view of the blade holder of FIG. 7; FIG. 10 is a medial side elevation view of the blade holder of FIG. 7; FIG. 11 is a front end view of the blade holder of FIG. 7; and, FIG. 12 is a rear end view of the blade holder of FIG. 7. The broken lines shown are included for the purpose of illustrating portions of the article which form no part of the claimed design.

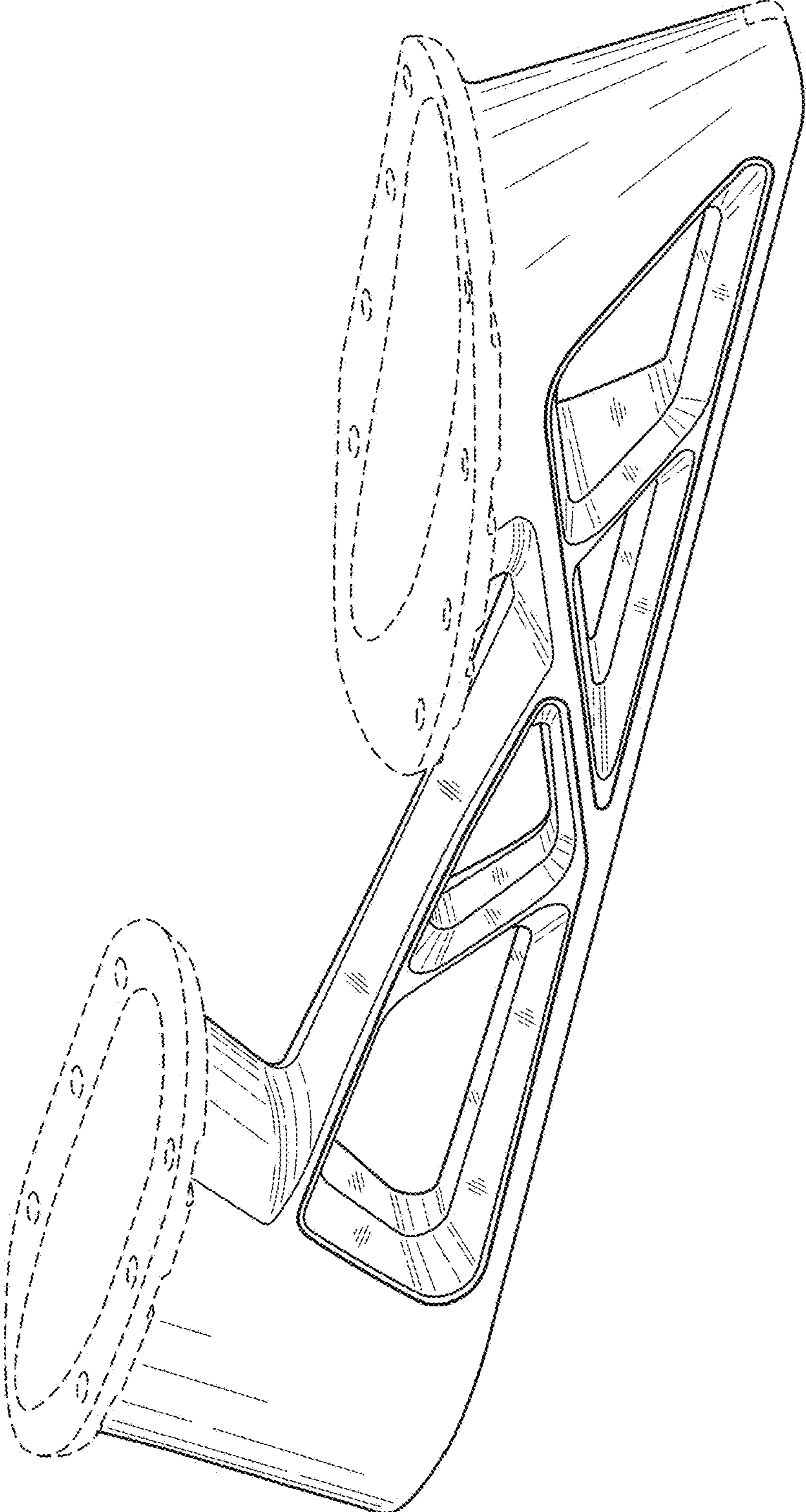

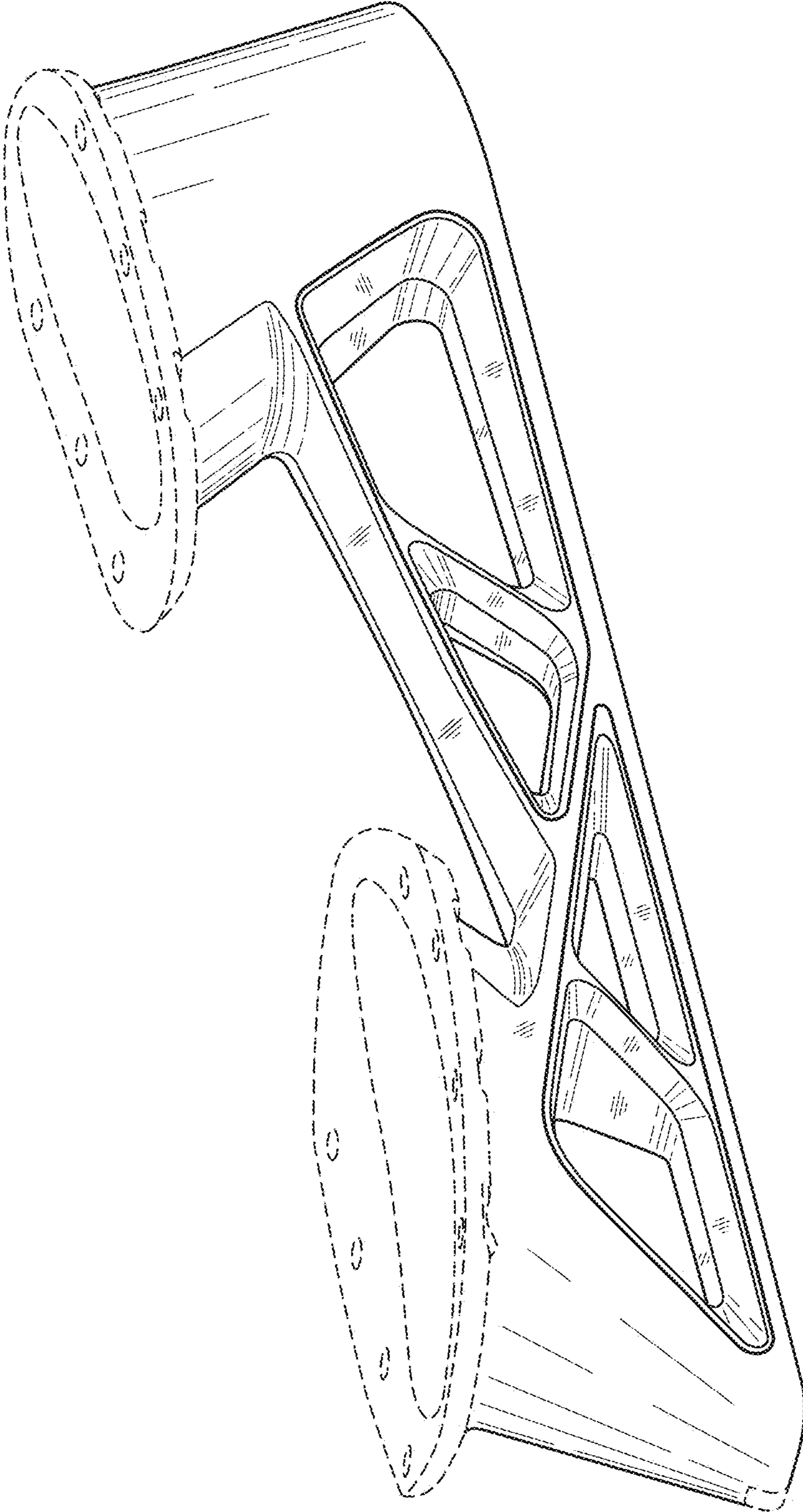

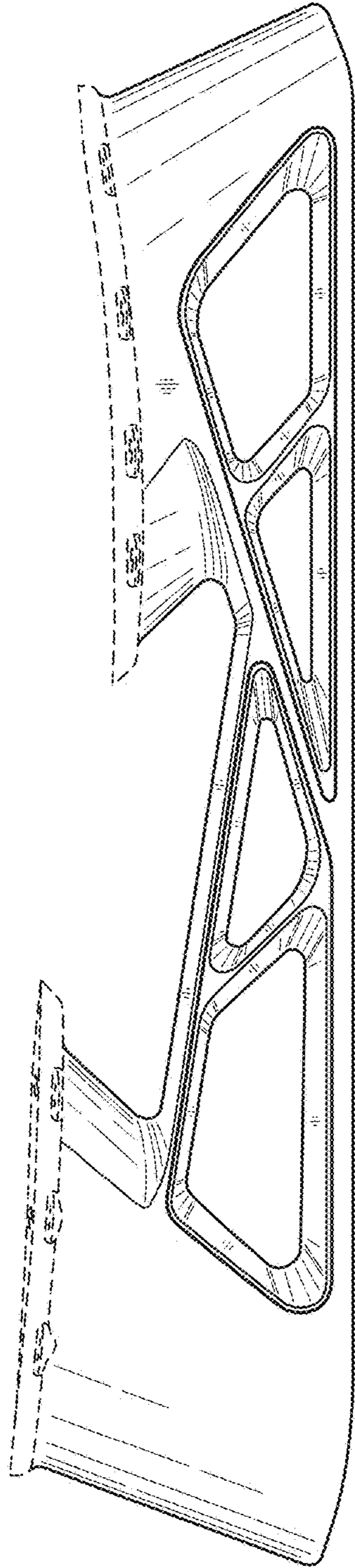

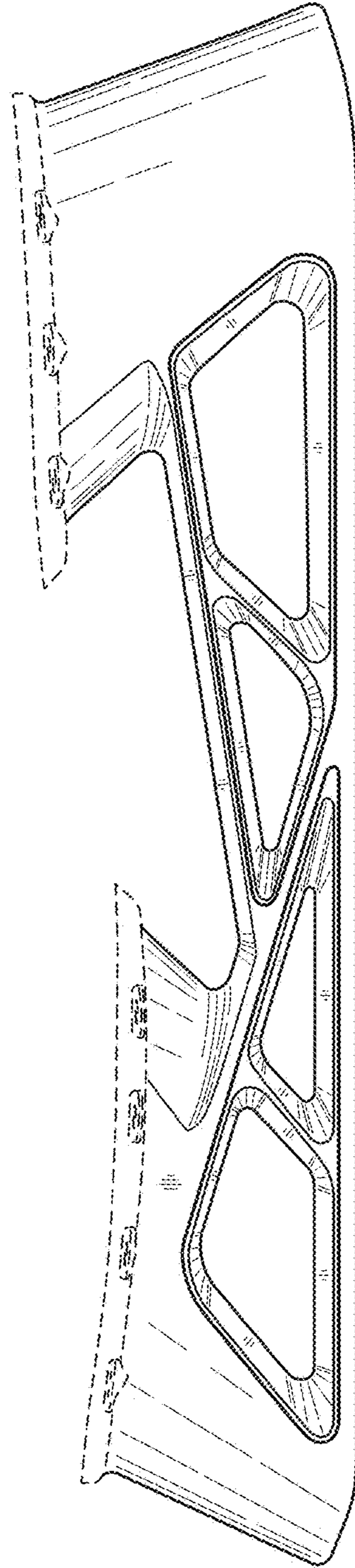

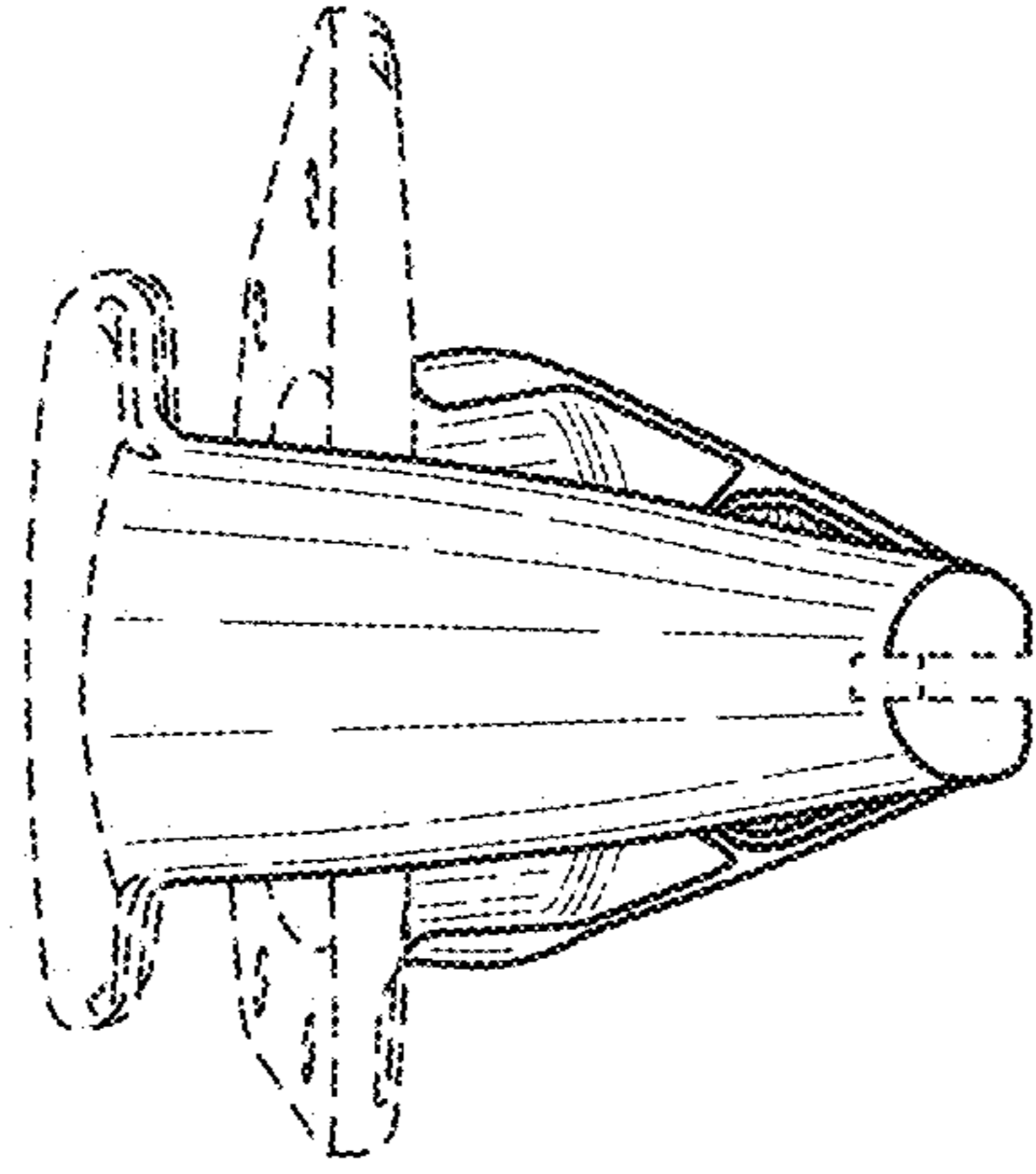

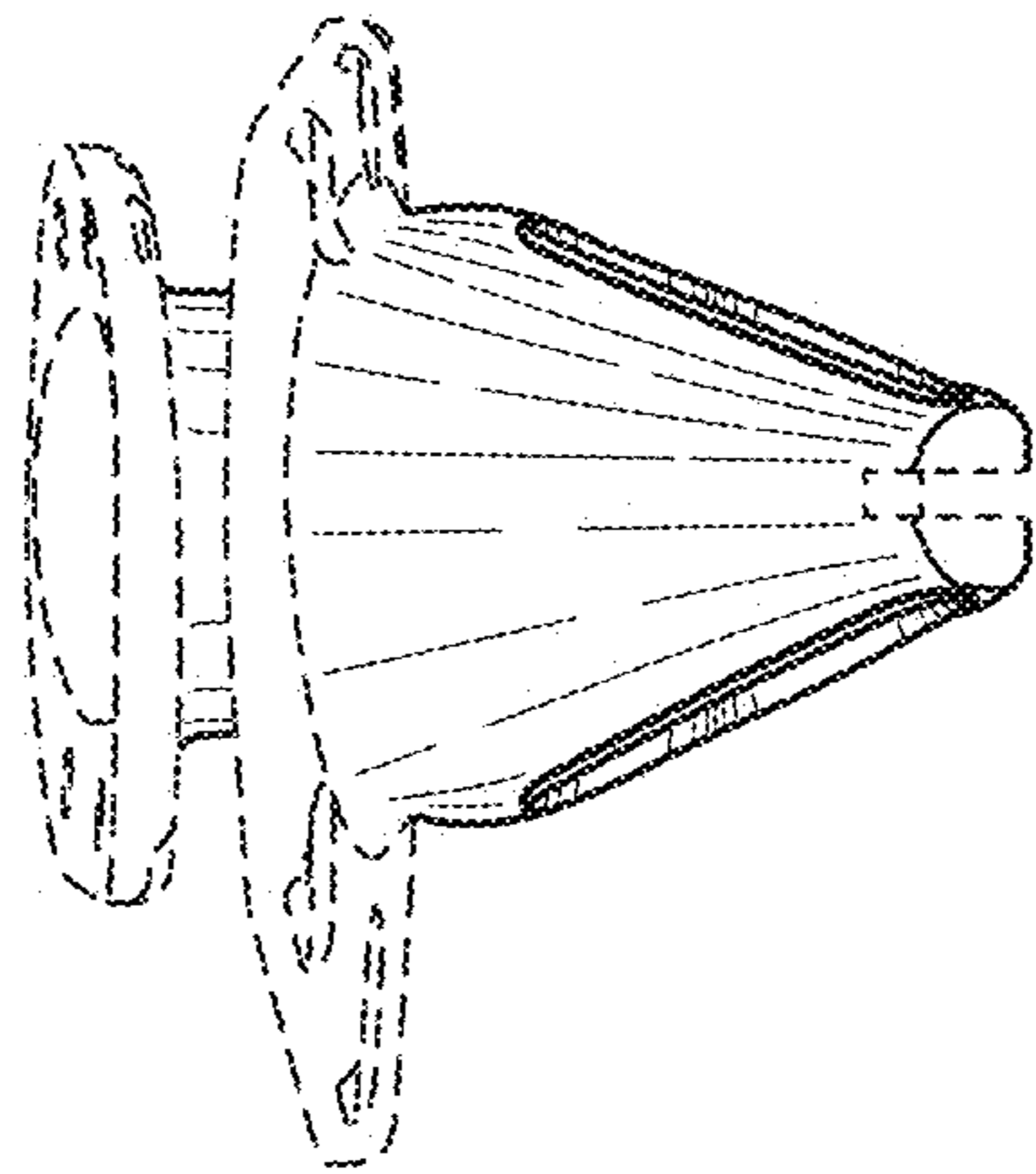

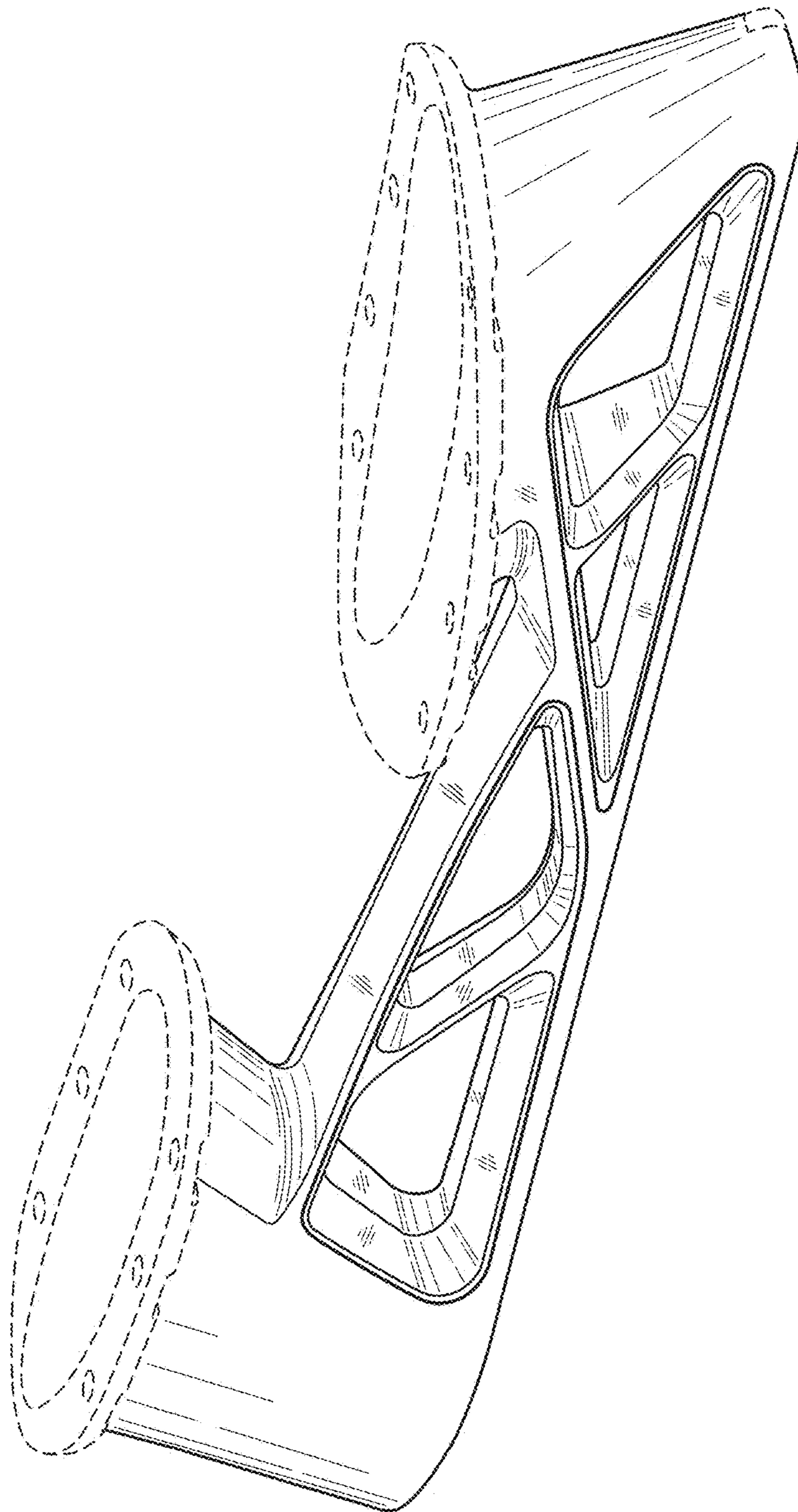

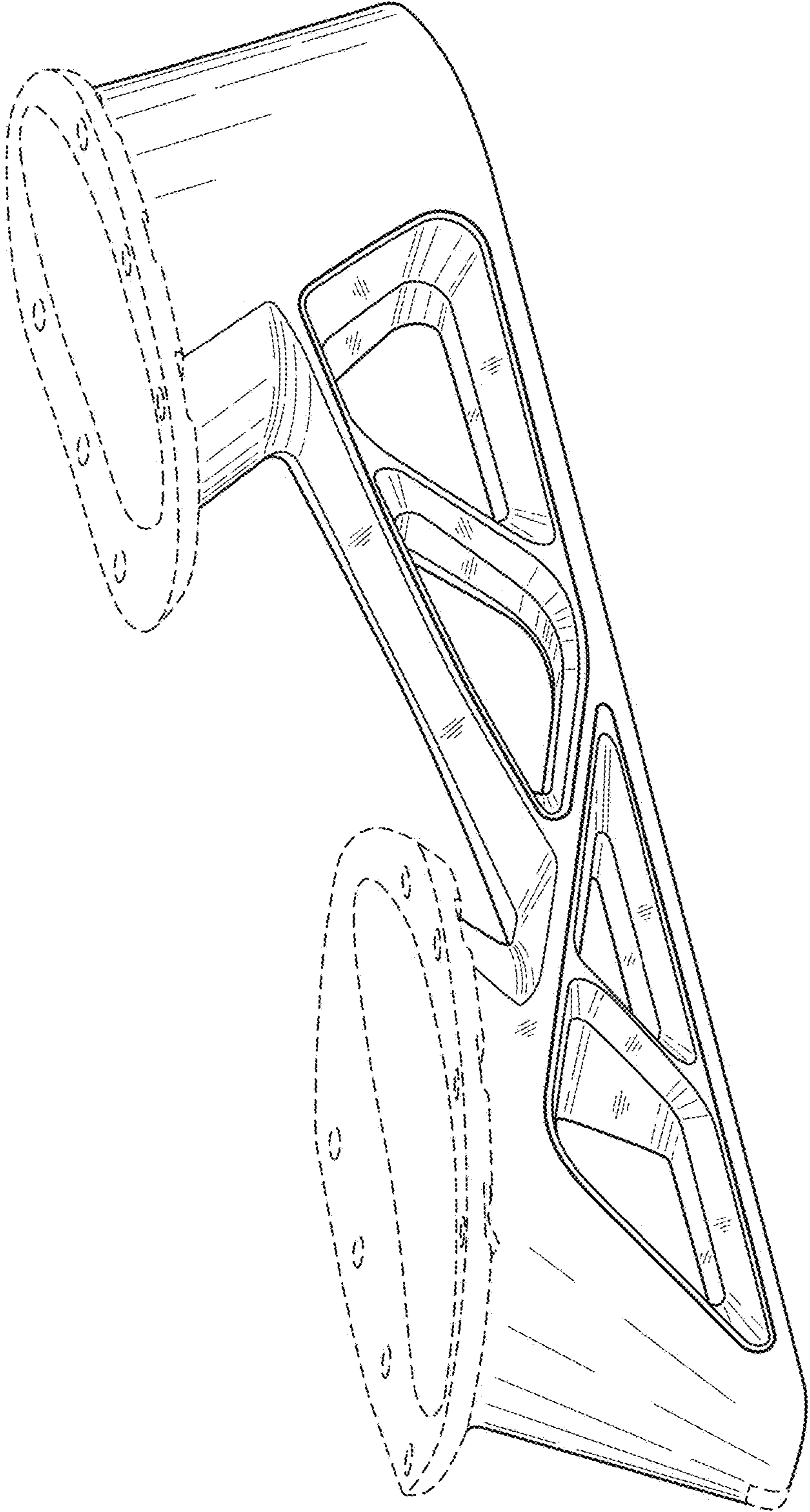

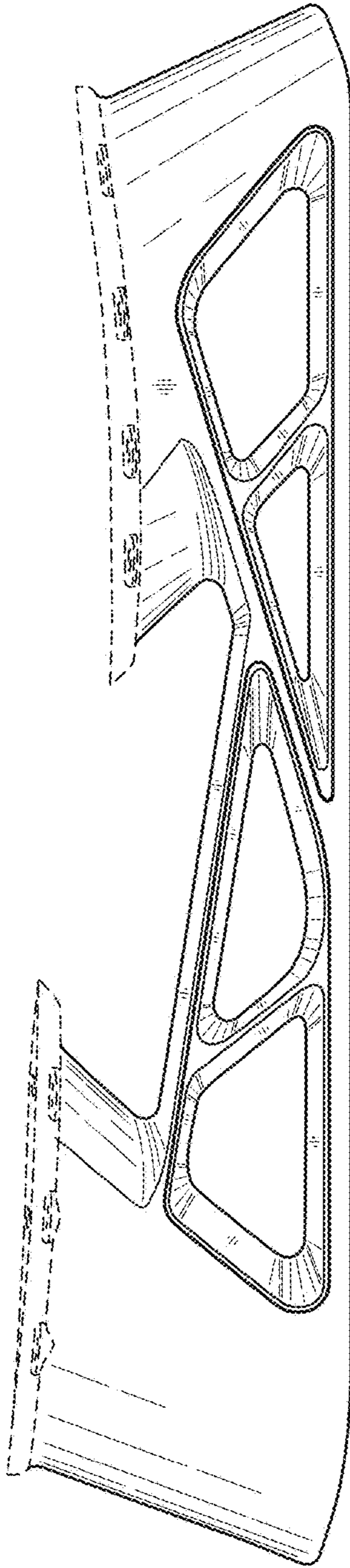

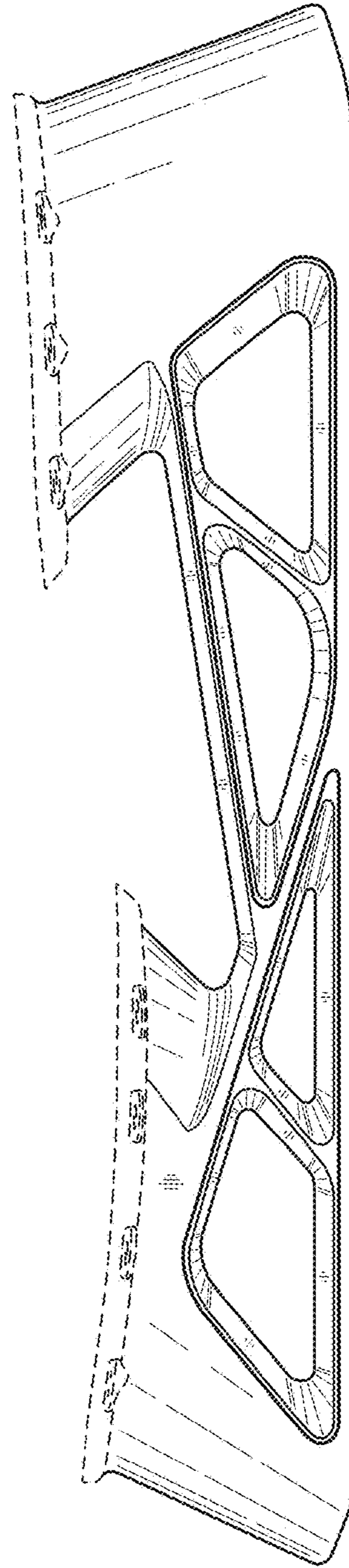

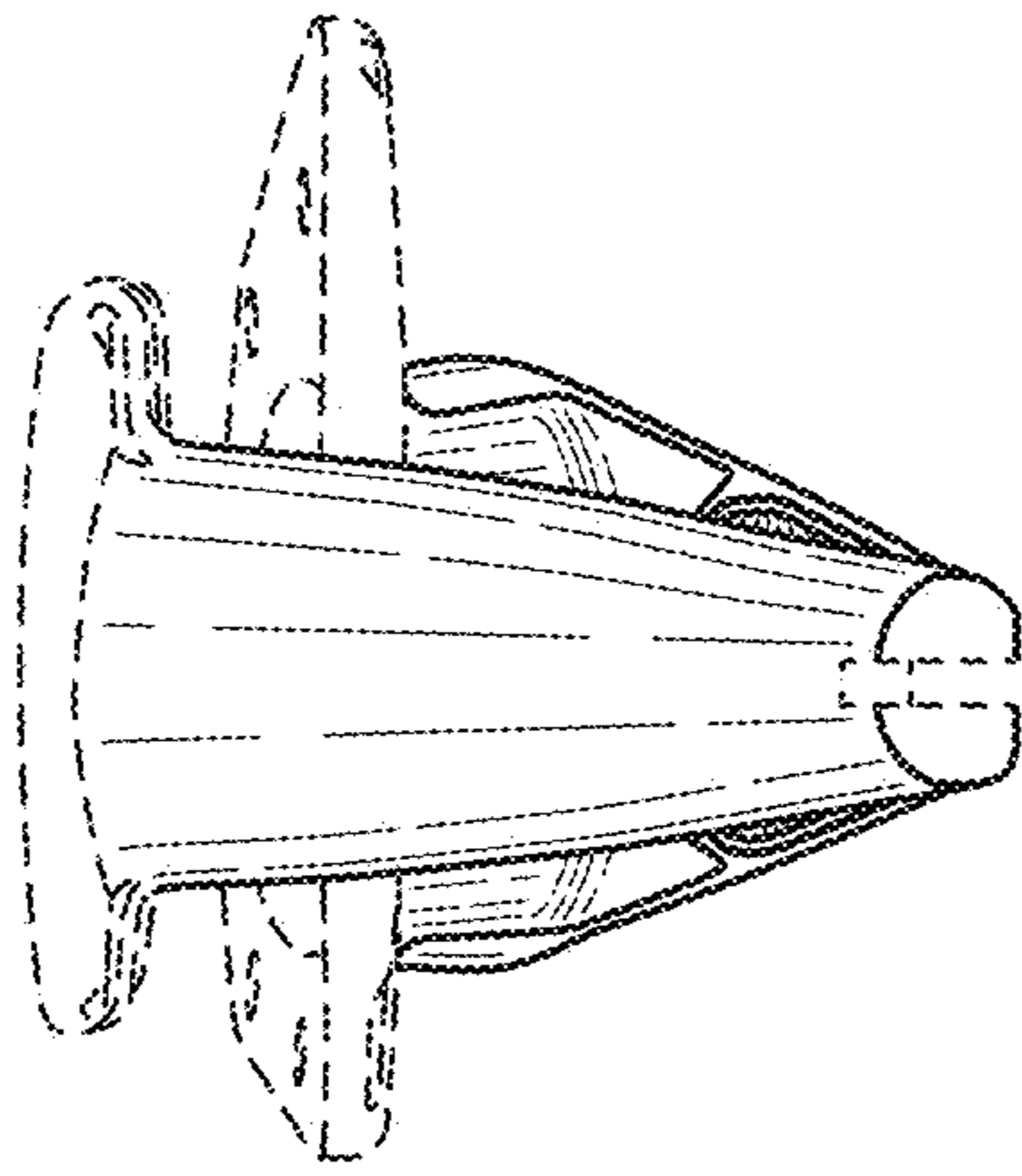

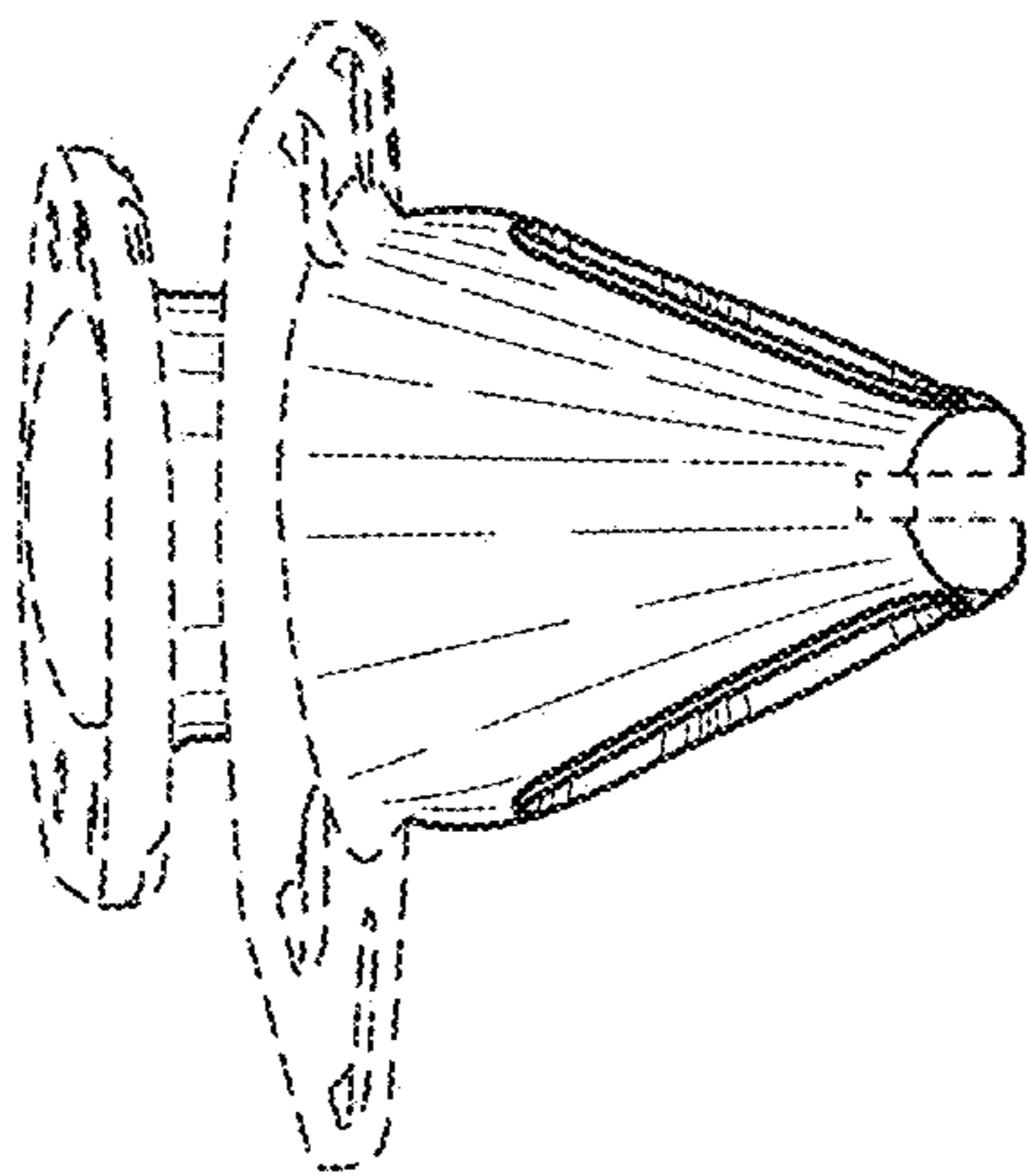
