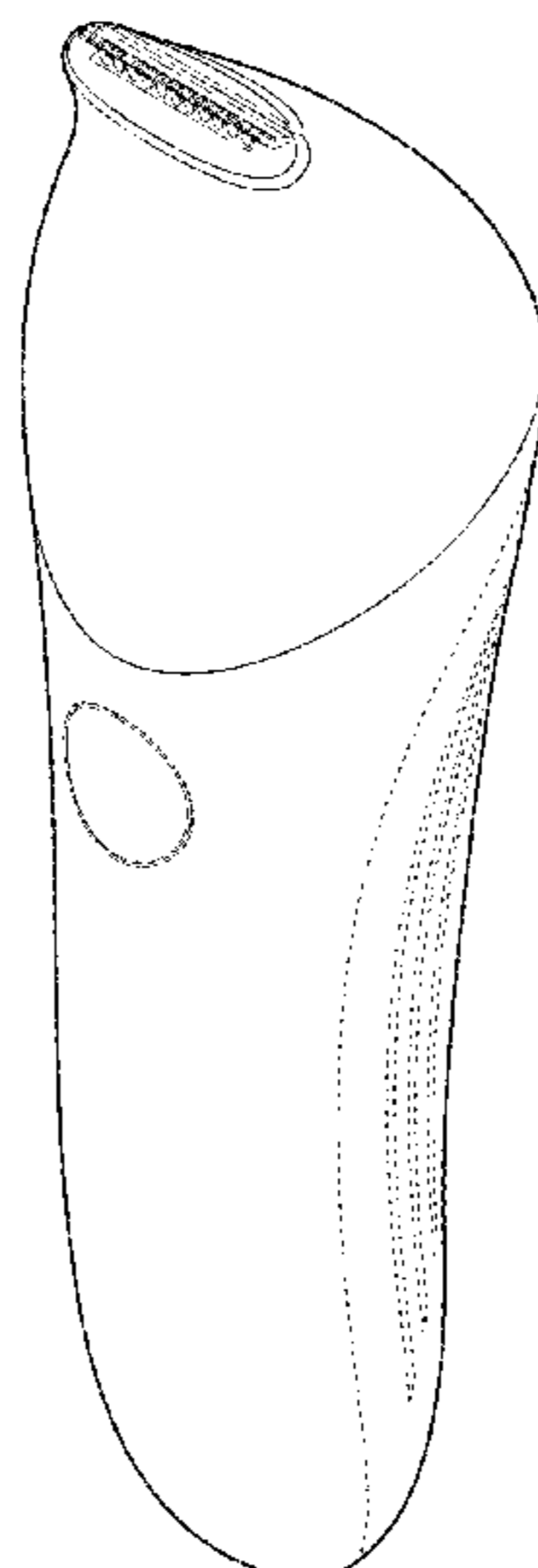

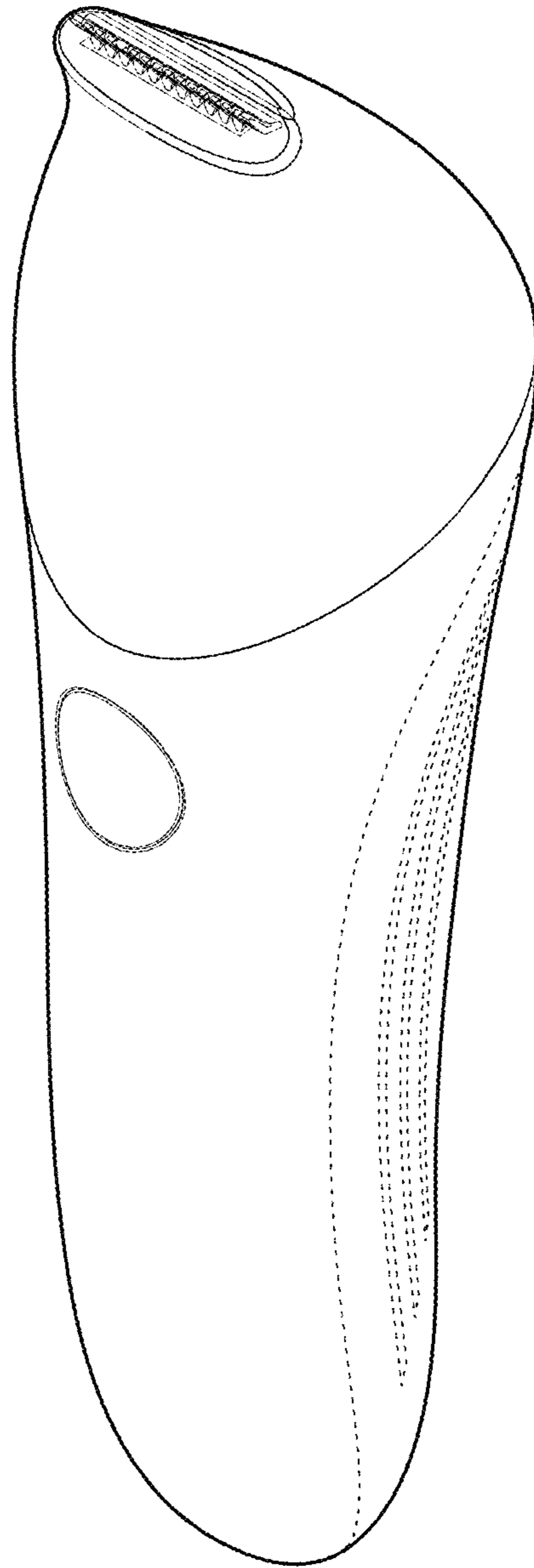

- 1.7 is a bottom view.

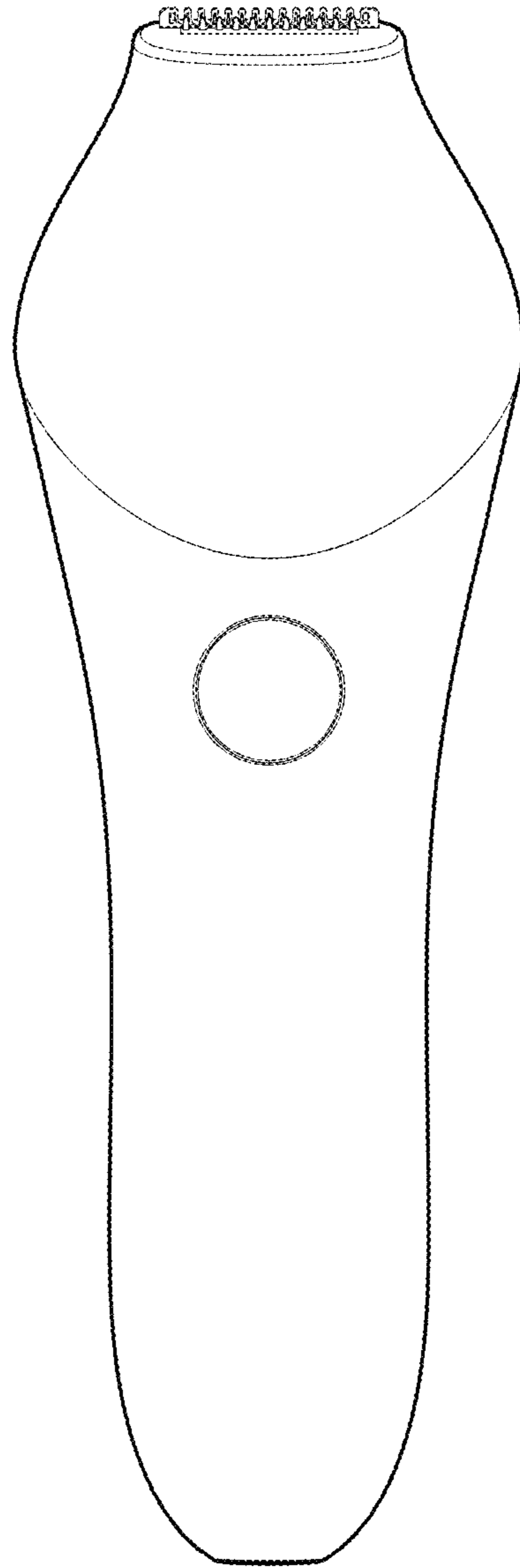
The broken lines in the drawings depict portions of the epilator that form no part of the claimed design.

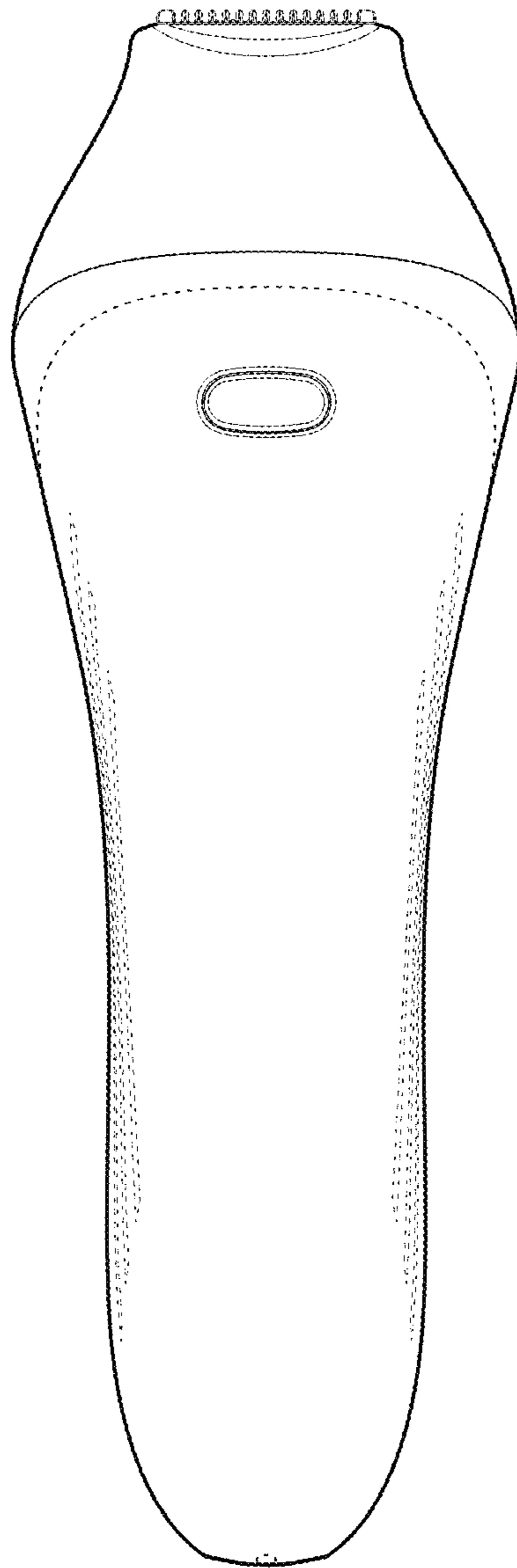




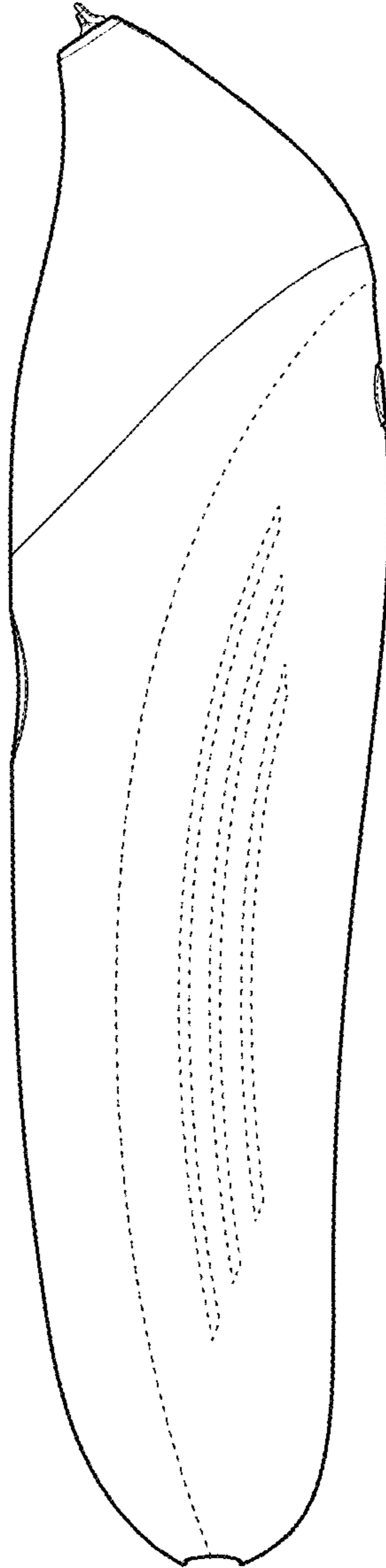

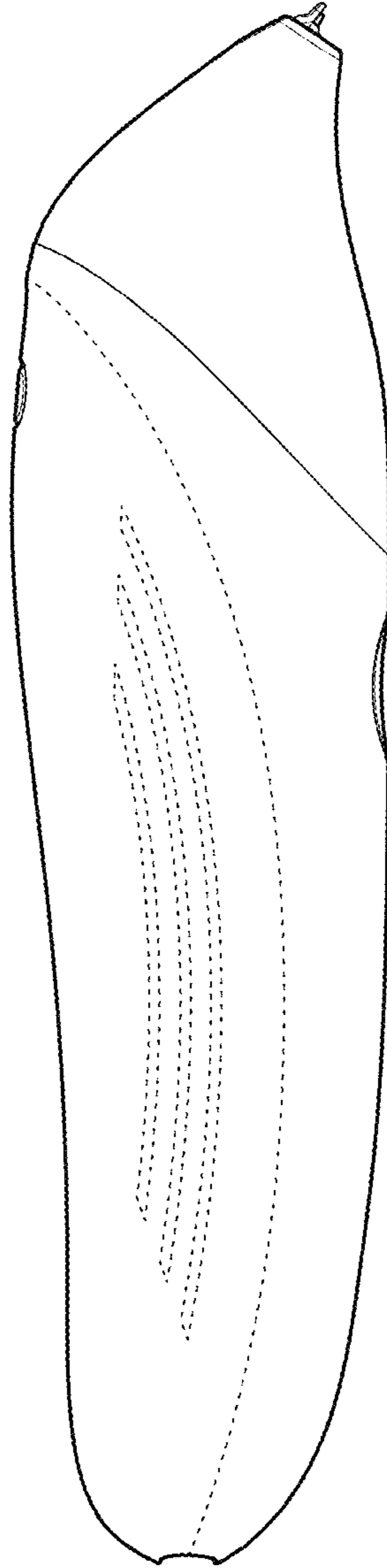

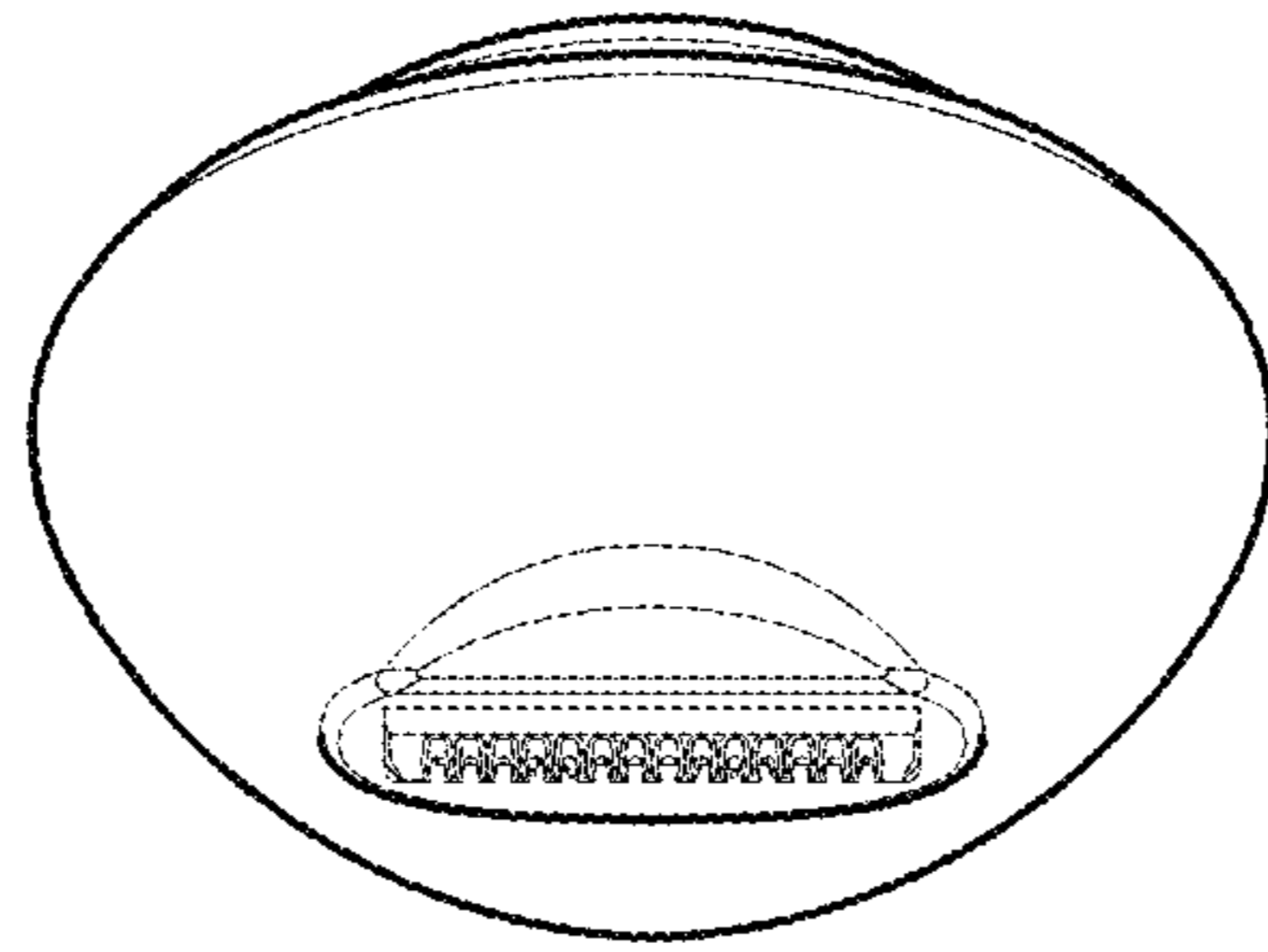

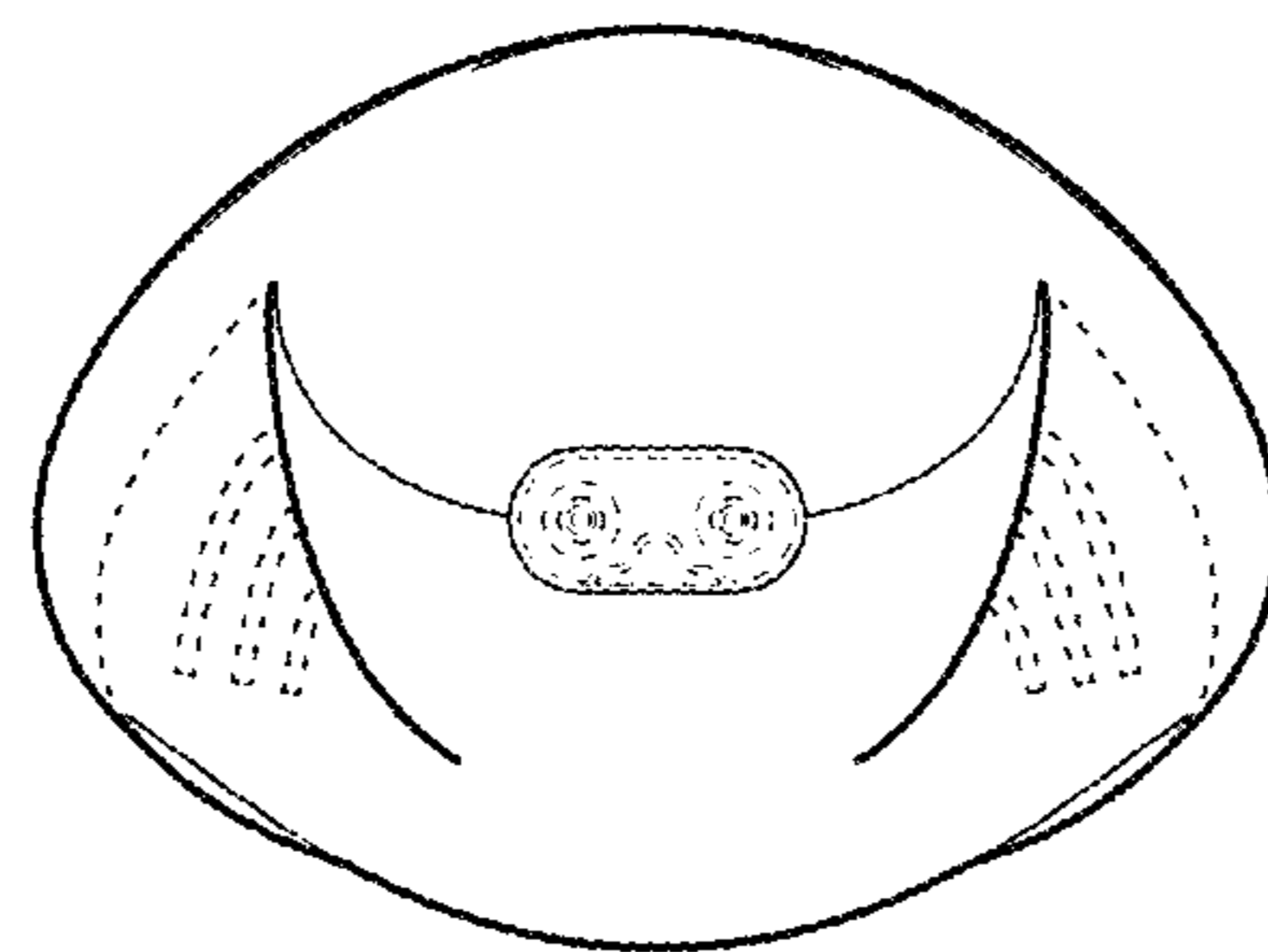
