DESCRIPTION

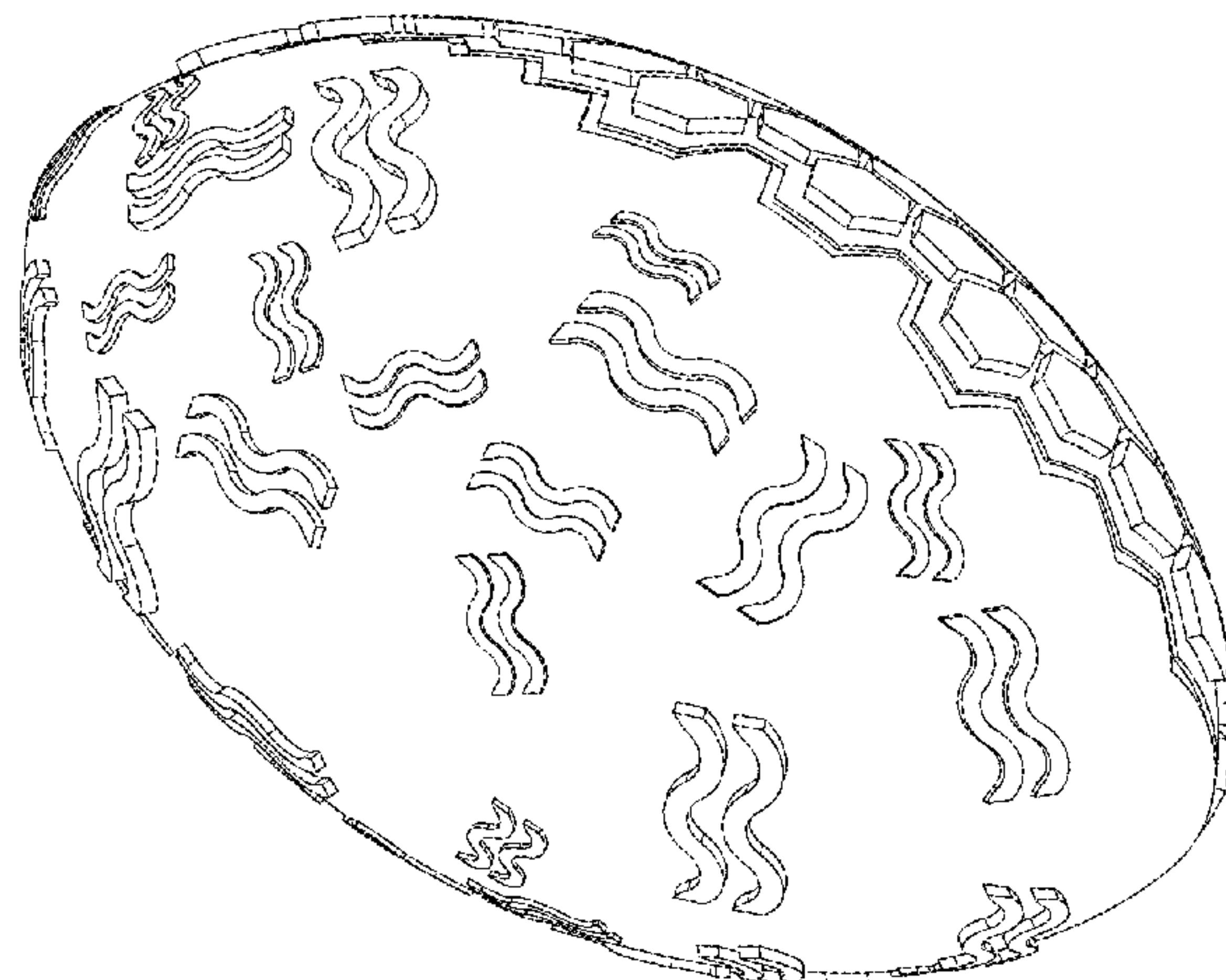
FIG. 1 is a top right perspective view of a pet toy embodying my design;

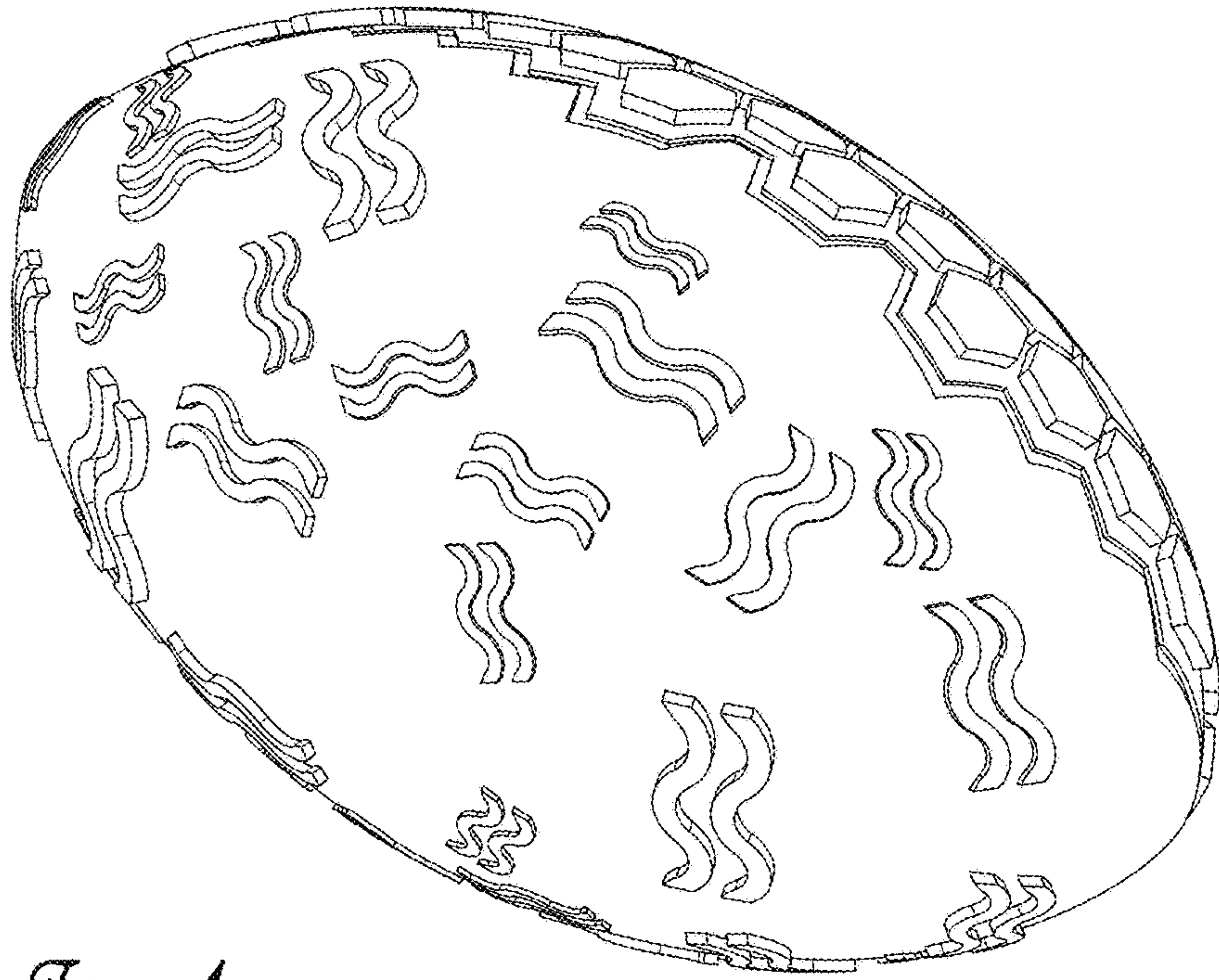

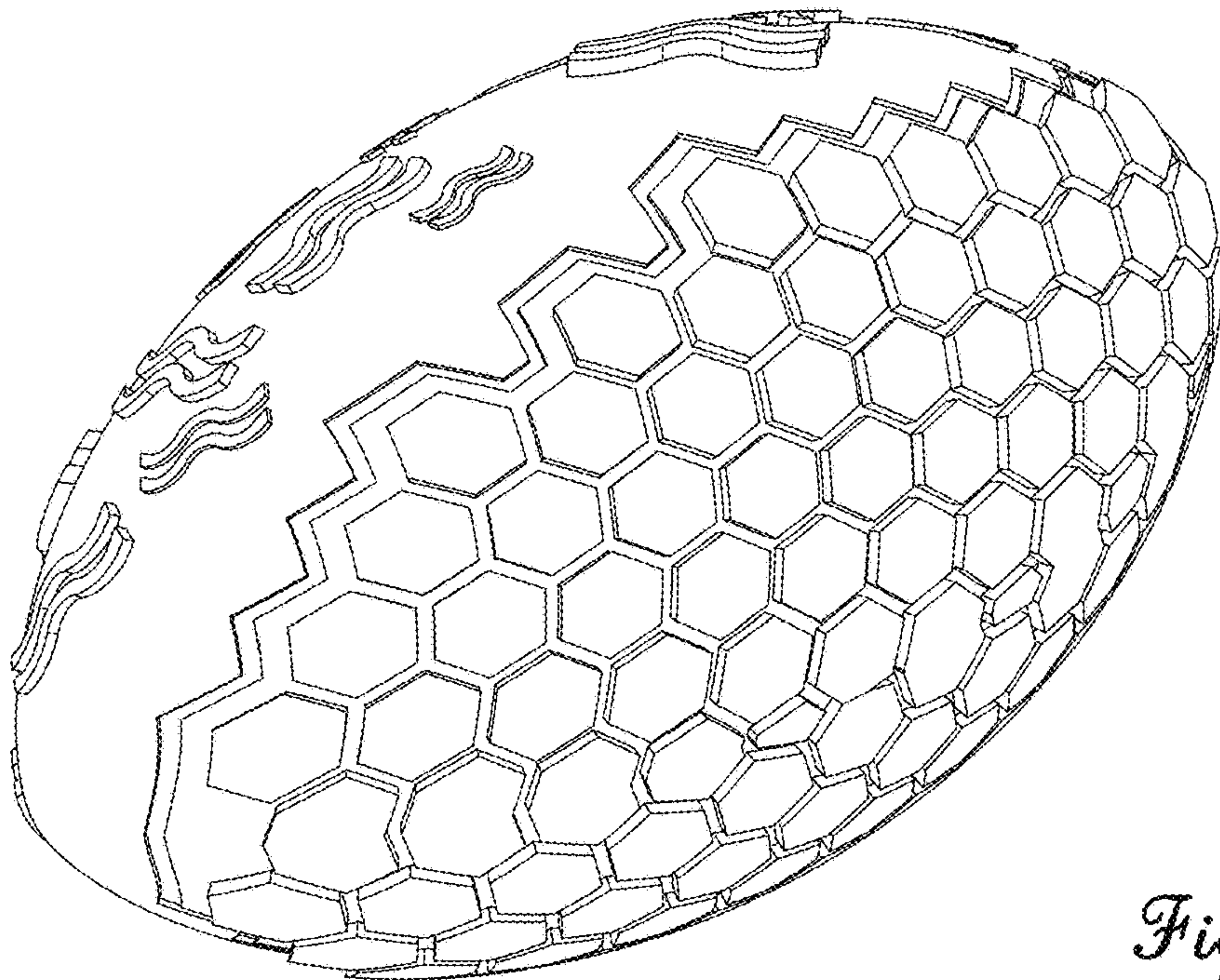

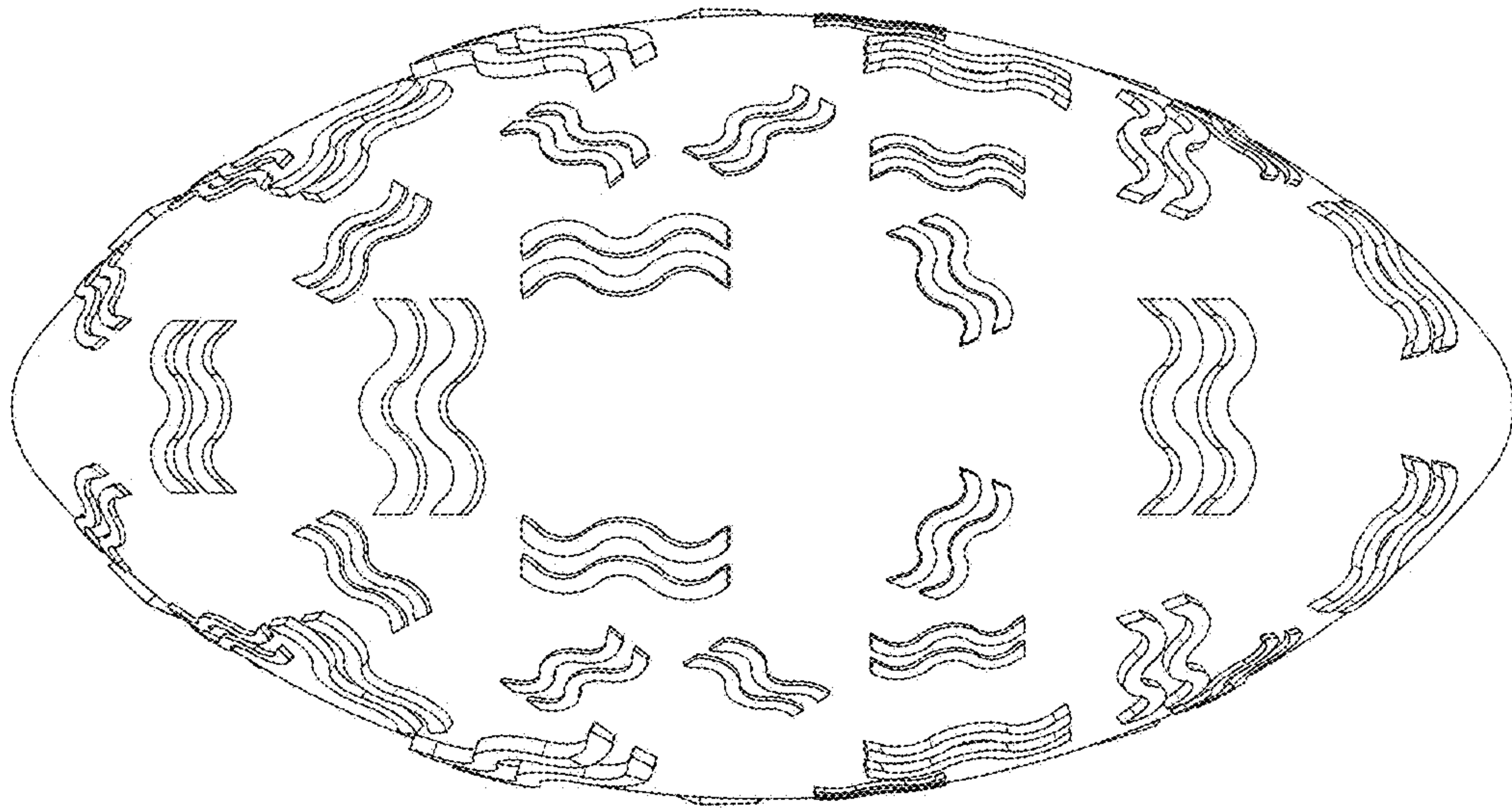

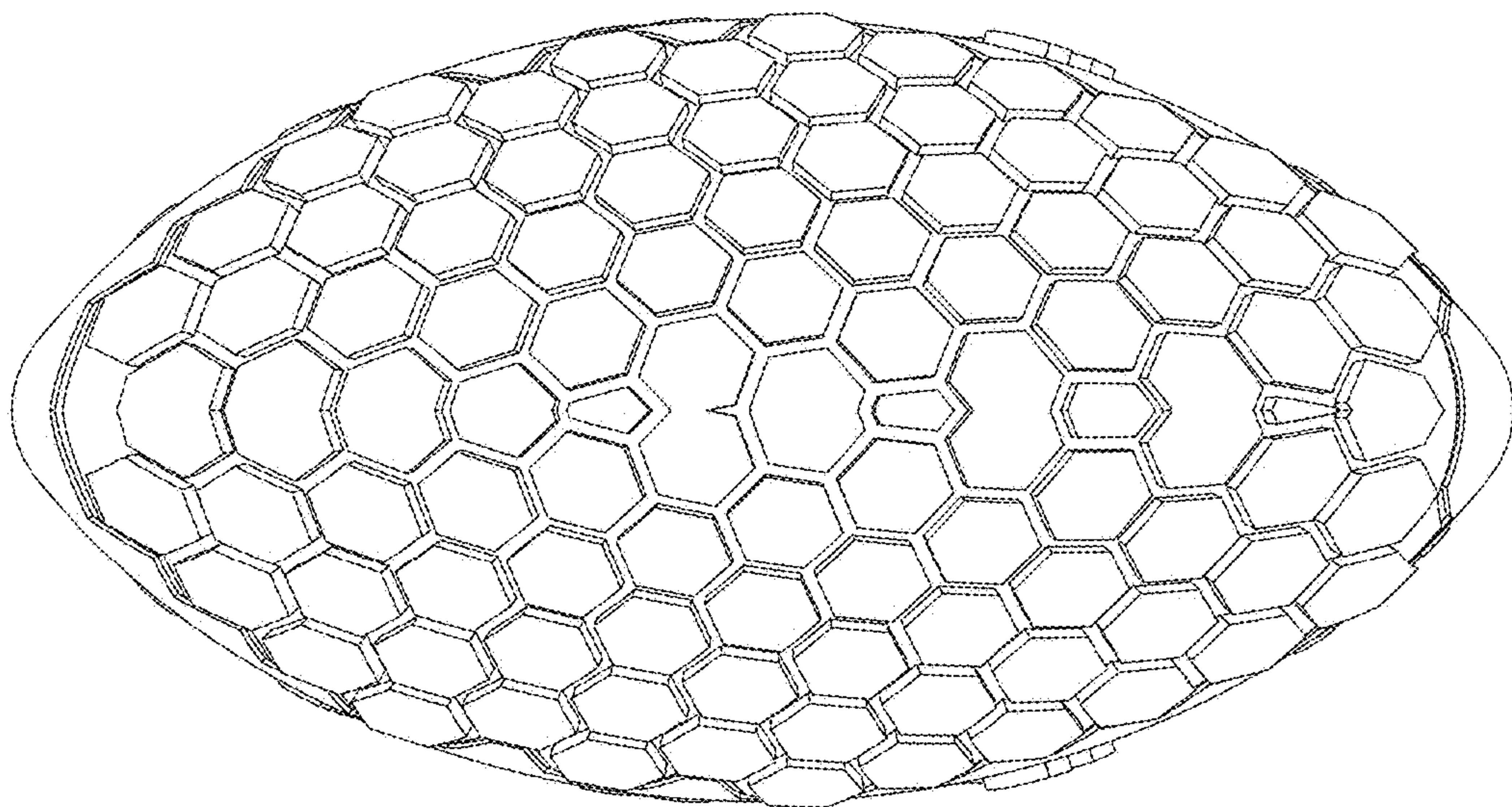

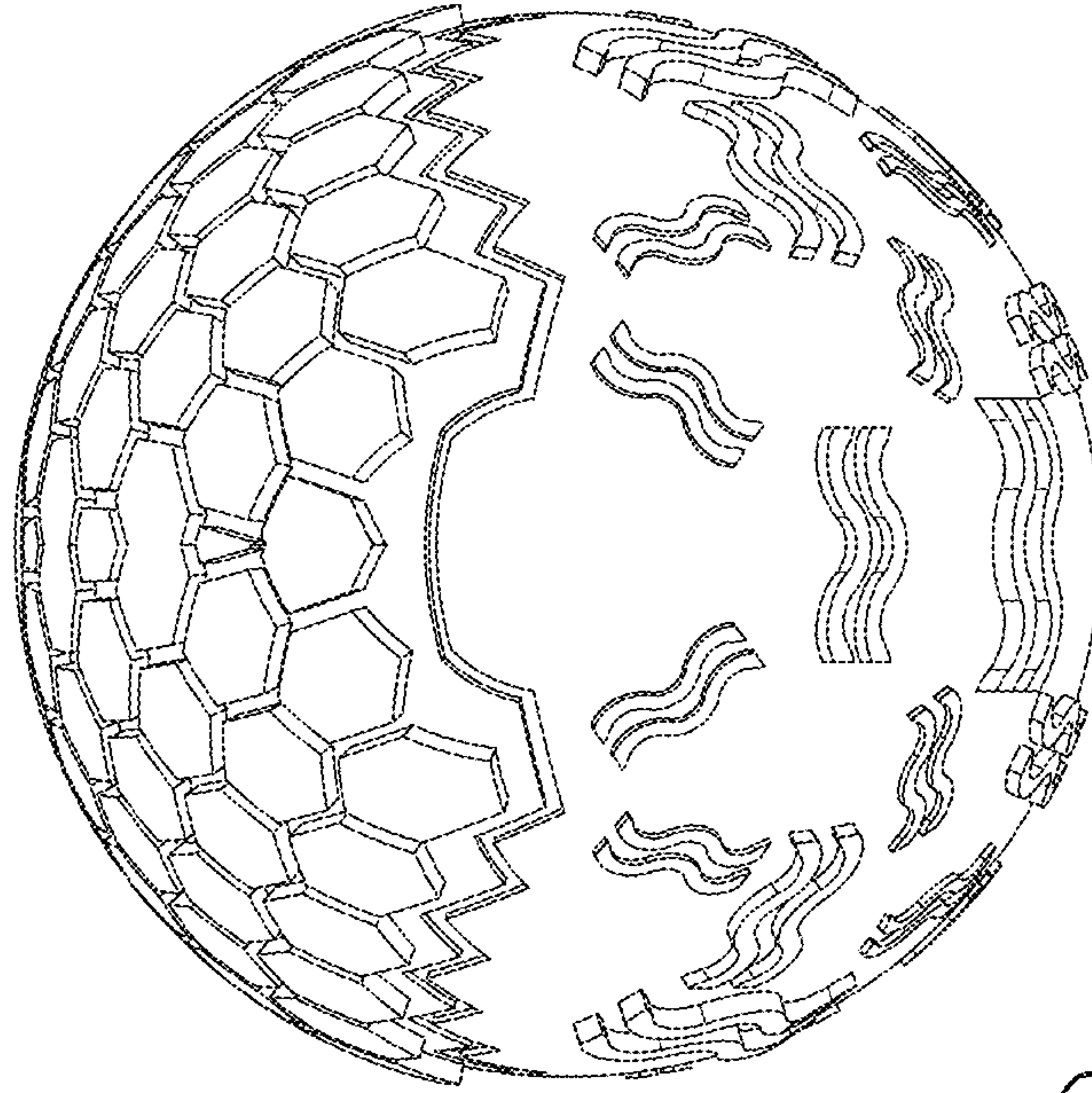

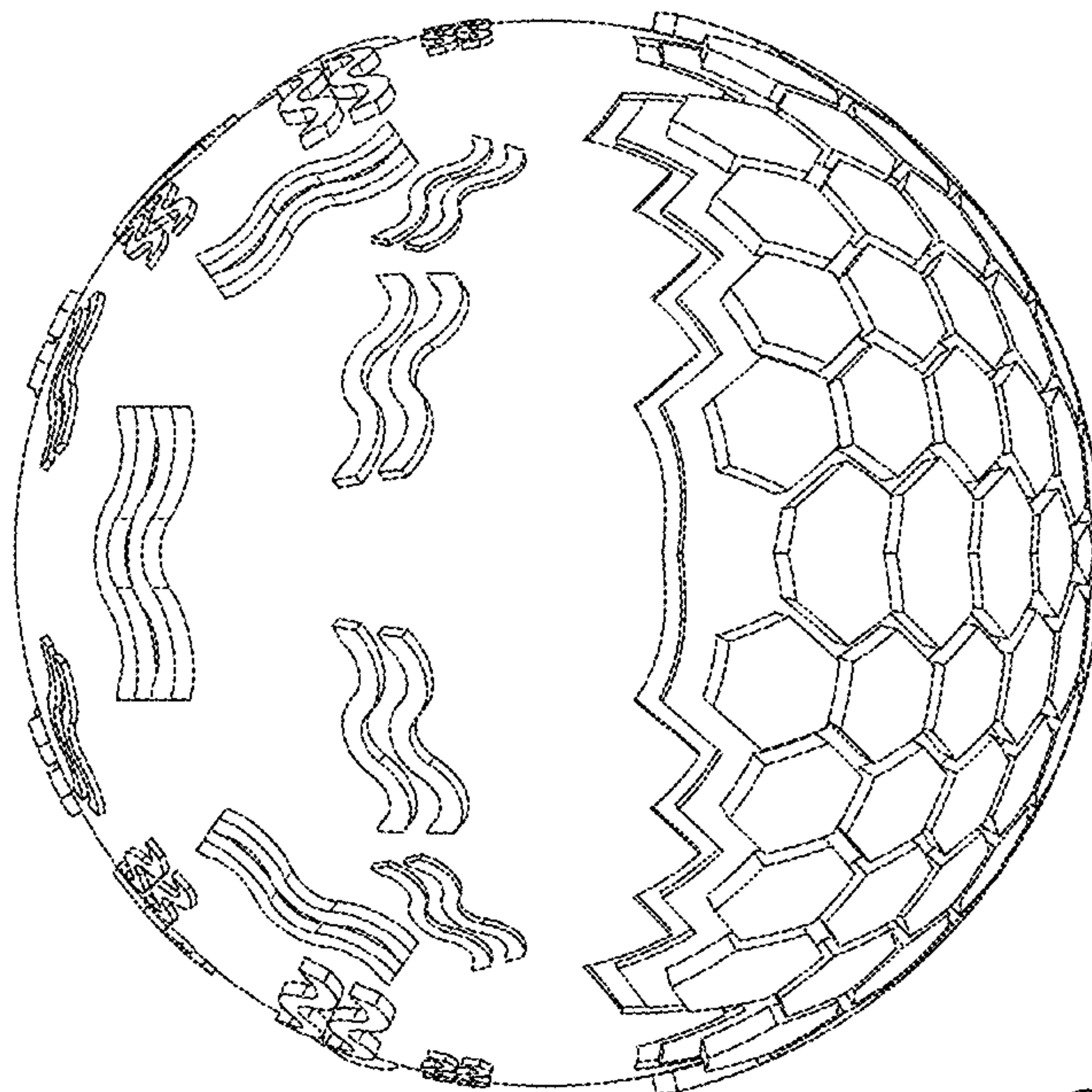

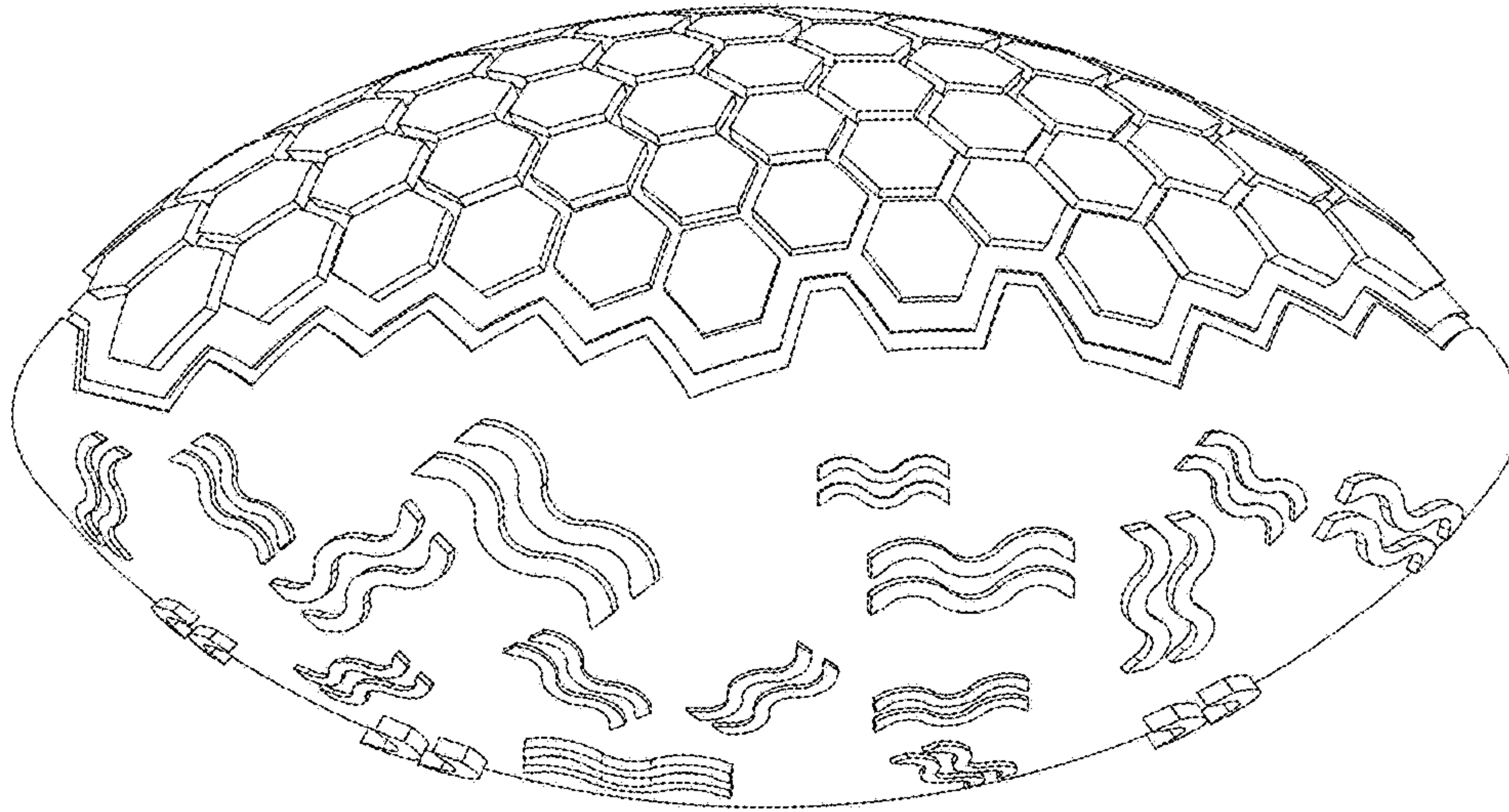

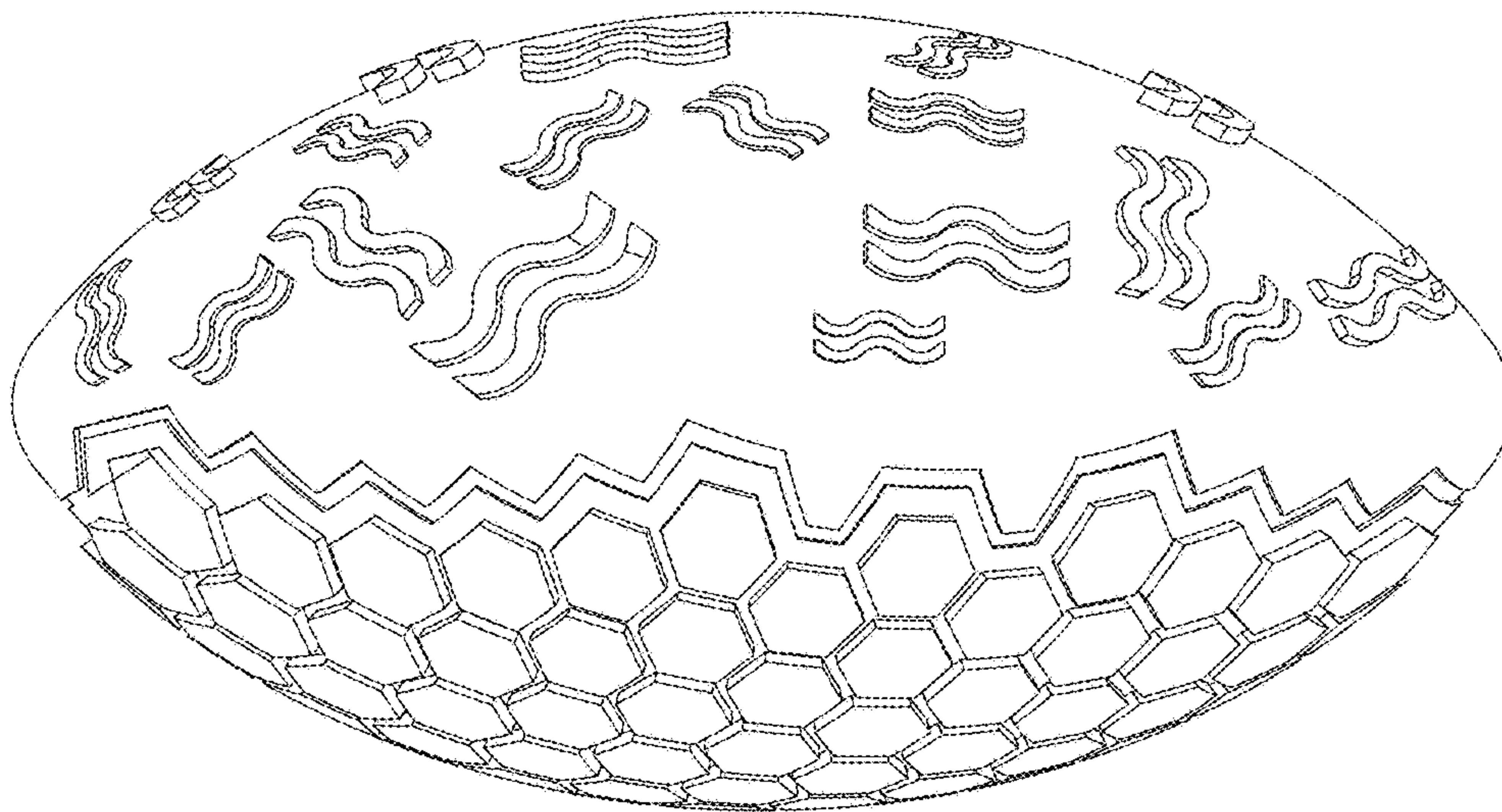
