I claim the ornamental design for a twisted knot puffed extrudate, as shown and described.

DESCRIPTION

FIG. 1 is a left, top, front perspective view of a twisted knot puffed extrudate showing my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a left side elevation view thereof;

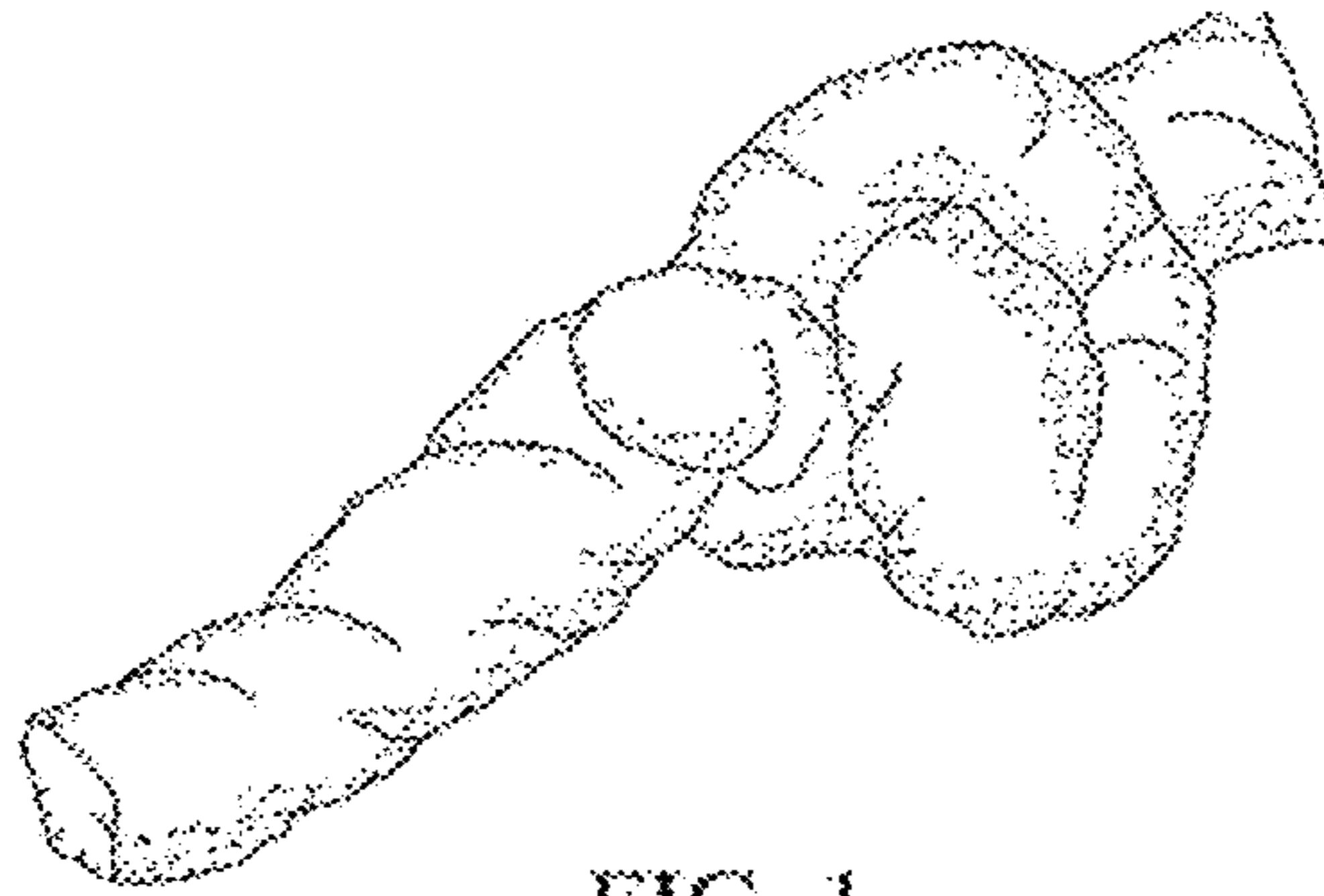

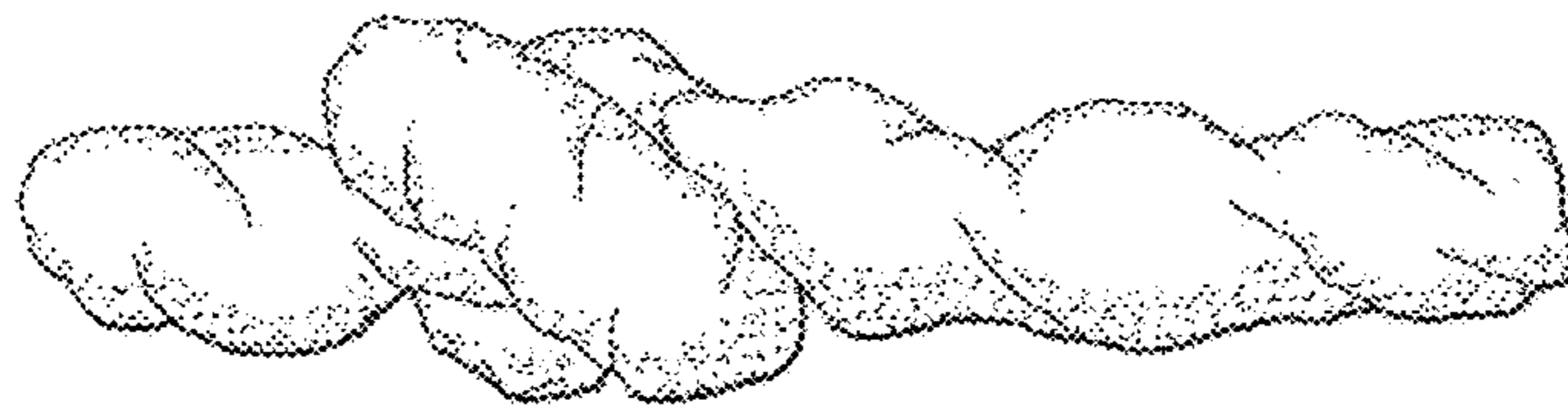

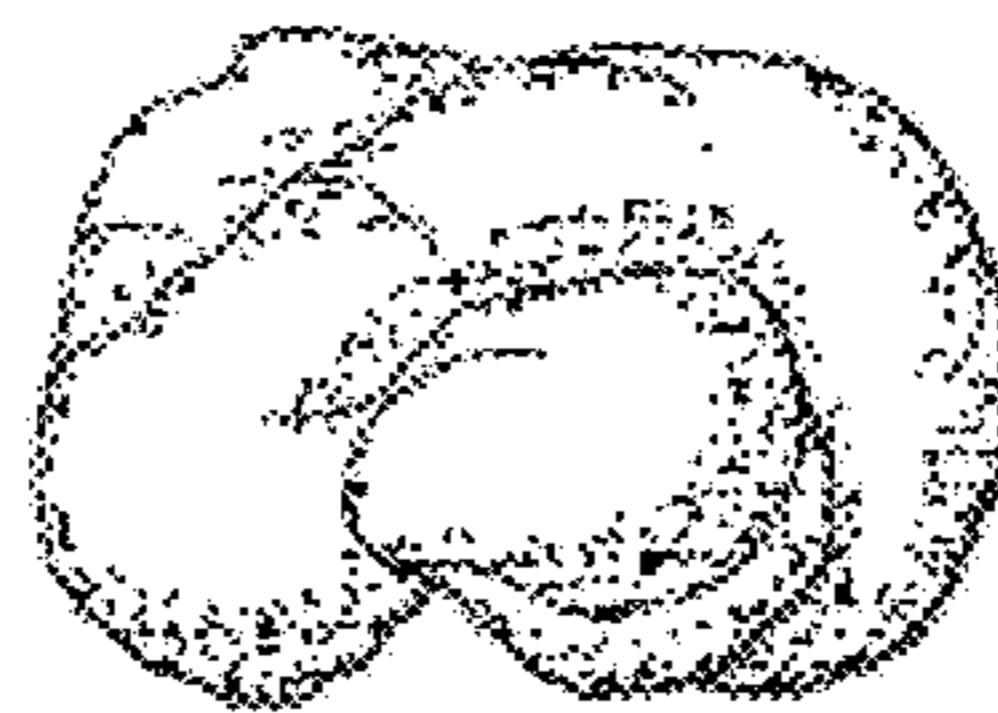

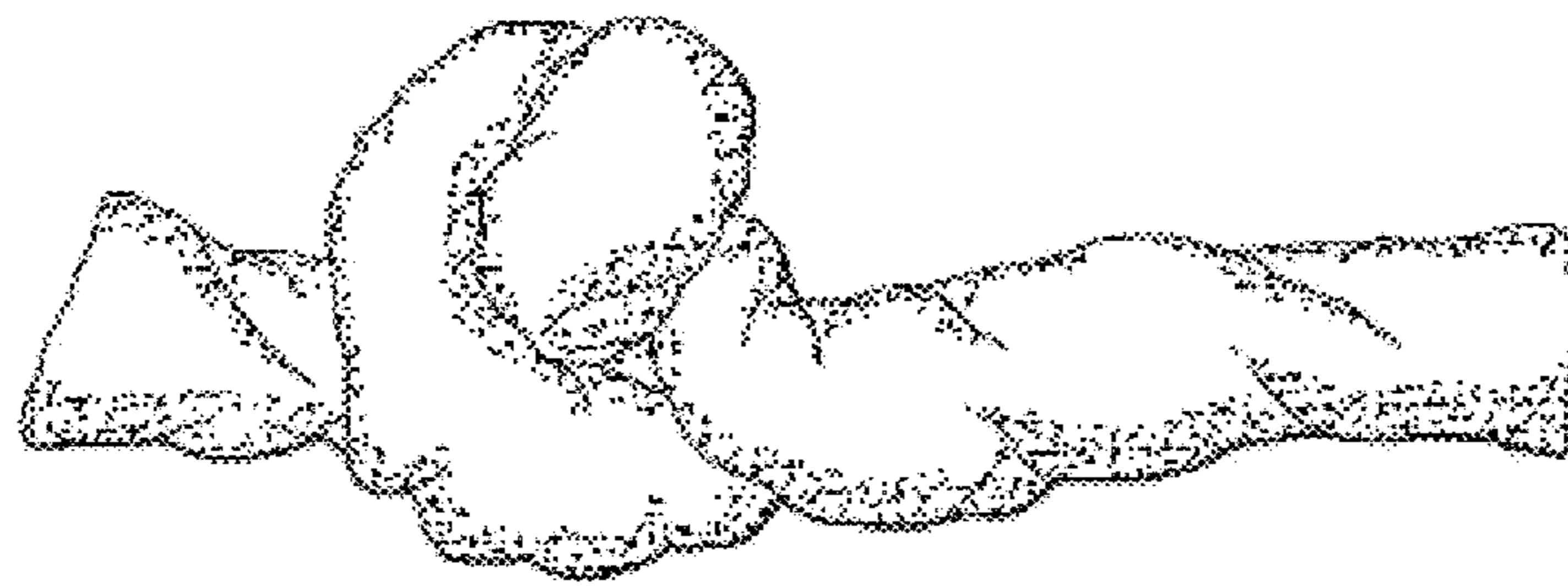

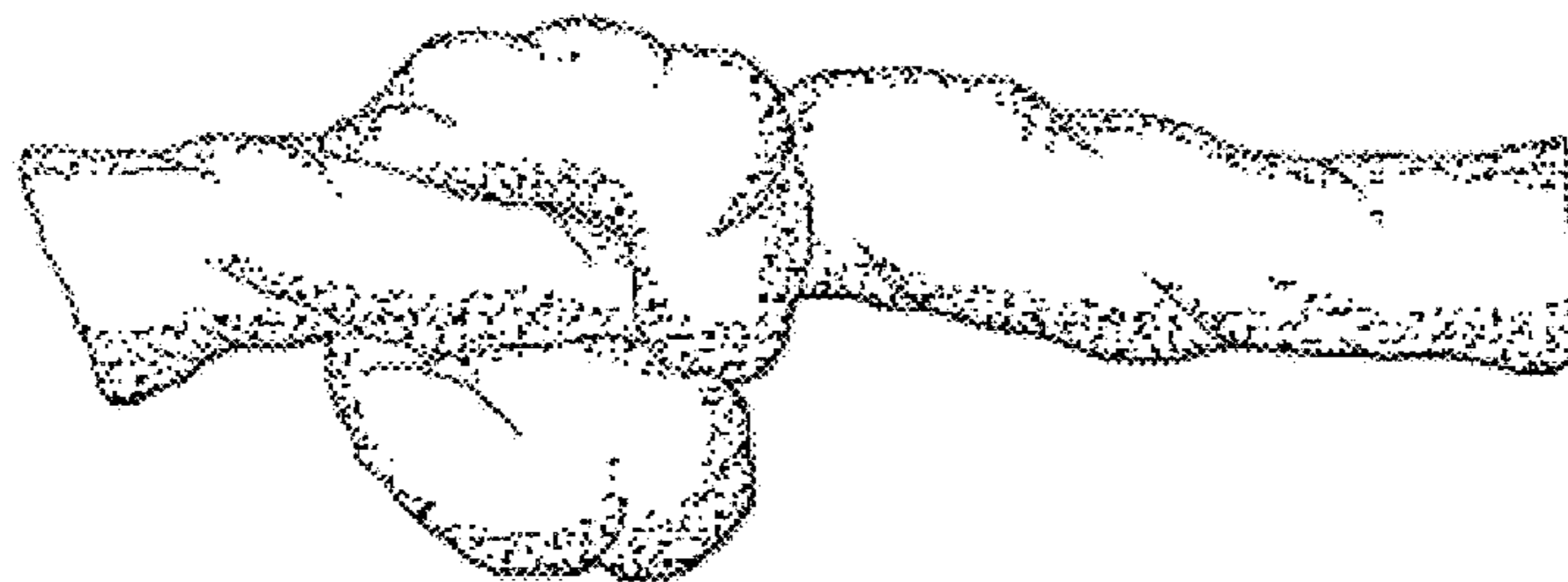
