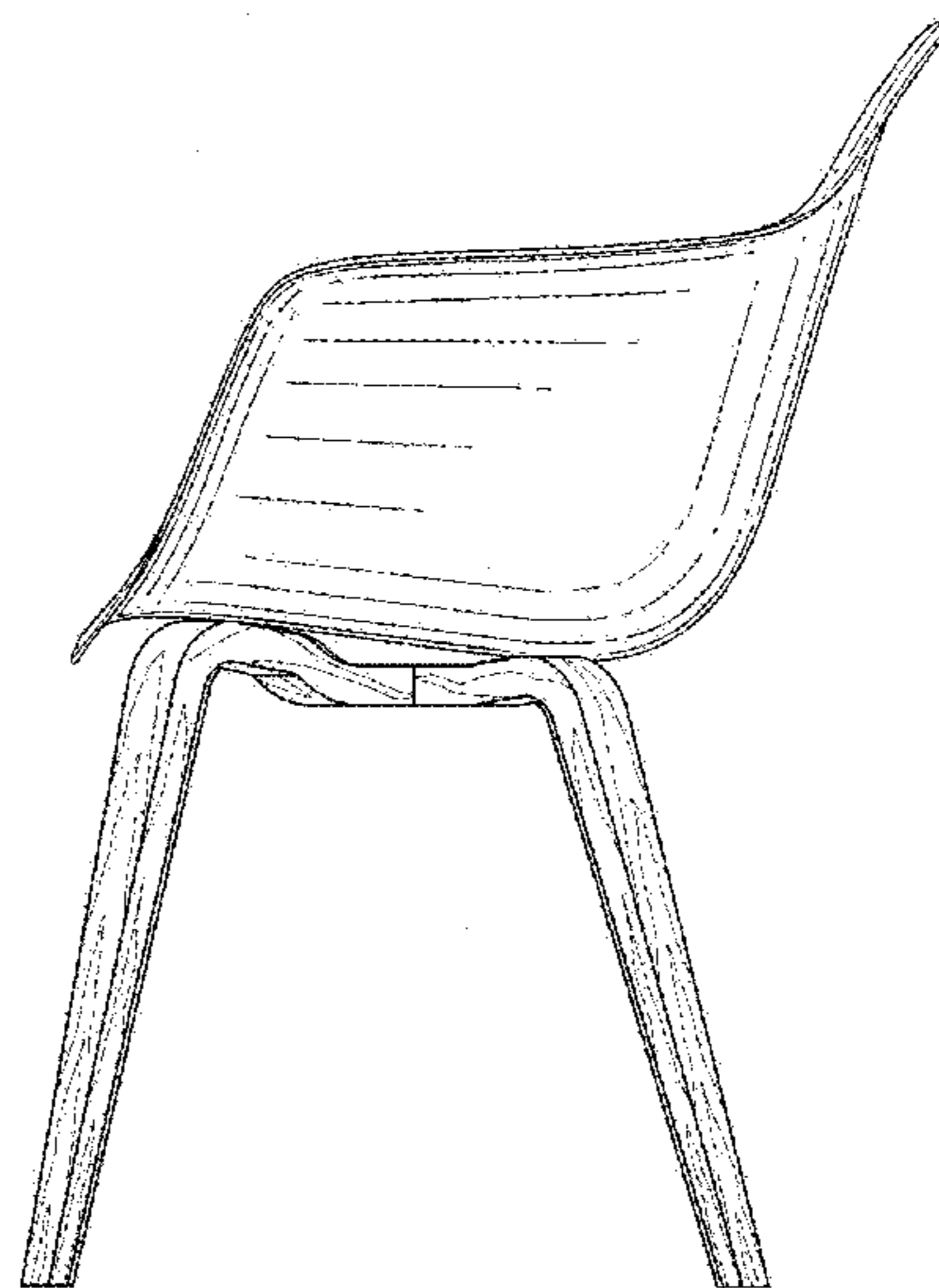
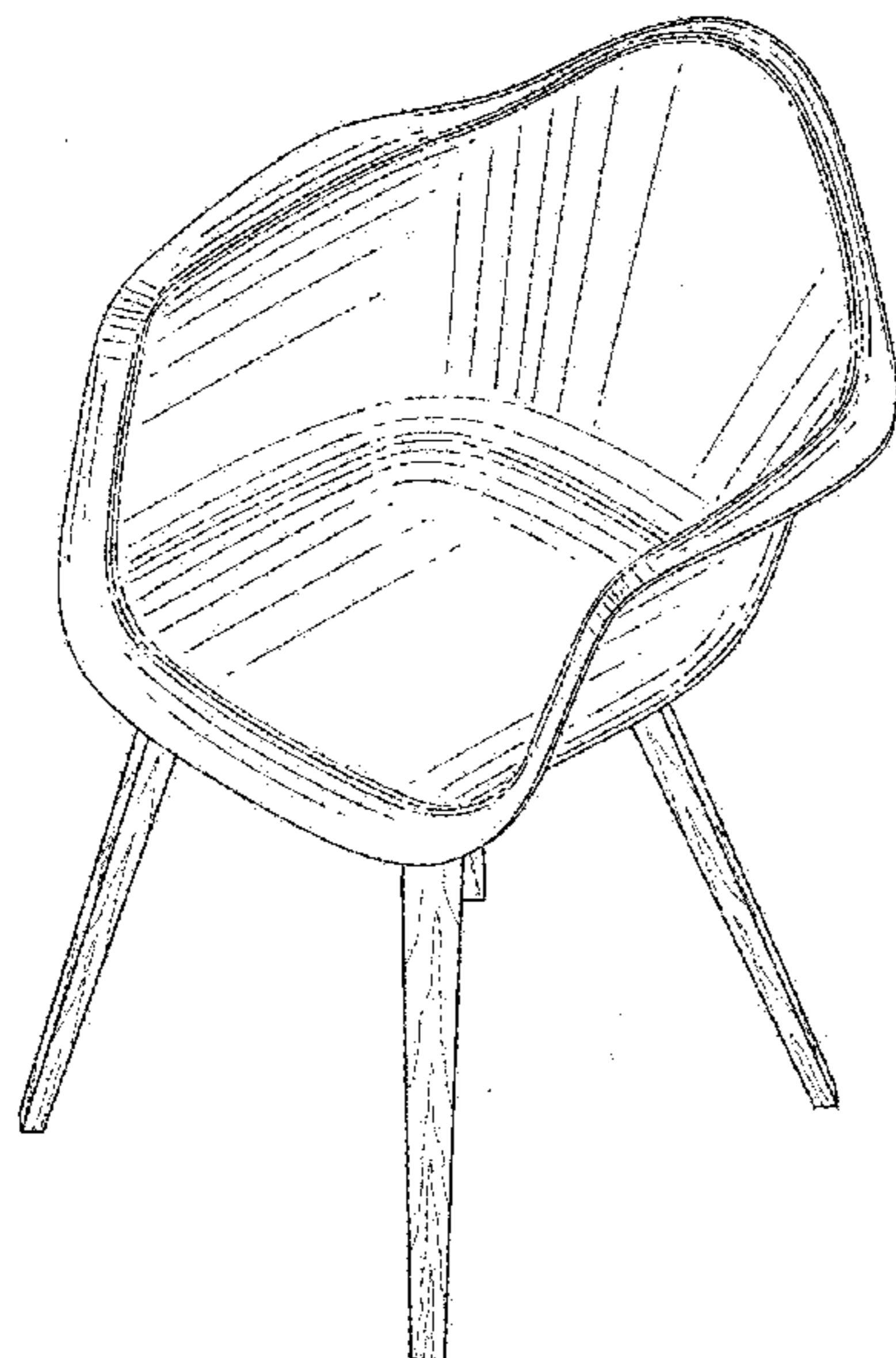
(57) **CLAIM**

The ornamental design for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the chair with a solid seat and arms.  
FIG. 2 is a top view of the chair with a solid seat and arms.  
FIG. 3 is a front view of the chair with a solid seat and arms.  
FIG. 4 is a left side view of the chair with a solid seat, the right side view being a mirror image of the left side view and arms; and,  
FIG. 5 is a back view of the chair with a solid seat and arms.  
The bottom view is not part of the design. The chair legs have an organic wood grain appearance.

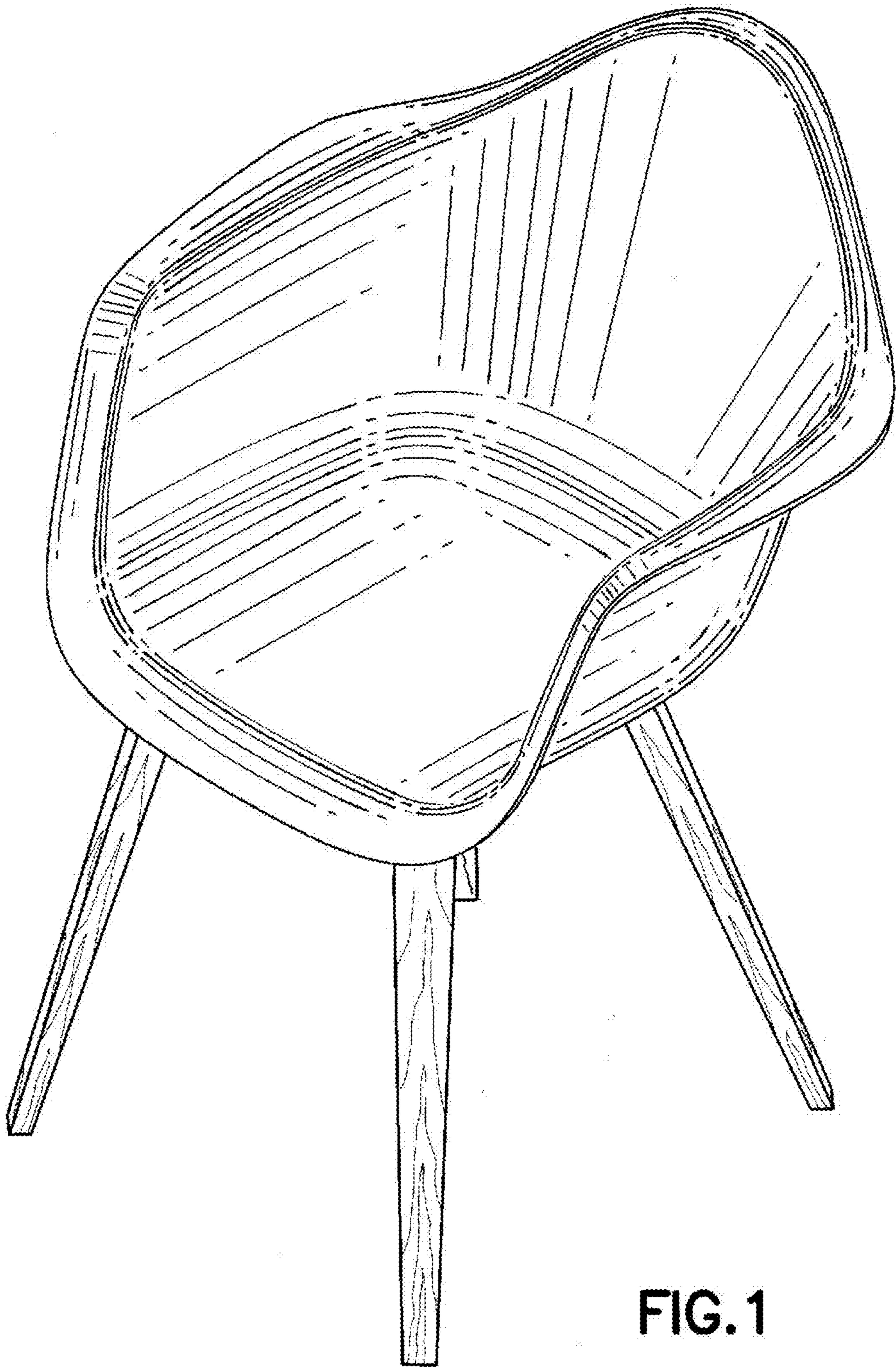

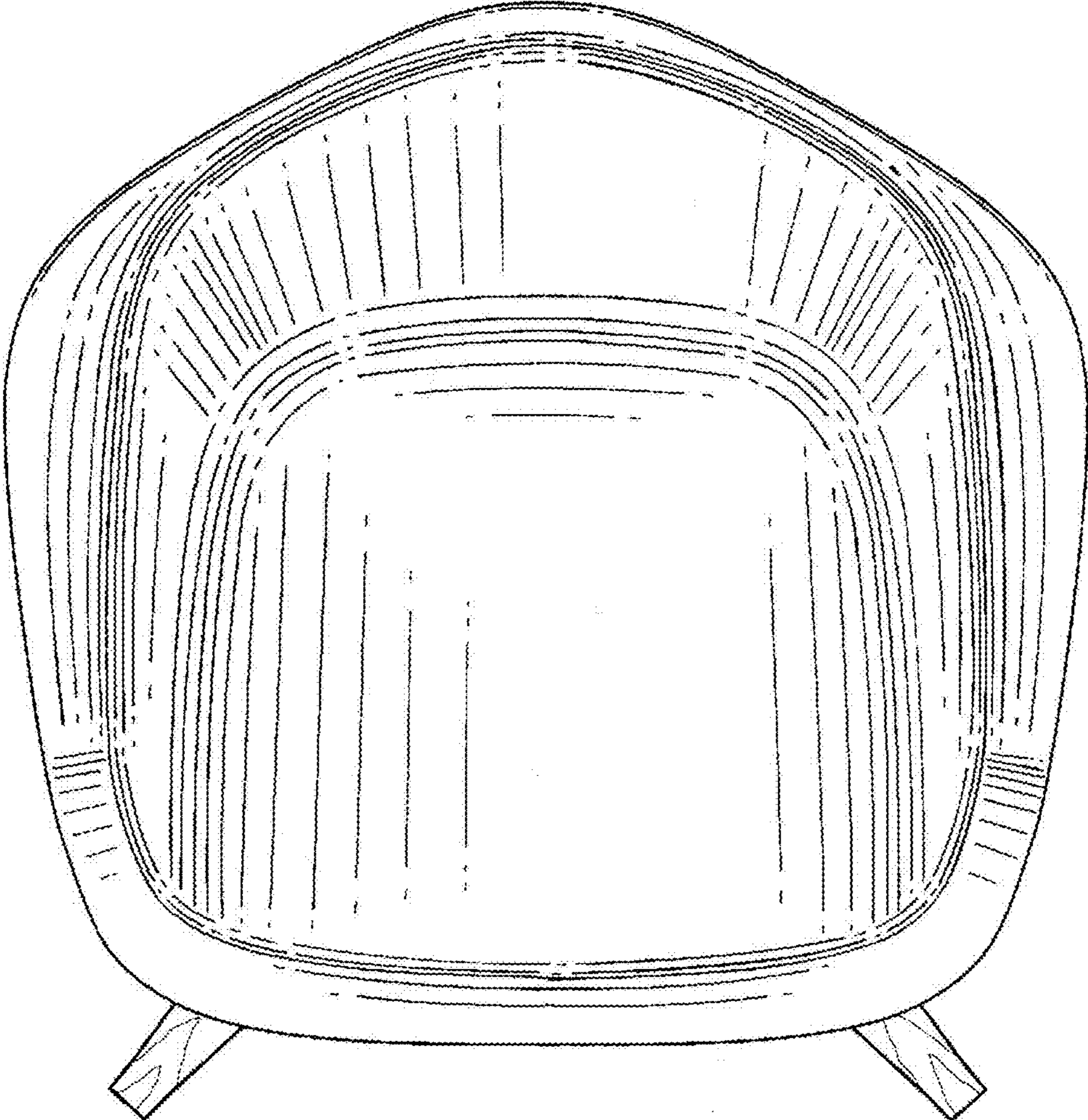

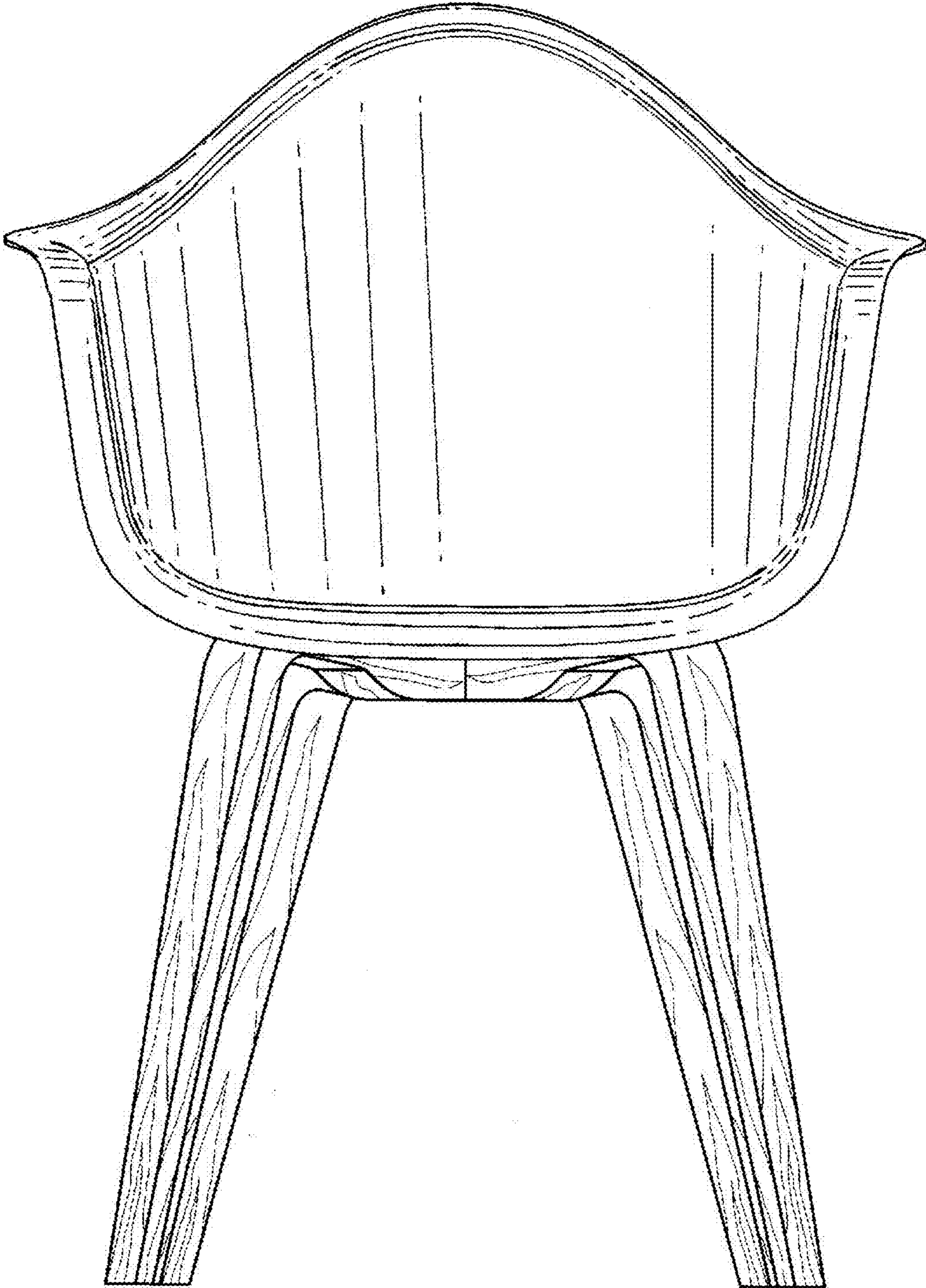

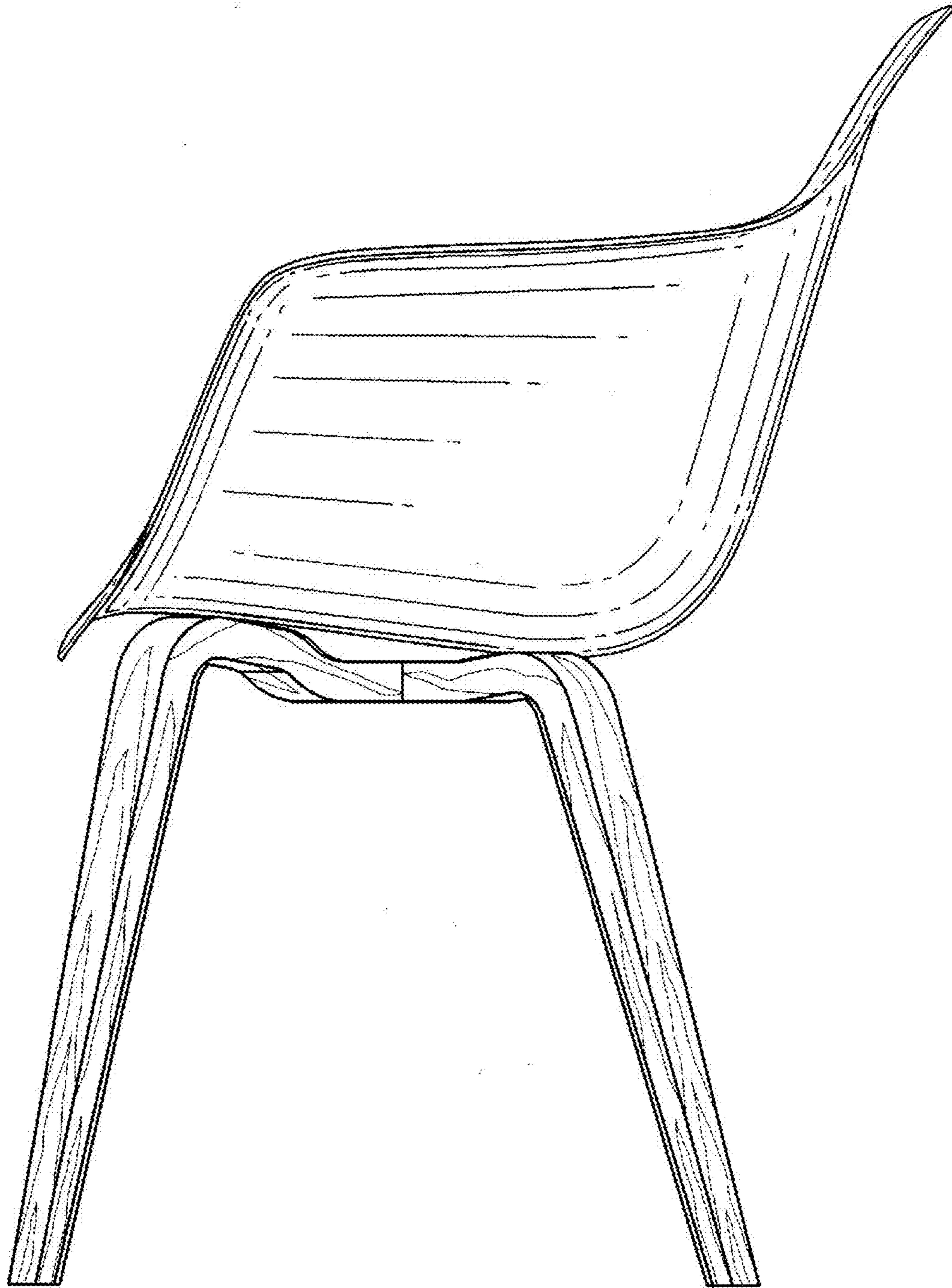

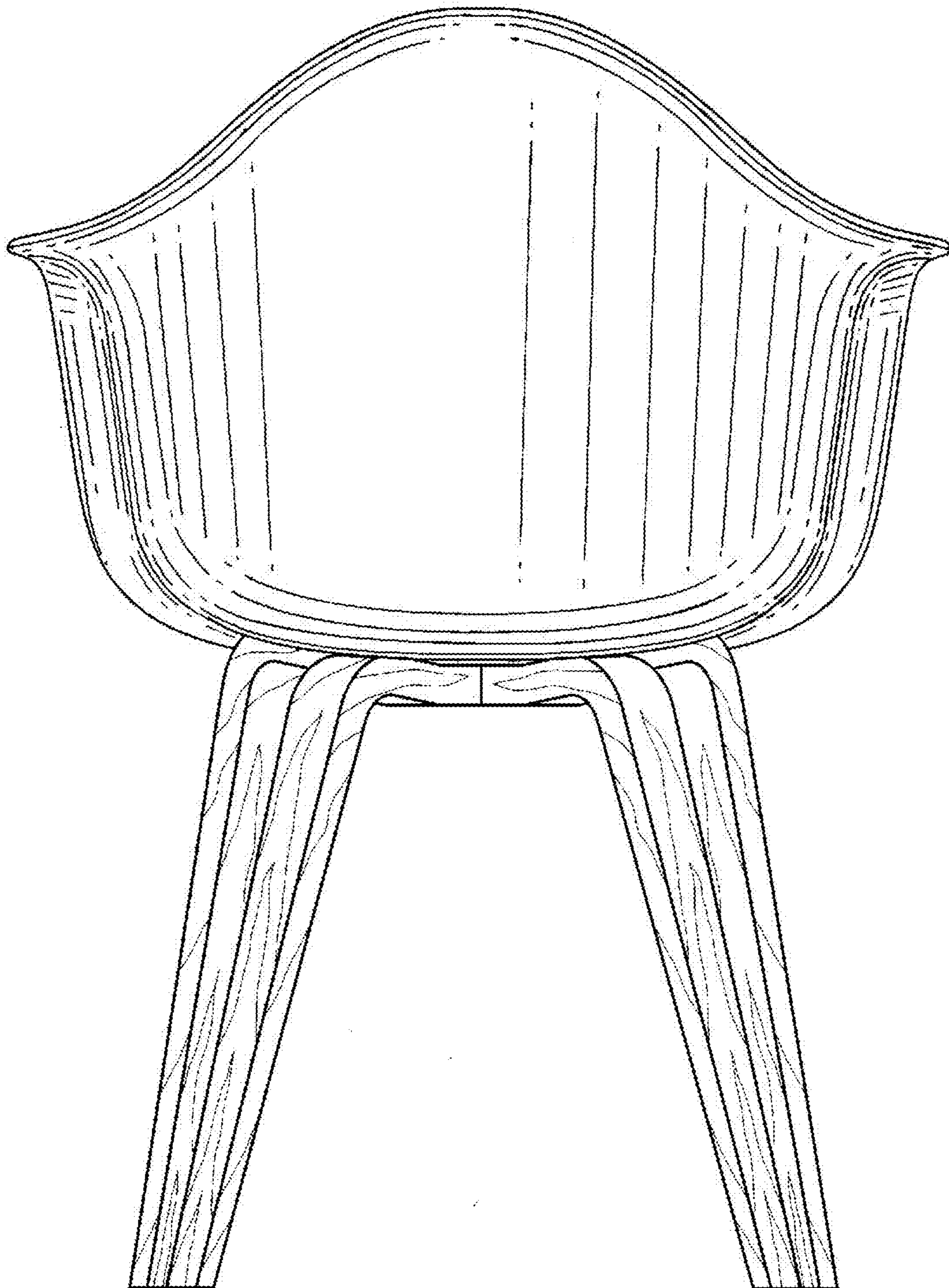
